(57) **CLAIM**

I claim the ornamental design for a vibrator, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a vibrator, showing the new design;

FIG. 2 is an enlarged perspective view thereof;

FIG. 3 is a left side elevation view of the vibrator of FIG. 2, the right side elevation view being a mirror image thereof;

FIG. 4 is a front elevation view of the vibrator of FIG. 2;

FIG. 5 is a rear elevation view of the vibrator of FIG. 2;

FIG. 6 is a top plan view of the vibrator of FIG. 2; and,

FIG. 7 is a bottom plan view of the vibrator of FIG. 2.

The broken lines showing a person and a pair of panties in FIG. 1 are included for the purpose of illustrating the invention in use, and form no part of the claimed design.

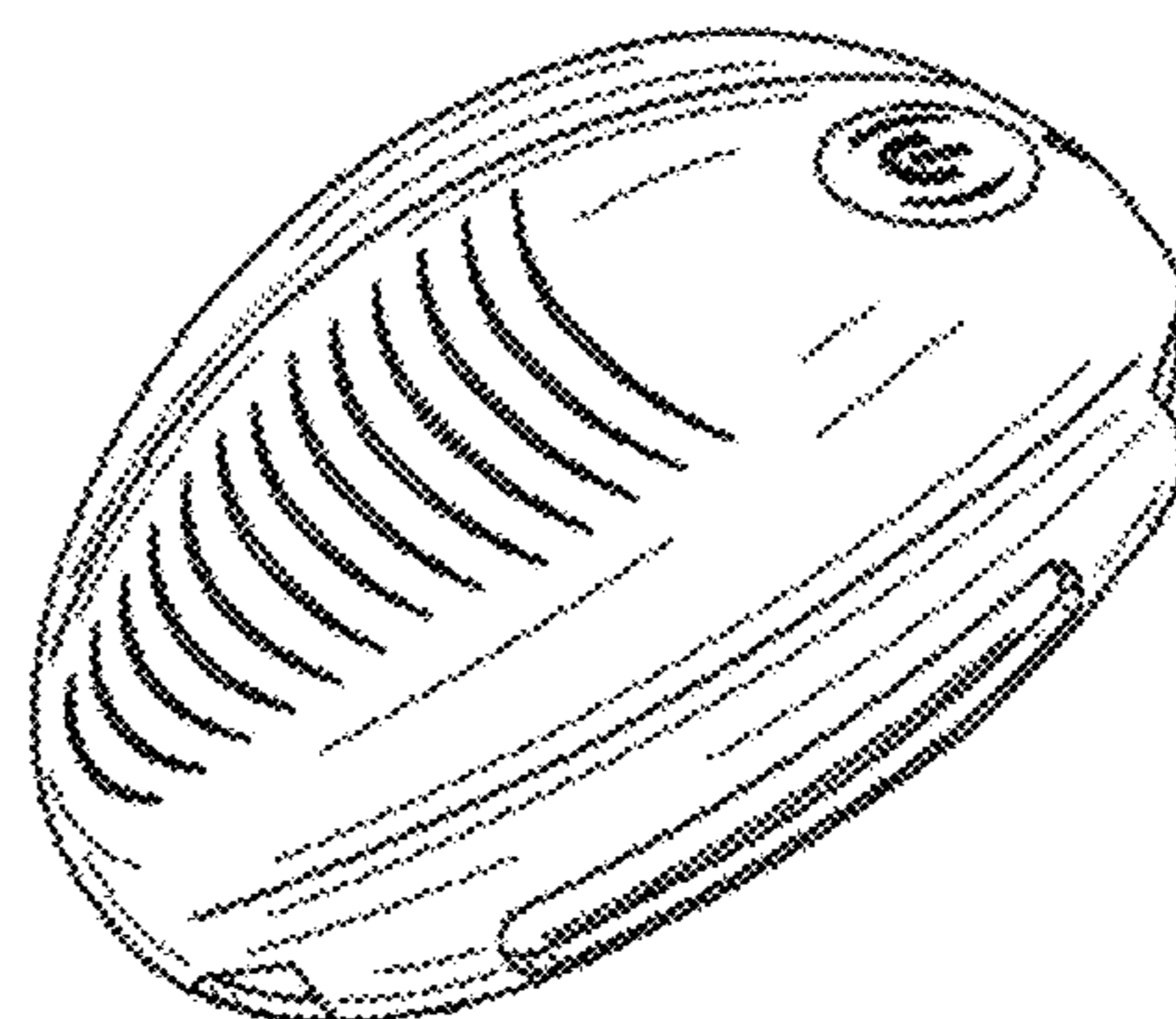

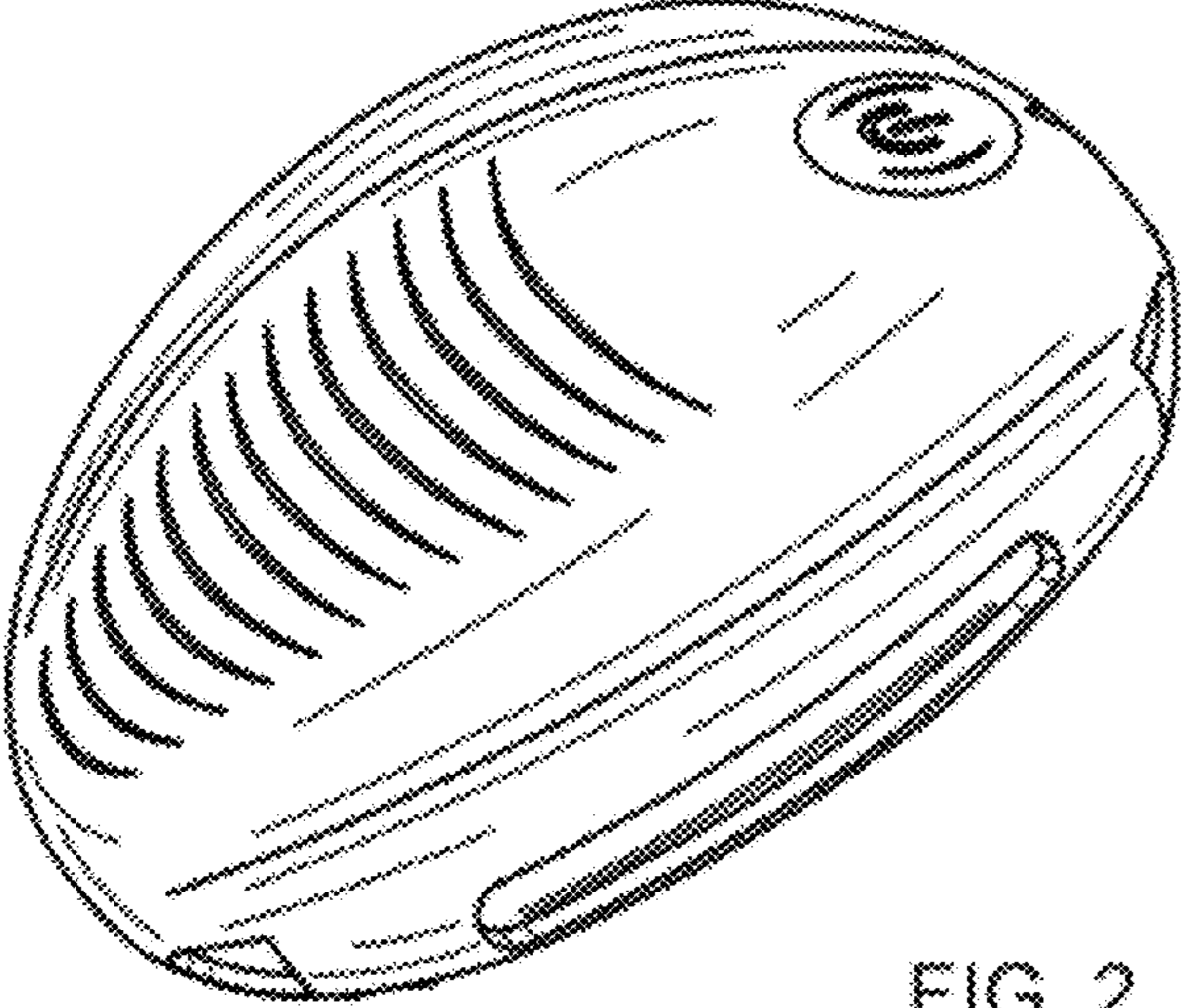

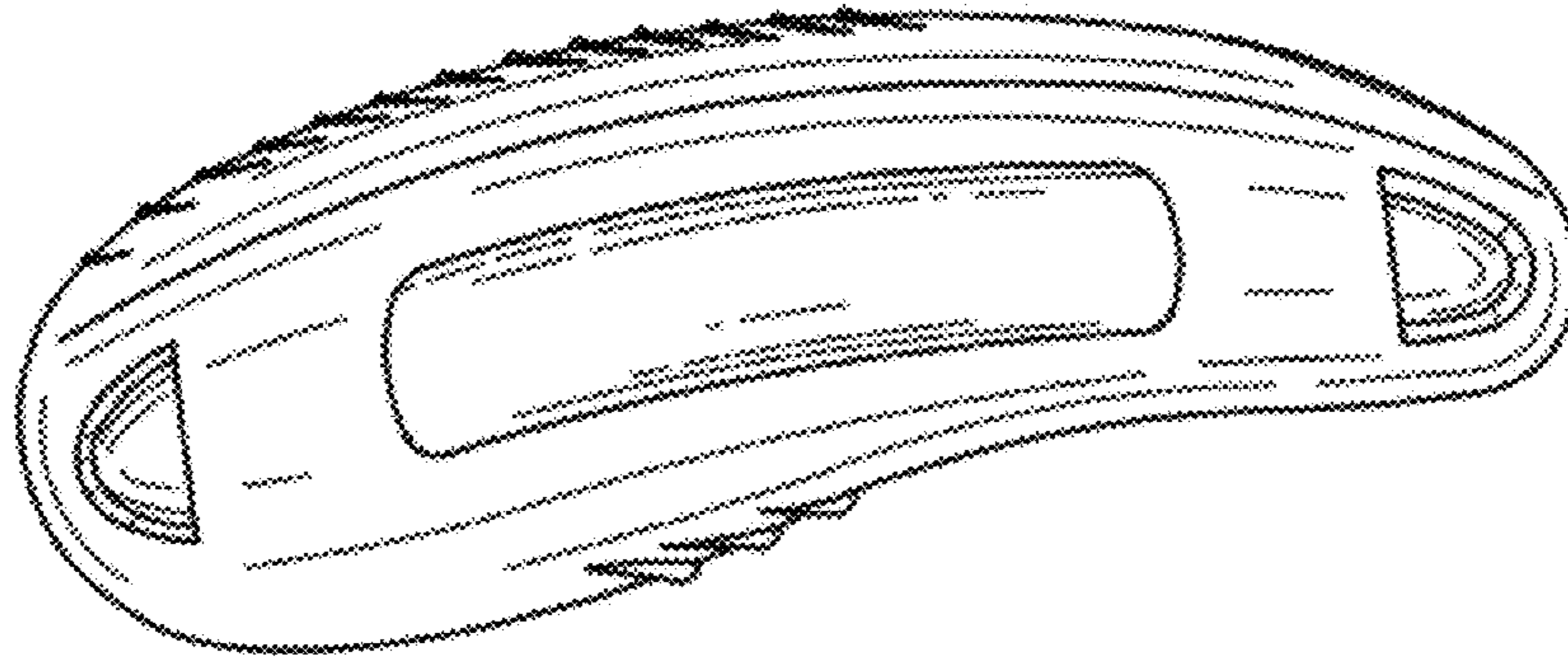

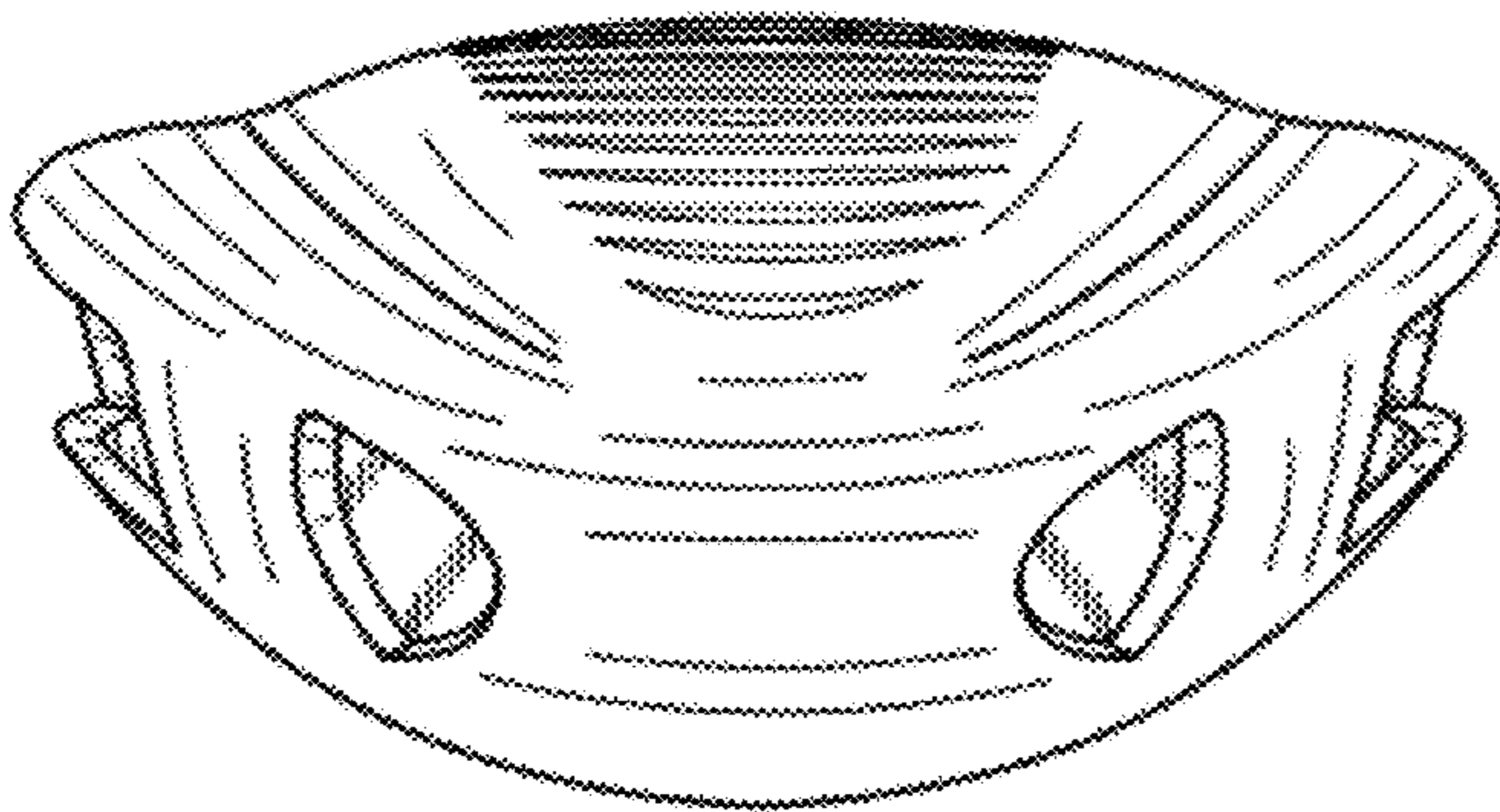

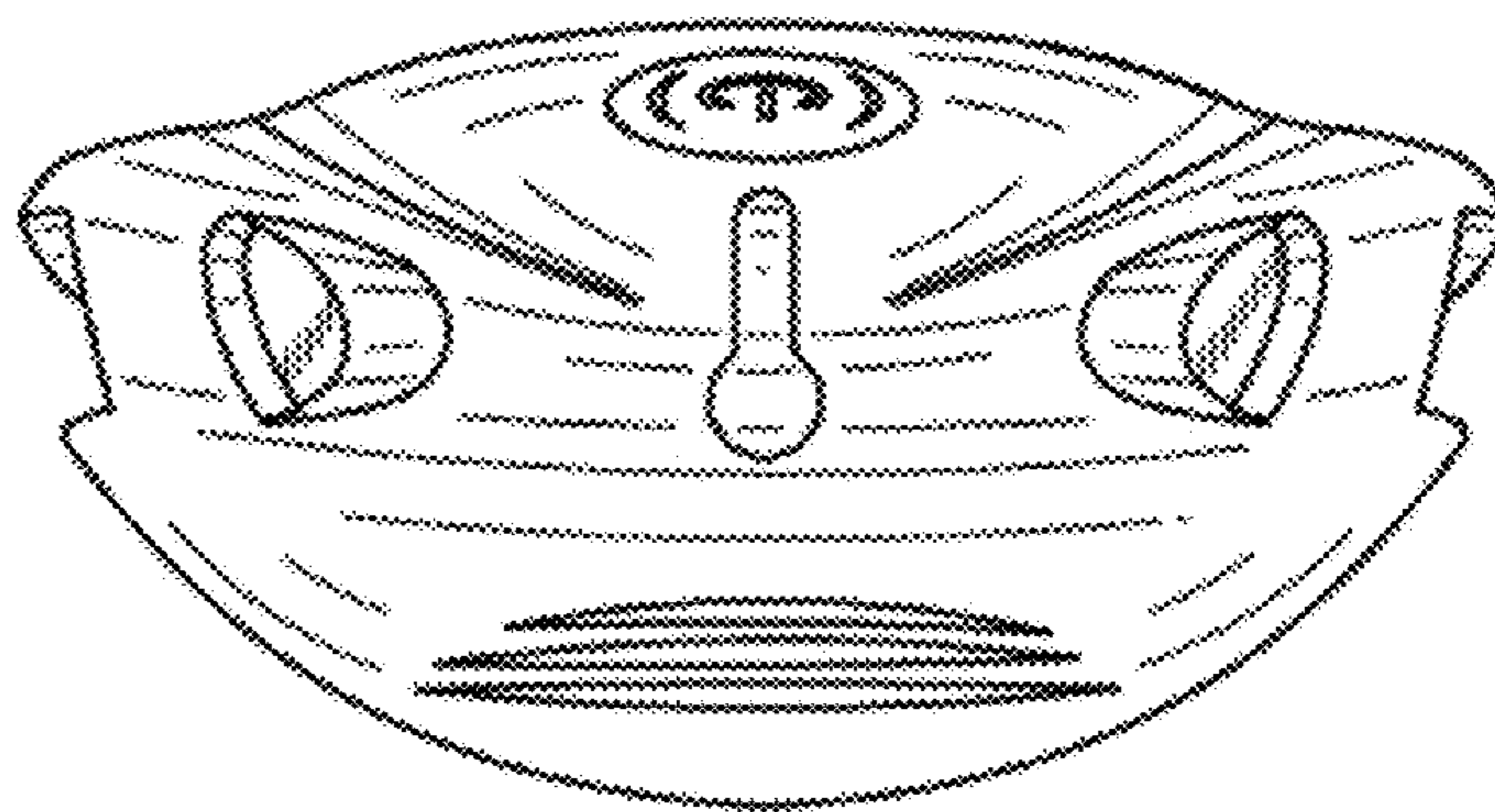

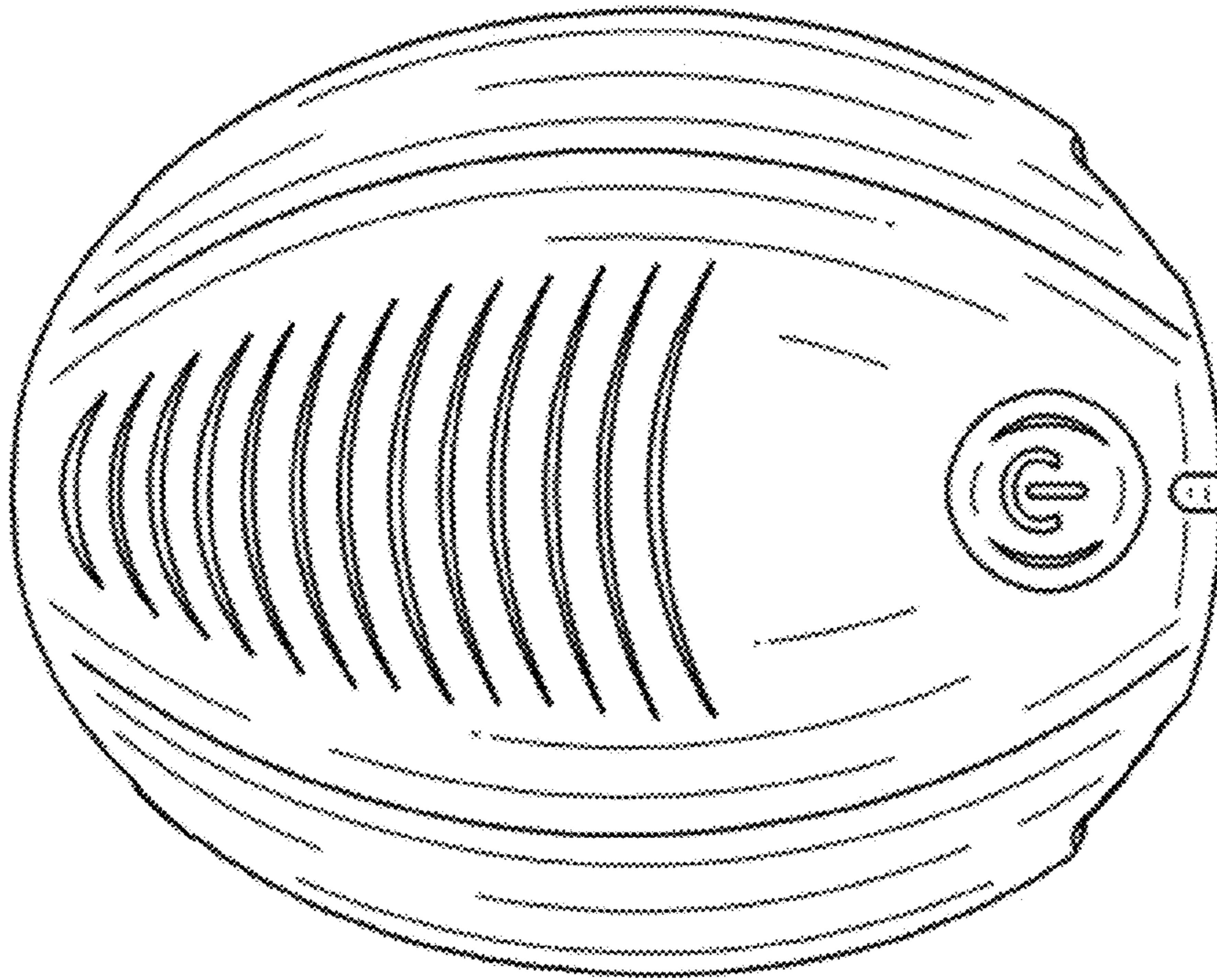

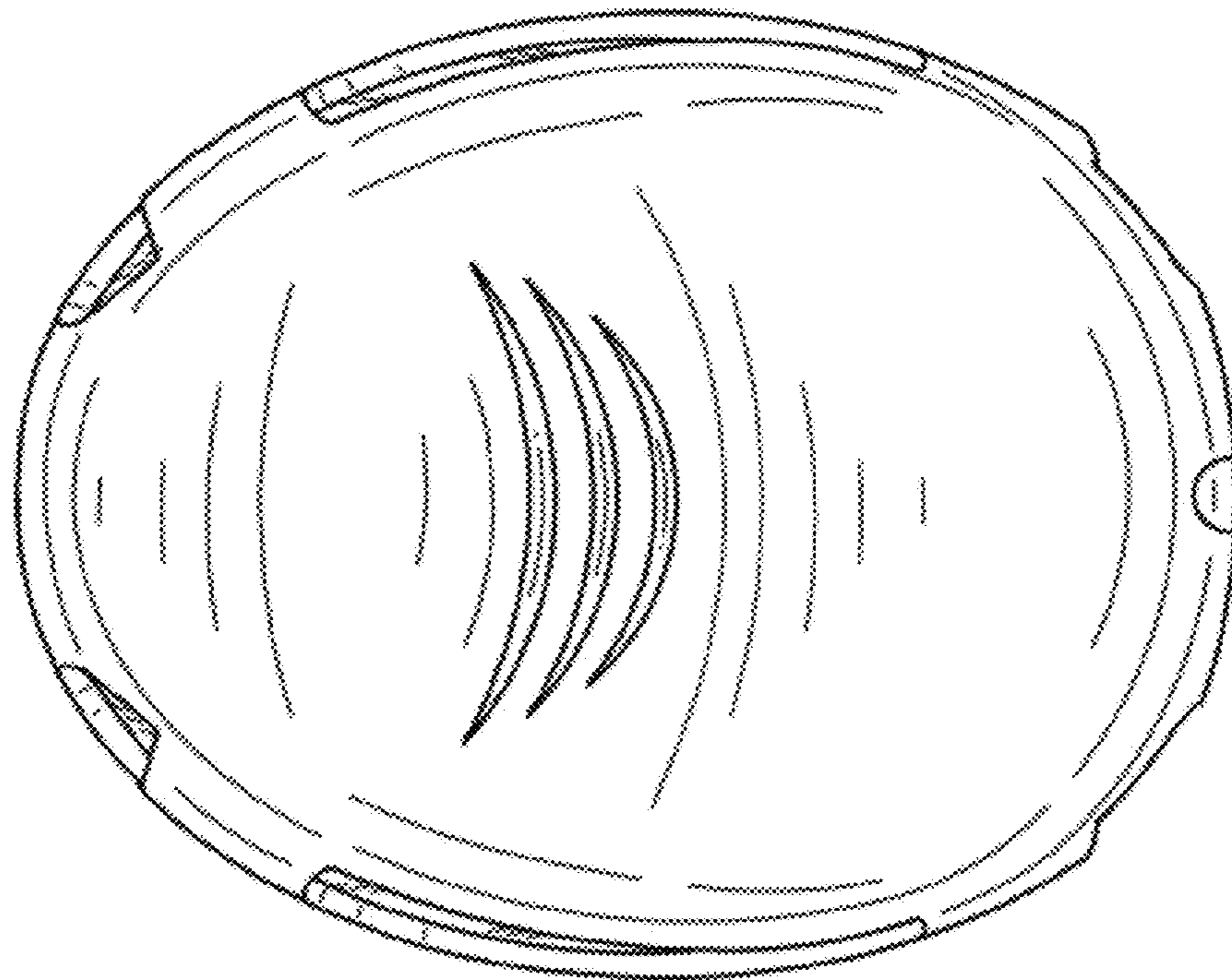
