(57) **CLAIM**

I claim the ornamental design for a paver, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a paver according to a first embodiment showing my new design;

FIG. 2 is a top view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a right side view thereof;

FIG. 5 is a rear side view thereof;

FIG. 6 is a left view thereof;

FIG. 7 is a top view thereof with other paver units shown in broken lines;

FIG. 11 is a right side view thereof;

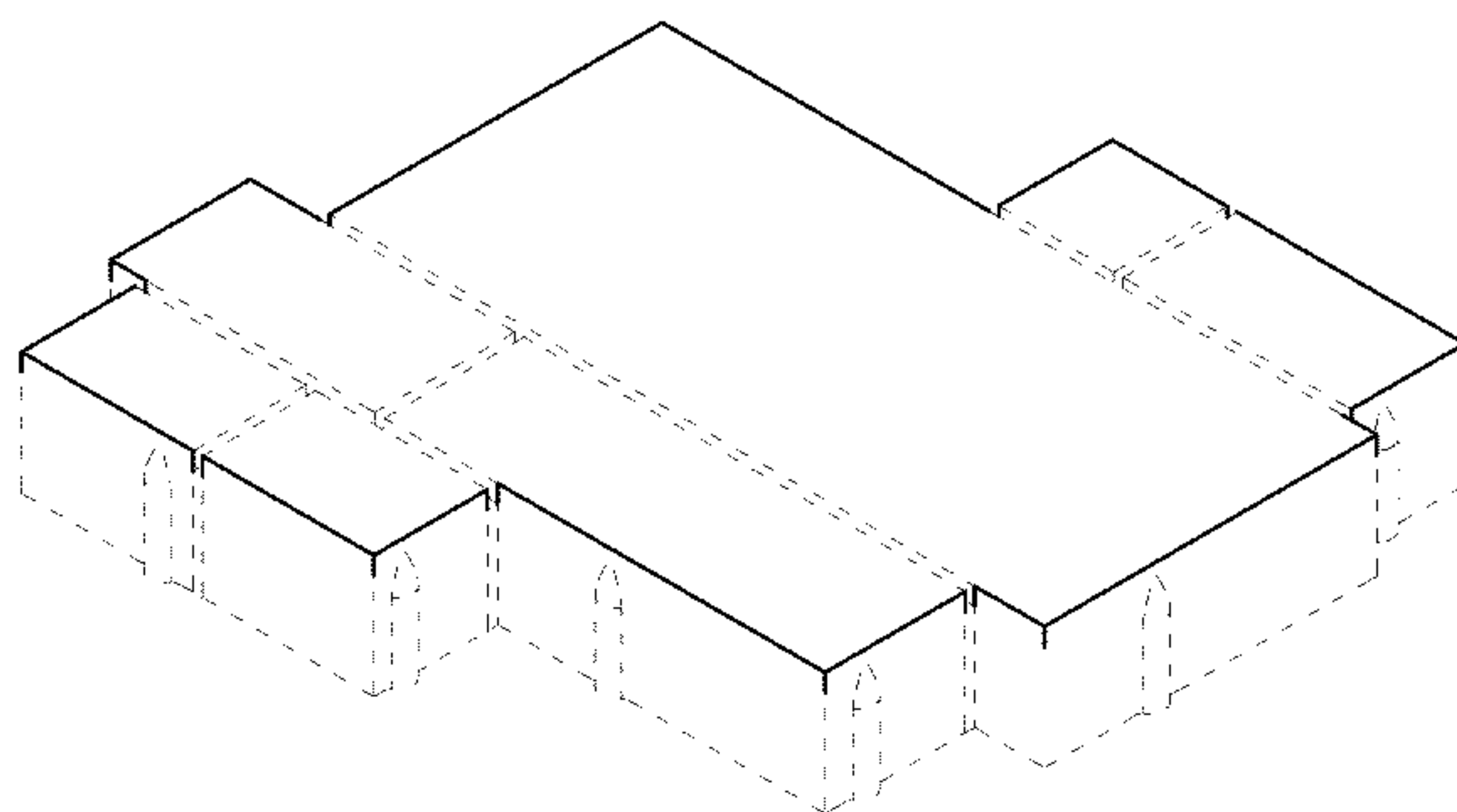
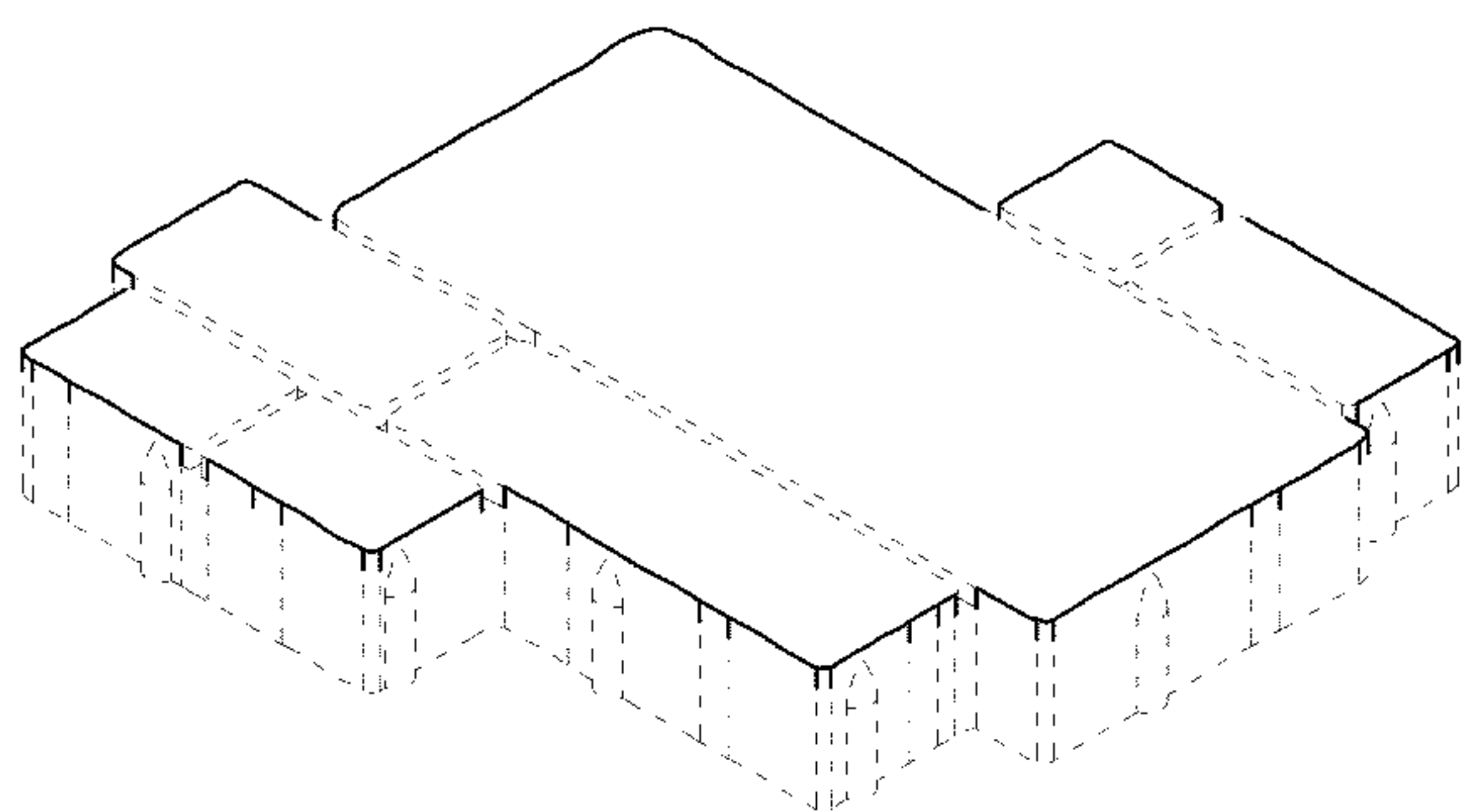
FIG. 12 is a rear side view thereof;

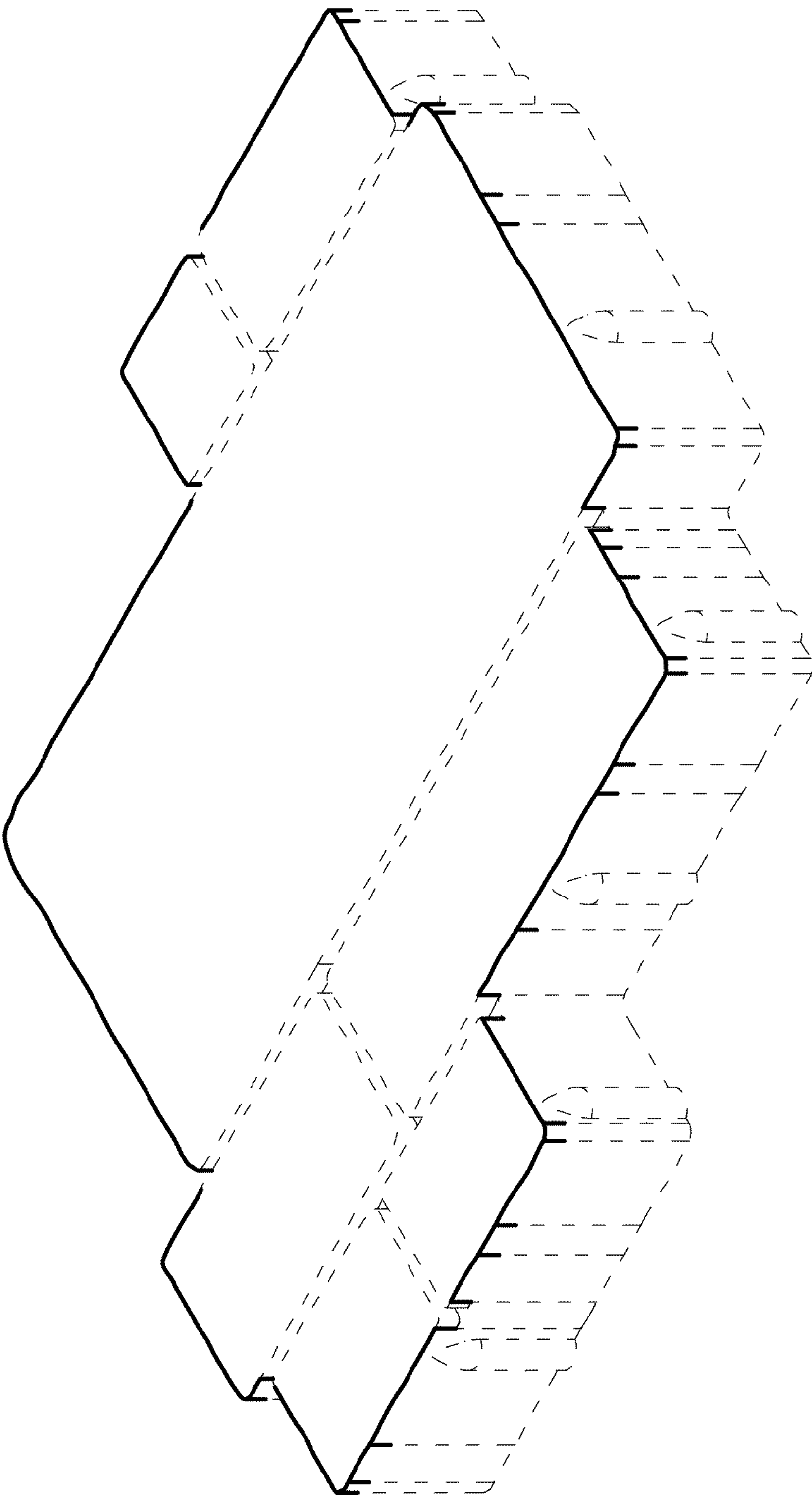

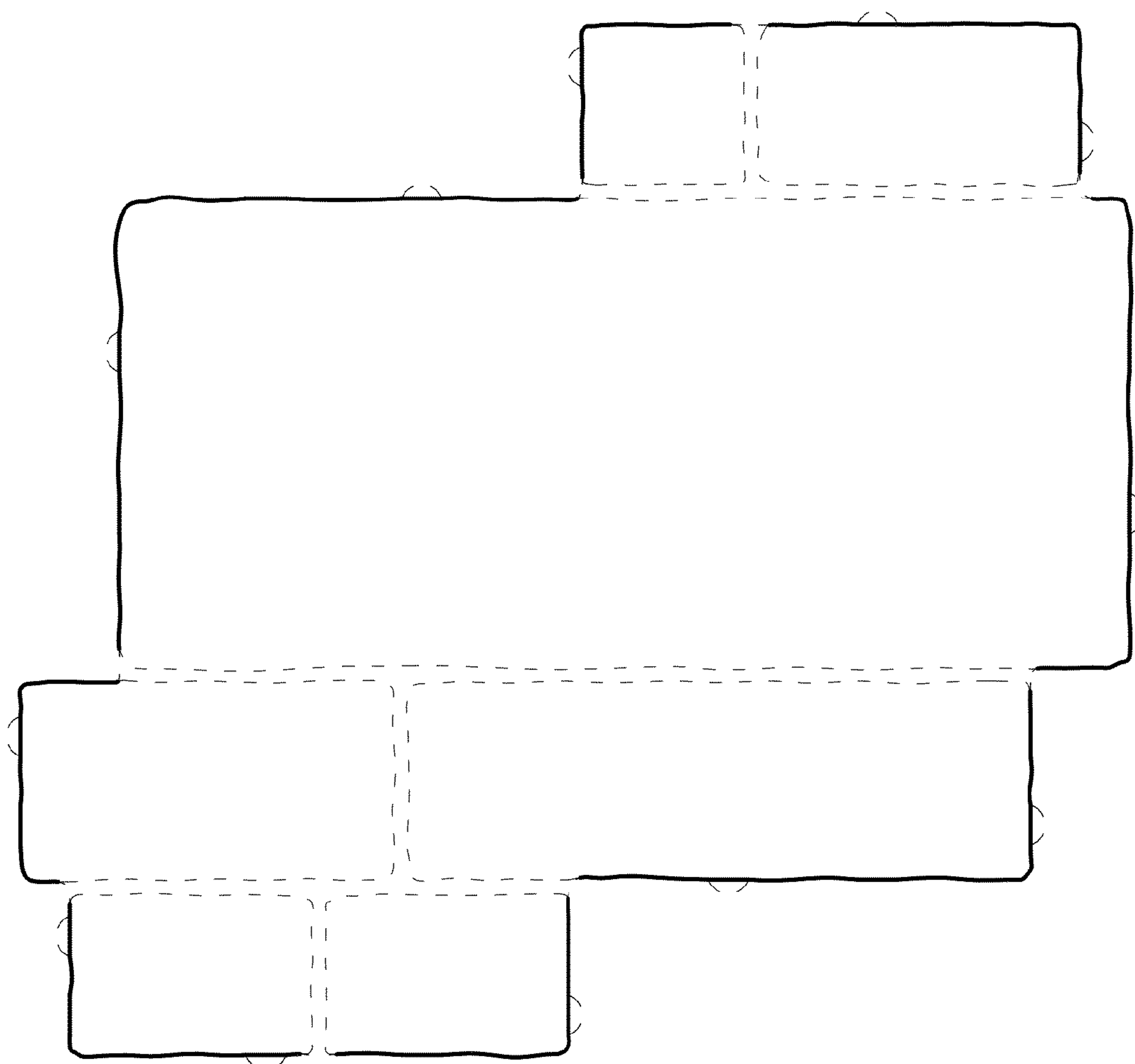

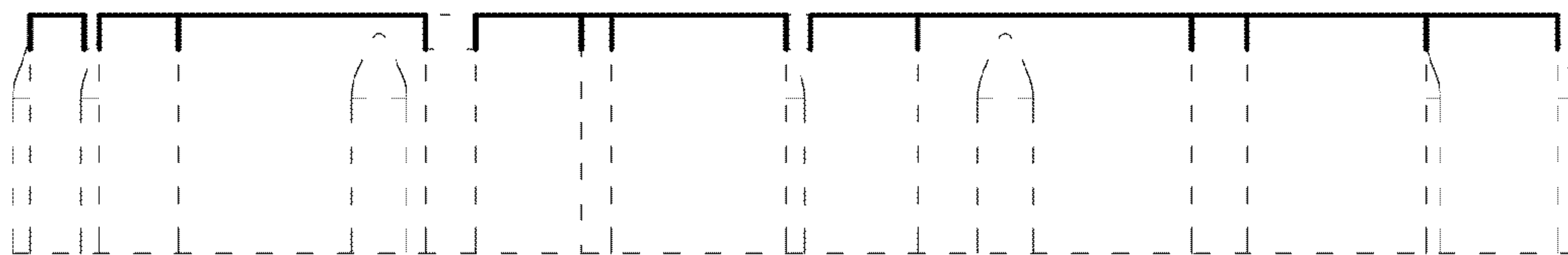

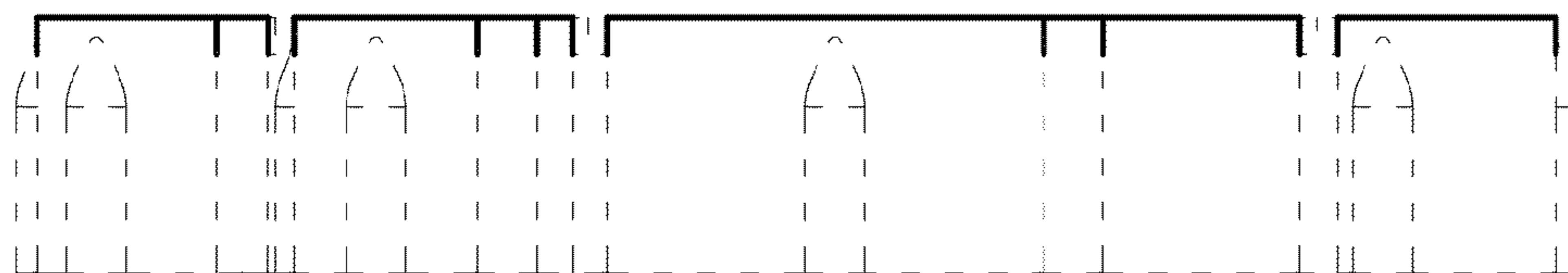

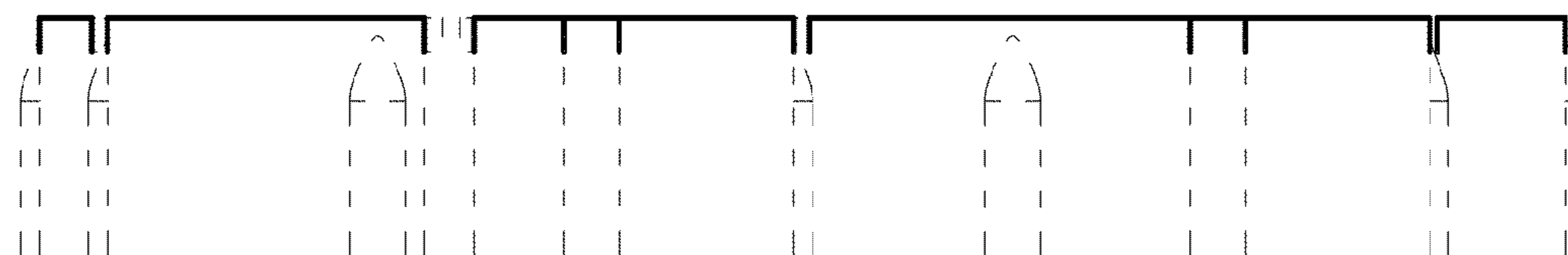

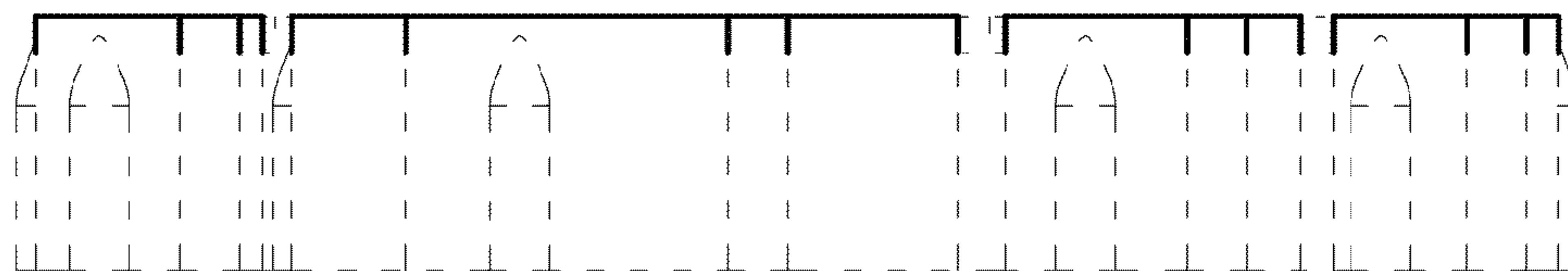

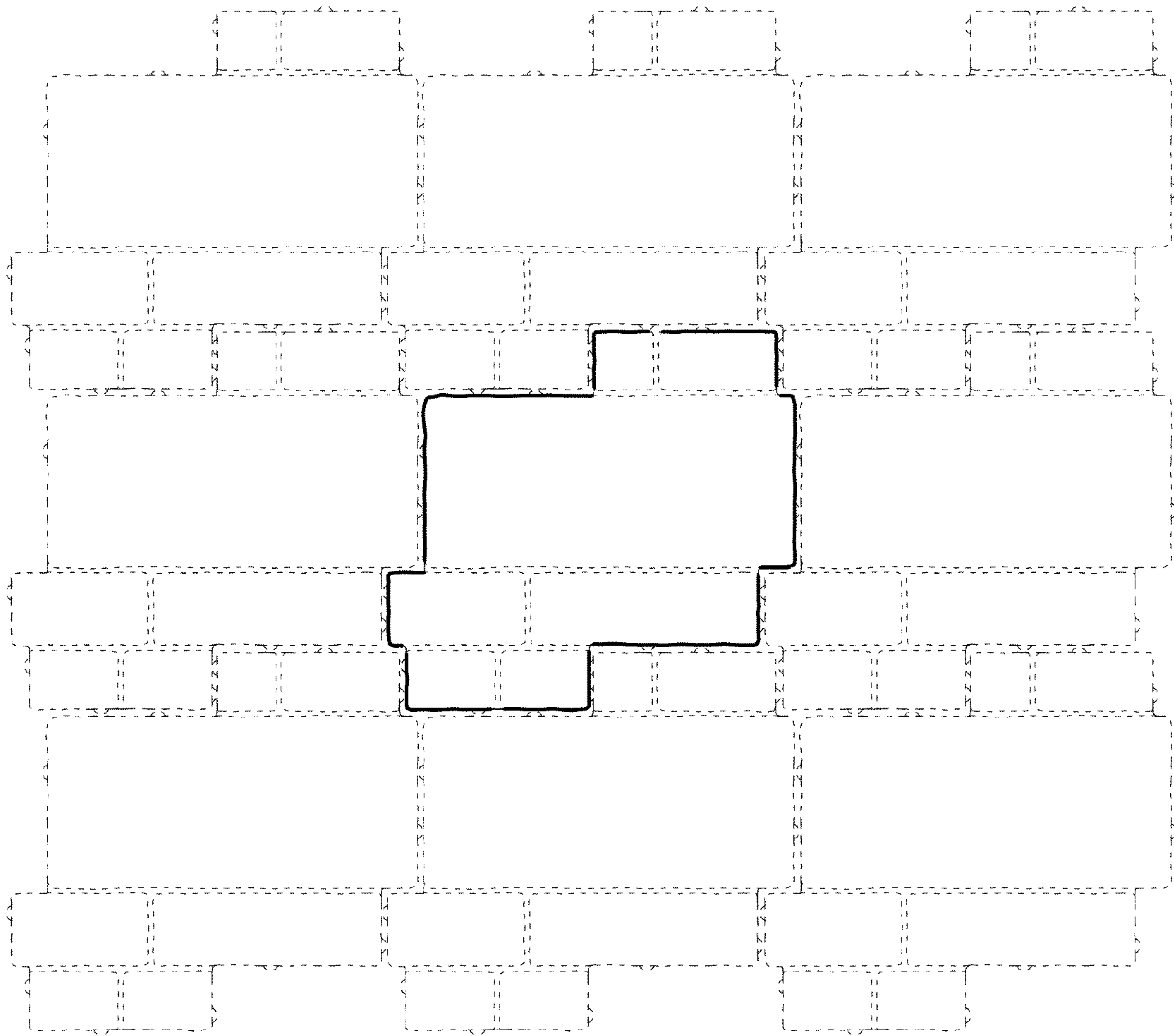

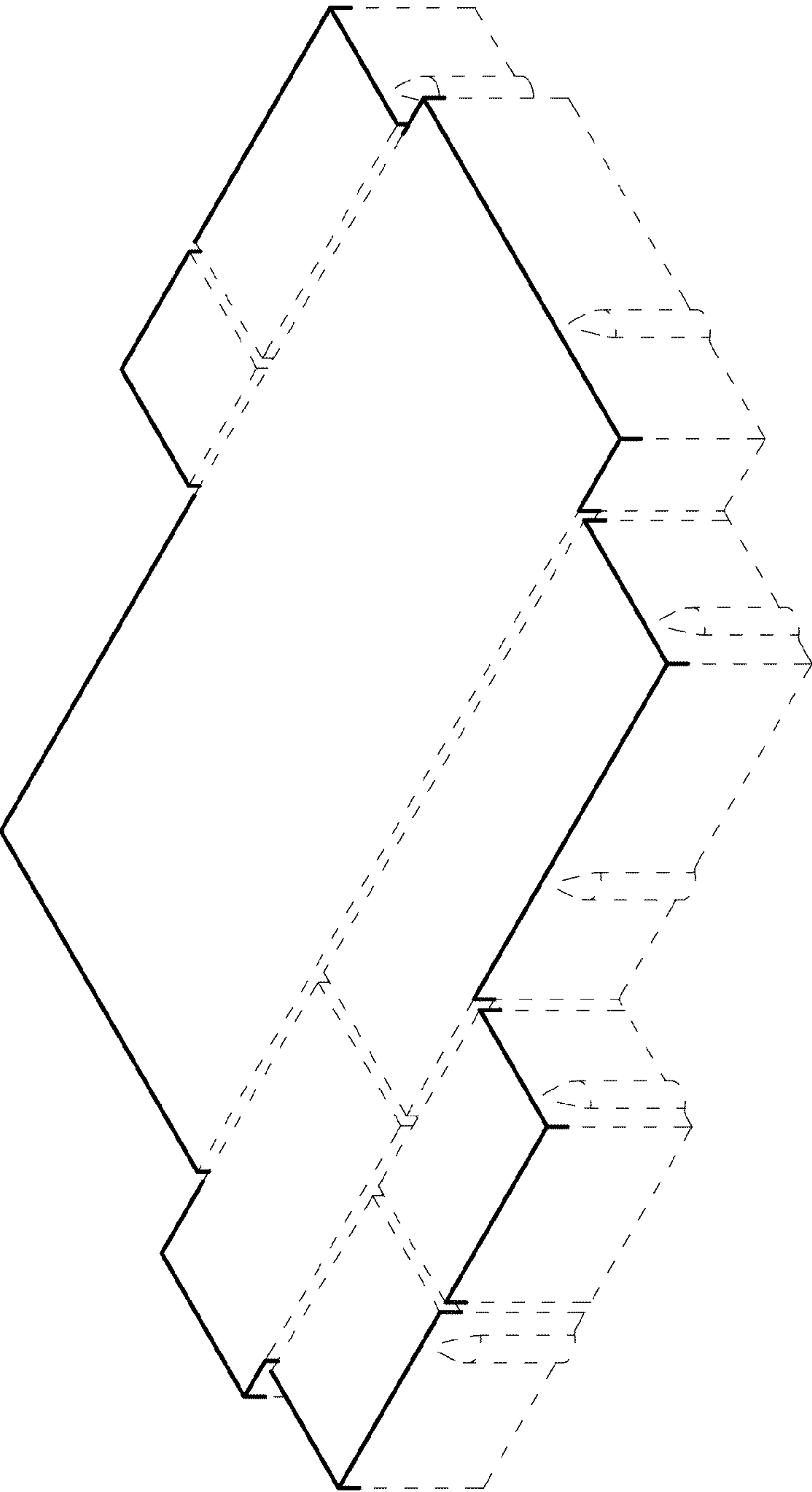

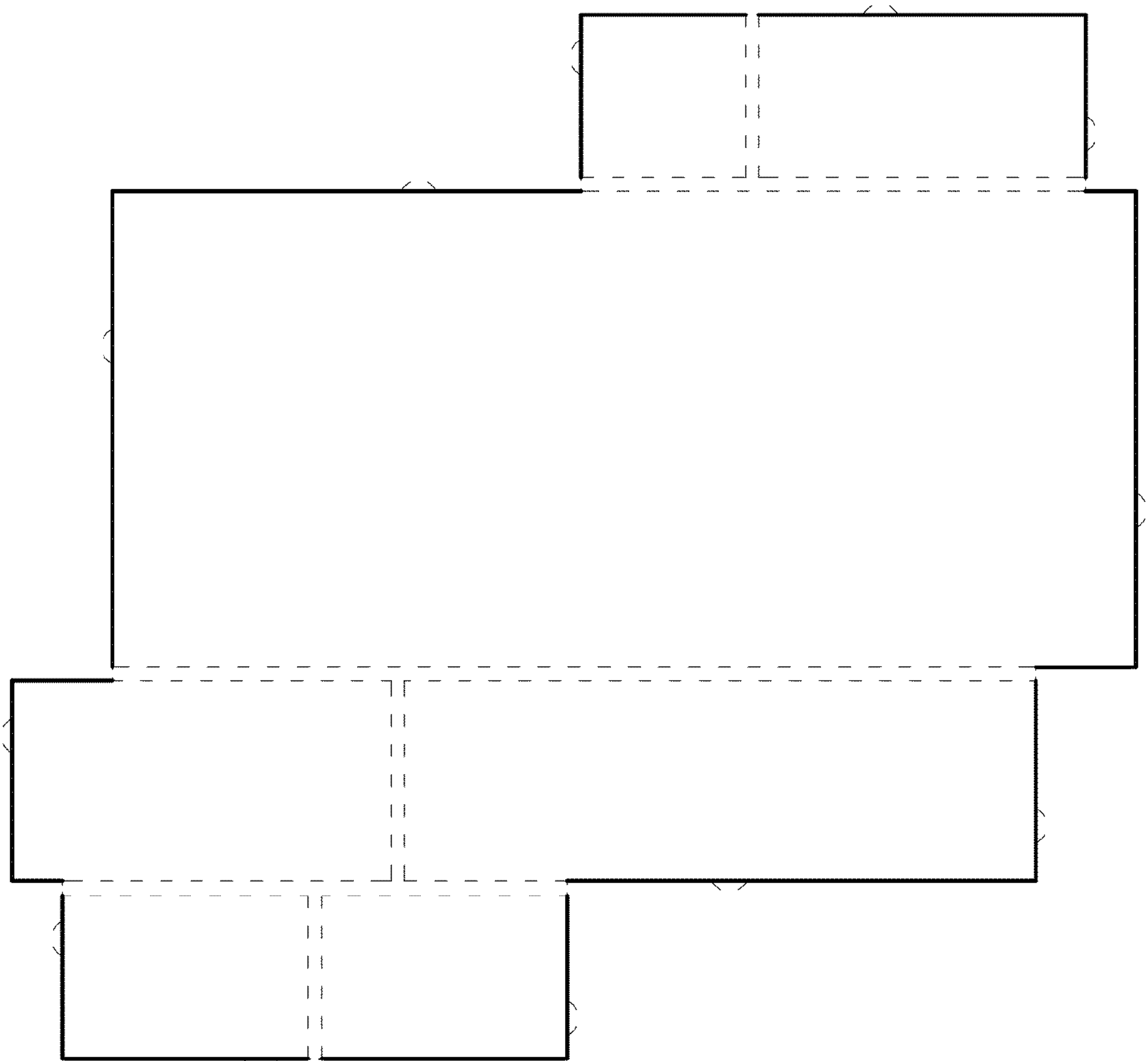

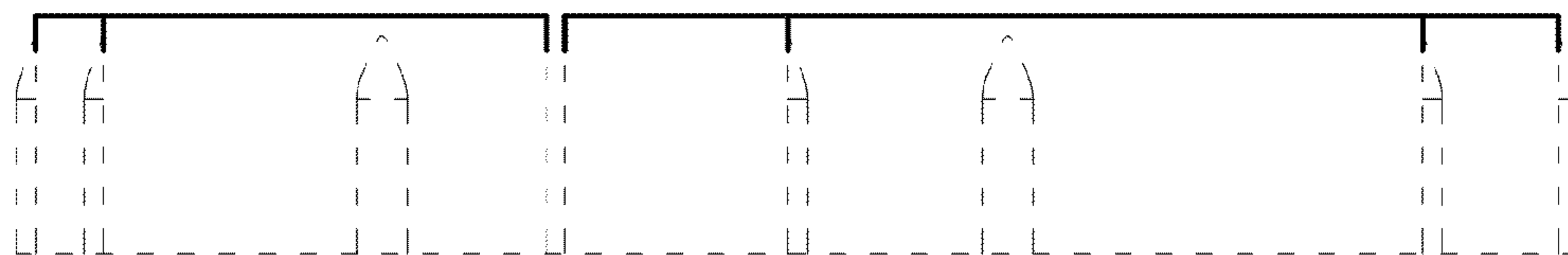

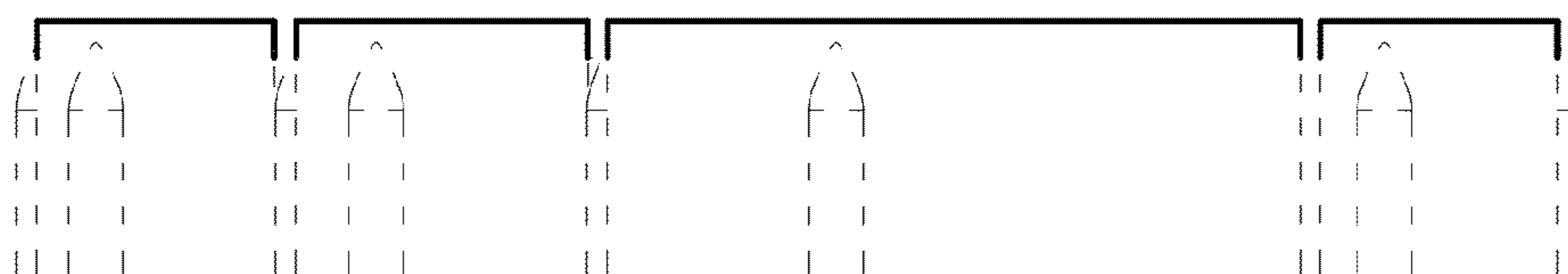

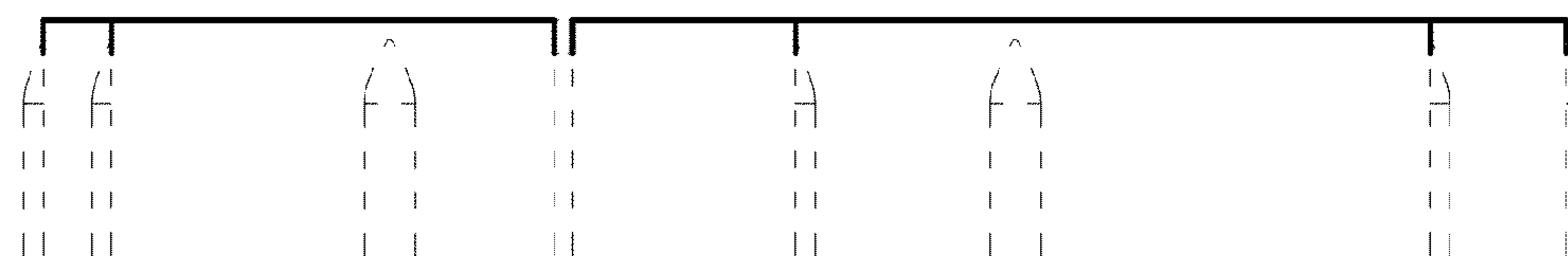

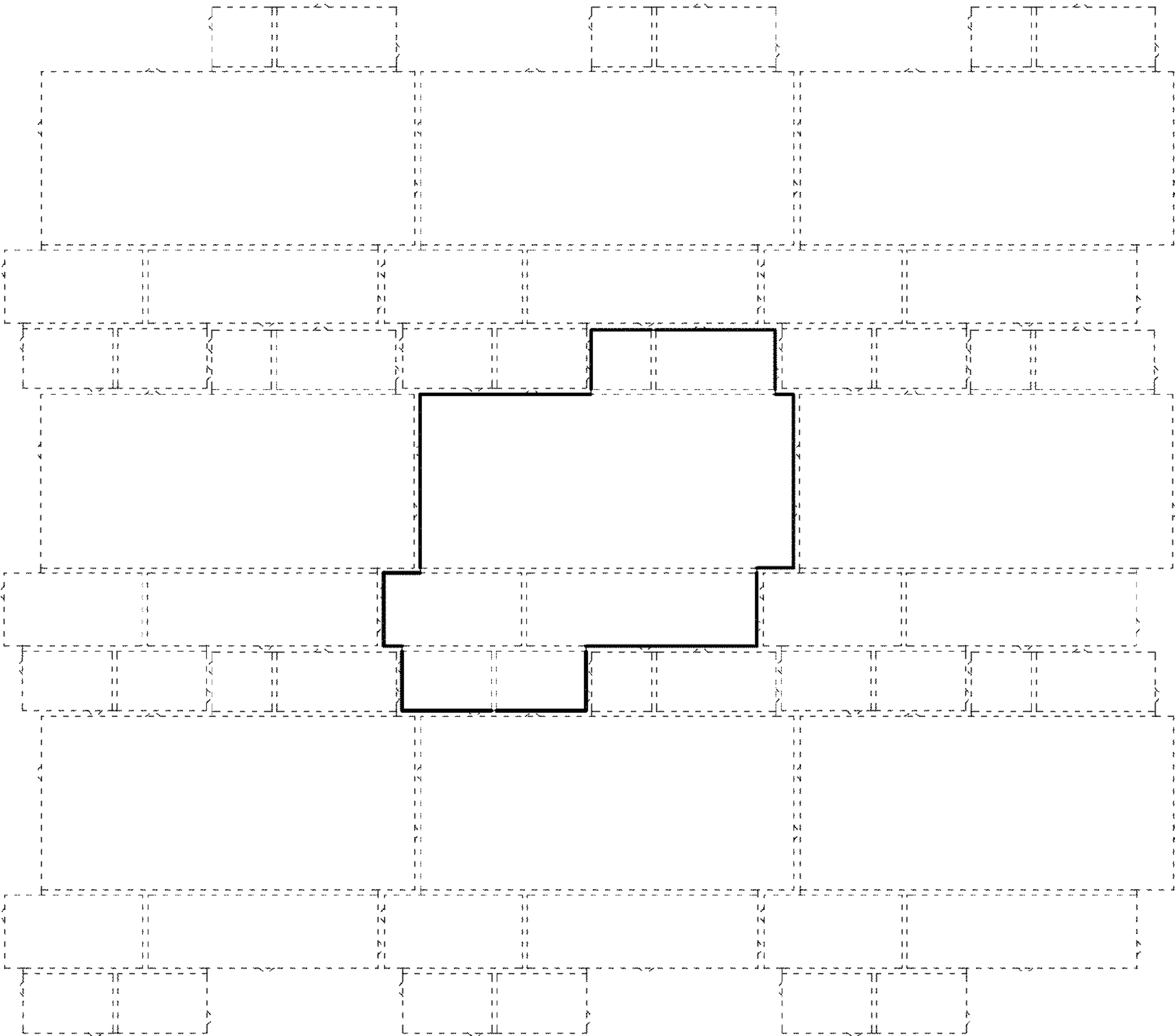
