DESCRIPTION

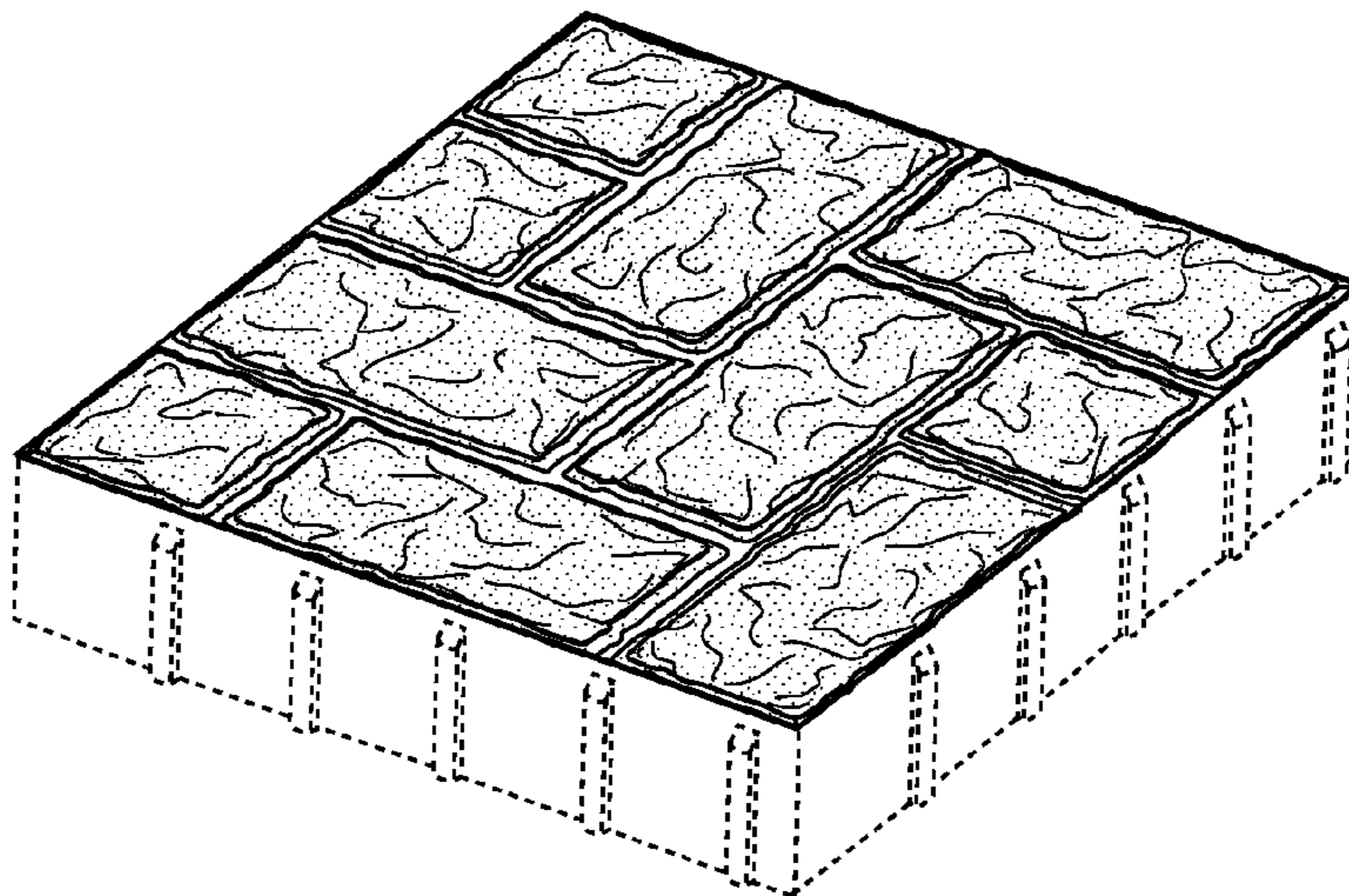
FIG. 1 is a front perspective view of a landscaping block; FIG. 2 is a rear elevational view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a left side elevational view thereof; and, FIG. 7 is a right side elevational view thereof. The broken lines in the drawing views are included for the purpose of illustrating portions of the landscaping block that form no part of the claimed design.

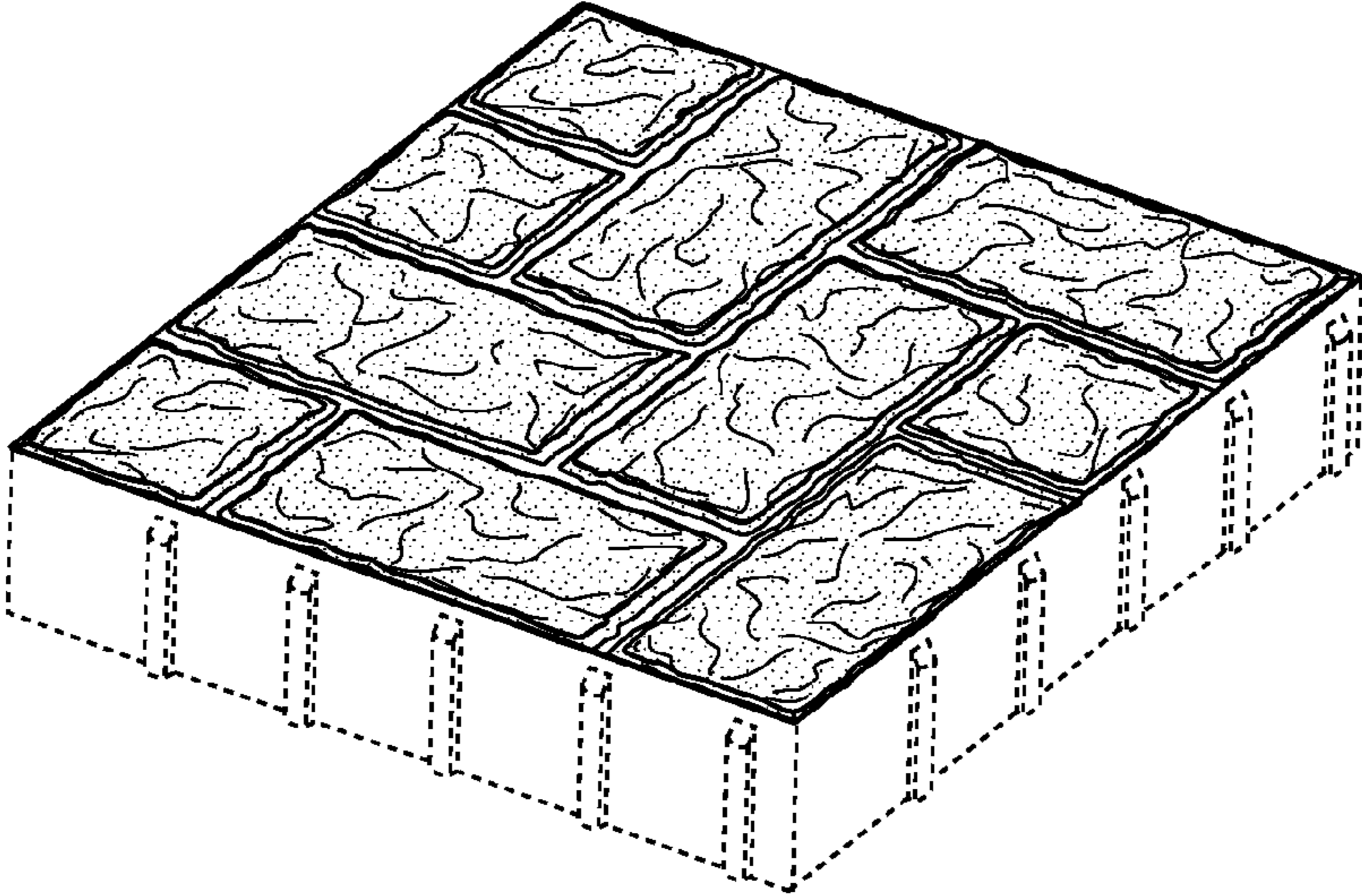

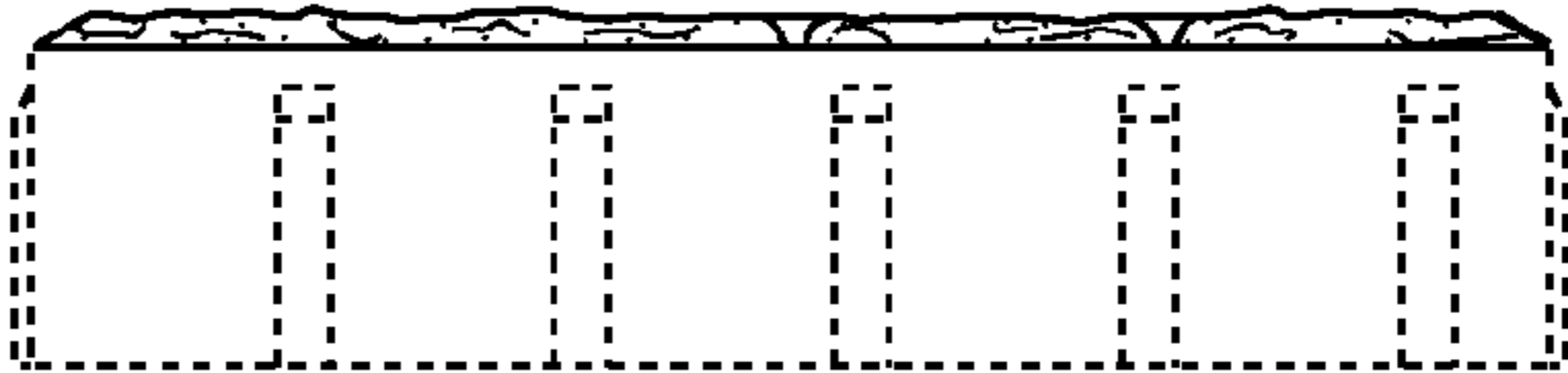

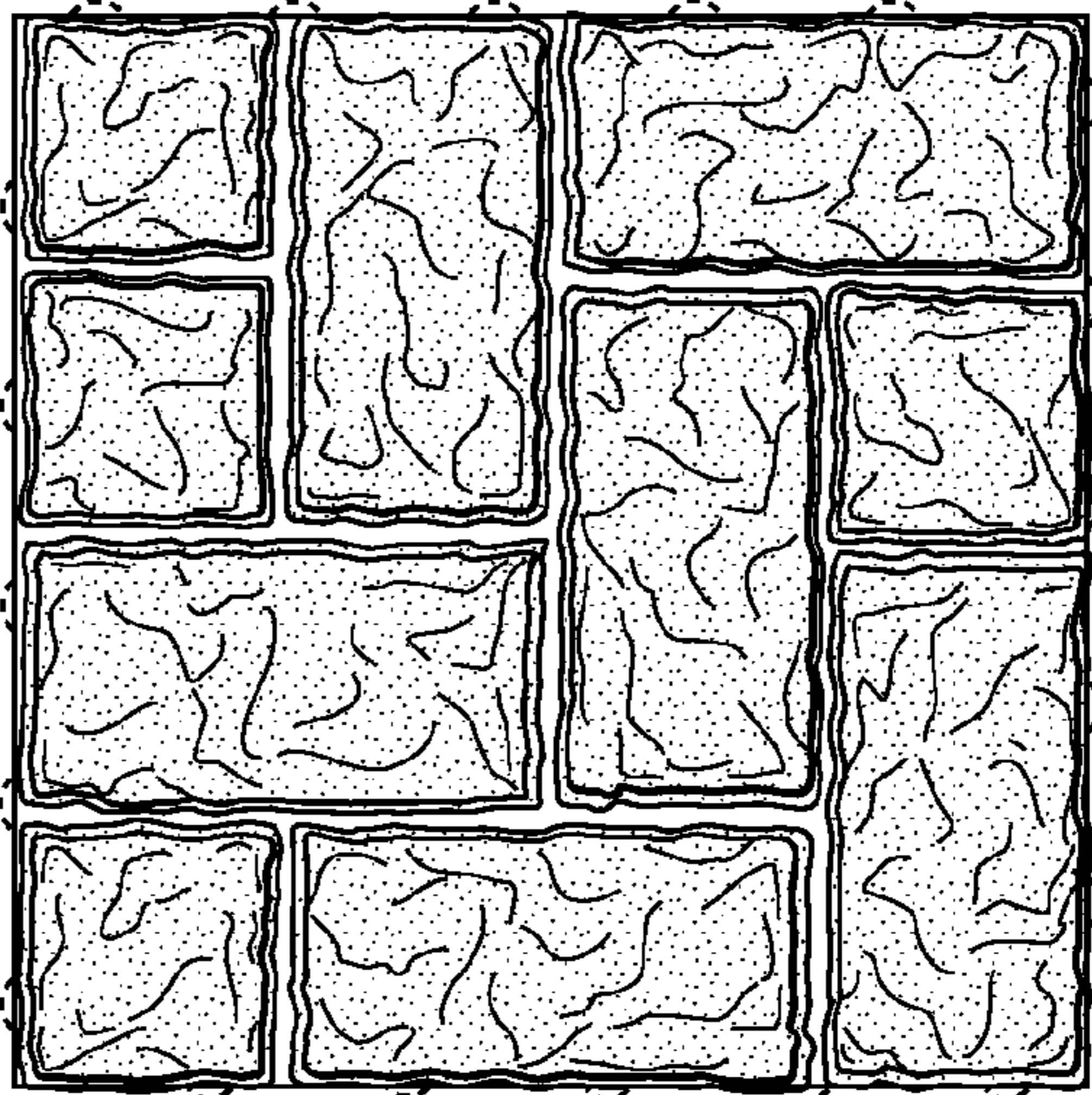

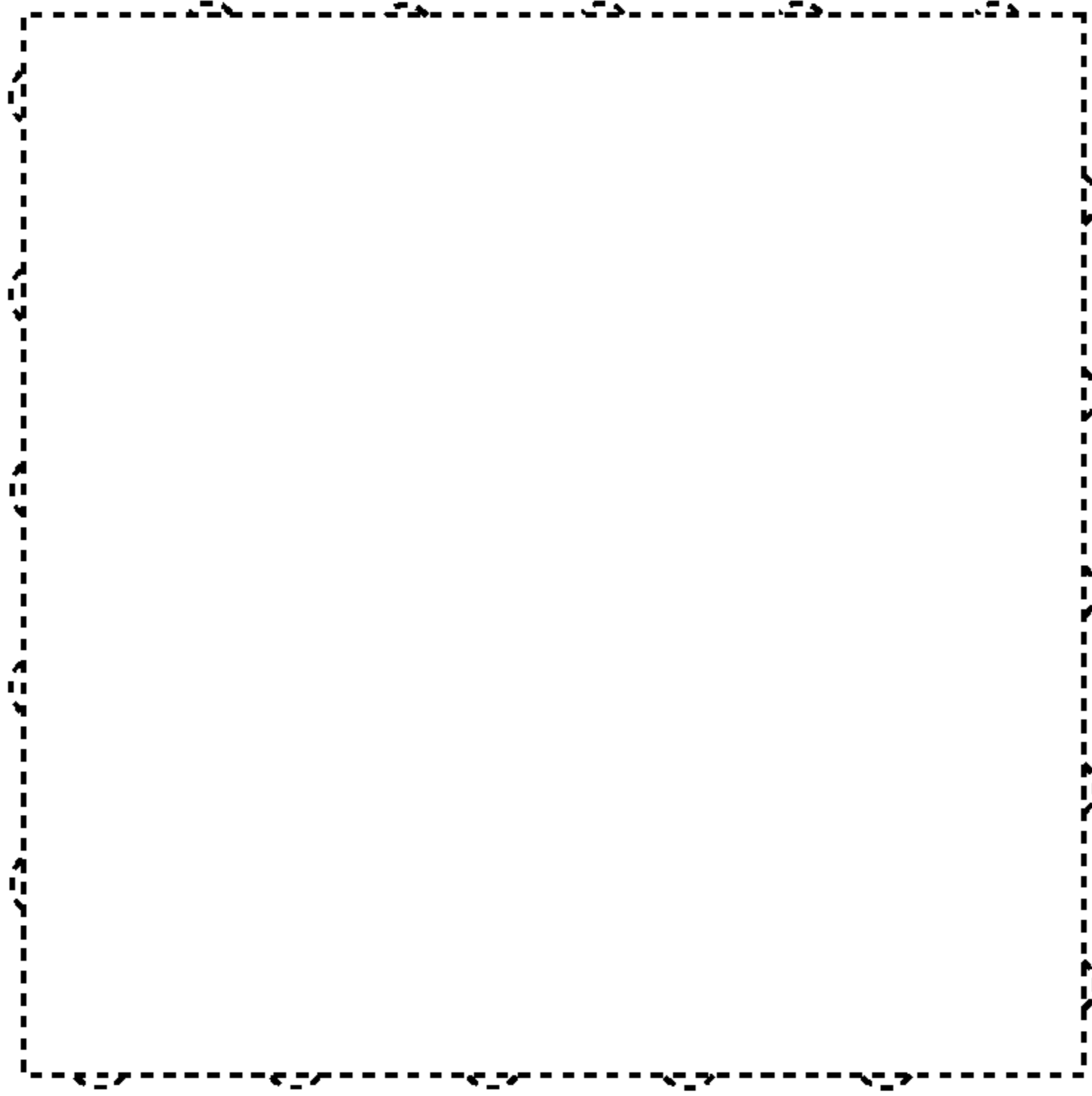

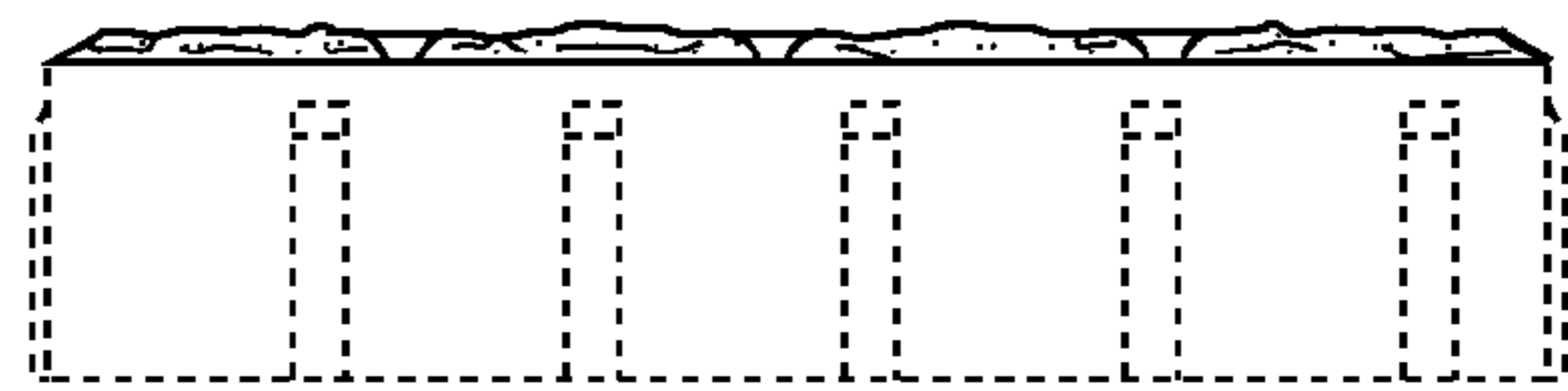

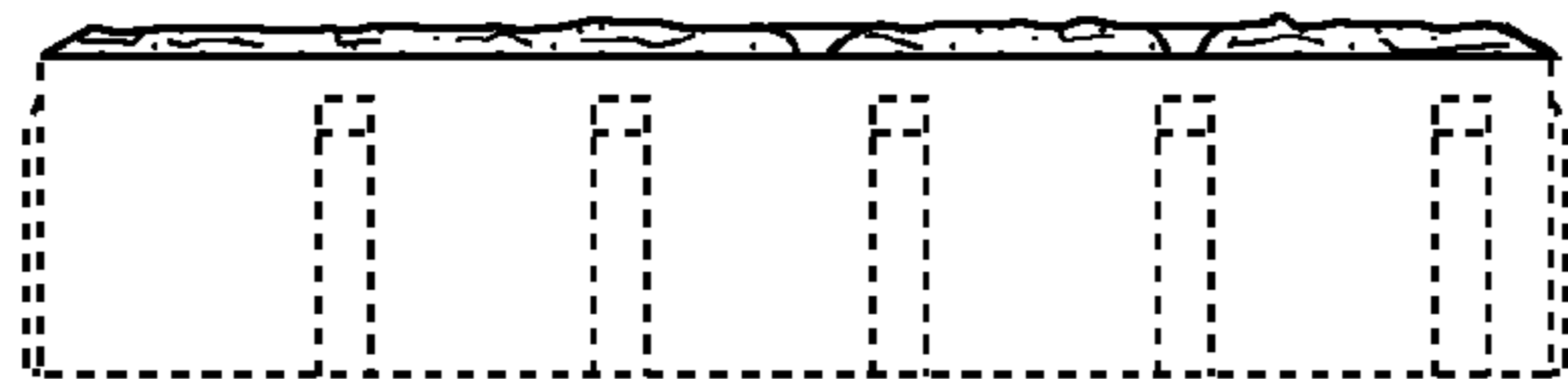
