**DESCRIPTION**

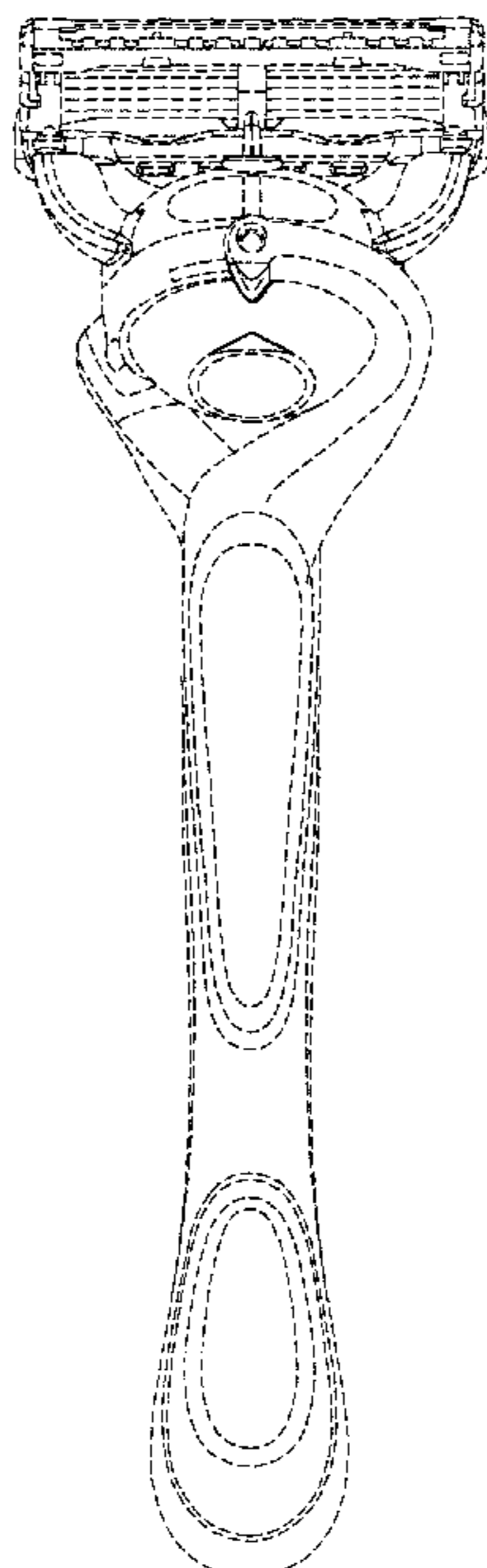
FIG. 1 is a perspective view of a portion of a shaving razor of the present invention;

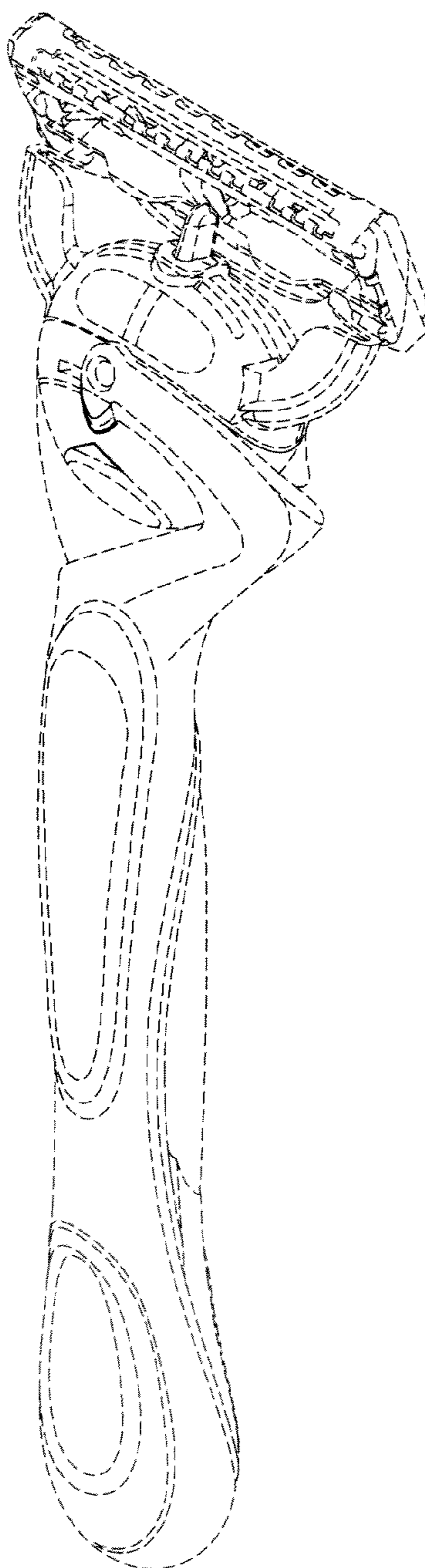

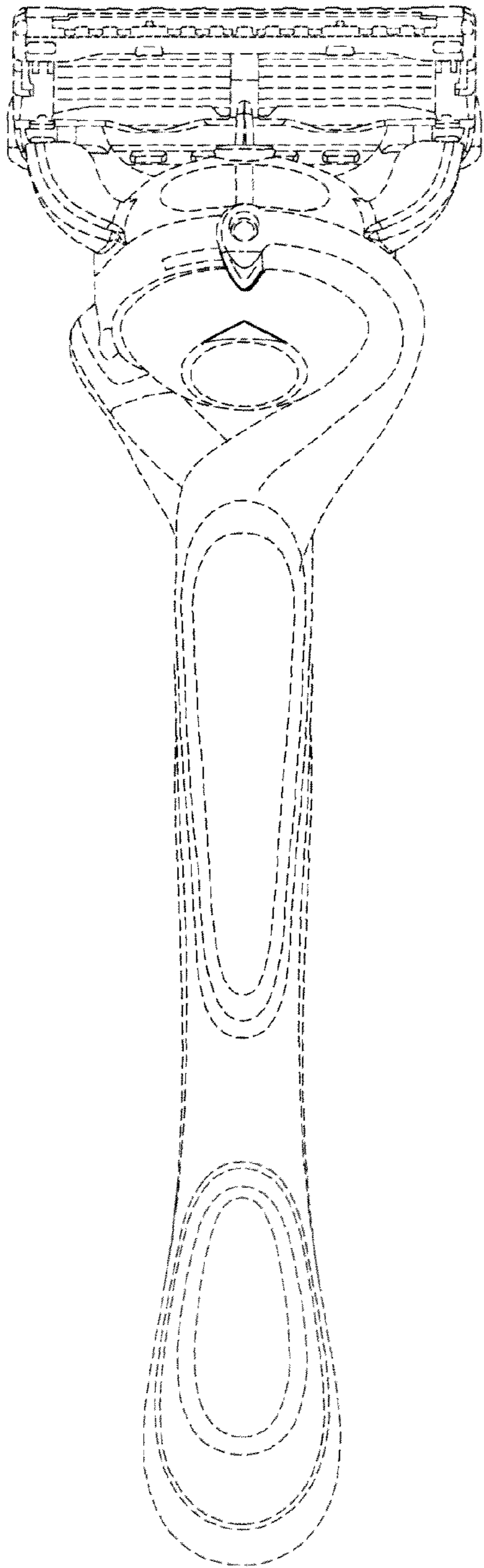

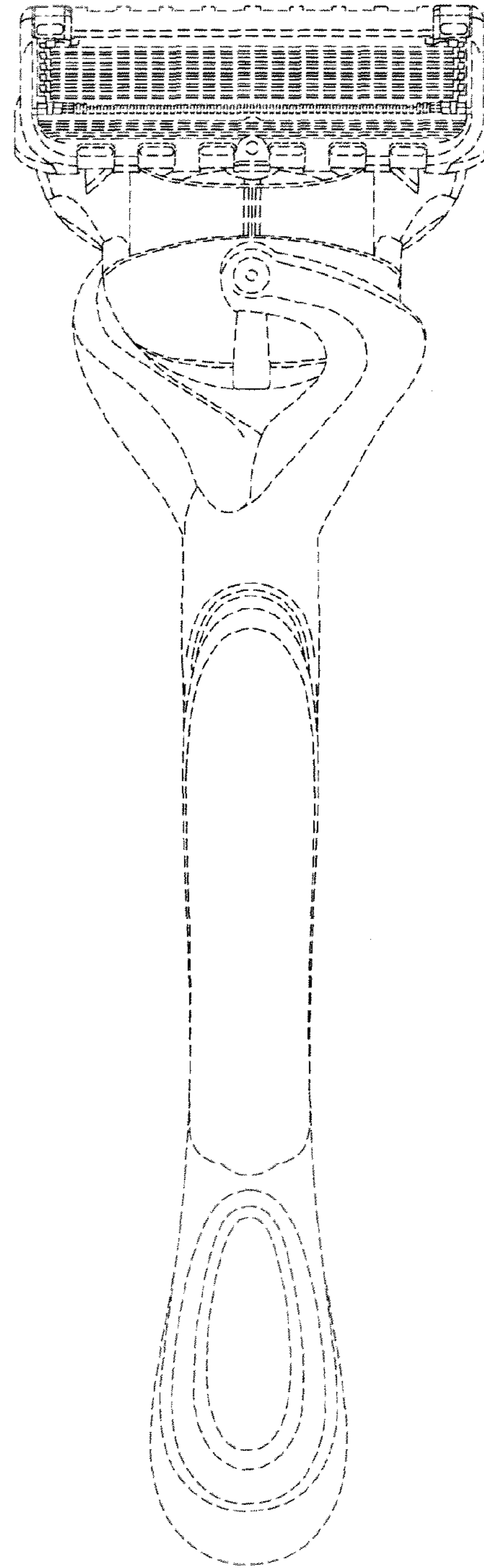

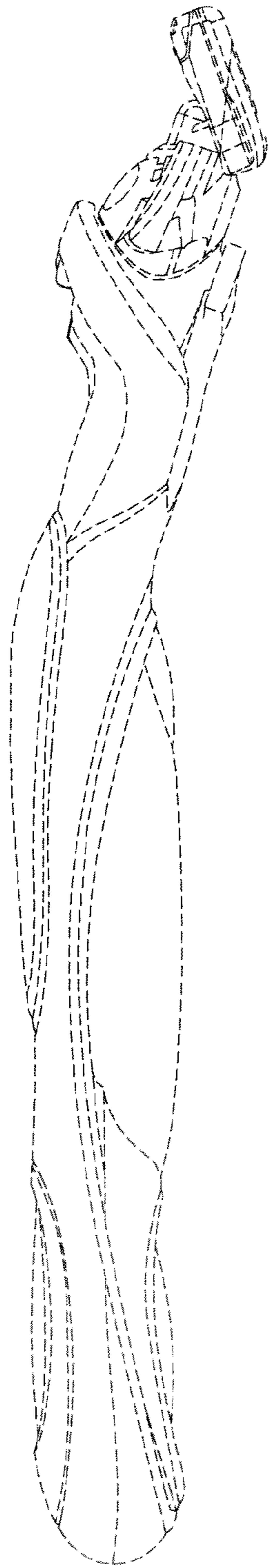

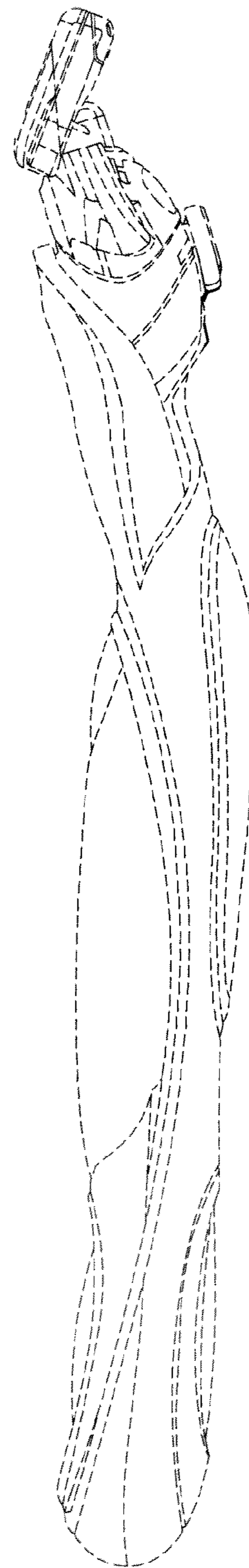

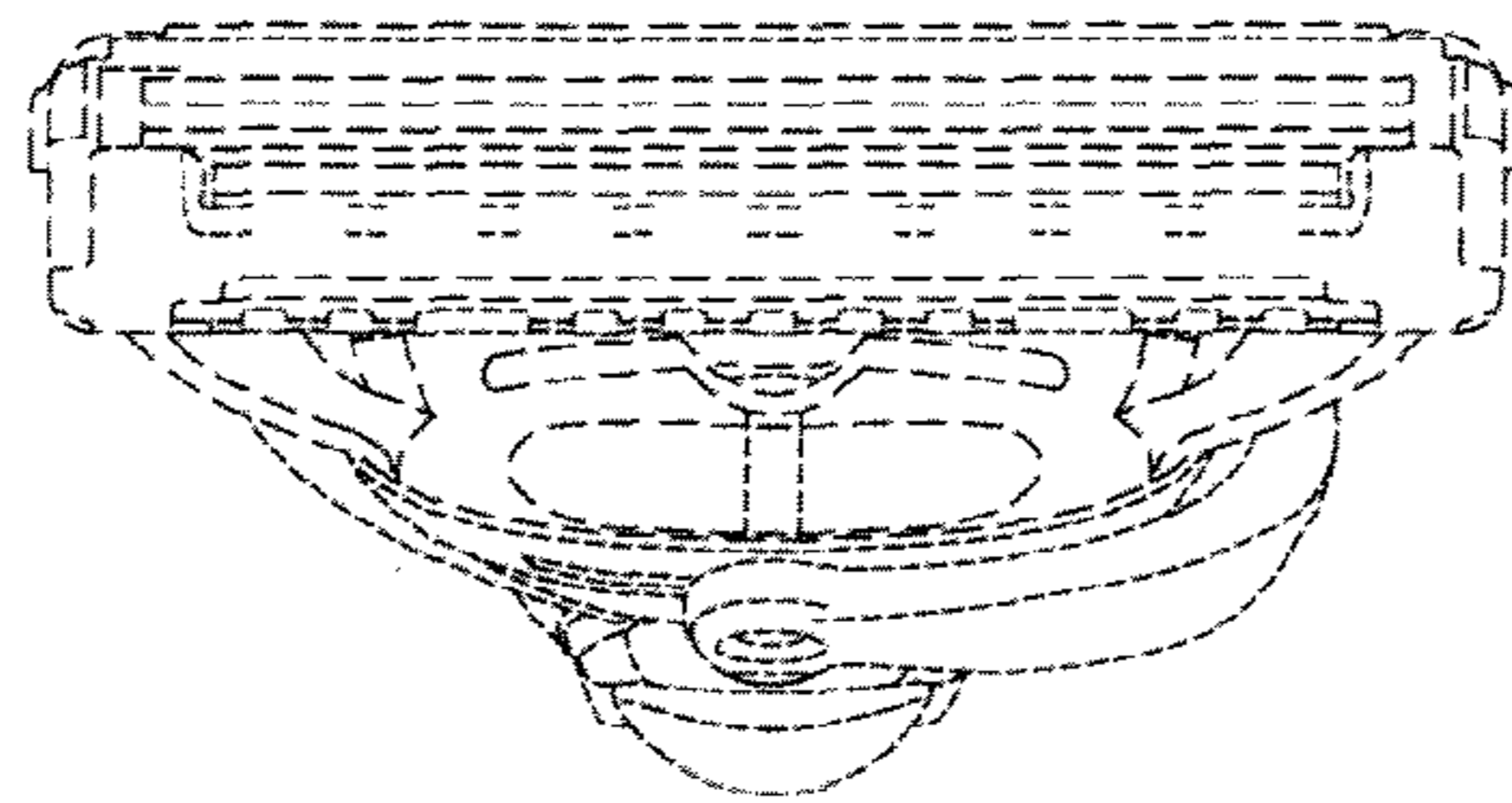

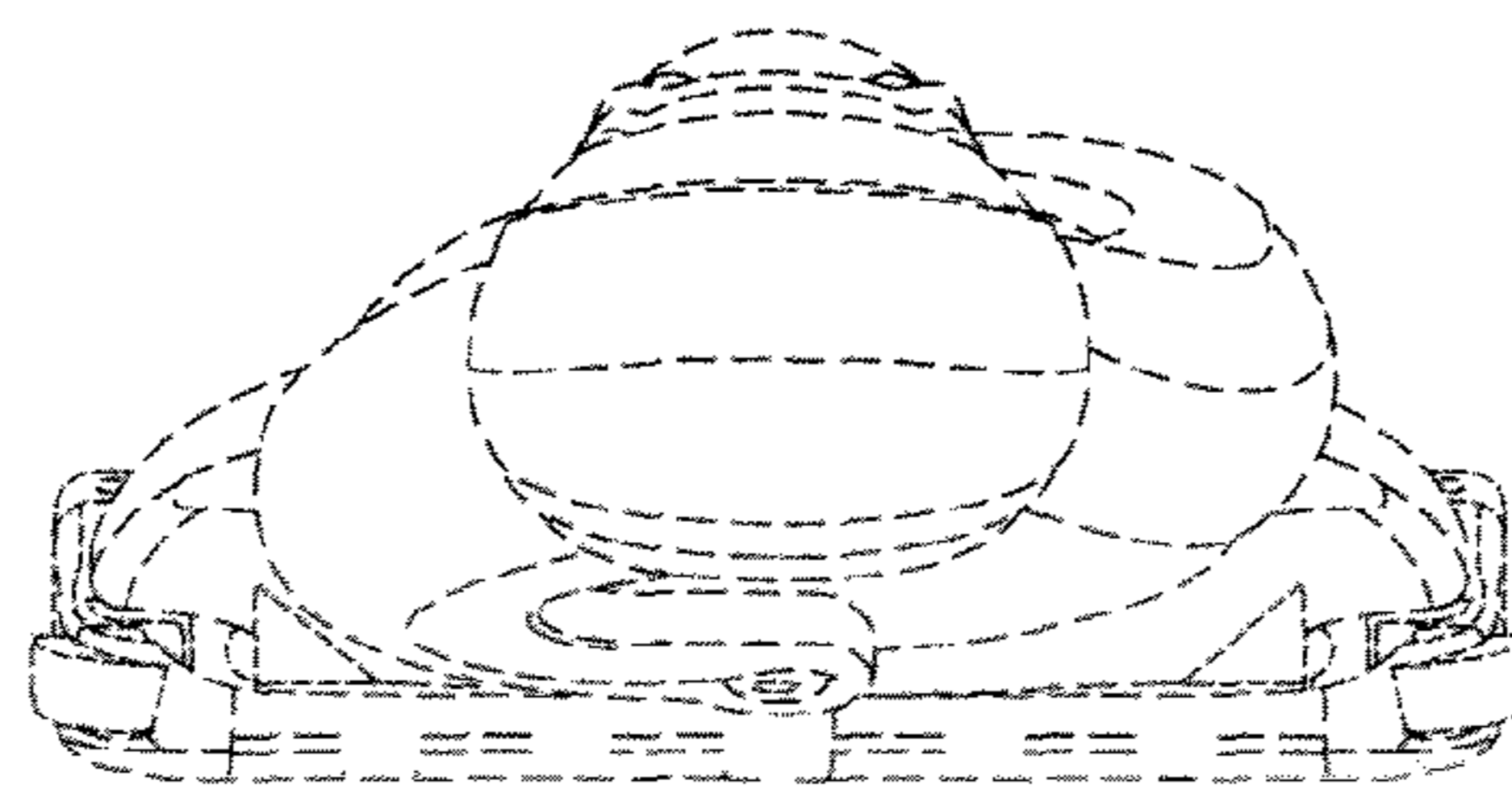
