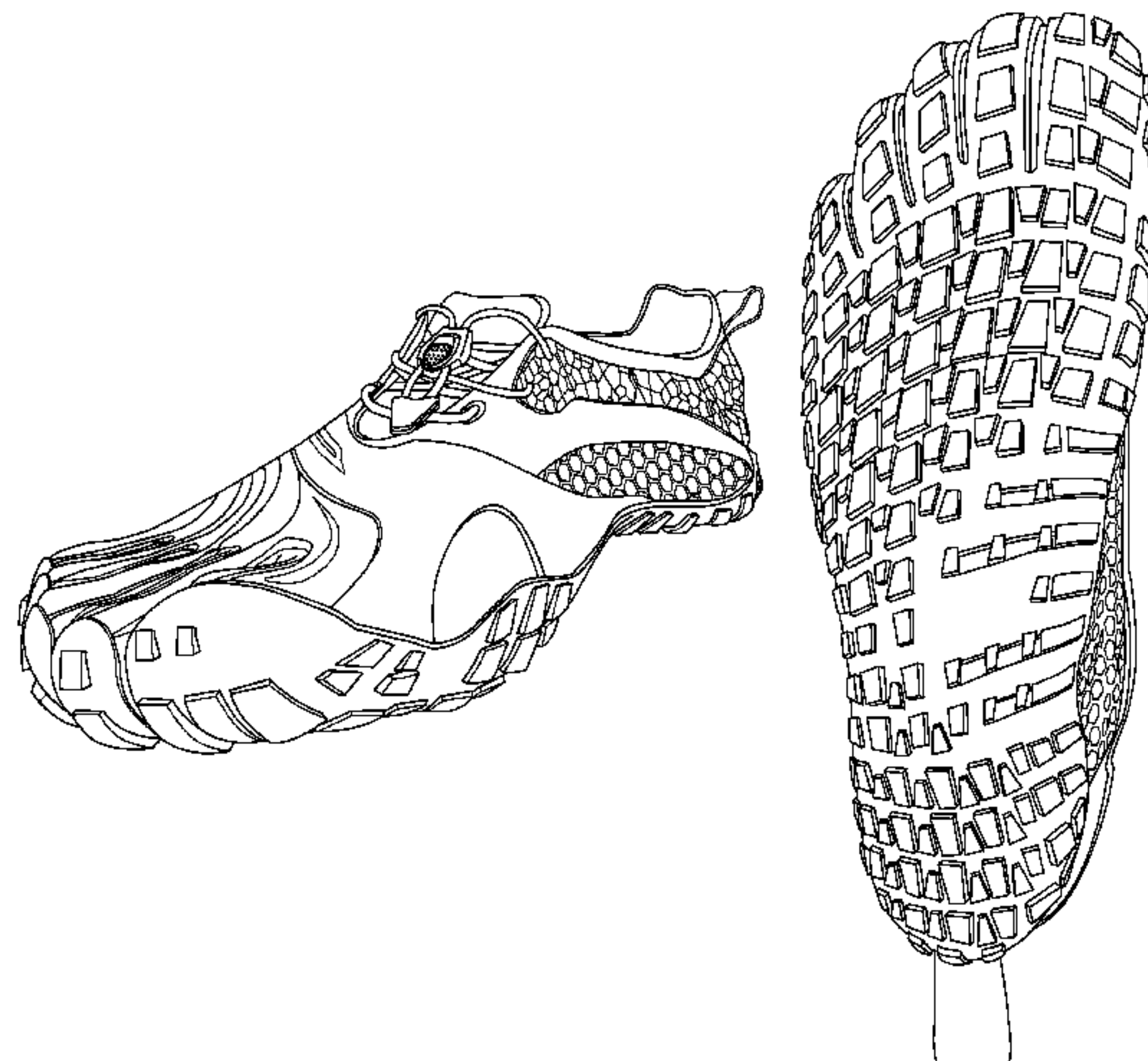
(57) **CLAIM**

We claim, the ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a shoe, showing our new design;
FIG. 2 is a bottom plan view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a front elevation view thereof;
FIG. 5 is a side elevation view thereof taken from the left of FIG. 4;
FIG. 6 is a side elevation view thereof taken from the right of FIG. 4; and,
FIG. 7 is a rear elevation view thereof.

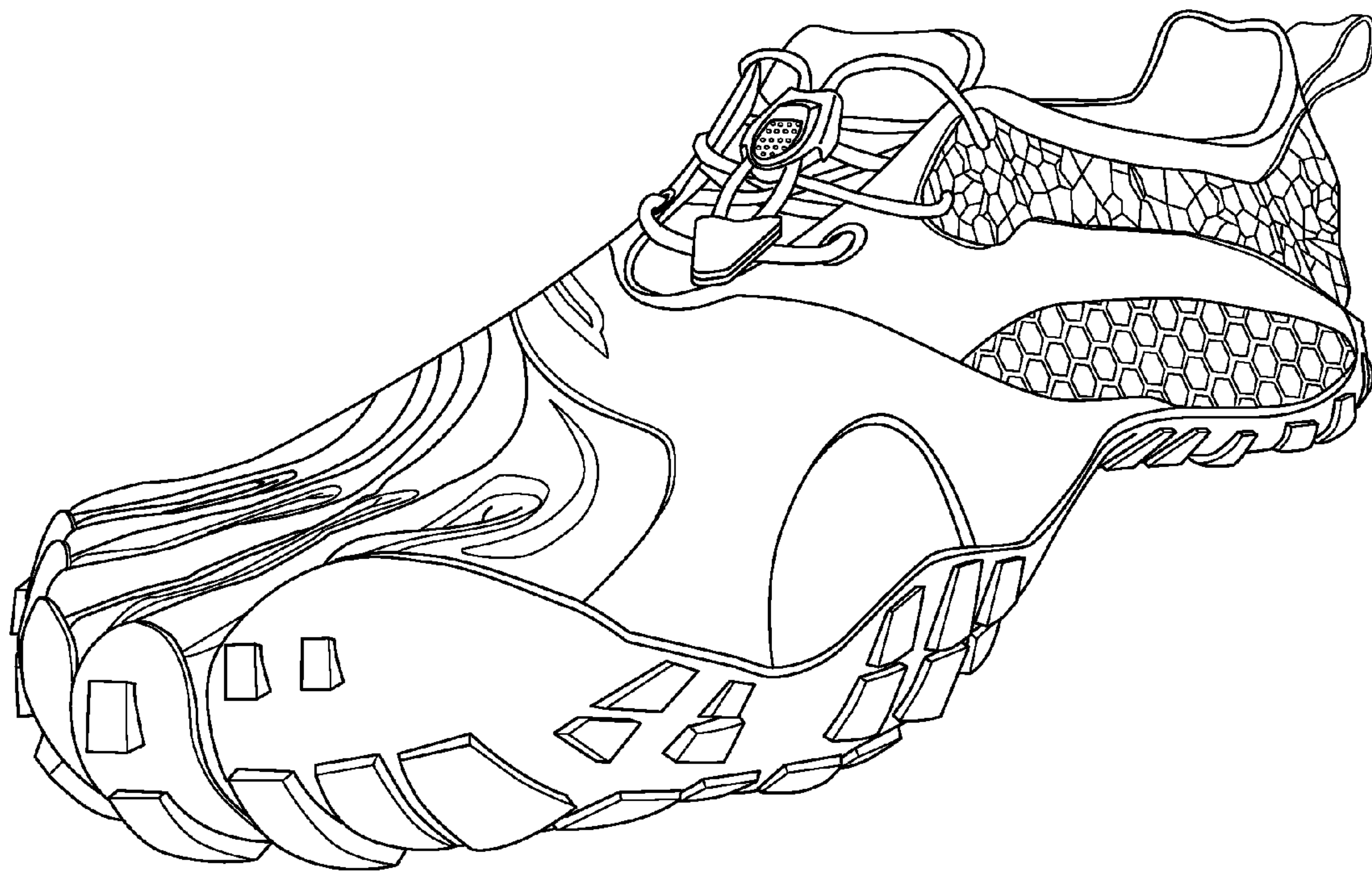

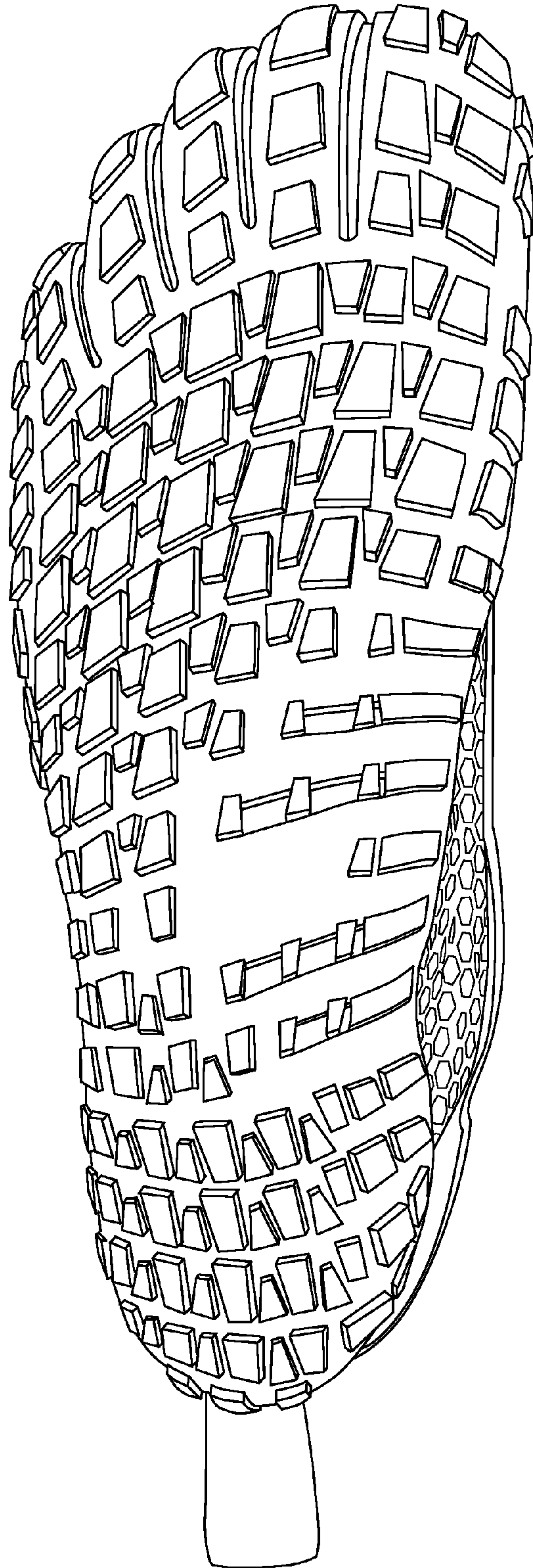

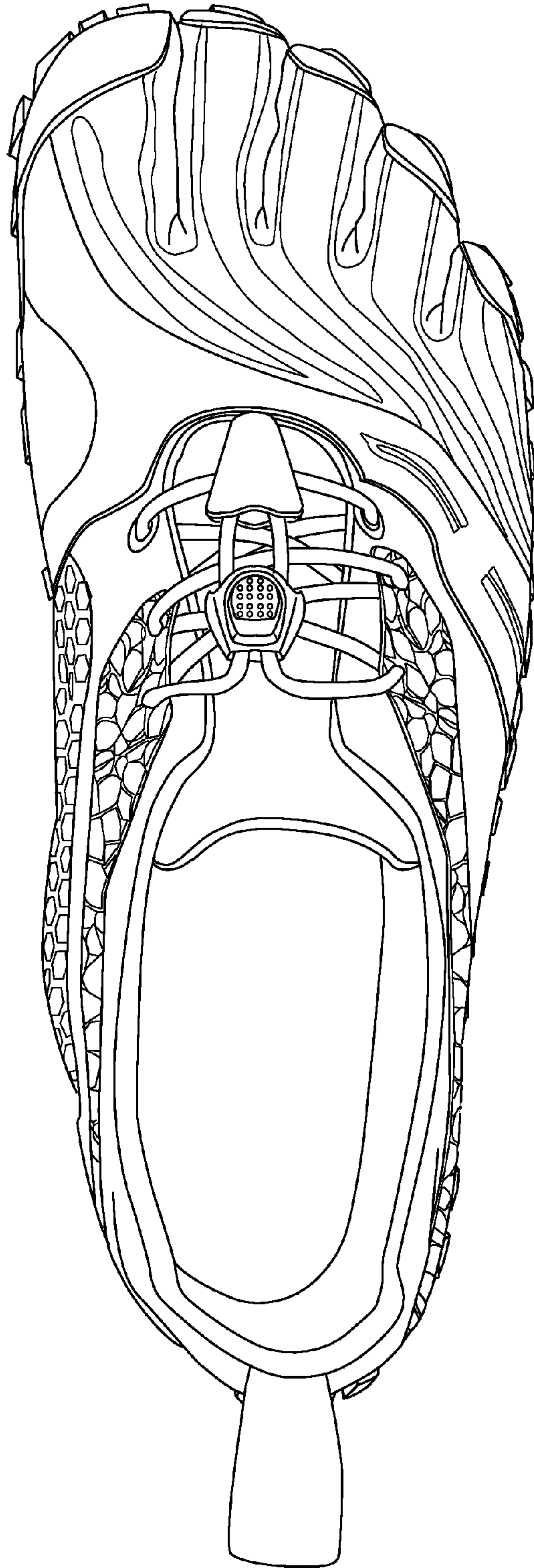

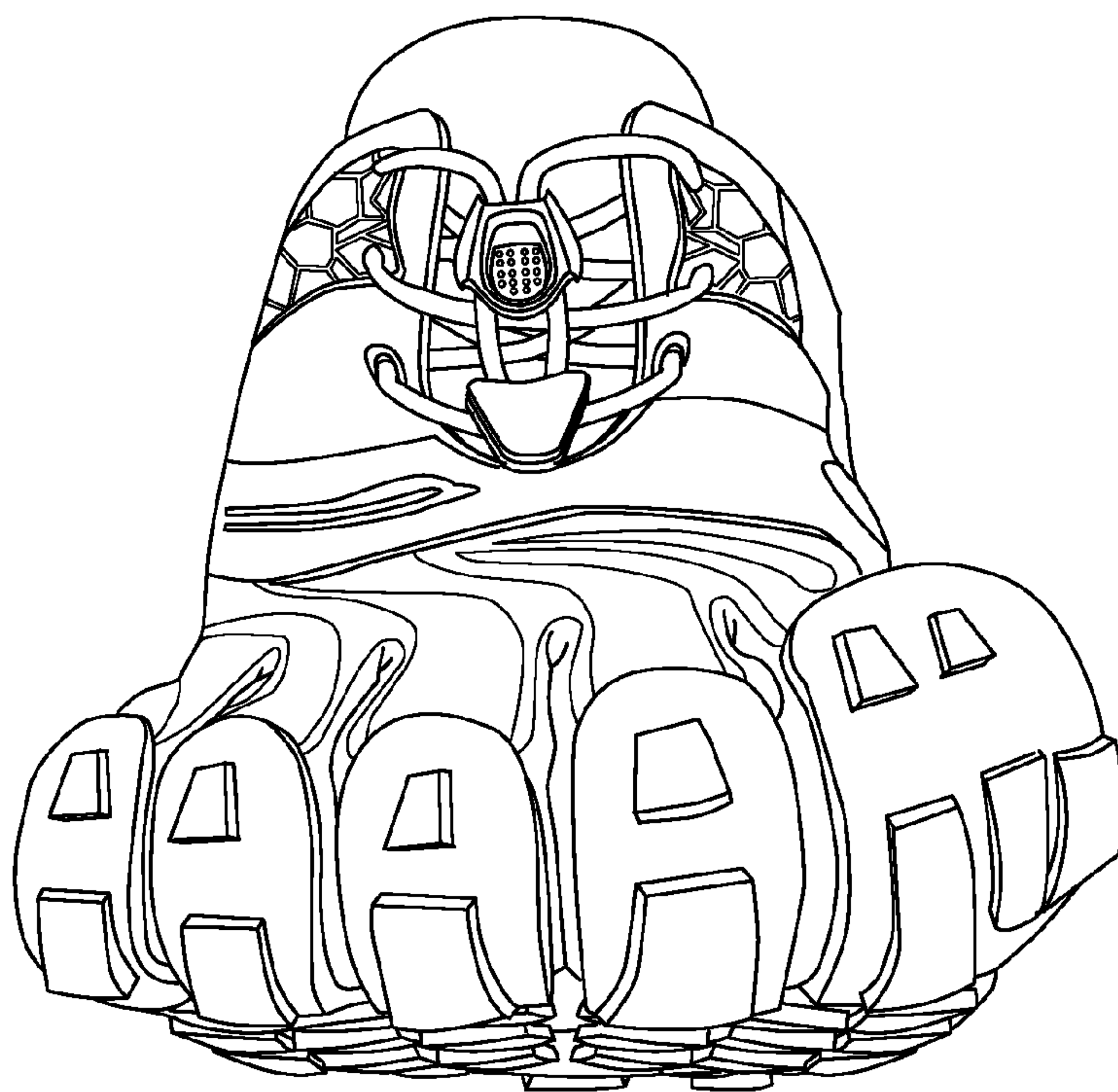

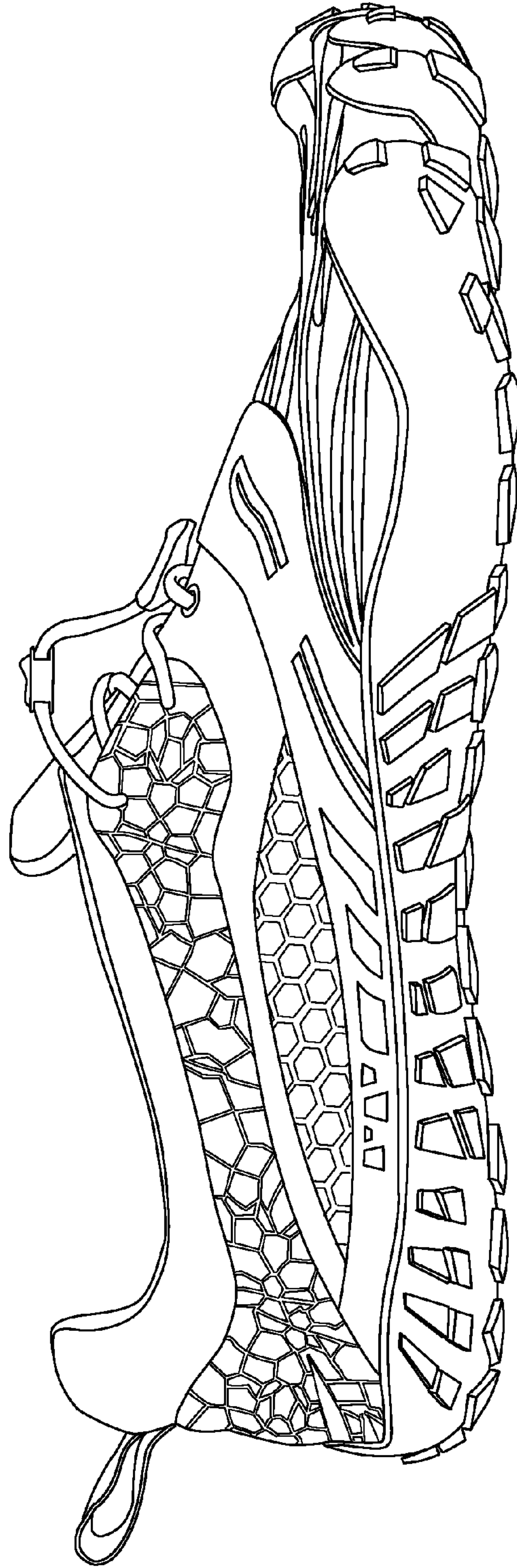

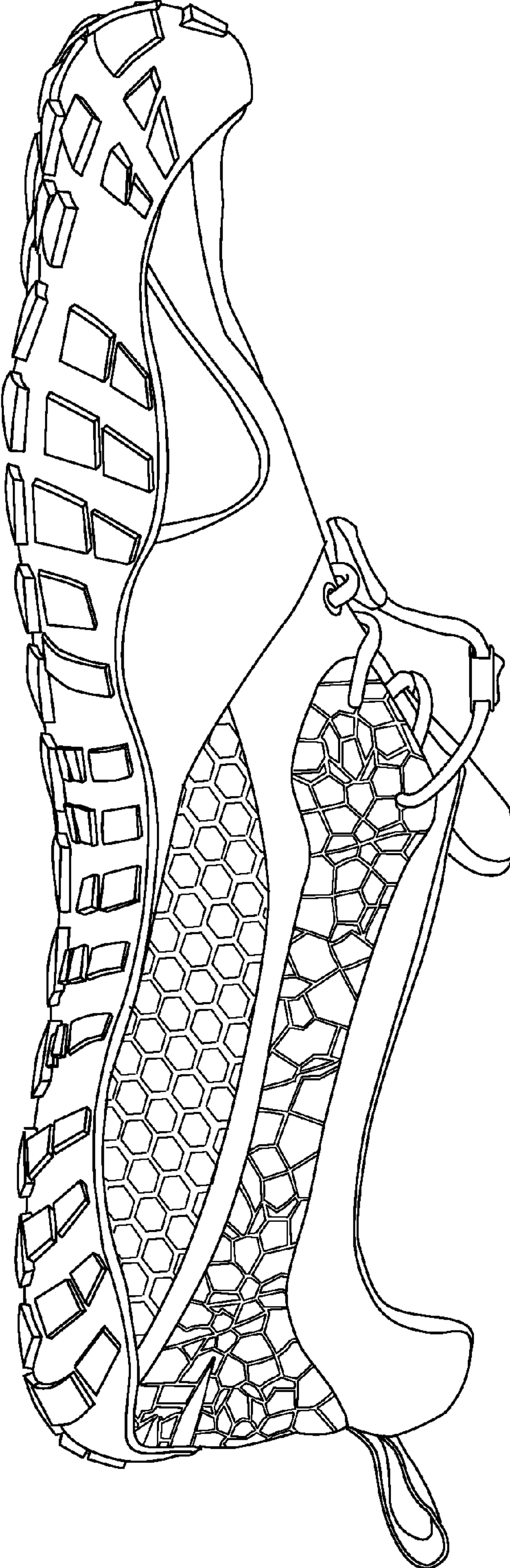

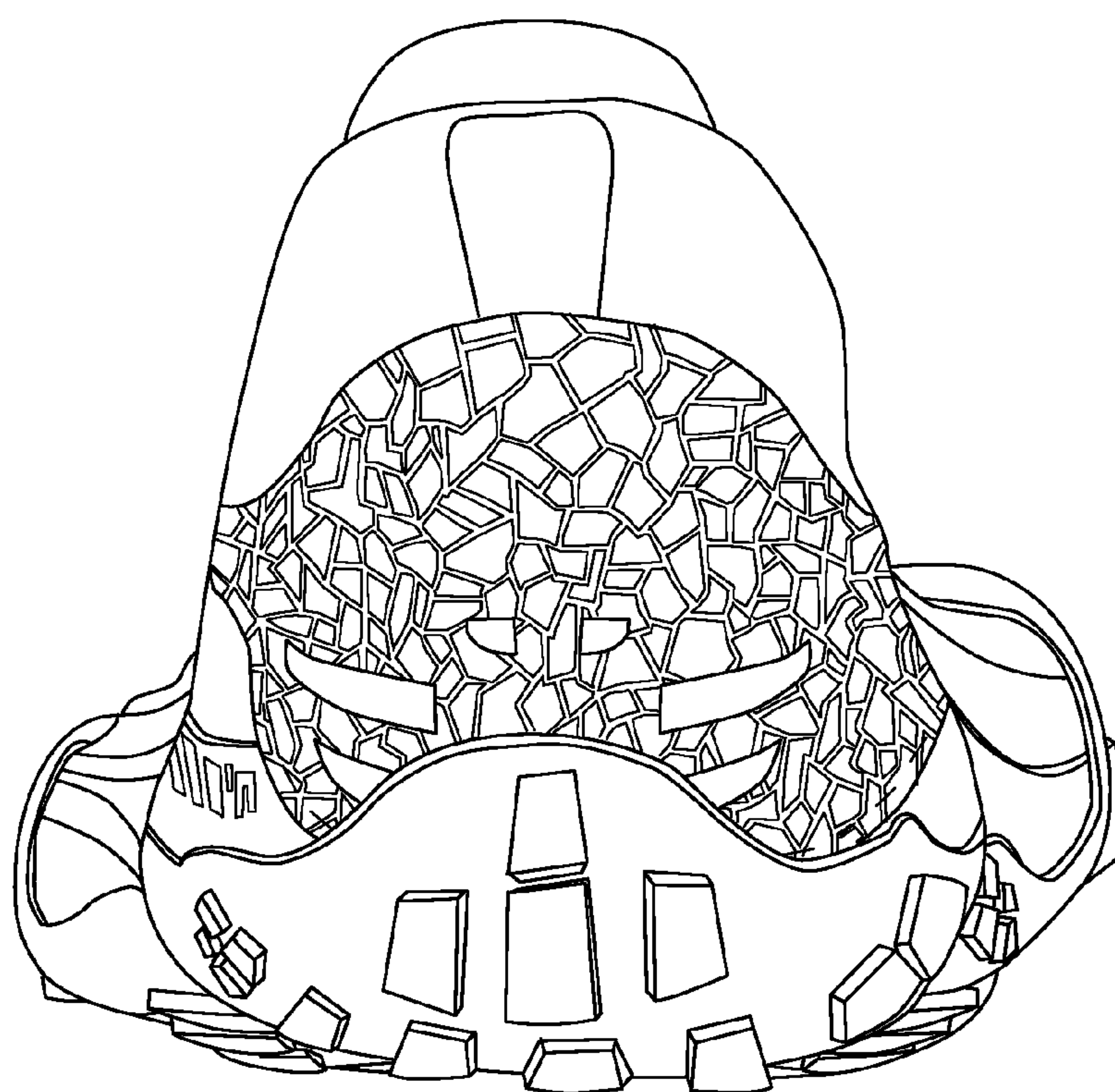
