FIG. 15 is a bottom view of the chair shown in FIG. 1, in a folded position.

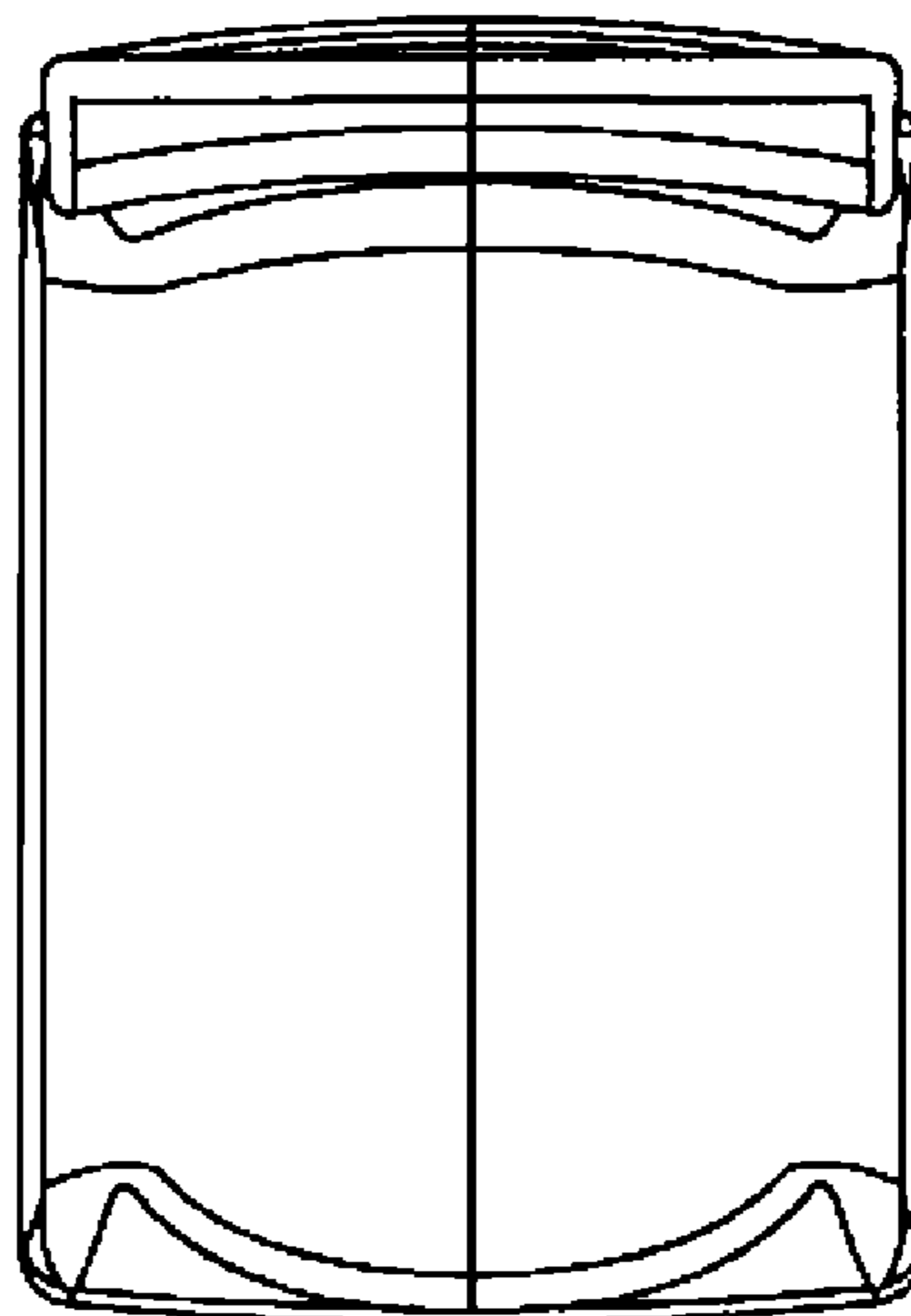

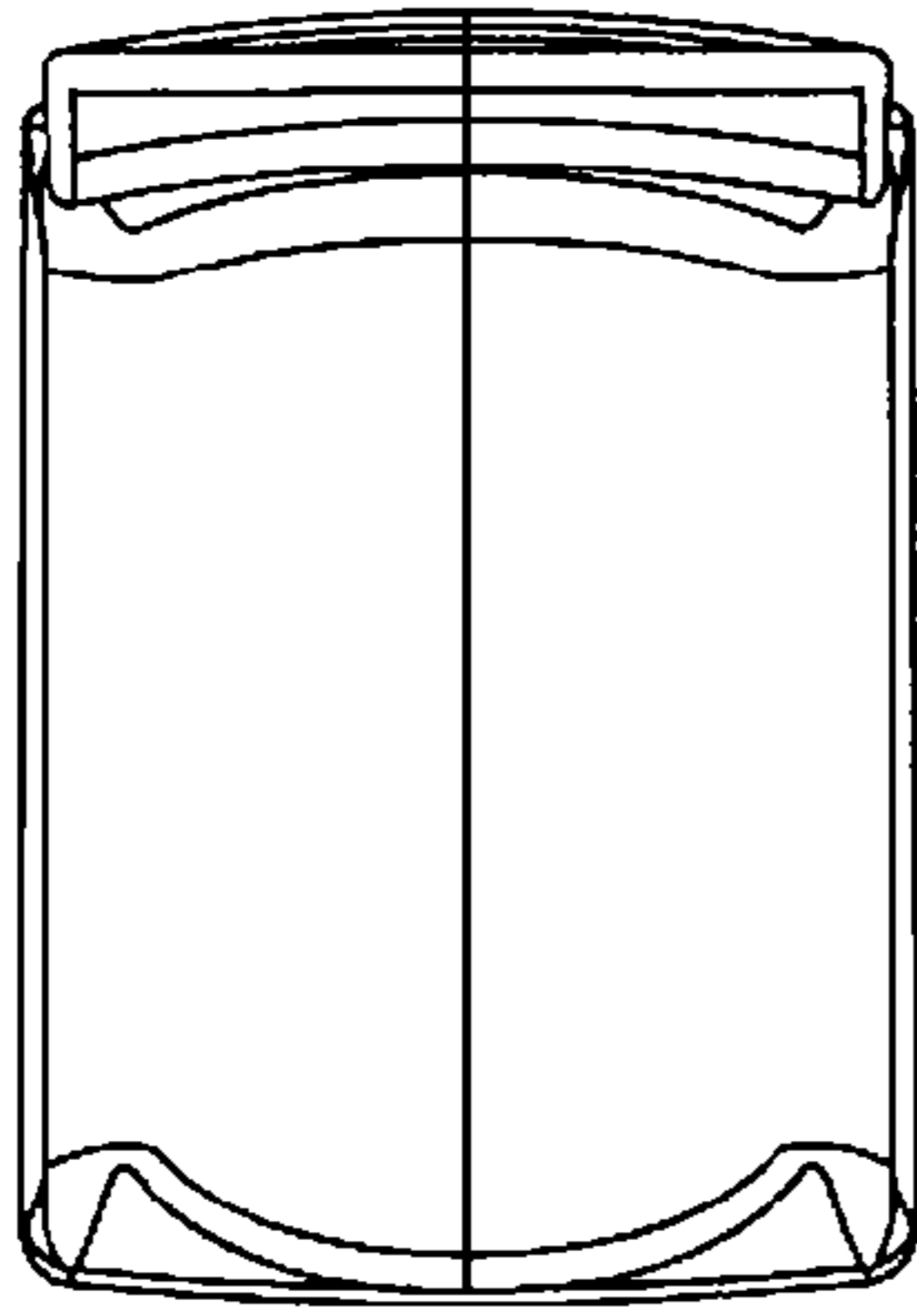

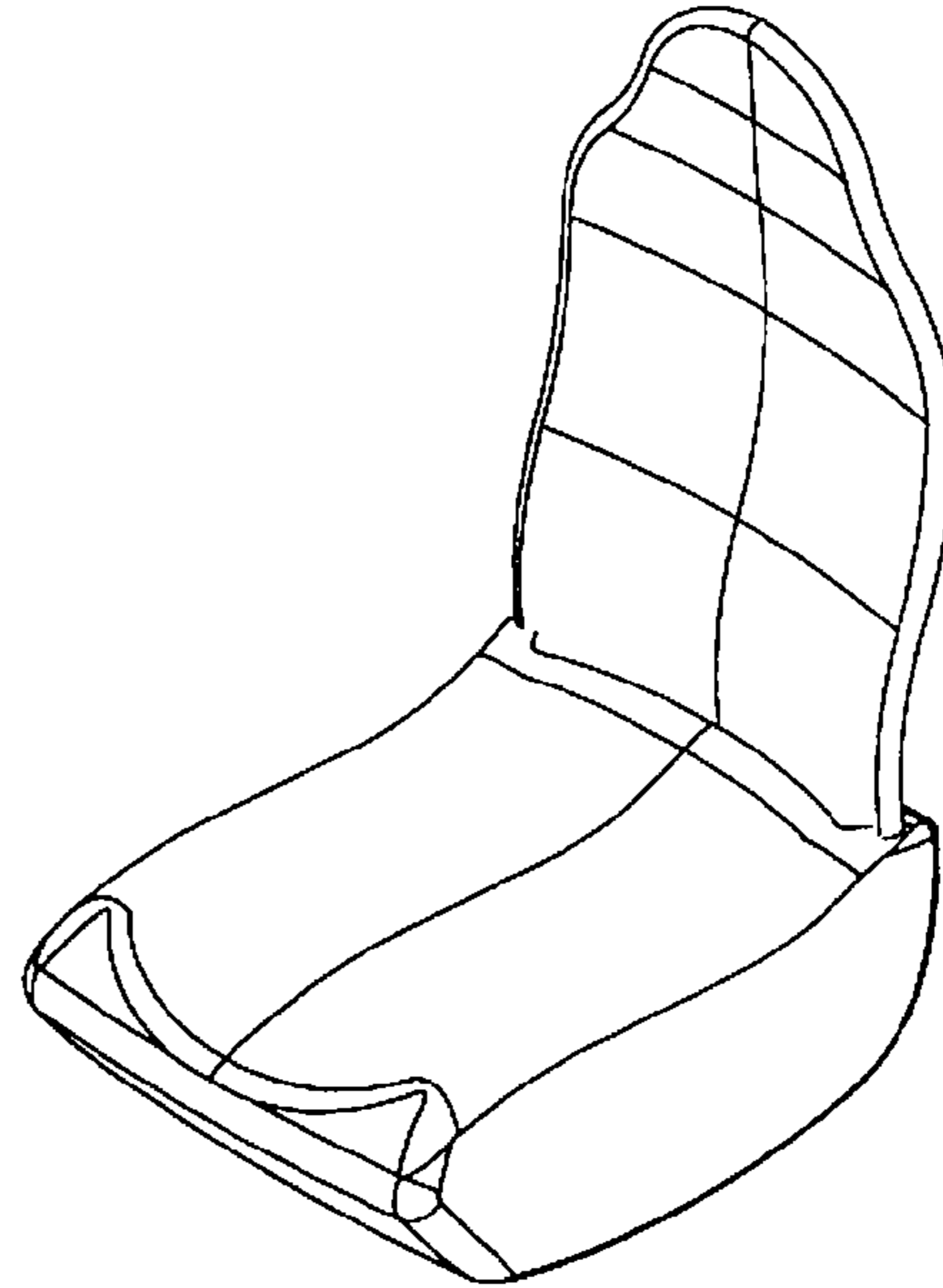

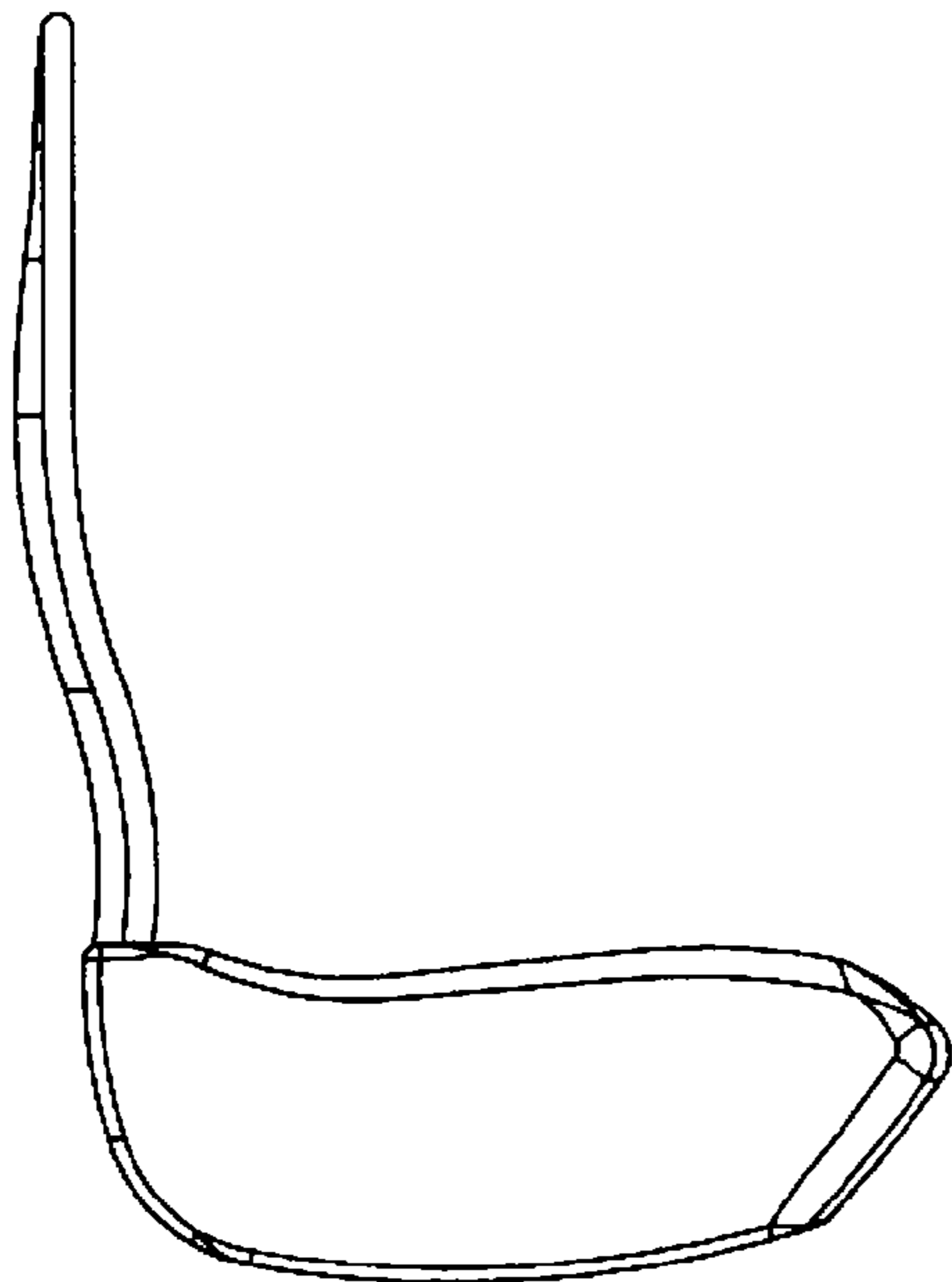

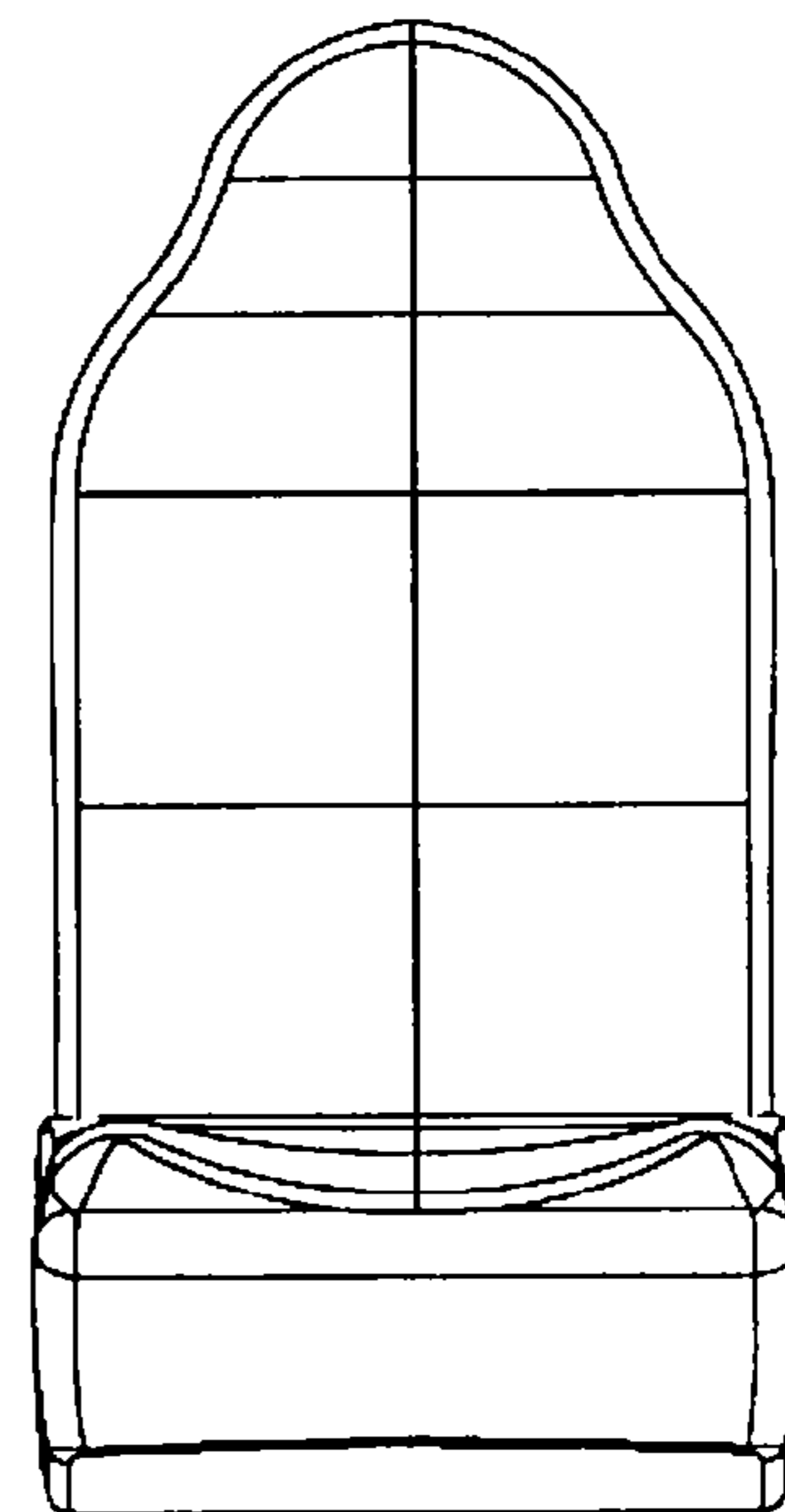

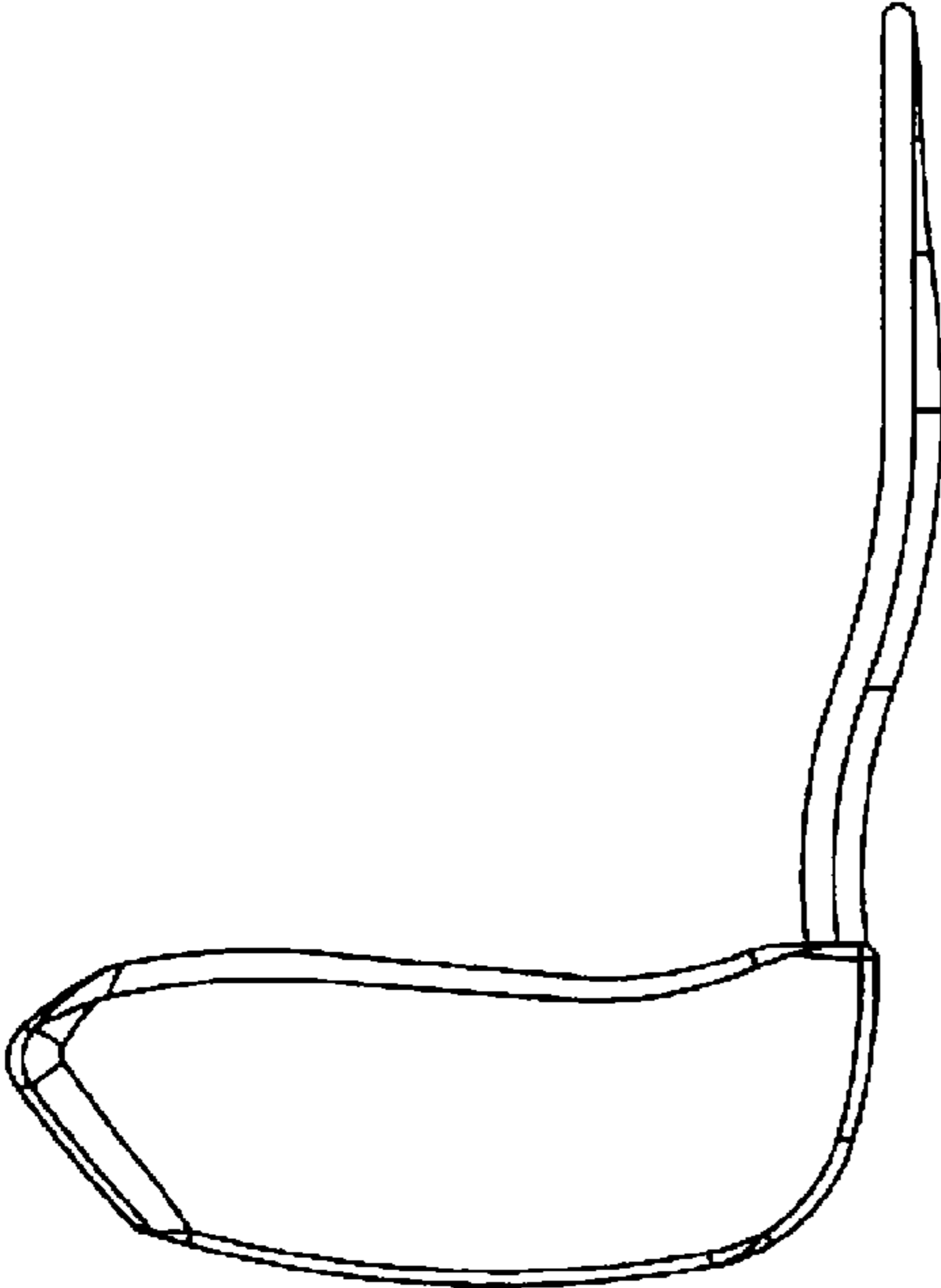

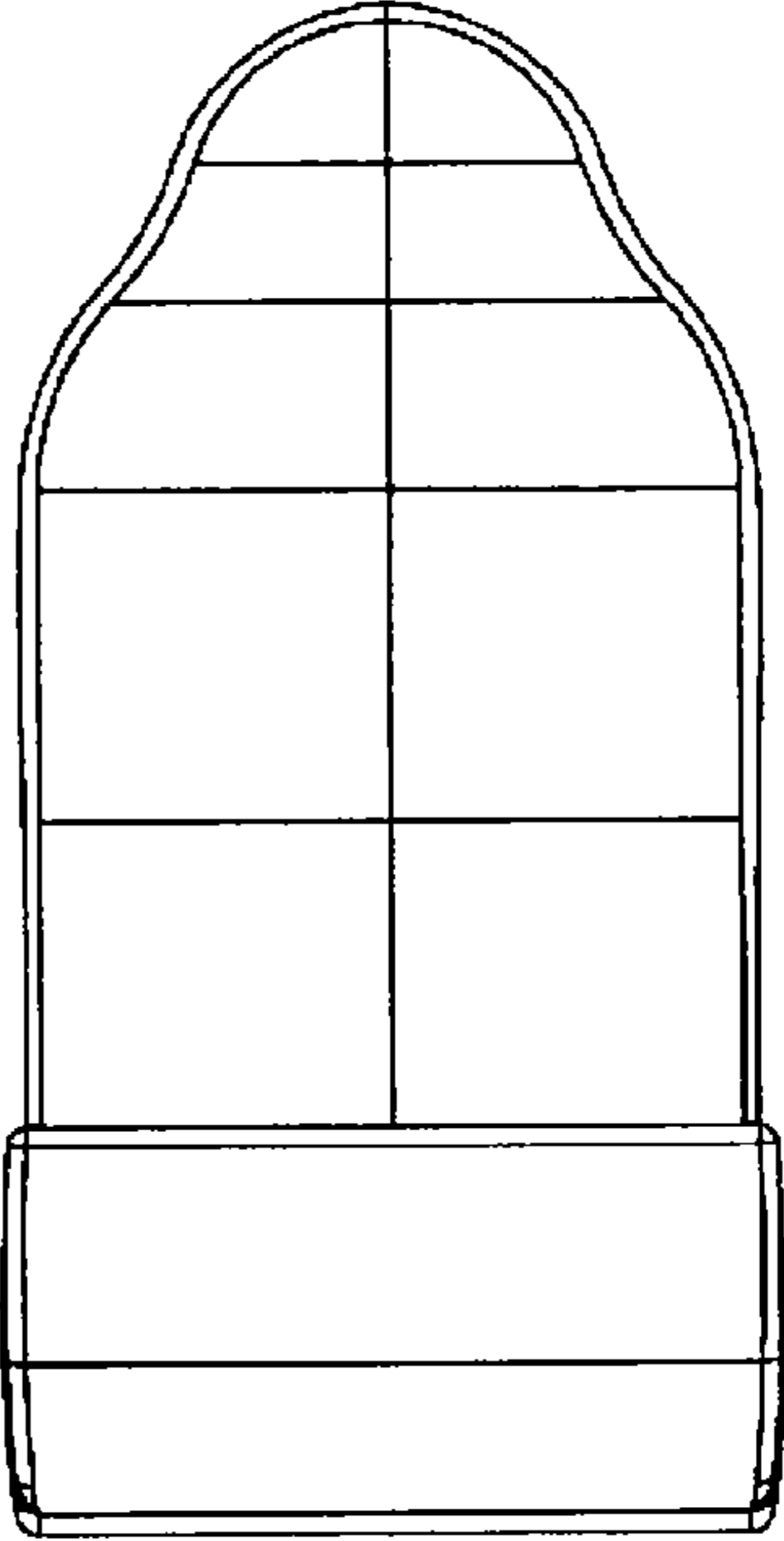

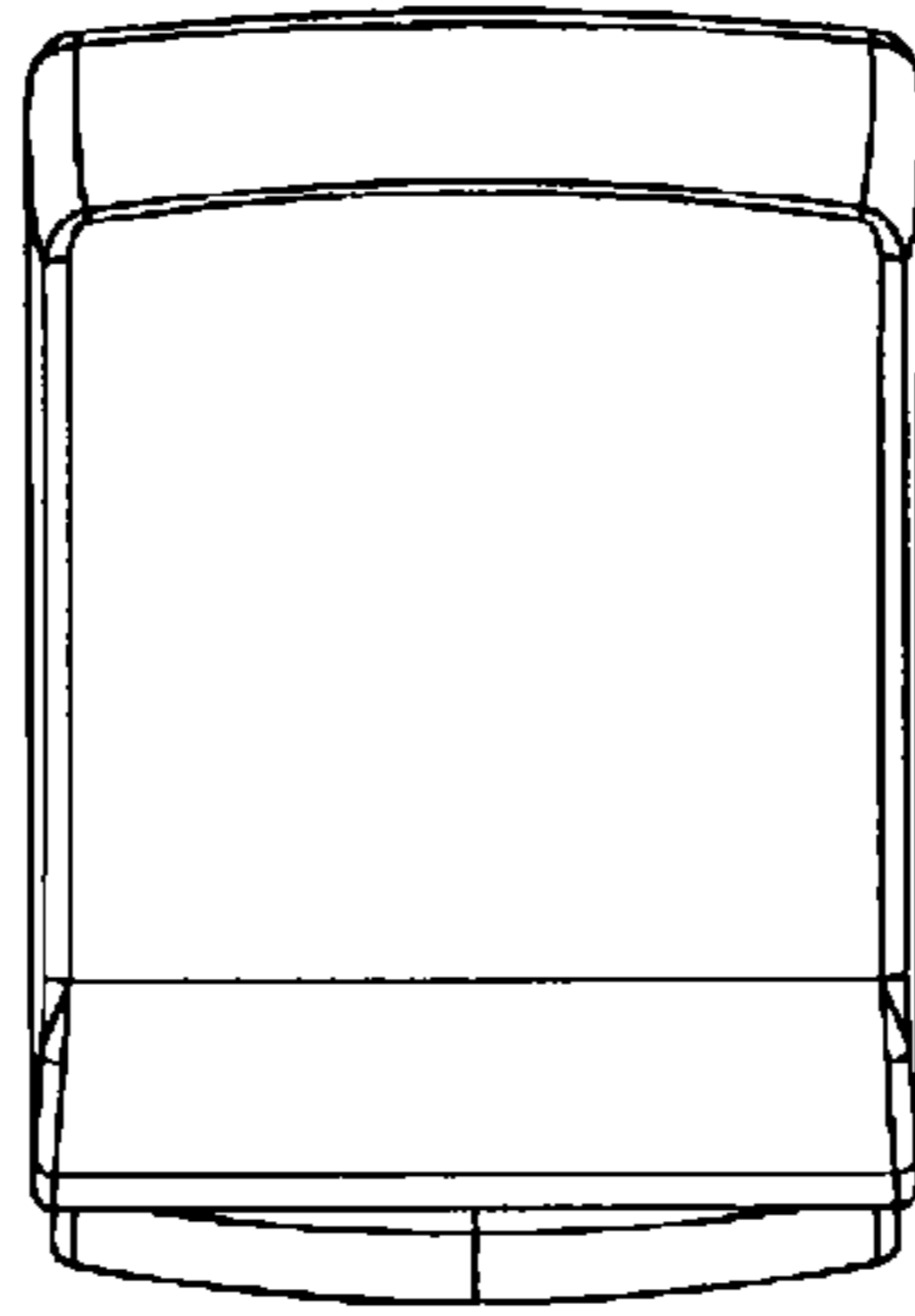

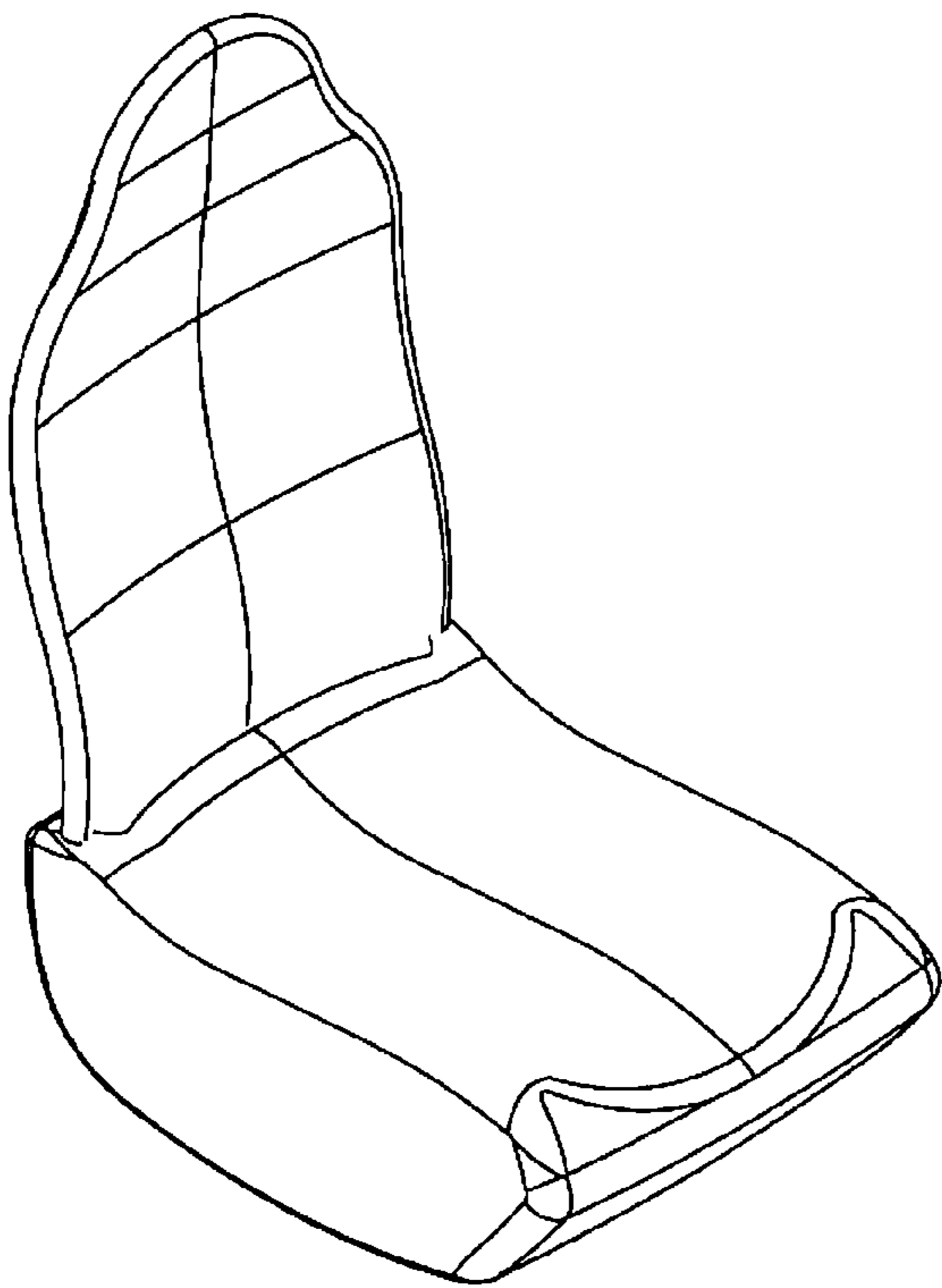

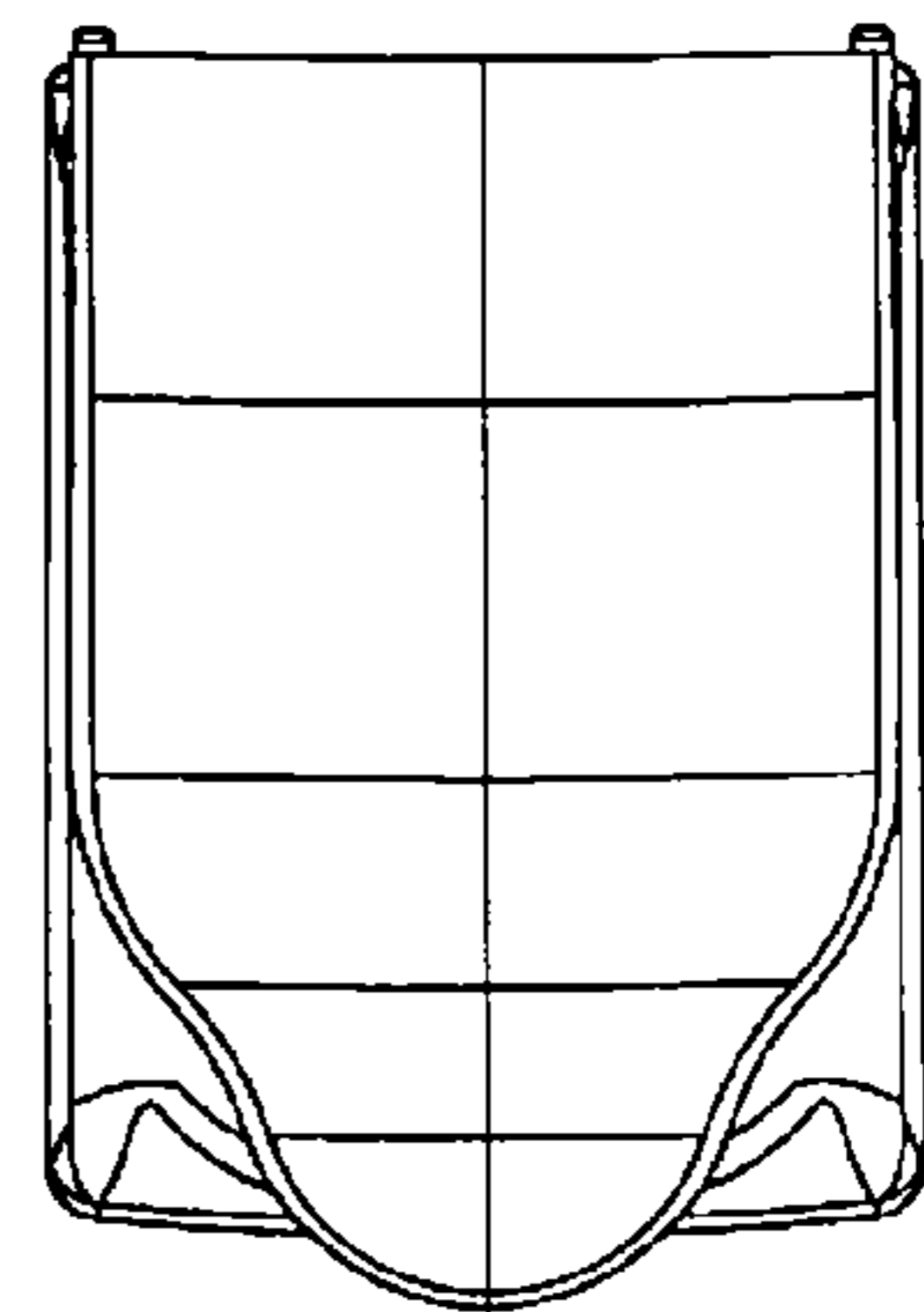

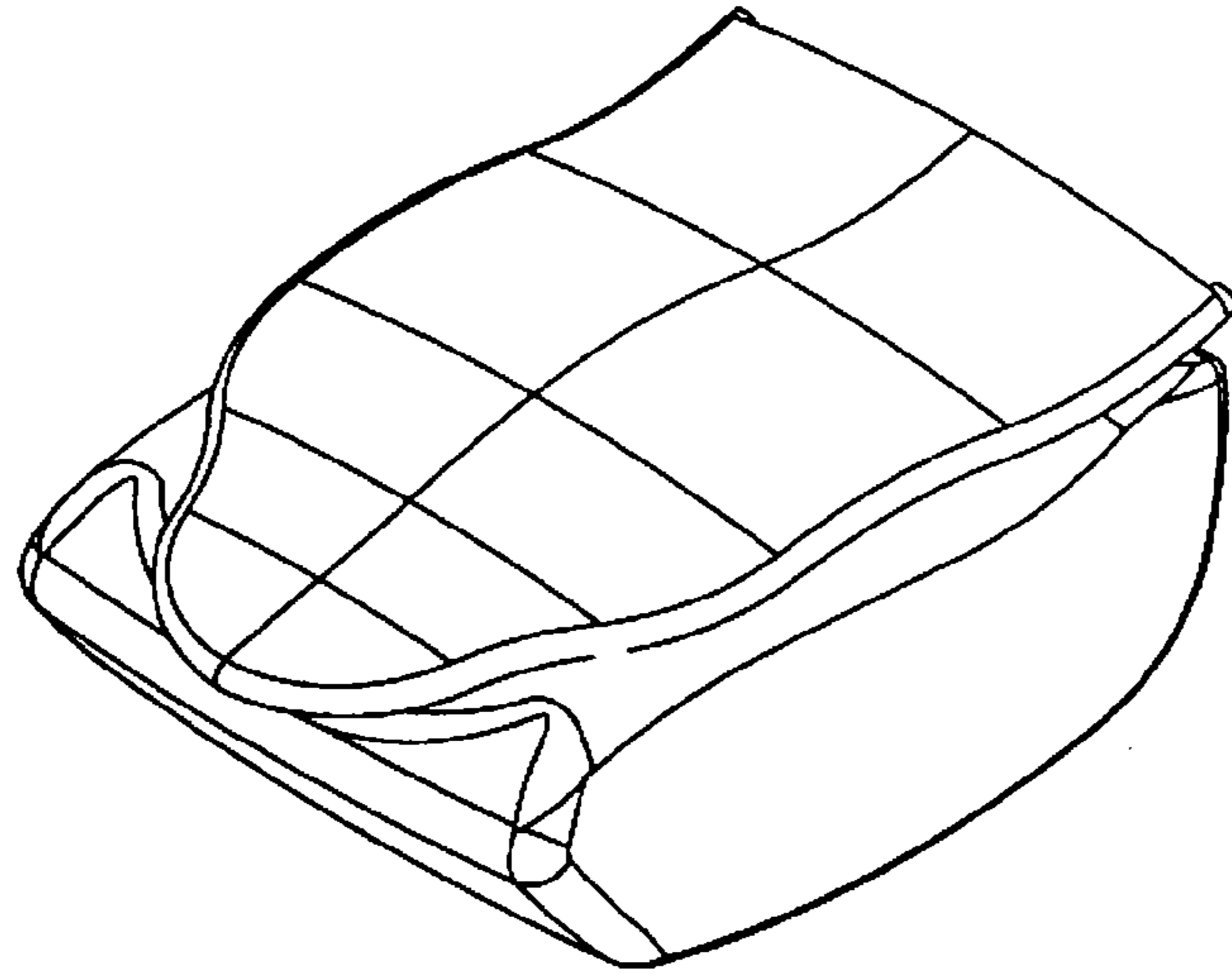

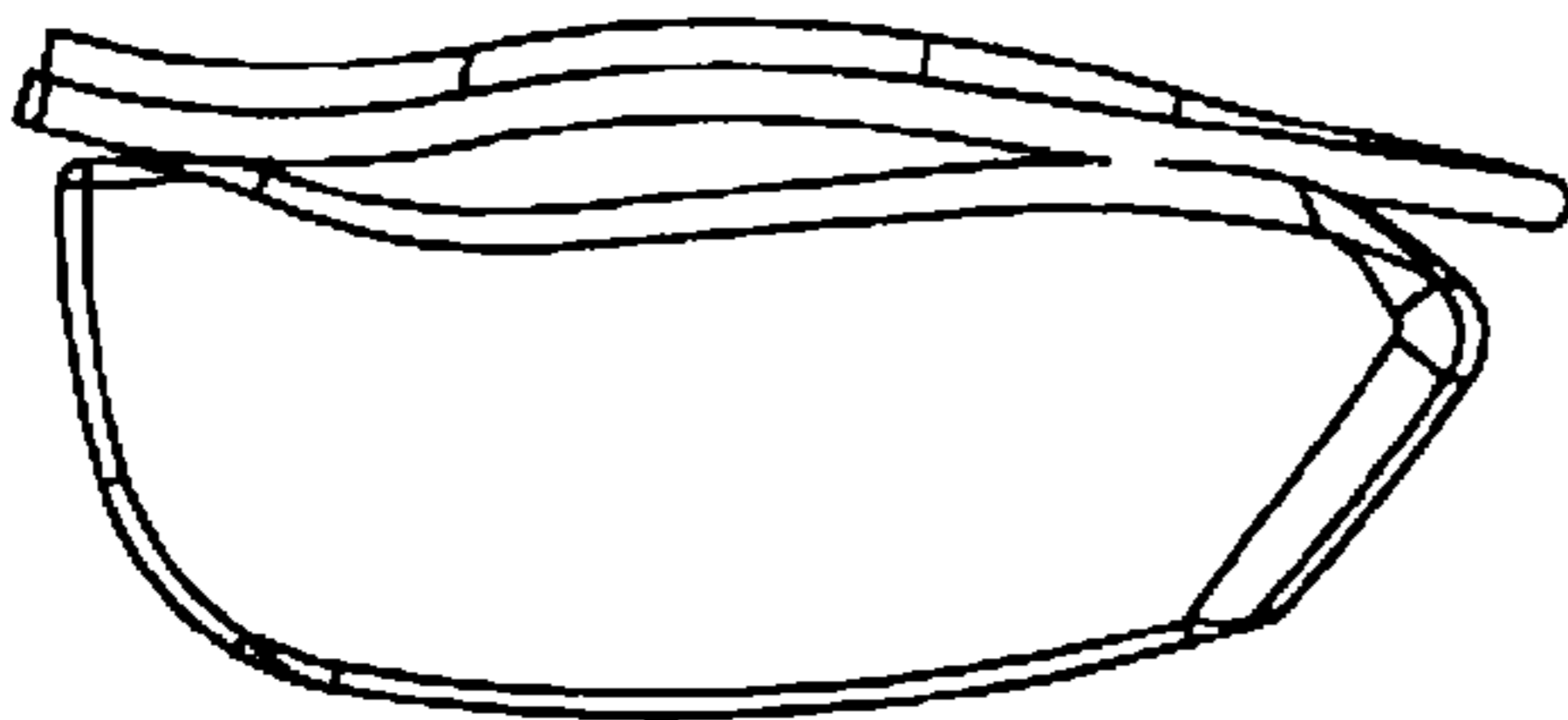

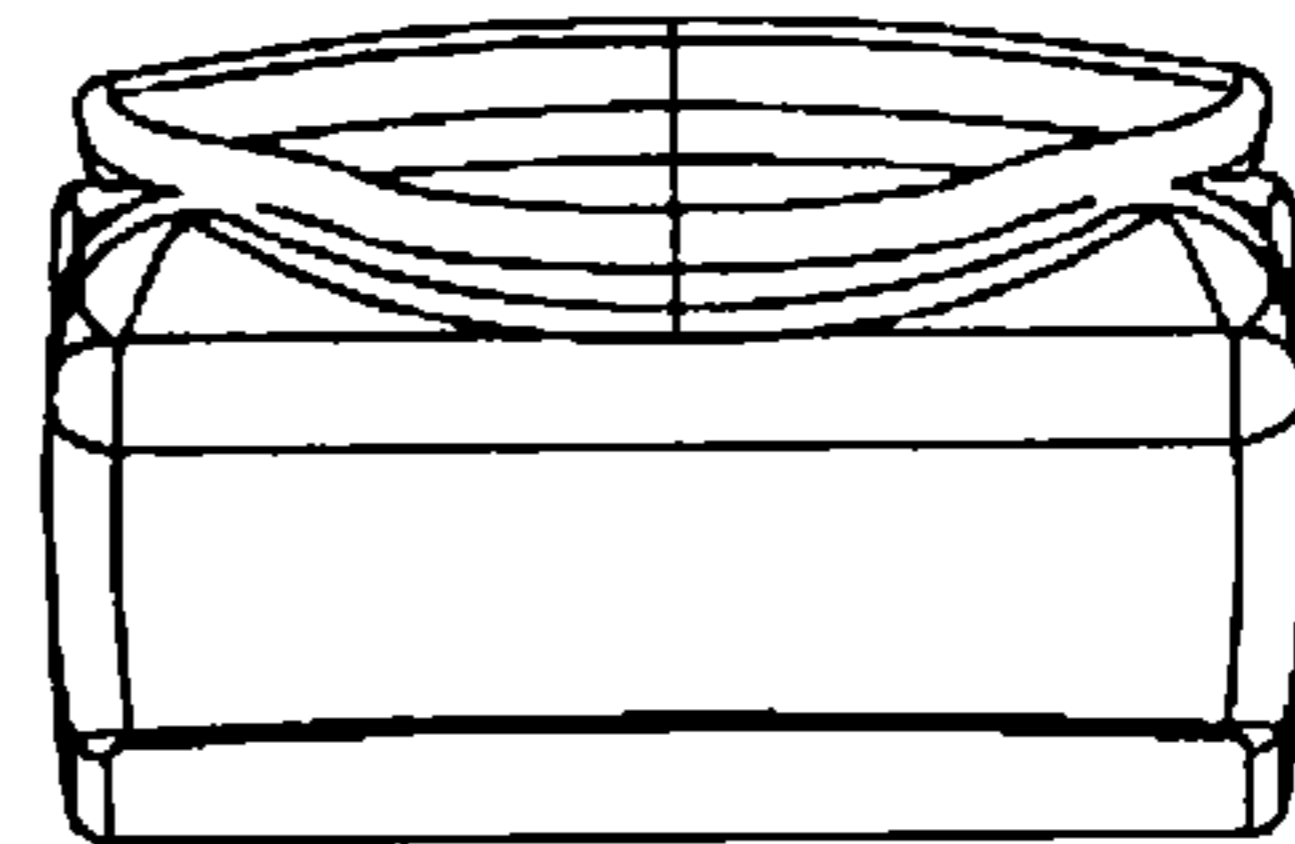

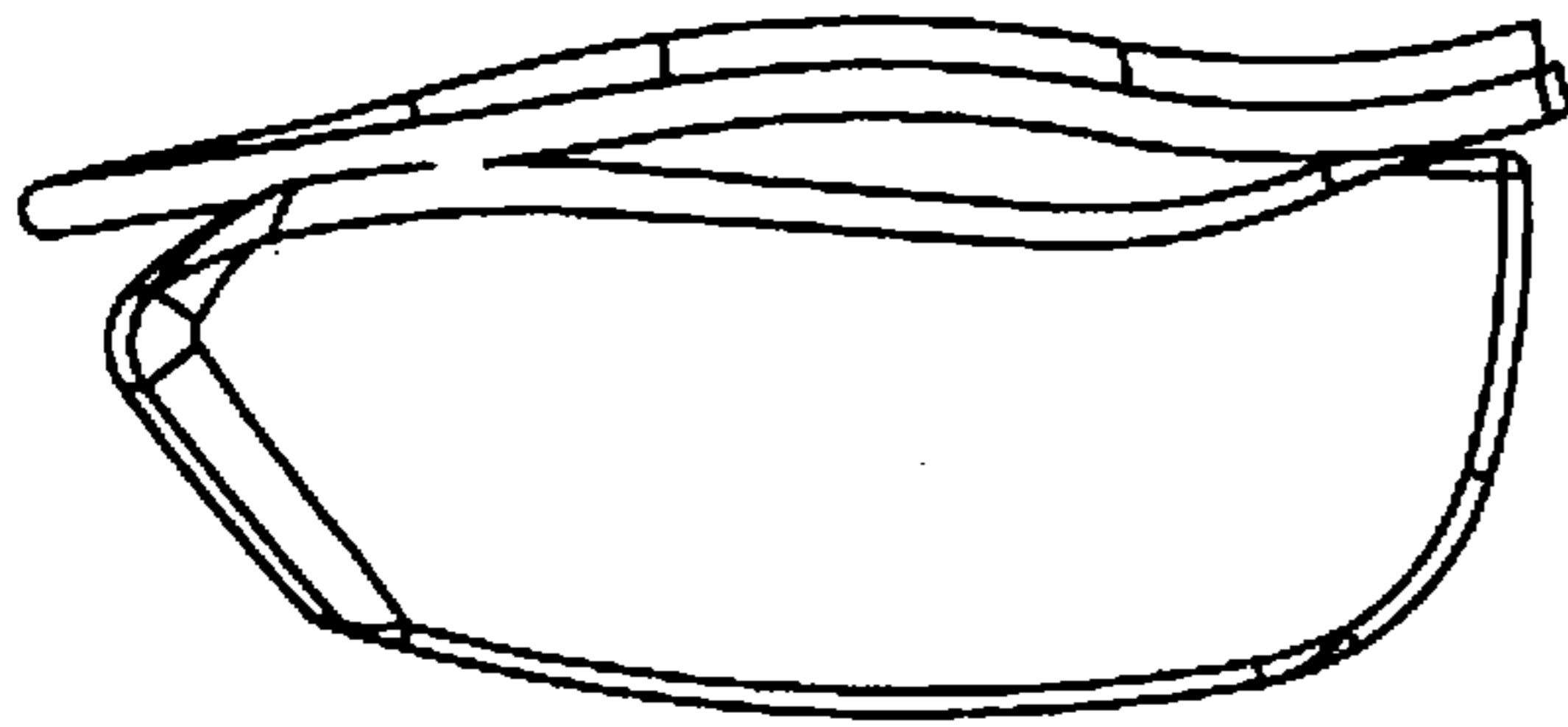

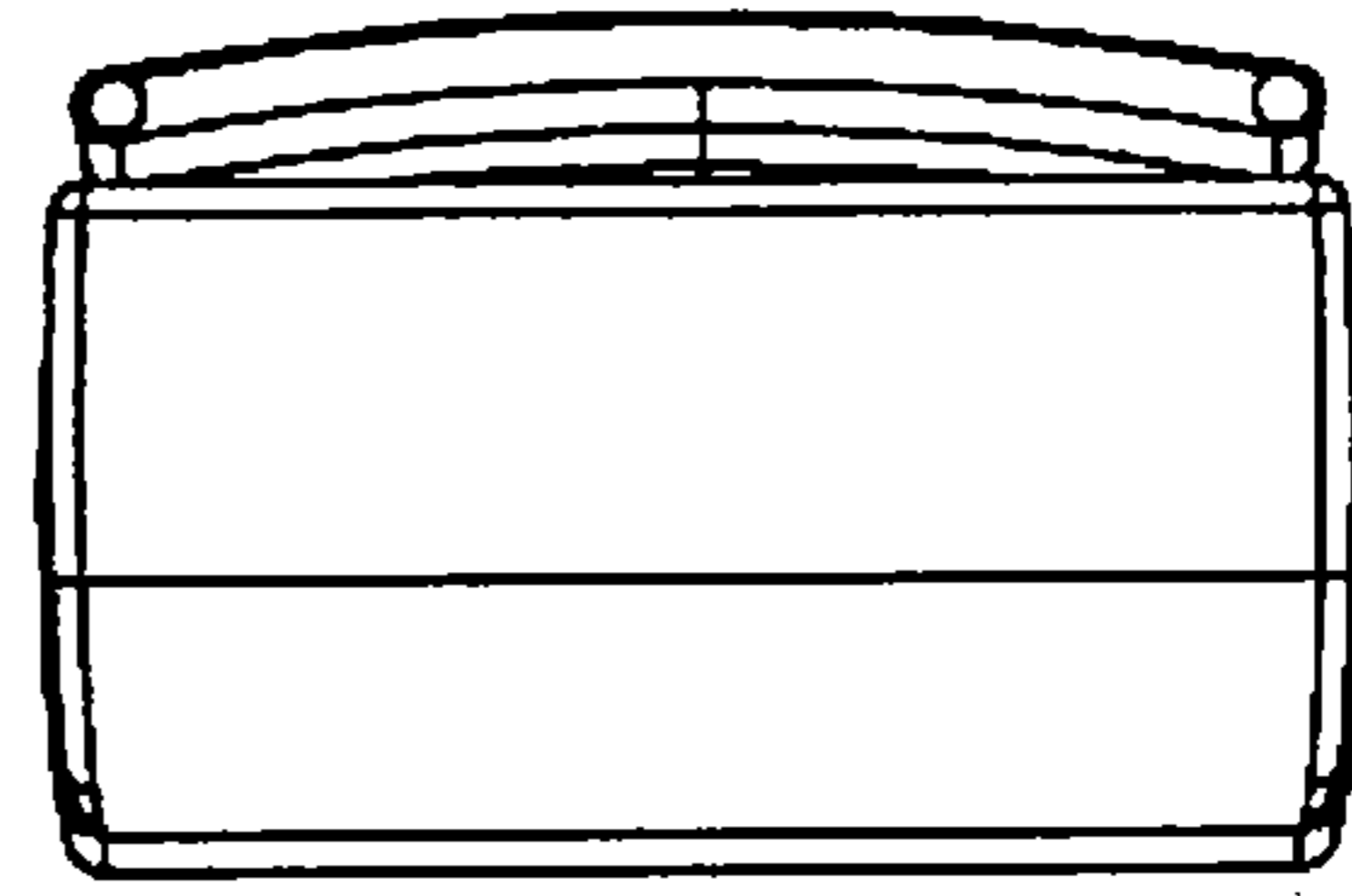

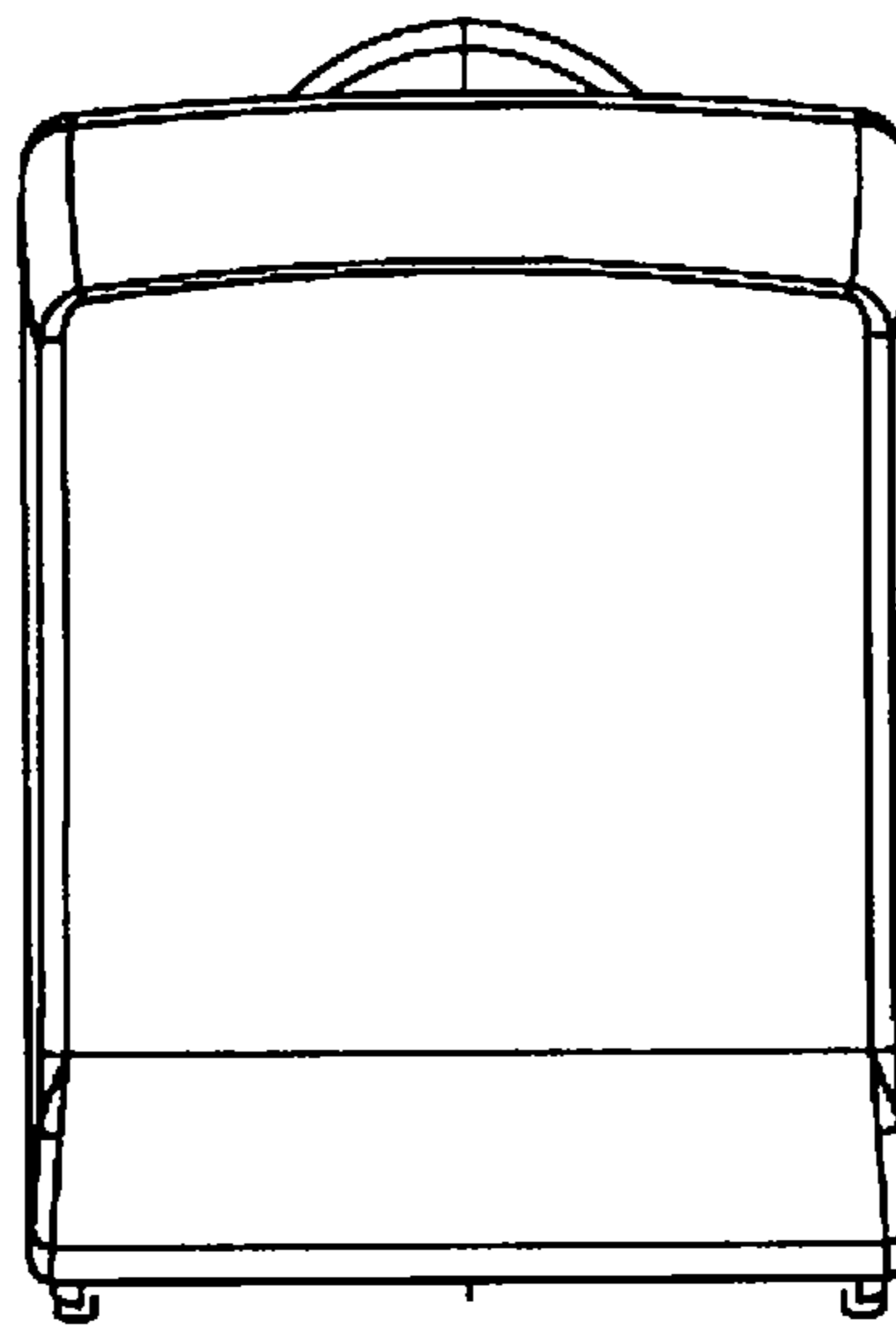
