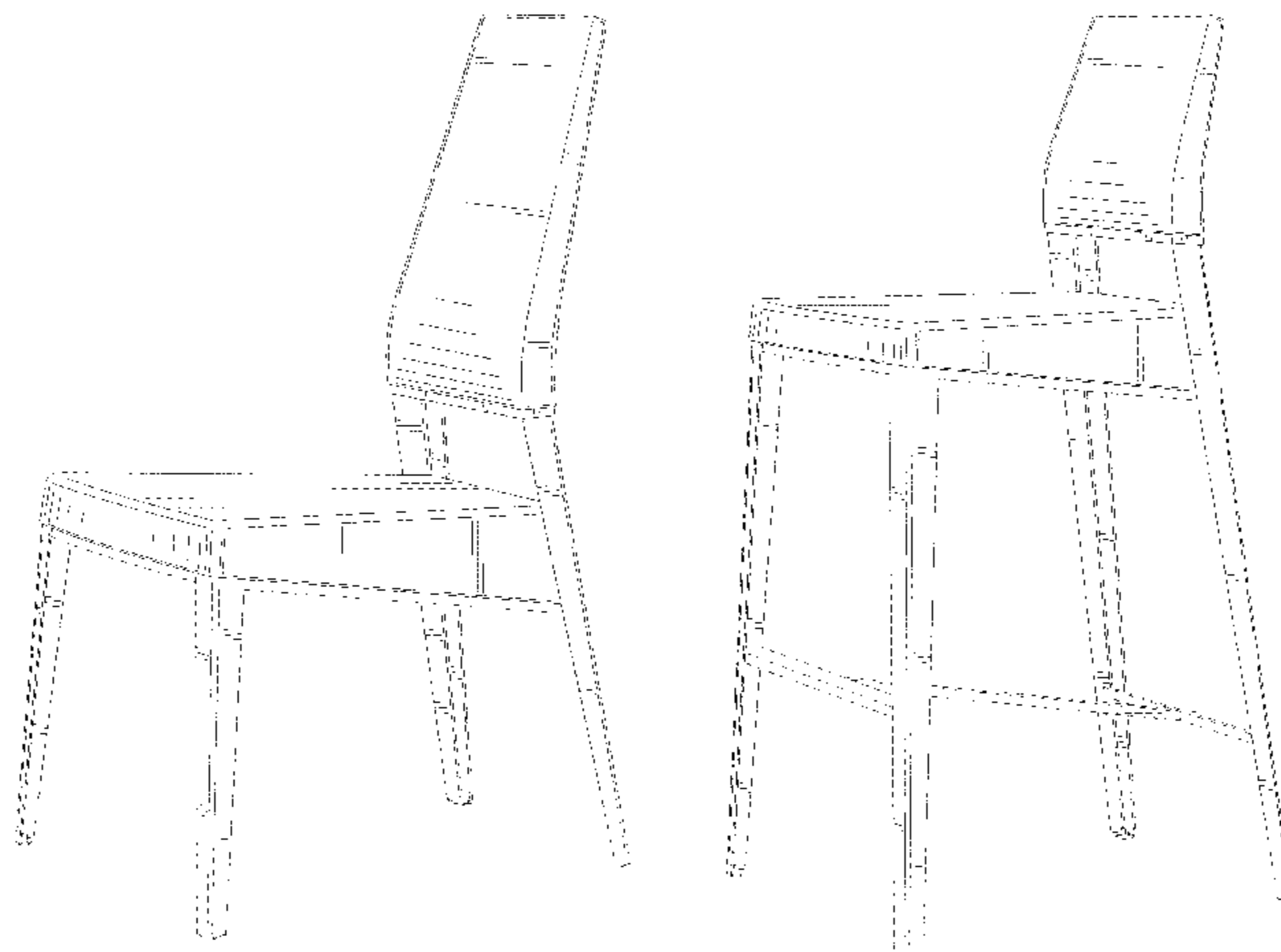
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a seat frame in accordance with the new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is an perspective view of an alternative embodiment of the seat frame;

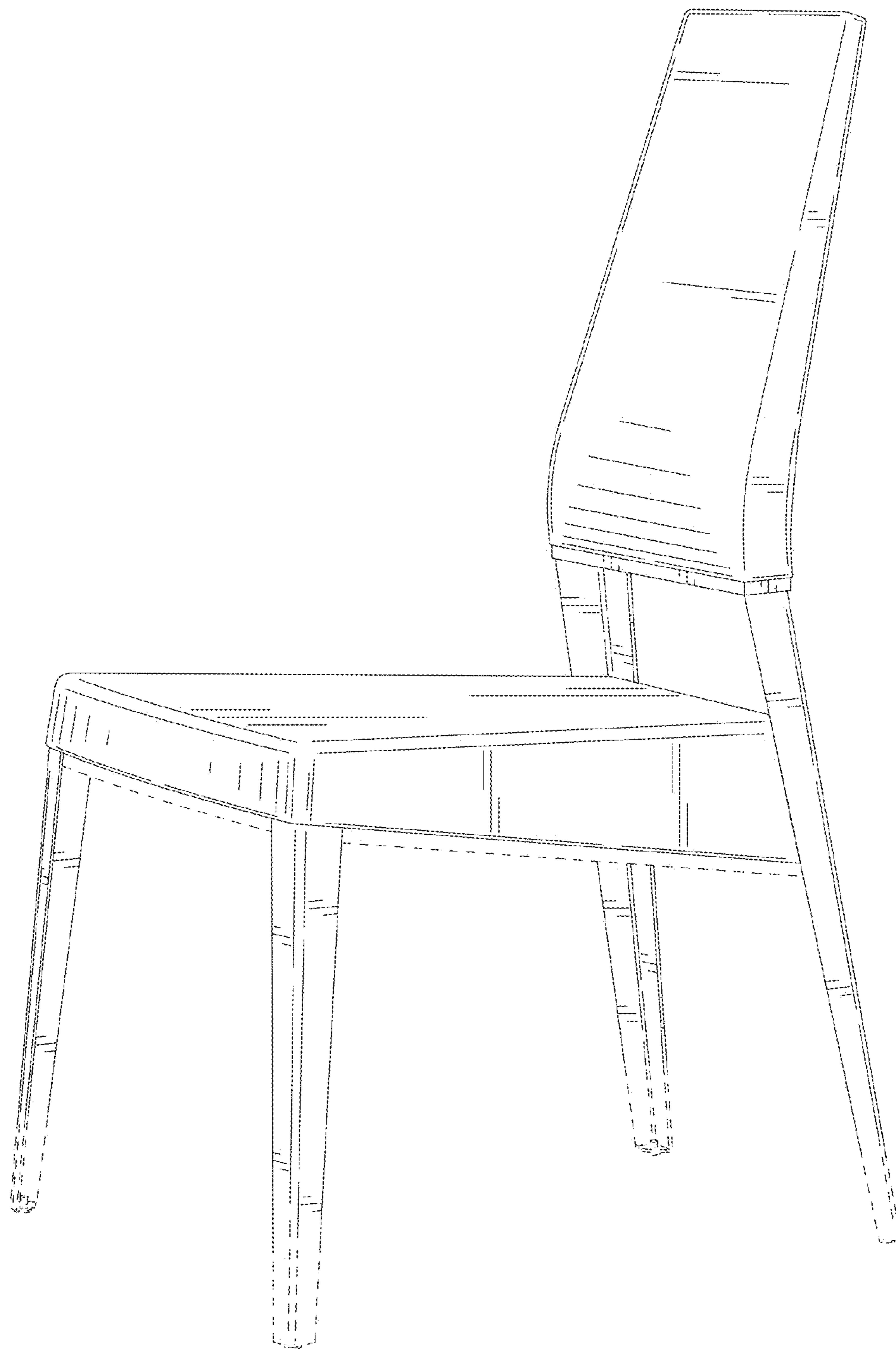

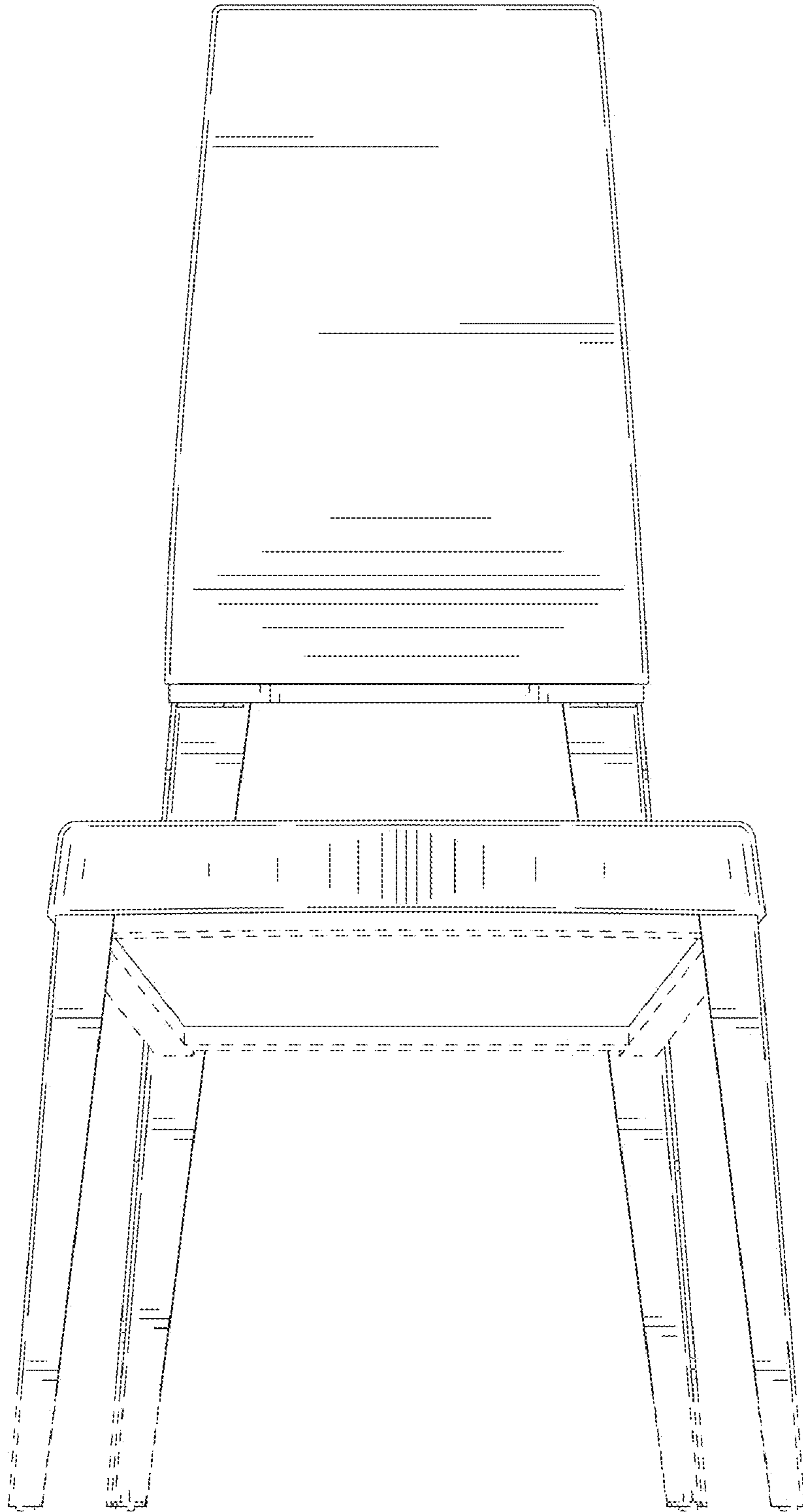

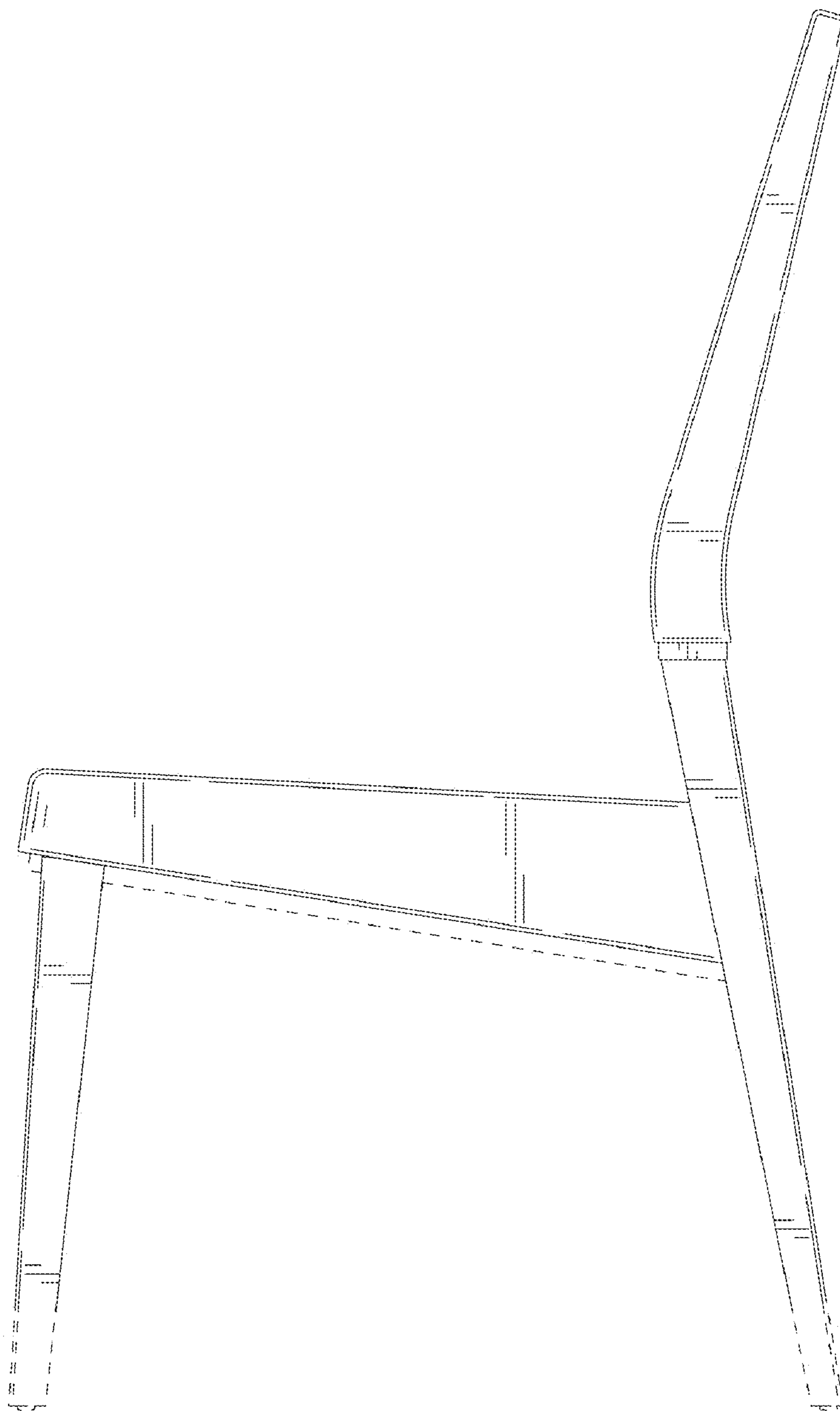

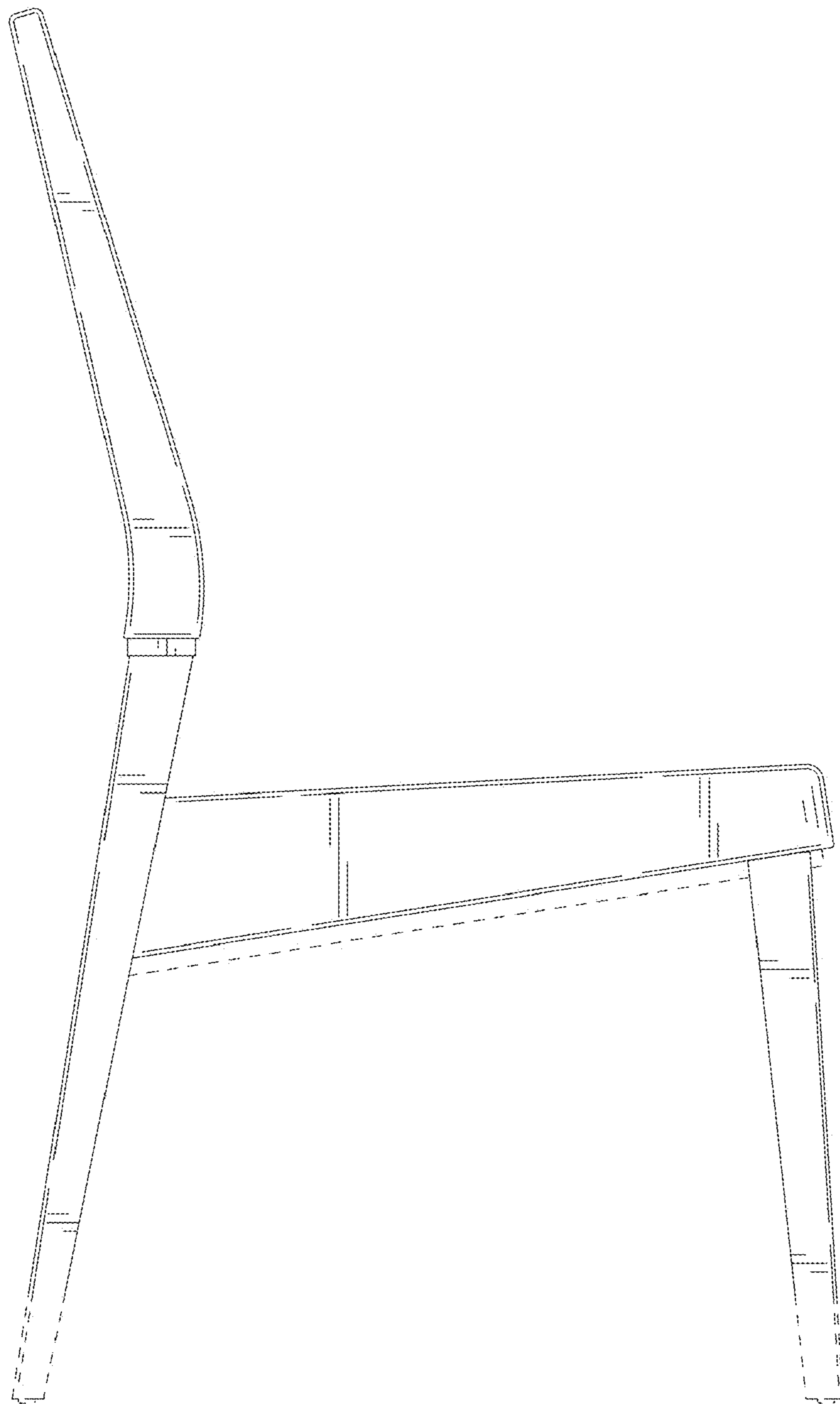

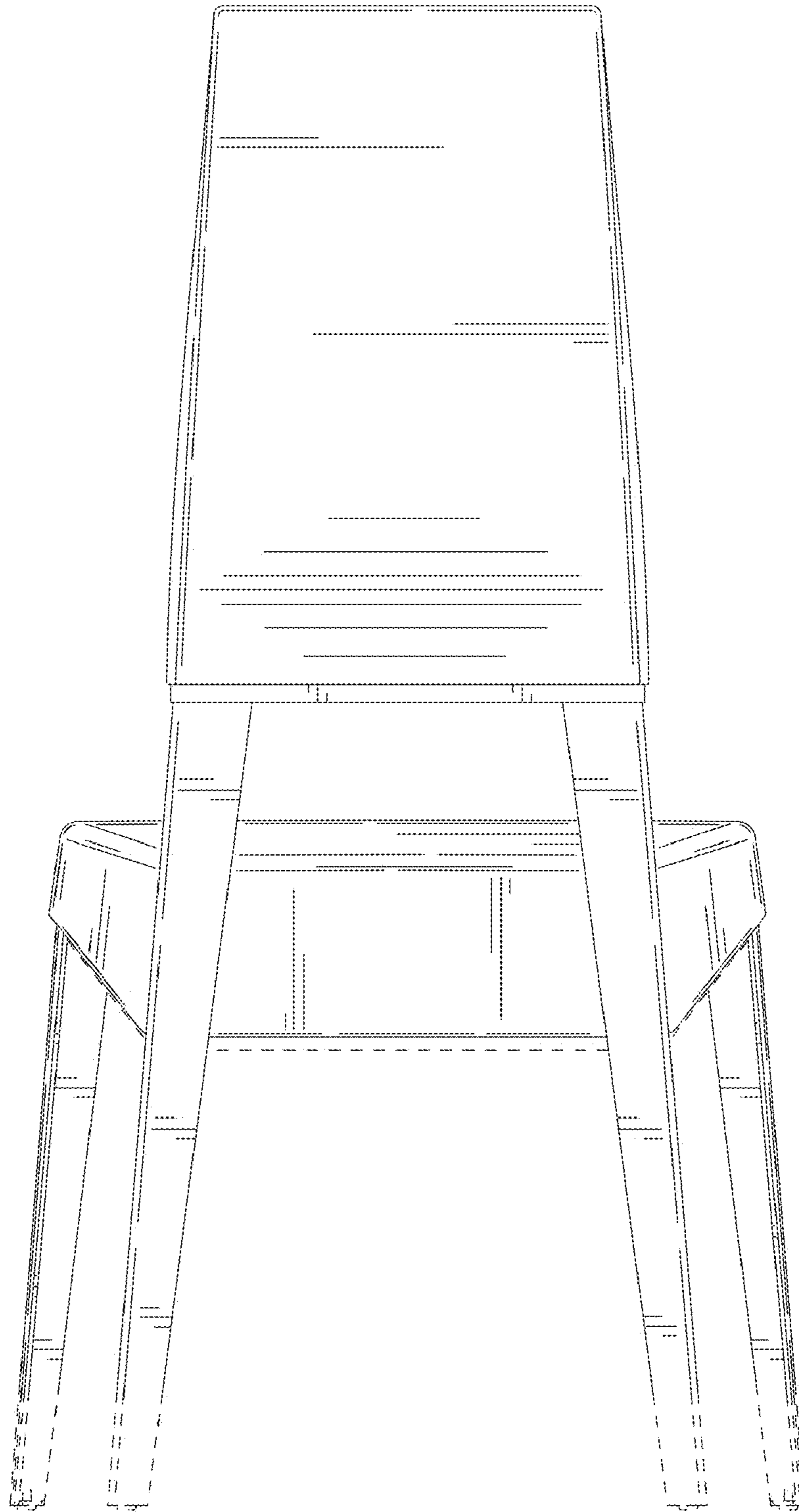

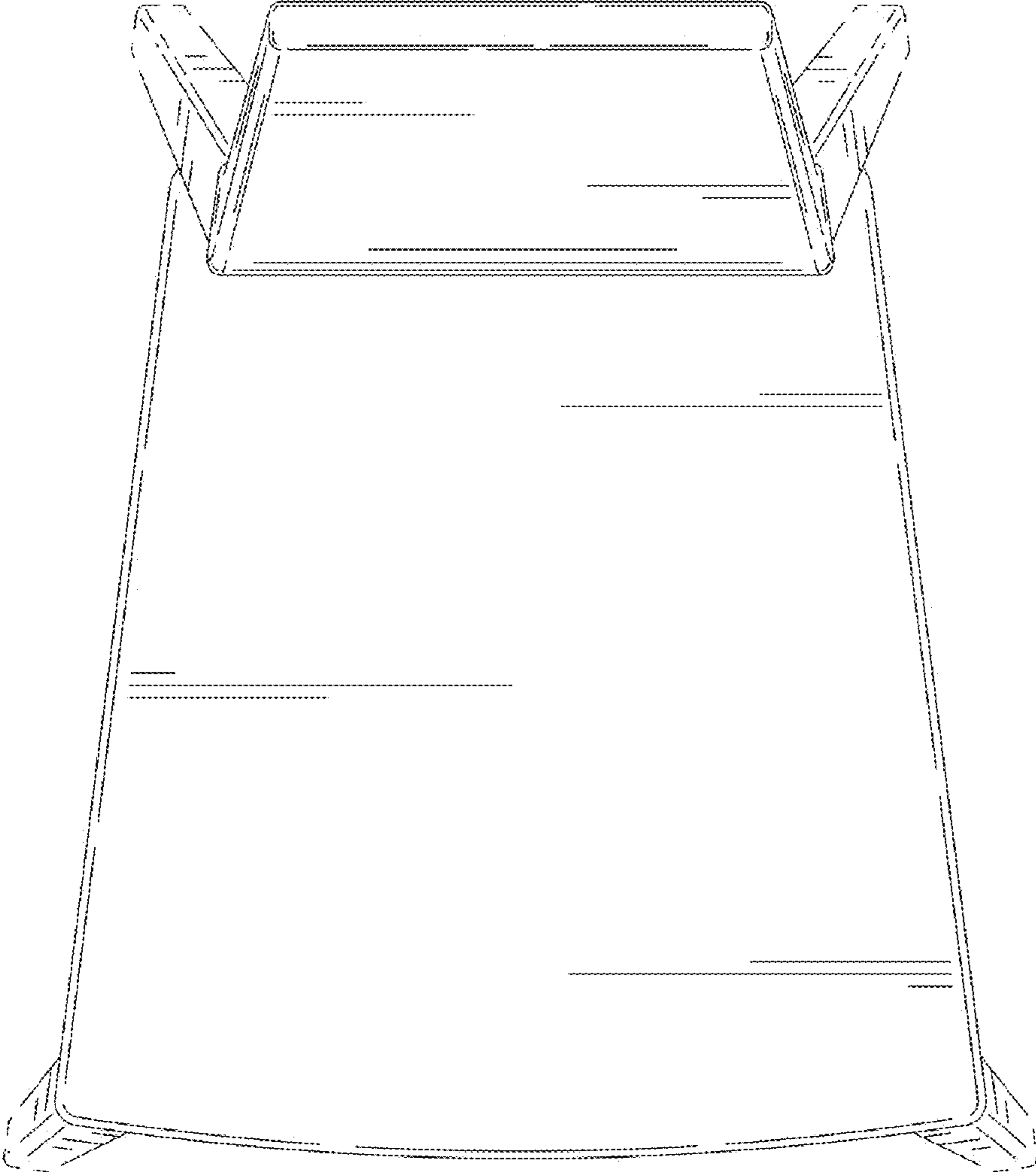

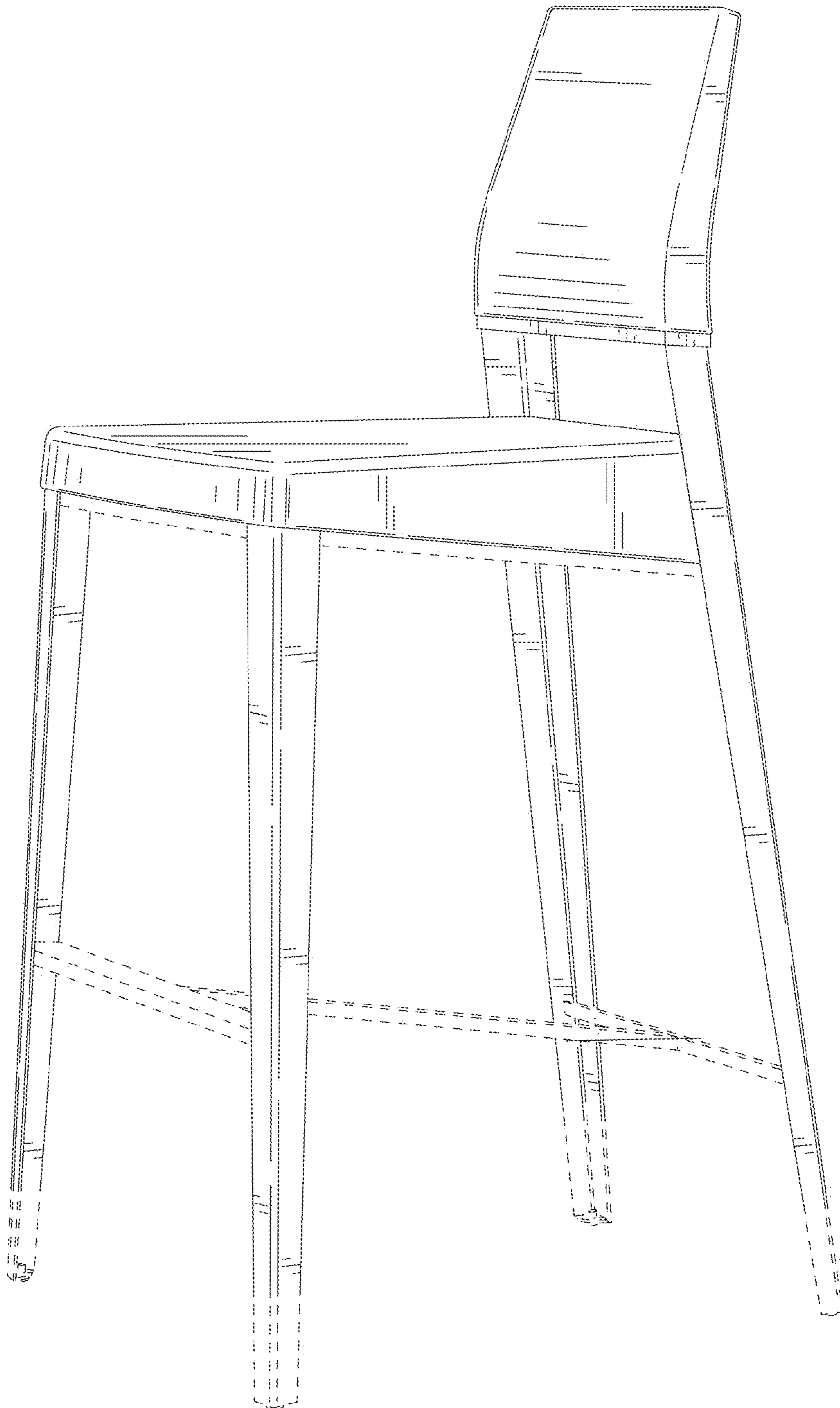

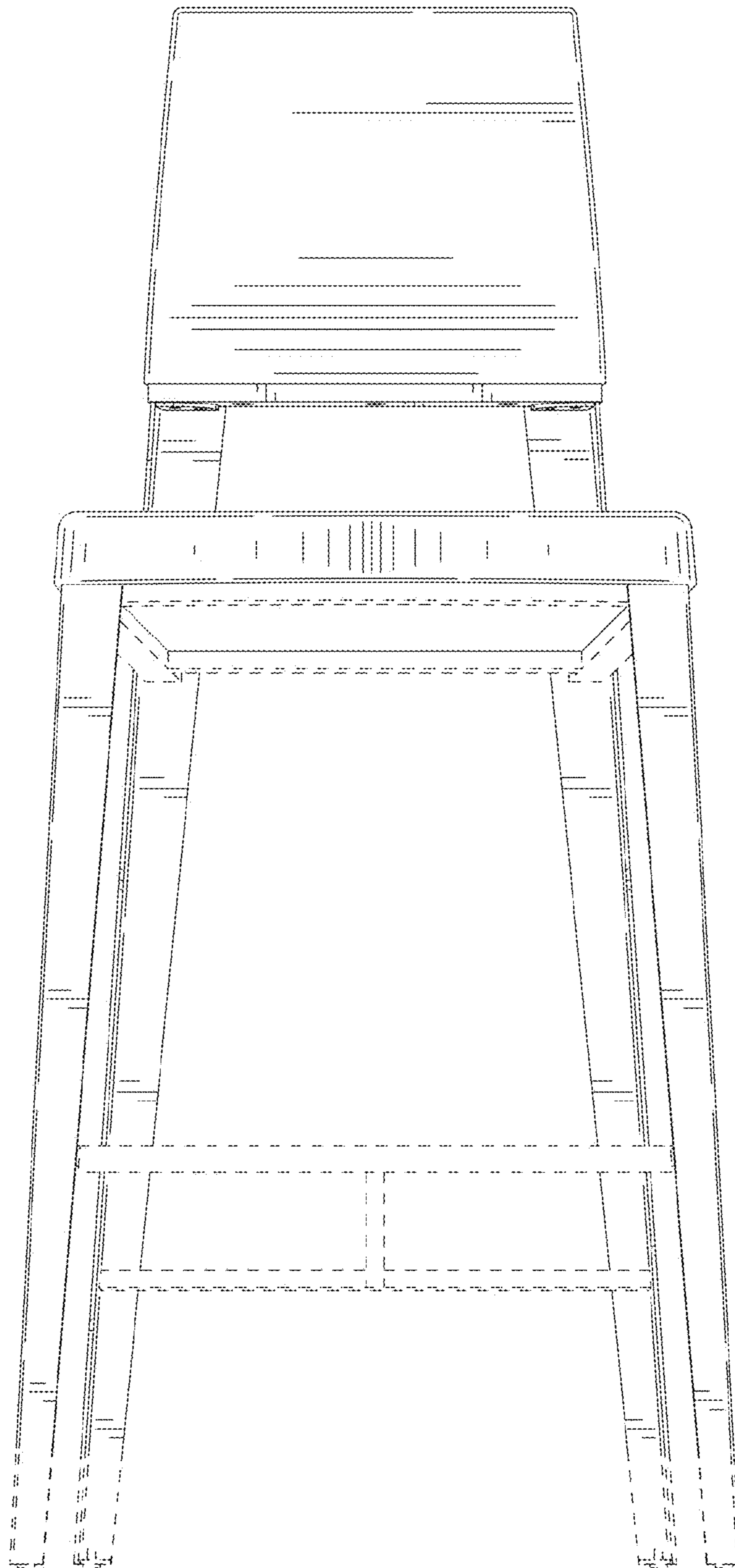

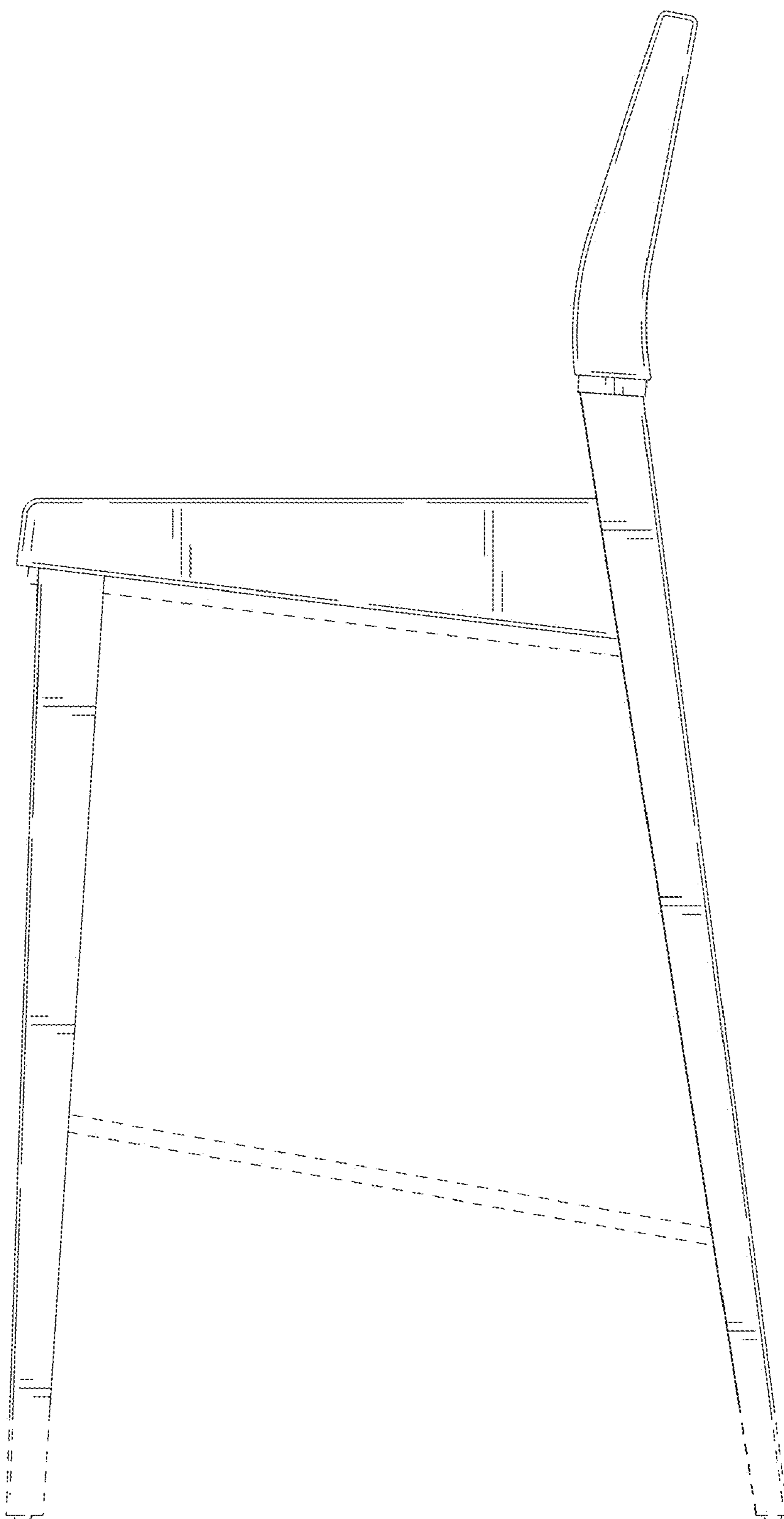

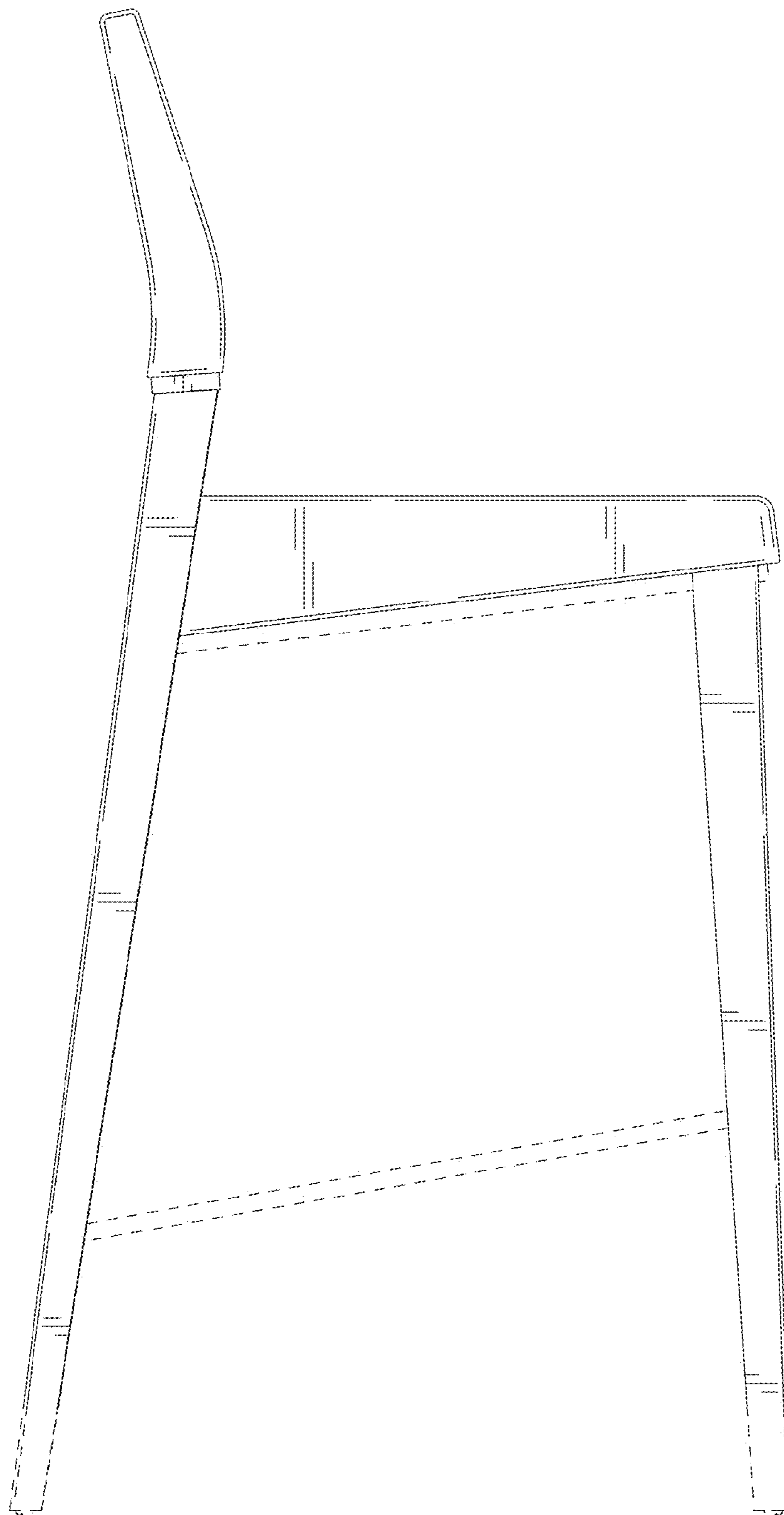

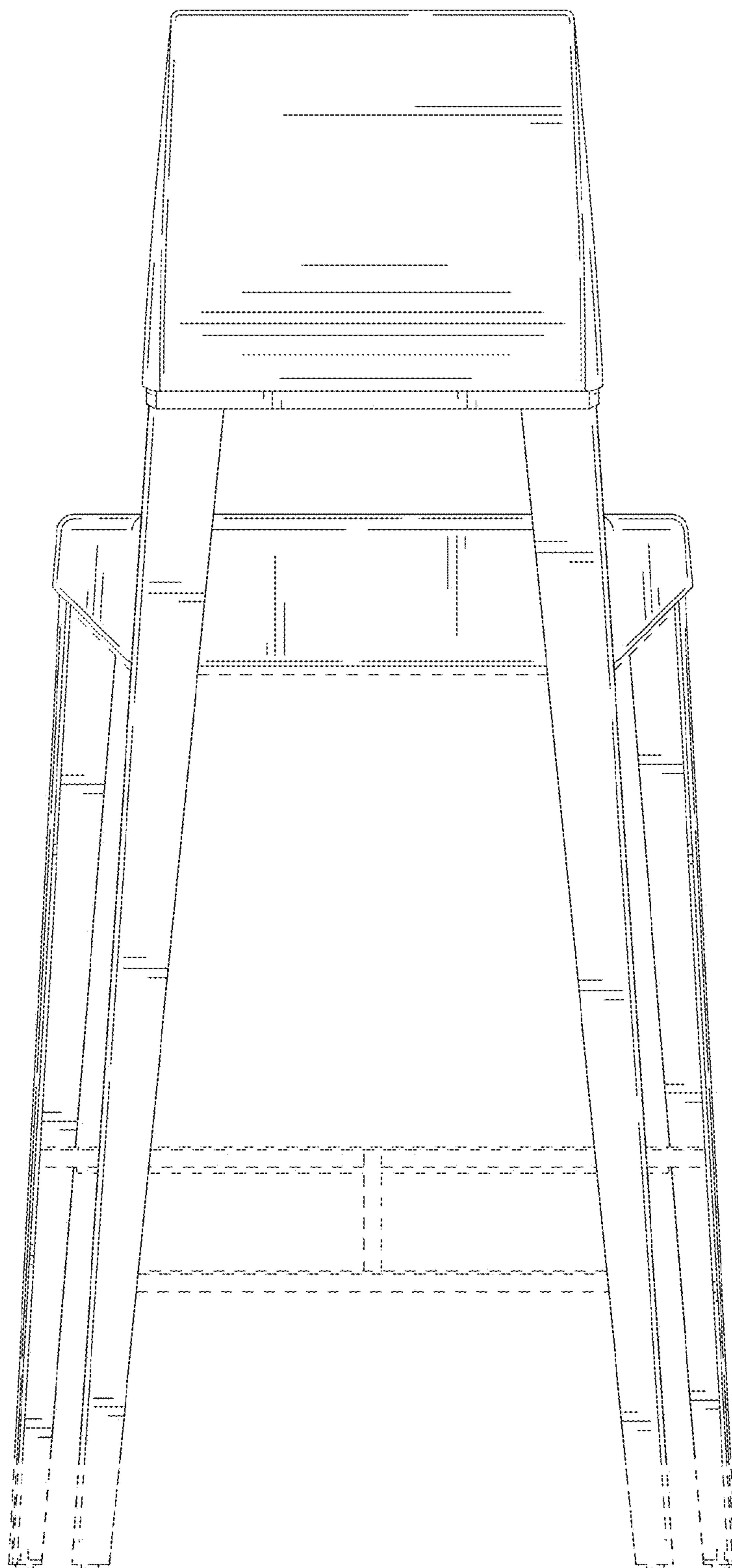

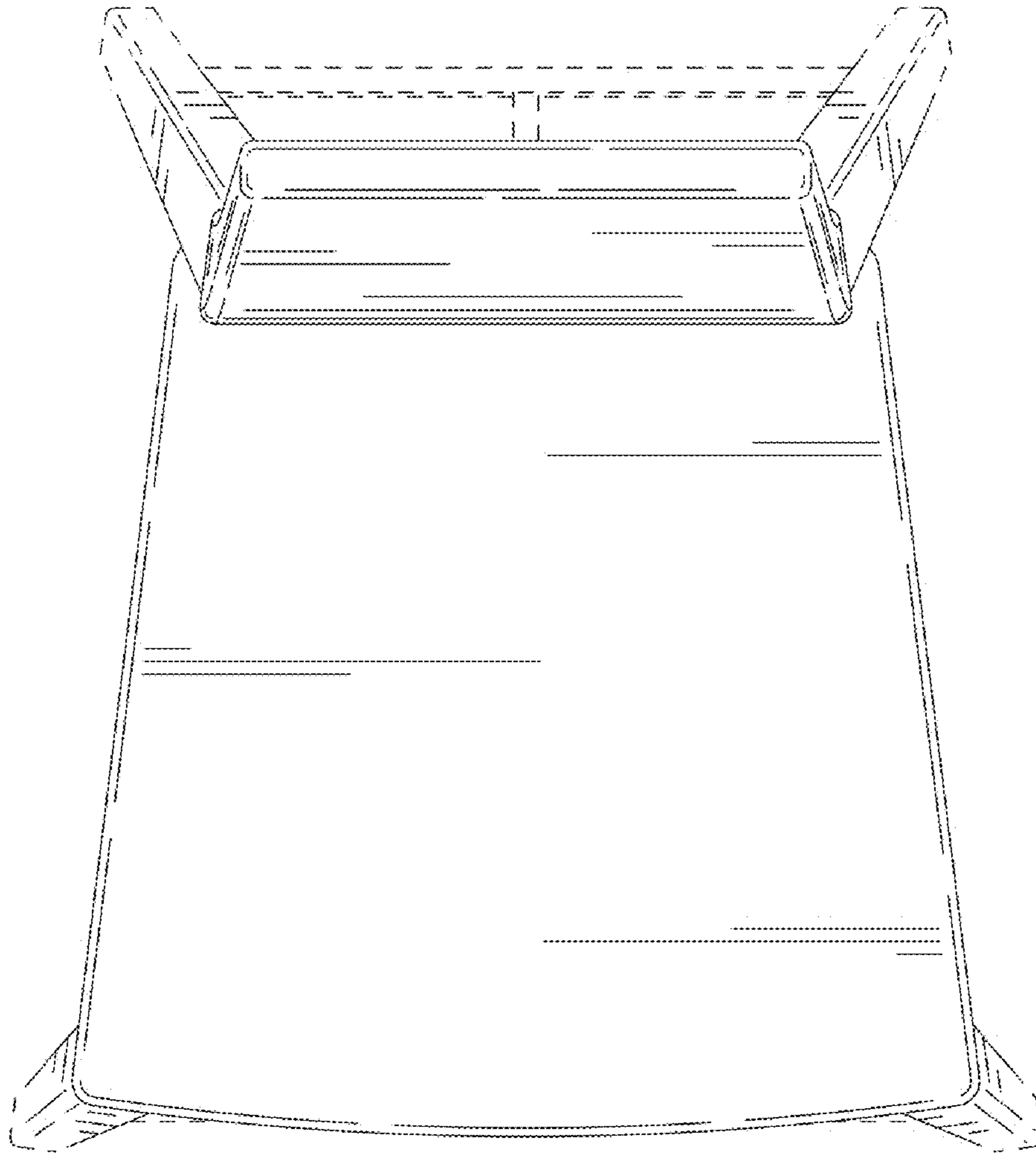
