(57) **CLAIM**

The ornamental designs for a coffee maker, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a coffee maker in accordance with the present invention;  
 FIG. 2 is a top view of the coffee maker shown in FIG. 1;  
 FIG. 3 is a front view of the coffee maker shown in FIG. 1;  
 FIG. 4 is a left side view of the coffee maker shown in FIG. 1;  
 FIG. 5 is a right side view of the coffee maker shown in FIG. 1; and,  
 FIG. 6 is a rear view of the coffee maker shown in FIG. 1.  
 The bottom view of the coffee maker has not been shown as it is not a part of the design.  
 The broken lines in the drawings are included for the purpose of illustration and form no part of the claimed design.

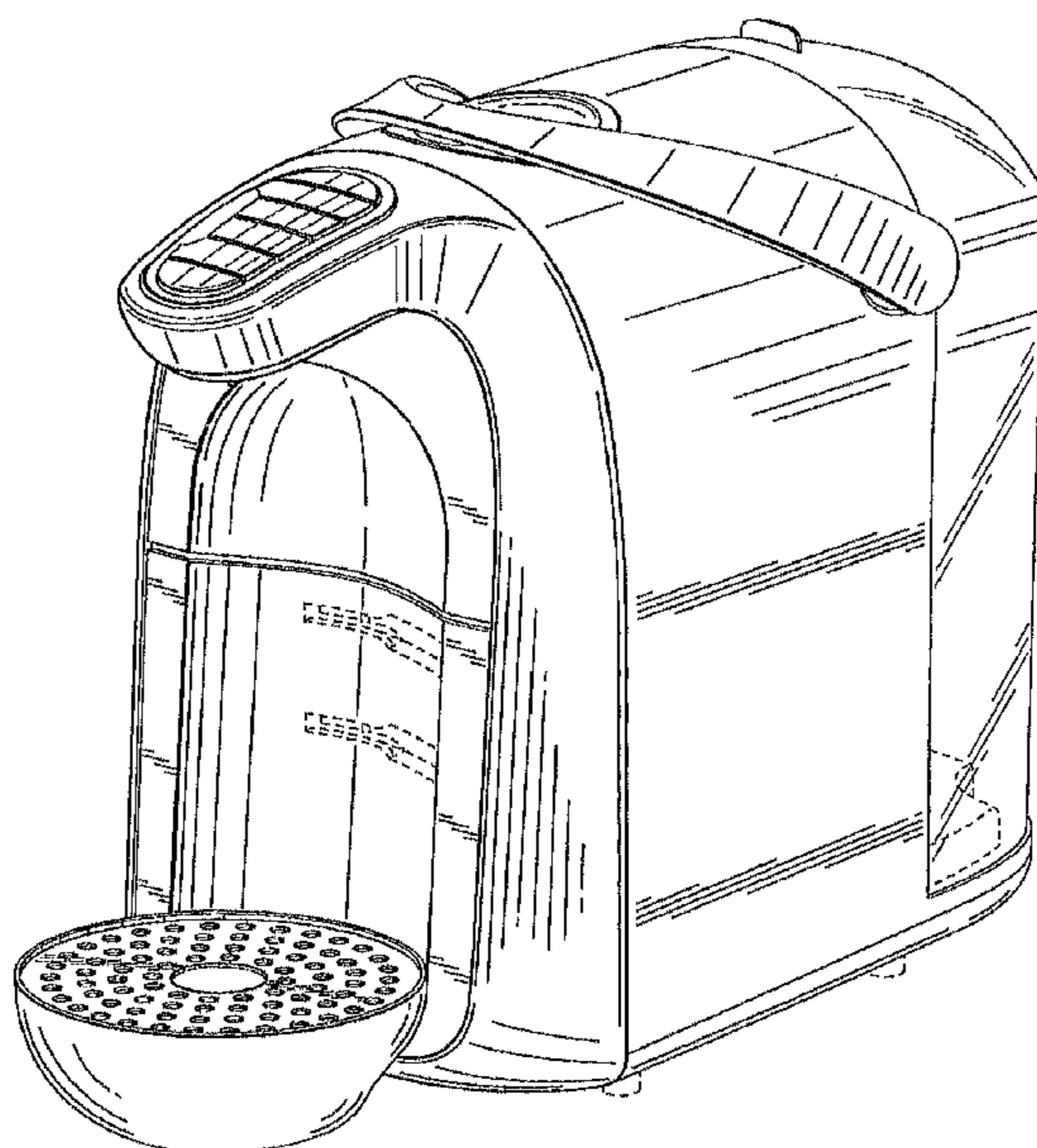

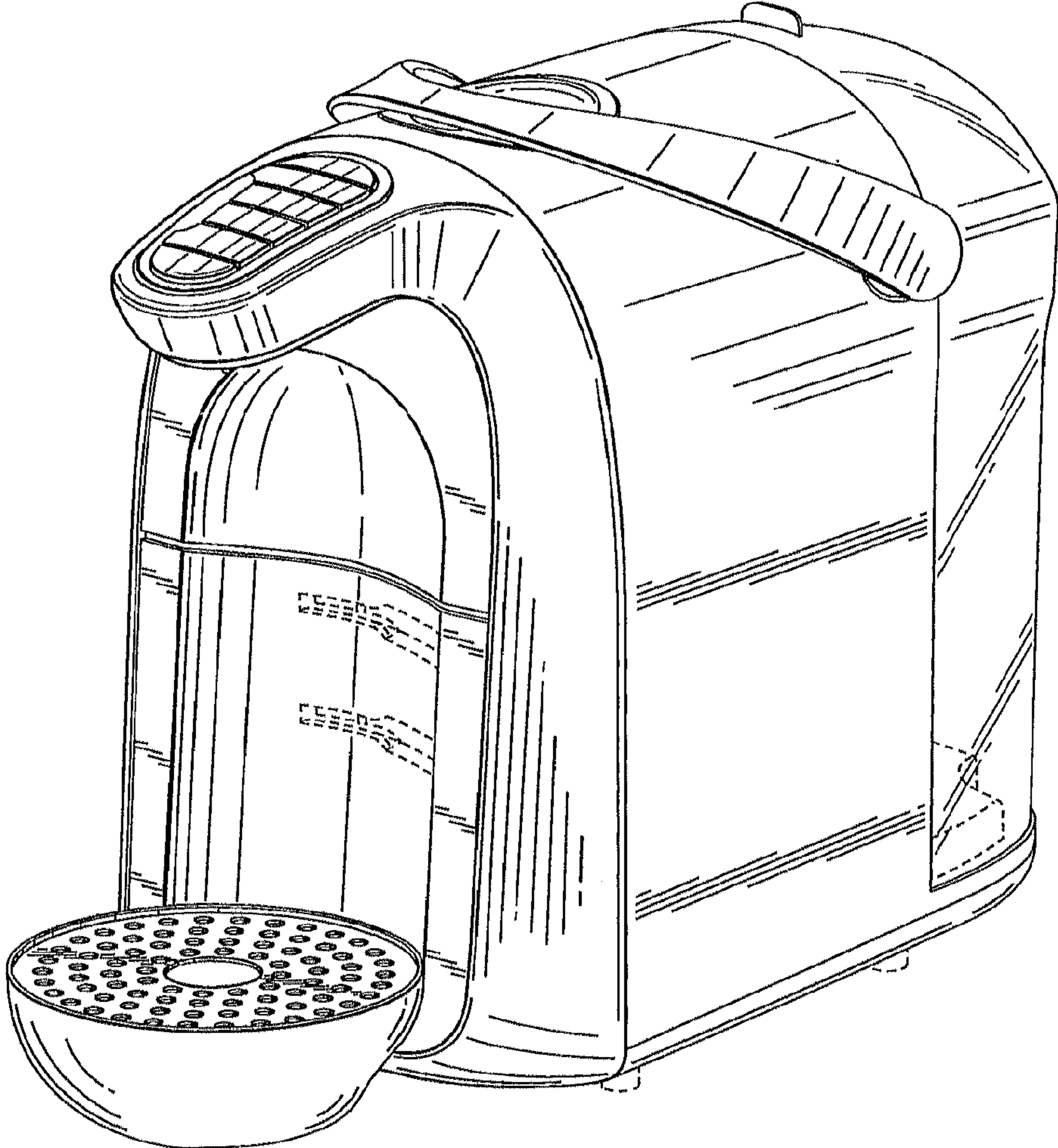

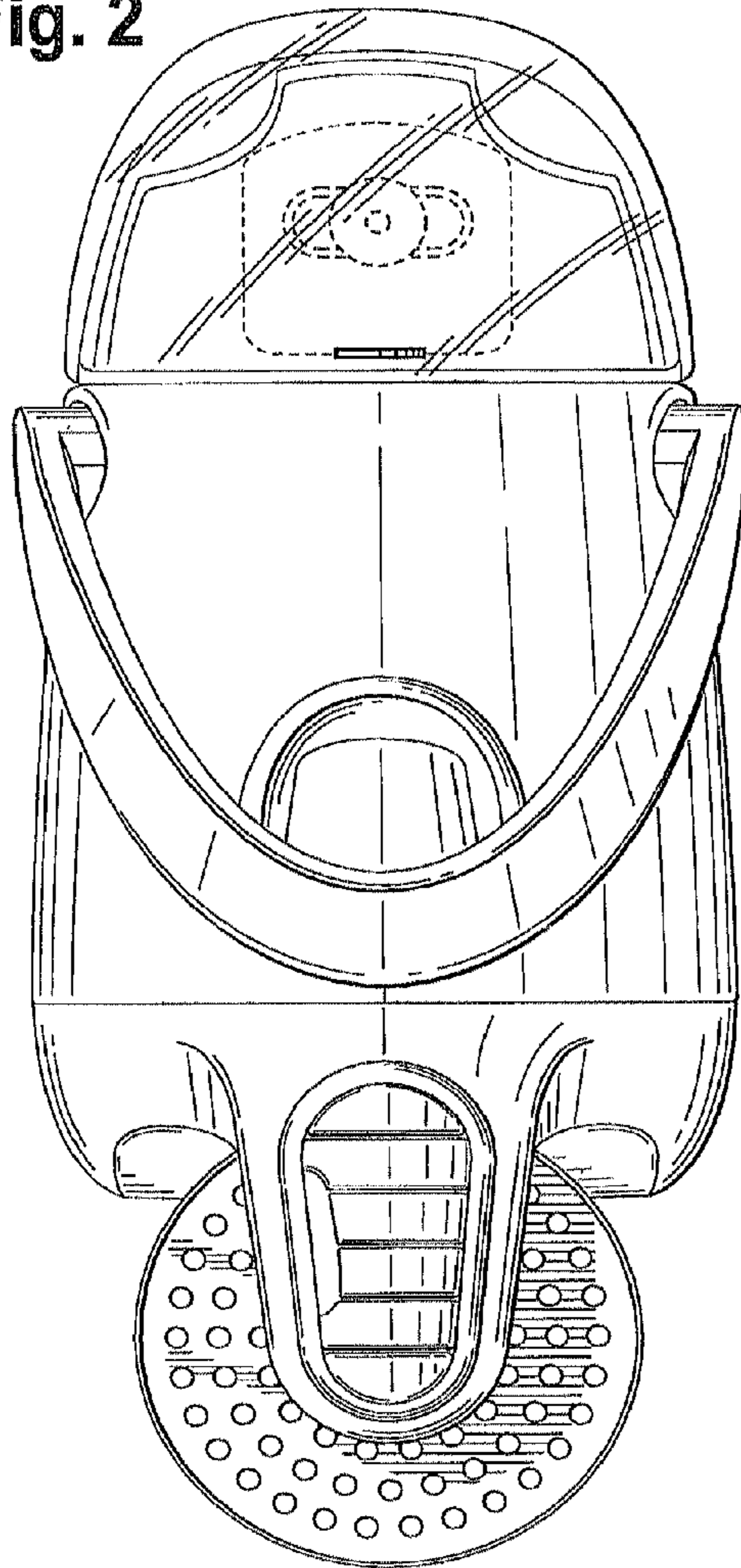

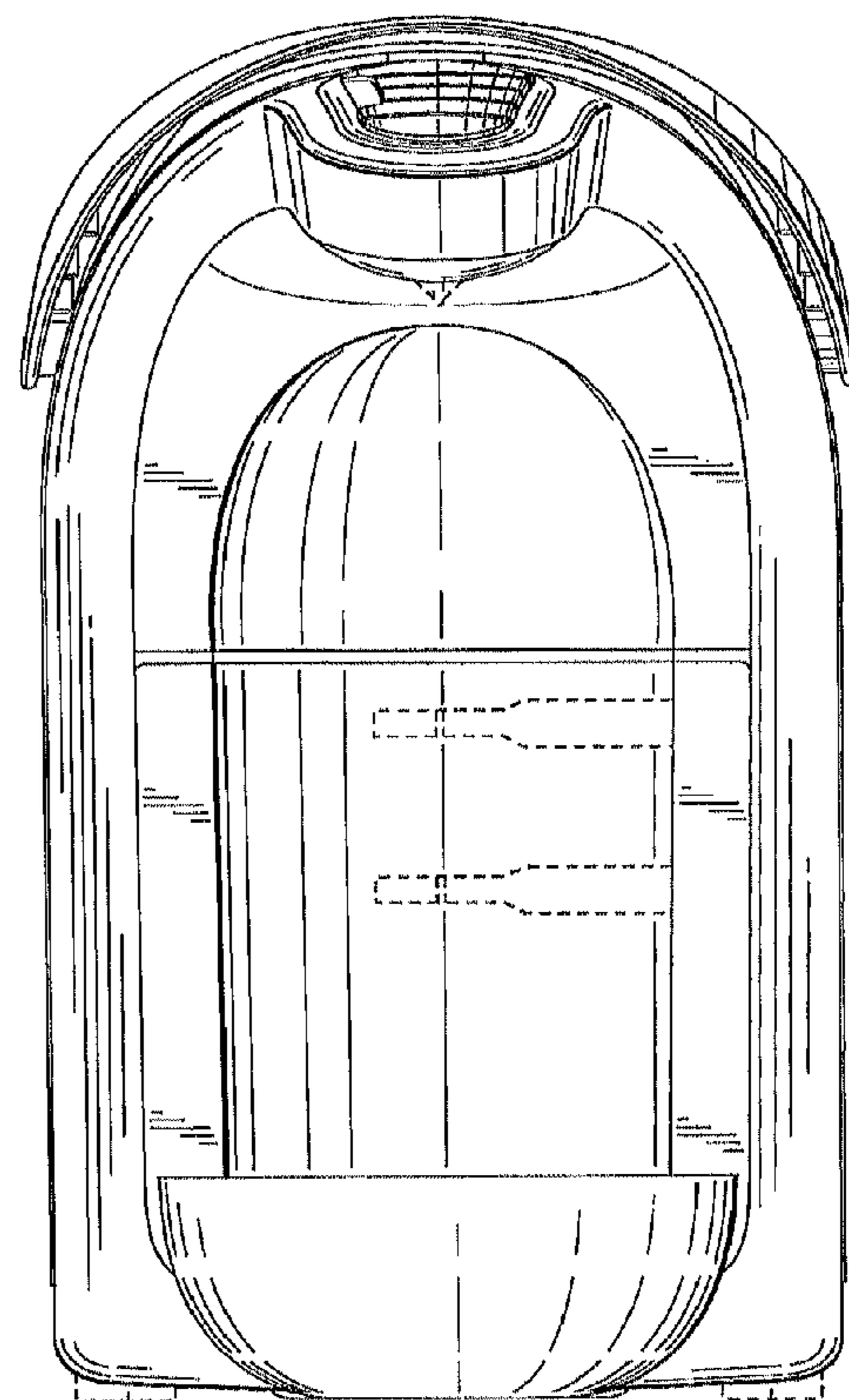

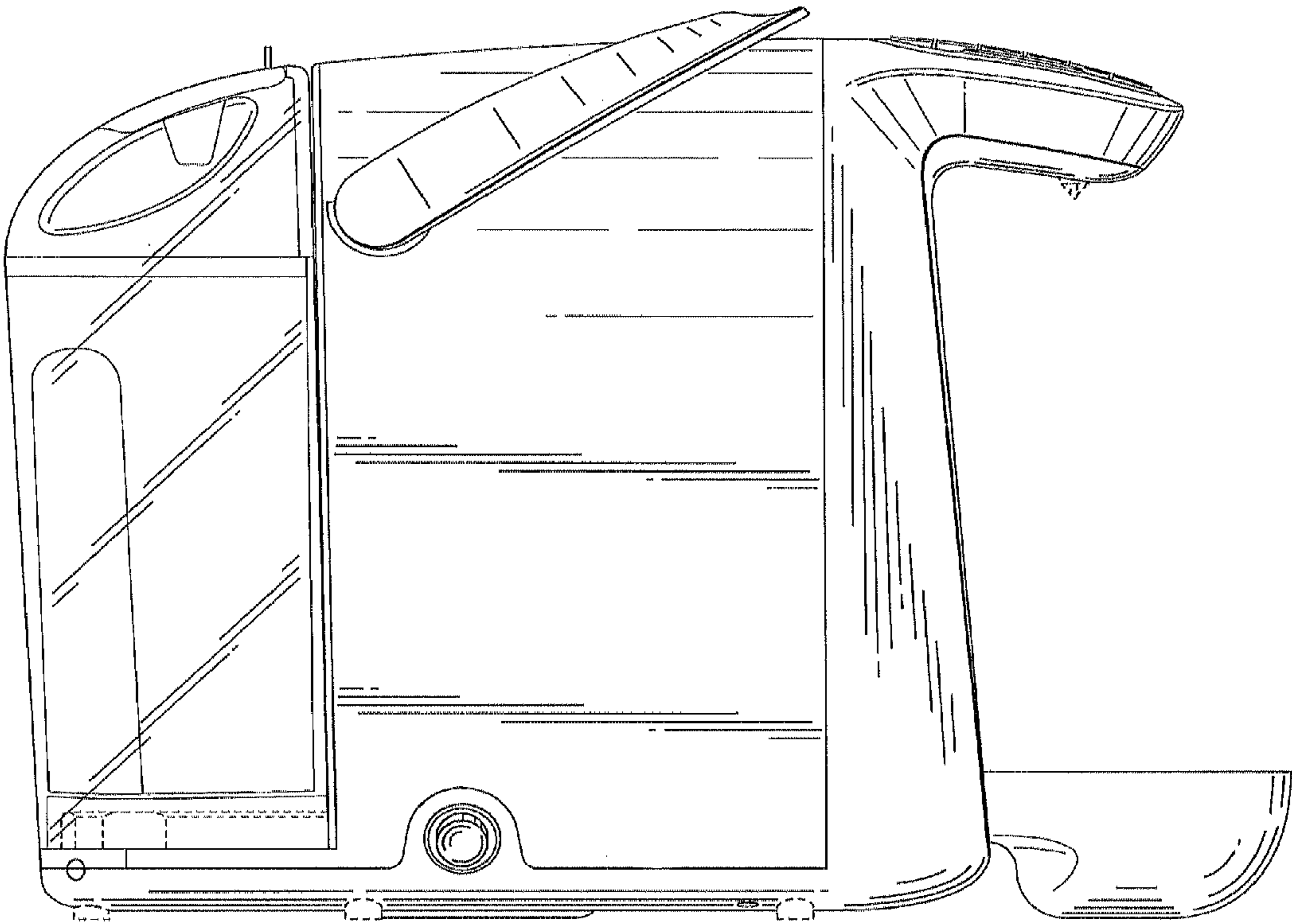

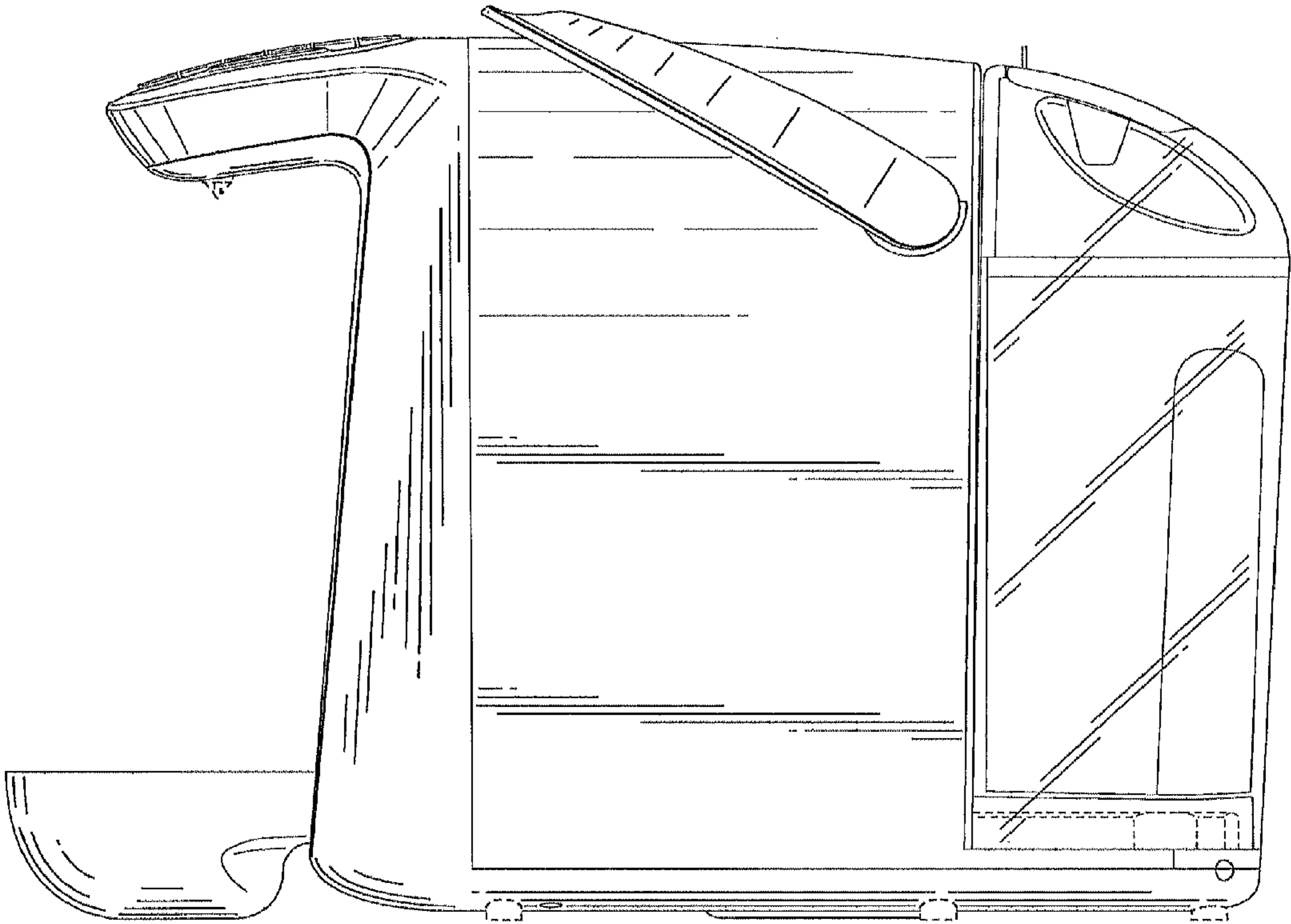
