(57) **CLAIM**

I claim the ornamental design for a stack of wine glass container devices, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a stack of wine glass container devices showing my new design;

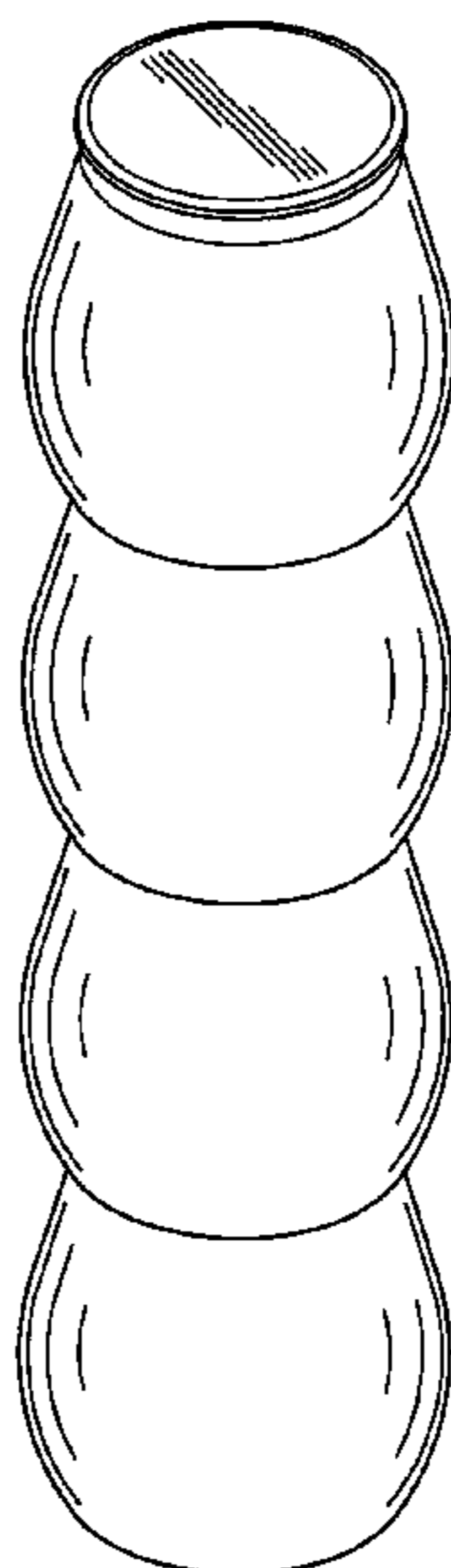
FIG. 2 is a front view of the stack of wine glass container devices of FIG. 1 as claimed with the left side, right side and rear views being identical;

FIG. 3 is a top view of the stack of wine glass container devices of FIG. 1 as claimed; and,

FIG. 4 is a bottom view of the stack of wine glass container devices of FIG. 1 as claimed.

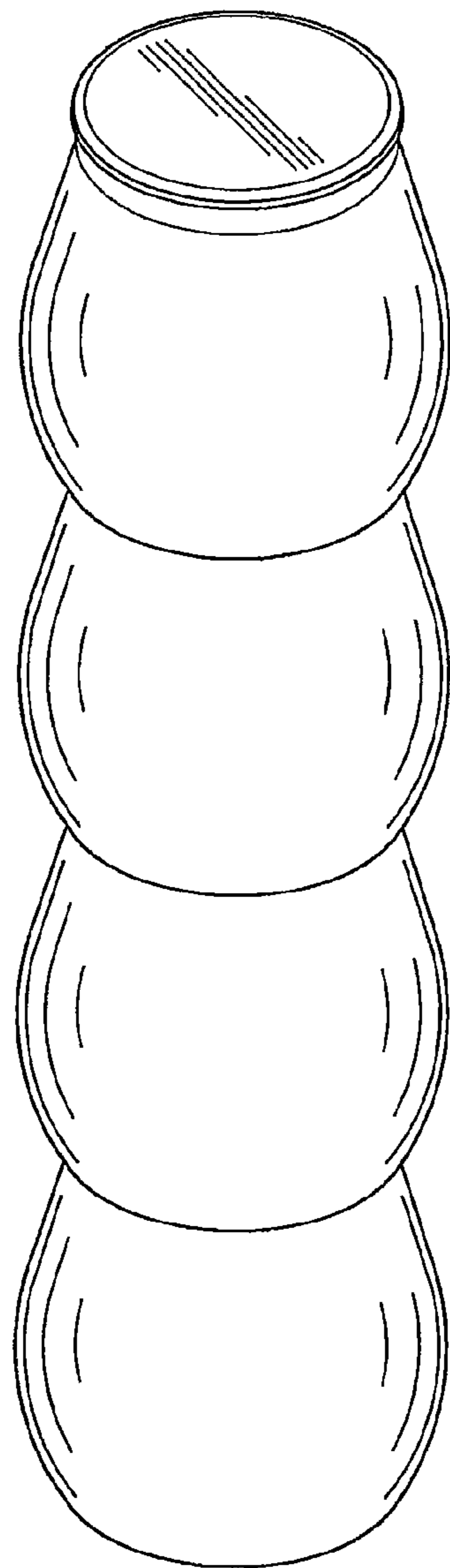

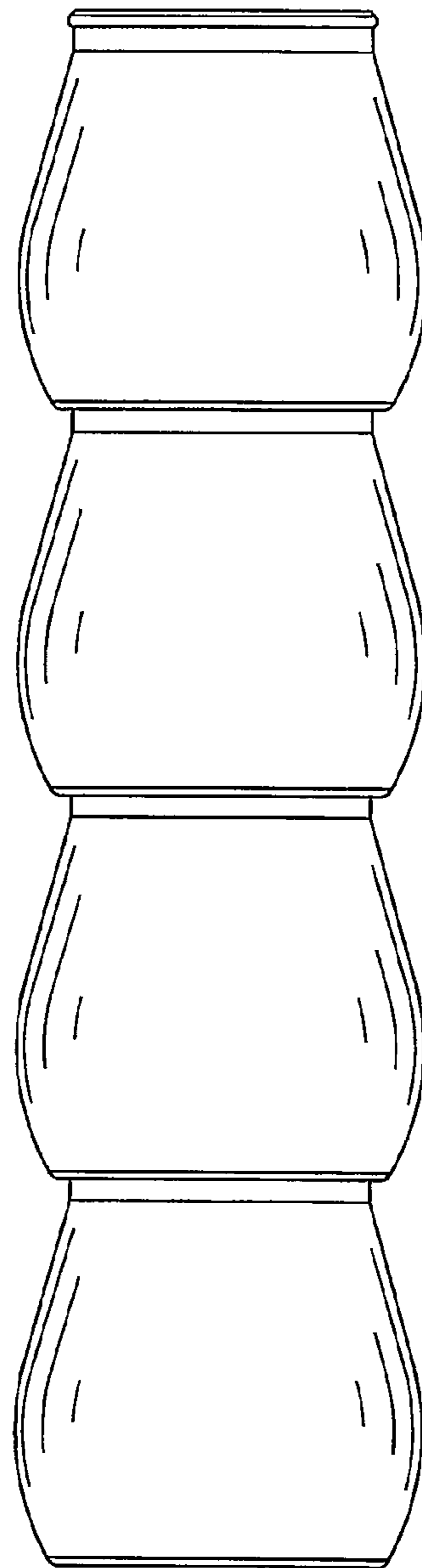

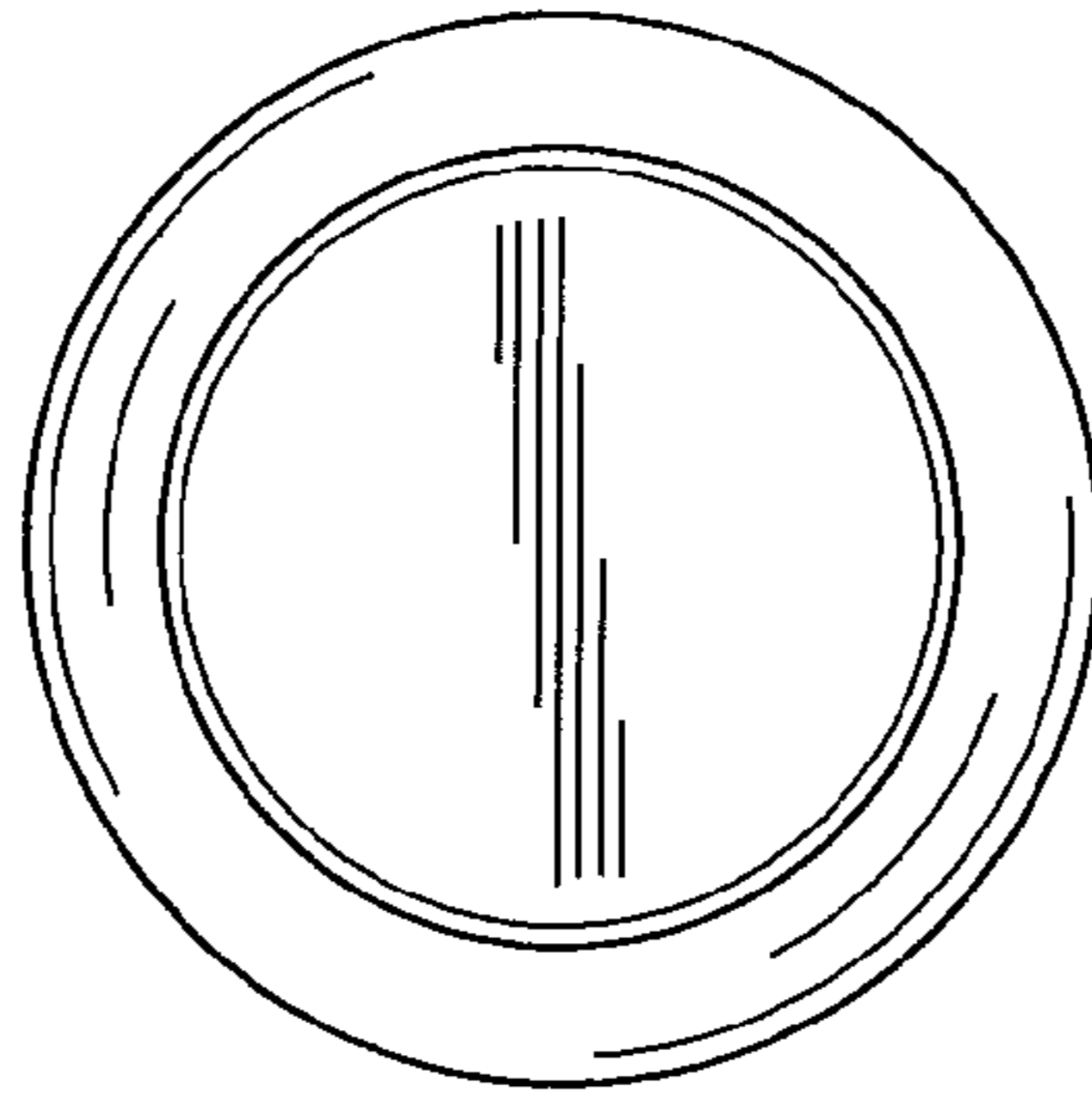

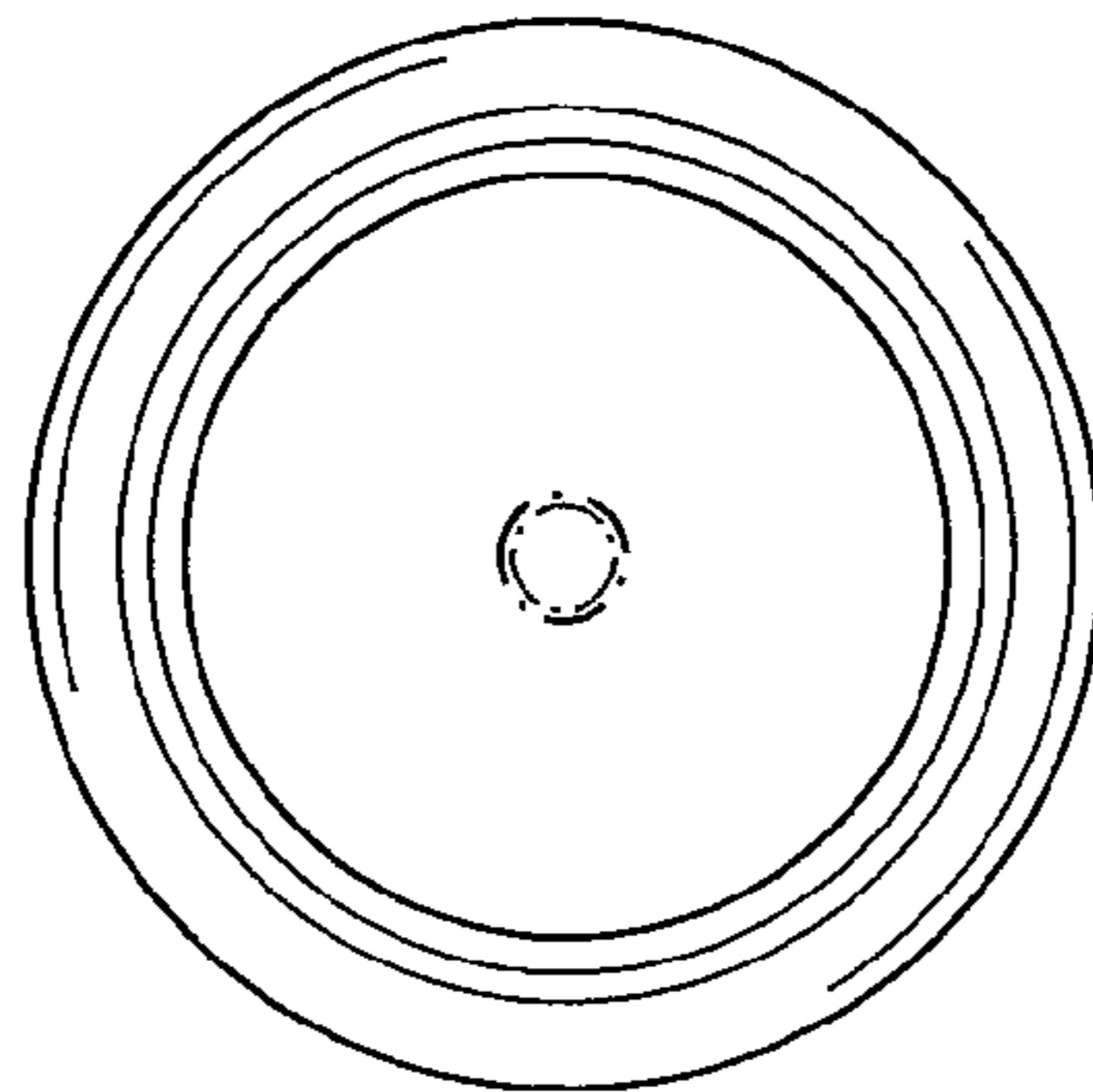
