(57) **CLAIM**

The ornamental design for a motor vehicle and/or toy replica thereof, as shown and described.

DESCRIPTION

FIG. 1 is a left, front perspective view of a motor vehicle and/or toy replica thereof showing our new design;
FIG. 2 is a left, rear perspective view thereof;
FIG. 3 is a left side view elevation thereof, the right side elevation view being a mirror image;

FIG. 4 is a top view thereof;

FIG. 5 is a front elevation view thereof; and,

FIG. 6 is a rear elevation view thereof.

The claimed design is indicated by the relatively dark portions in FIGS. 1-6, while the relatively light portions thereof are environmental and form no part of the claimed design.
The broken lines are for the purpose of illustrating portions of the motor vehicle and/or toy replica thereof and form no part of the claimed design.








