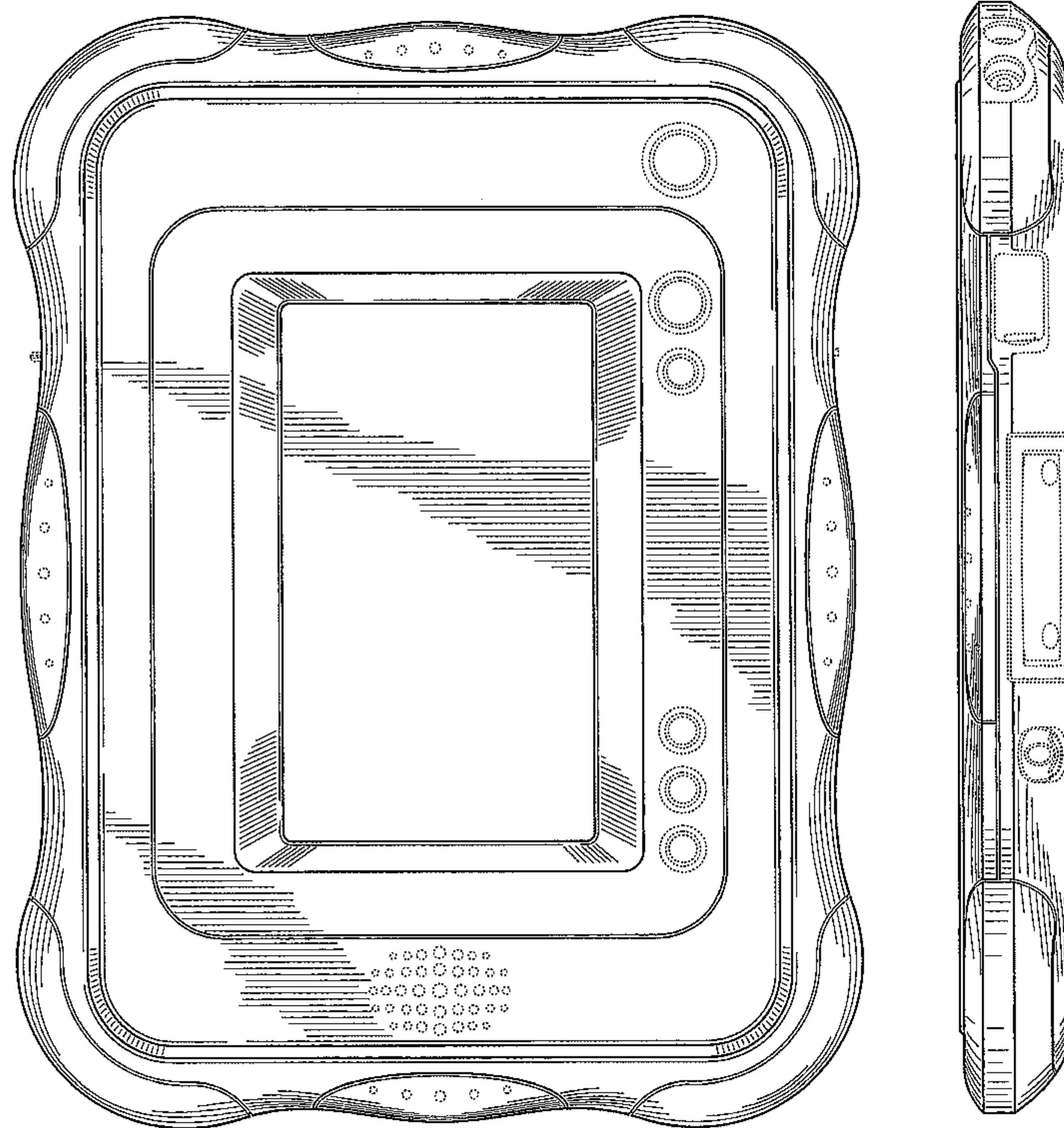
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front, left, bottom perspective view of my new design for an electronic device;

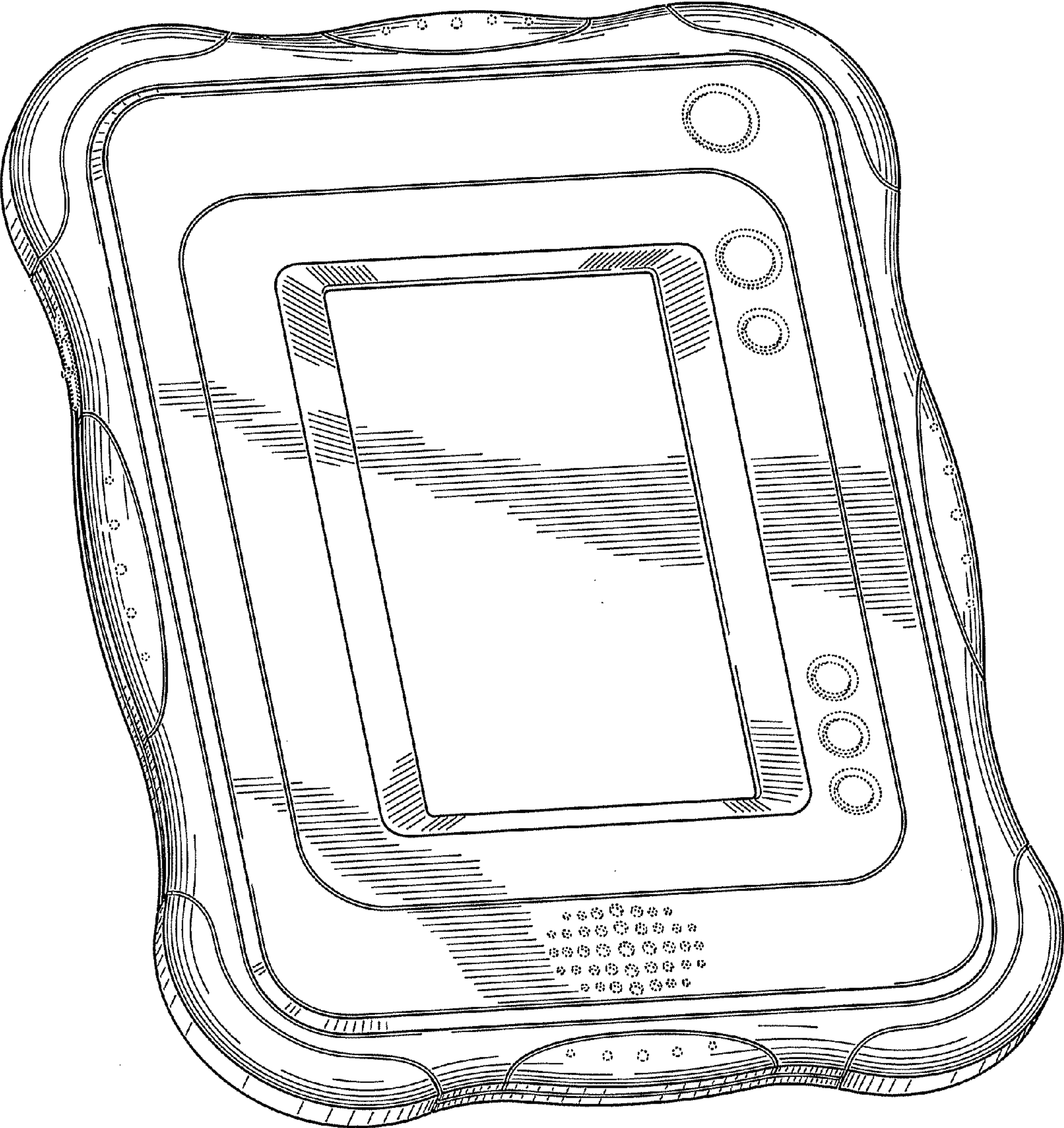

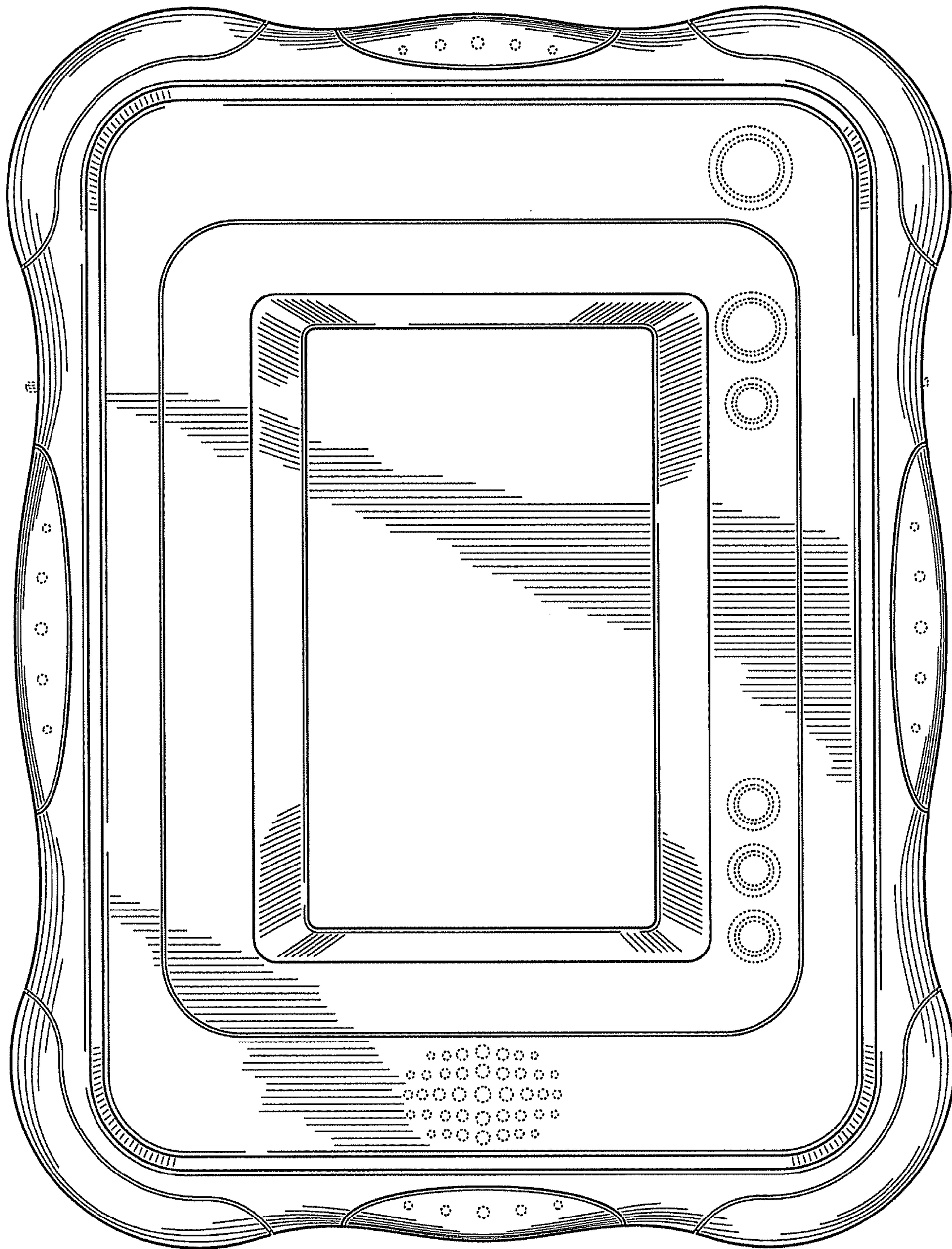

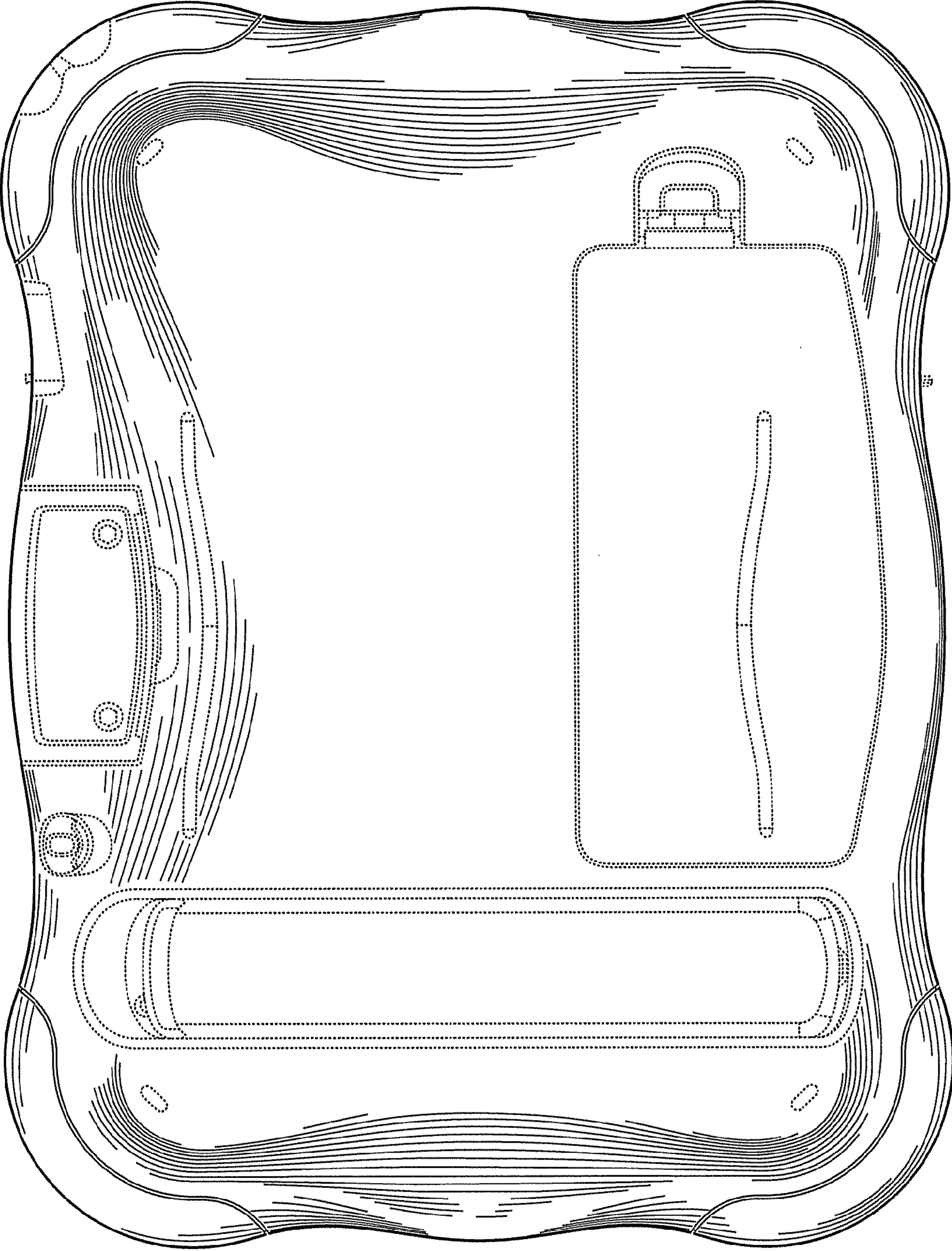

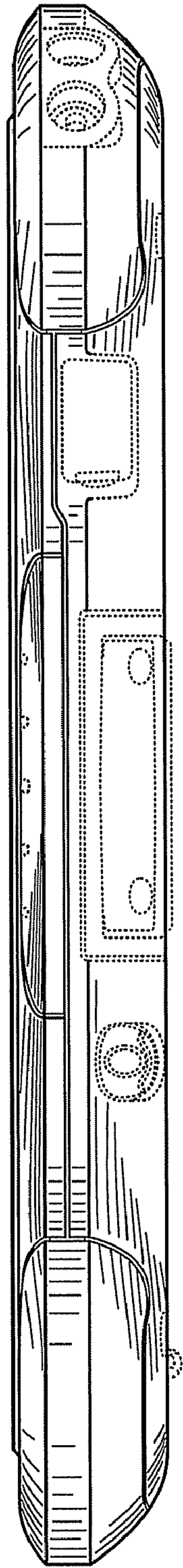

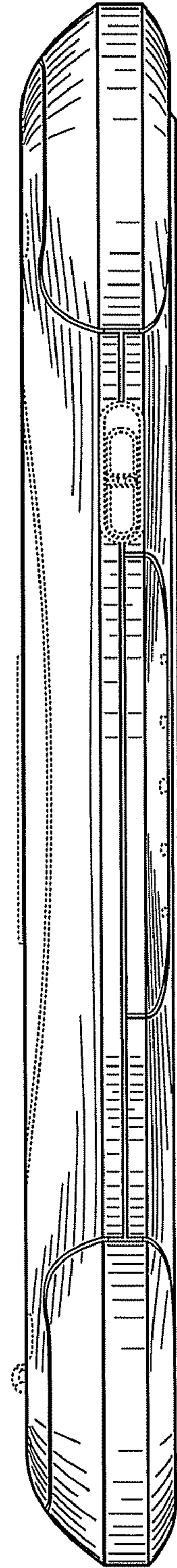

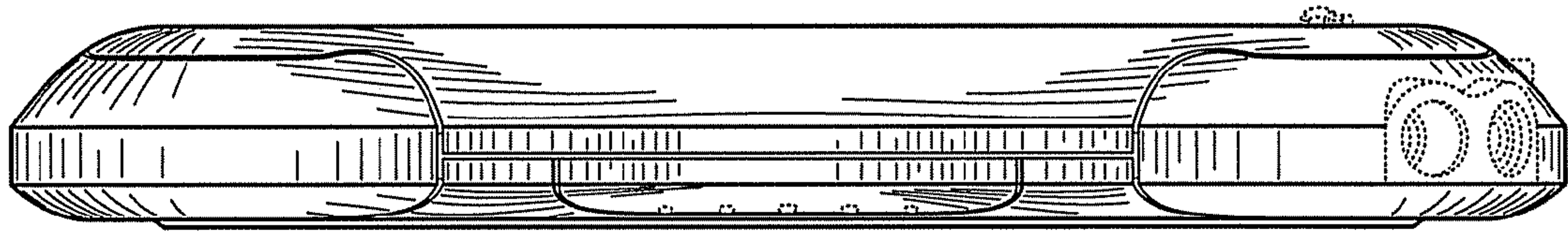

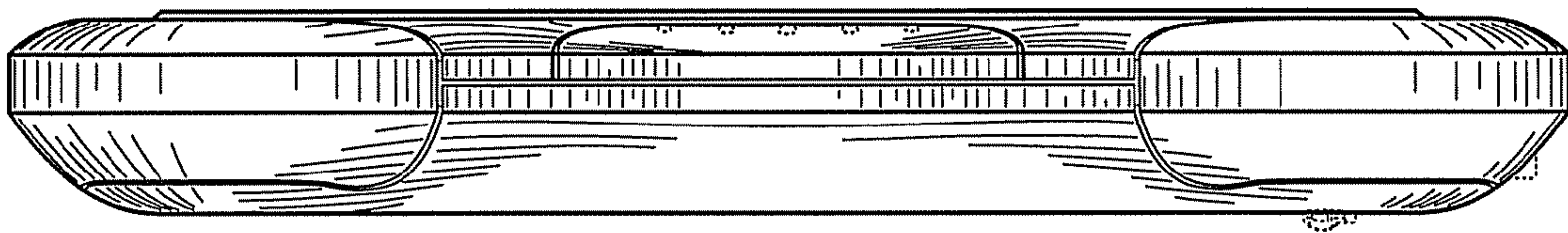
