FIG. 1 is a side view of the magnifier, showing our new design;

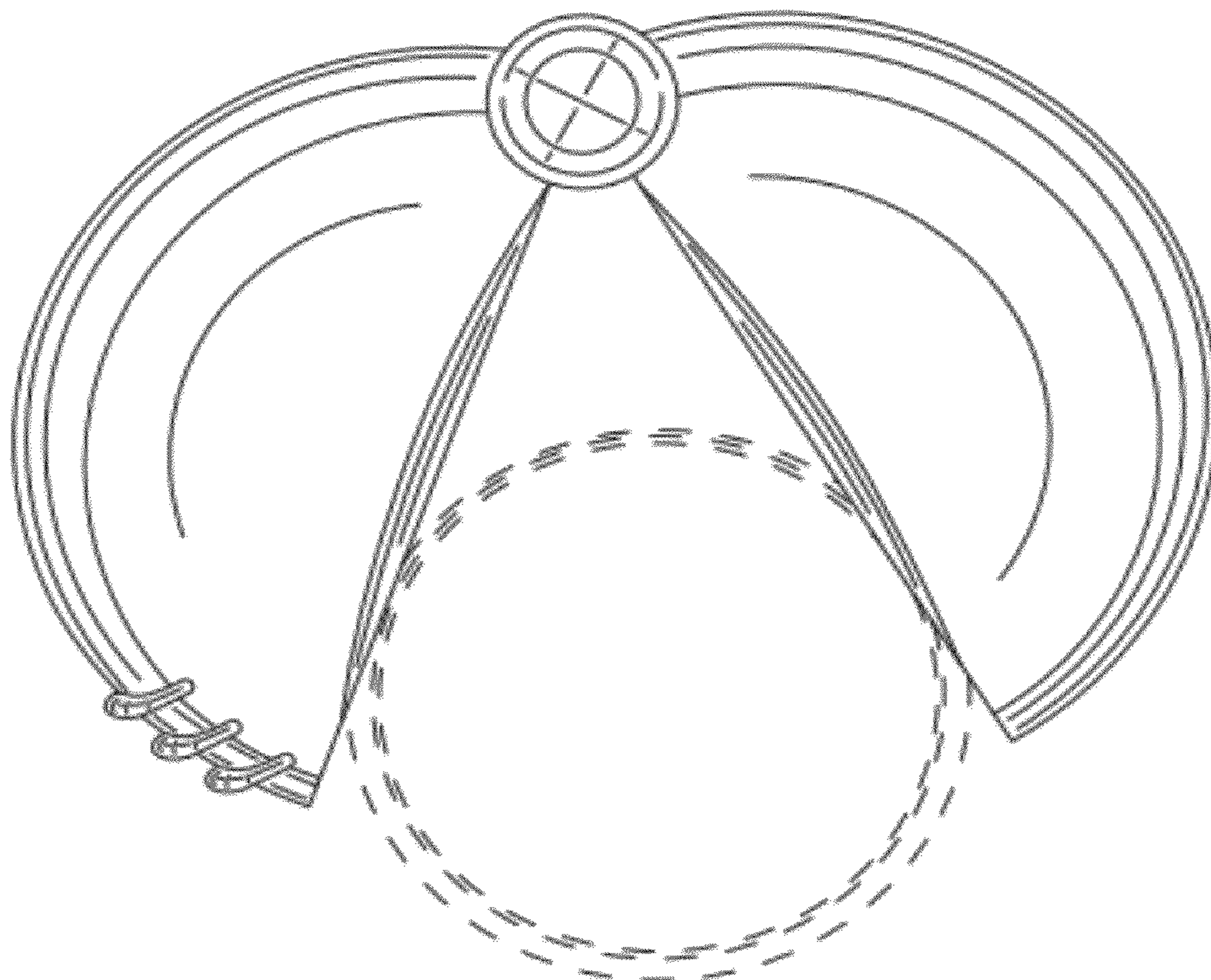
FIG. 2 is a top plan view thereof;

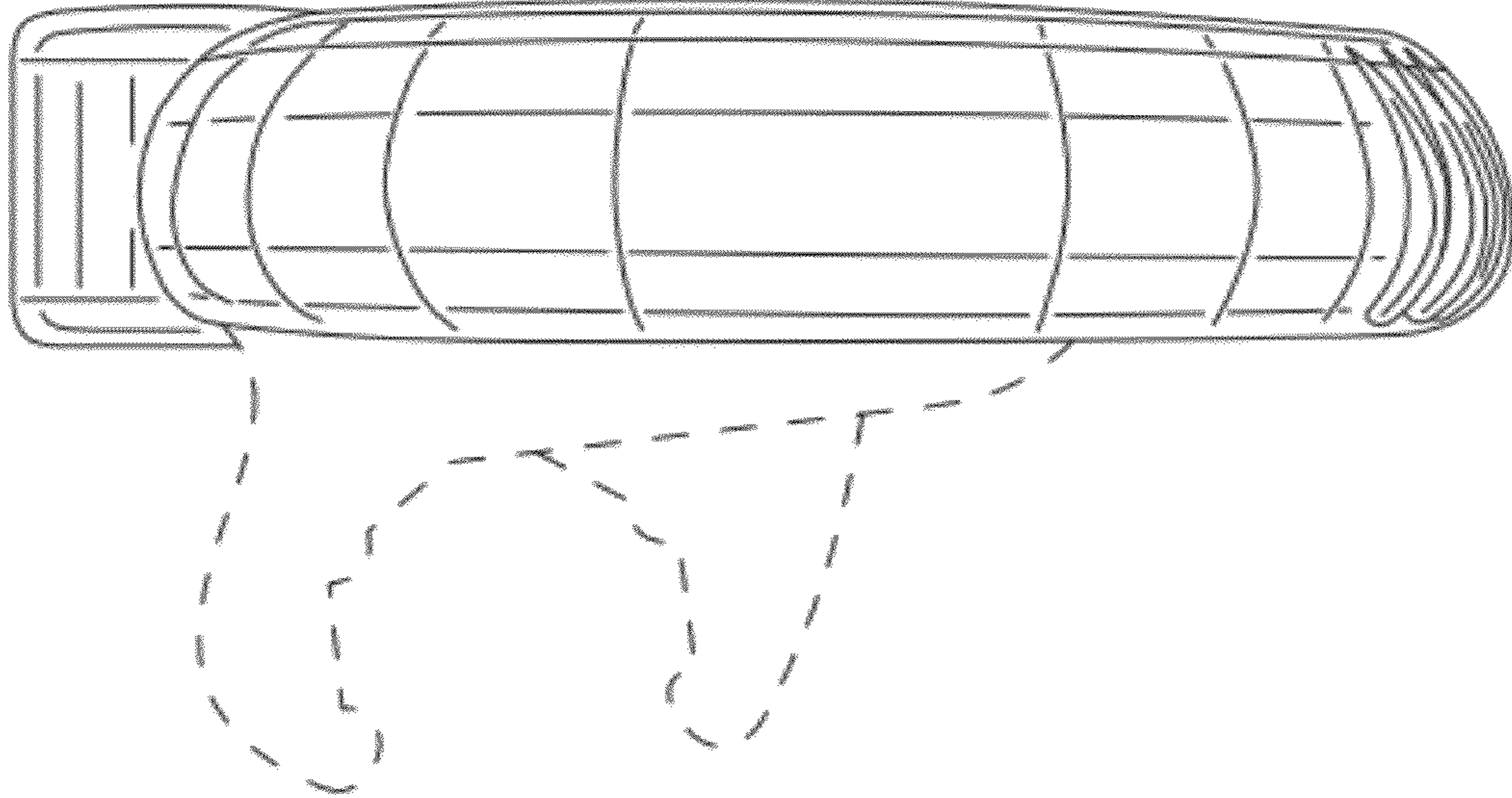

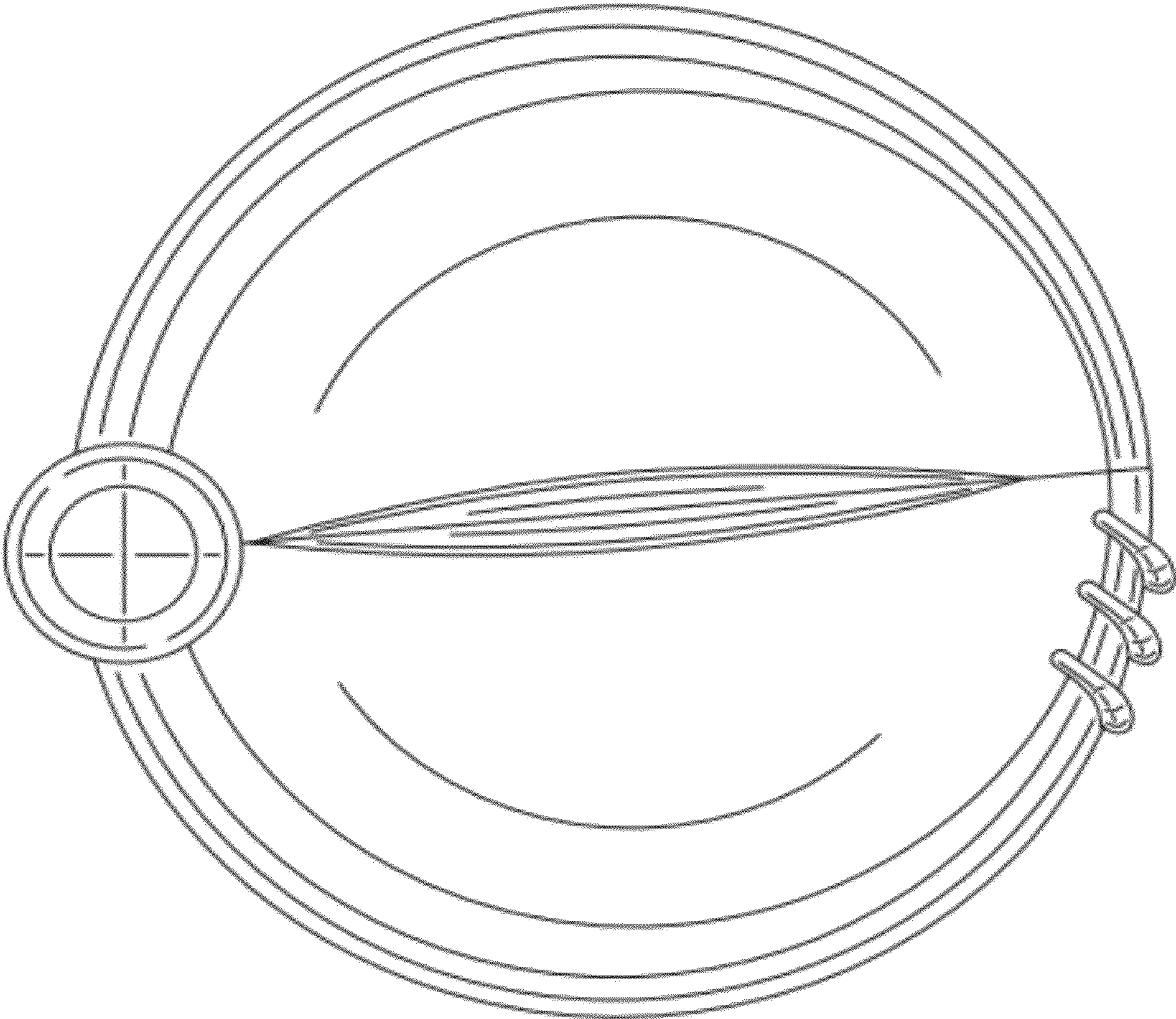

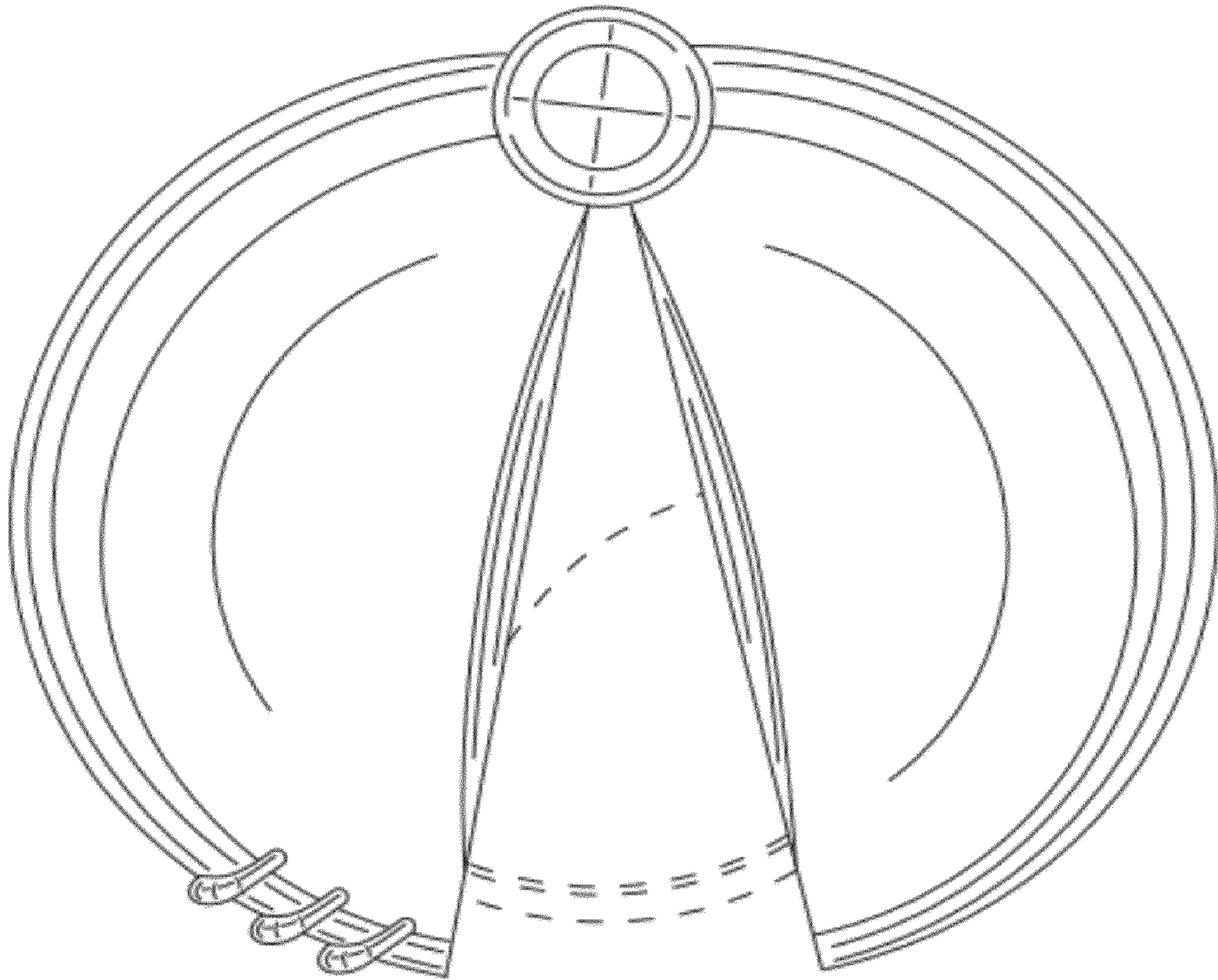

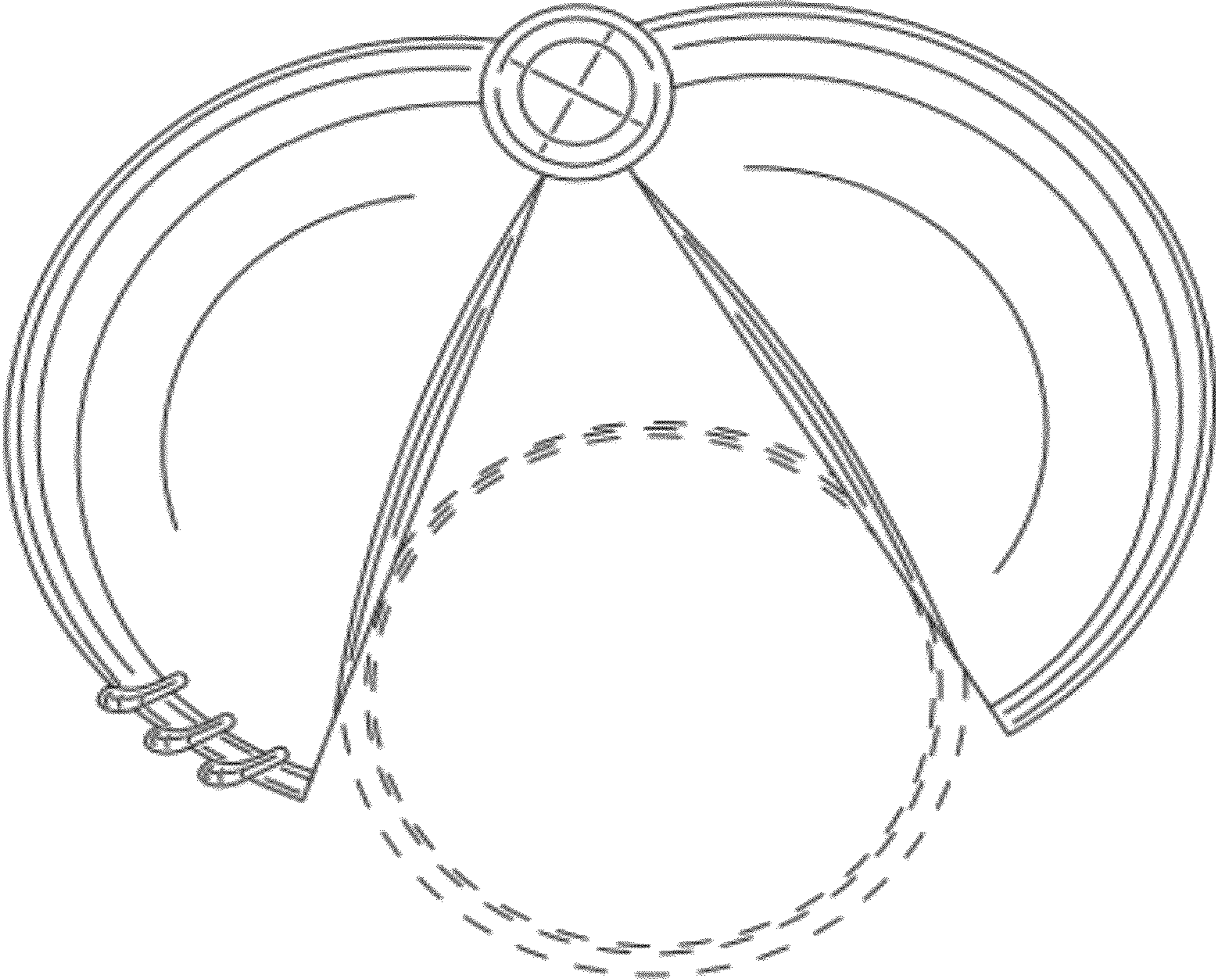
