The ornamental design for sunglasses, as shown and described.

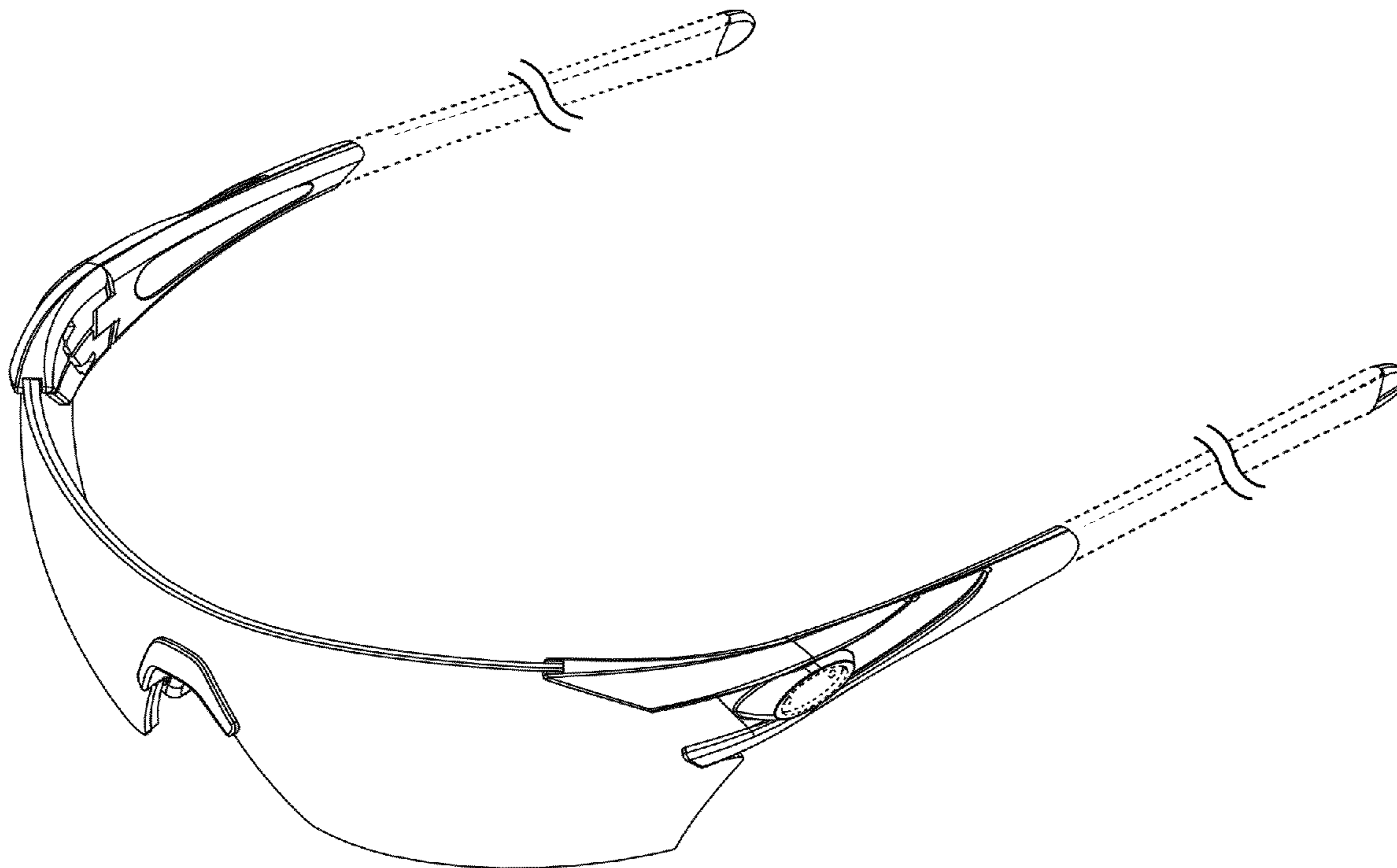
**DESCRIPTION**

This application is related to the United States Patent Application that is being filed concurrently herewith, bears the title of “Lens Receptor Lock for Glasses”, and is filed under customer No. 35856 and assigned application Ser. 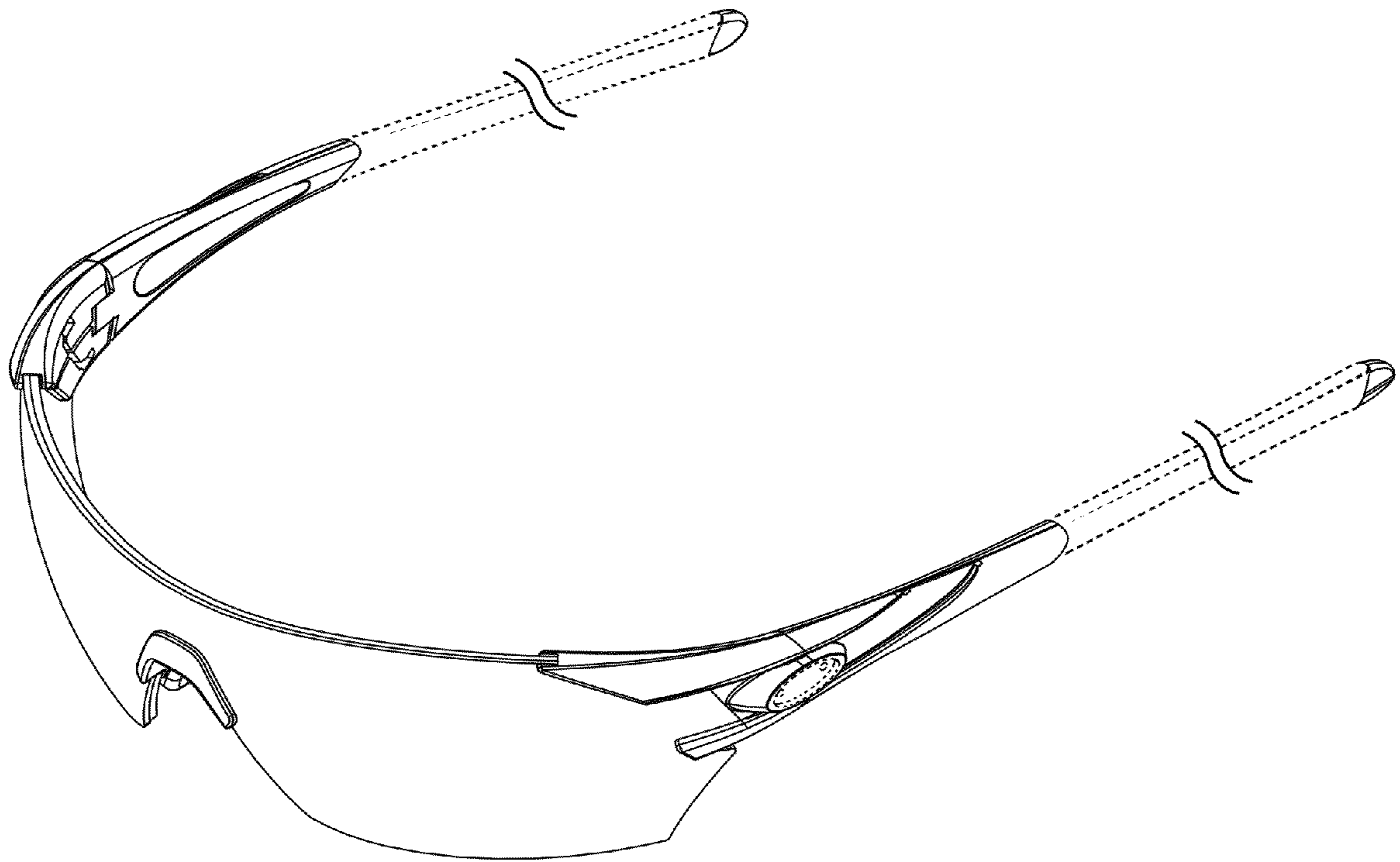

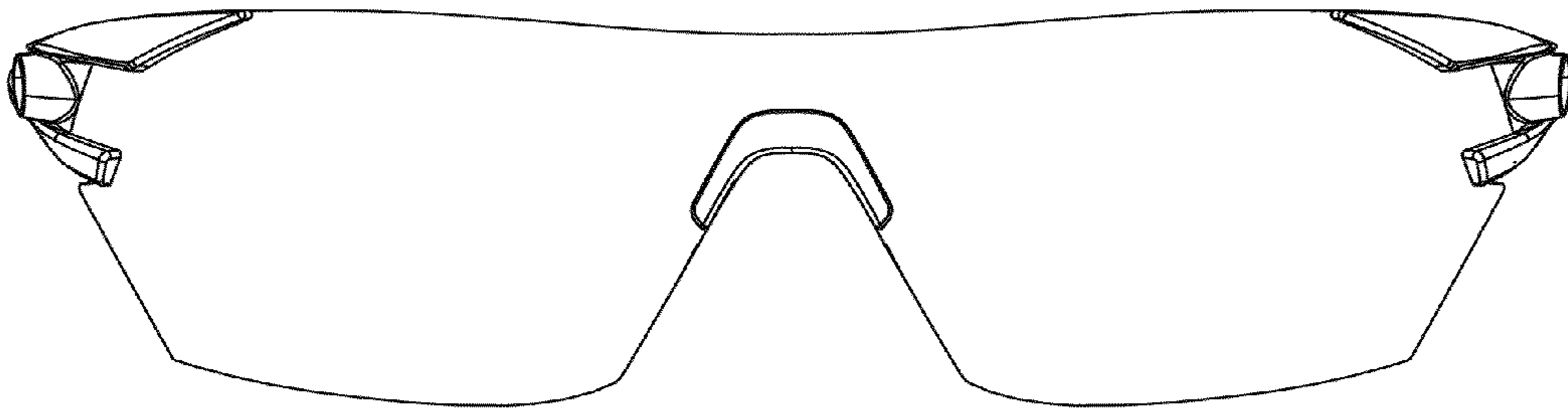

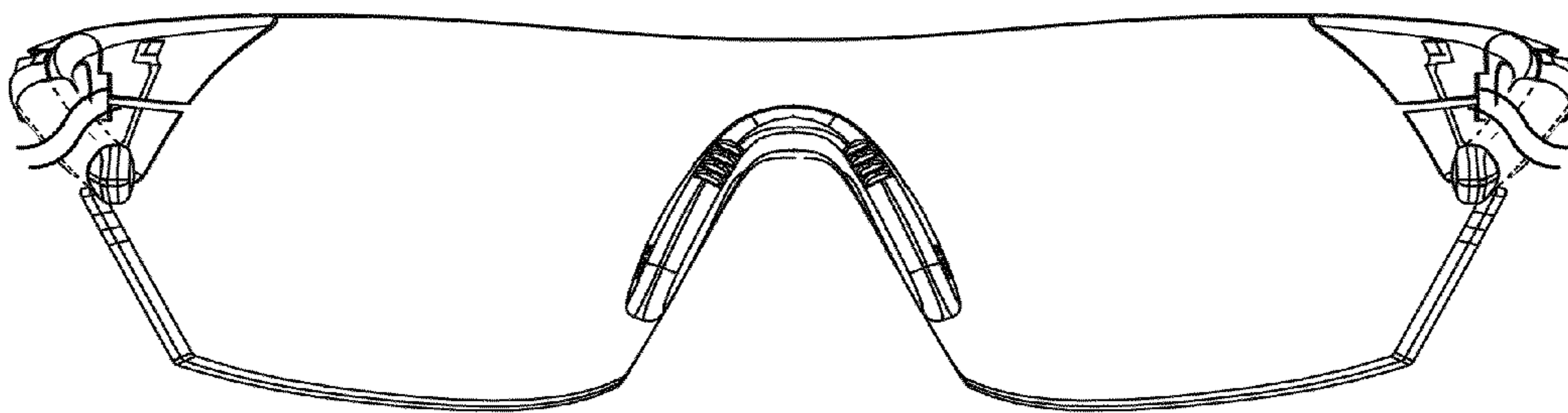

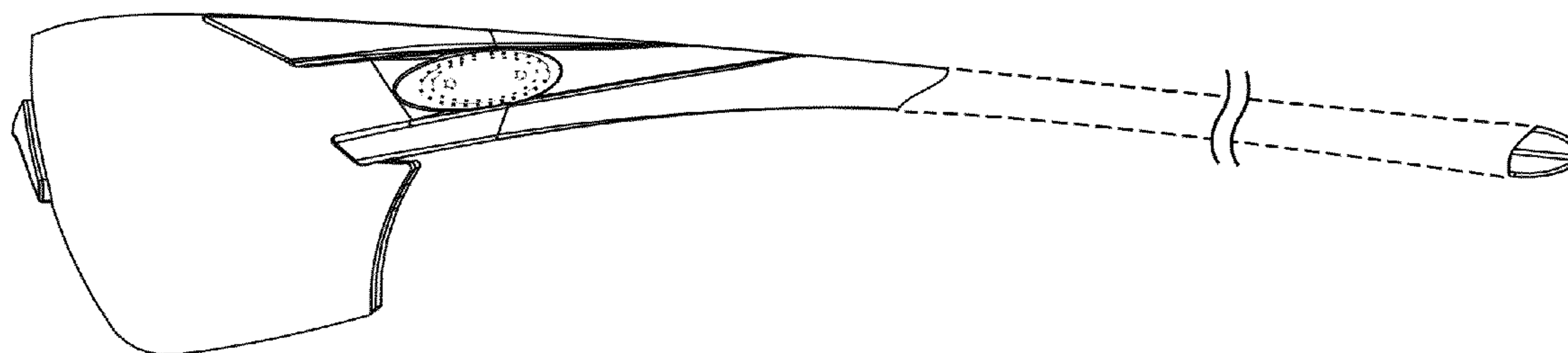

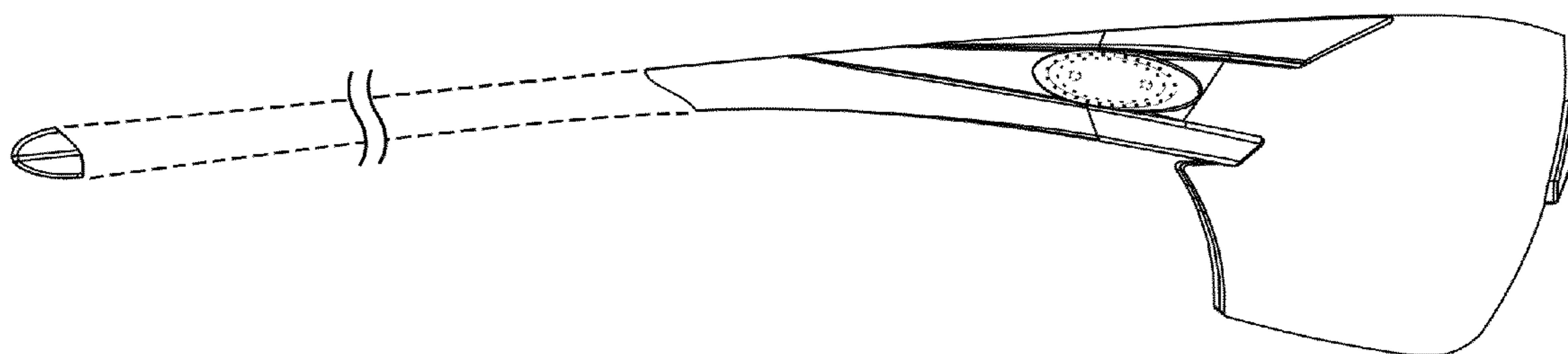
