(57) **CLAIM**

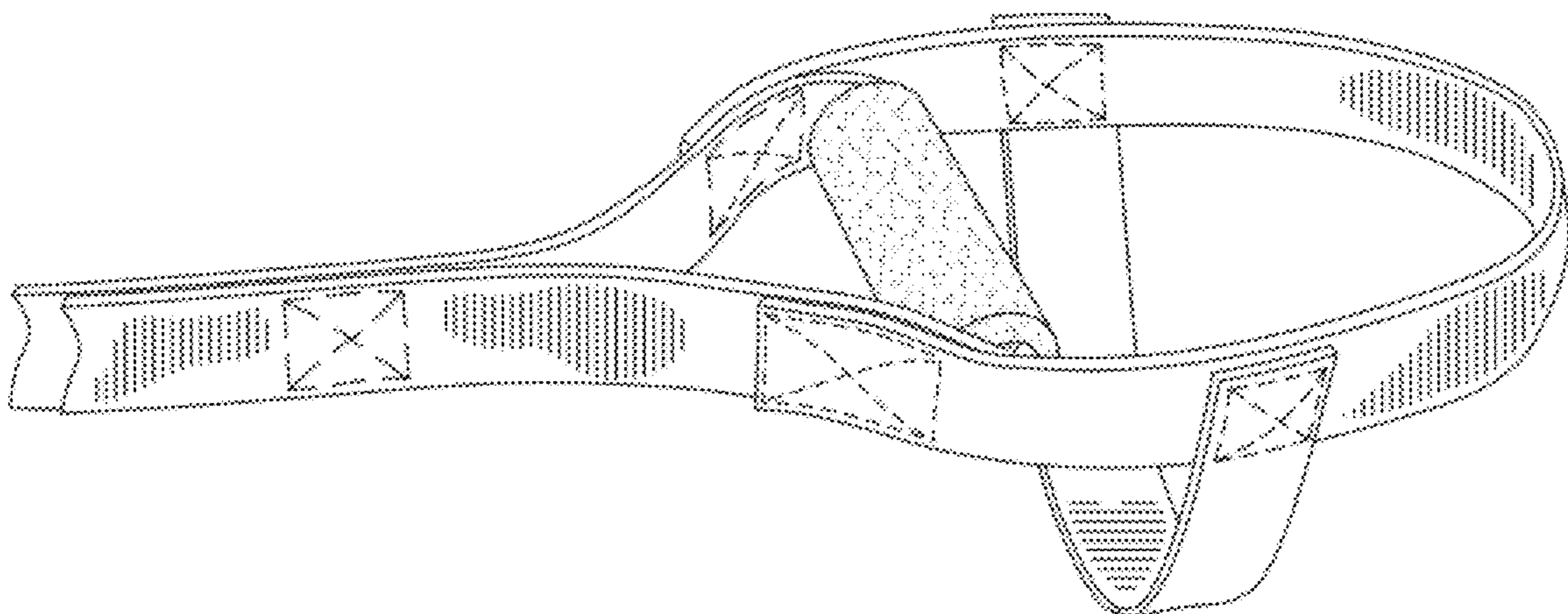
We claim the ornamental design for an exercise grip, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective top view of an exercise grip;  
FIG. 2 is a perspective top view thereof, illustrating an application of the exercise grip as an ankle support;  
FIG. 3 is a left side perspective view thereof;  
FIG. 4 is a front elevation view thereof;  
FIG. 5 is a rear elevation view thereof;  
FIG. 6 is a right side perspective view thereof;  
FIG. 7 is a top view thereof; and,  
FIG. 8 is a bottom view thereof.

The broken lines showing a foot and stitching illustrate portions of the claim and environmental structure, which form no part of the claimed design.

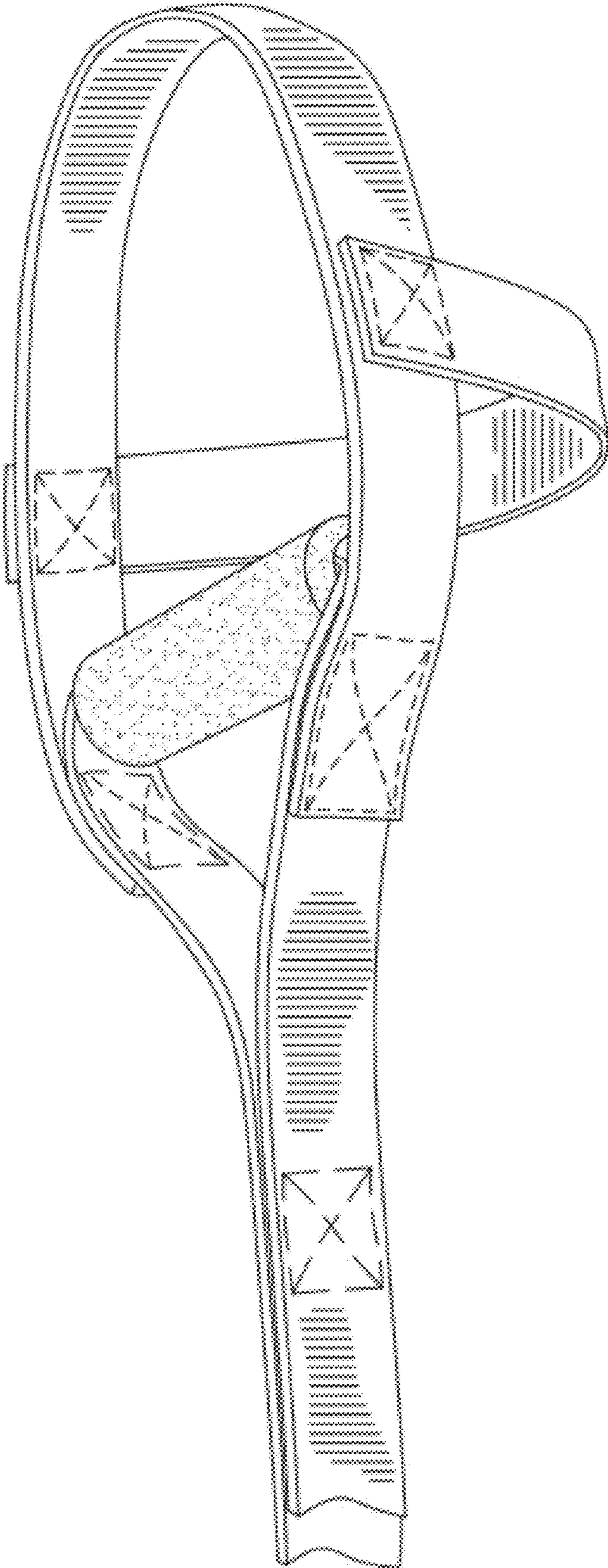

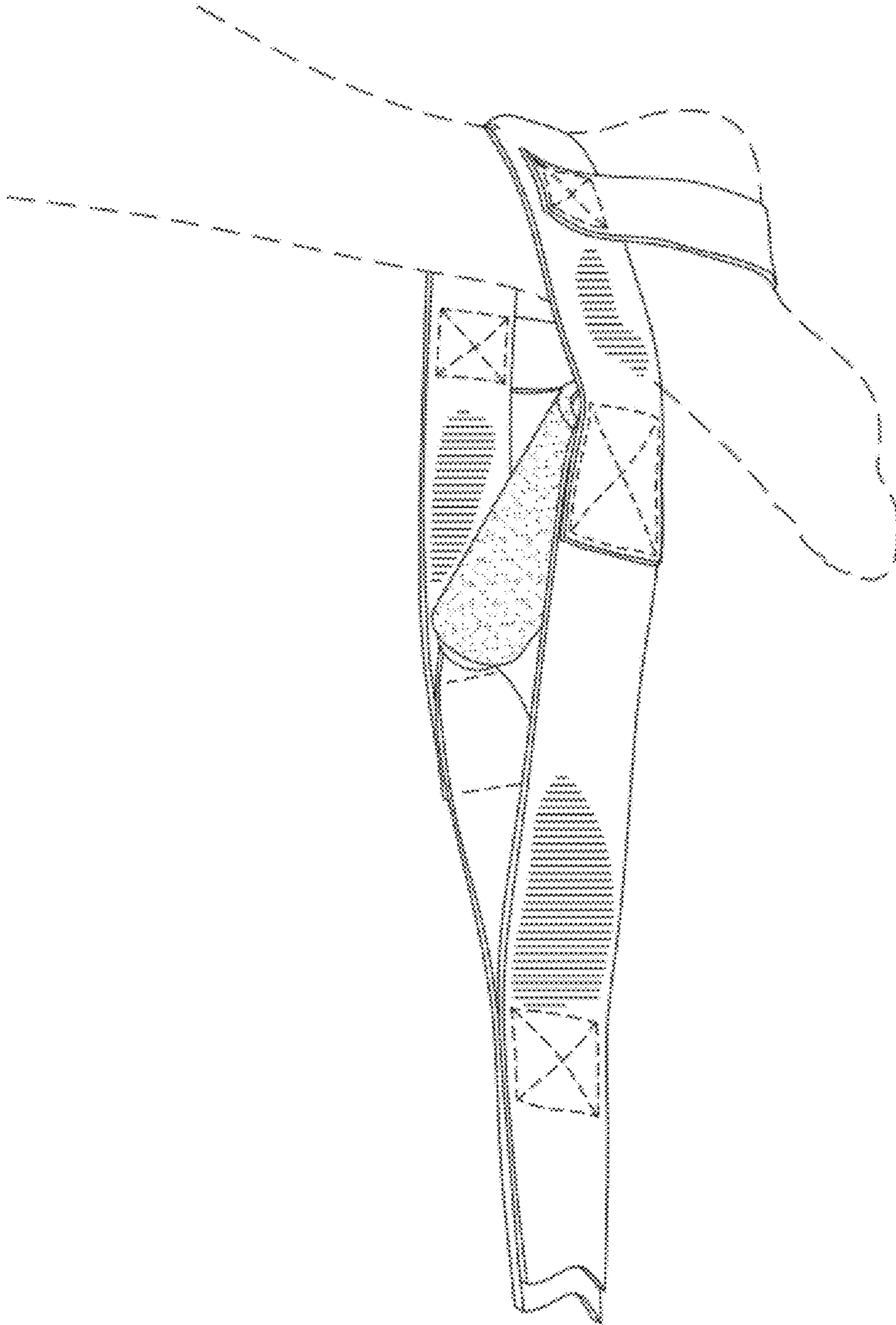

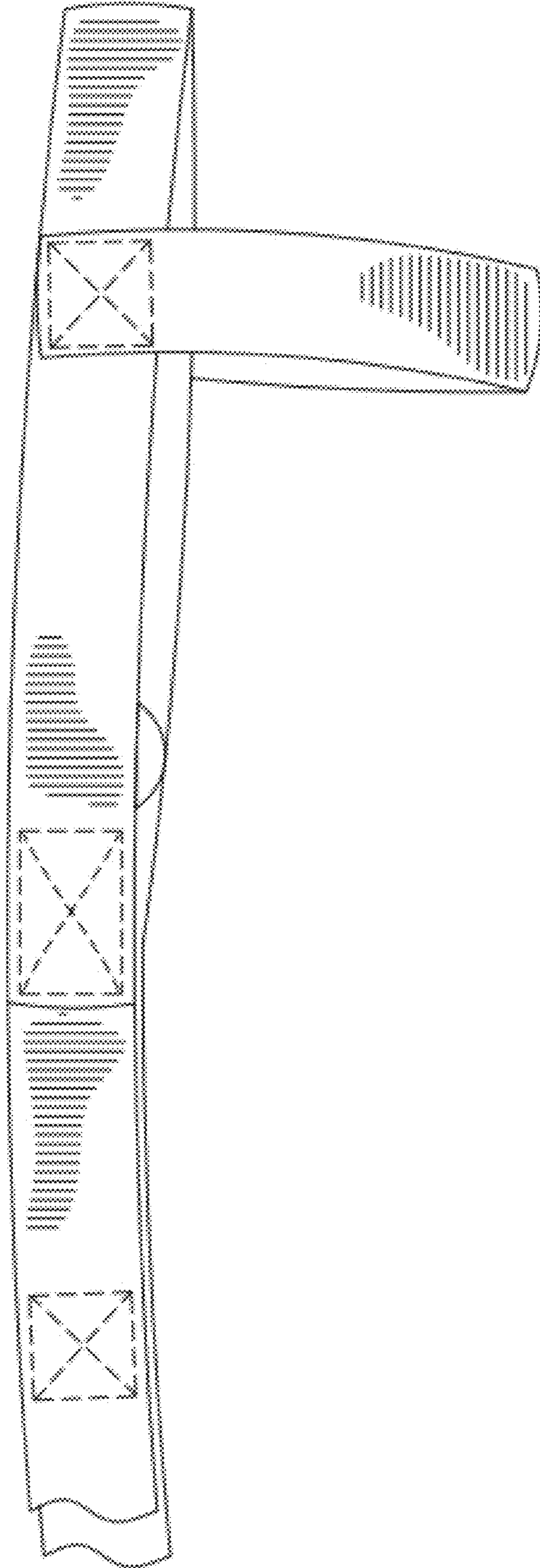

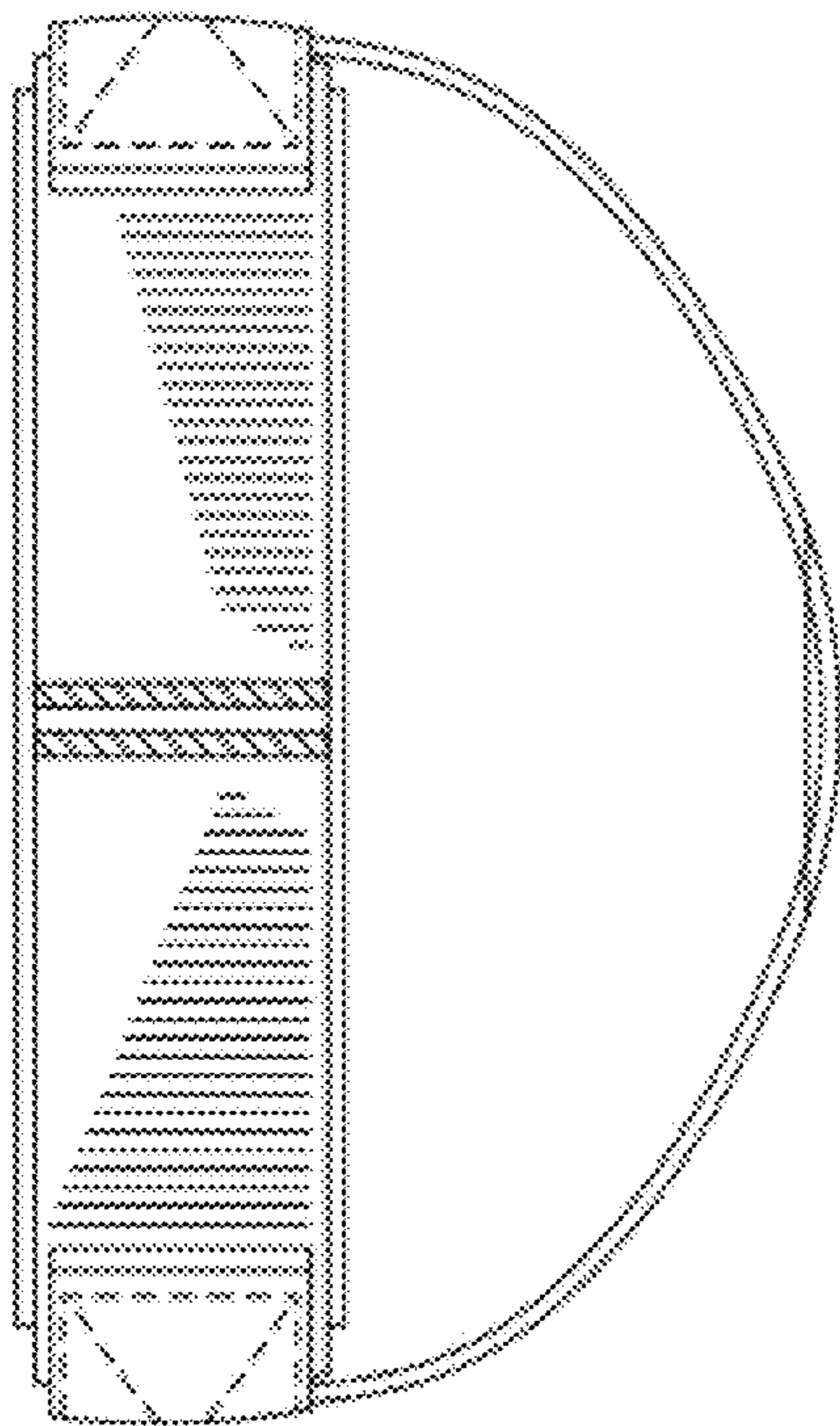

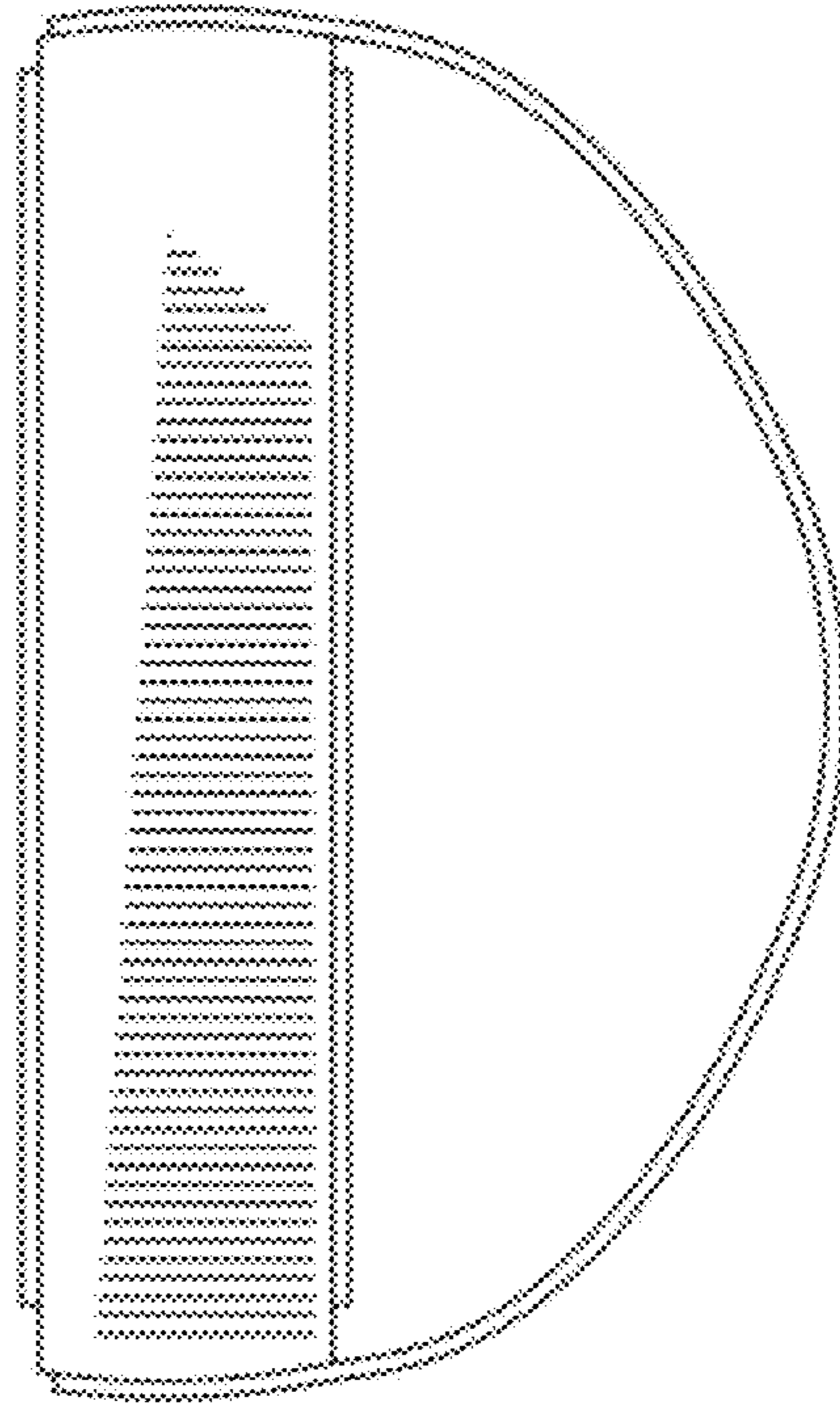

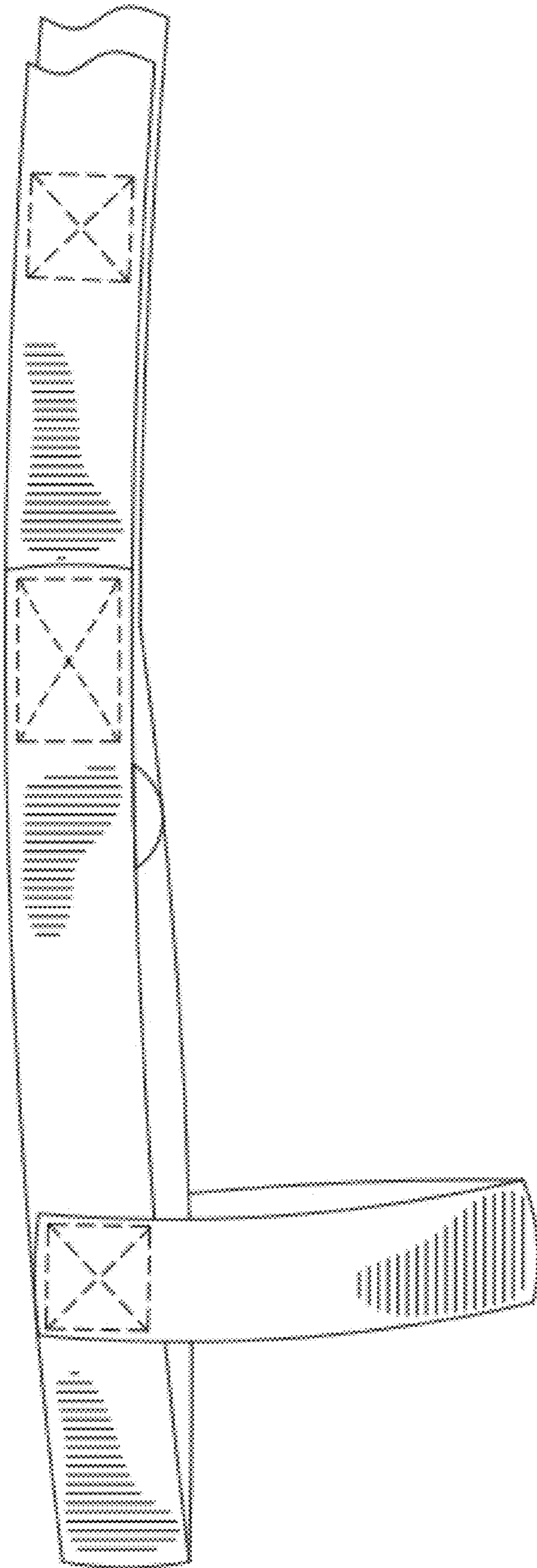

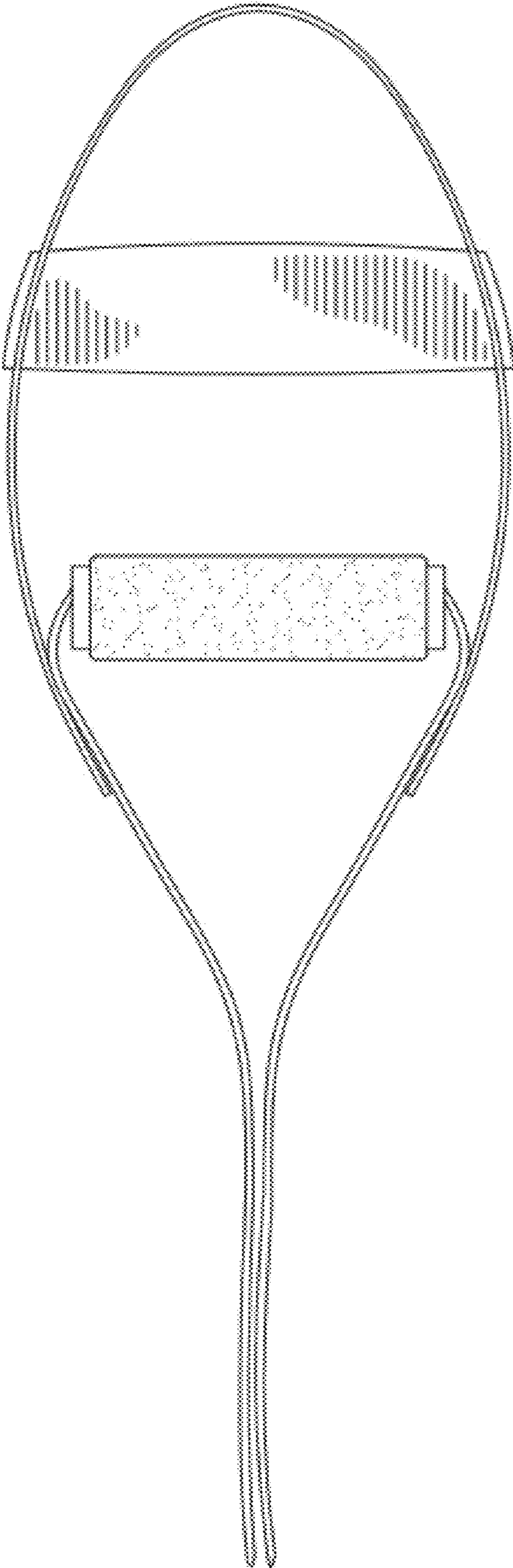

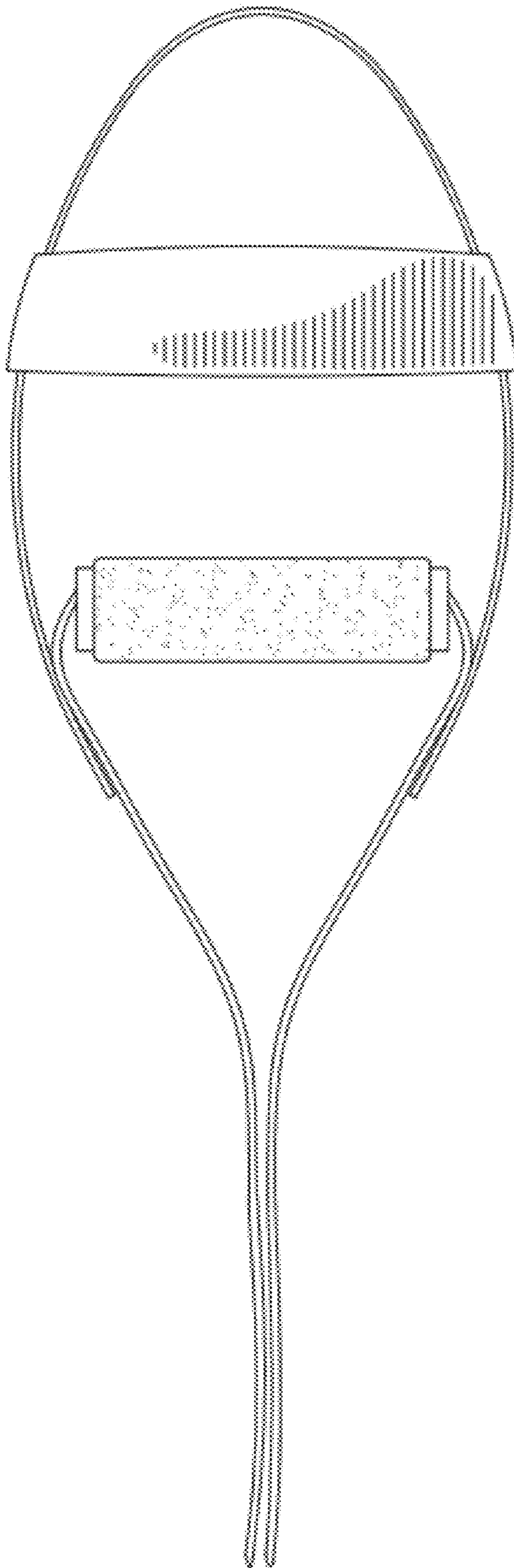
