DESCRIPTION

FIG. 1 is a top, front, left perspective view of a firearm showing the new design.

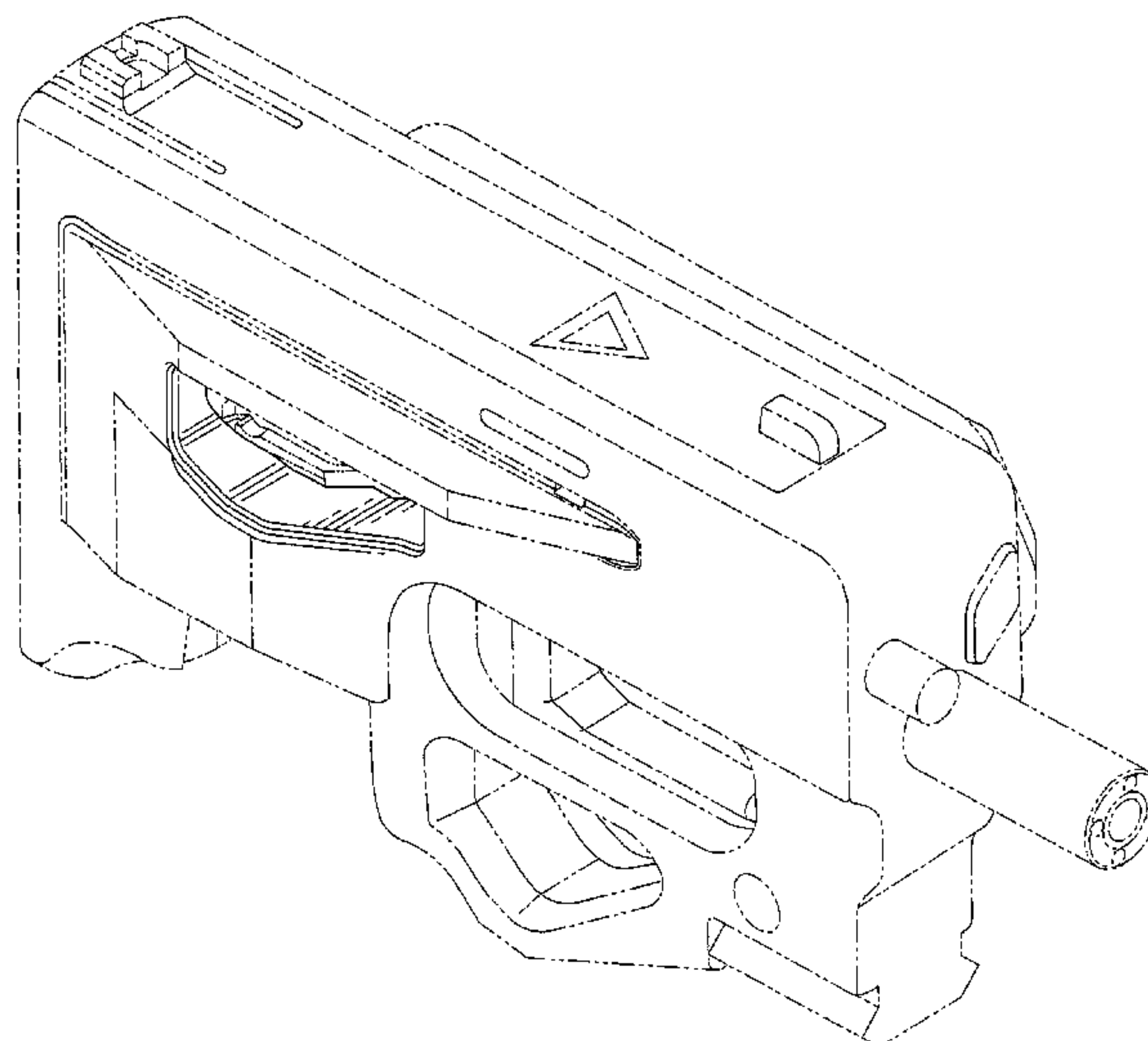
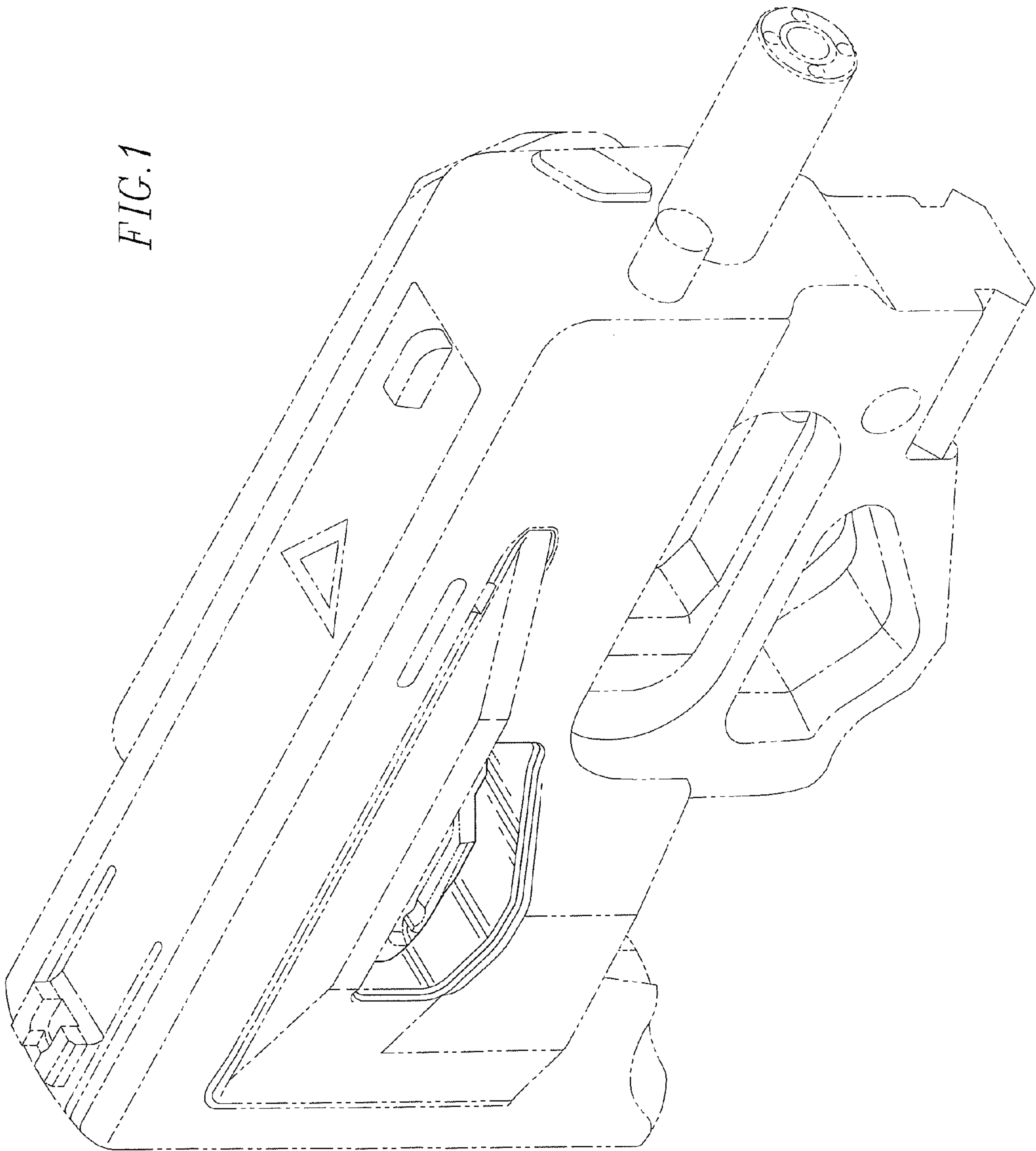

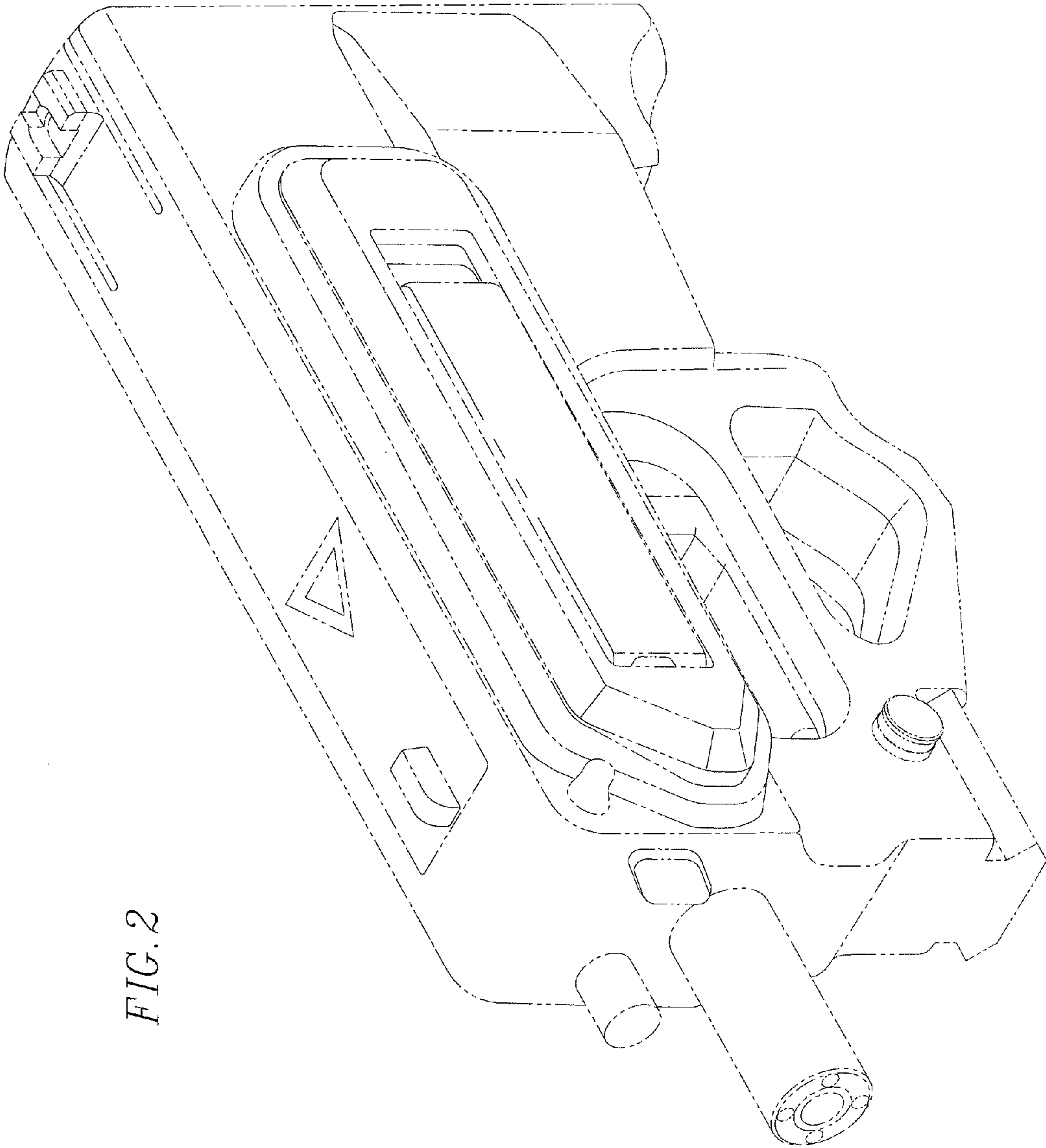

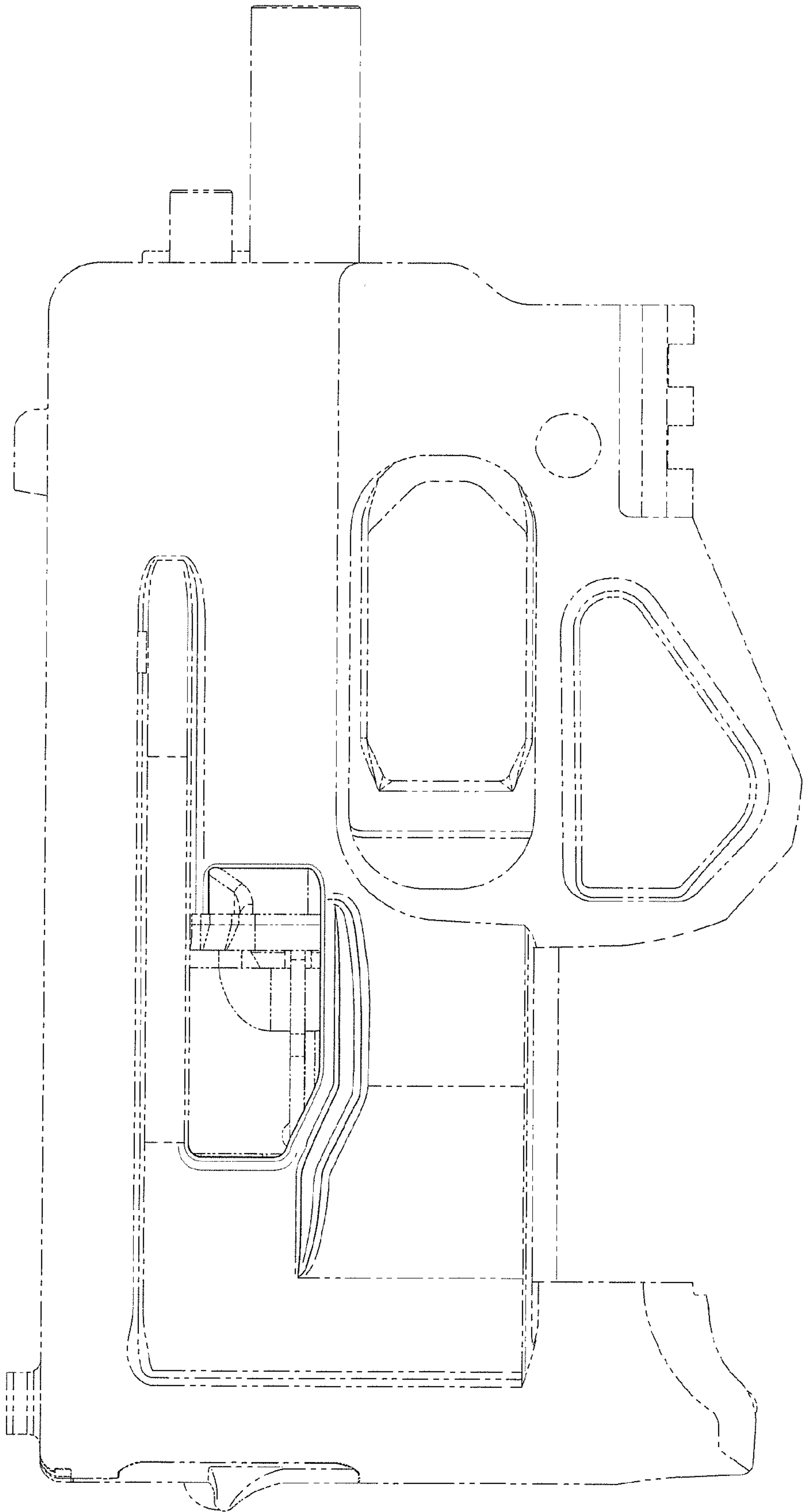

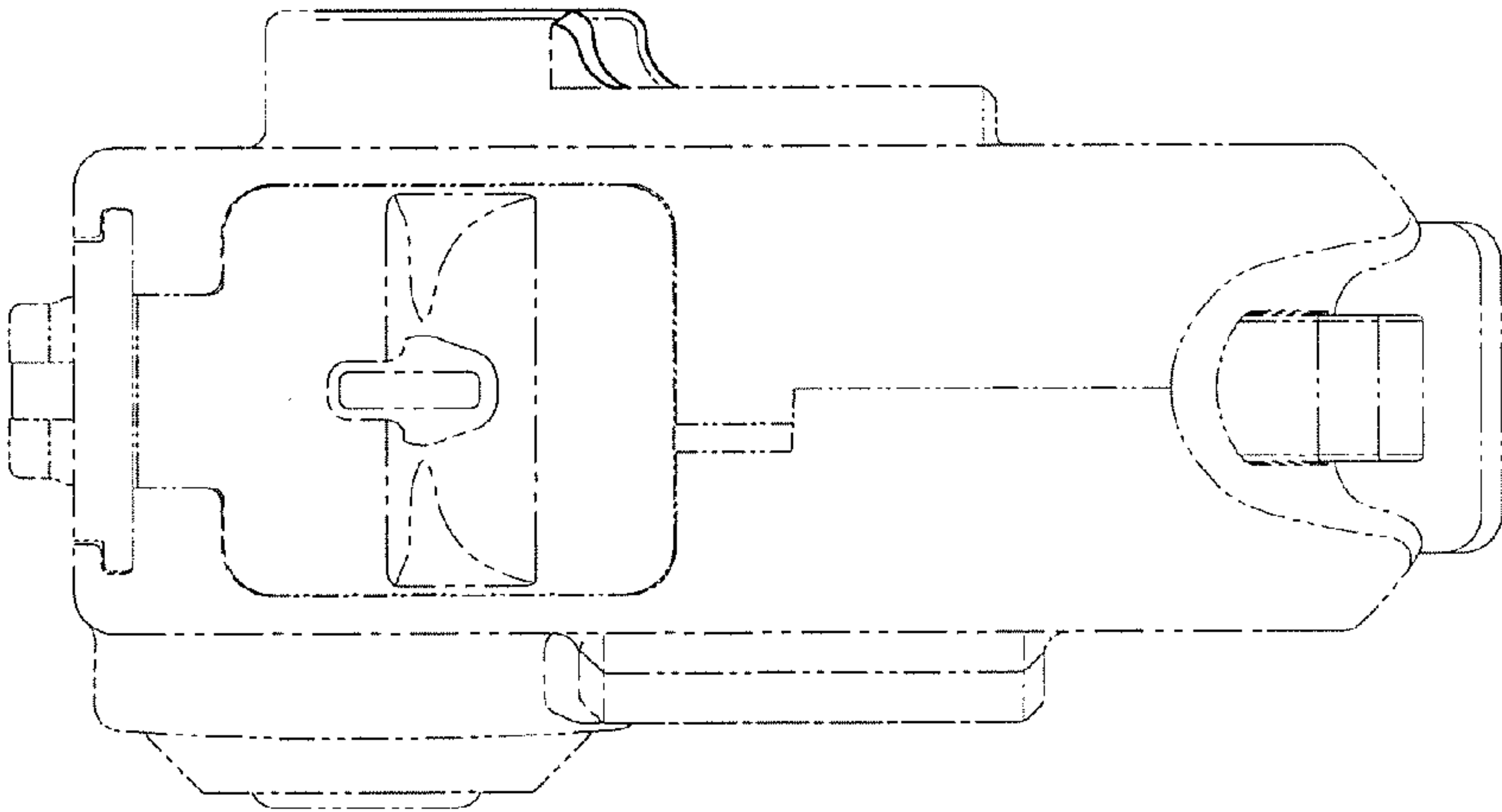

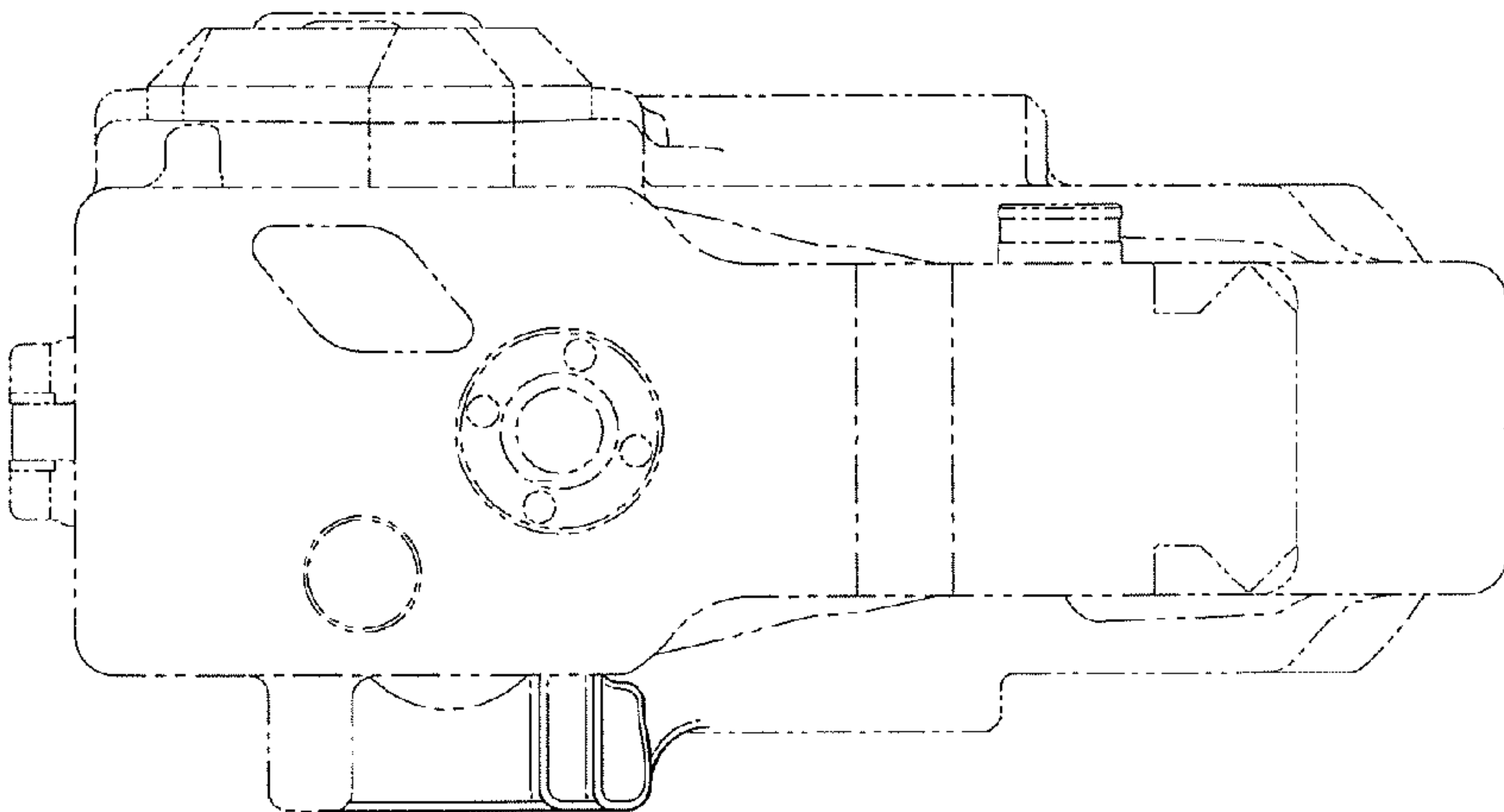

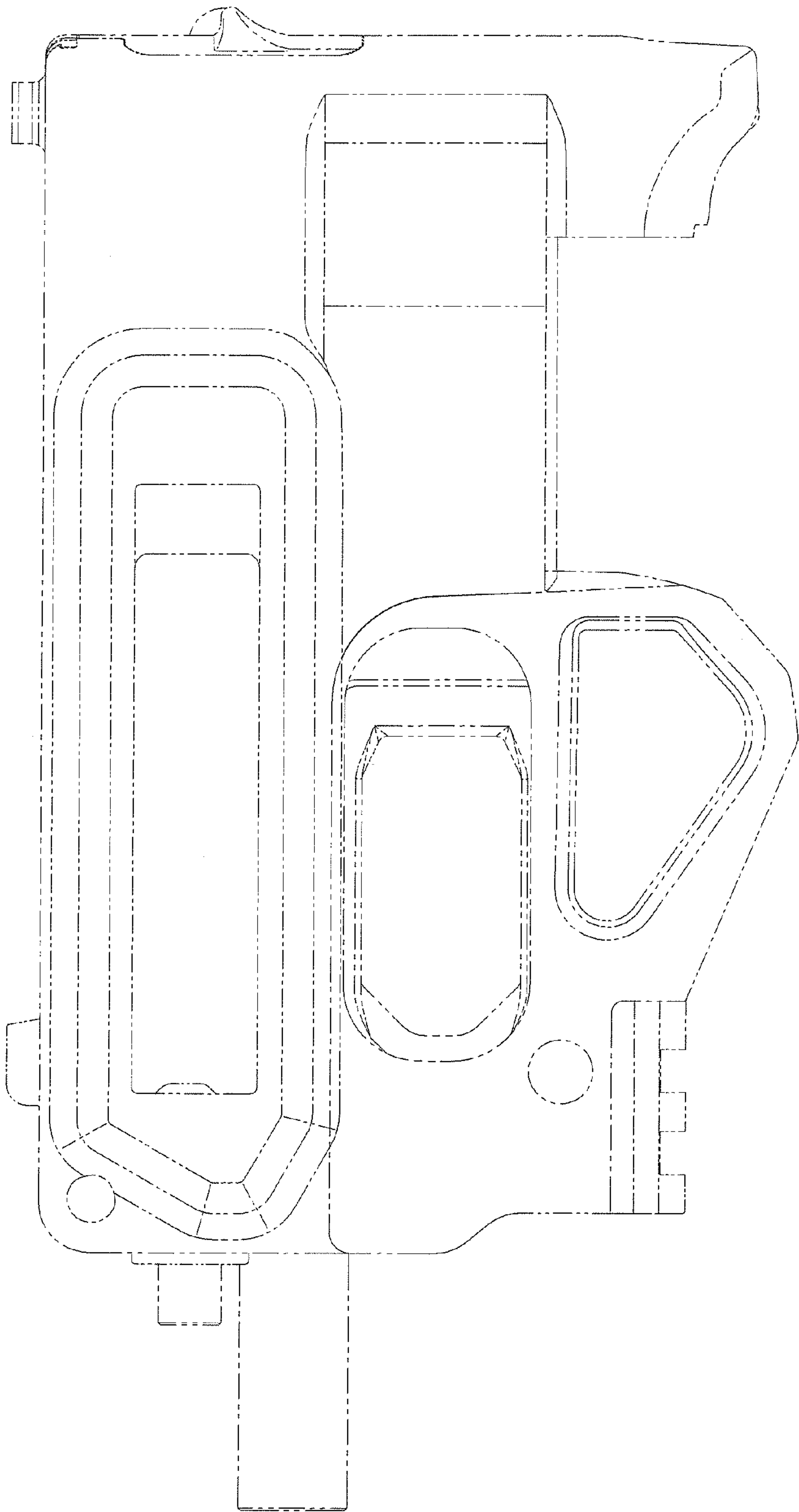

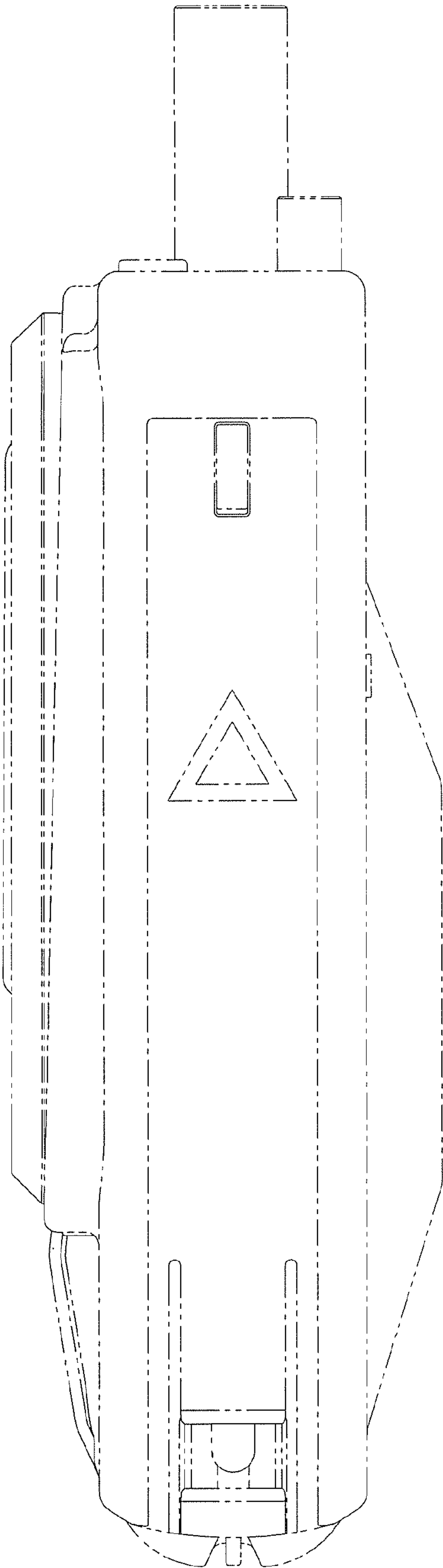

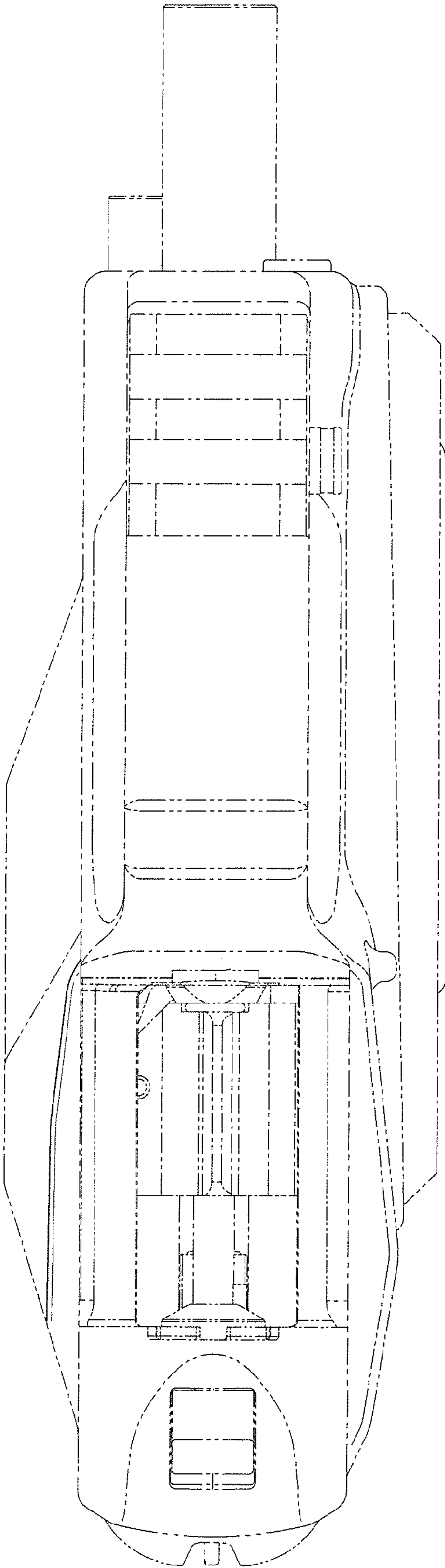
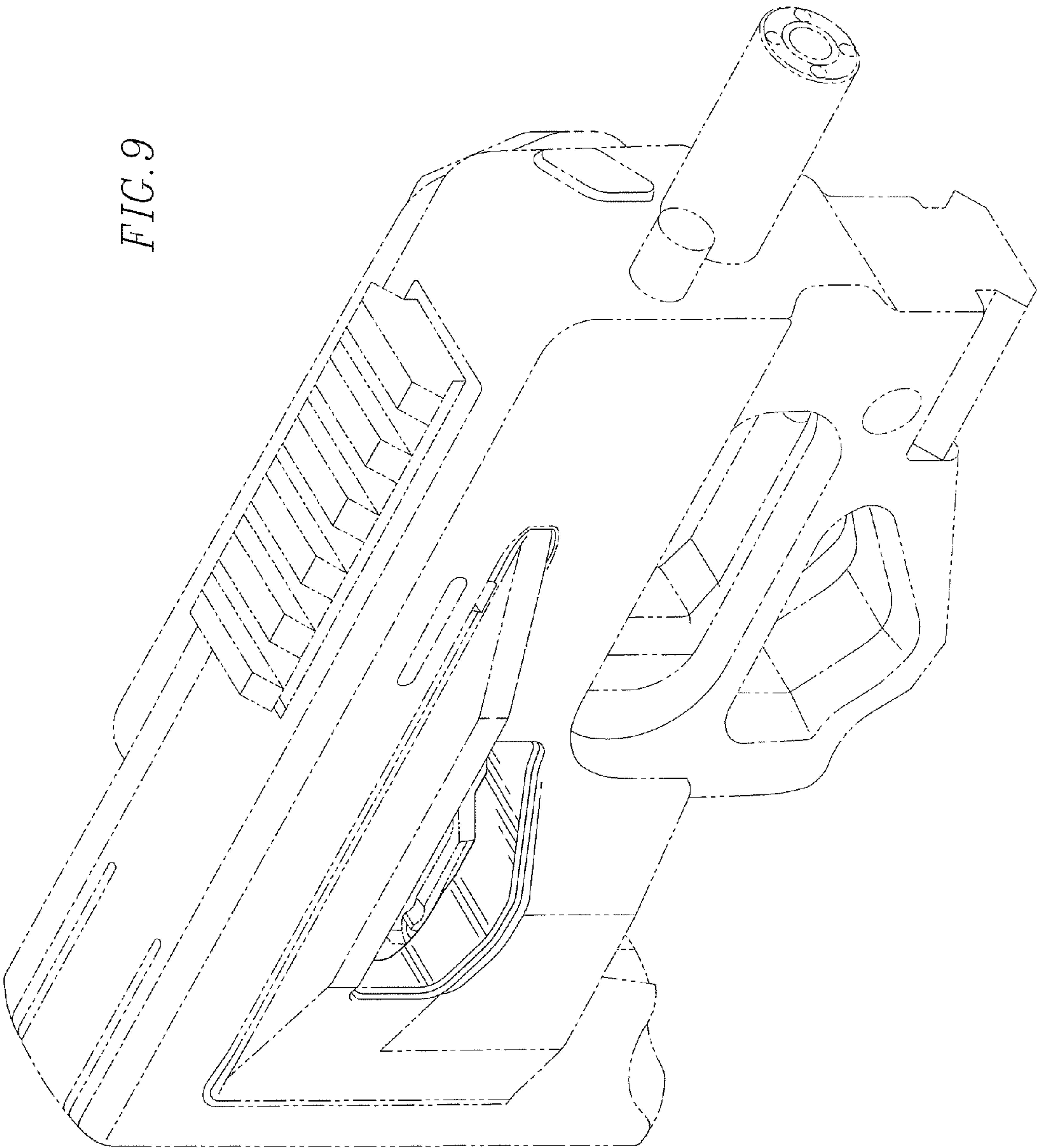

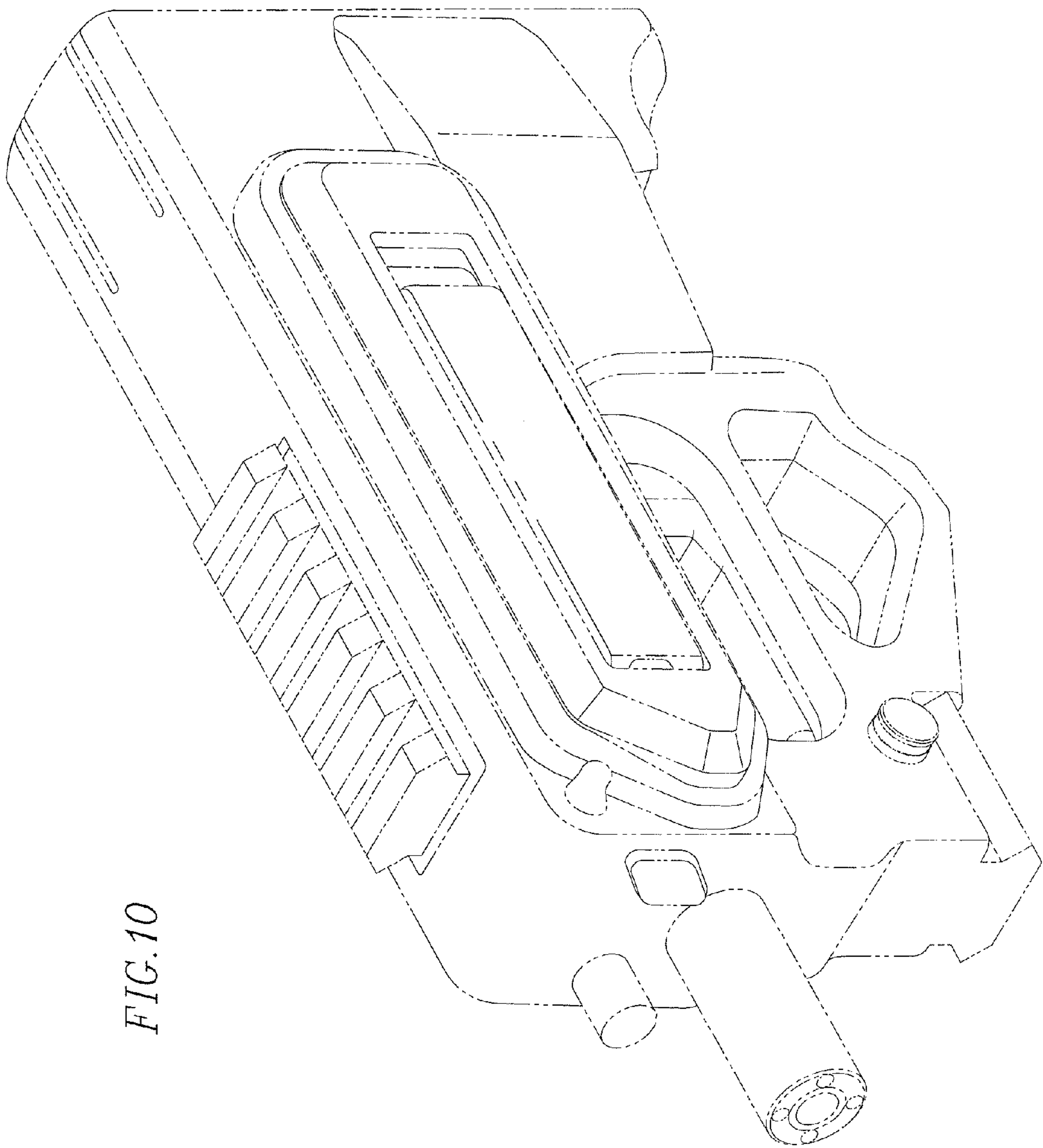
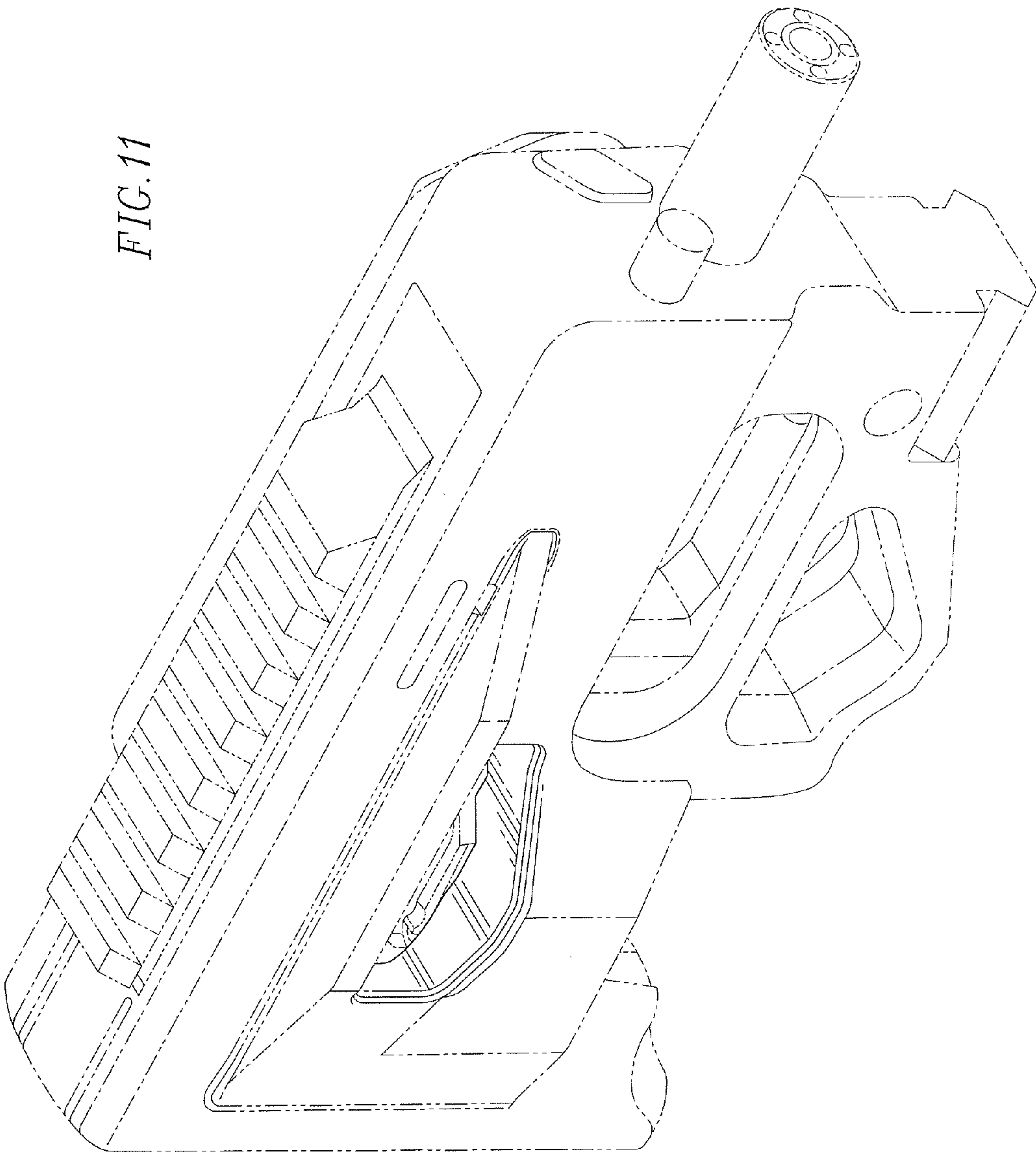

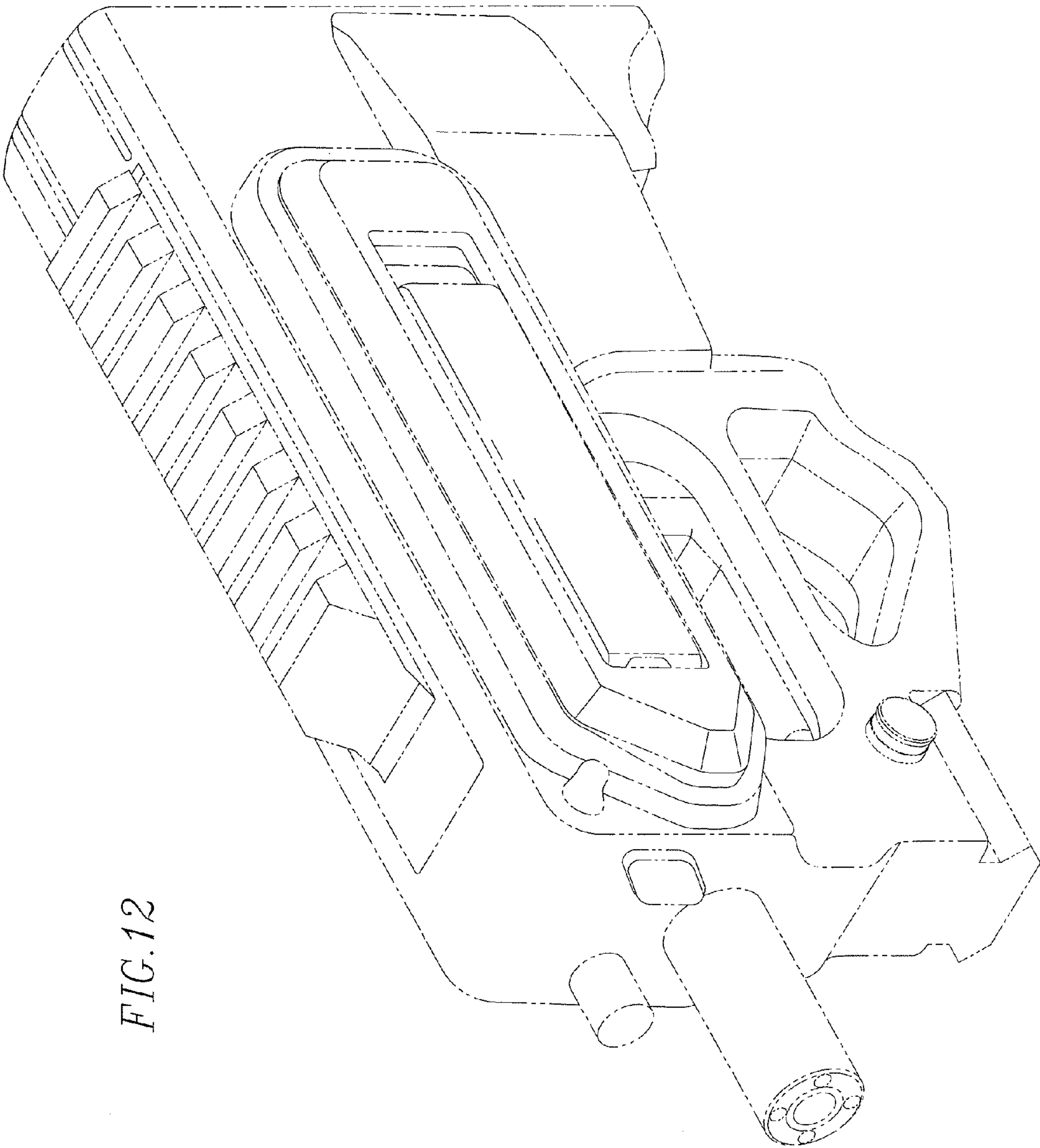
