FIG. 1 is a perspective view of a non-electronic hearing aid showing my new design in use, with broken lines representing environmental features forming no part of the design sought to be patented;

FIG. 2 is a perspective view of a non-electronic hearing aid embodying my design in a transparent embodiment;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a left-side elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a right side elevational view thereof;

FIG. 7 is a top plan view thereof;

FIG. 8 is a bottom plan view thereof;

FIG. 9 is a top plan view of the unfolded transparent embodiment shown in FIG. 2, the bottom plan view being a mirror image thereof;

FIG. 10 is a perspective view of a second embodiment of a my non-electronic hearing aid design embodied as non-transparent;

FIG. 11 is a front elevational view of the second embodiment;

FIG. 12 is a left-side elevational view of the second embodiment;

FIG. 13 is a rear elevational view of the second embodiment;

FIG. 14 is a right side elevational view of the second embodiment;

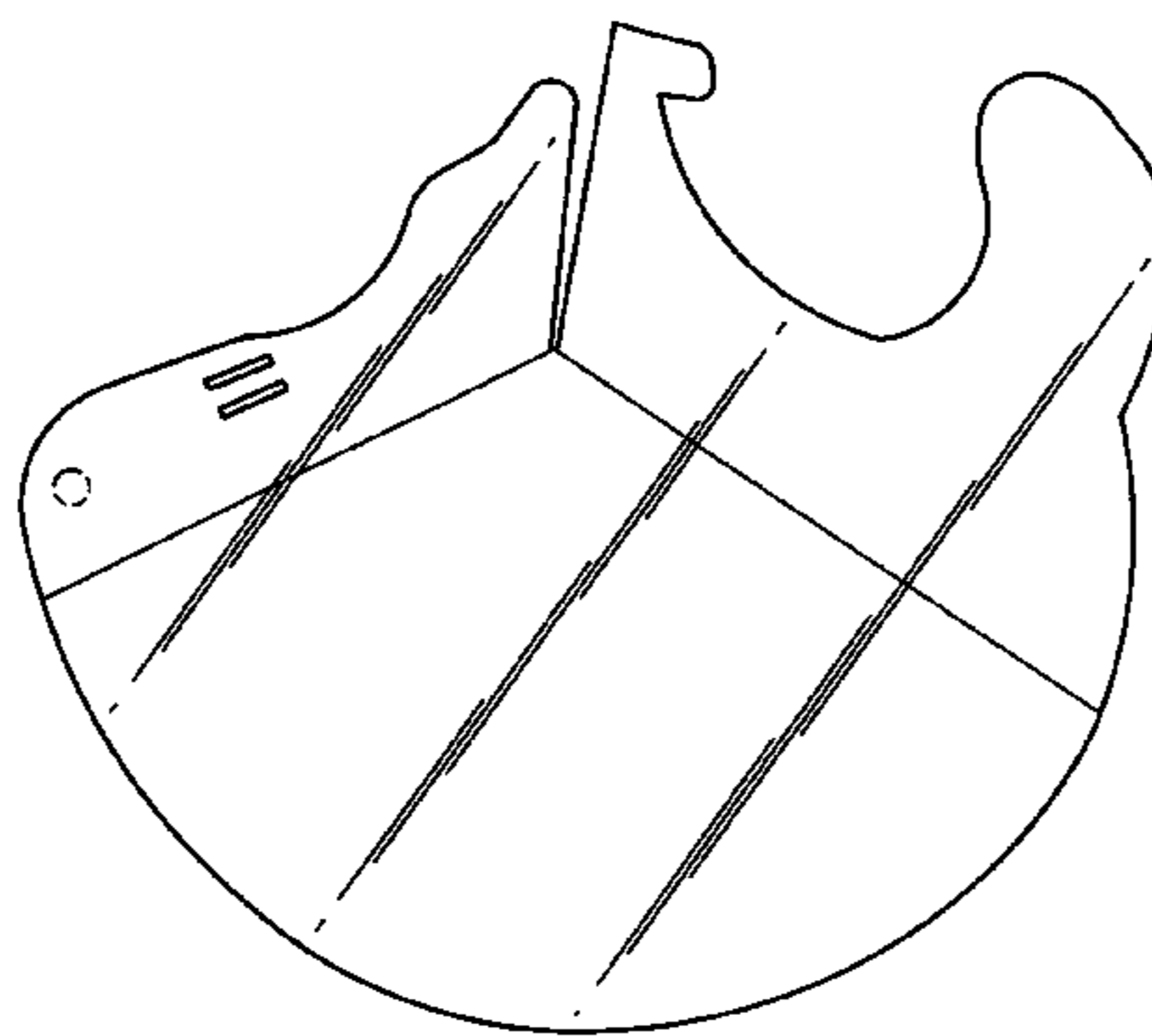
FIG. 15 is a top plan view of the second embodiment;

FIG. 16 is a bottom plan view of the second embodiment; and,

FIG. 17 is a top plan view of the unfolded second embodiment of my design shown in FIG. 10, said bottom plan view being a mirror image thereof.

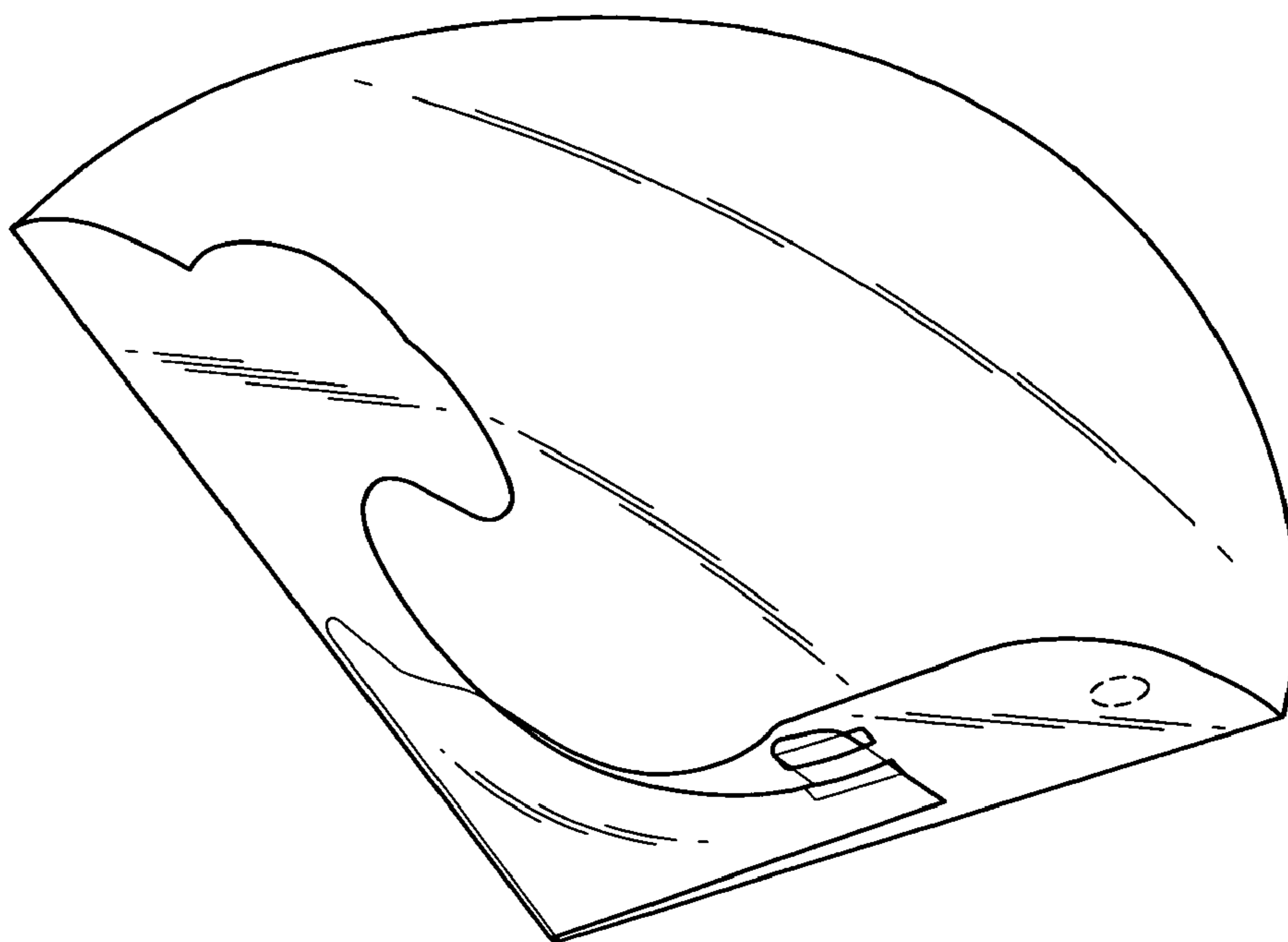

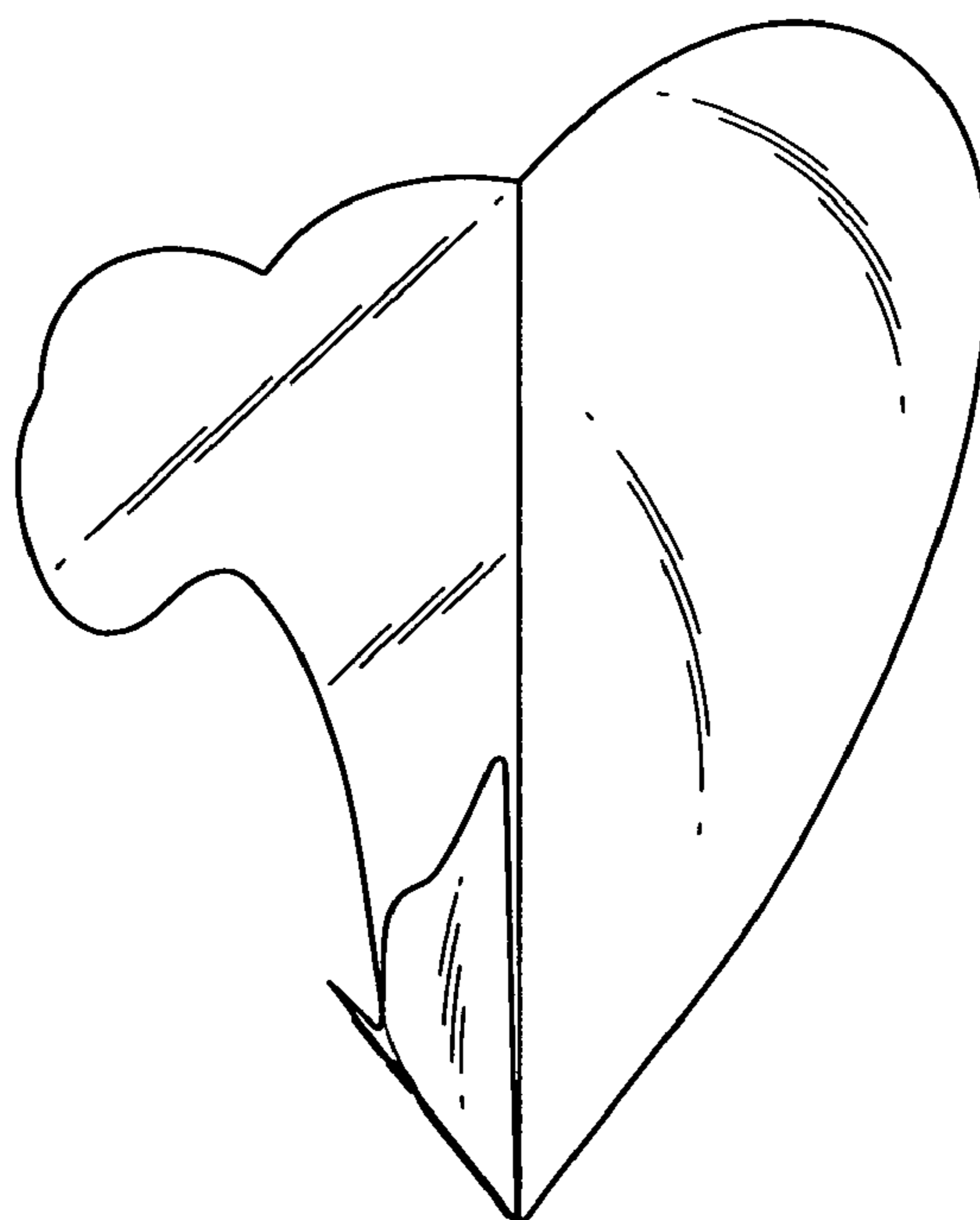

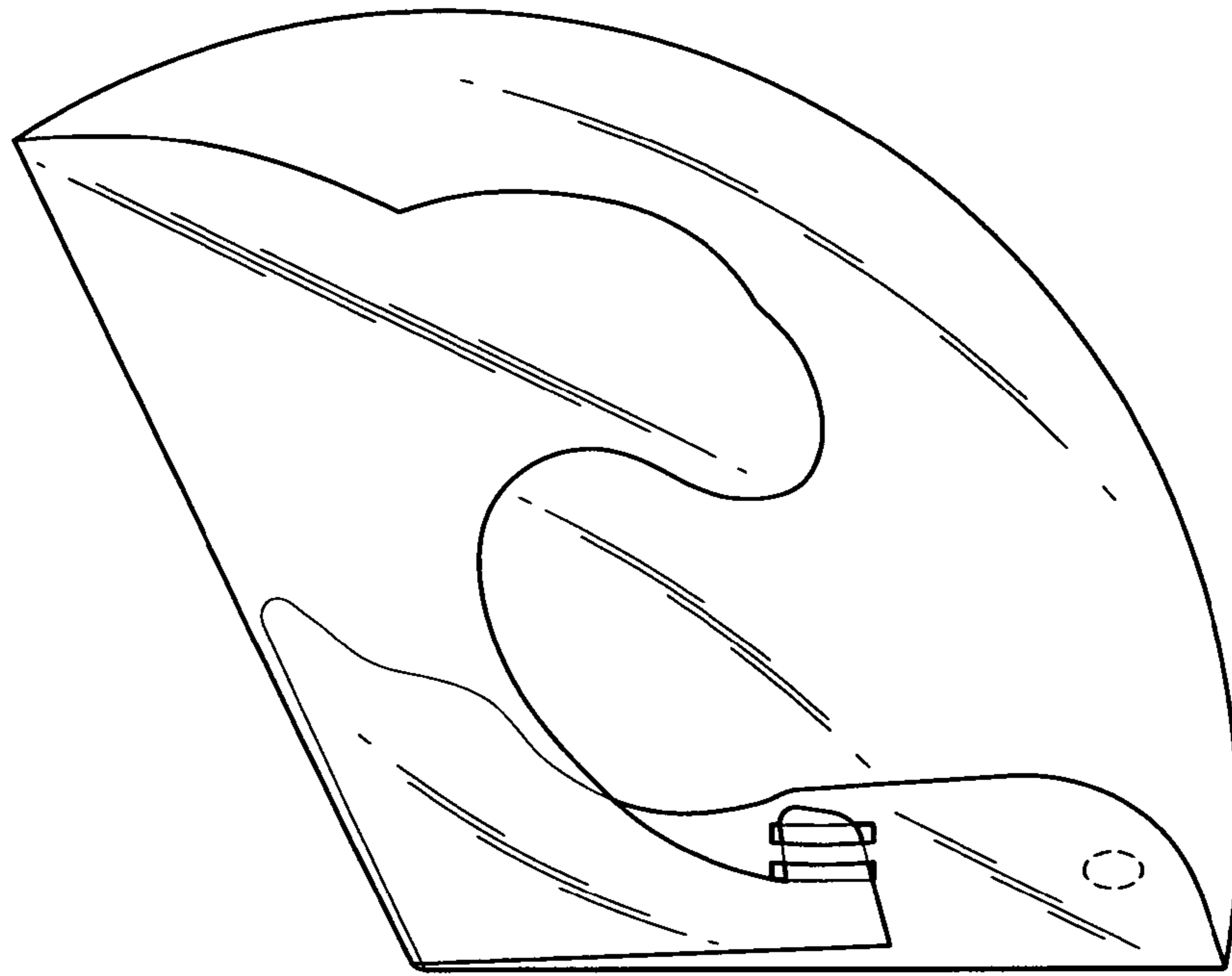

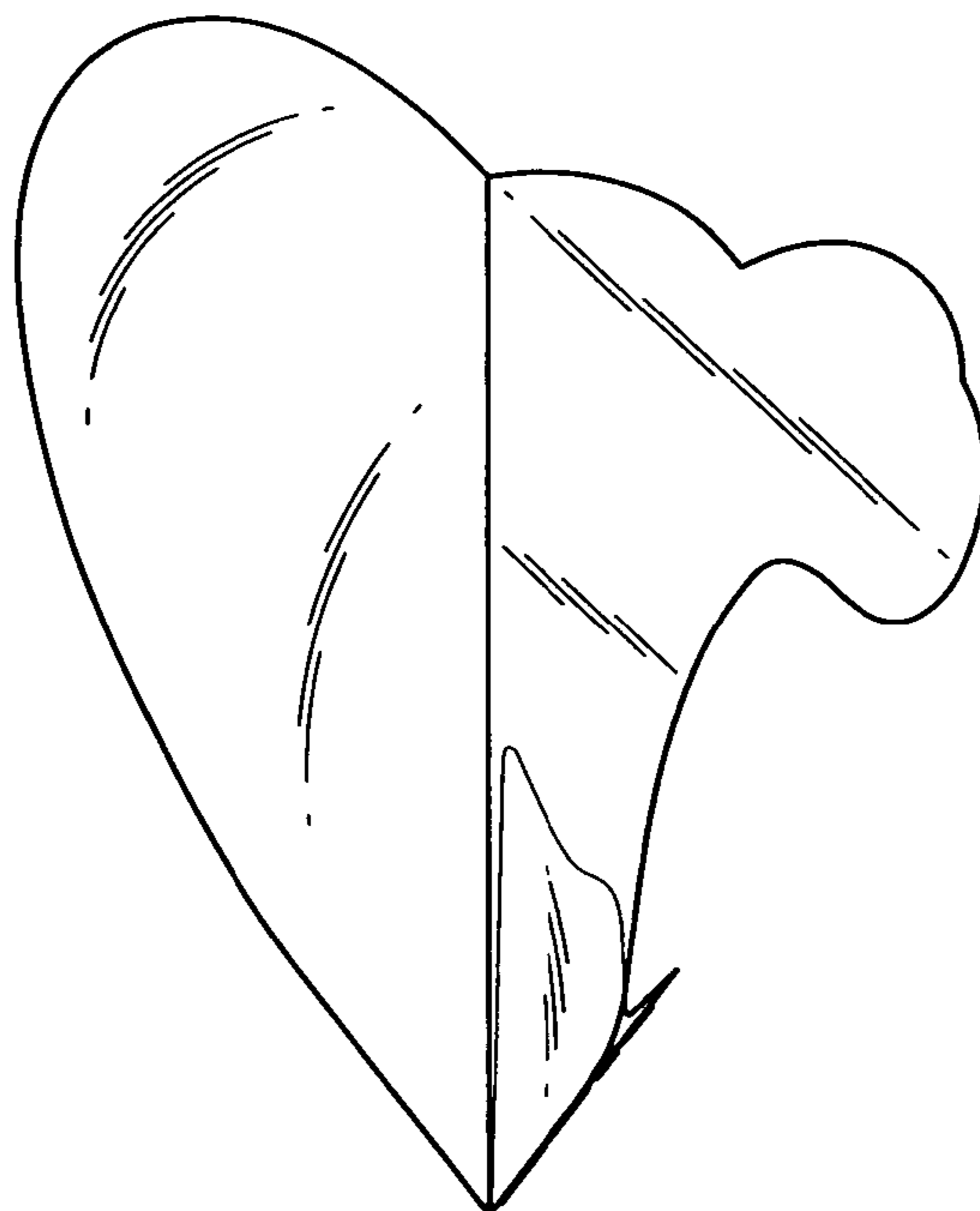

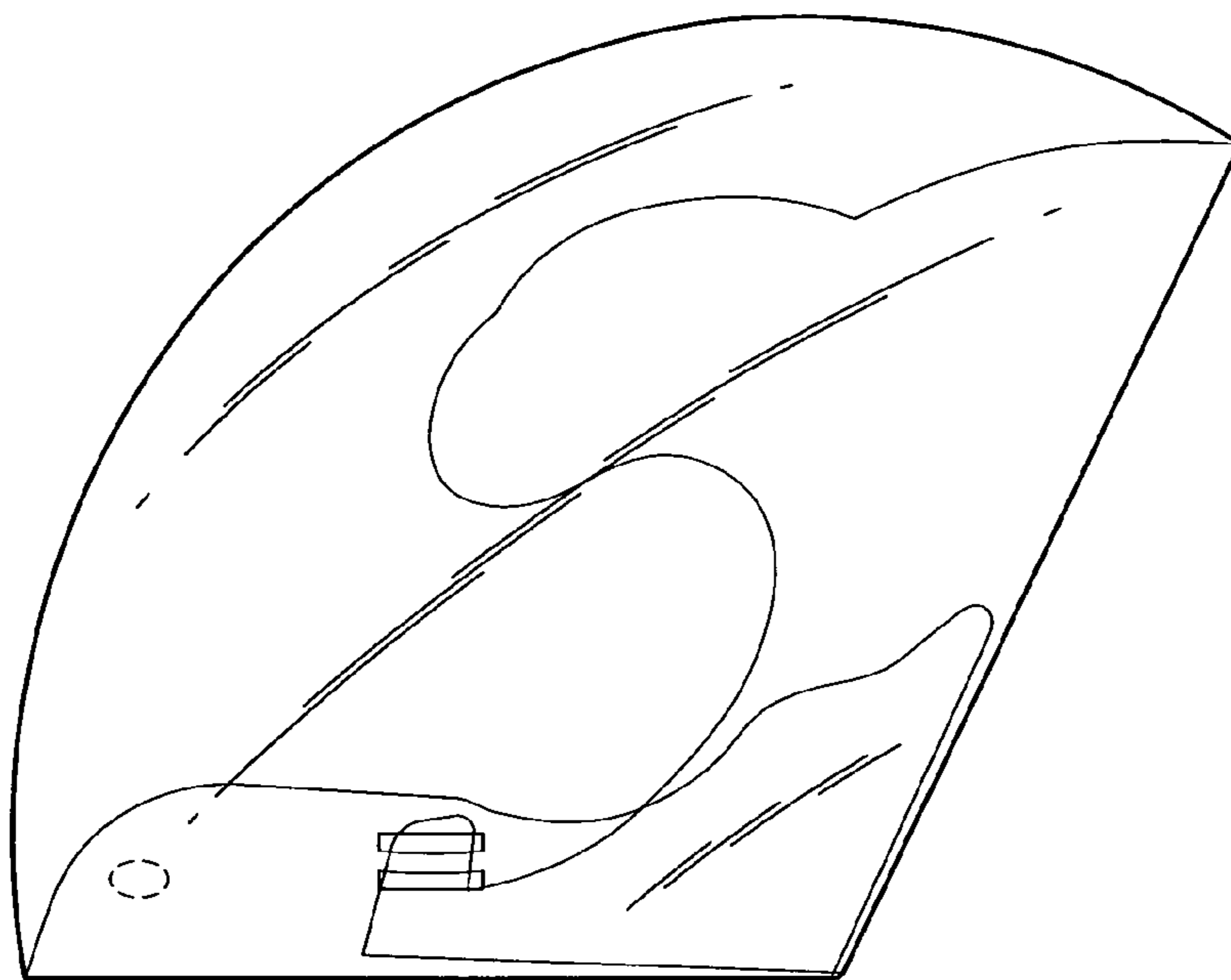

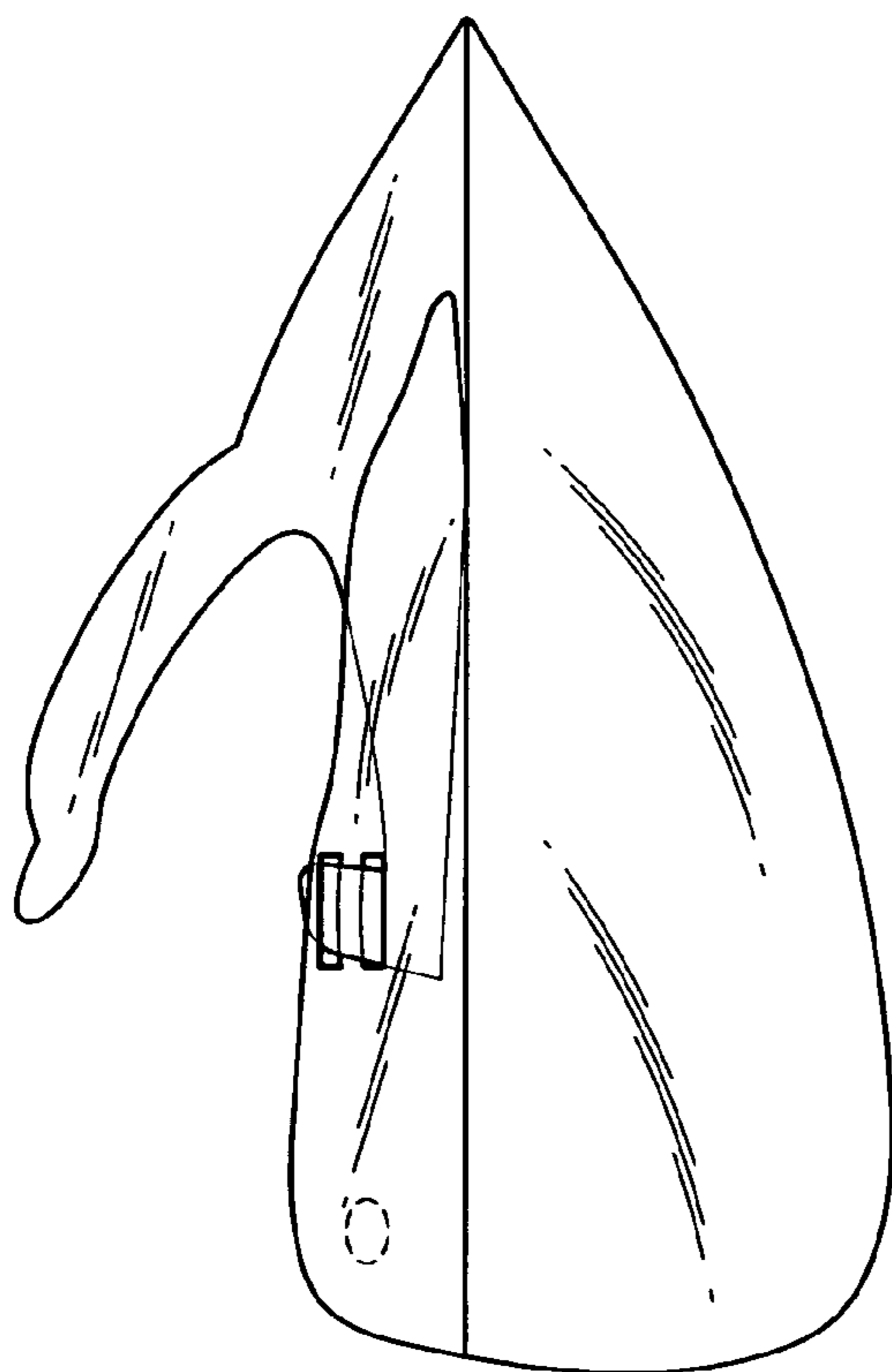

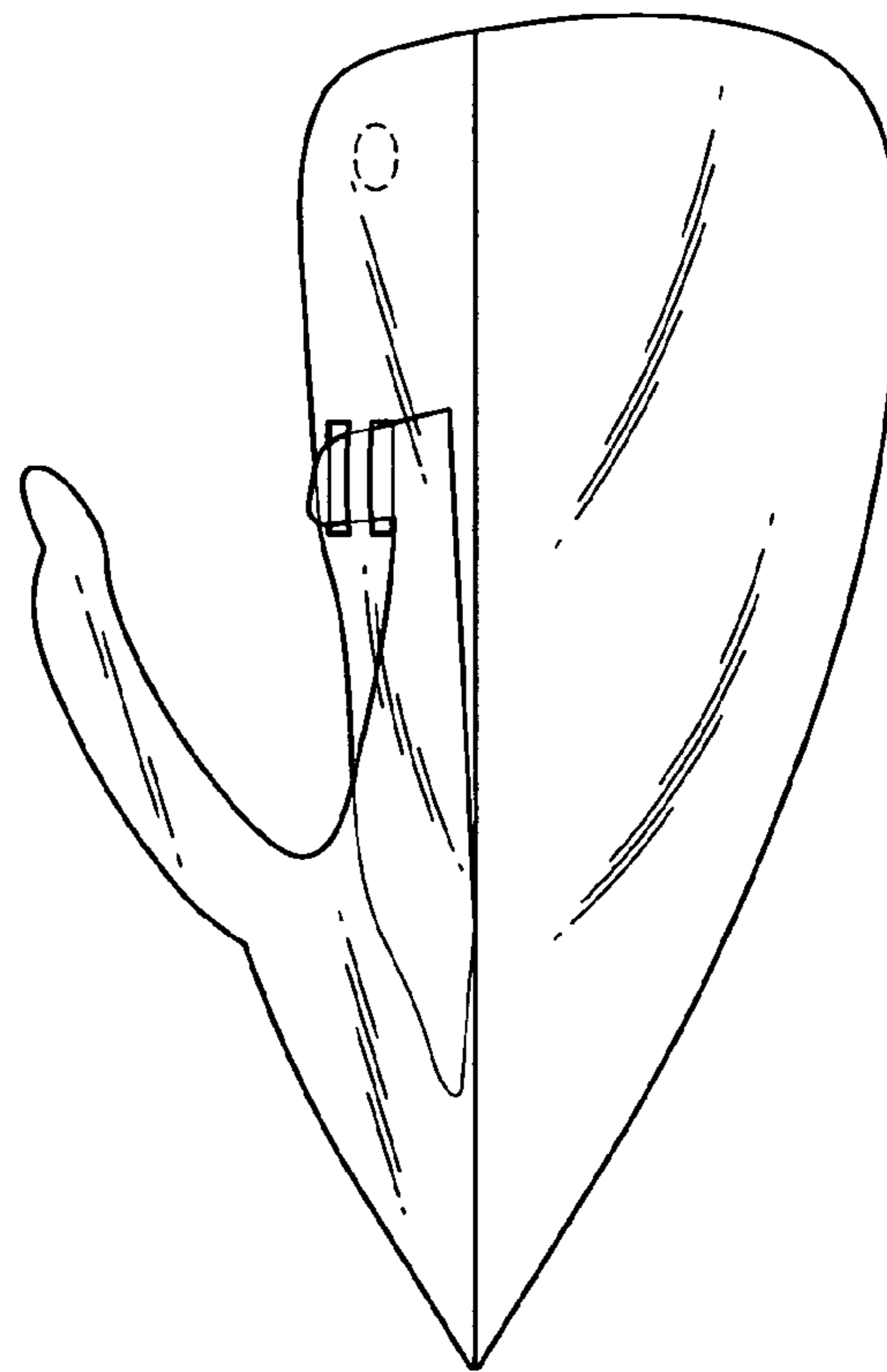

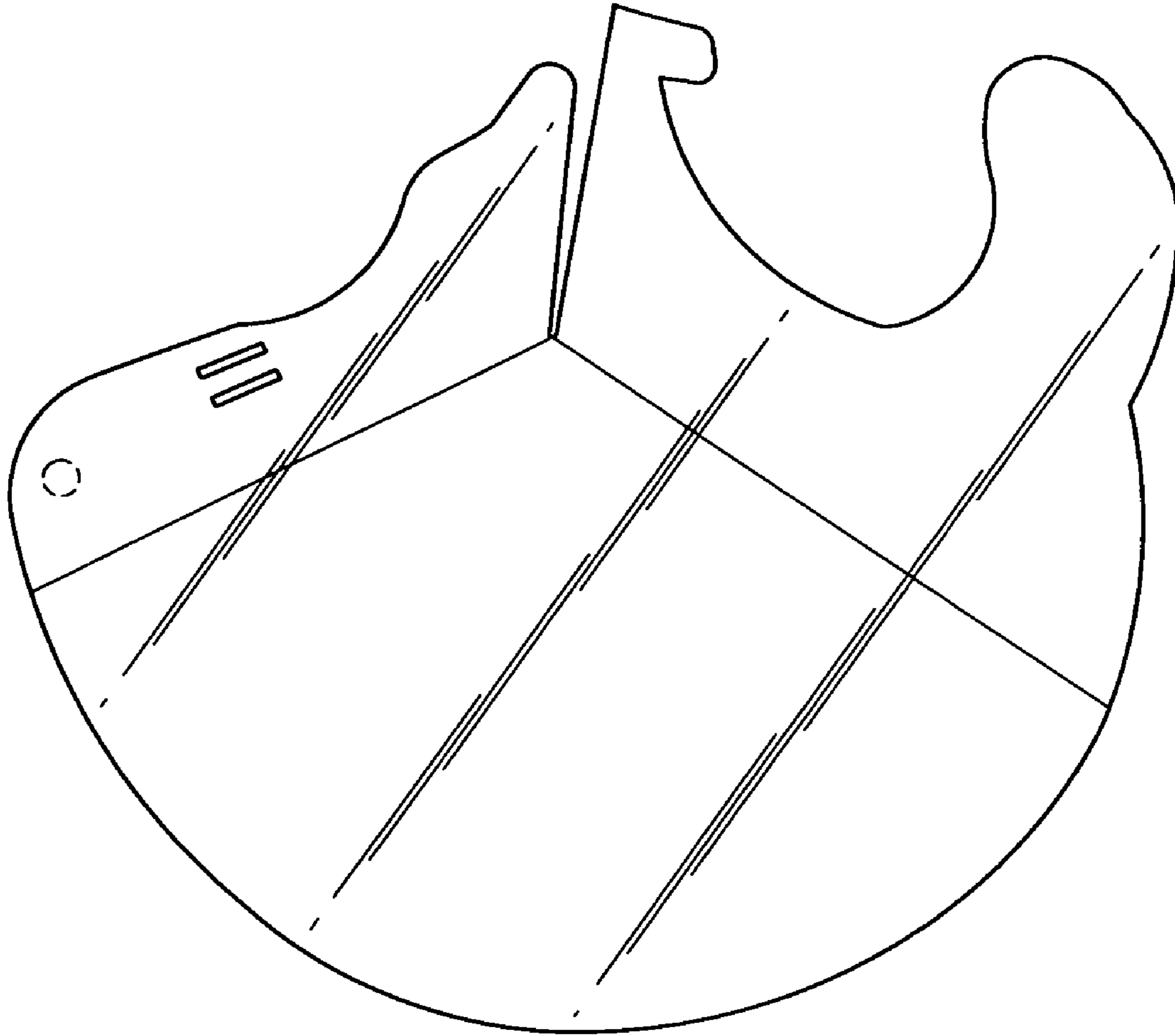

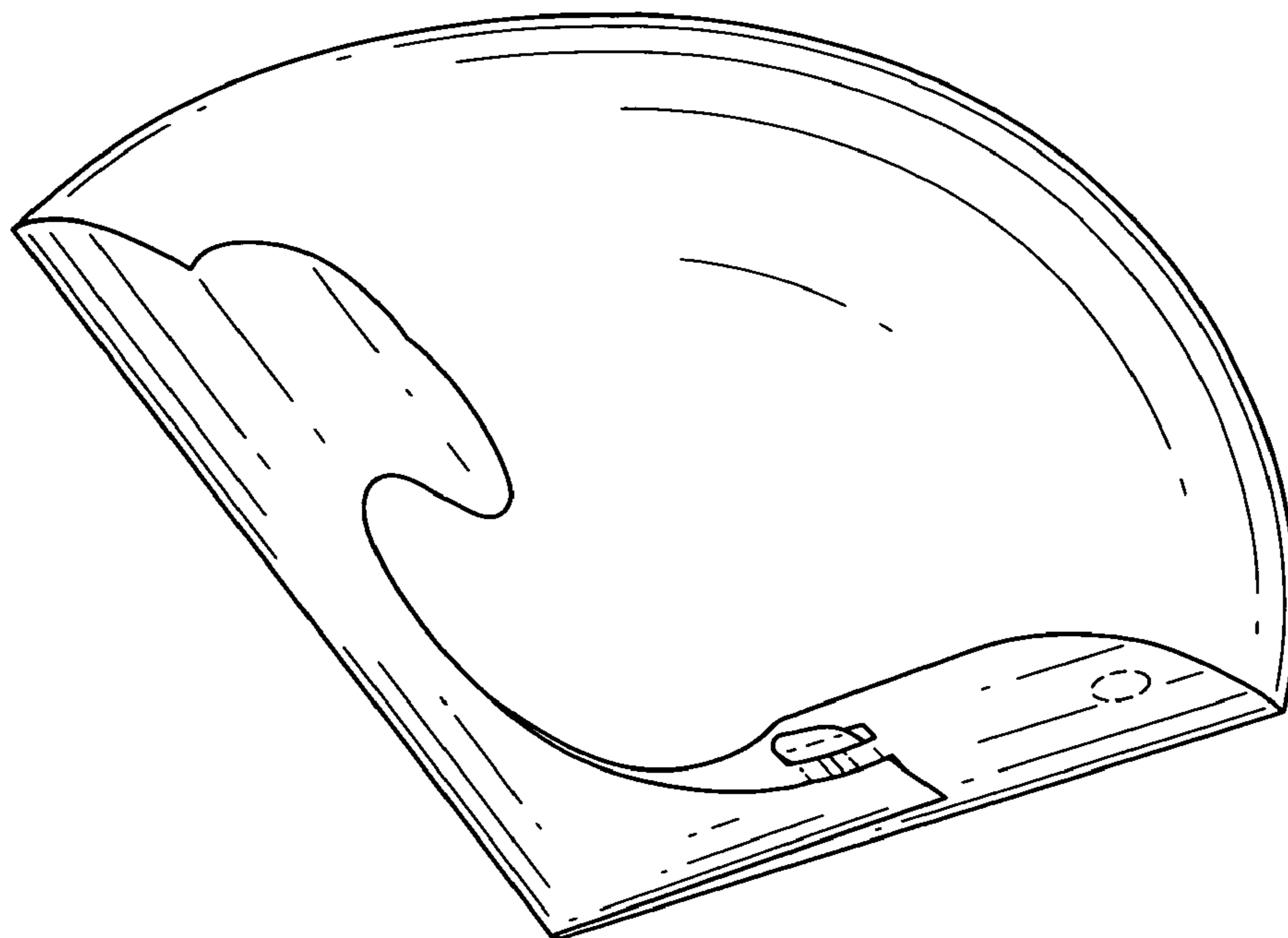

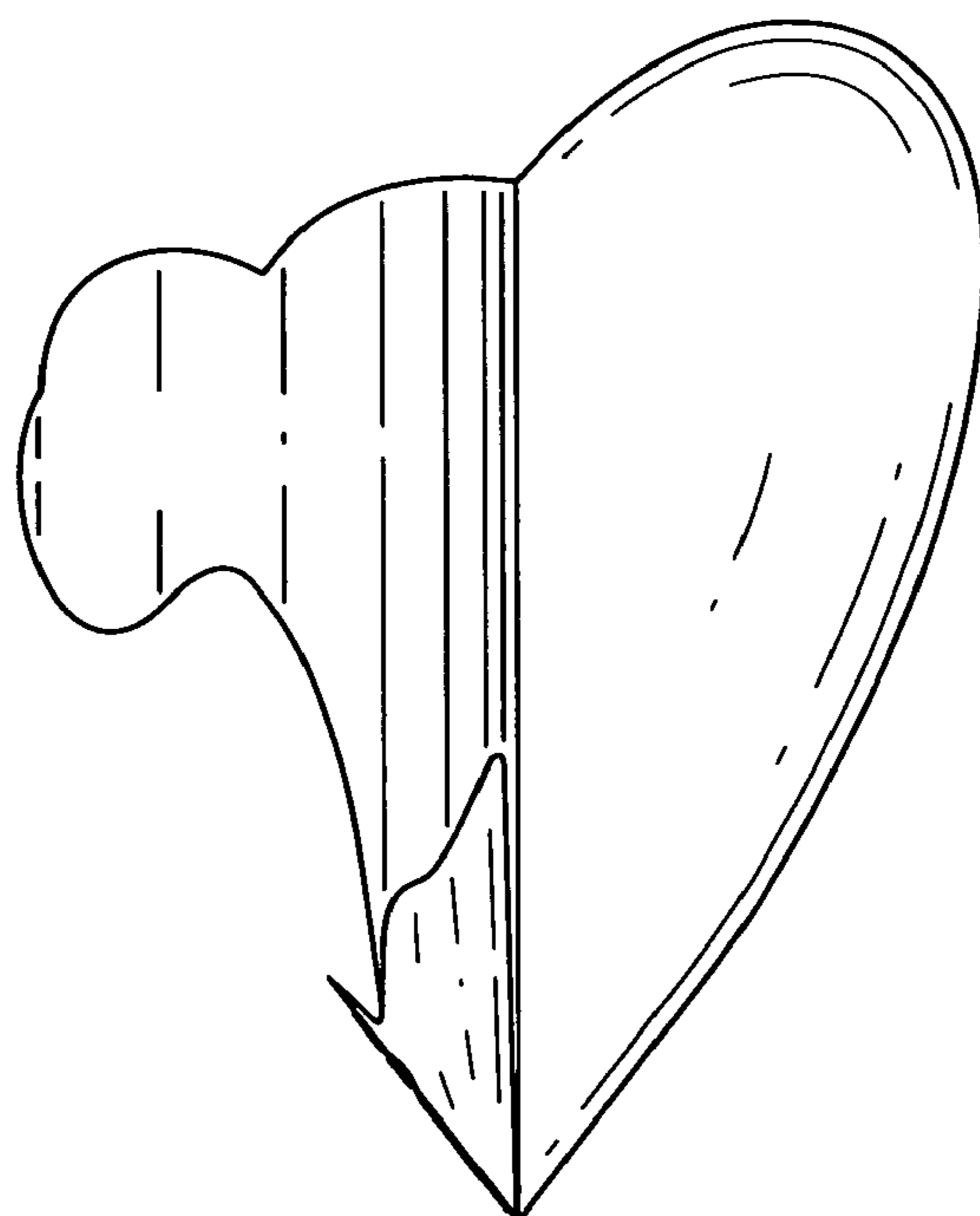

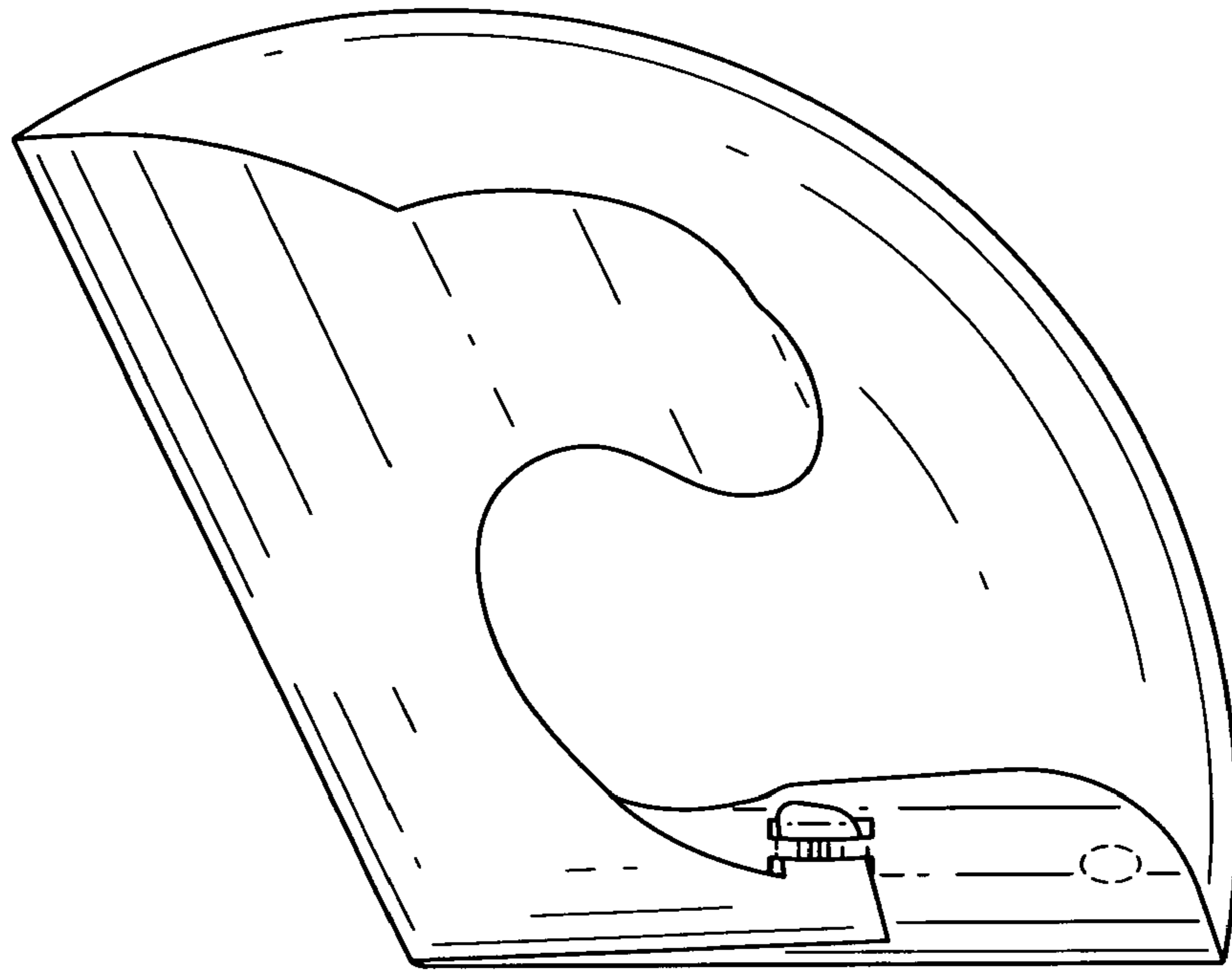

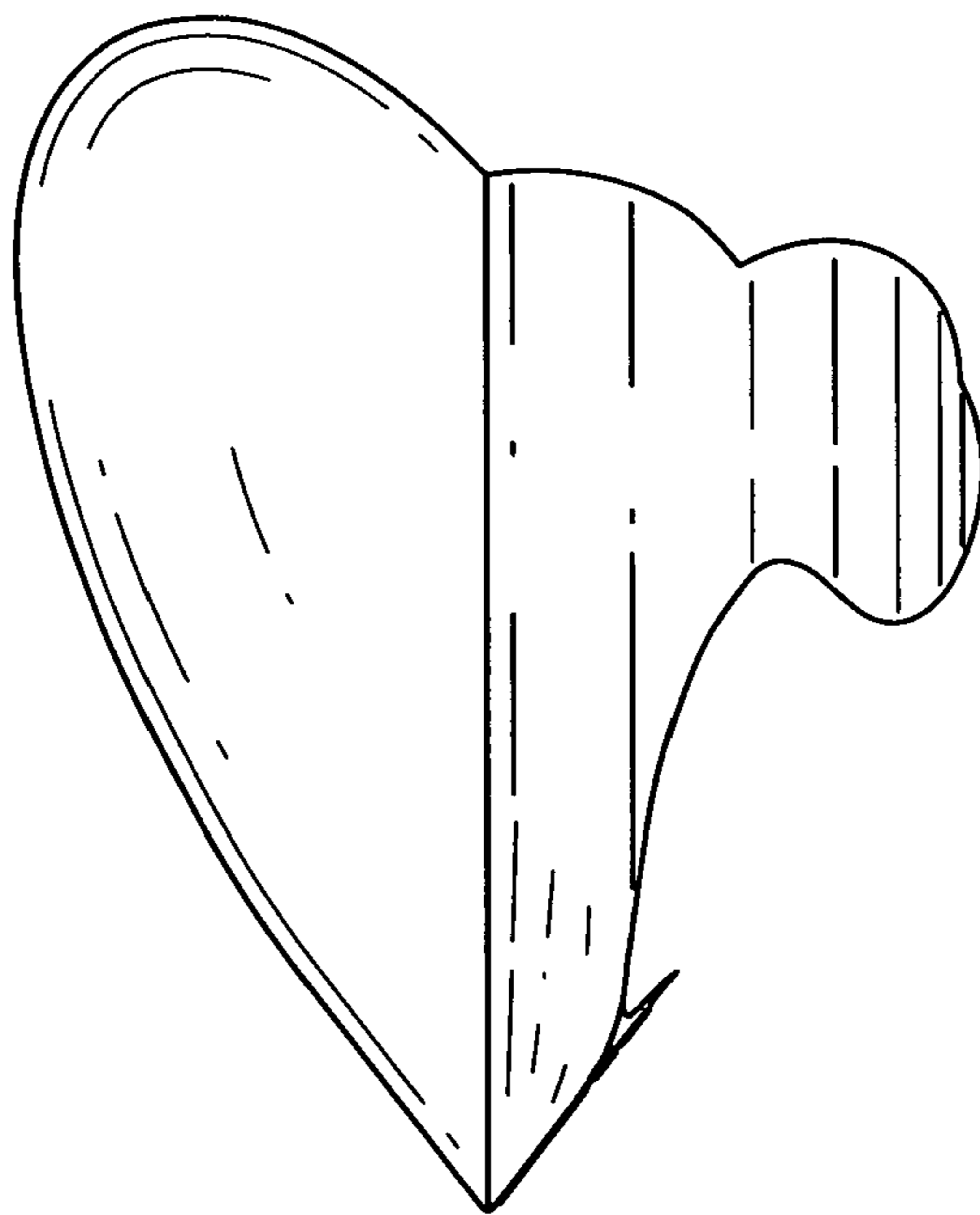

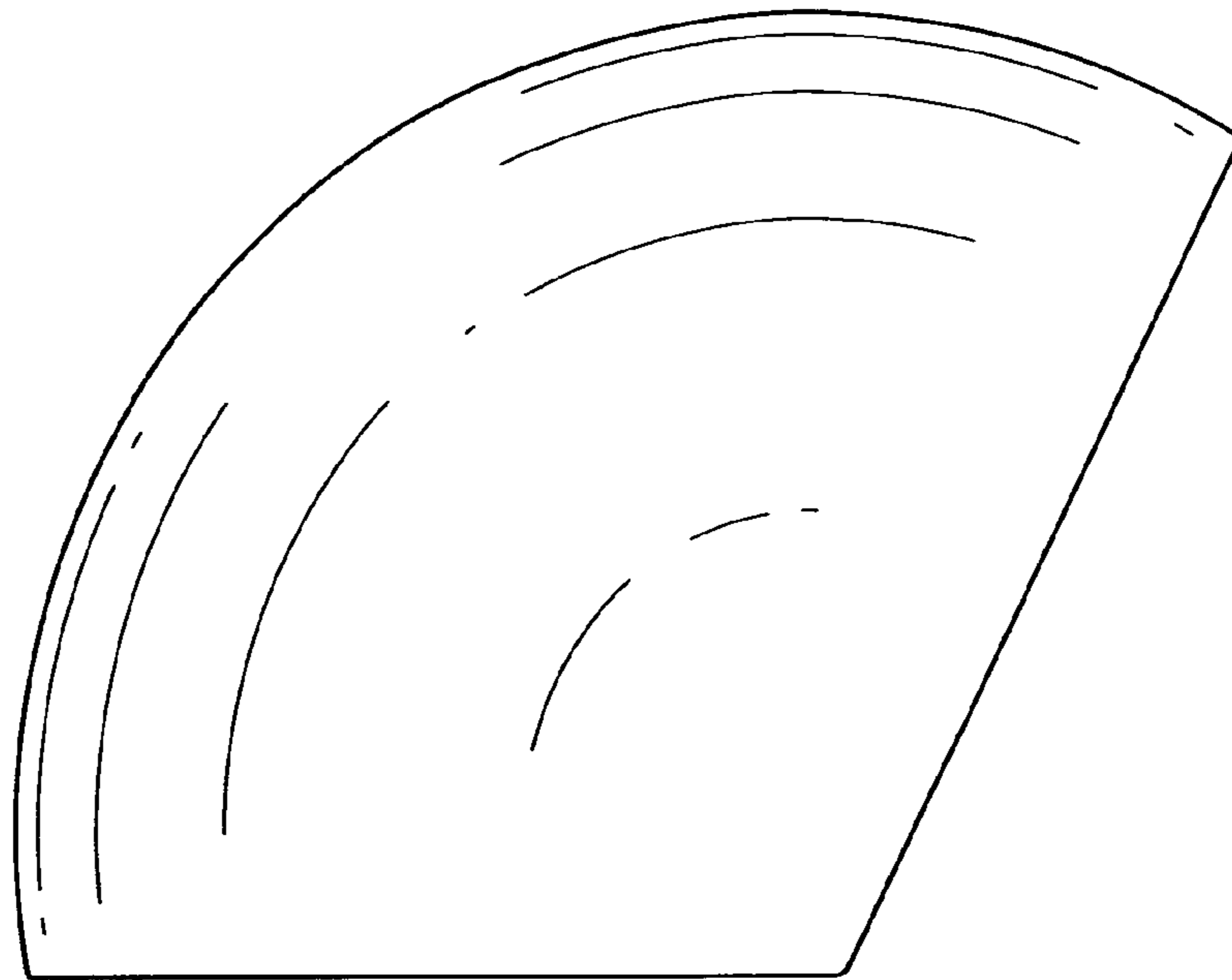

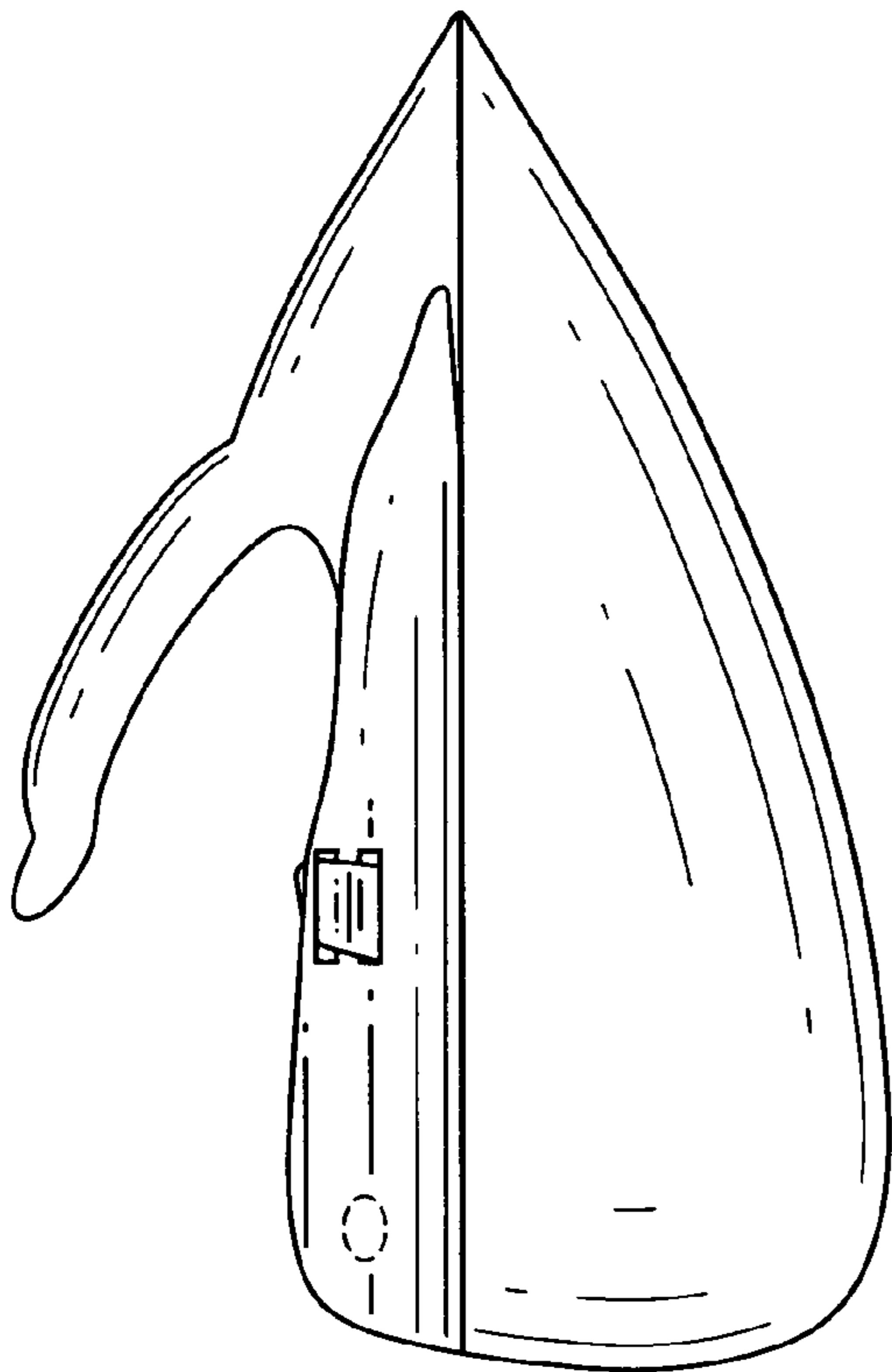

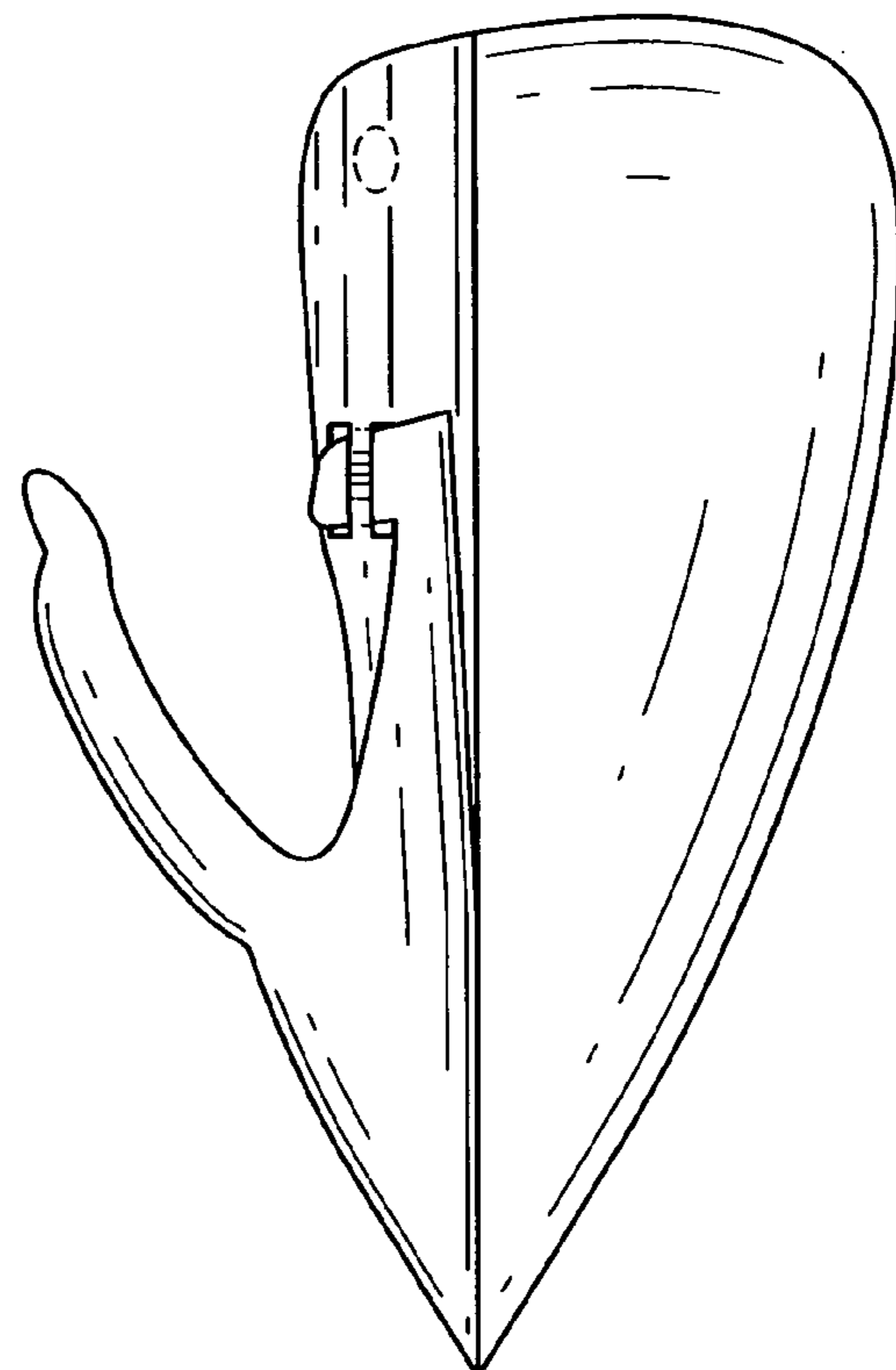

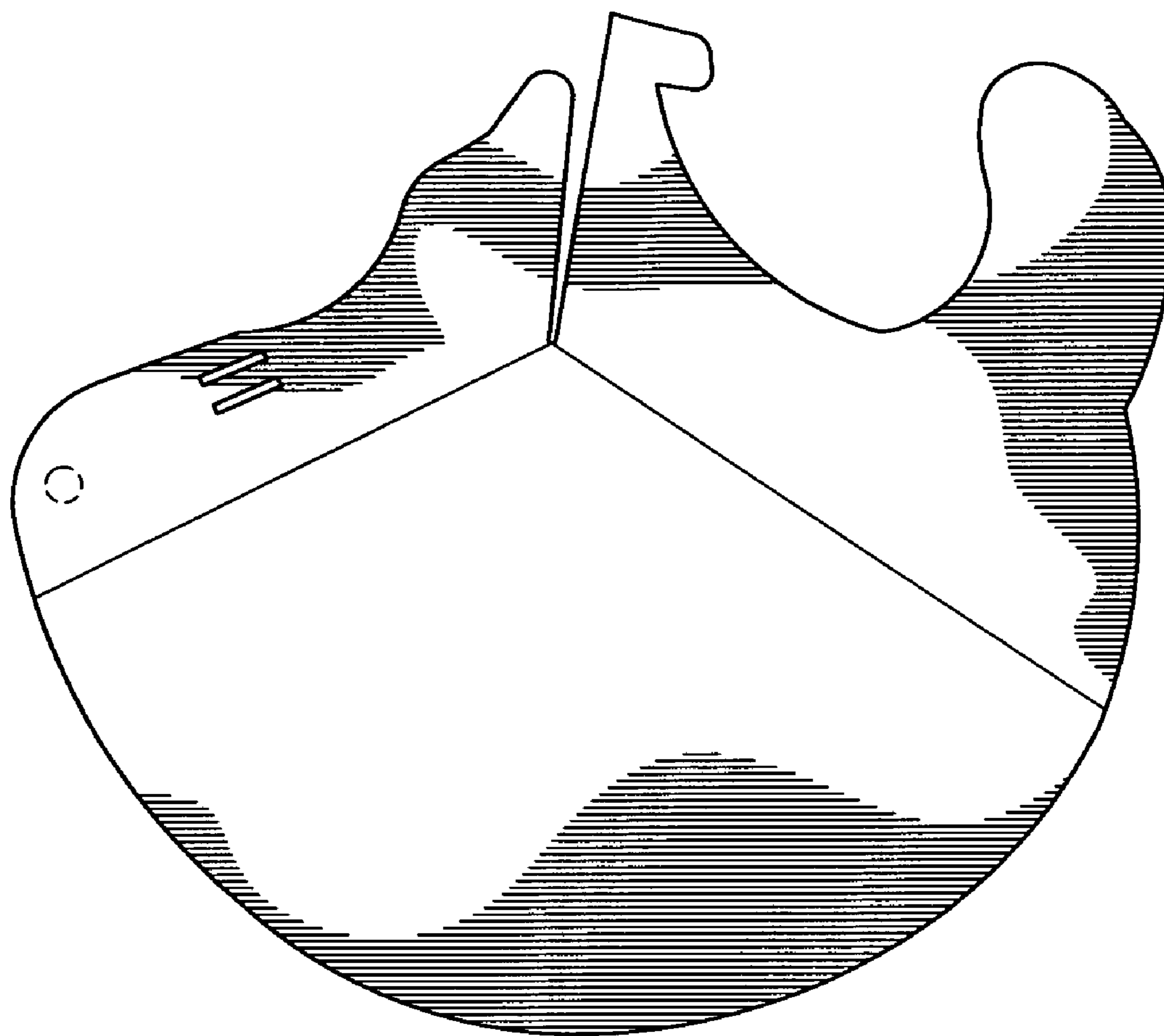
