FIG. 3 is a front elevational view of an adhesive body support.

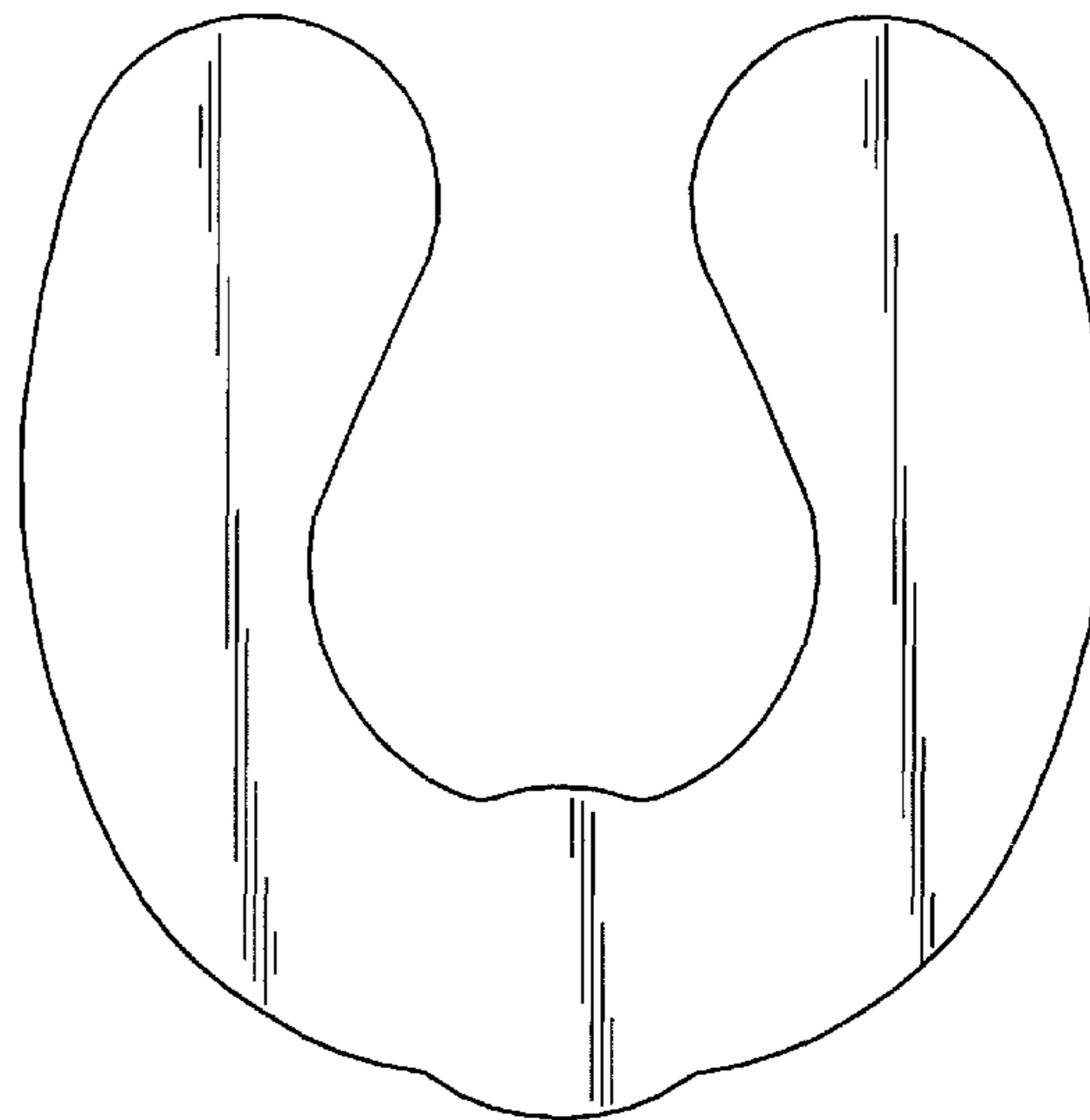
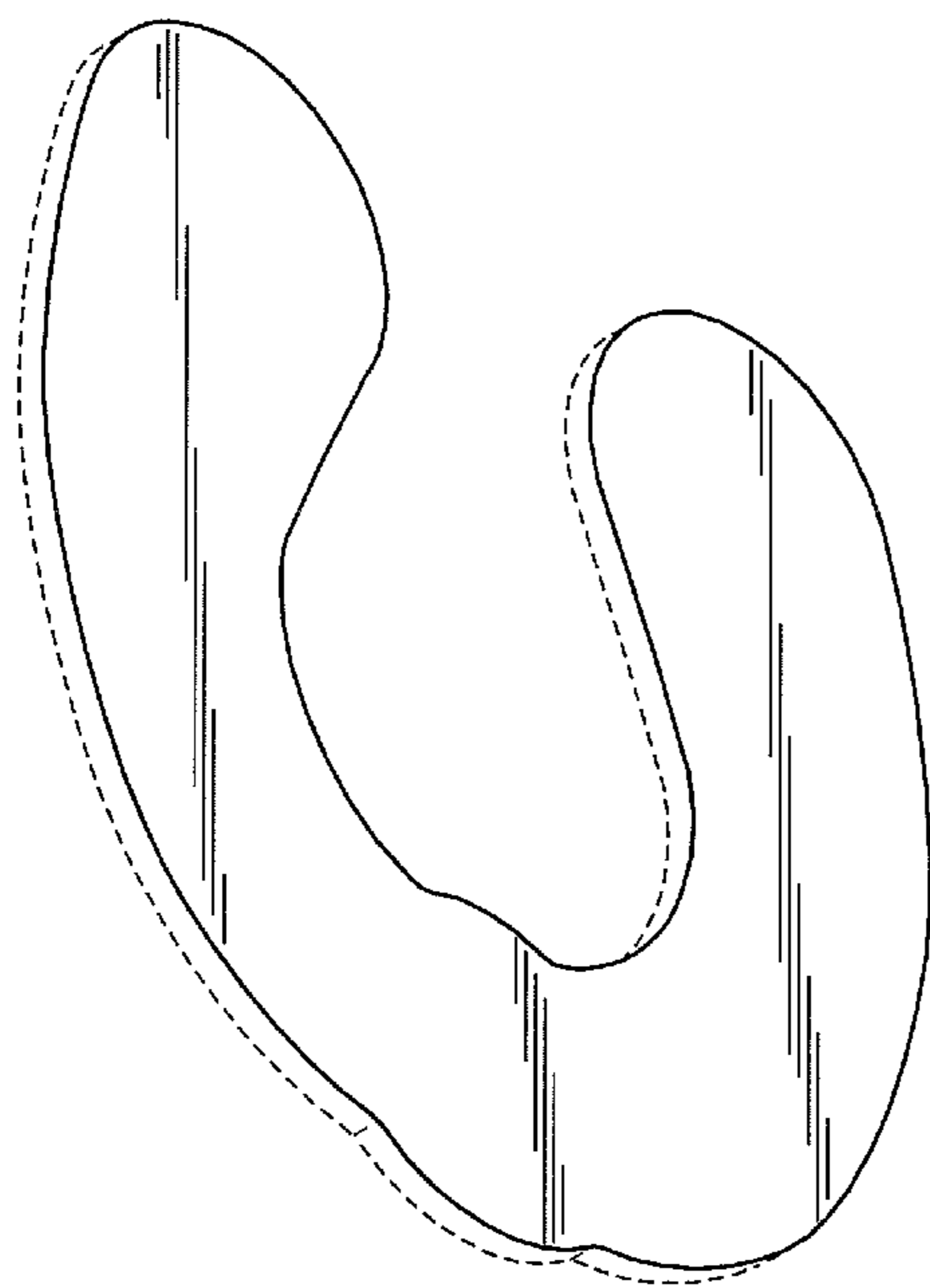
FIG. 4 is a right side elevational view of an adhesive body support.

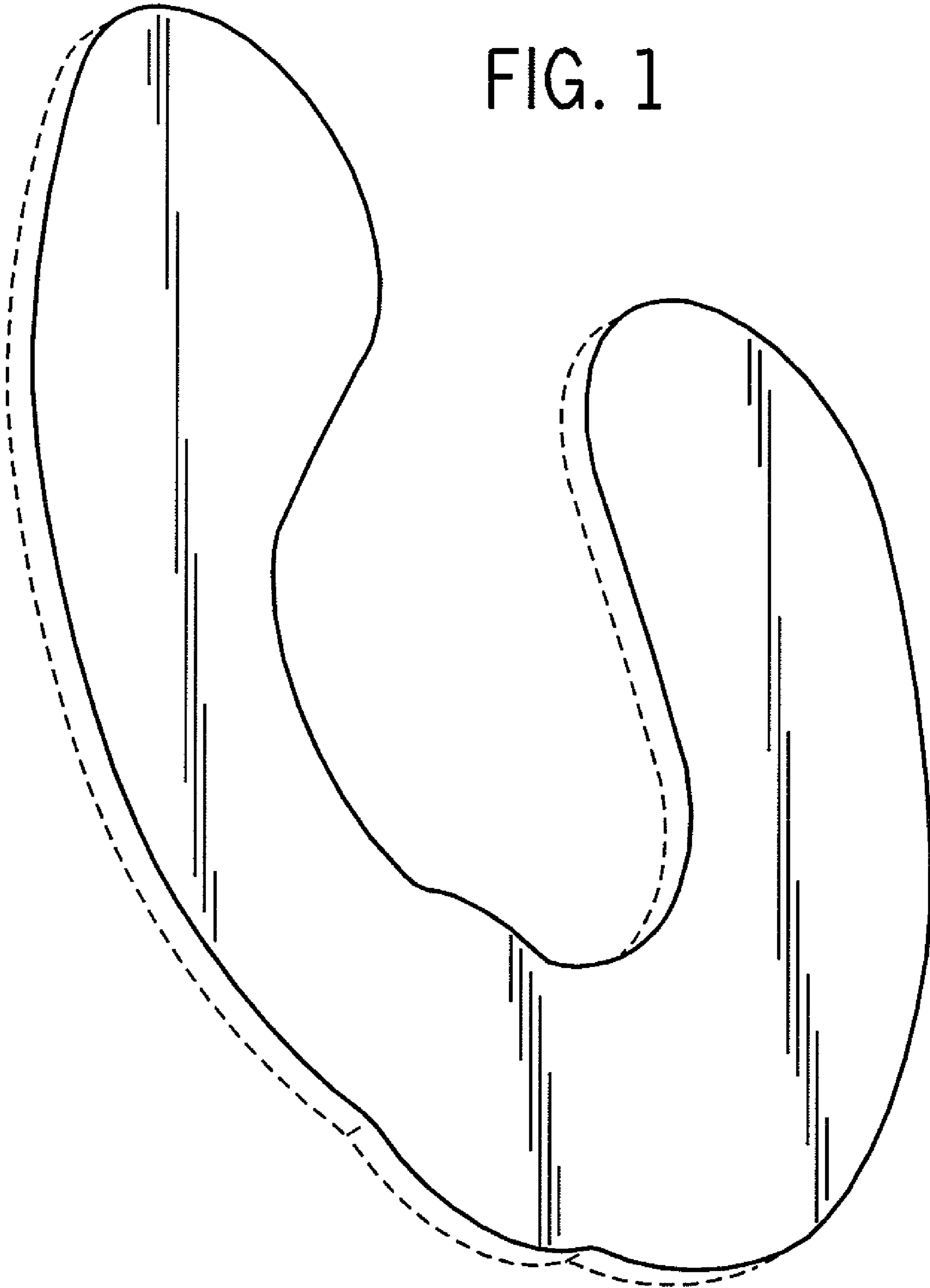

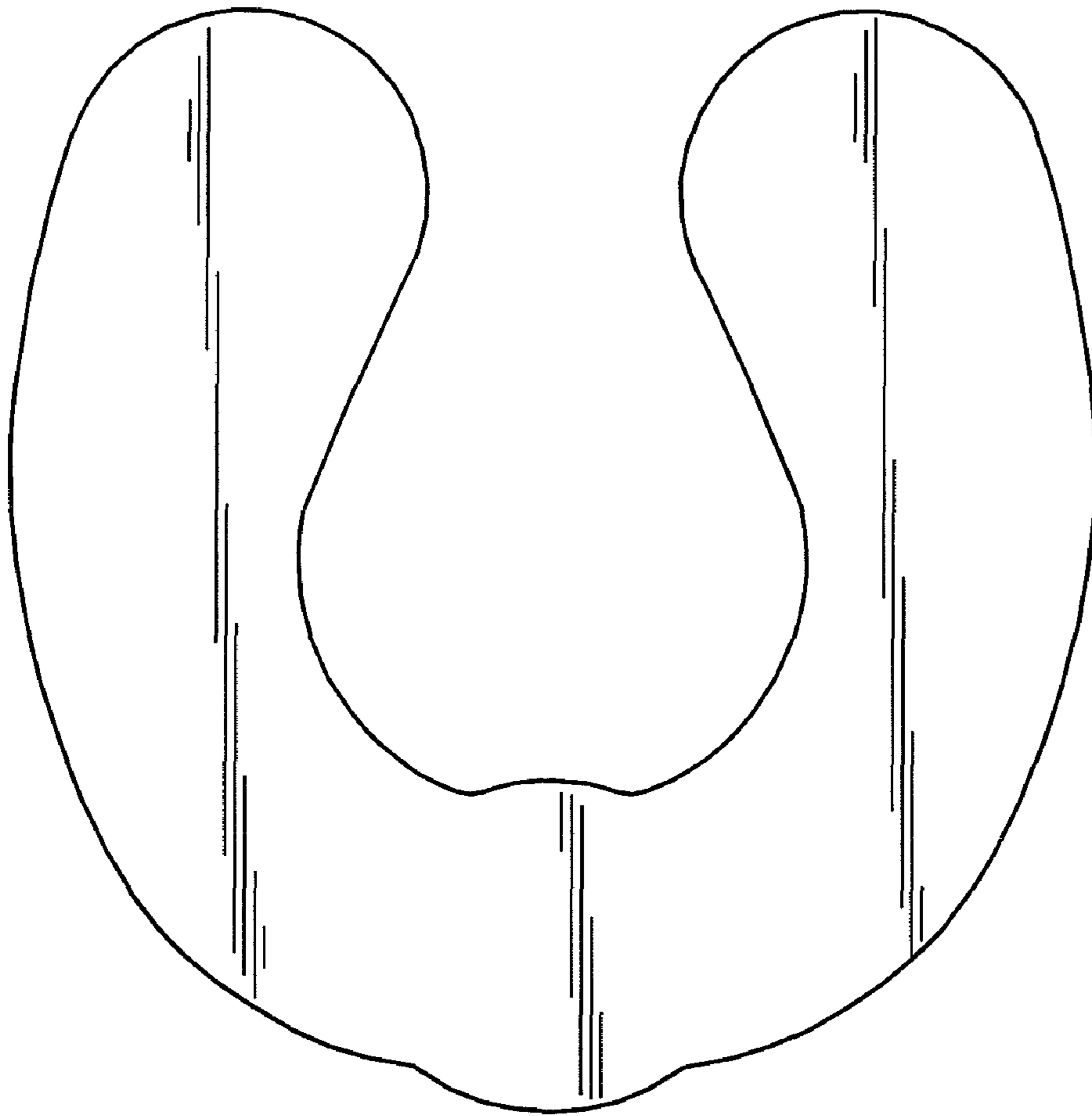

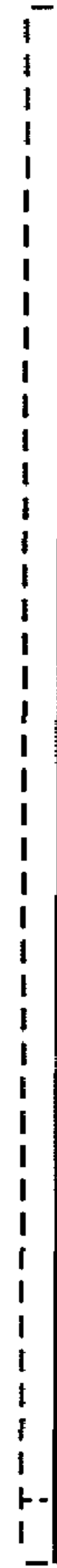

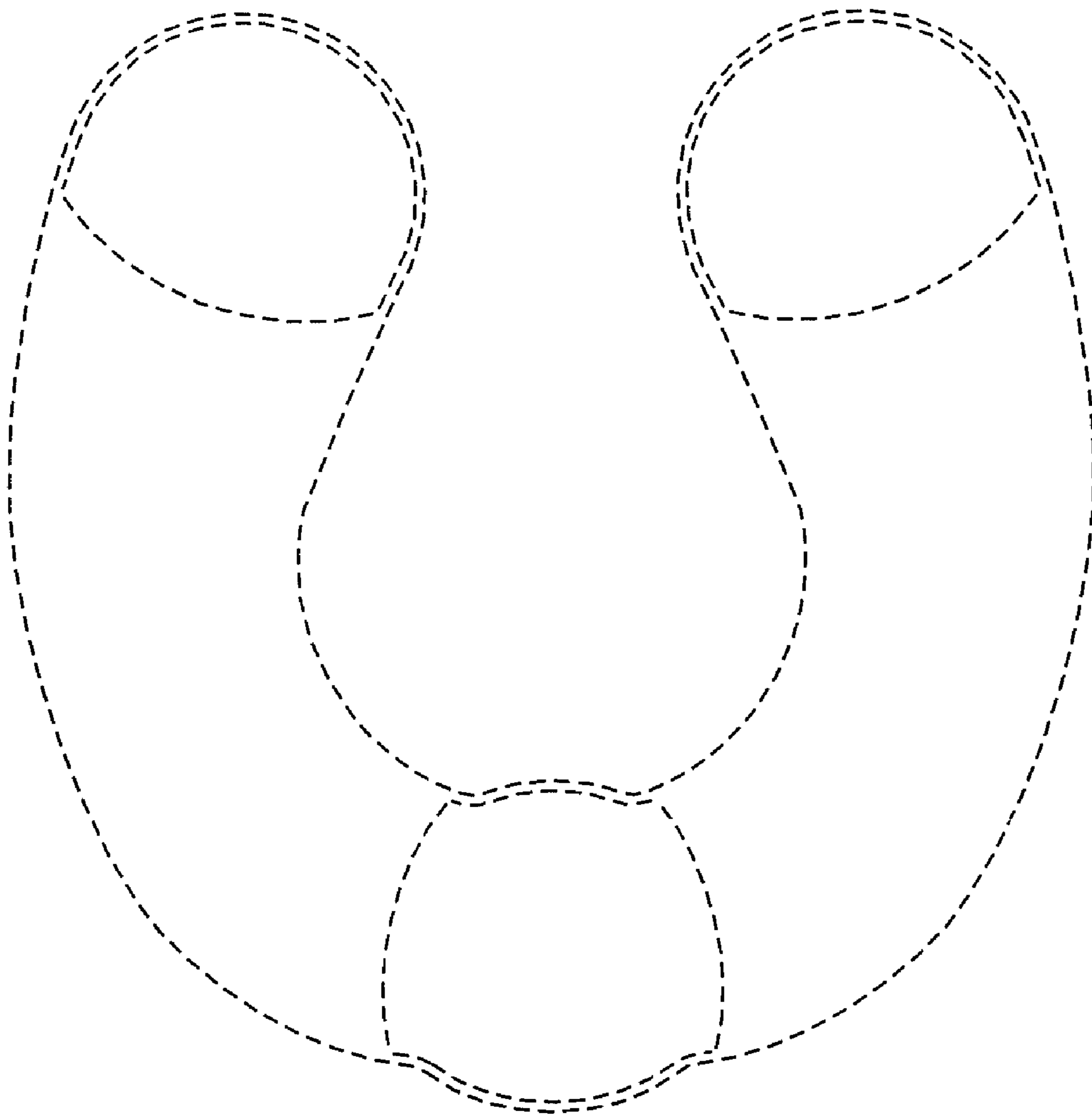
