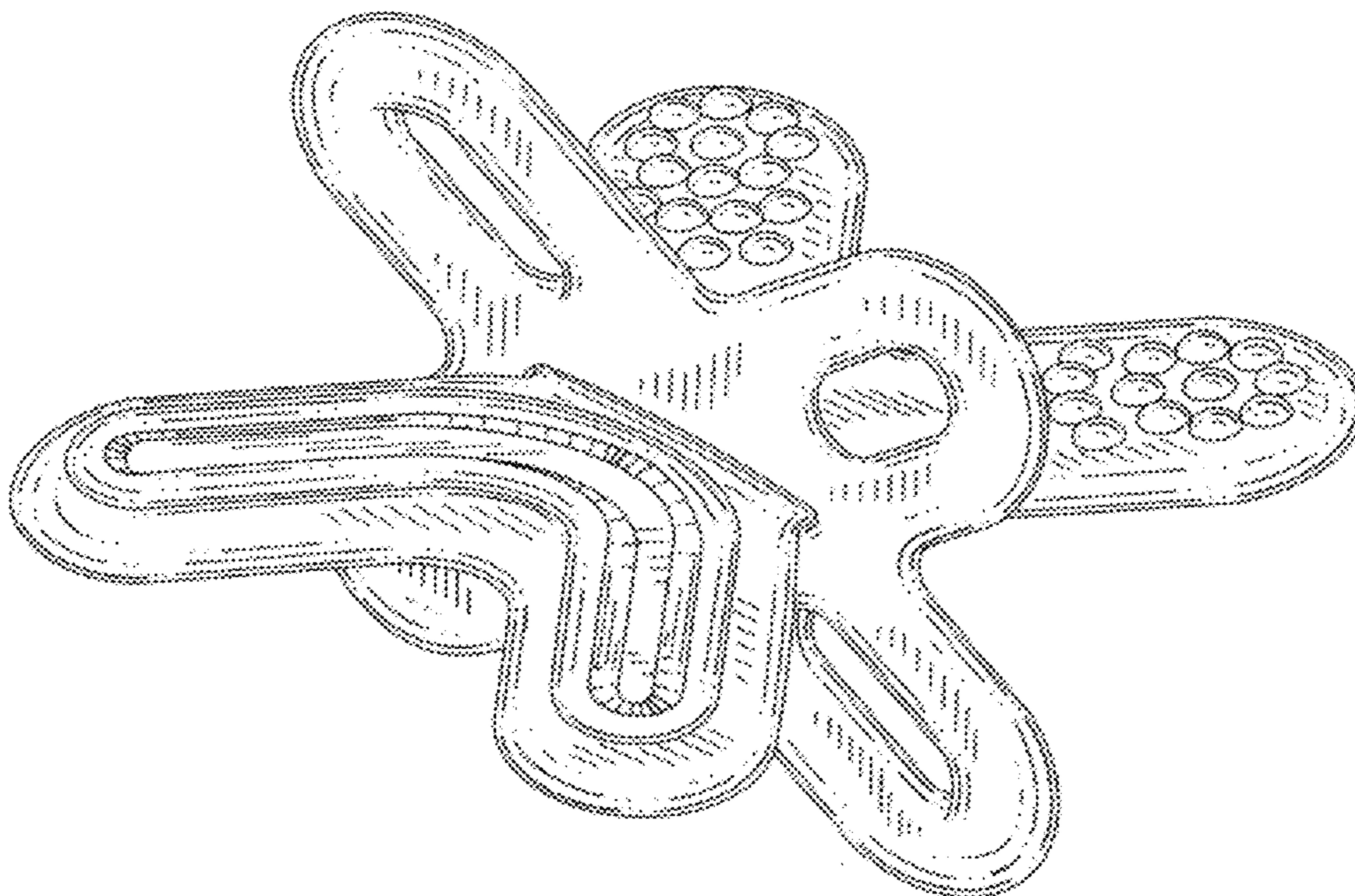
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top and right side perspective view of the pacifier teether showing the new design;
FIG. 2 is a bottom plan view thereof;

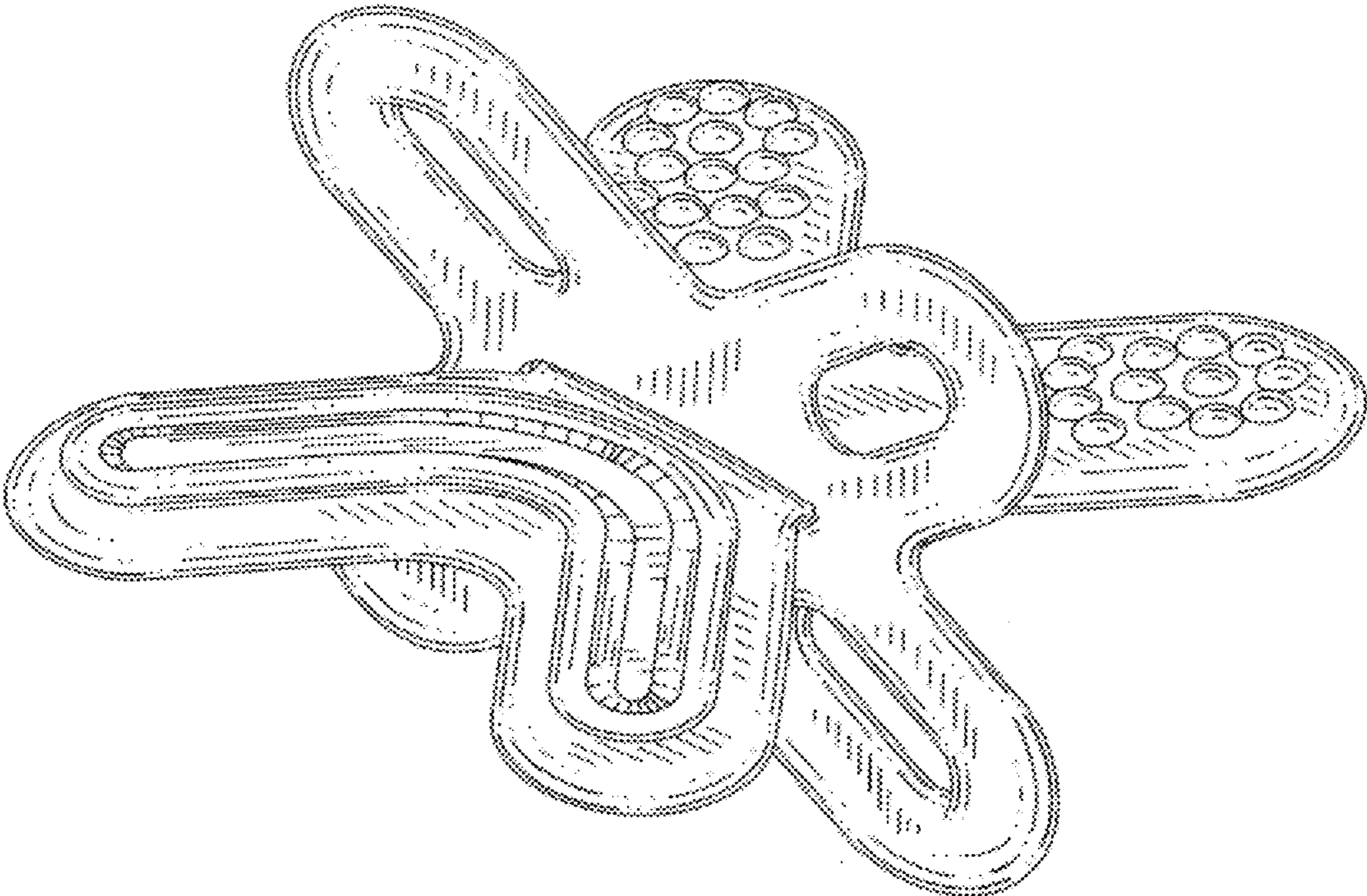

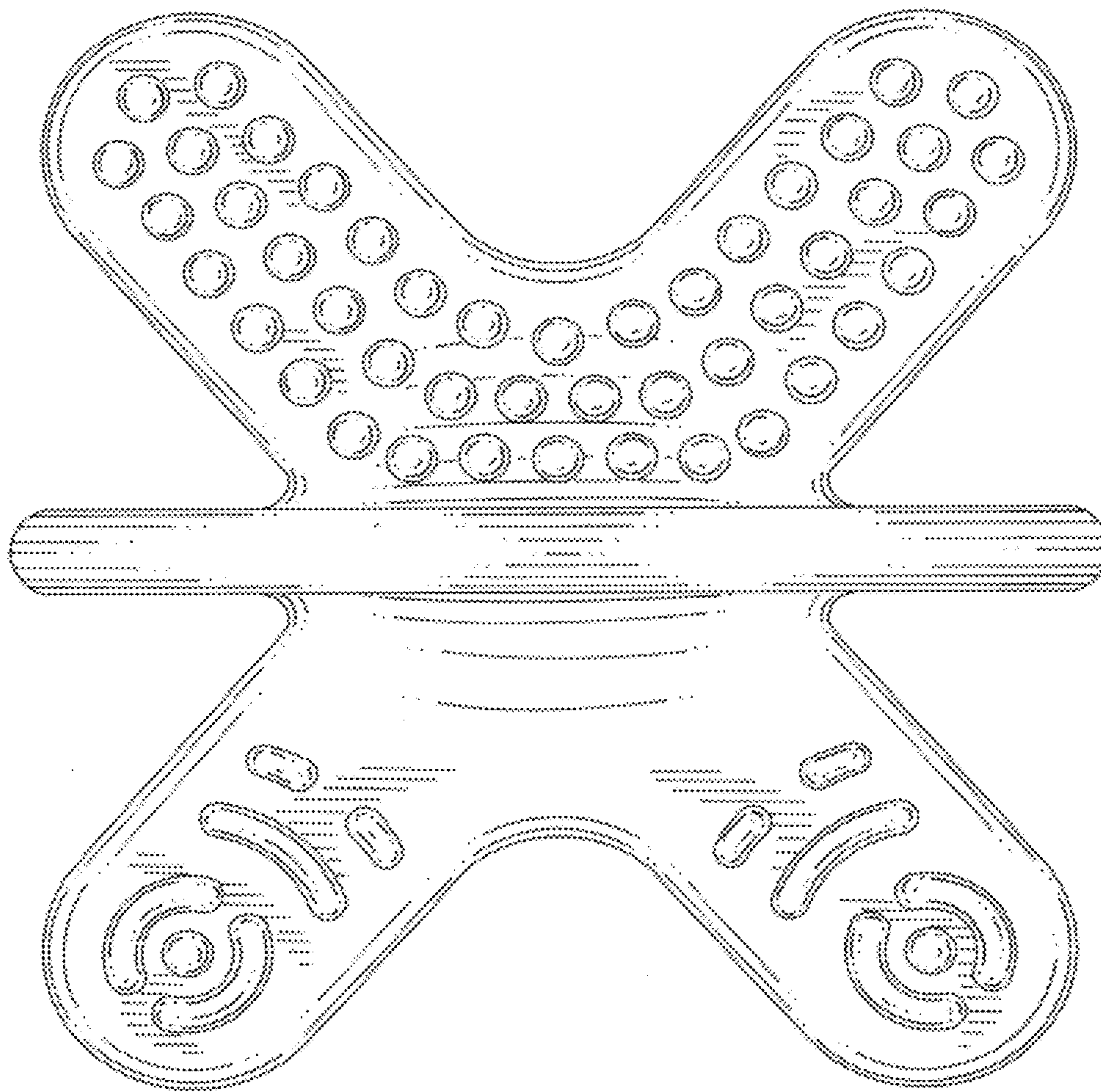

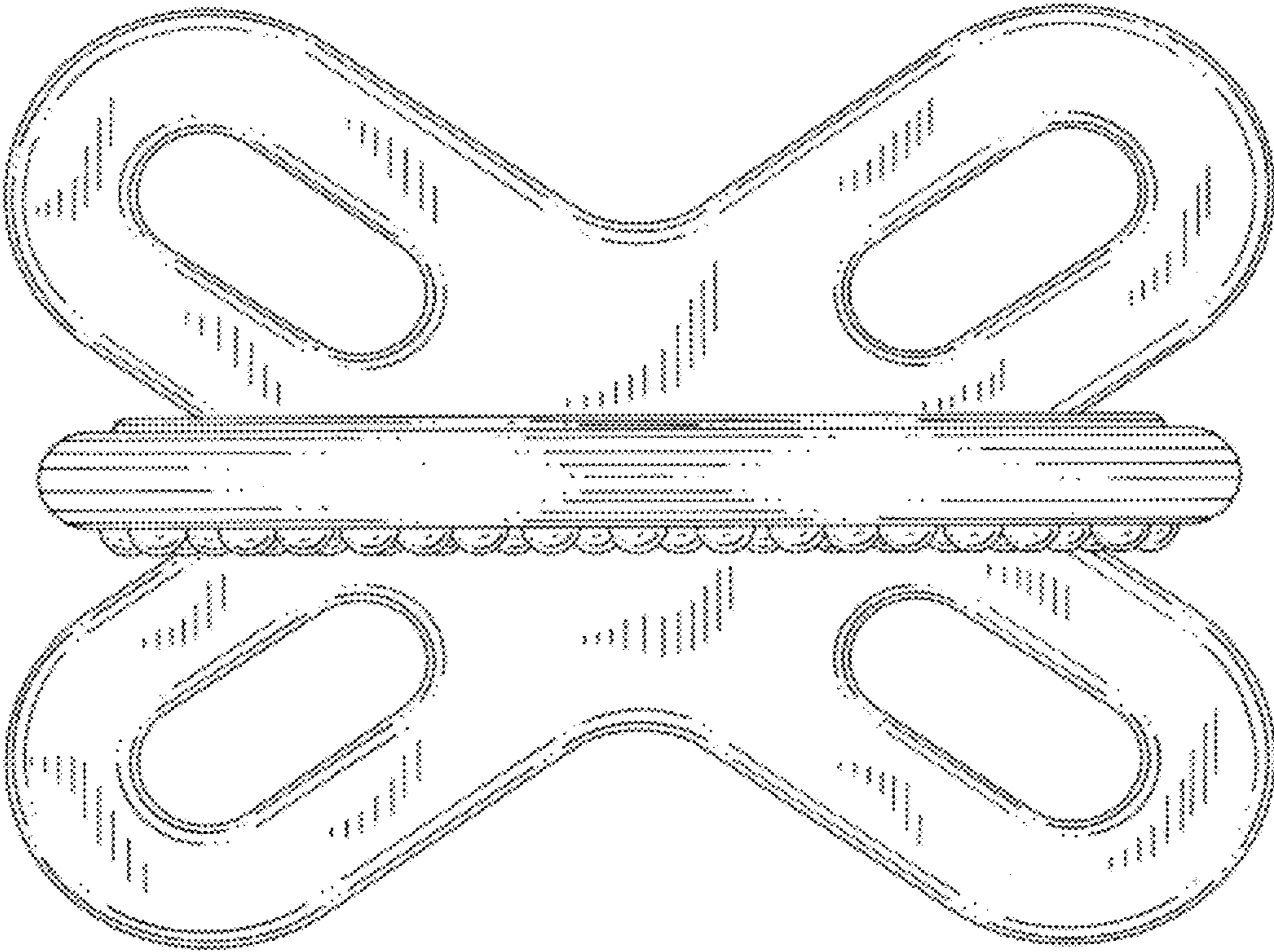

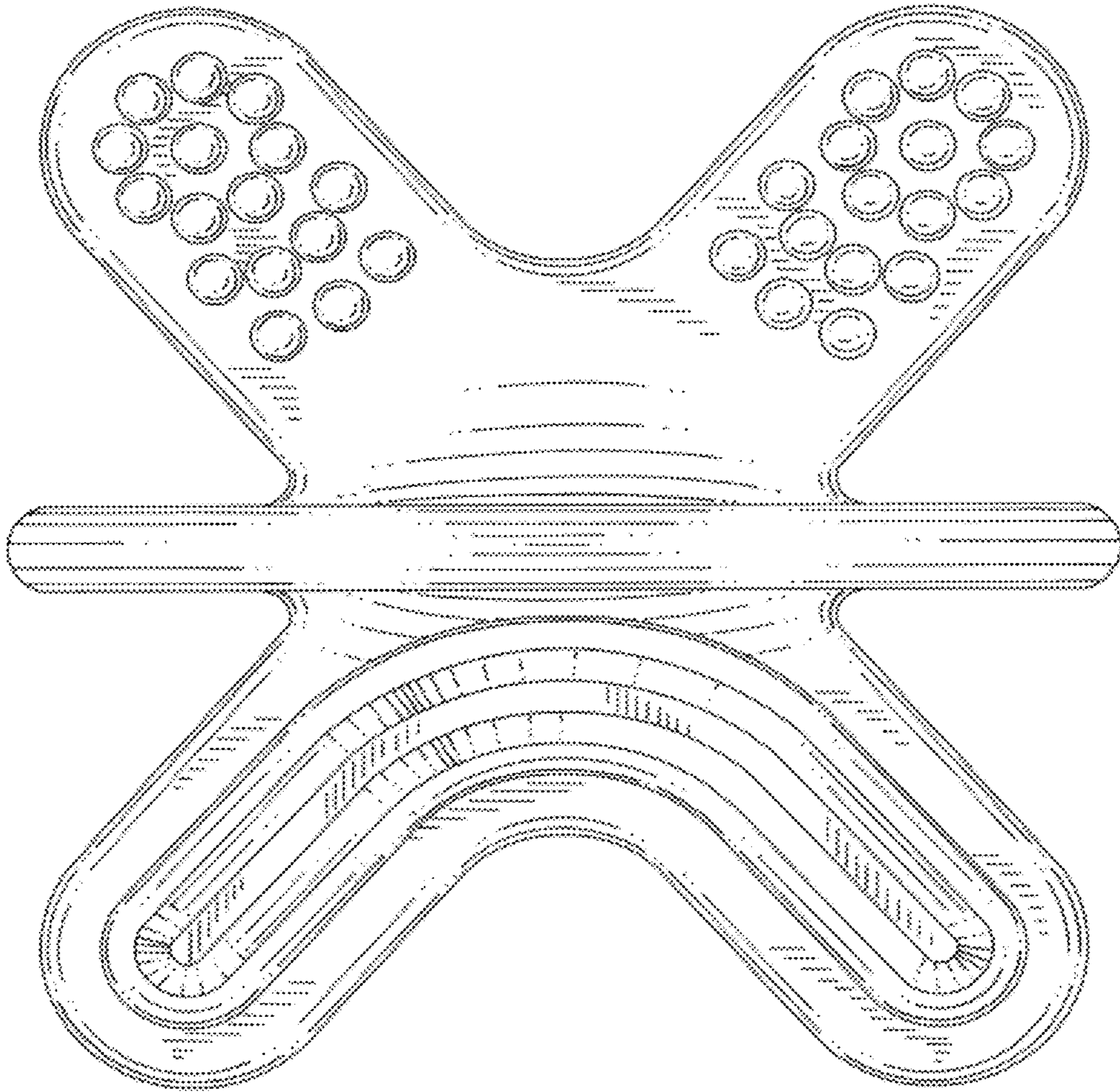

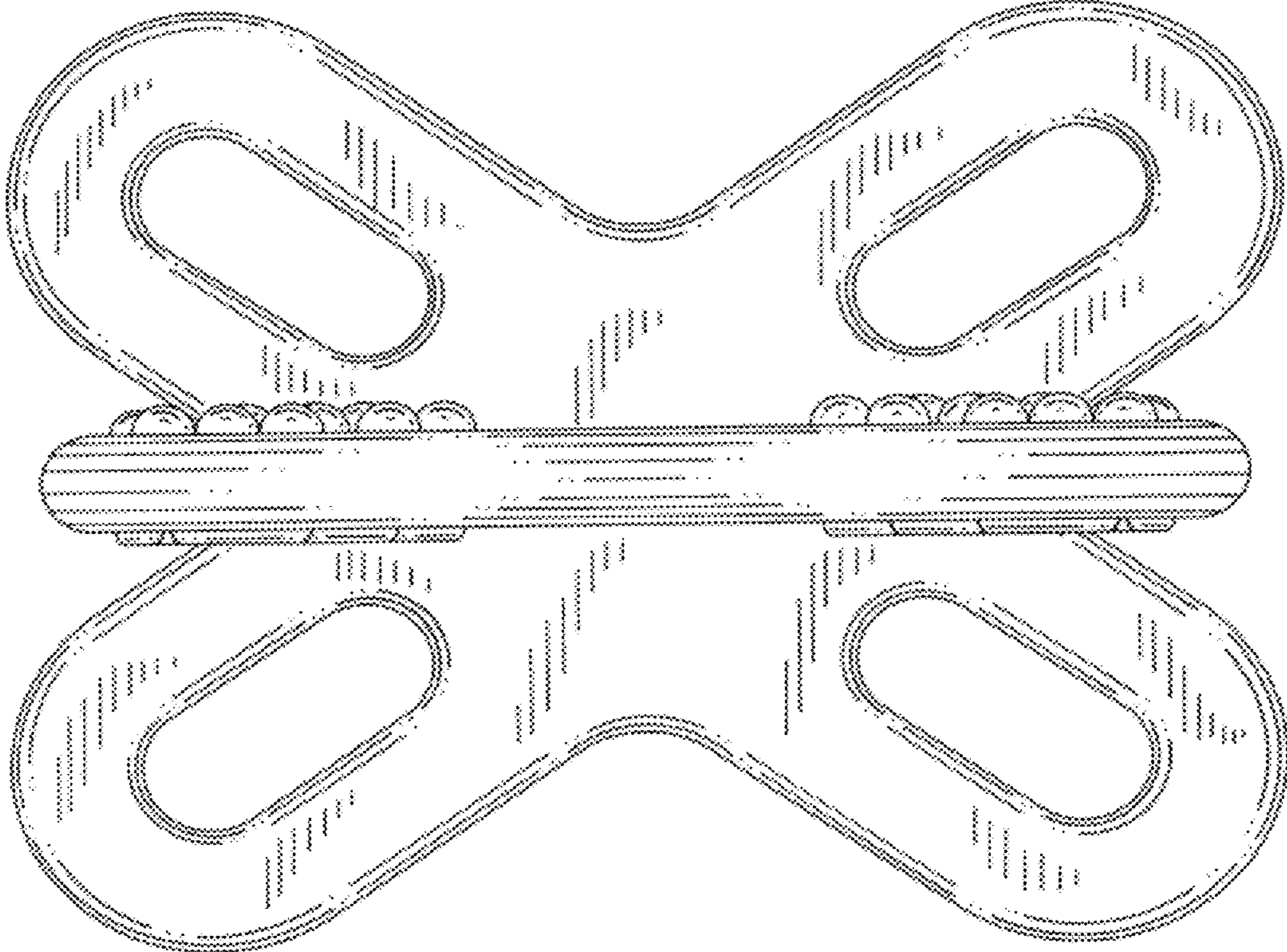

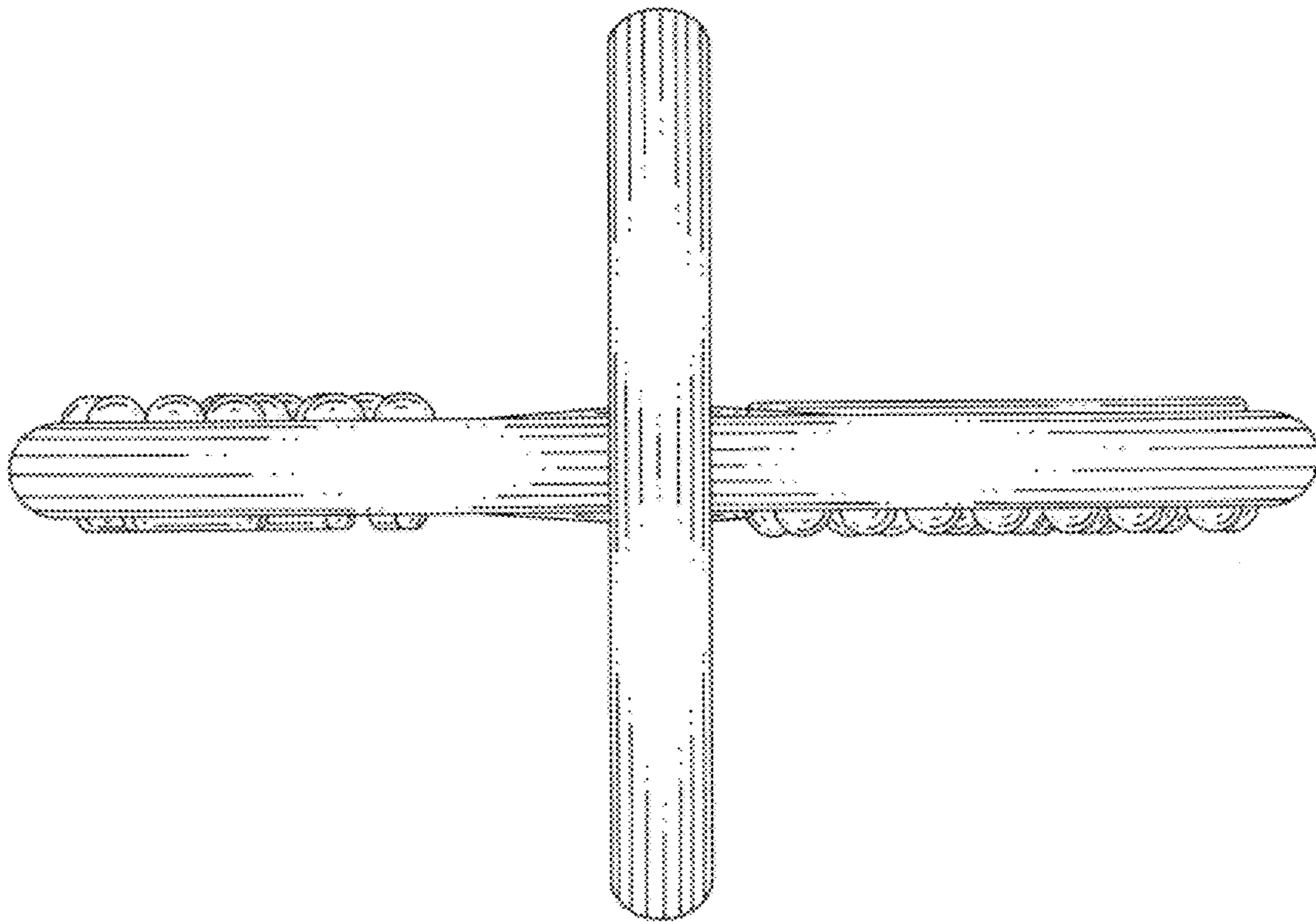

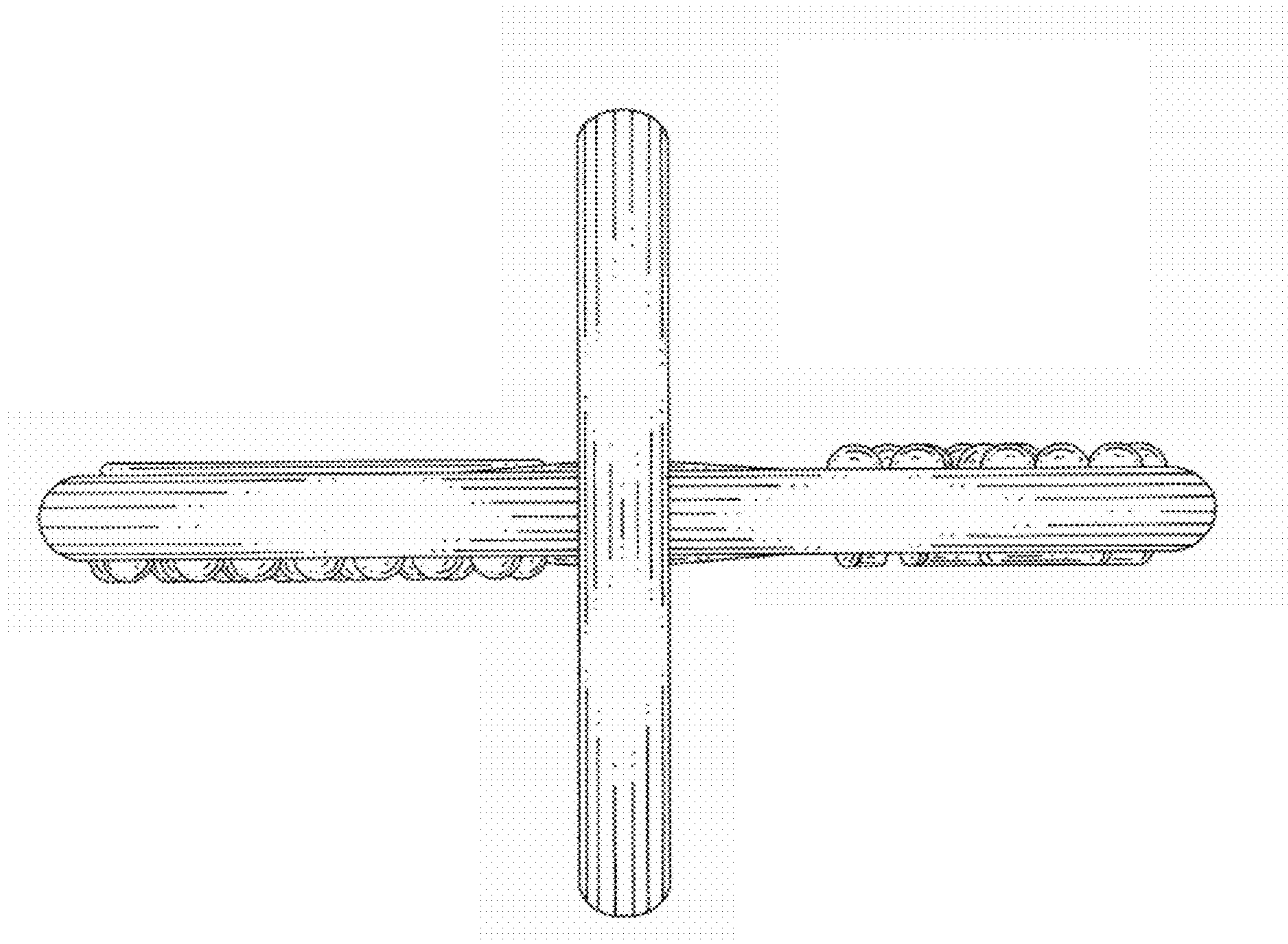
