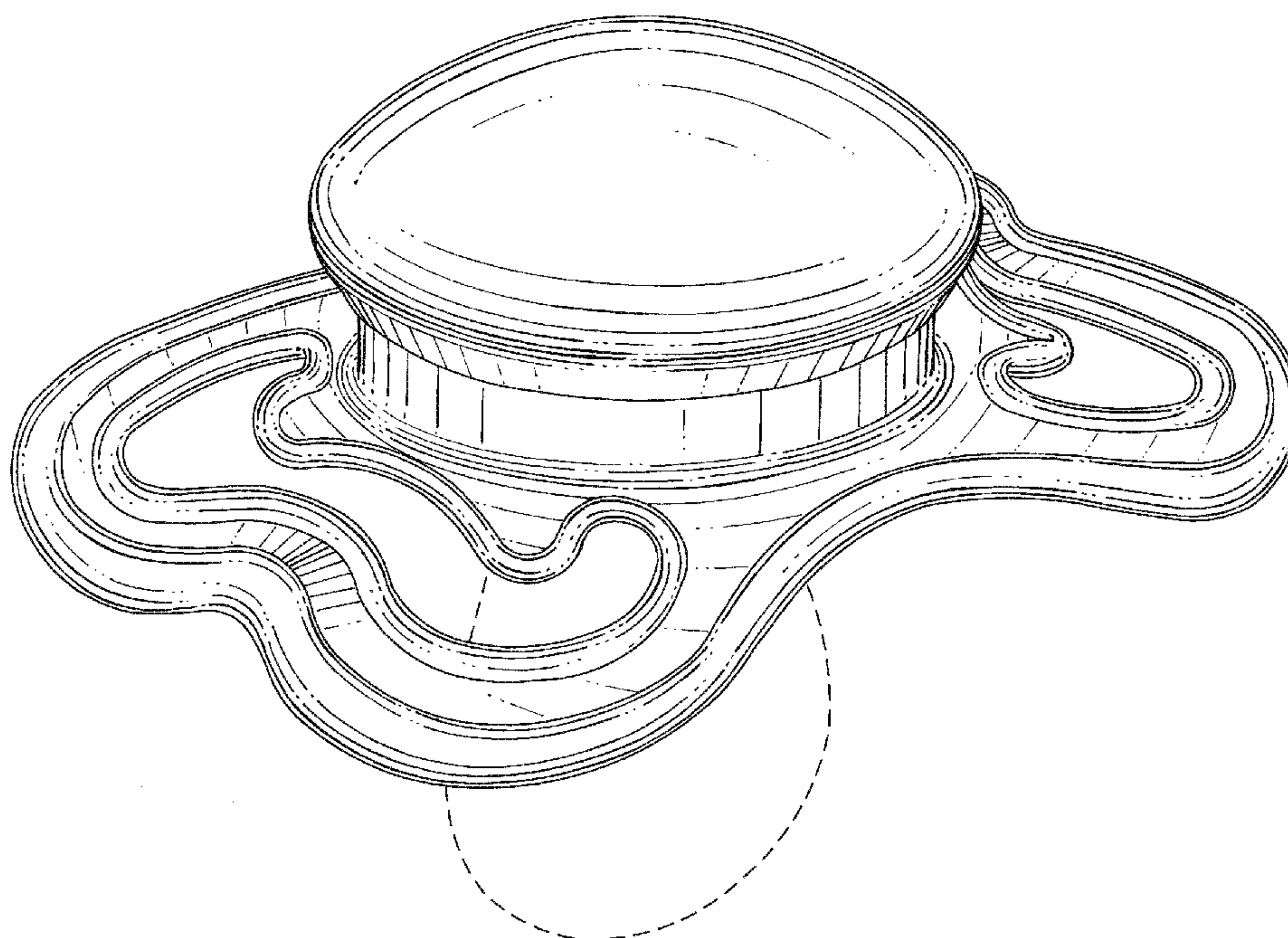
(57) **CLAIM**

The ornamental design for a pacifier, as shown and described.

DESCRIPTION

FIG. 1 is a top and left side perspective view of the pacifier showing the new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a front elevation view thereof, the back elevation view being a mirror image thereof; and,
FIG. 5 is a left side elevation view thereof, the right side elevation view being a mirror image thereof.
The broken lines illustrate portions of the pacifier that form no part of the claimed design.

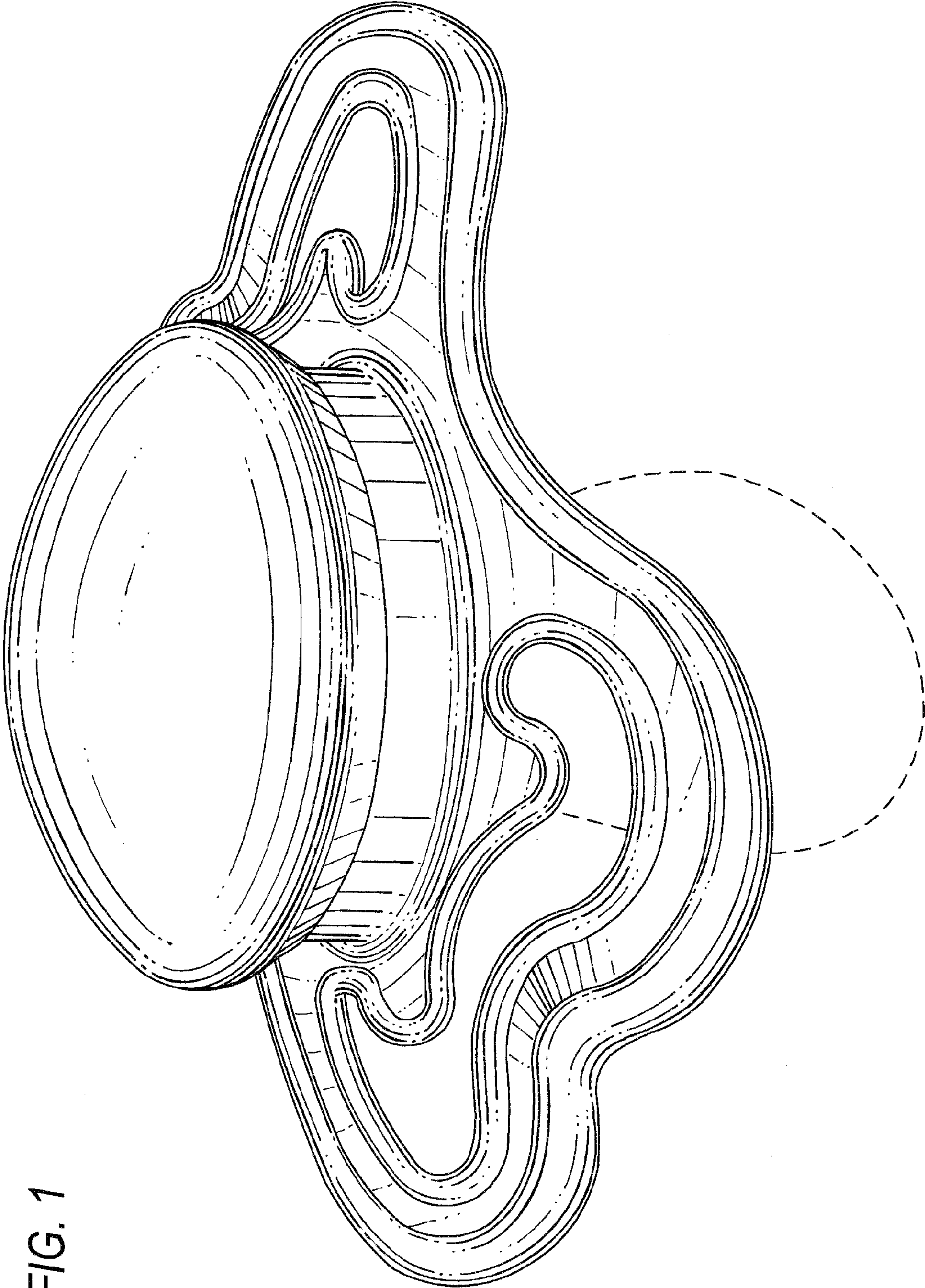

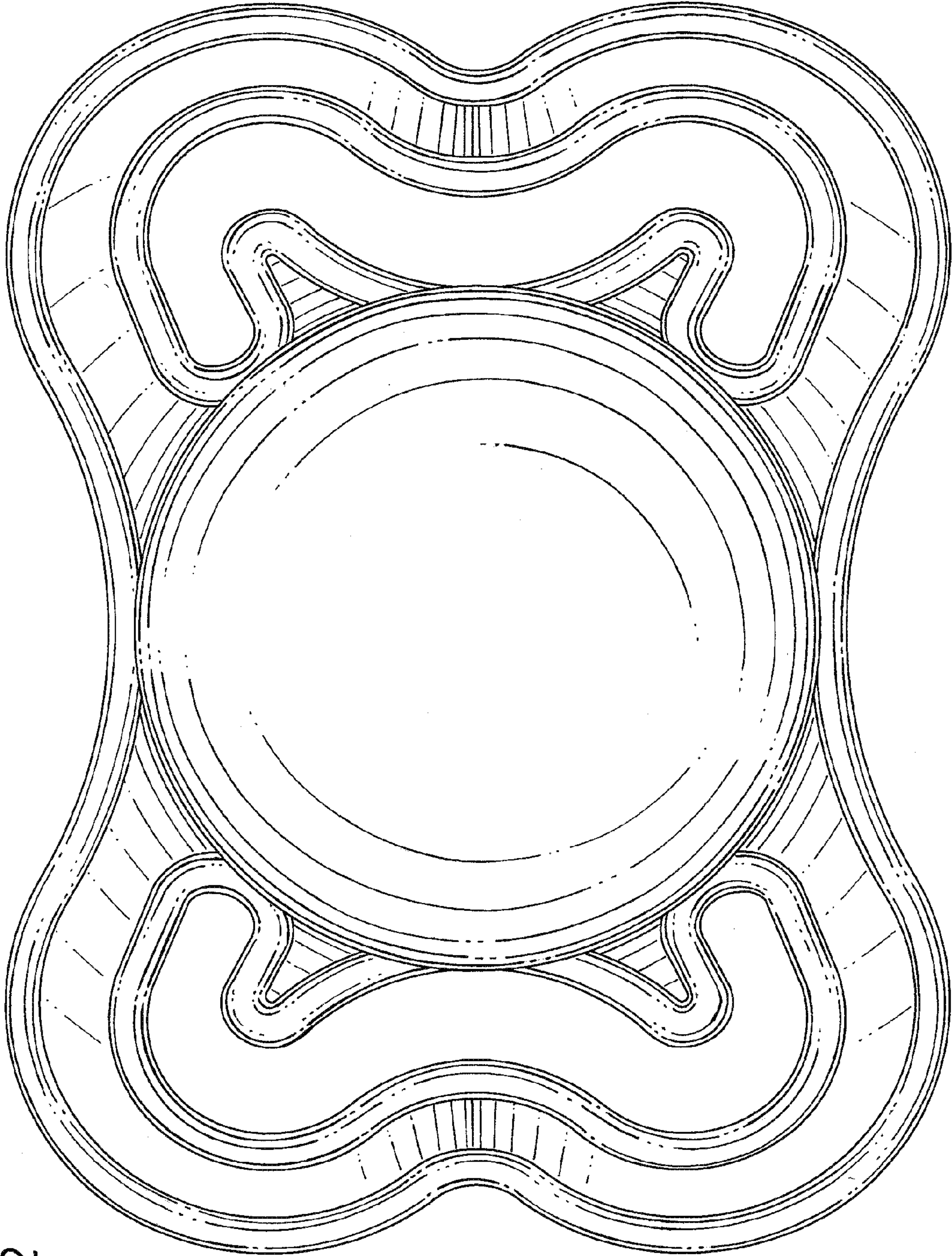

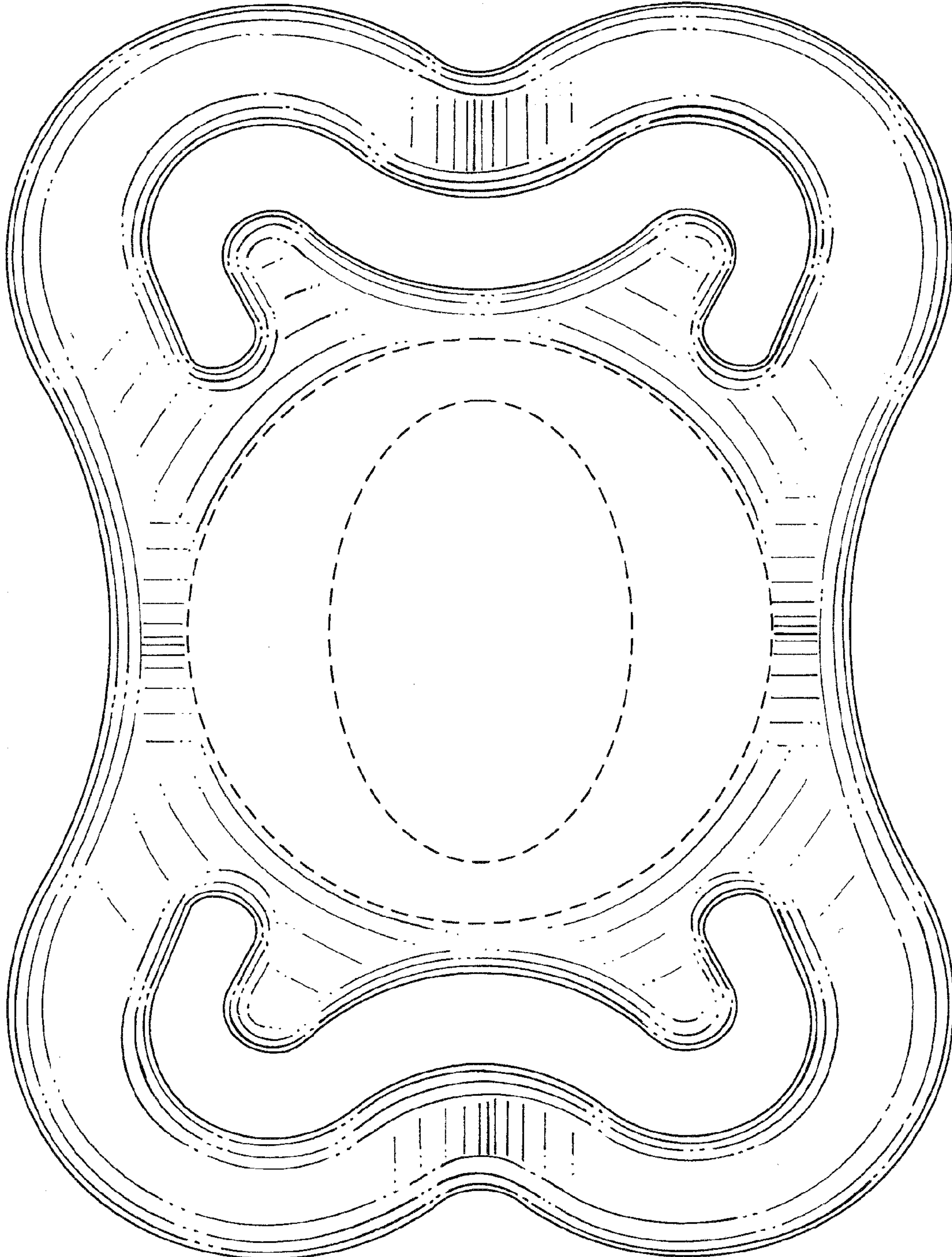

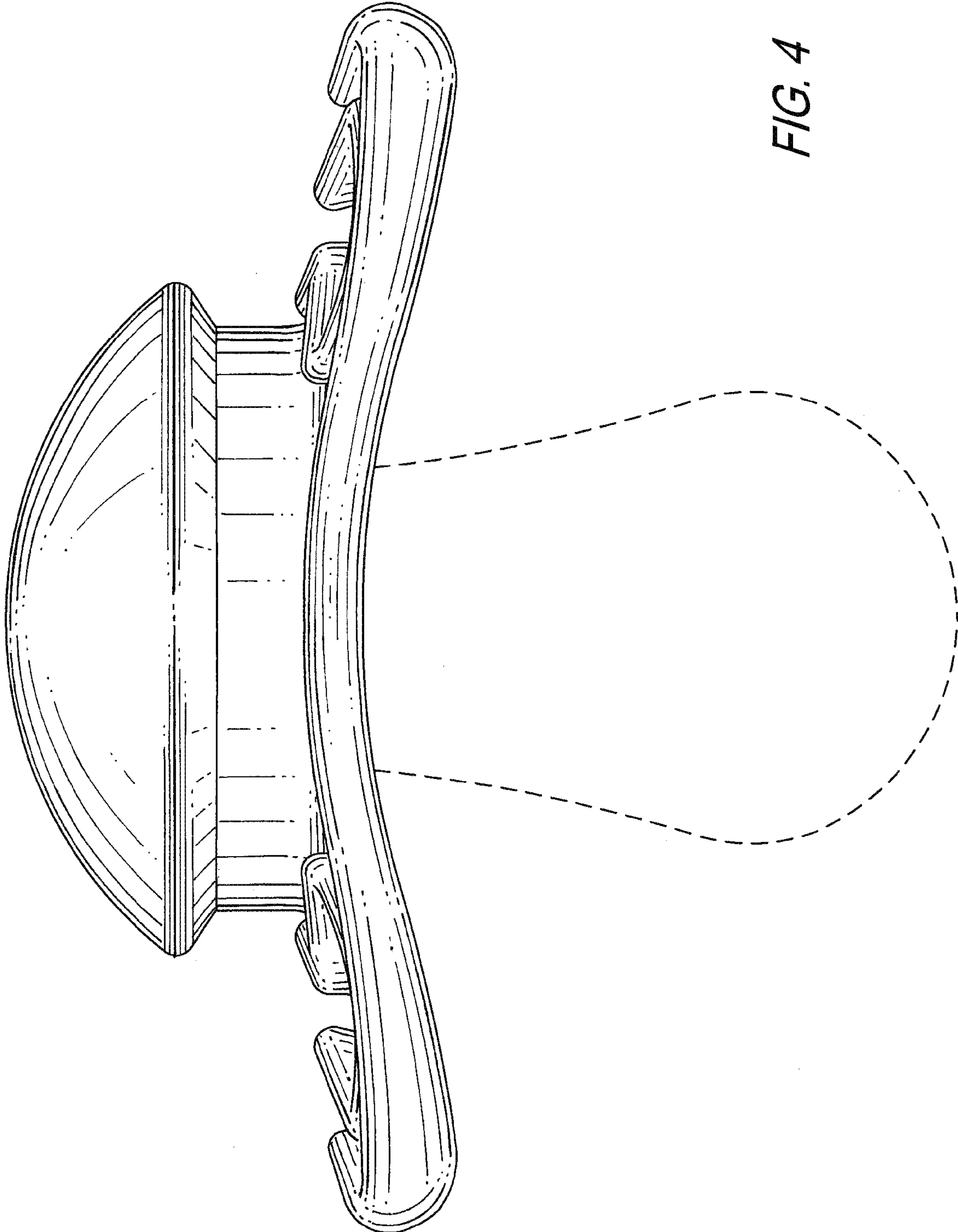

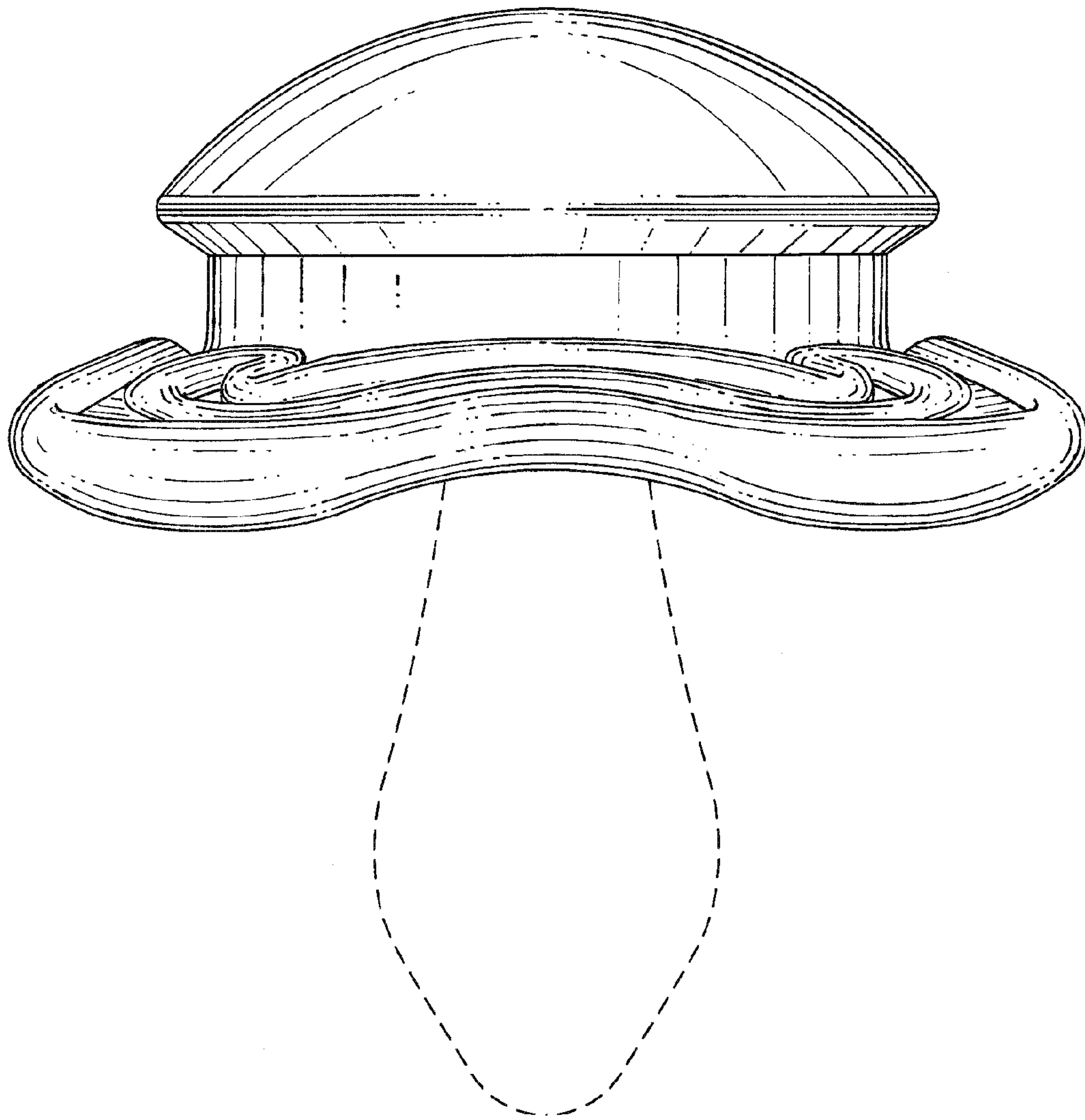
