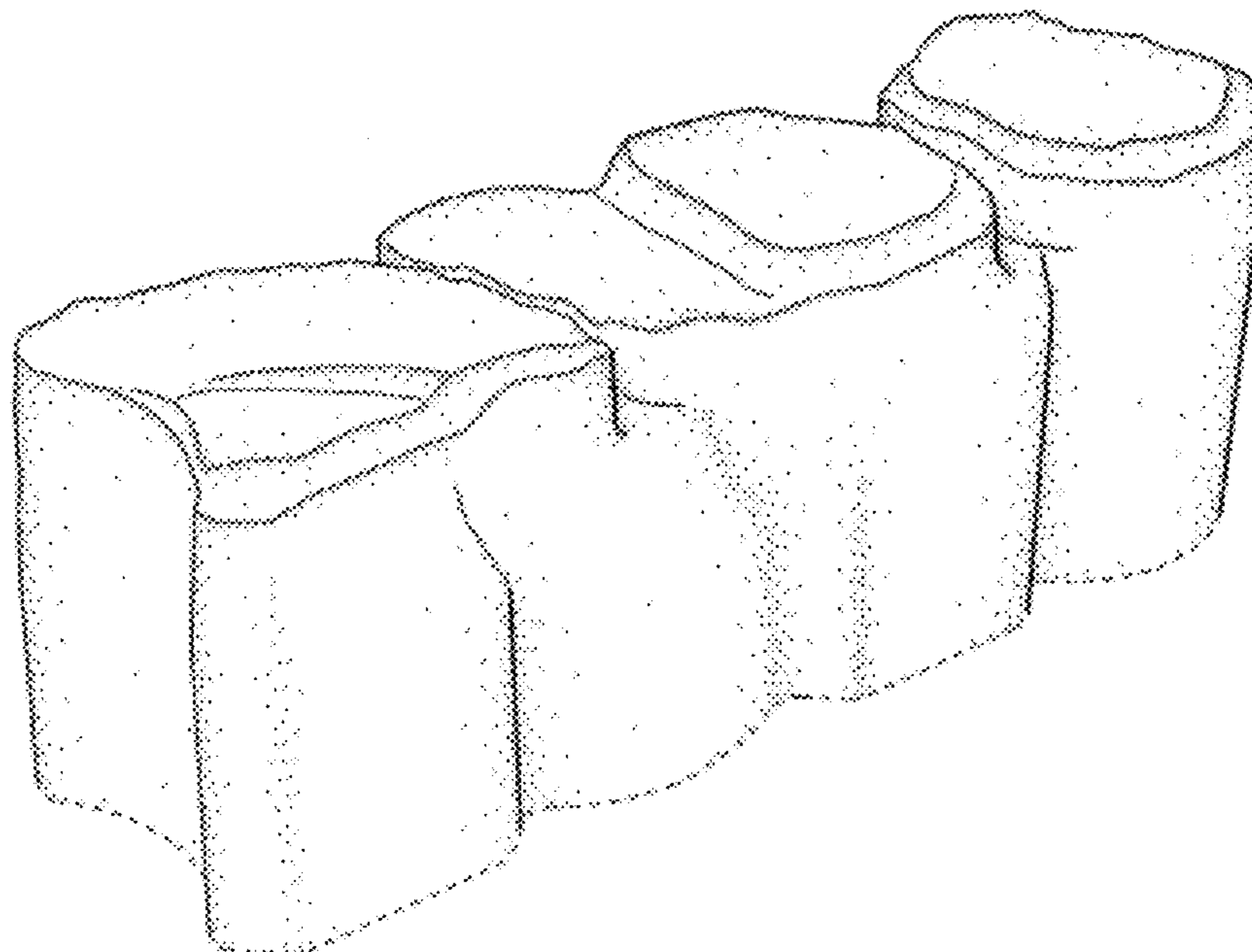
FIG. 4 is an end elevational view thereof.

FIG. 4 is an elevational view of the other side thereof.

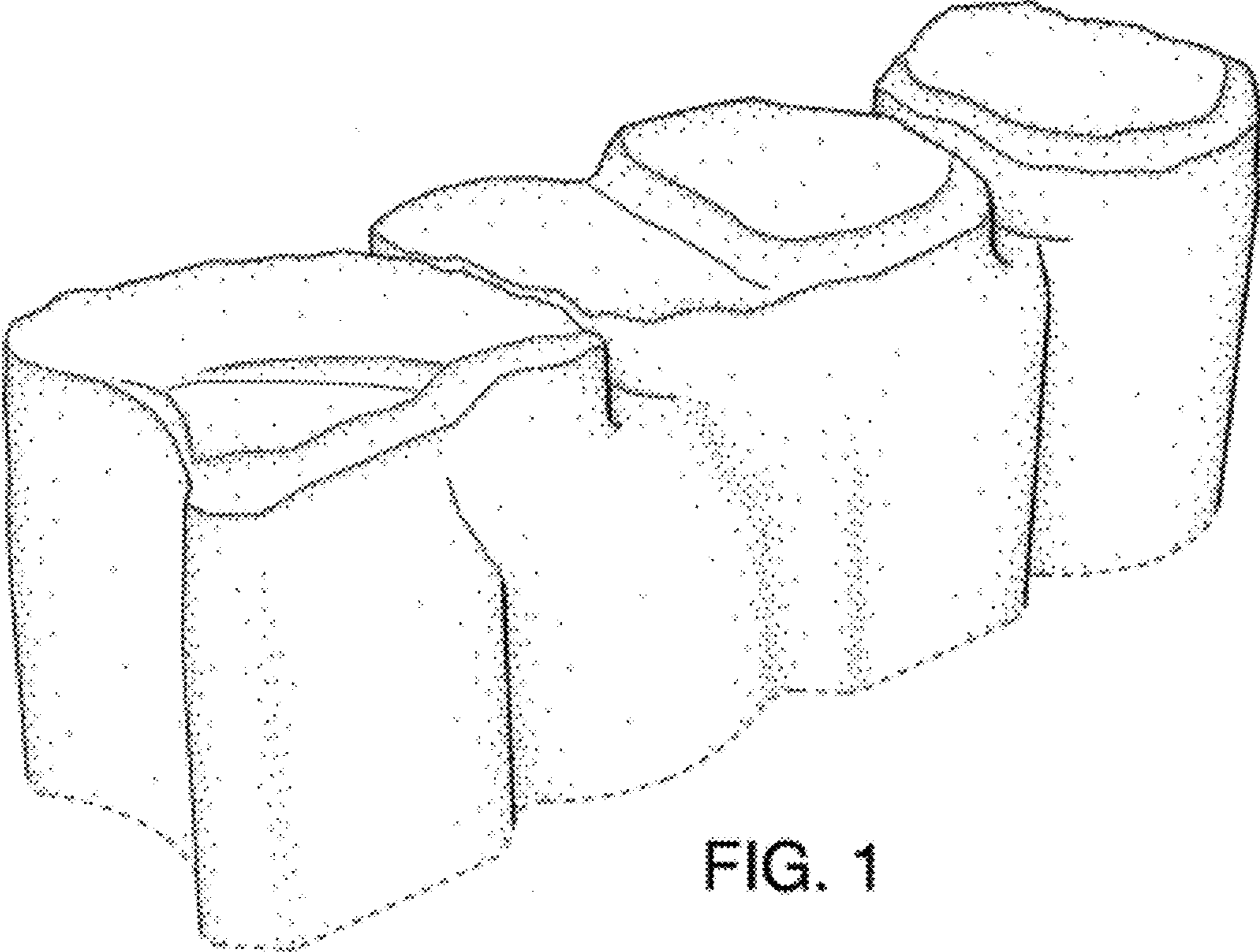

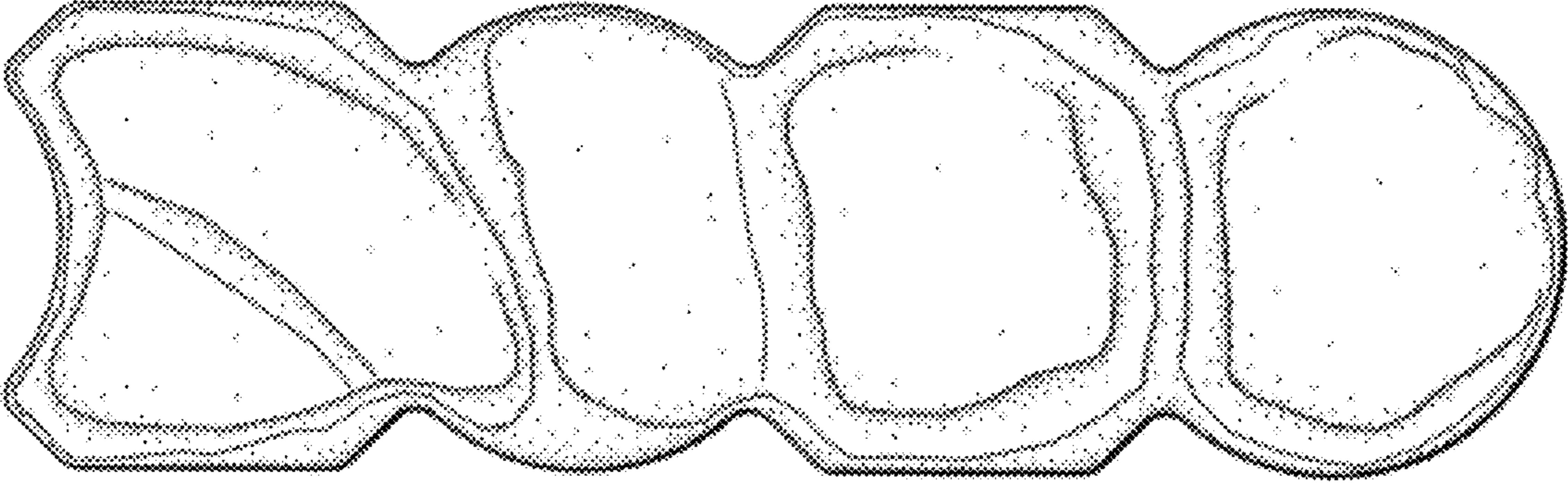

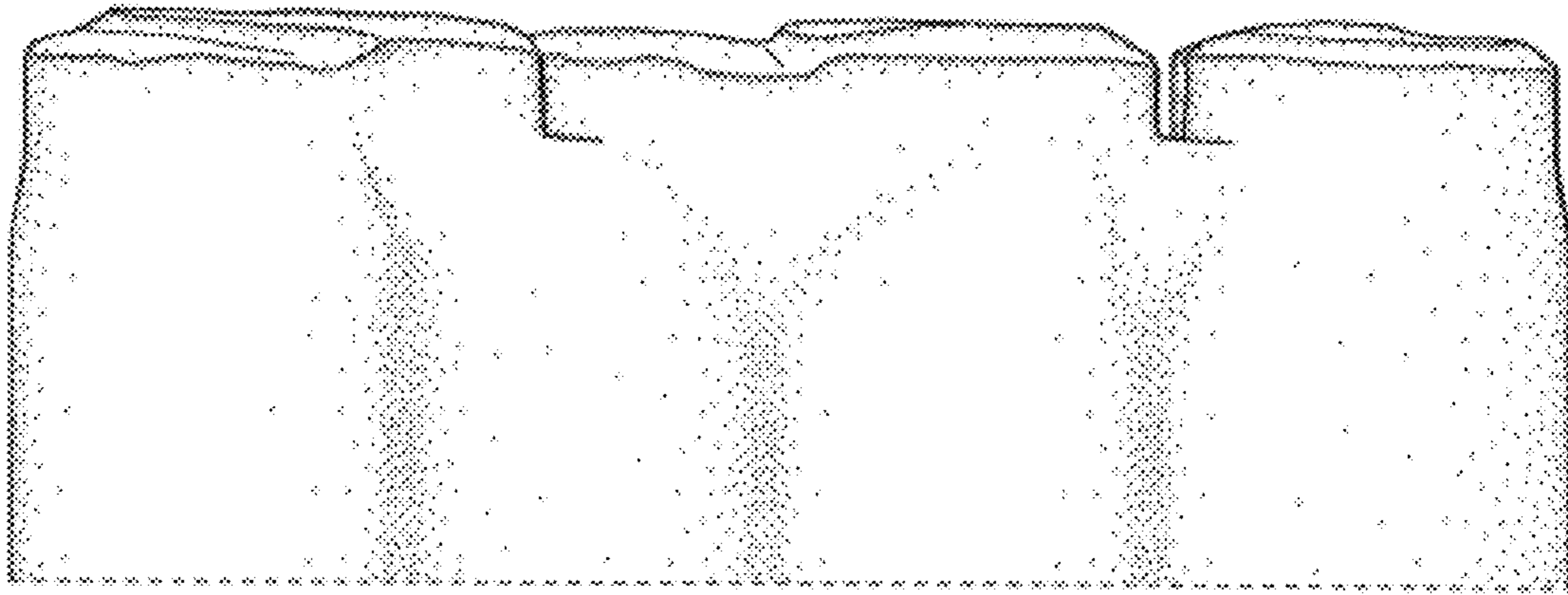

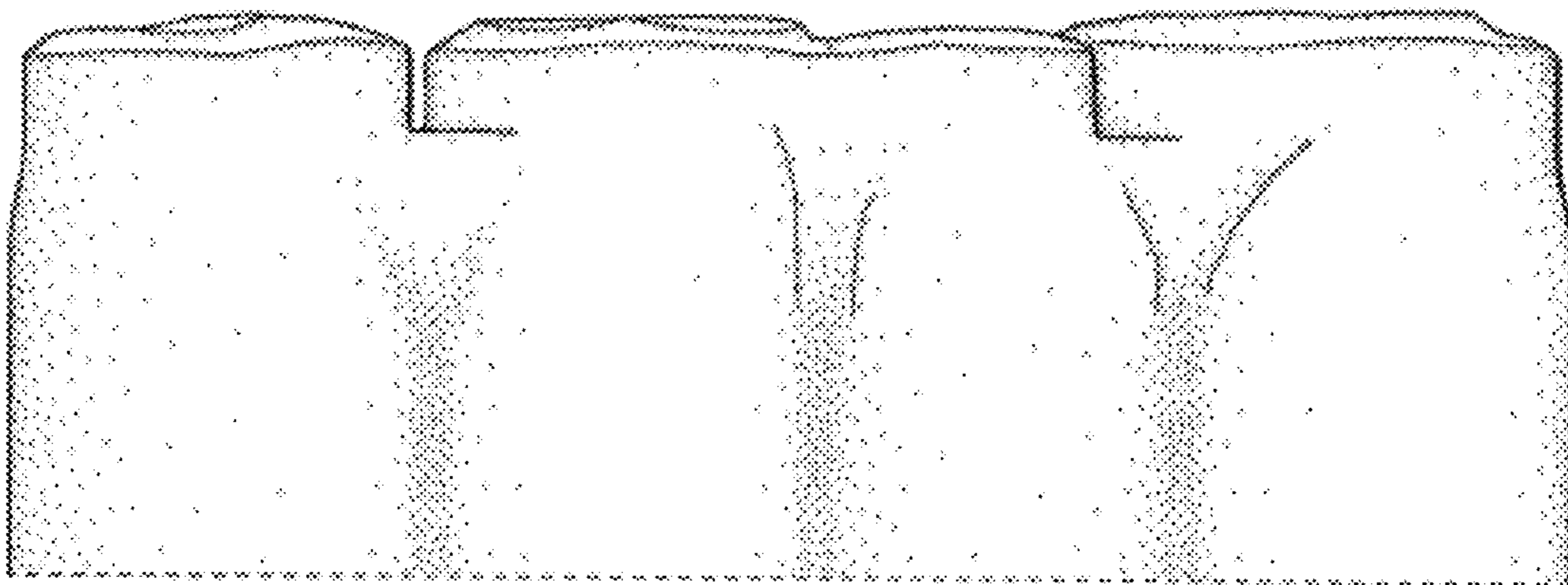

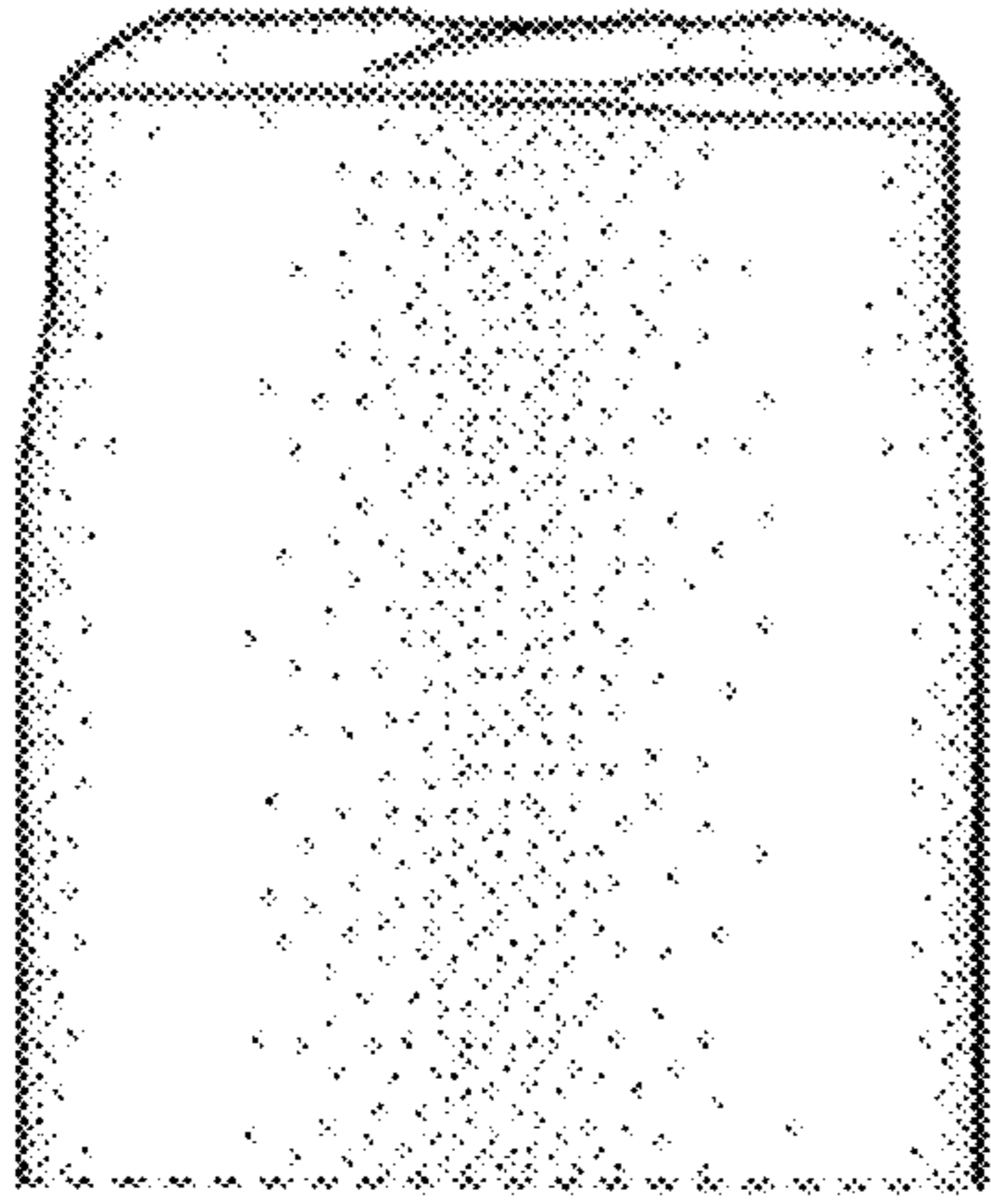

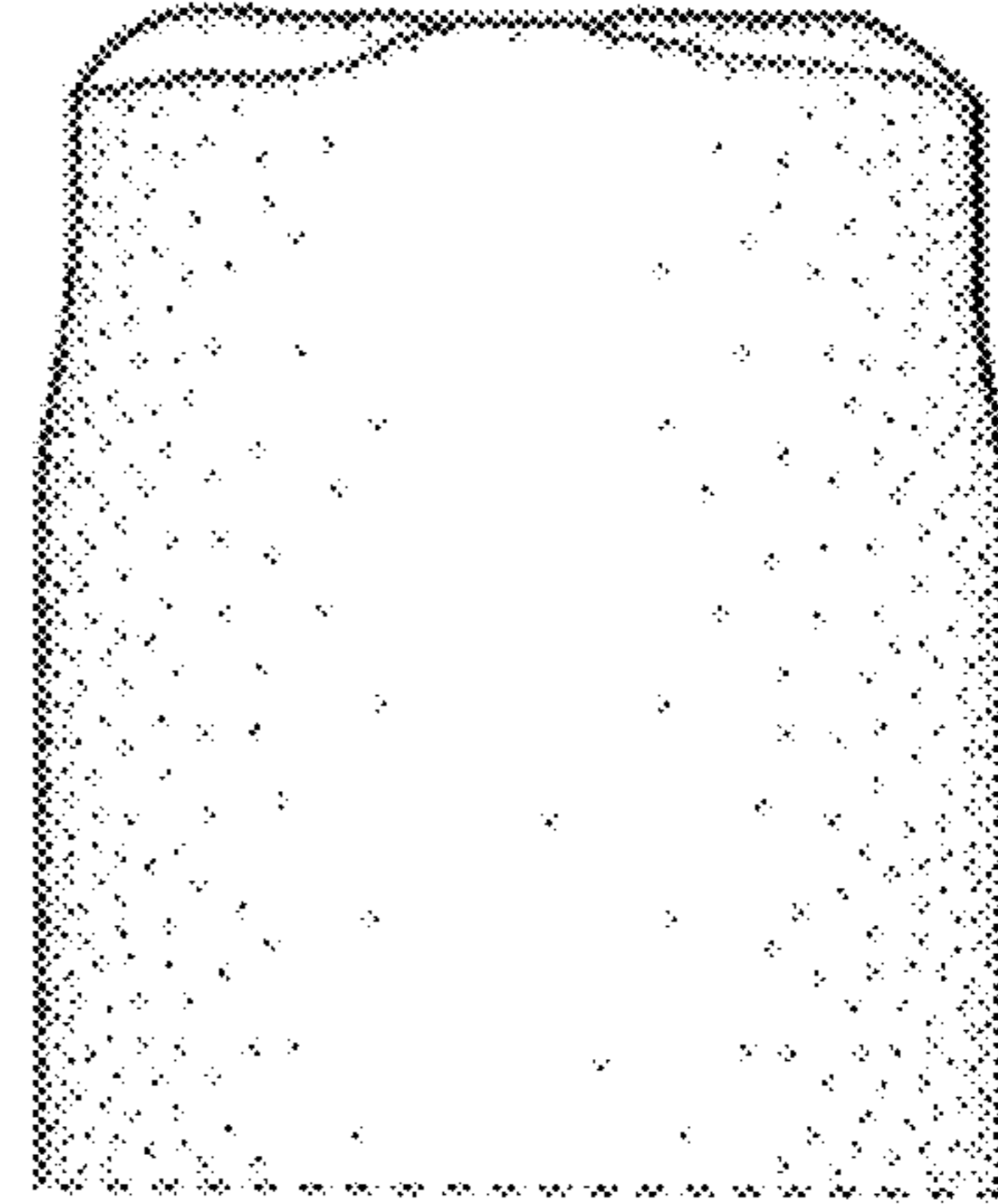

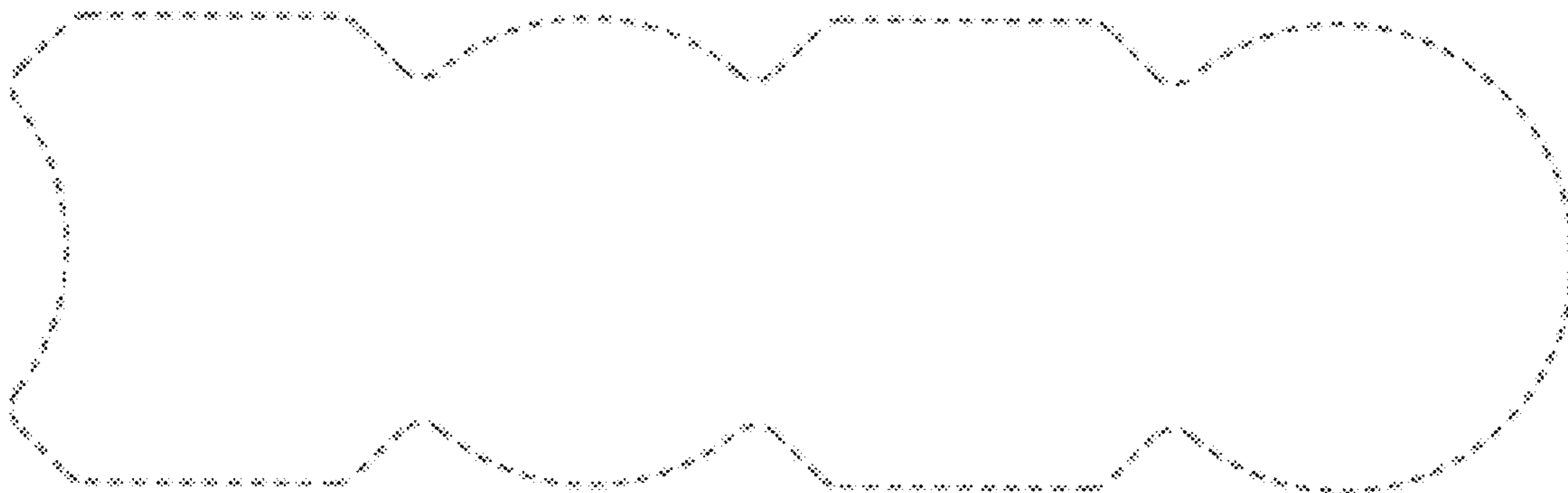
