DESCRIPTION

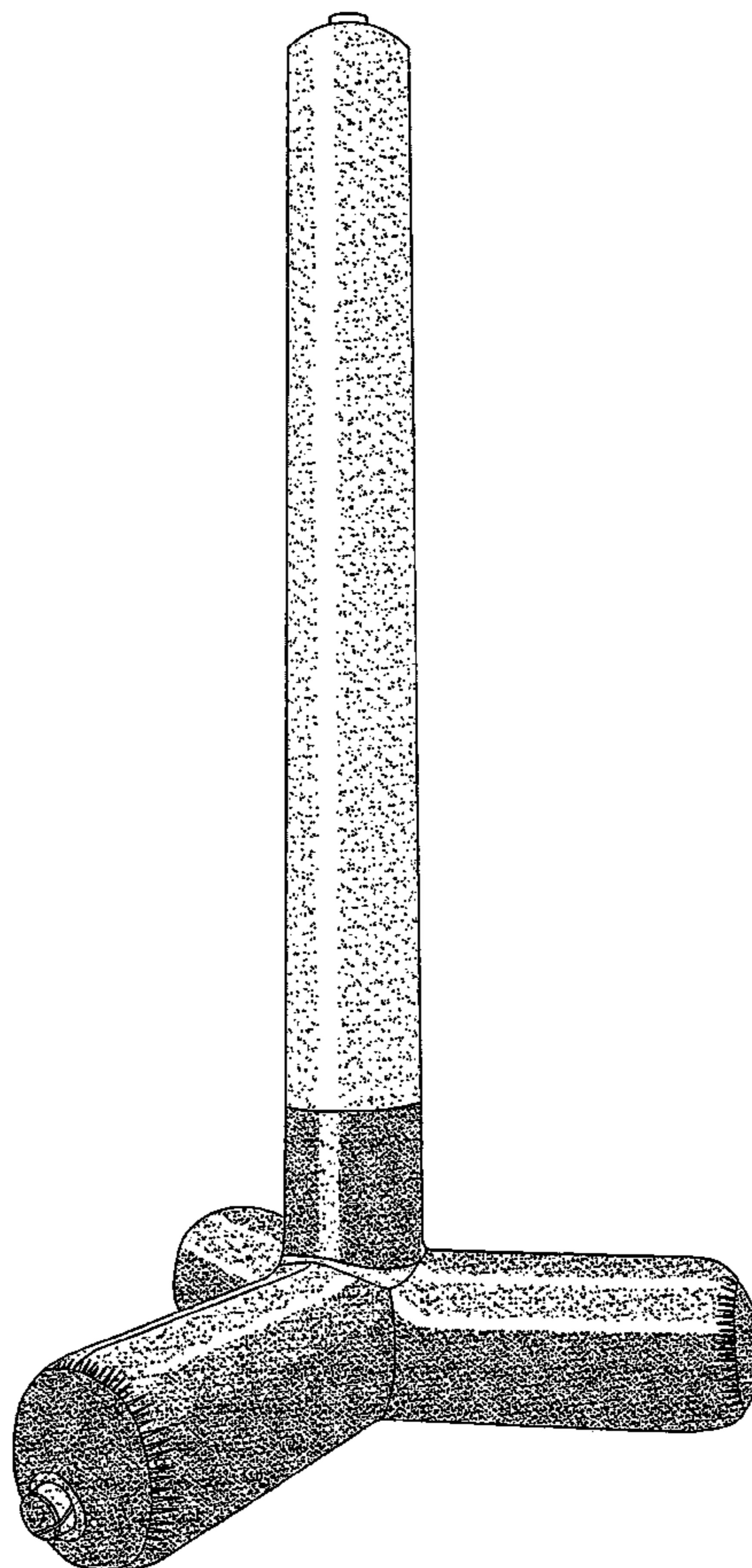
FIG. 1 is a front perspective view of a lighting installation showing our new design;

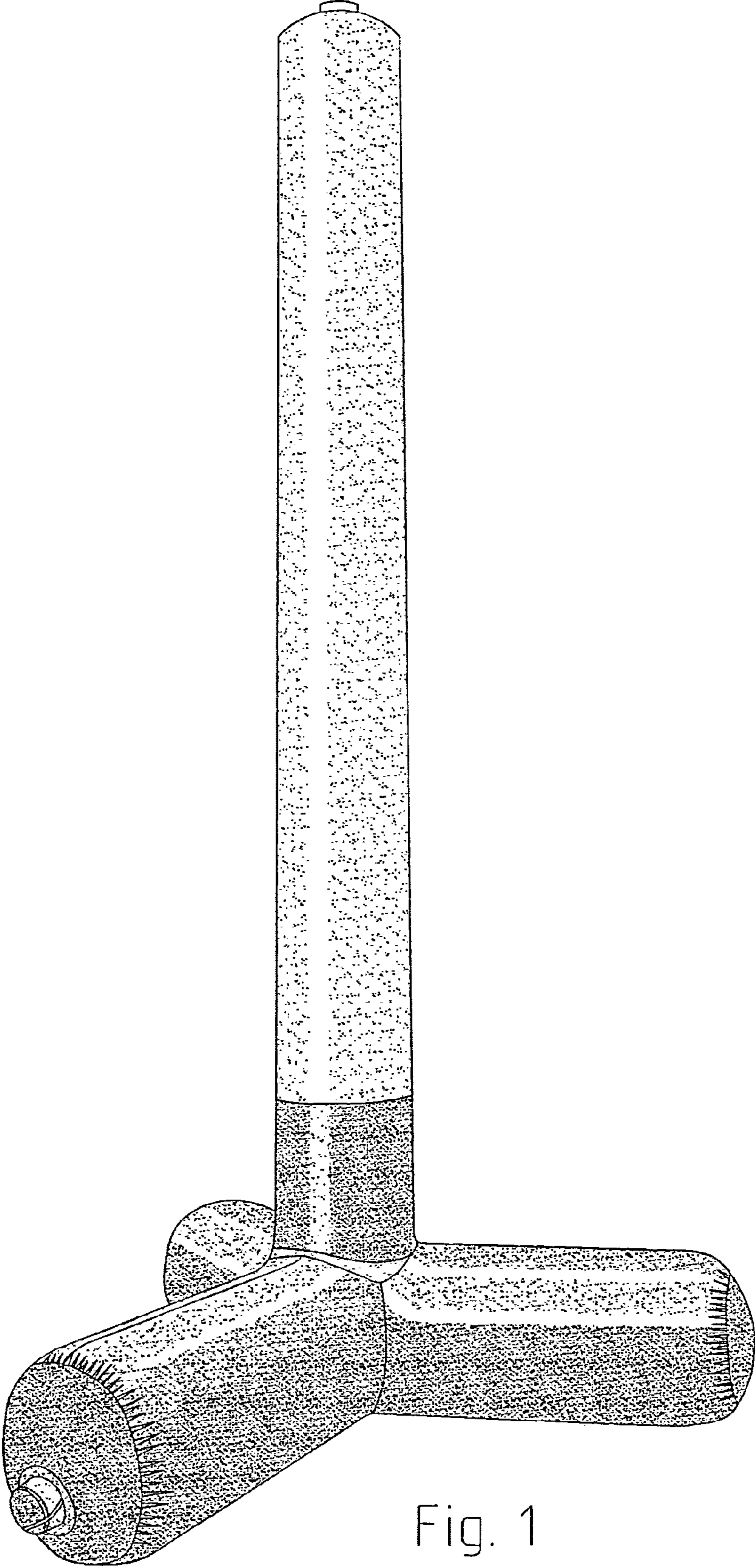
FIG. 2 is a top plan view thereof;

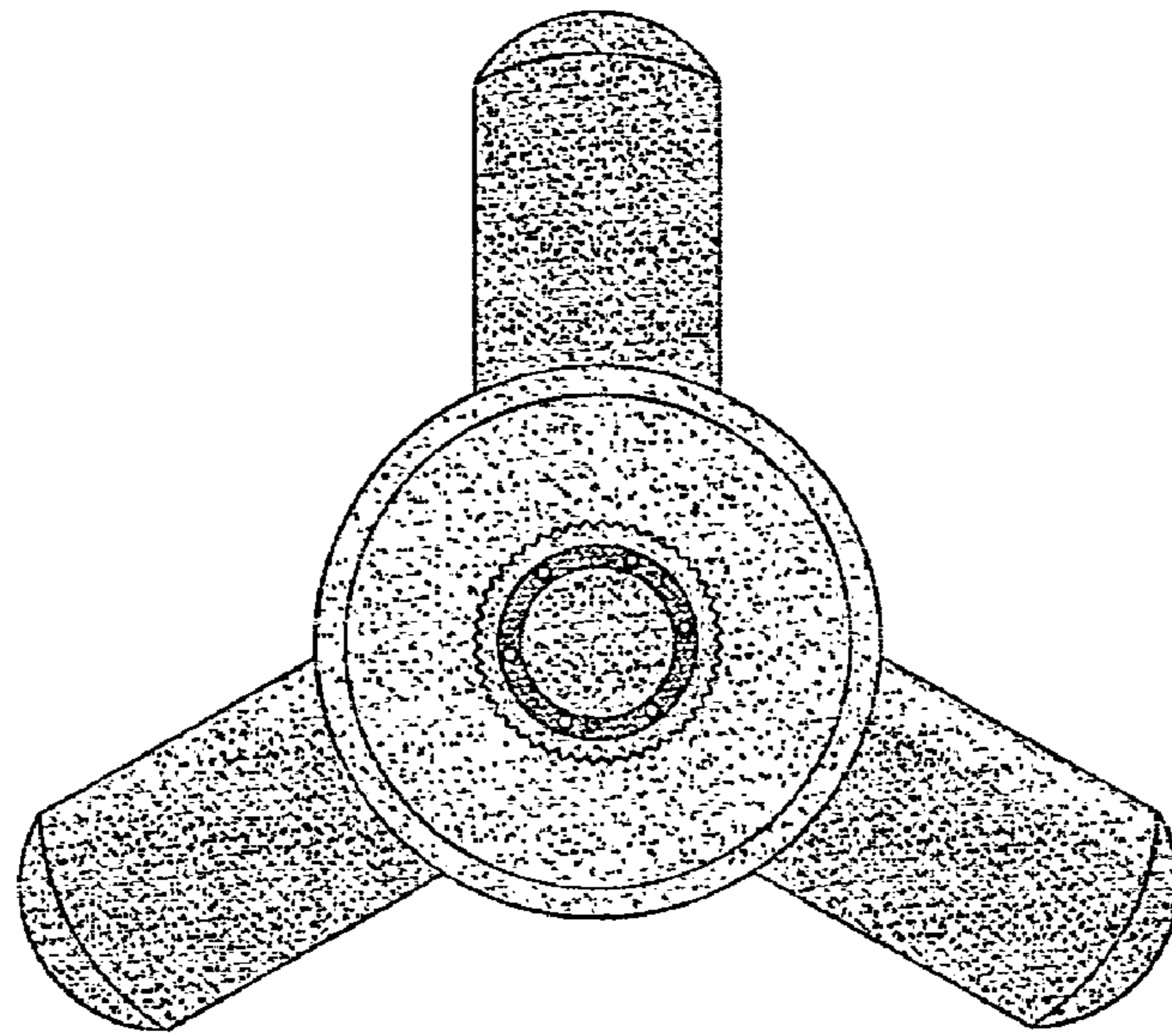

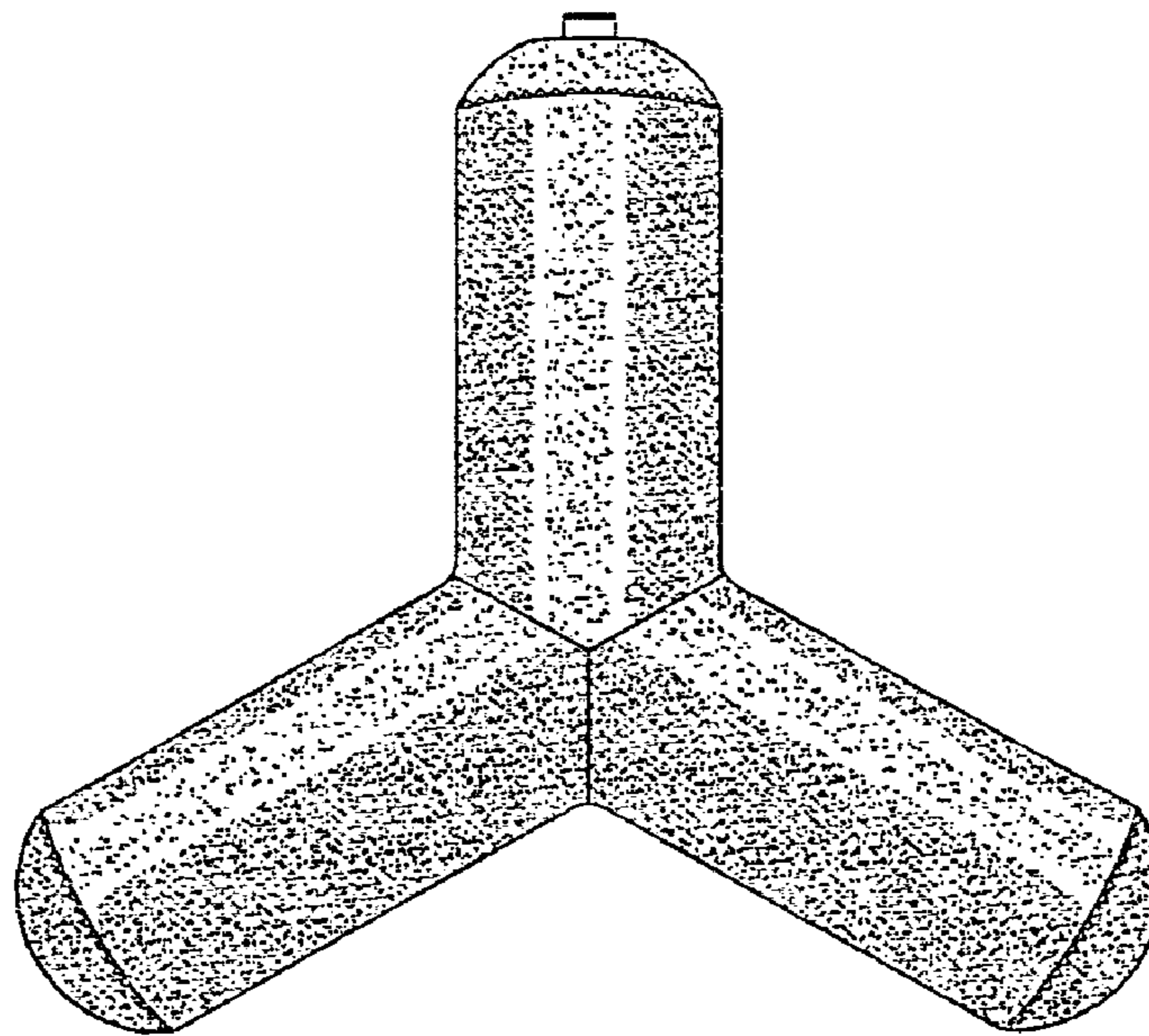

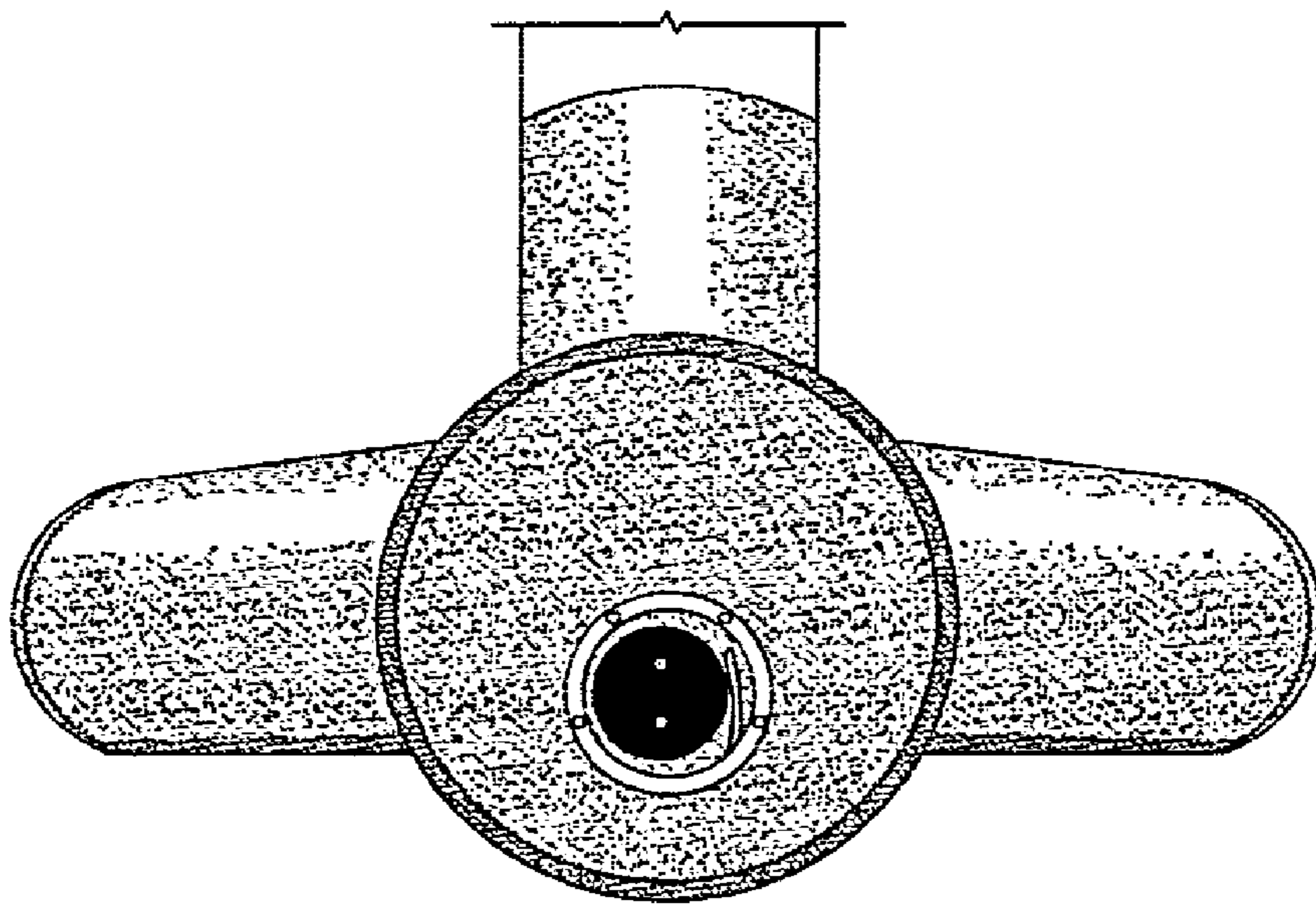
