(57) **CLAIM**

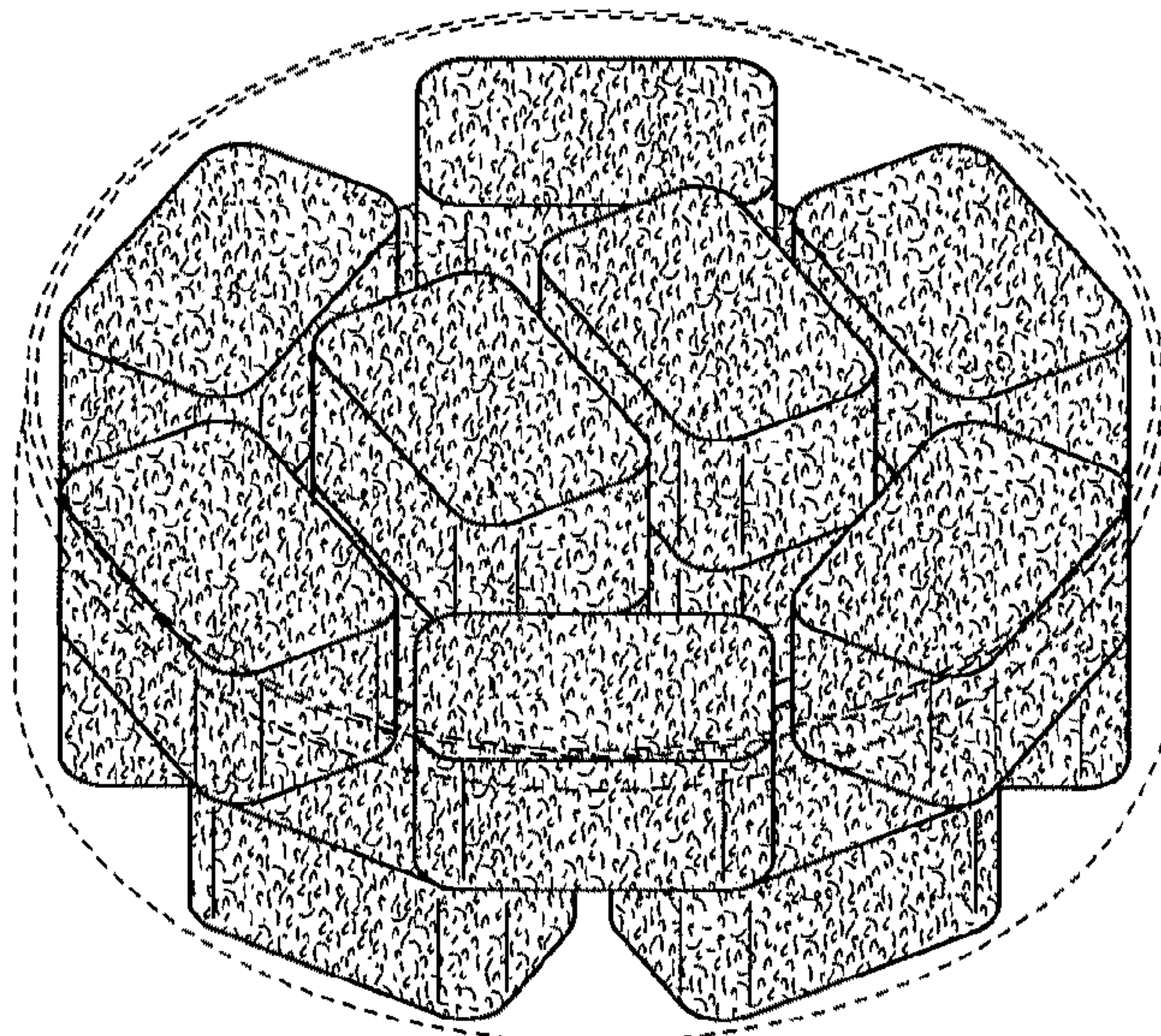
The ornamental design for a set of oral tobacco articles, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a set of oral tobacco articles. FIG. 2 is top view of the set of oral tobacco articles of FIG. 1; and, FIG. 3 is a bottom view of the set of oral tobacco articles of FIG. 1.

The broken lines which define environmental structure of the claimed design form no part thereof. The broken lines depict a container with the lid removed (i.e., upon opening by an adult tobacco consumer).

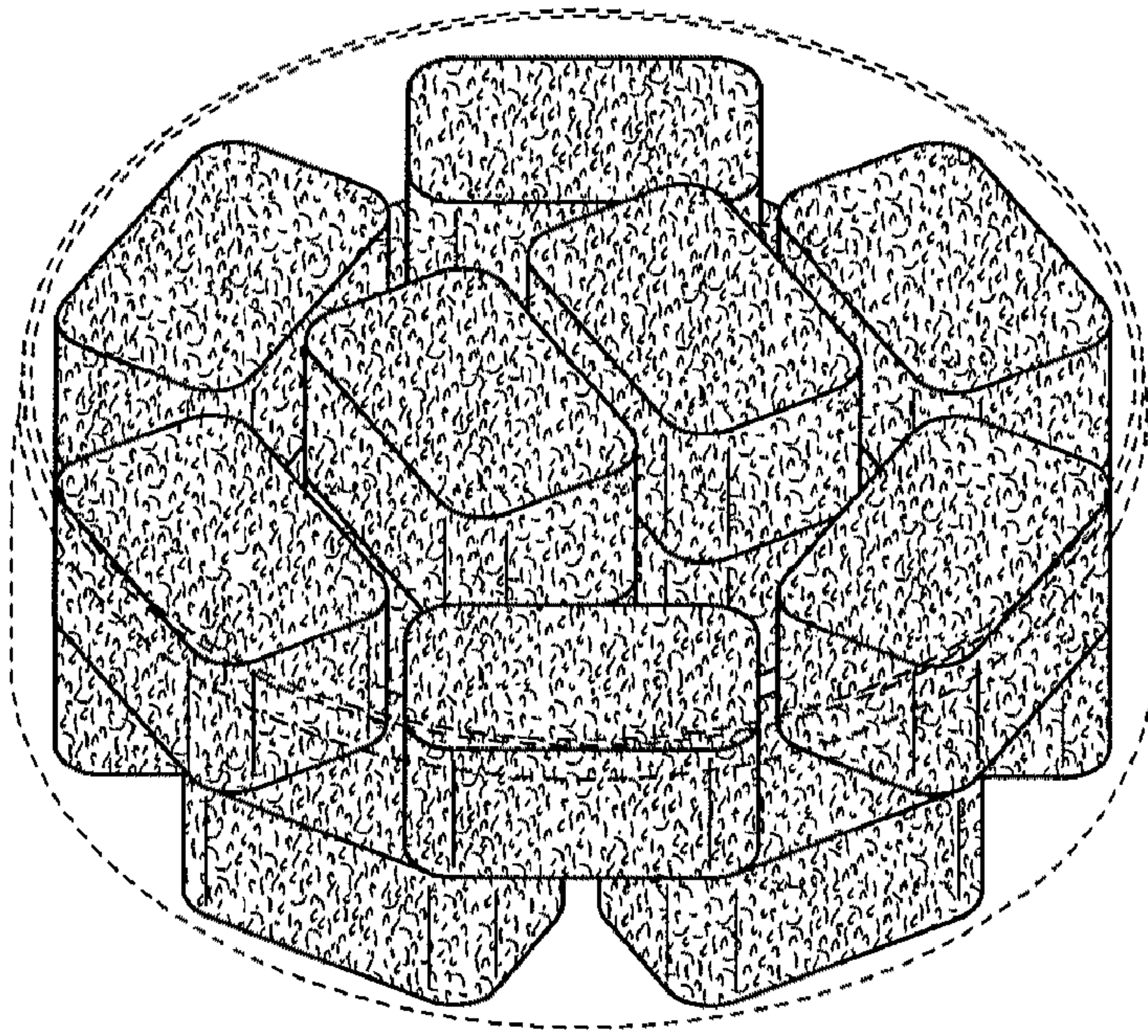

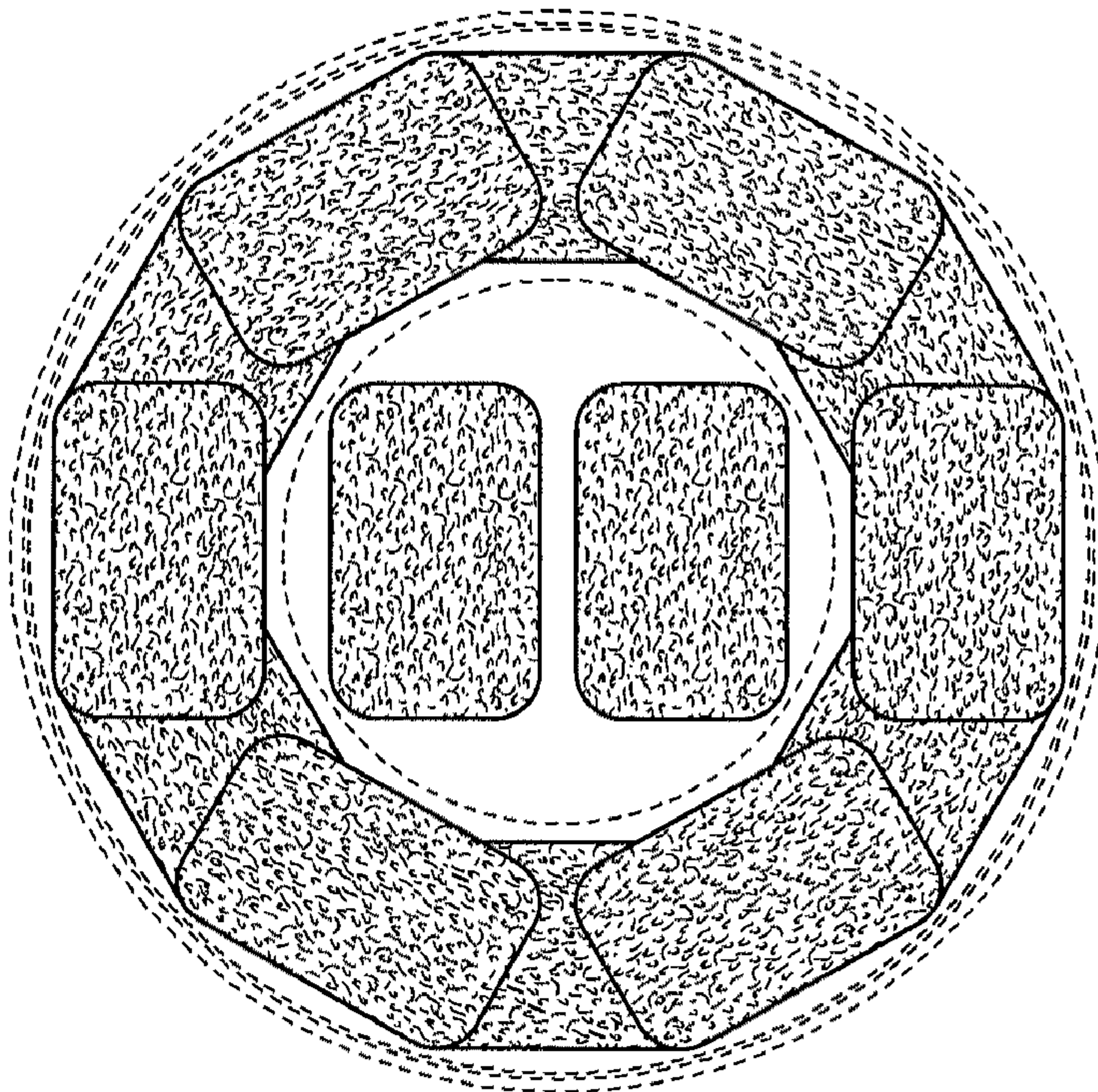

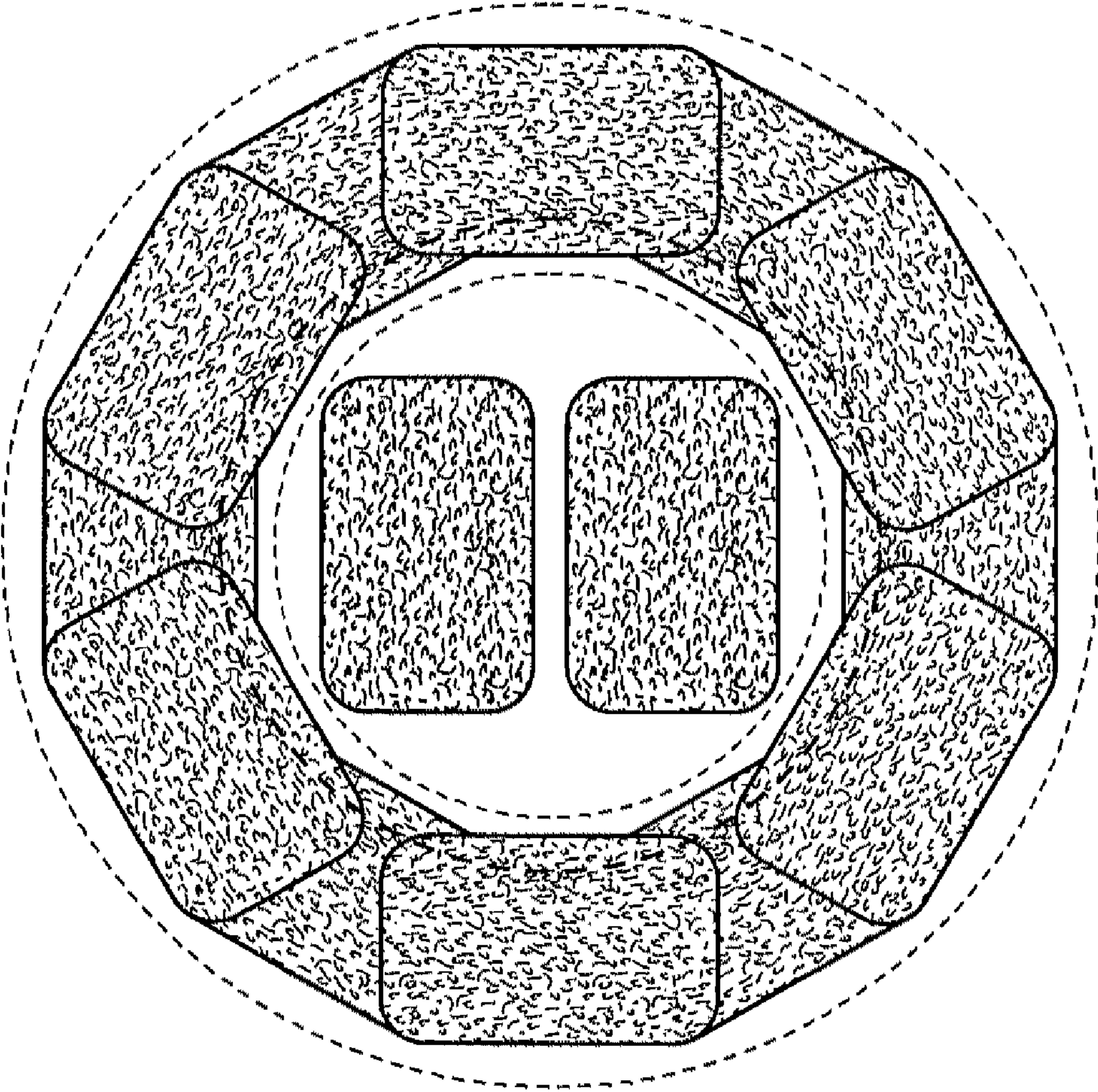
