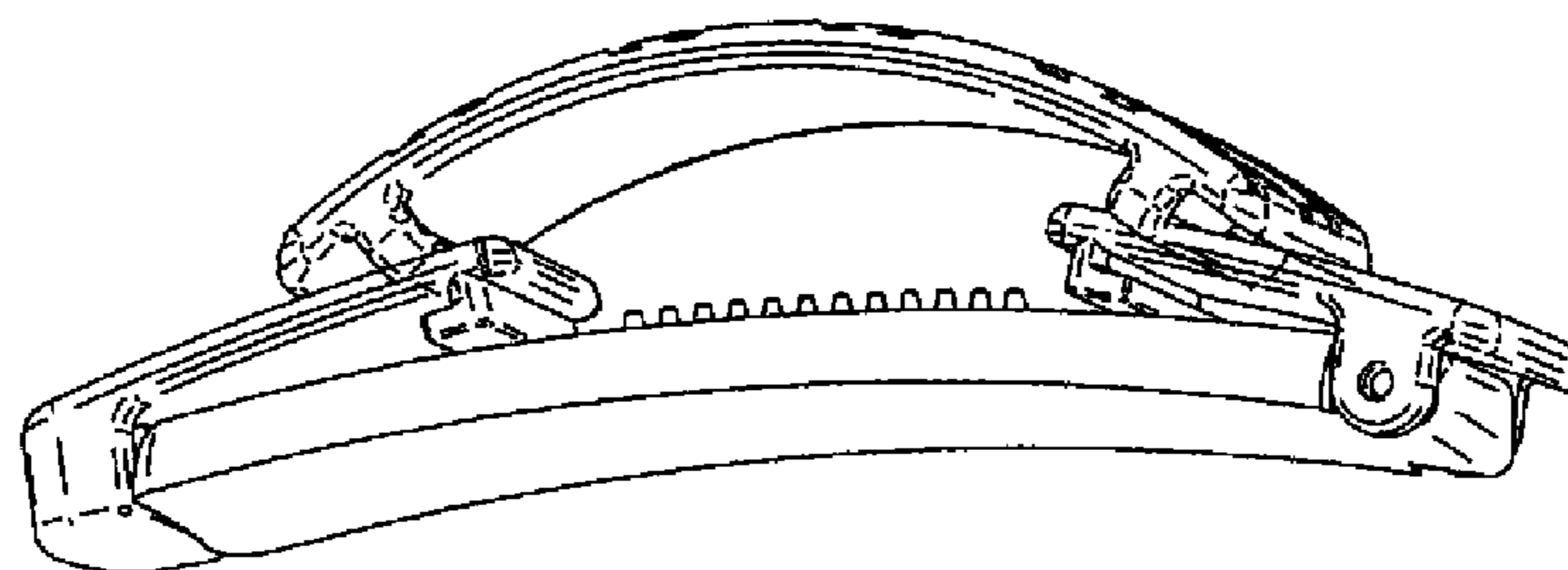
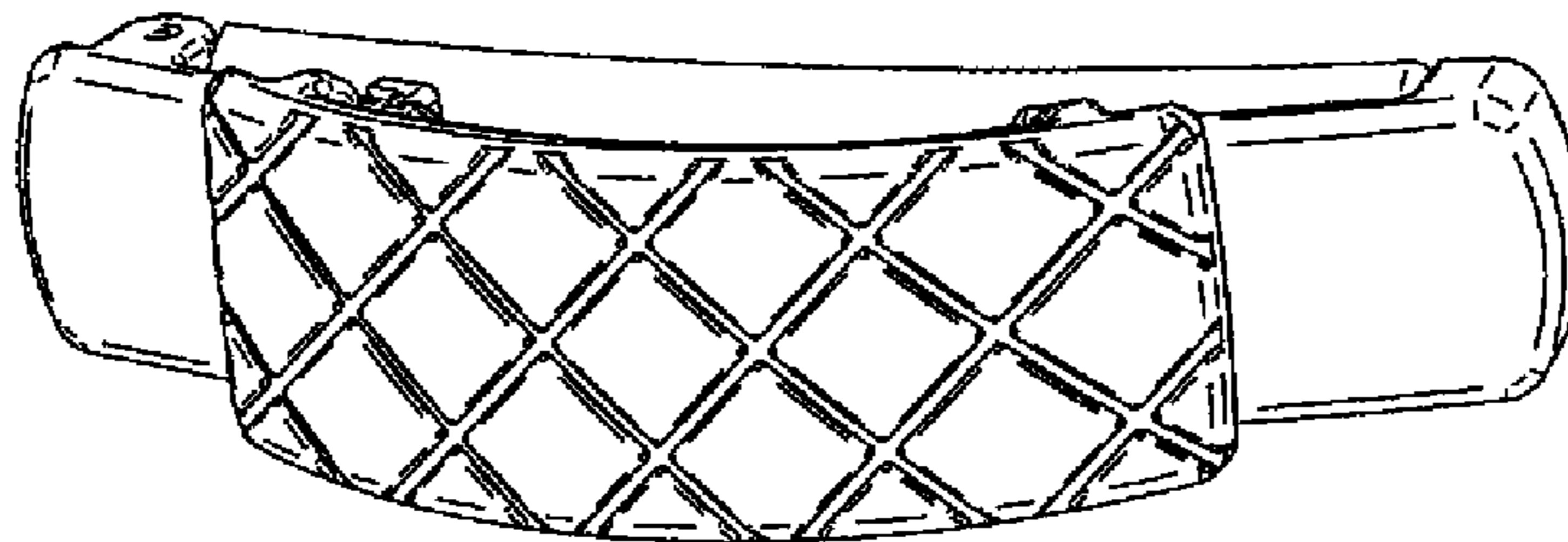
(57) **CLAIM**

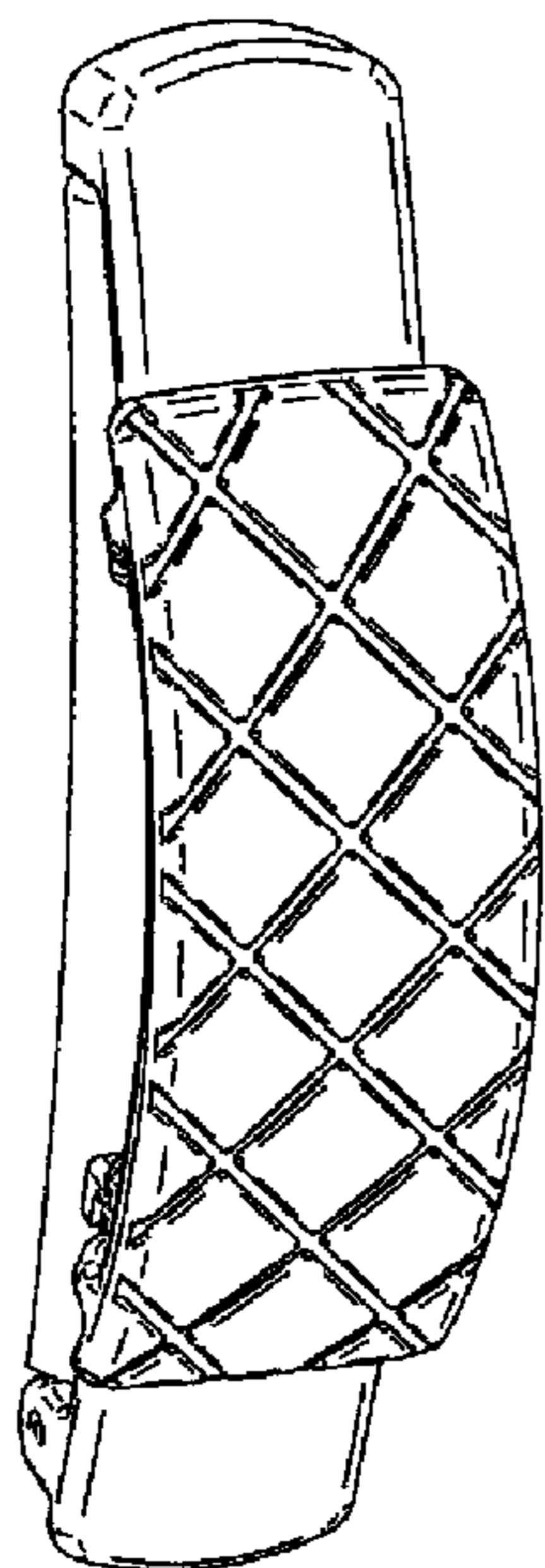

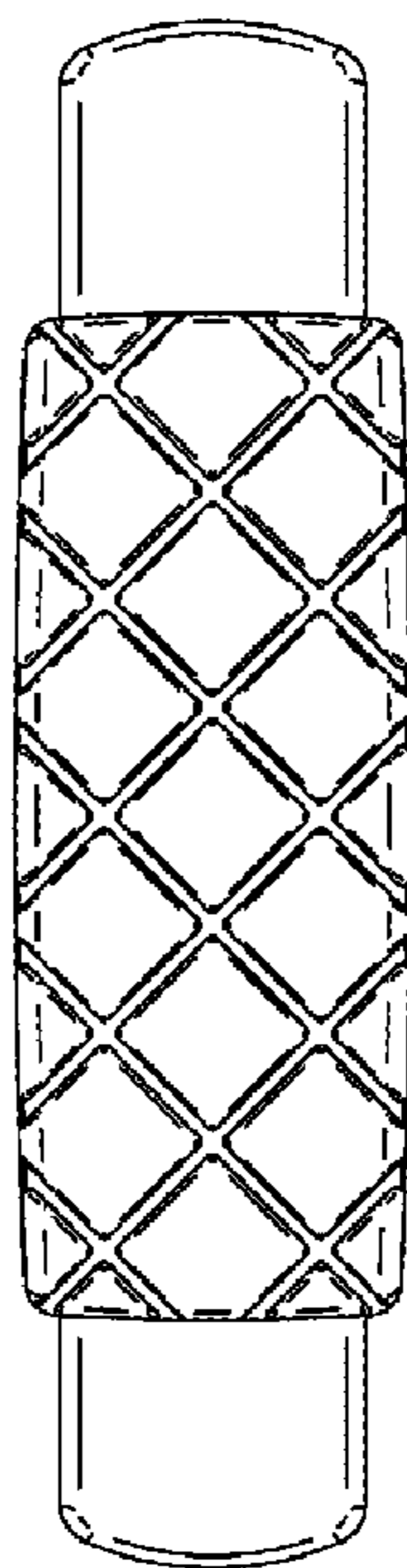


FIG. 3 FIG. 4

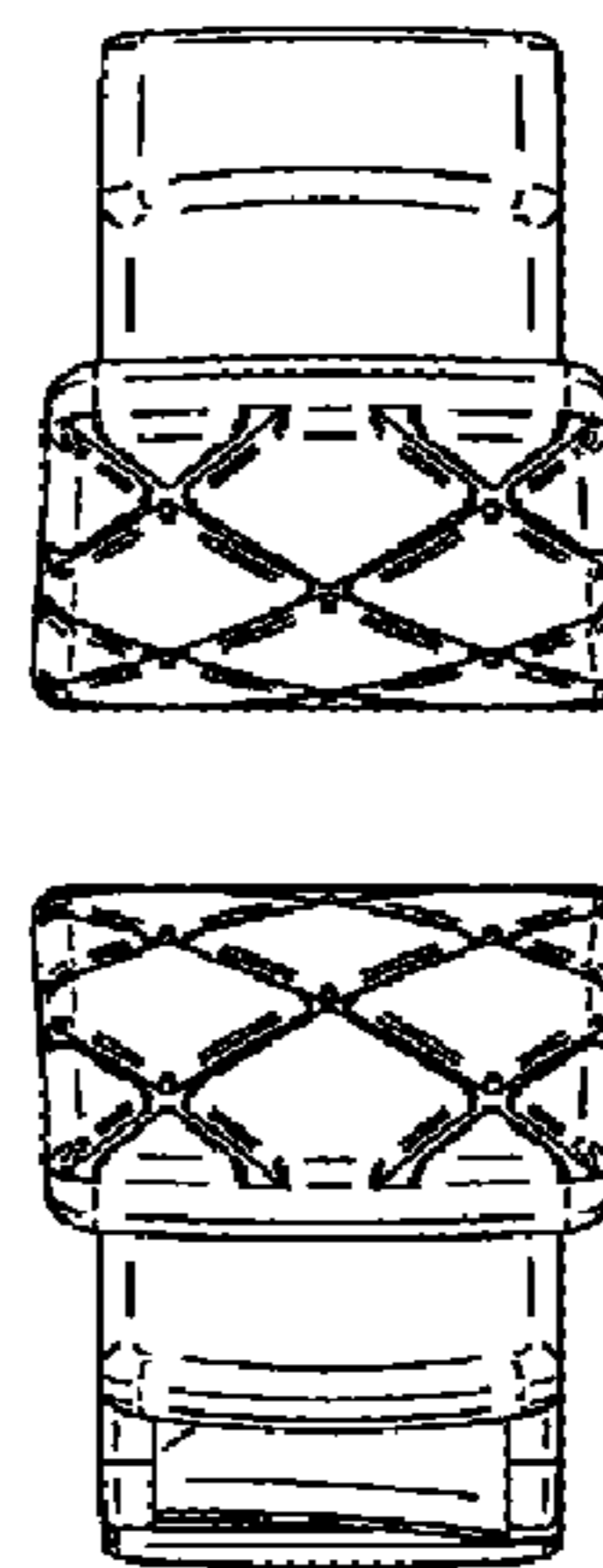

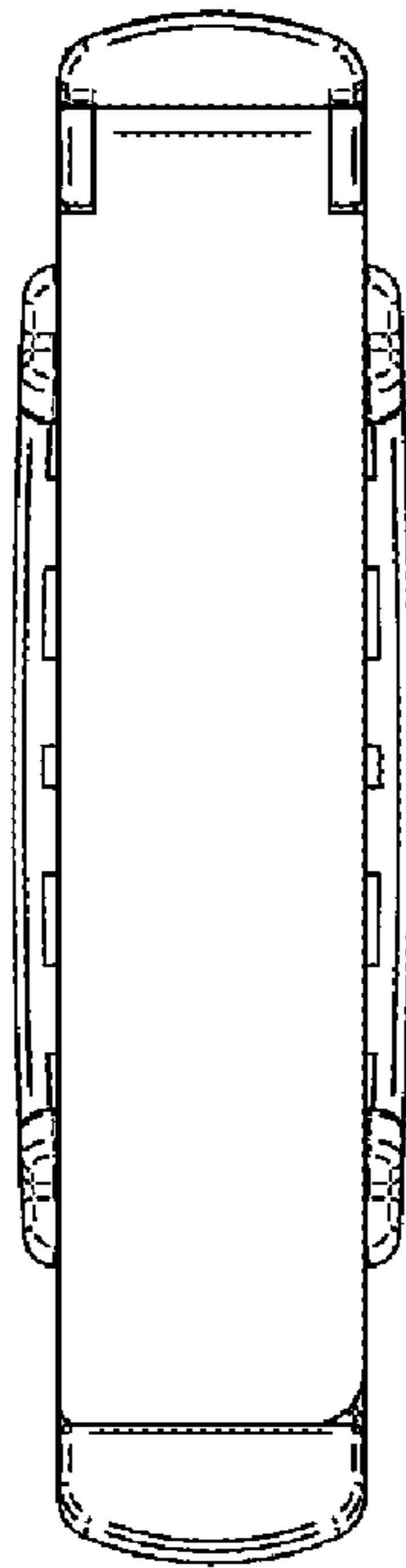

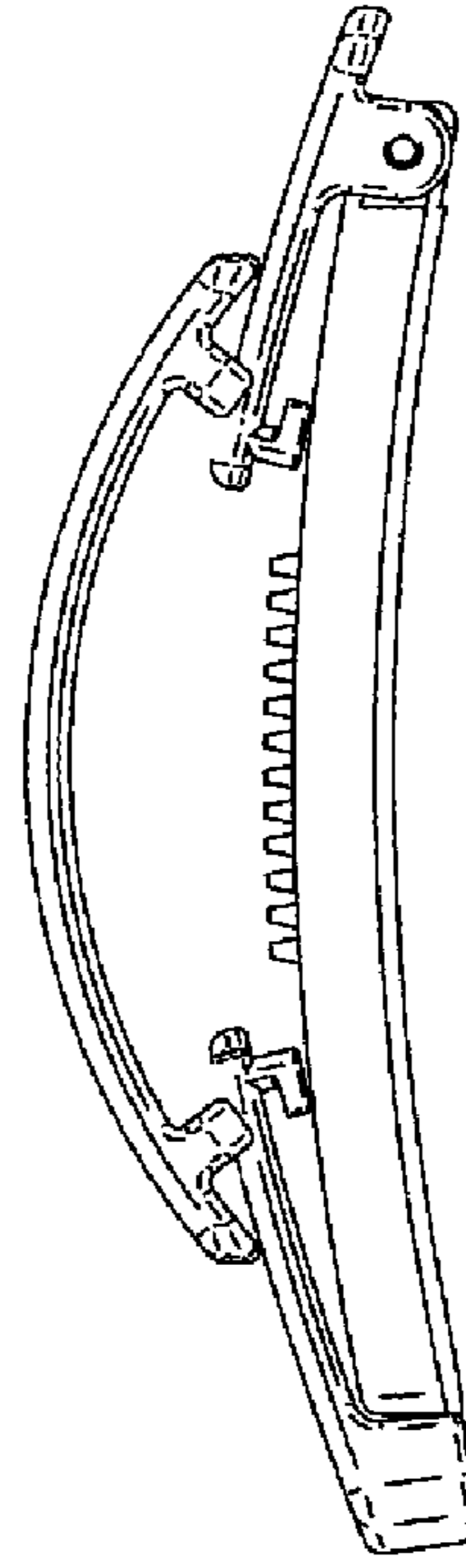

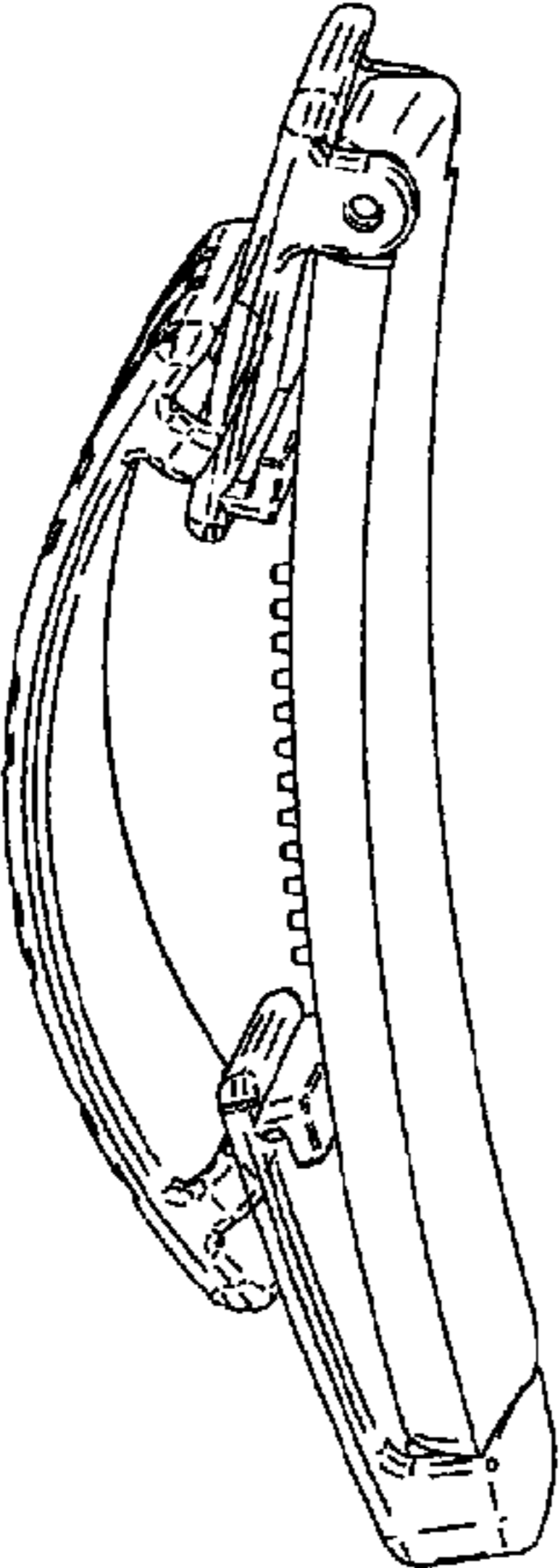

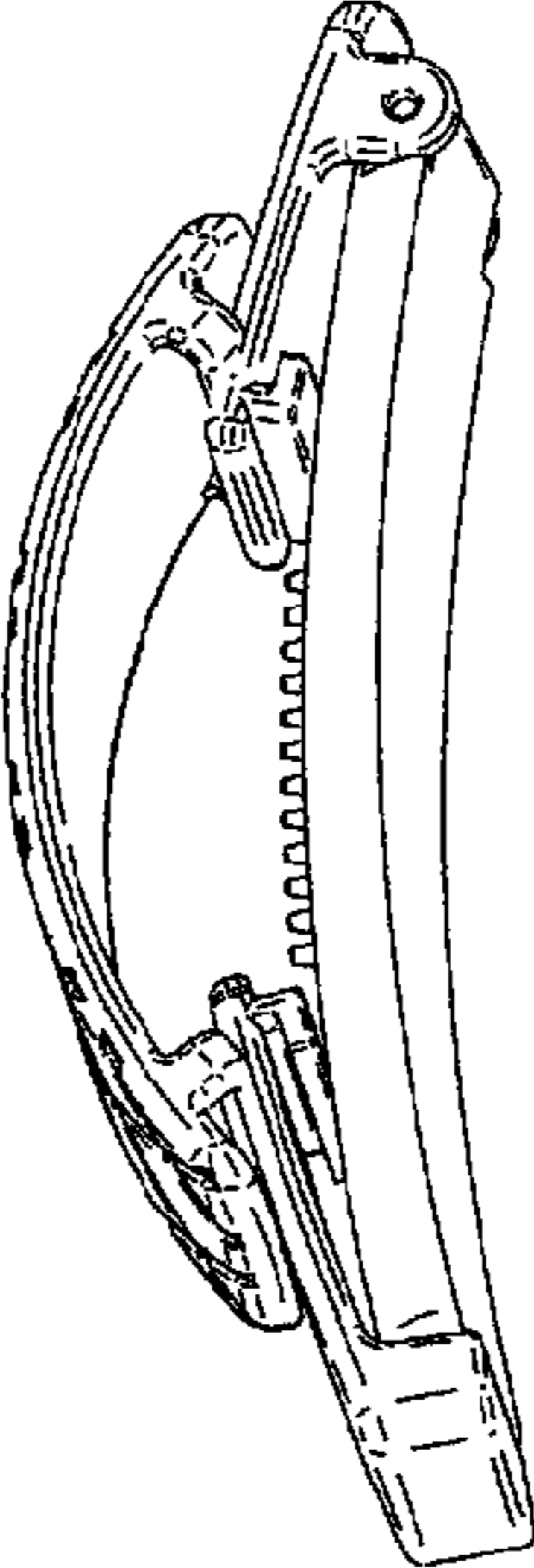
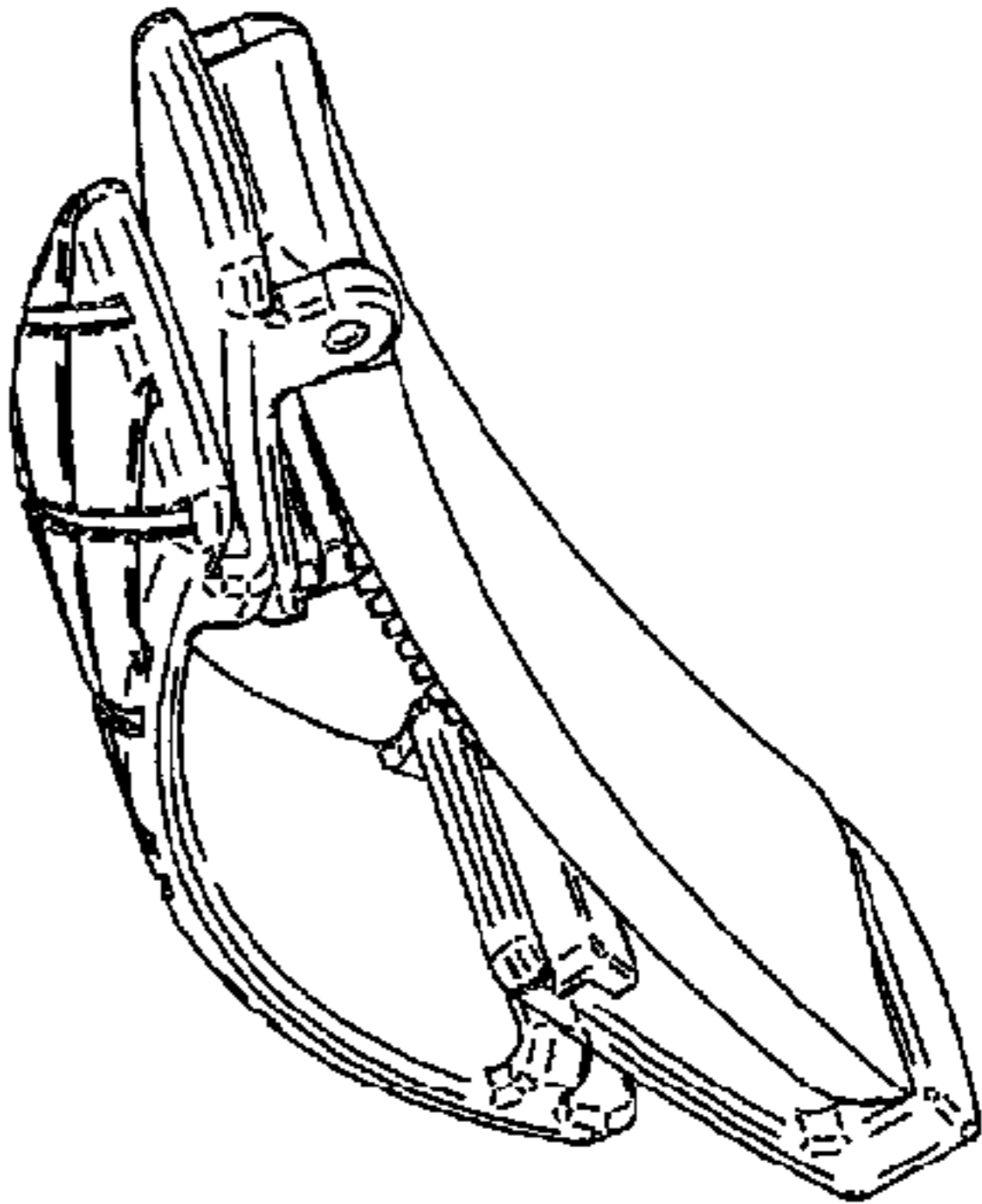
