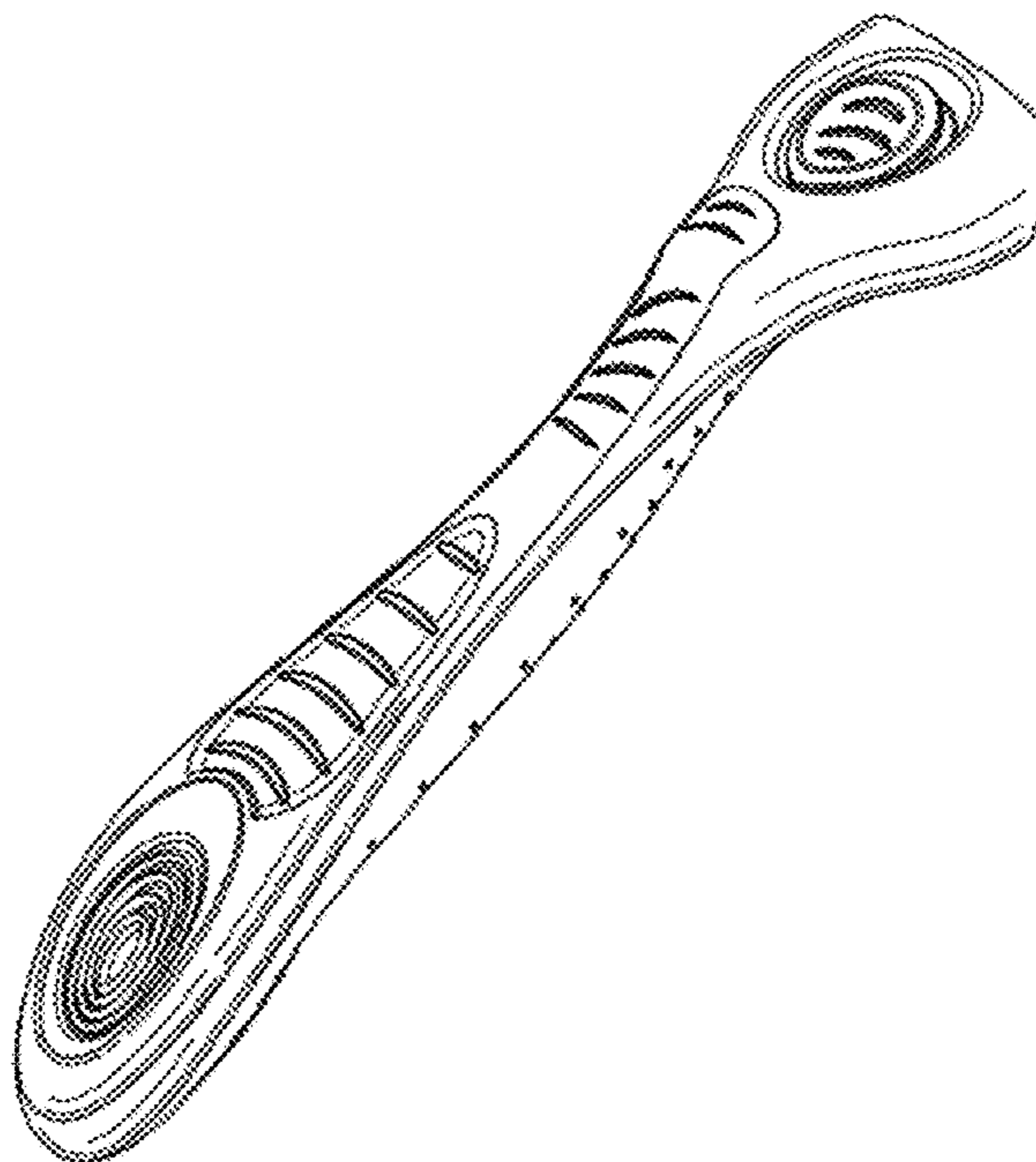
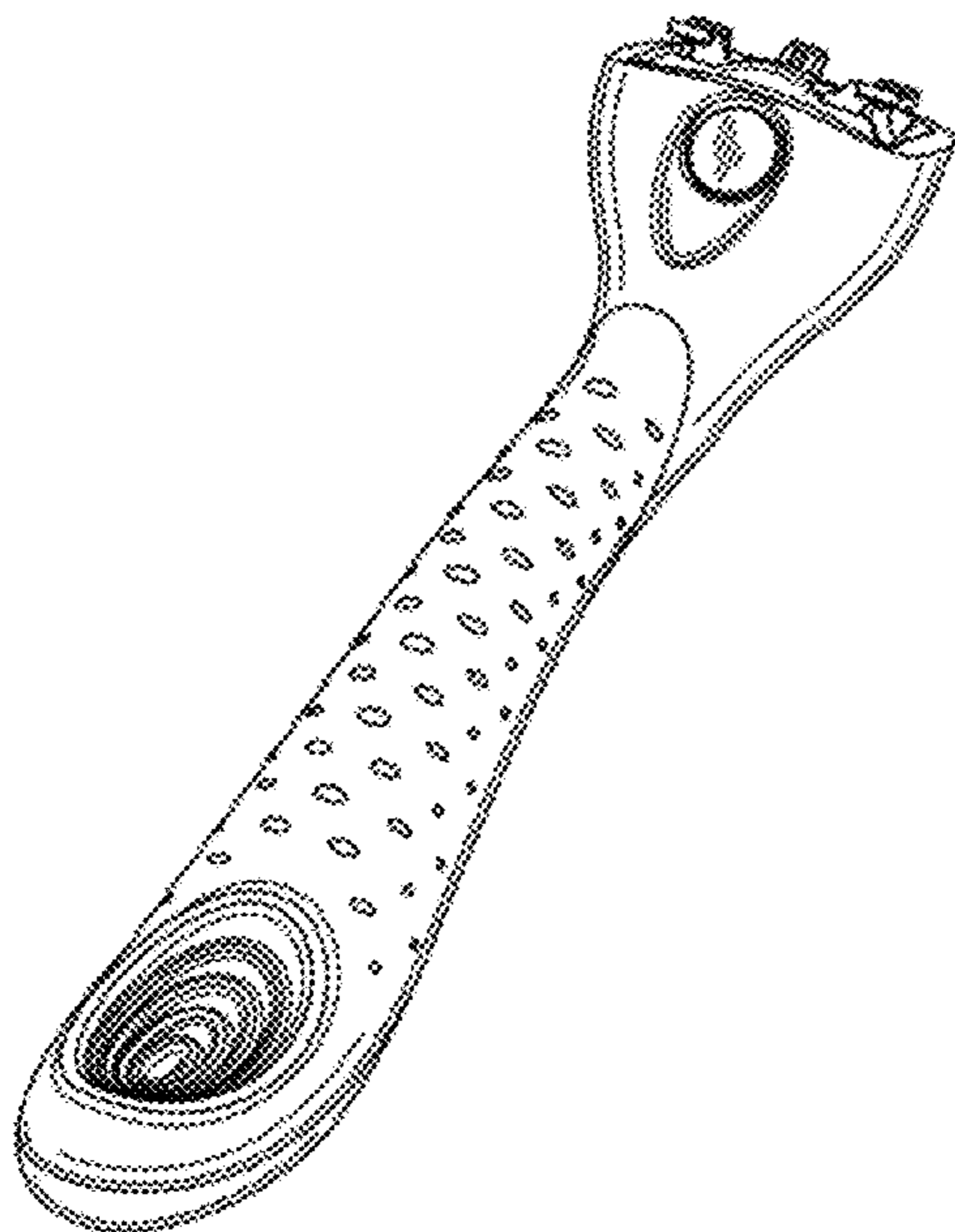
FIG. 1 is a lower perspective view of a safety razor handle.

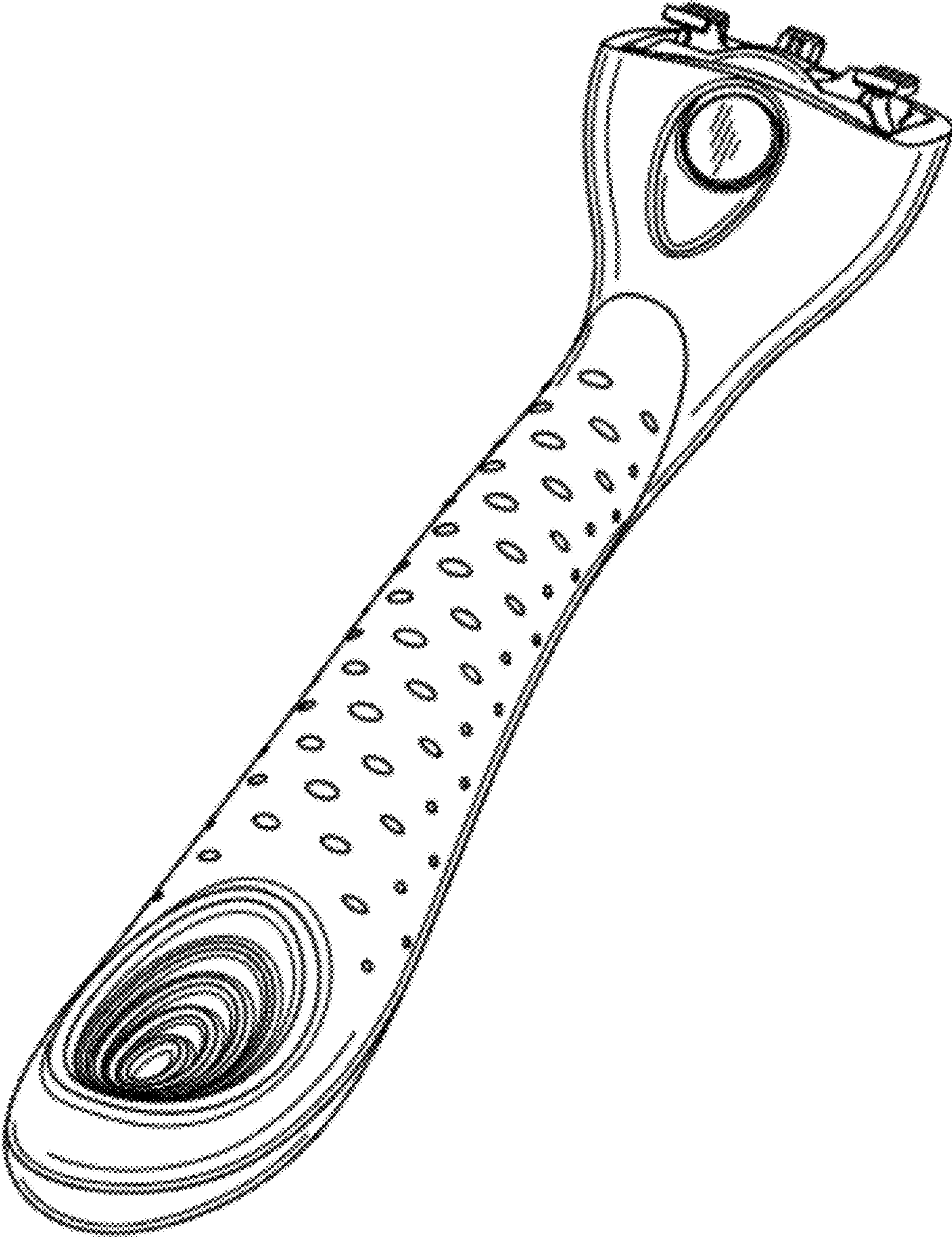

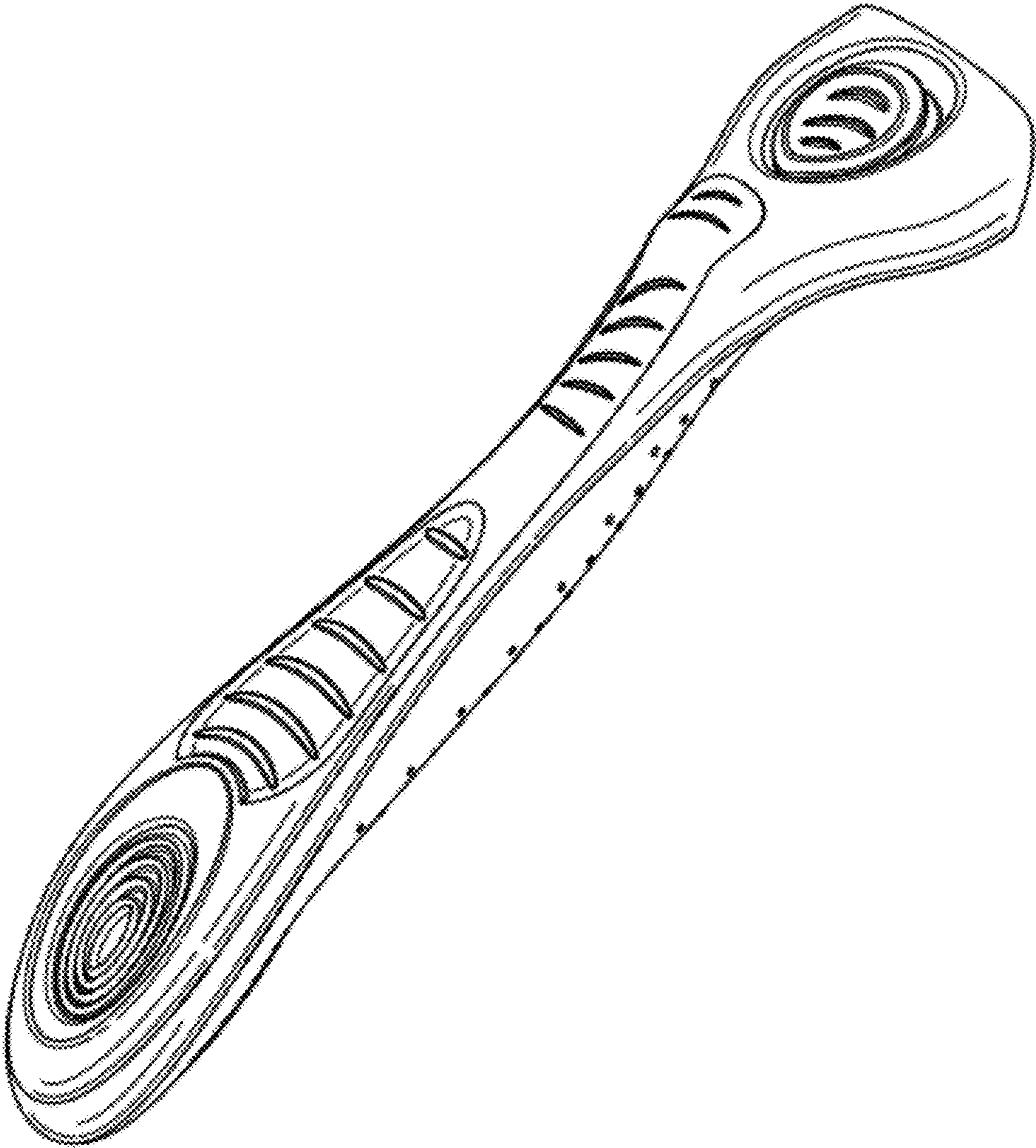

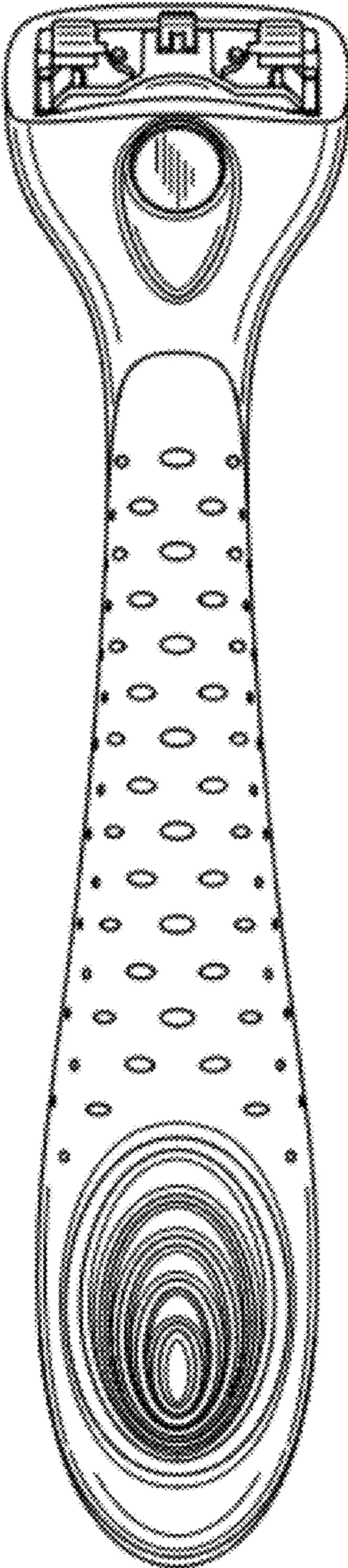

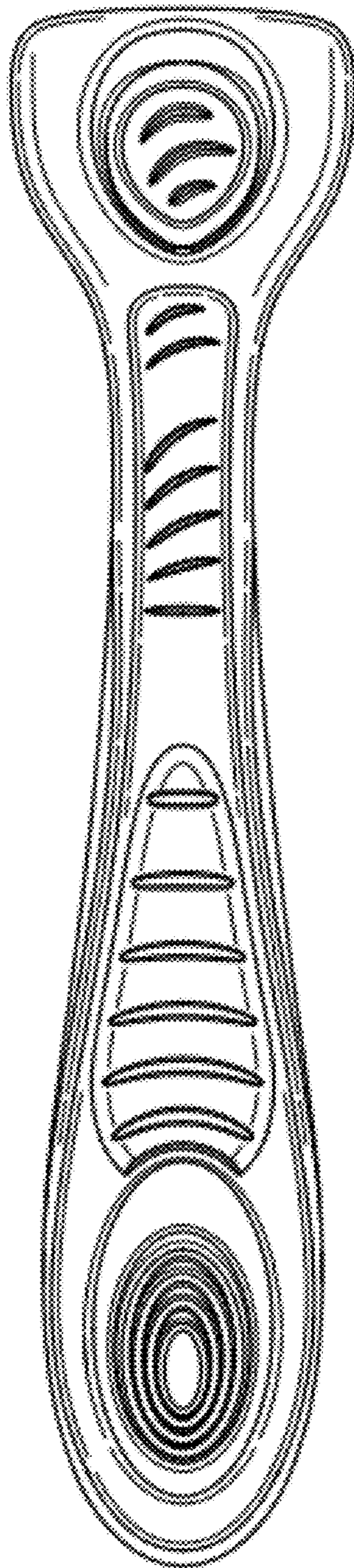

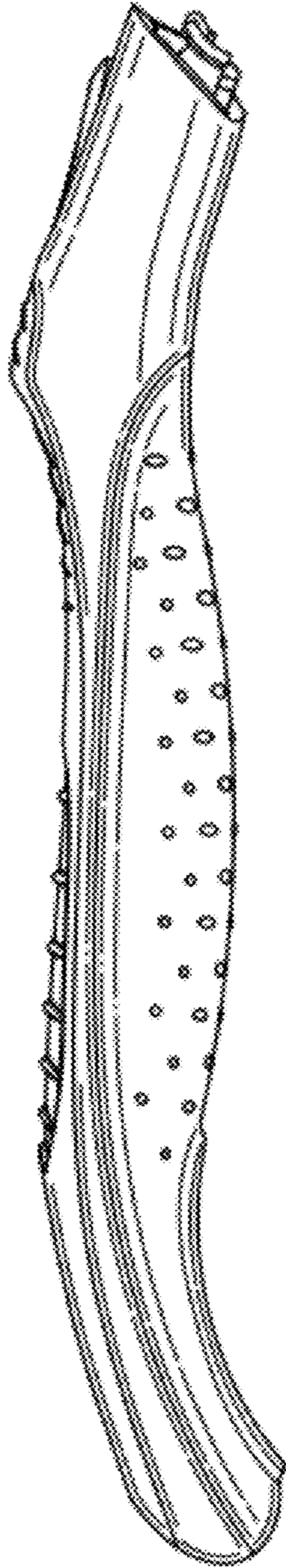

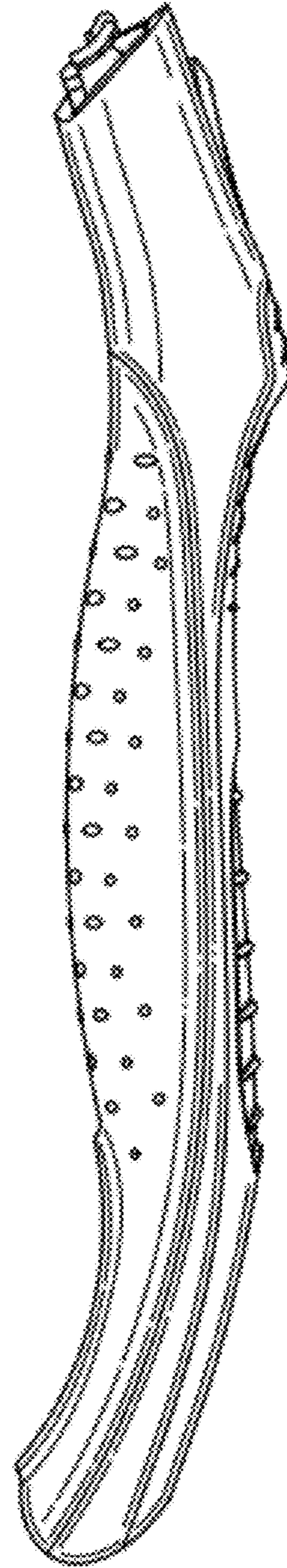

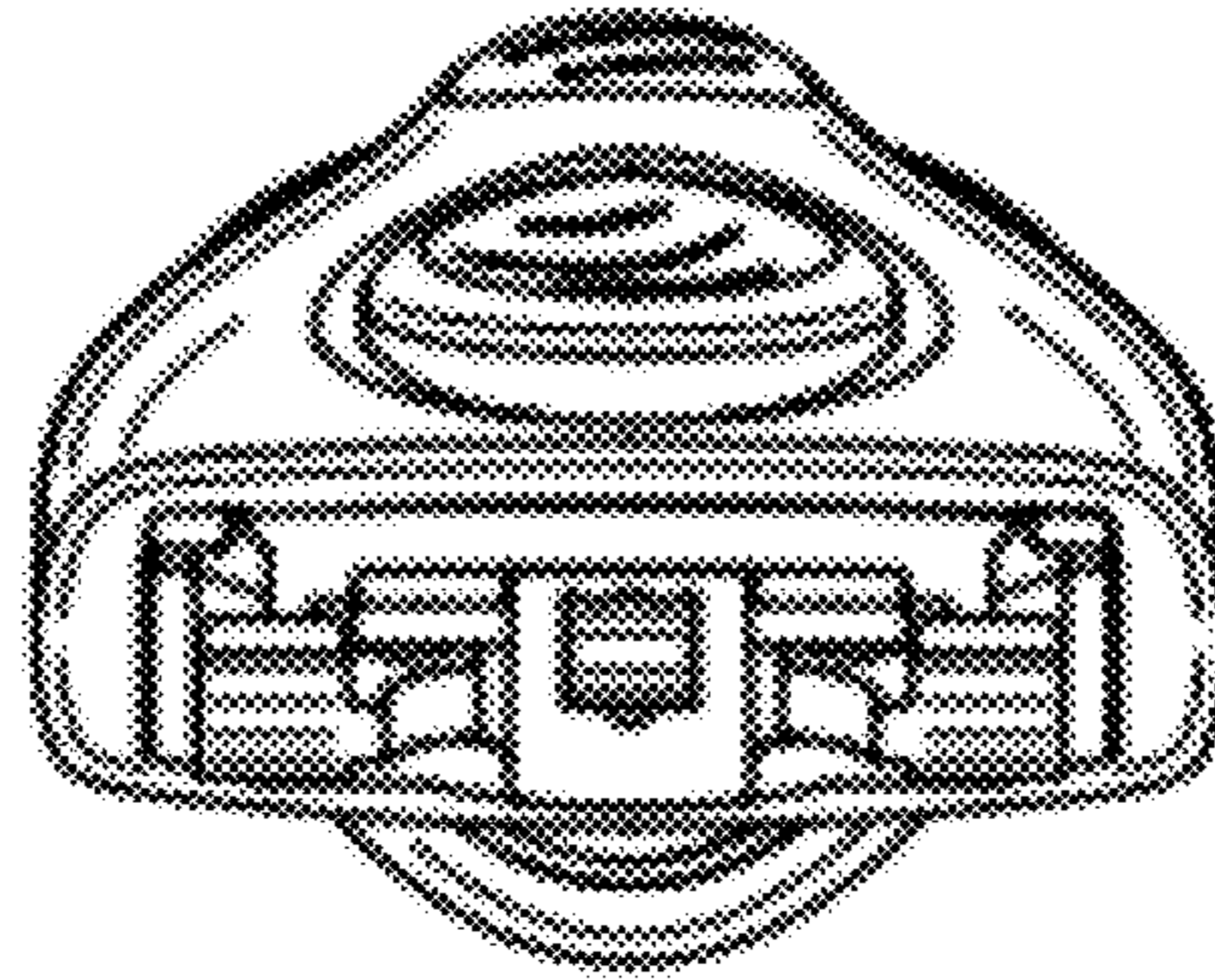

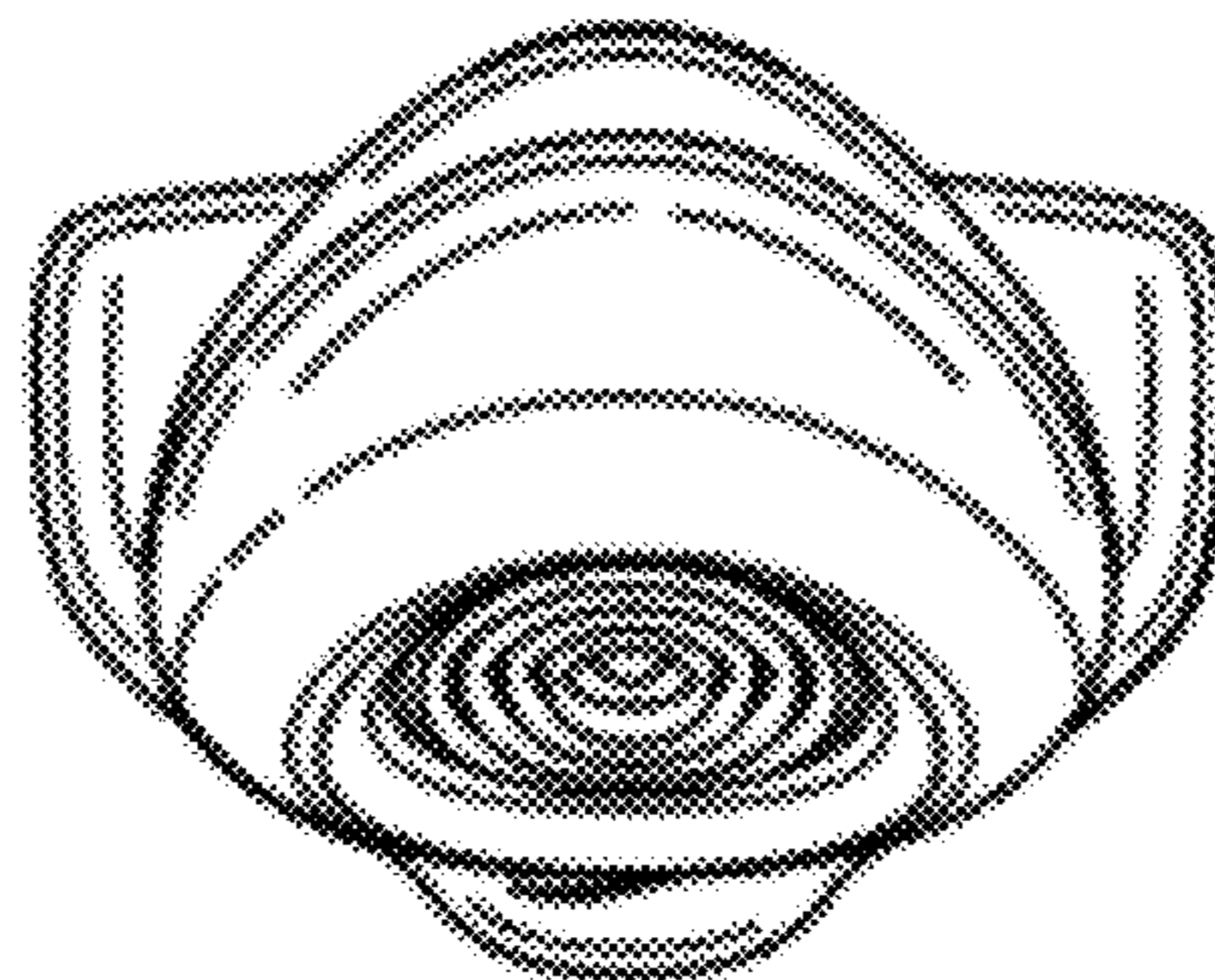
