The ornamental design for an electric shaver, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an electric shaver; FIG. 2 is a rear perspective view of thereof; FIG. 3 is a front view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a rear view thereof; FIG. 7 is a left side view thereof; FIG. 8 is a bottom plan view thereof; FIG. 9 is a sectional view thereof taken along line 9-9 in FIG. 3, in which the internal components are omitted; and, FIG. 10 is a sectional view thereof taken along line 10II-10II between lines 10I-10I in FIG. 3 in which the internal components are omitted.

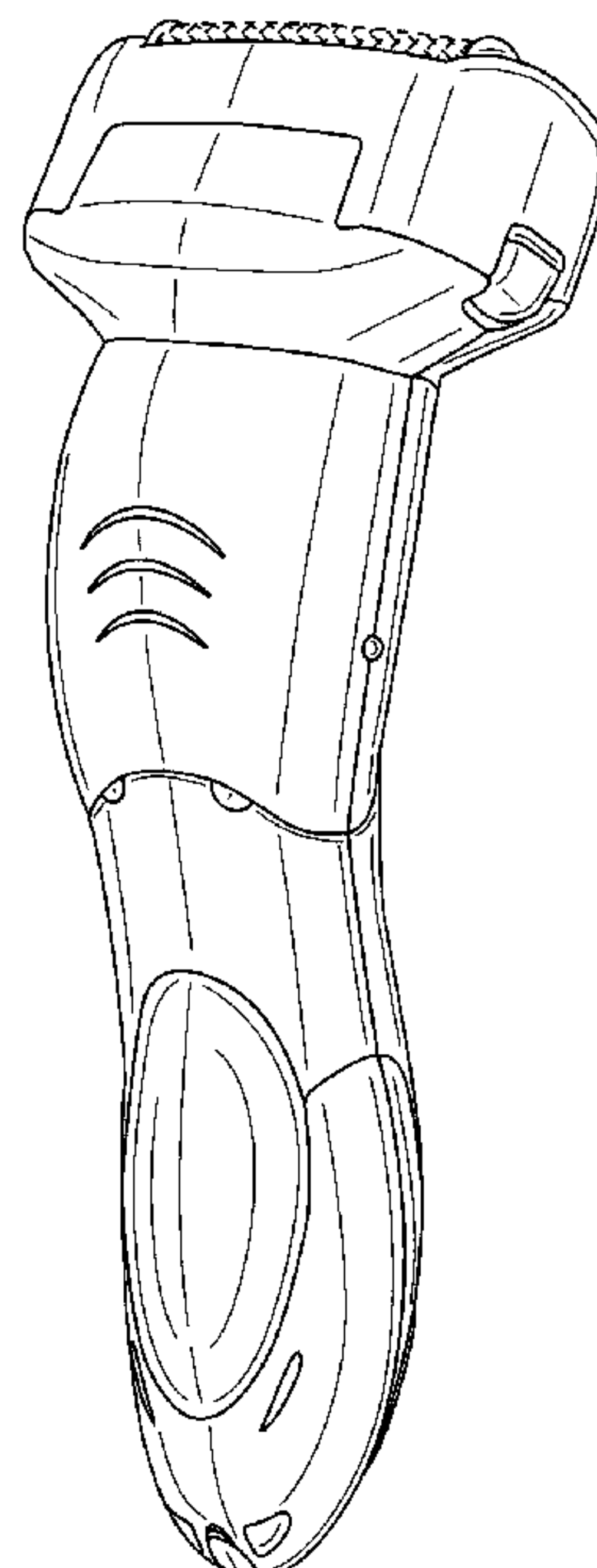
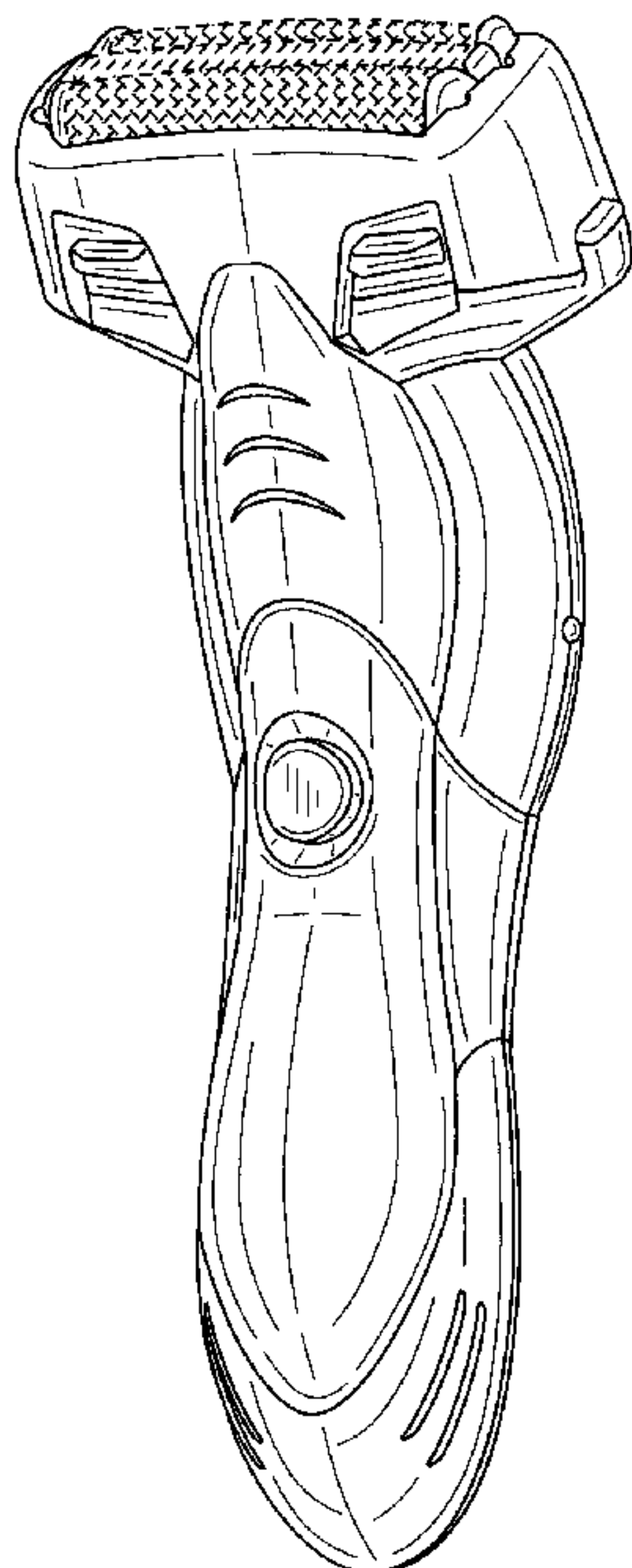

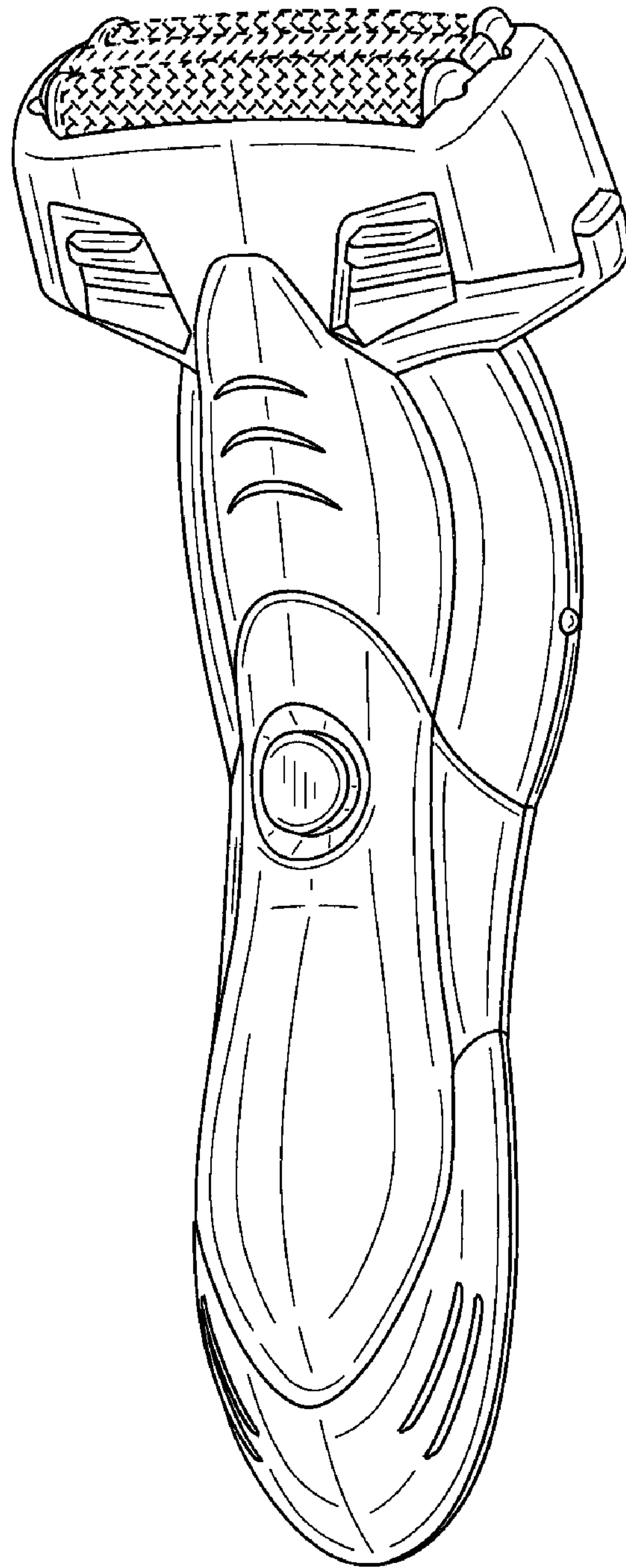

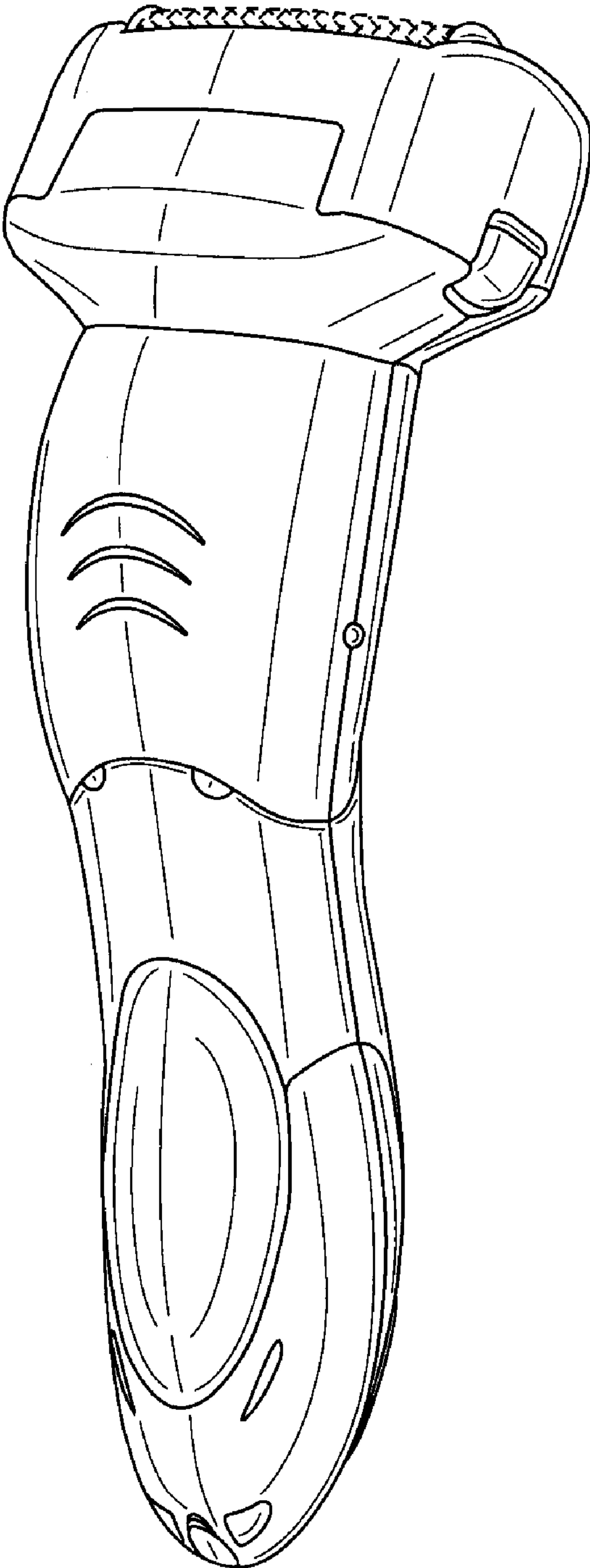

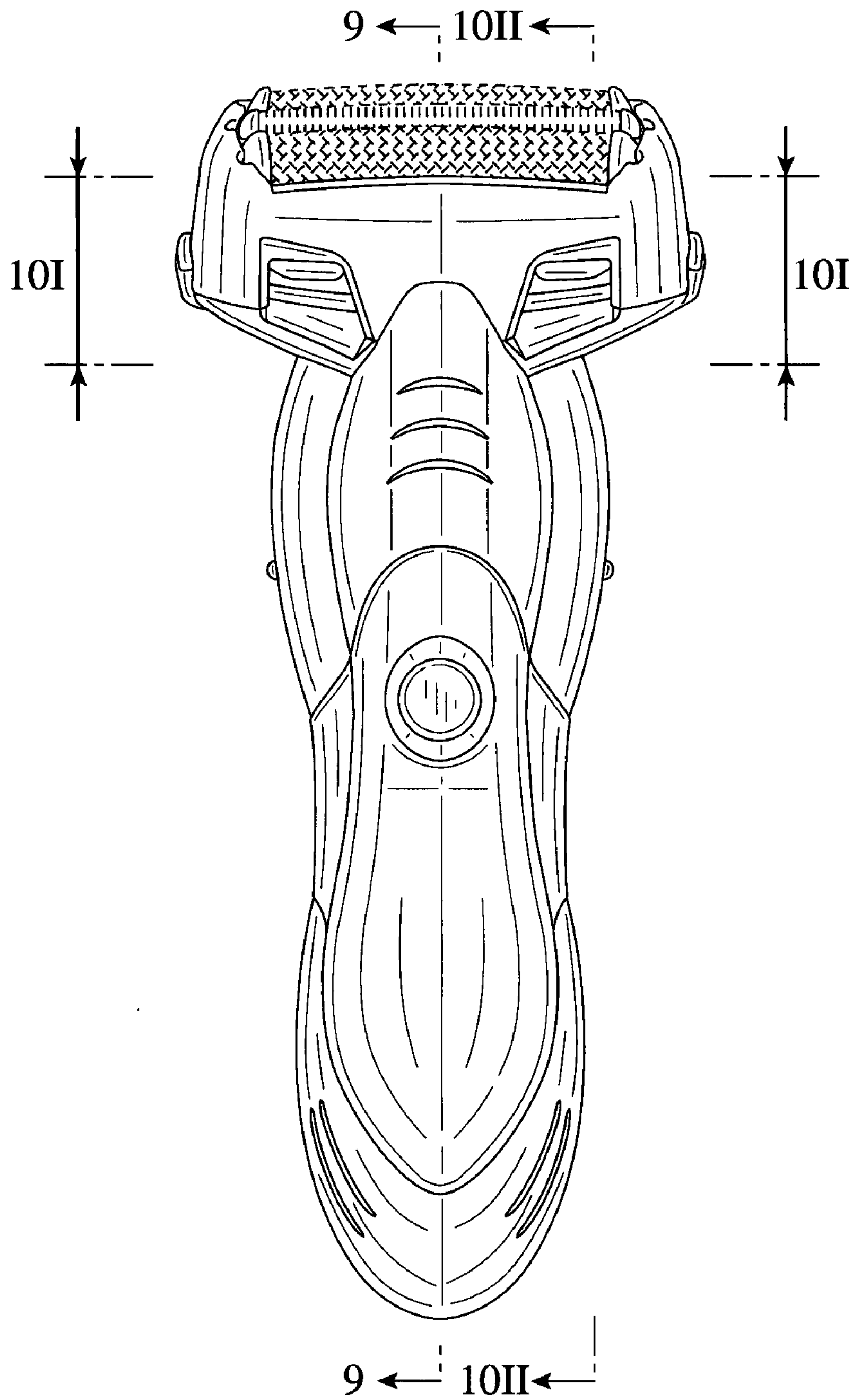

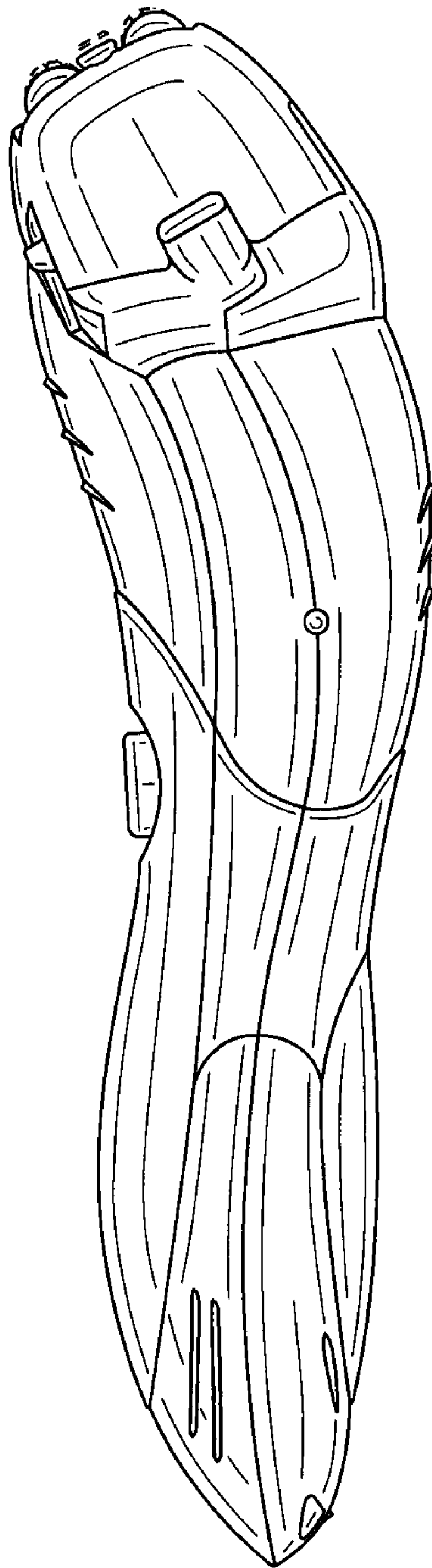

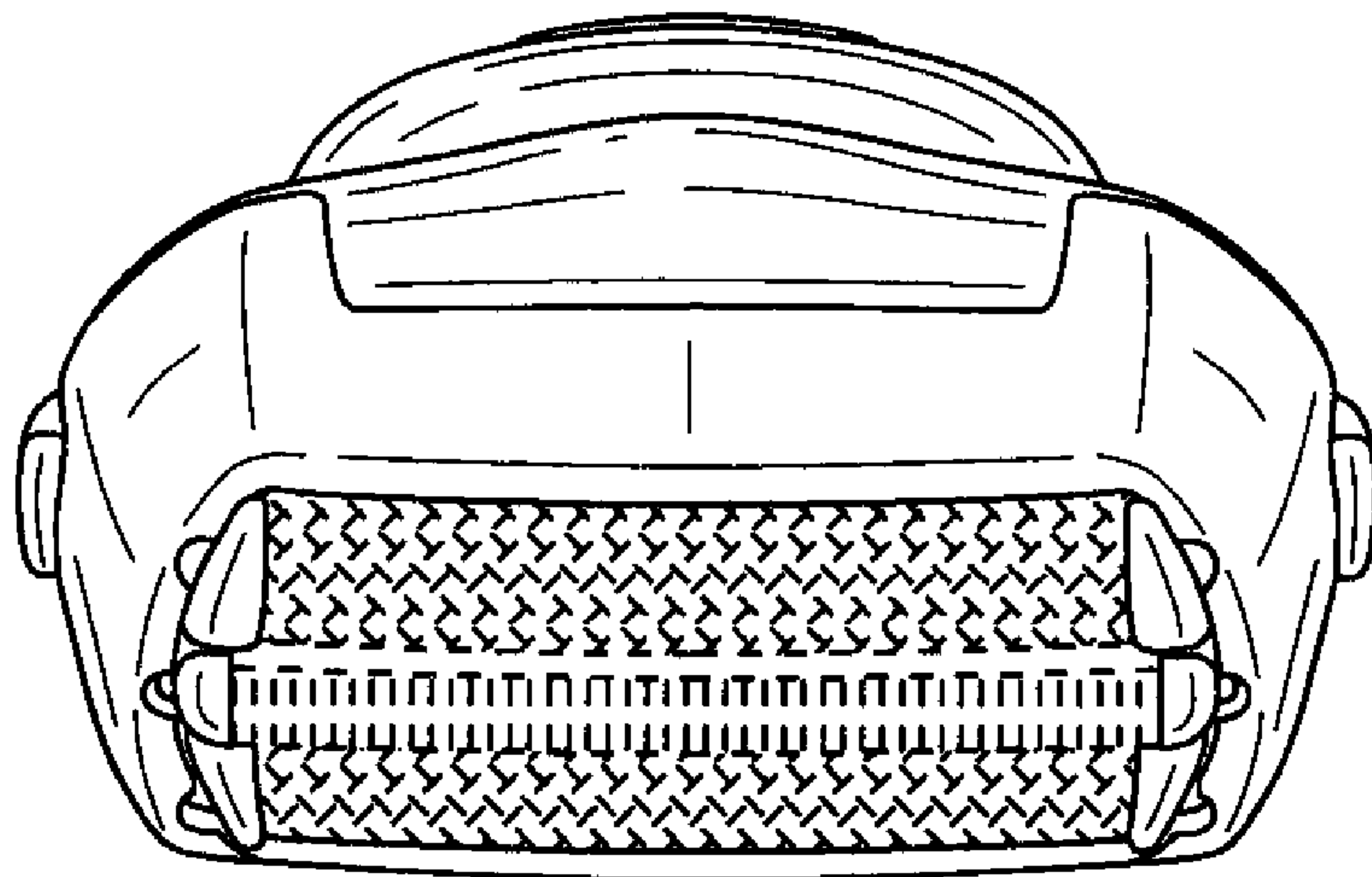

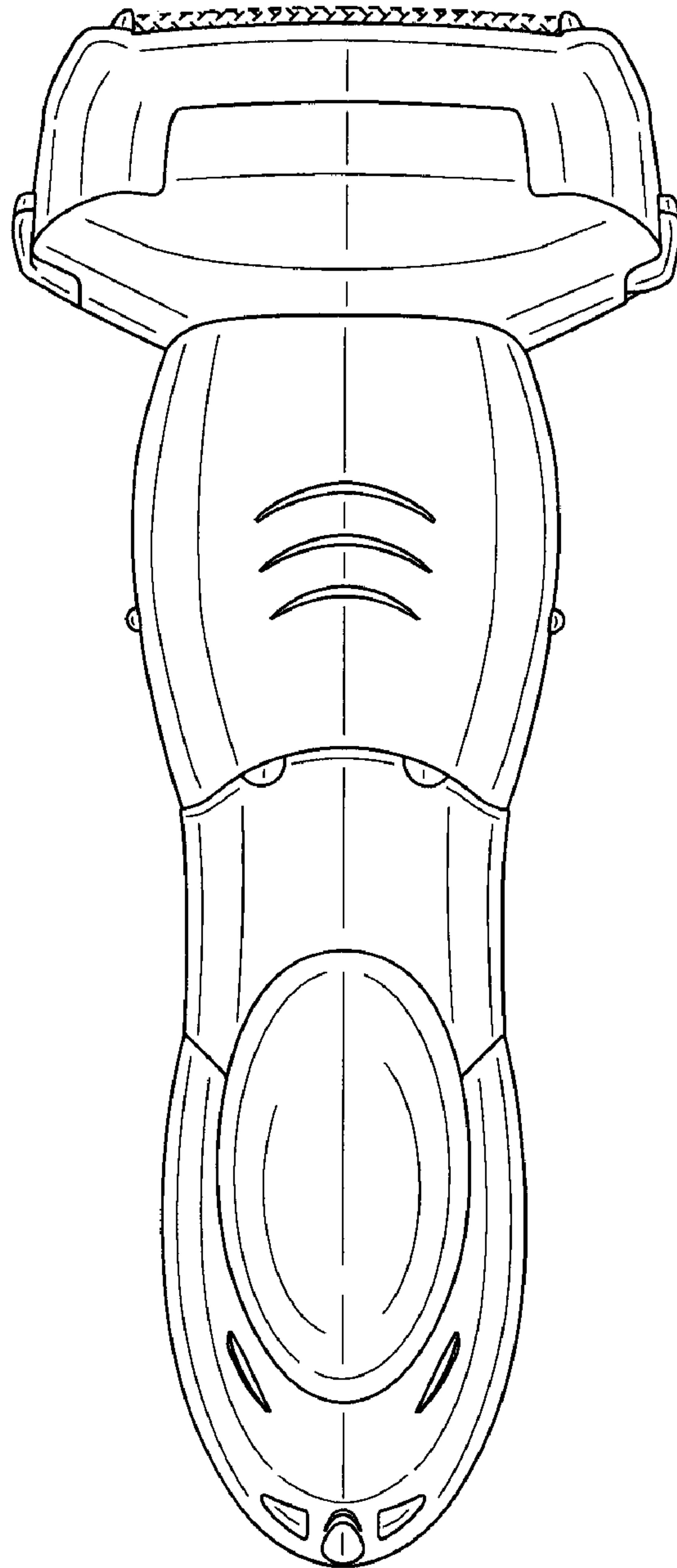

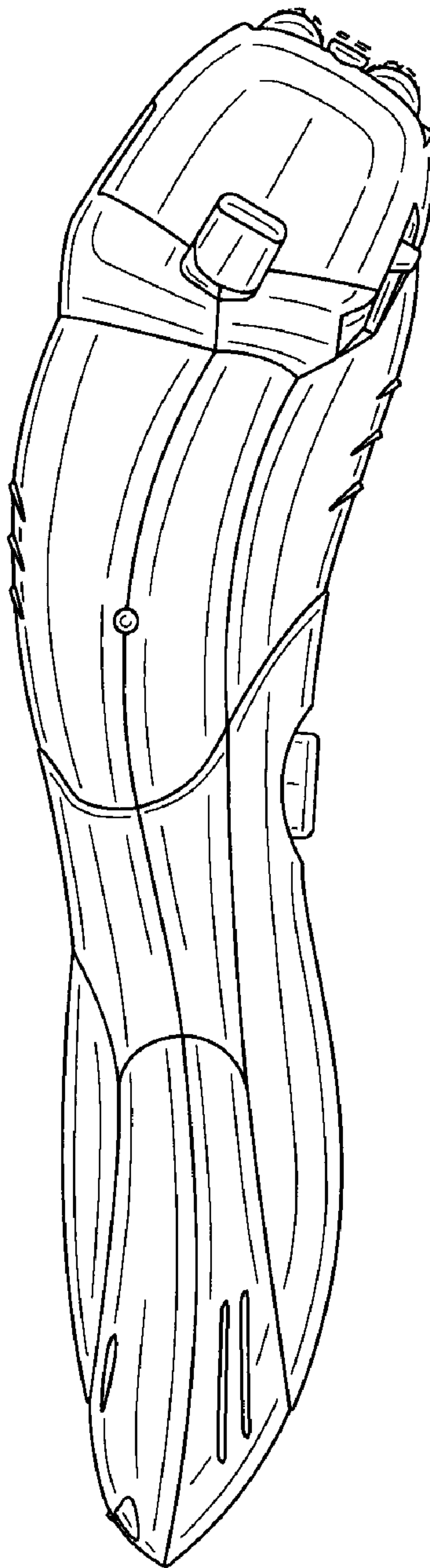

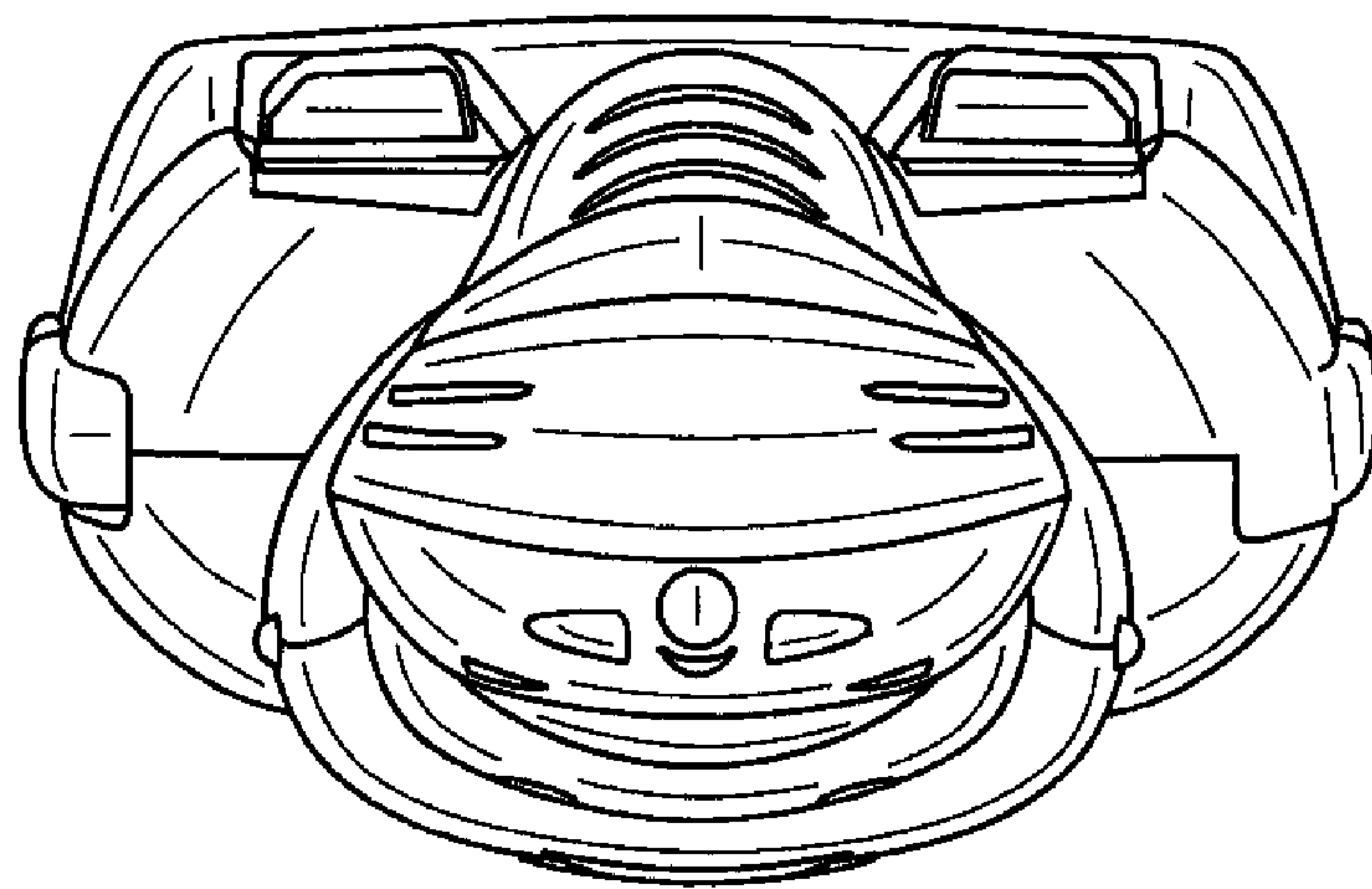

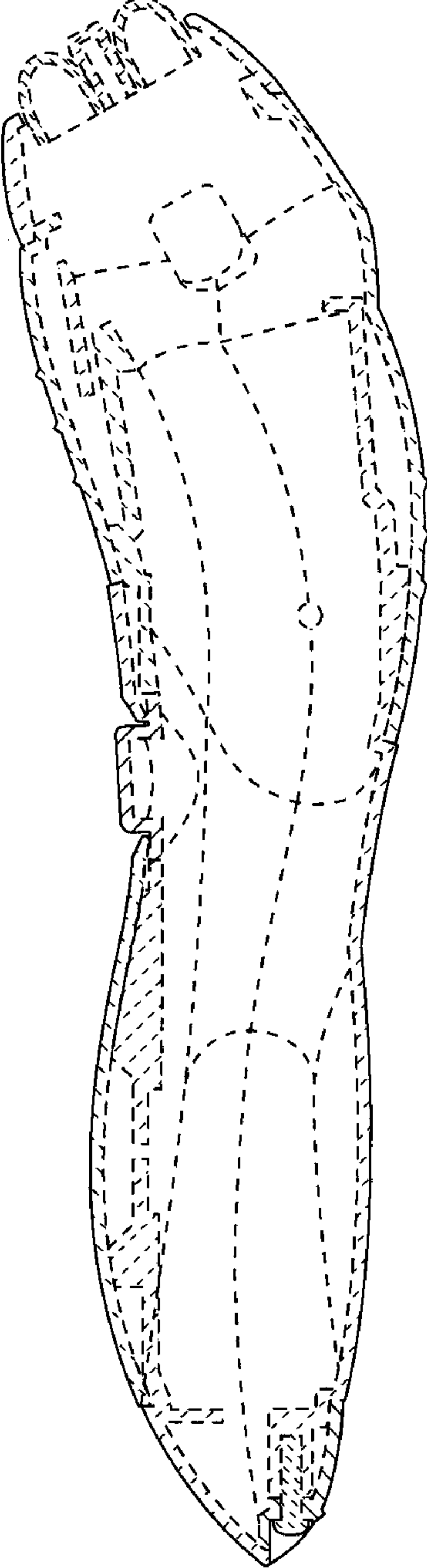
