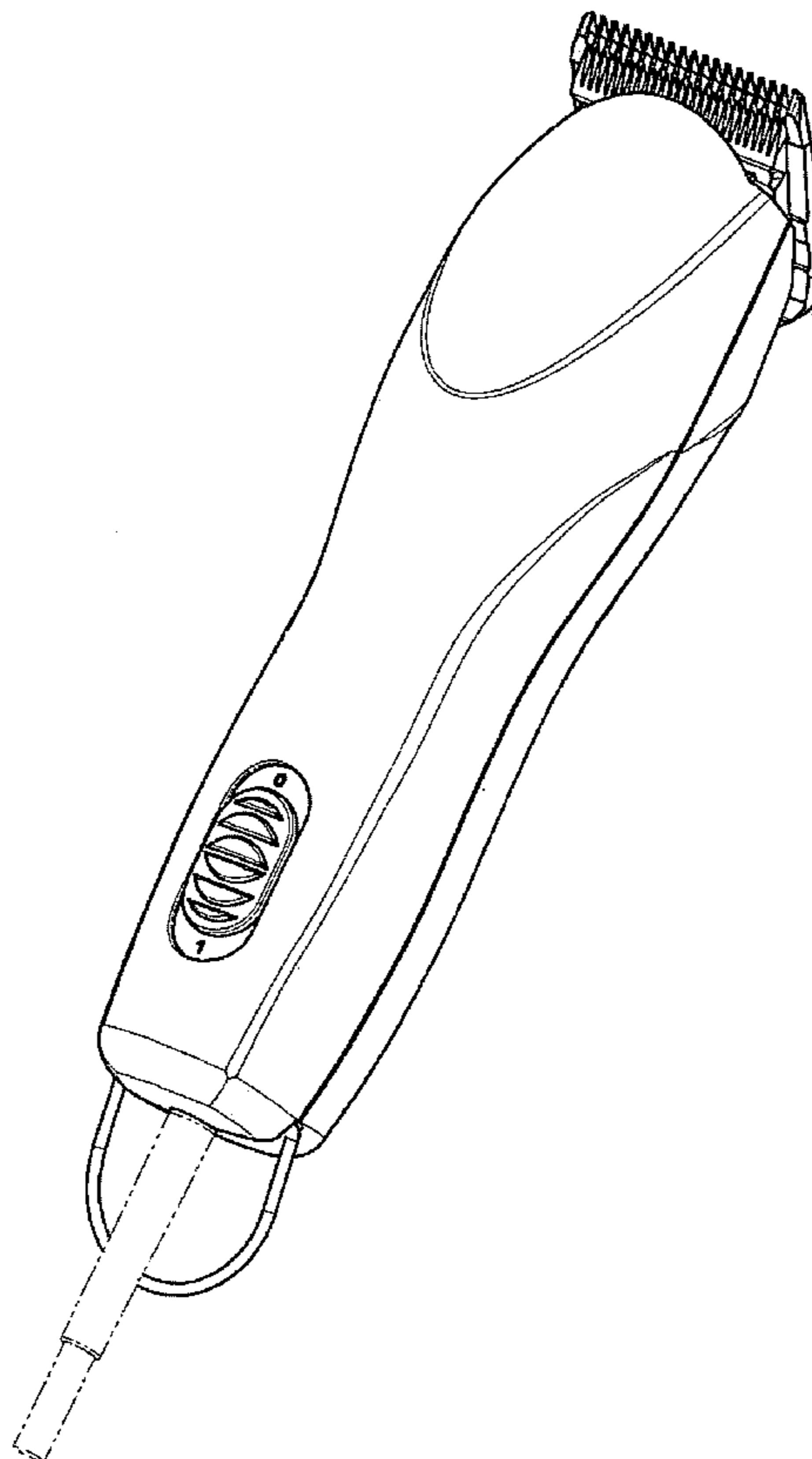
The ornamental design for a hair cutting machine with stand,

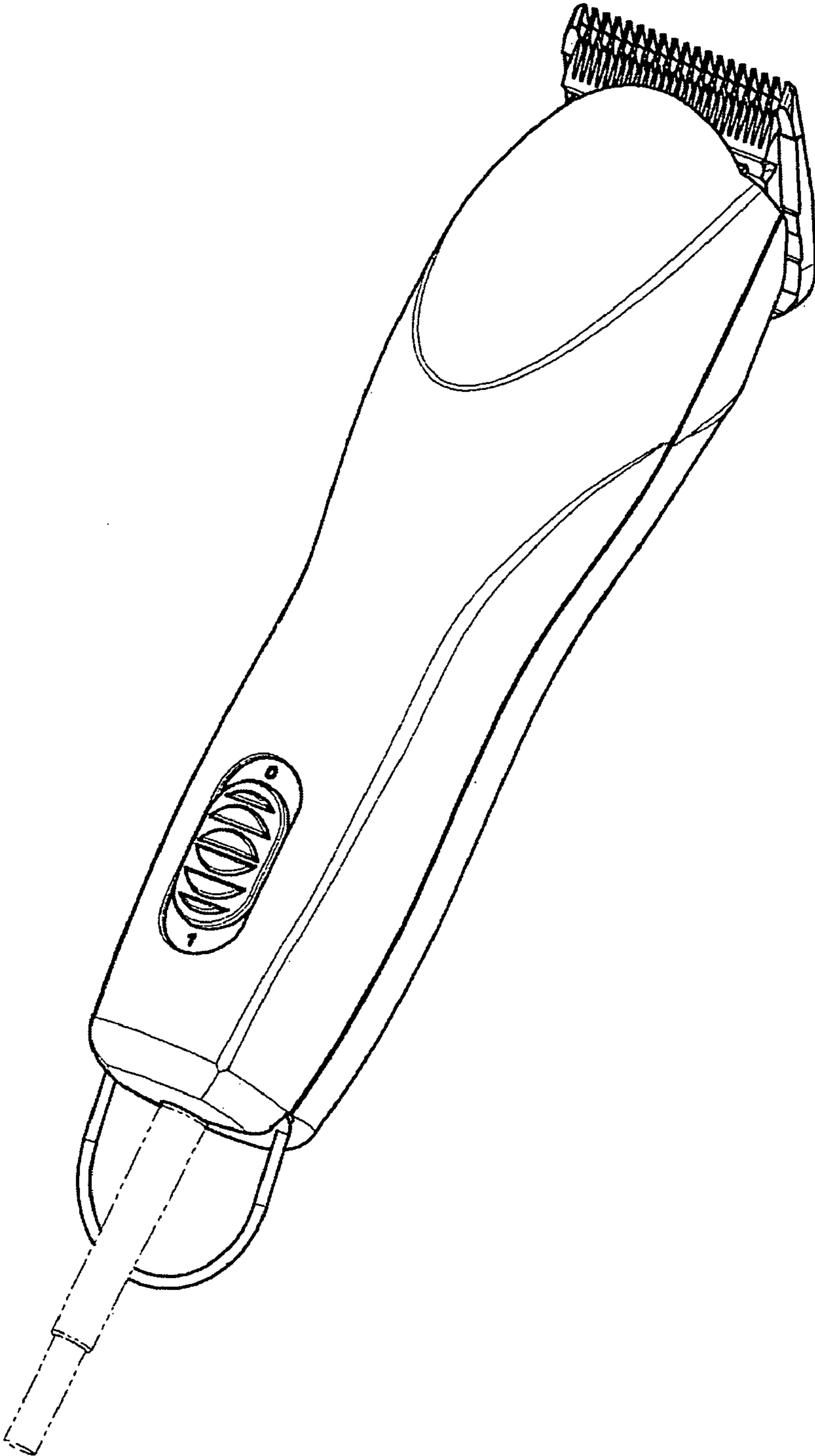

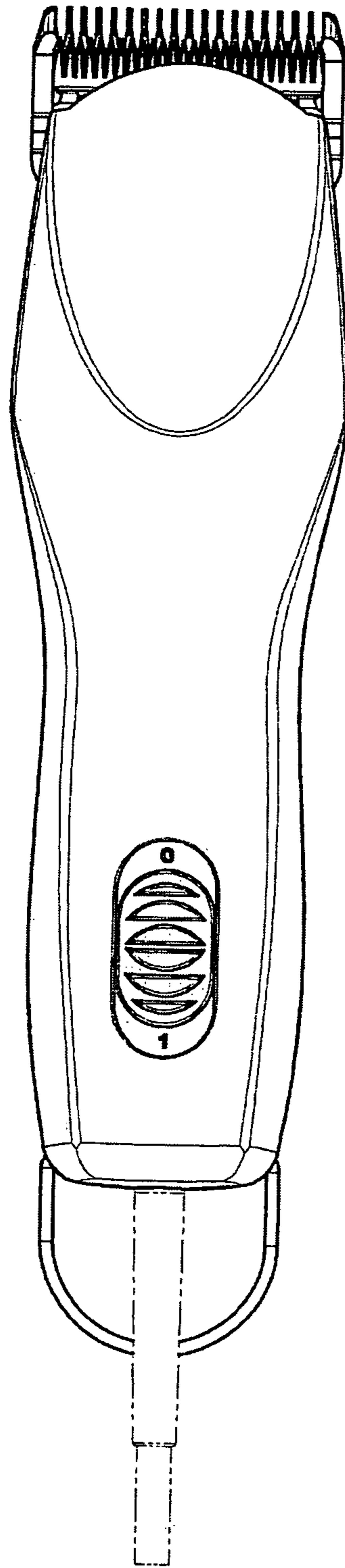

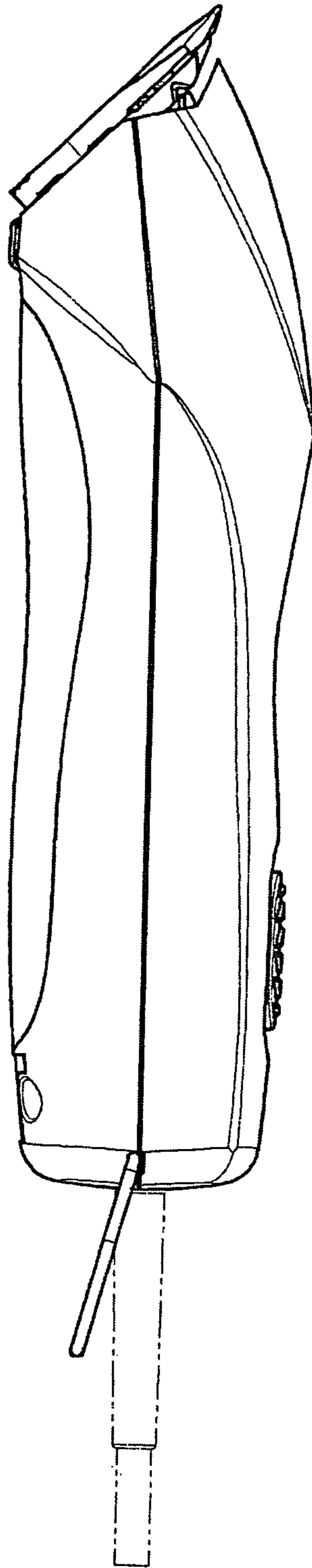

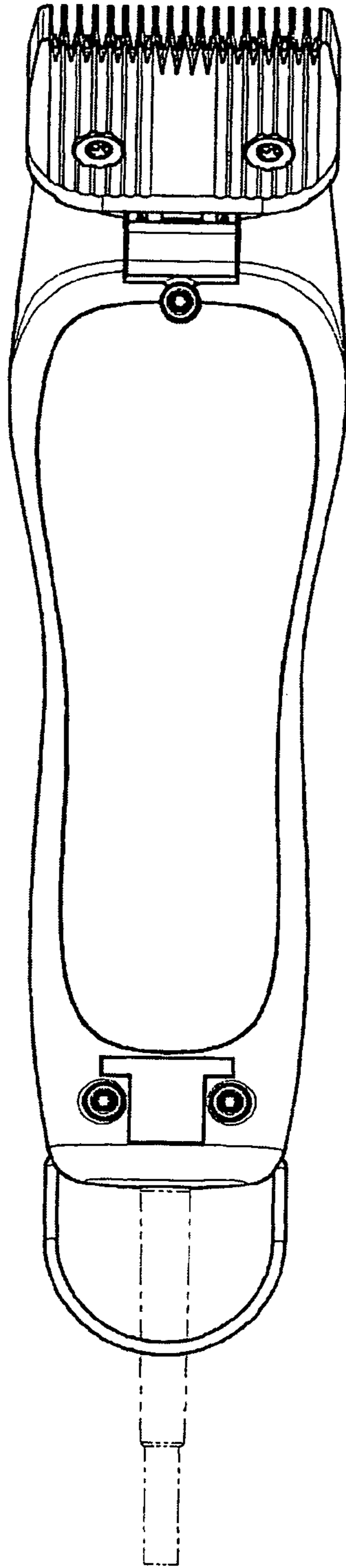

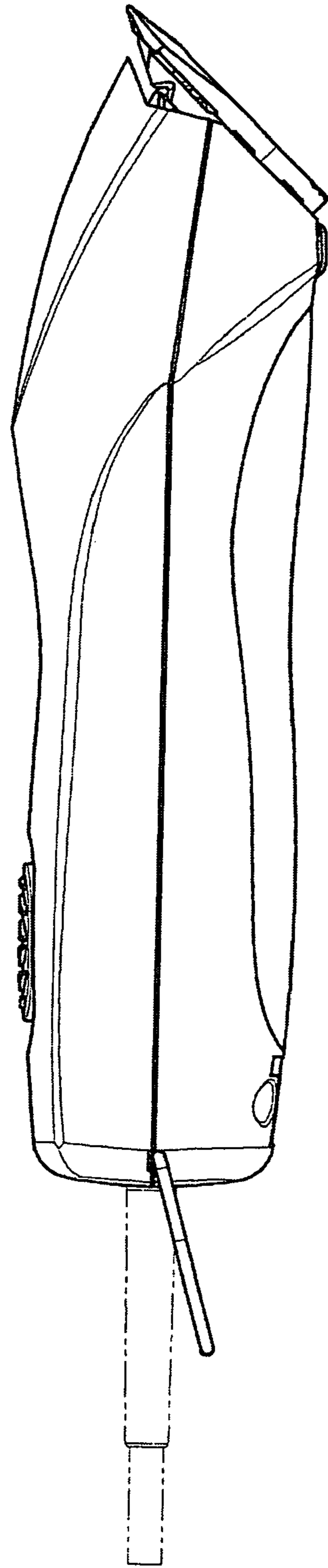

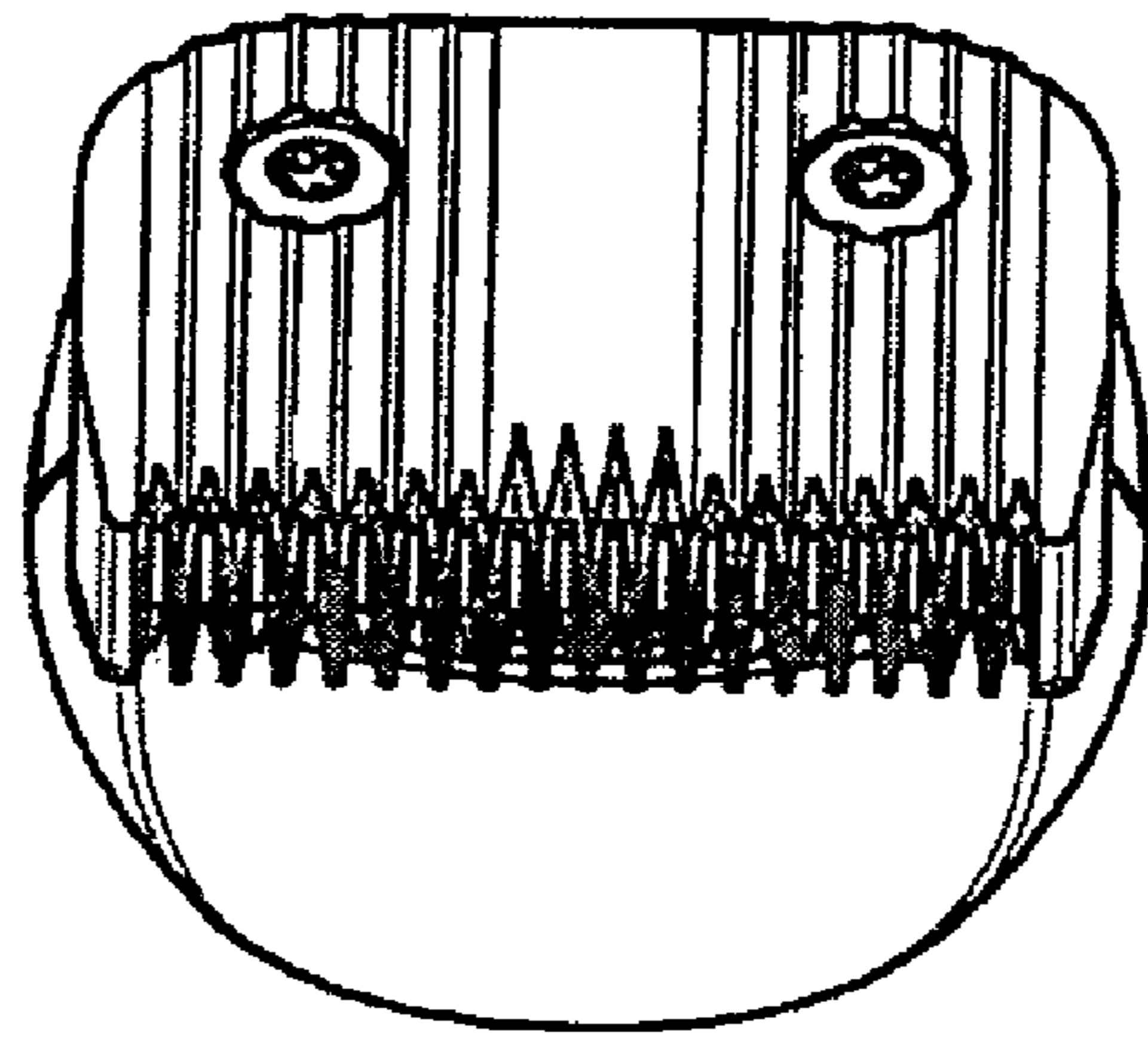

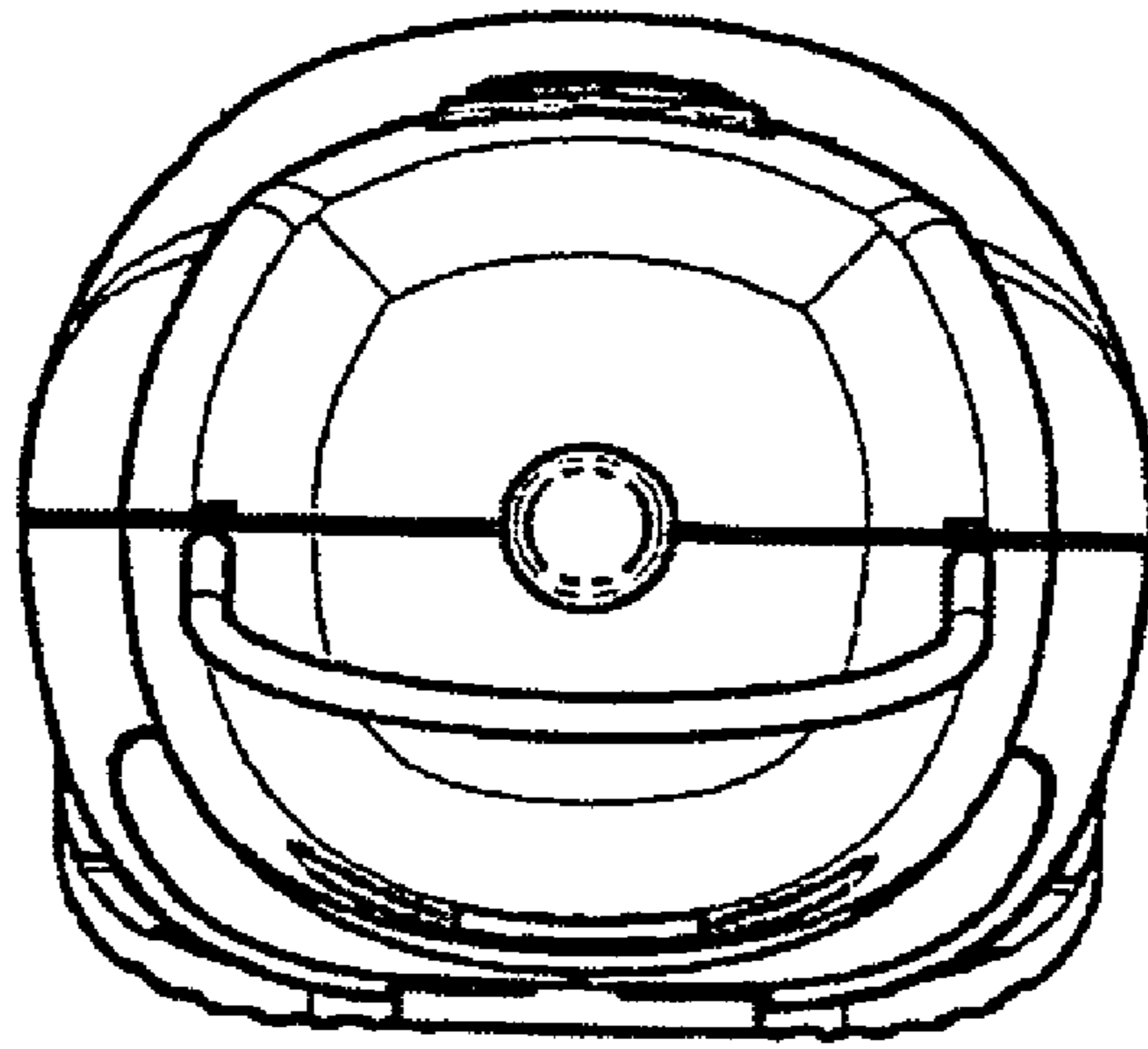
