(57) **CLAIM**

I claim the ornamental design for shirt with adjustable adornments, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a shirt with adjustable adornments showing my new design;

FIG. 2 is a front view thereof, showing an unclaimed adornment affixed to the shirt;

FIG. 3 is another front view thereof, showing an unclaimed adornment affixed to the shirt; and,

FIG. 4 is a rear view thereof.

In FIGS. 1-4, the broken lines represent the portions of the shirt that form no part of the claimed design.

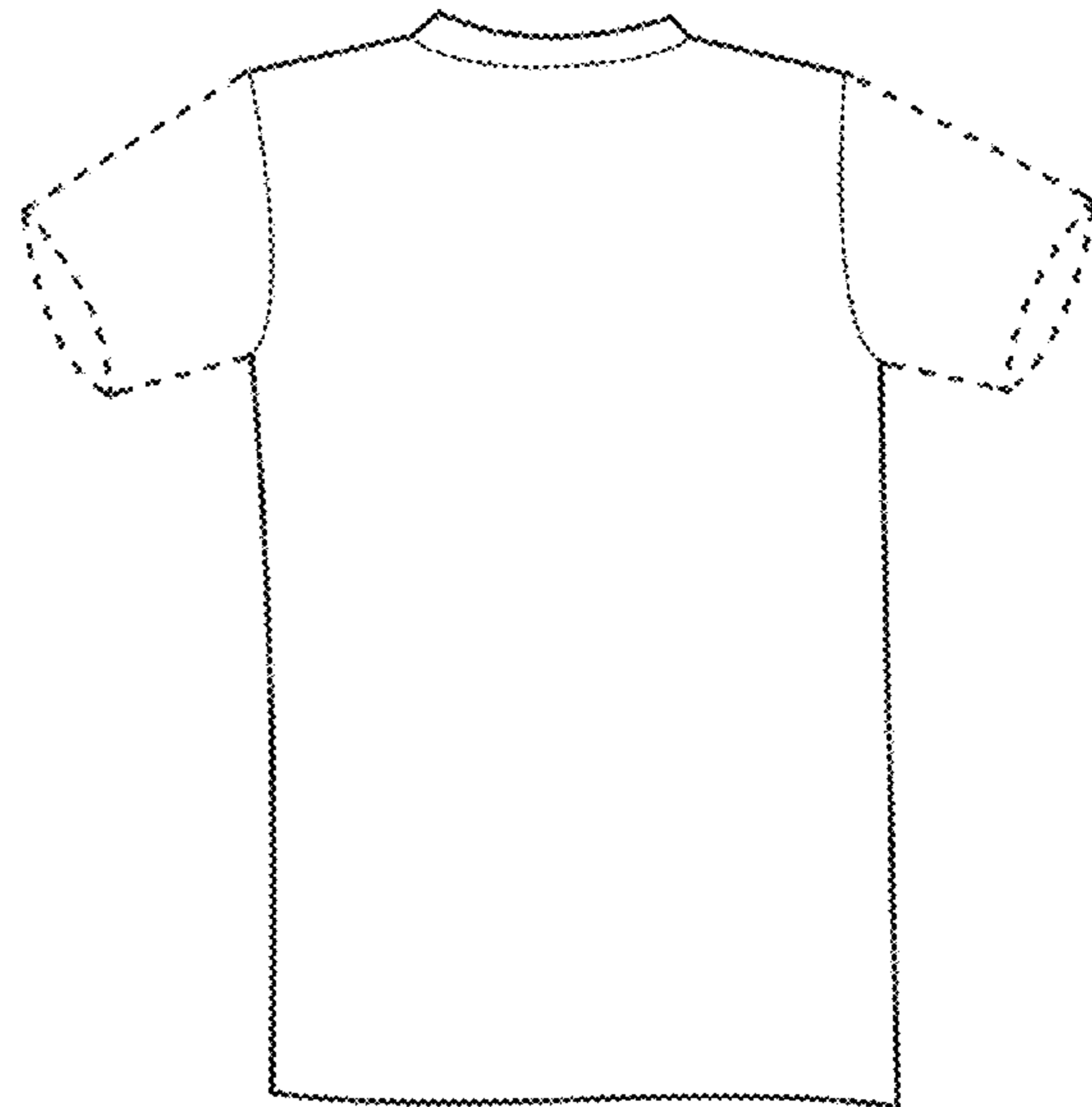

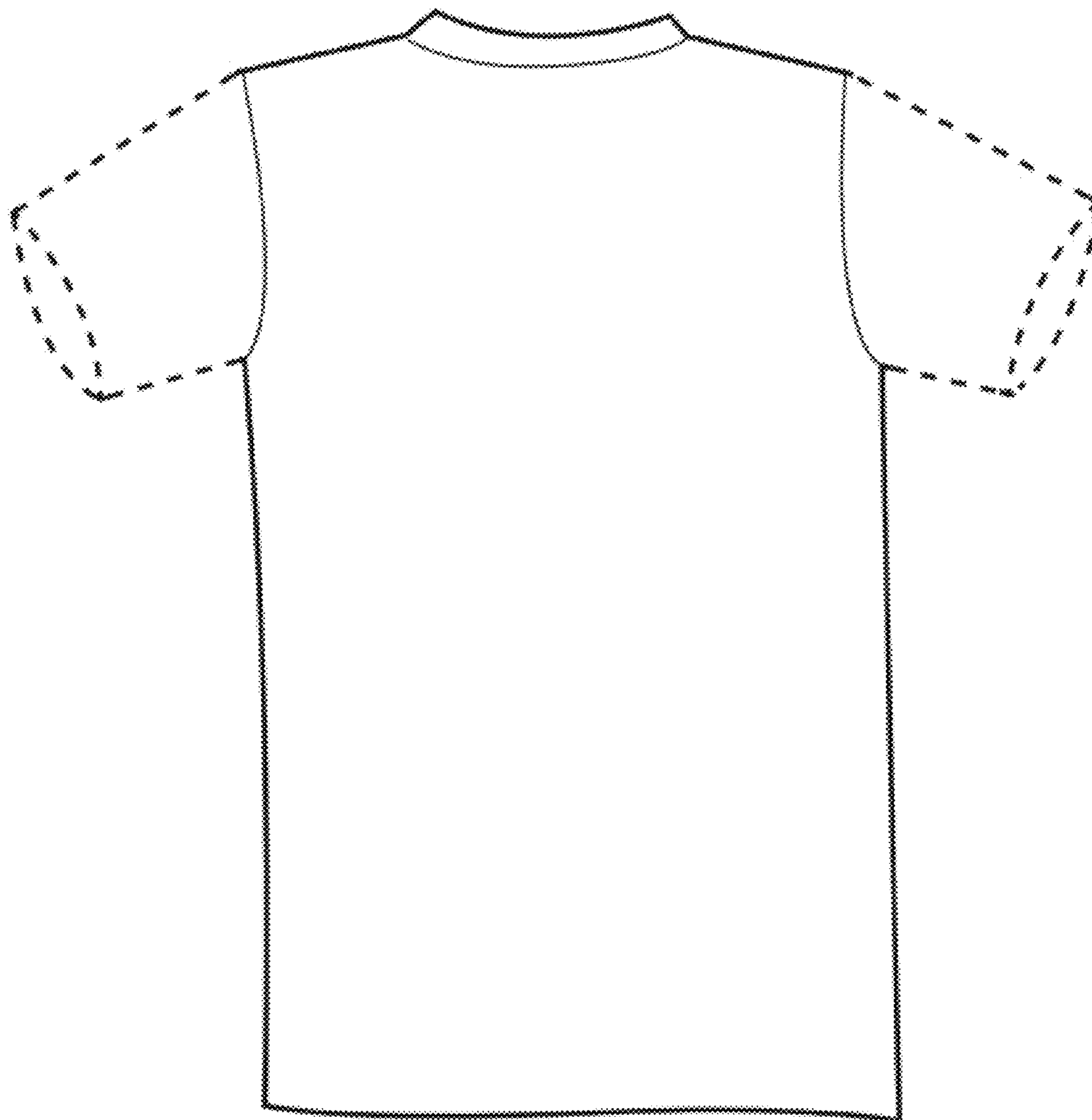
