The ornamental design for a shoe bottom, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a shoe bottom according to the present invention;

FIG. 2 is a bottom view of the shoe bottom of FIG. 1;

FIG. 3 is a right side view of the shoe bottom of FIG. 1;

FIG. 4 is a left side view of the shoe bottom of FIG. 1;

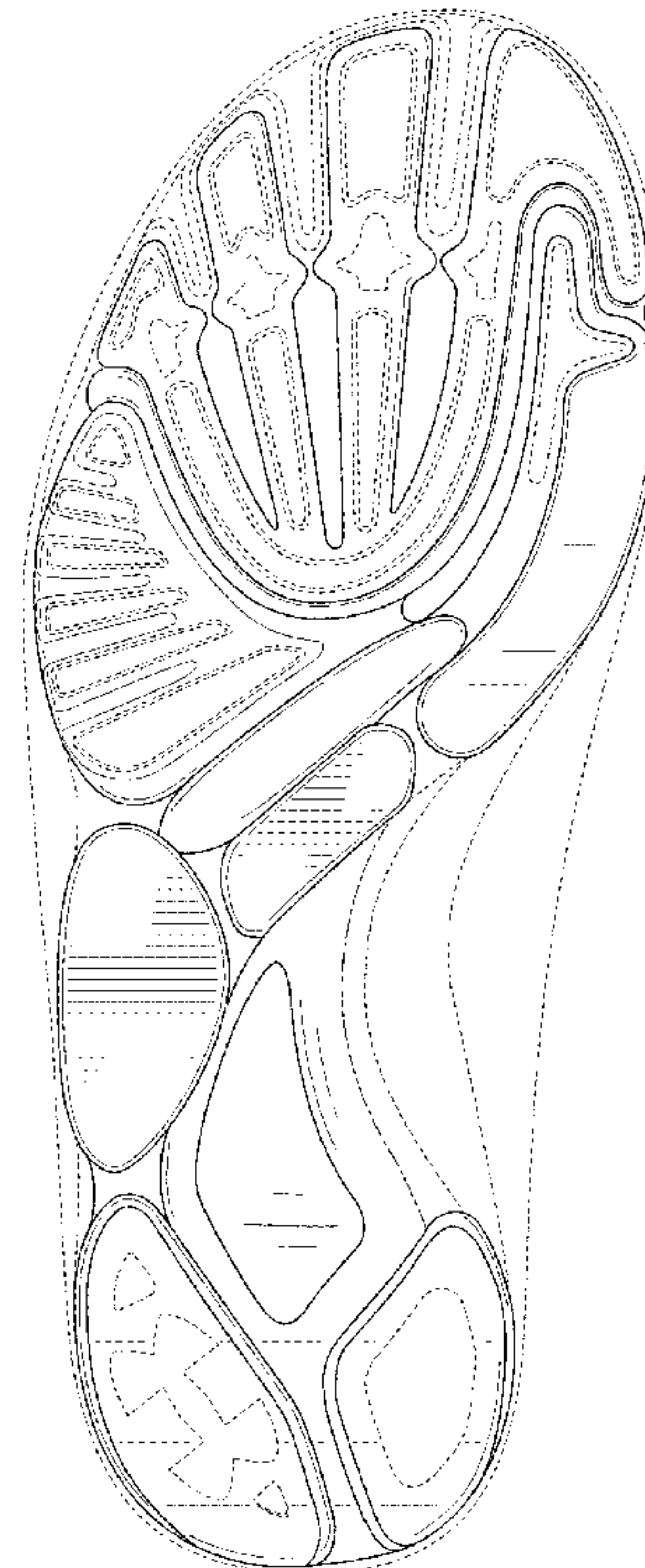
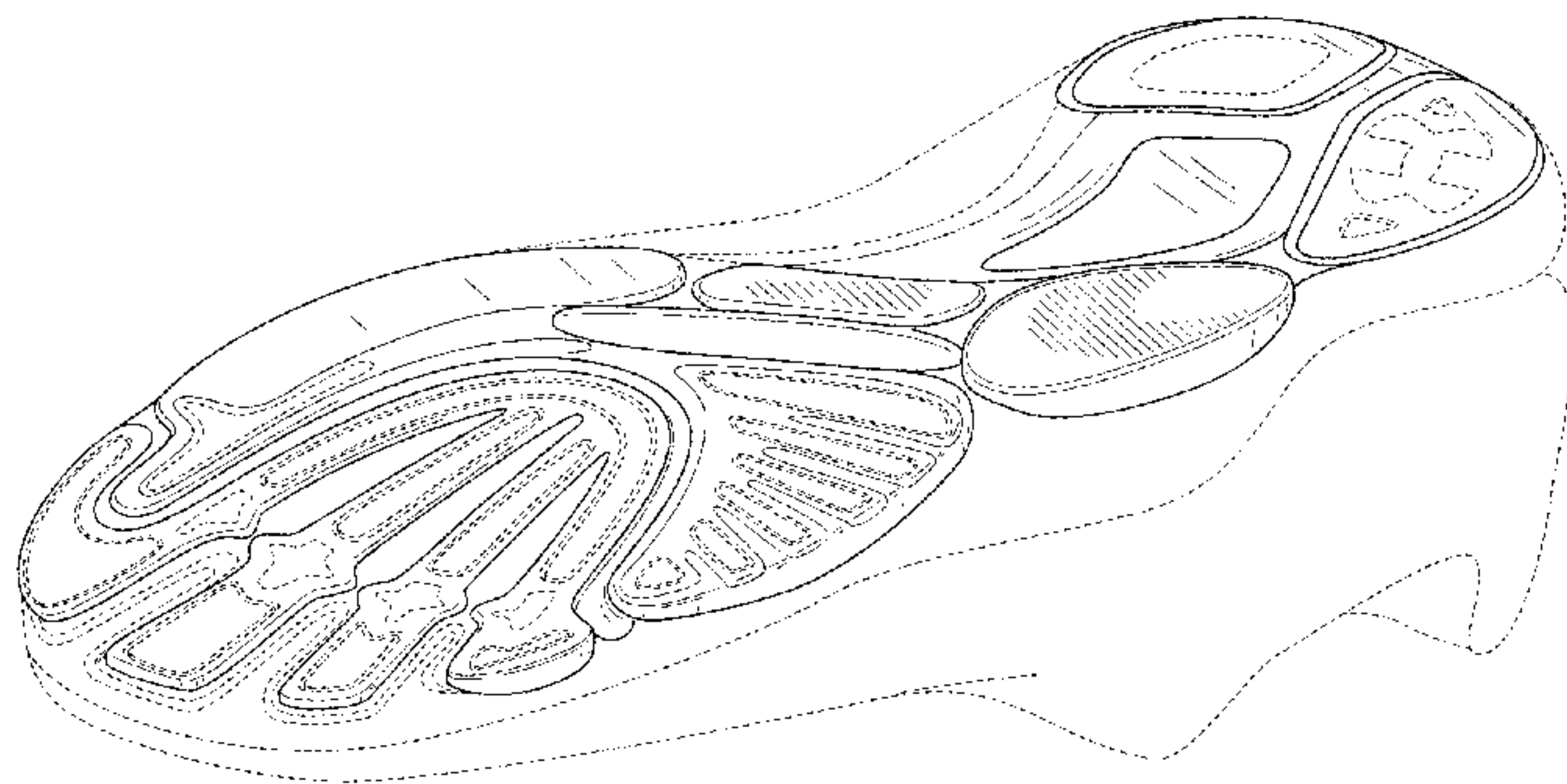
FIG. 5 is a front view of the shoe bottom of FIG. 1; and,

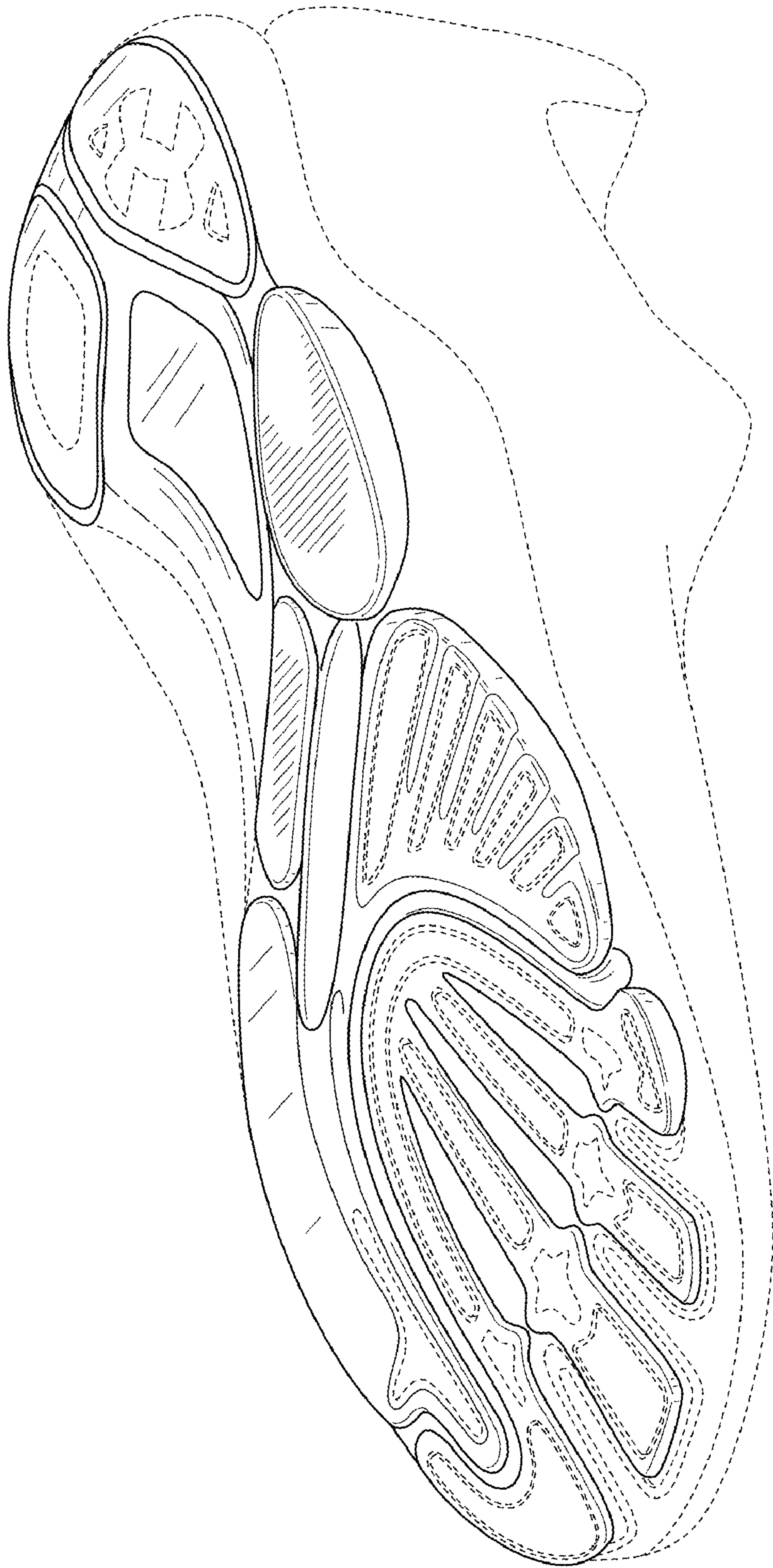

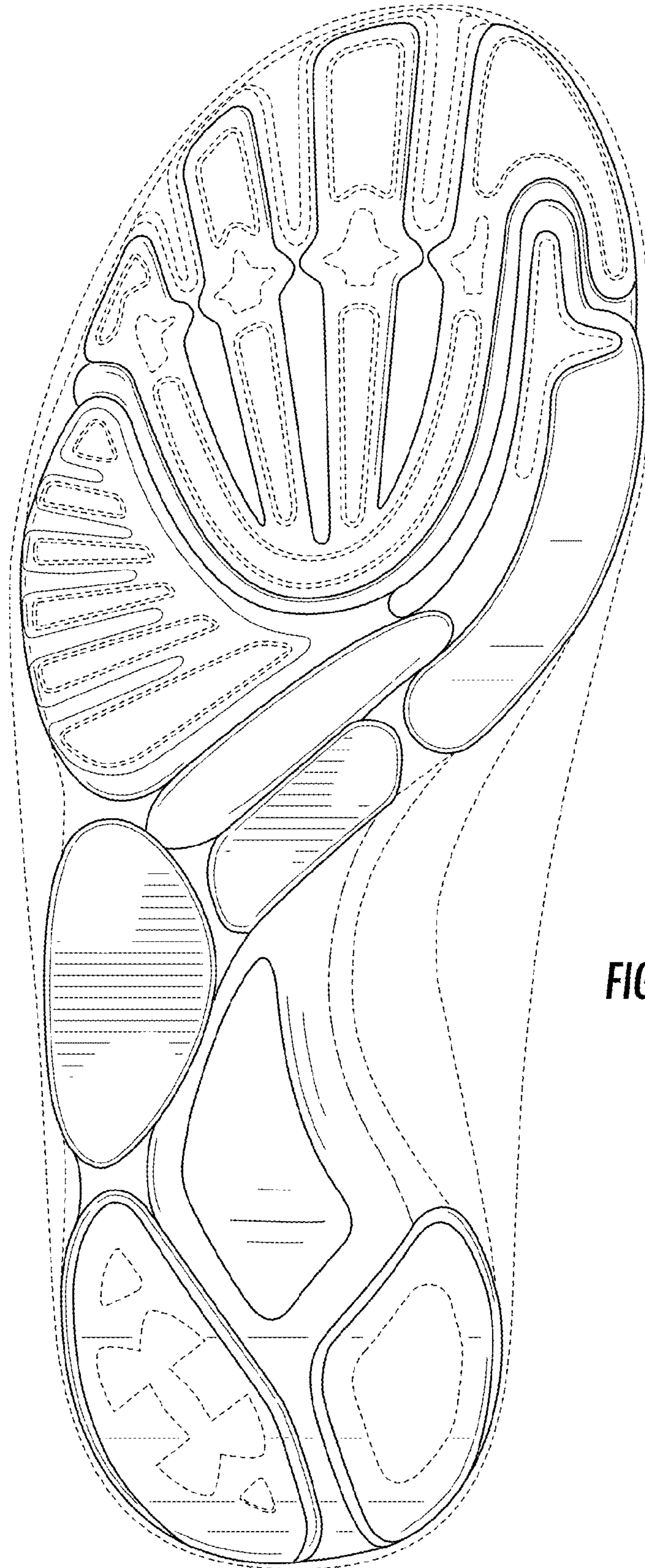

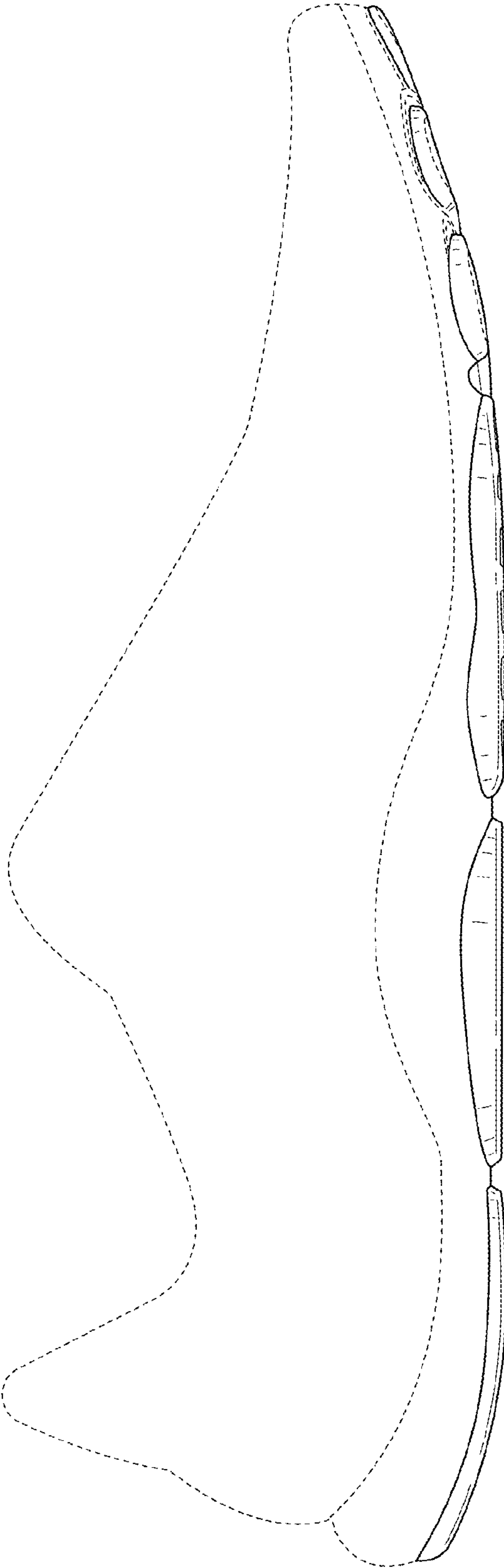

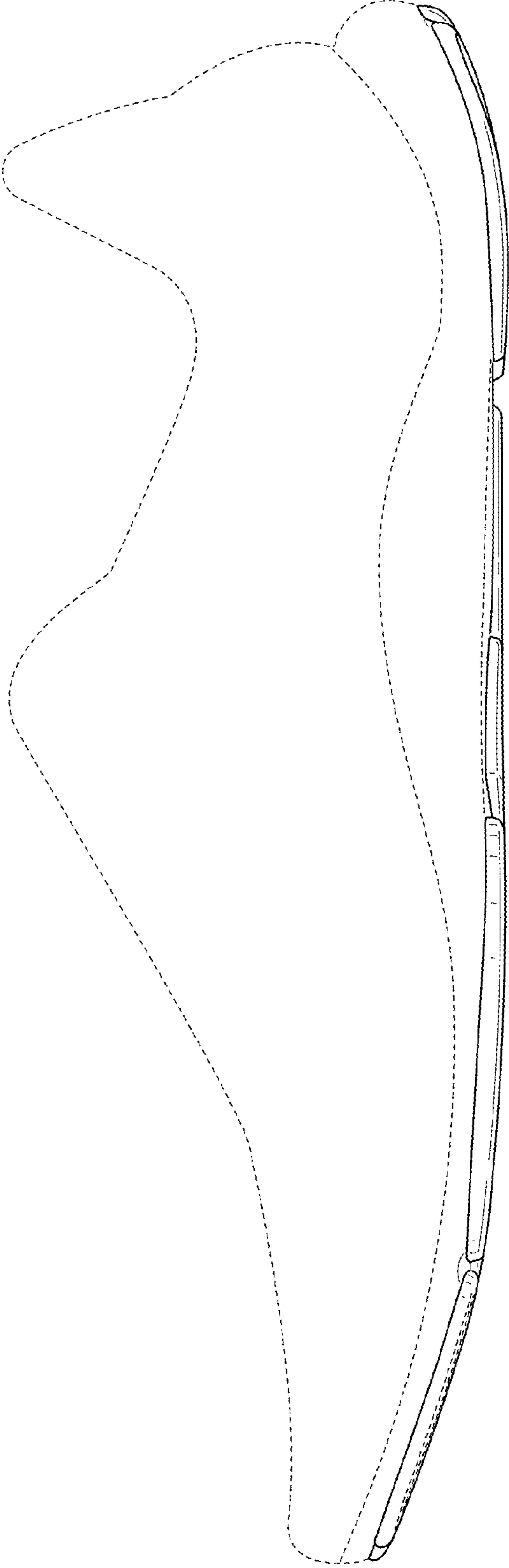

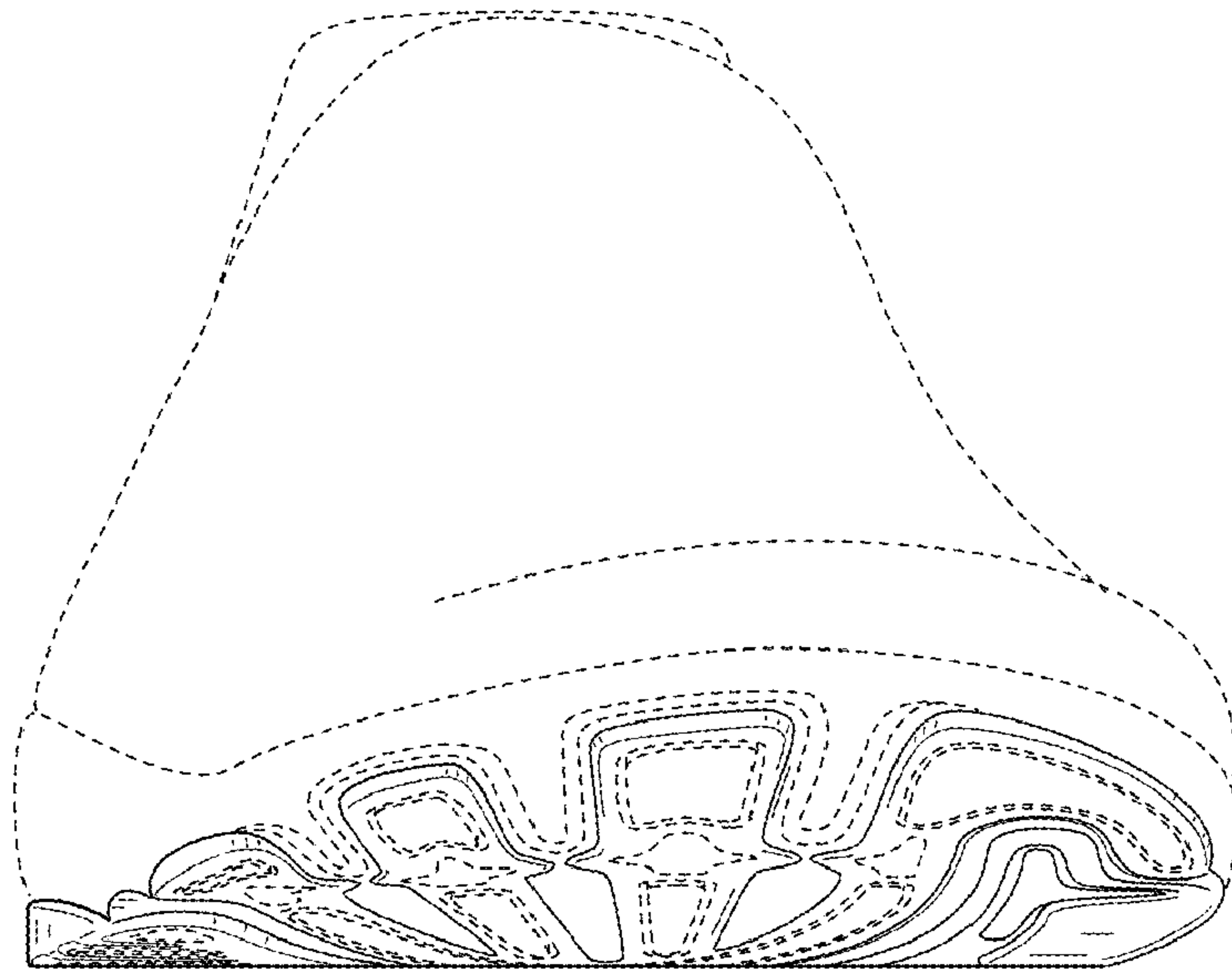

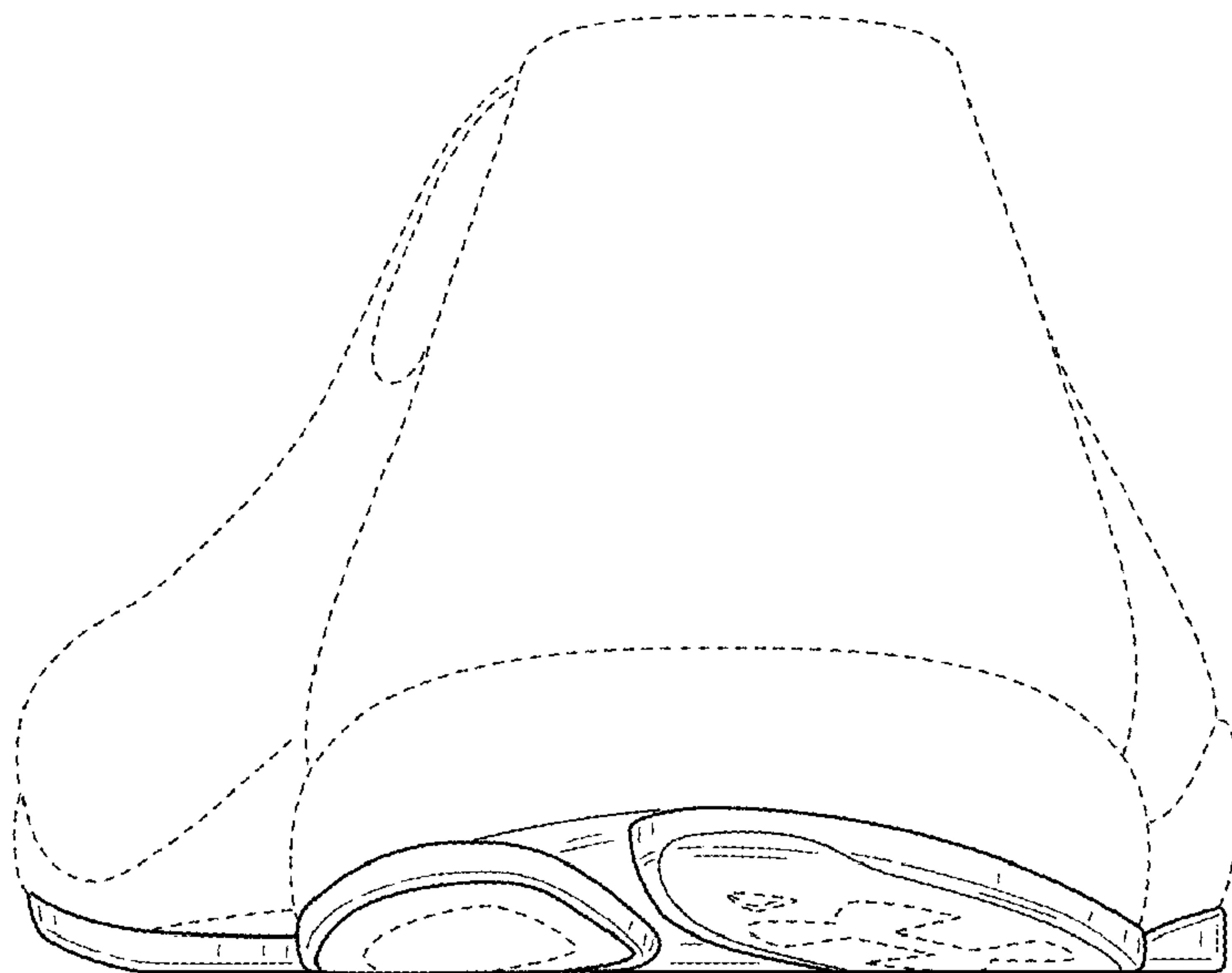
