(57) **CLAIM**

We claim the ornamental design for an embossed tissue sheet, as shown and described.

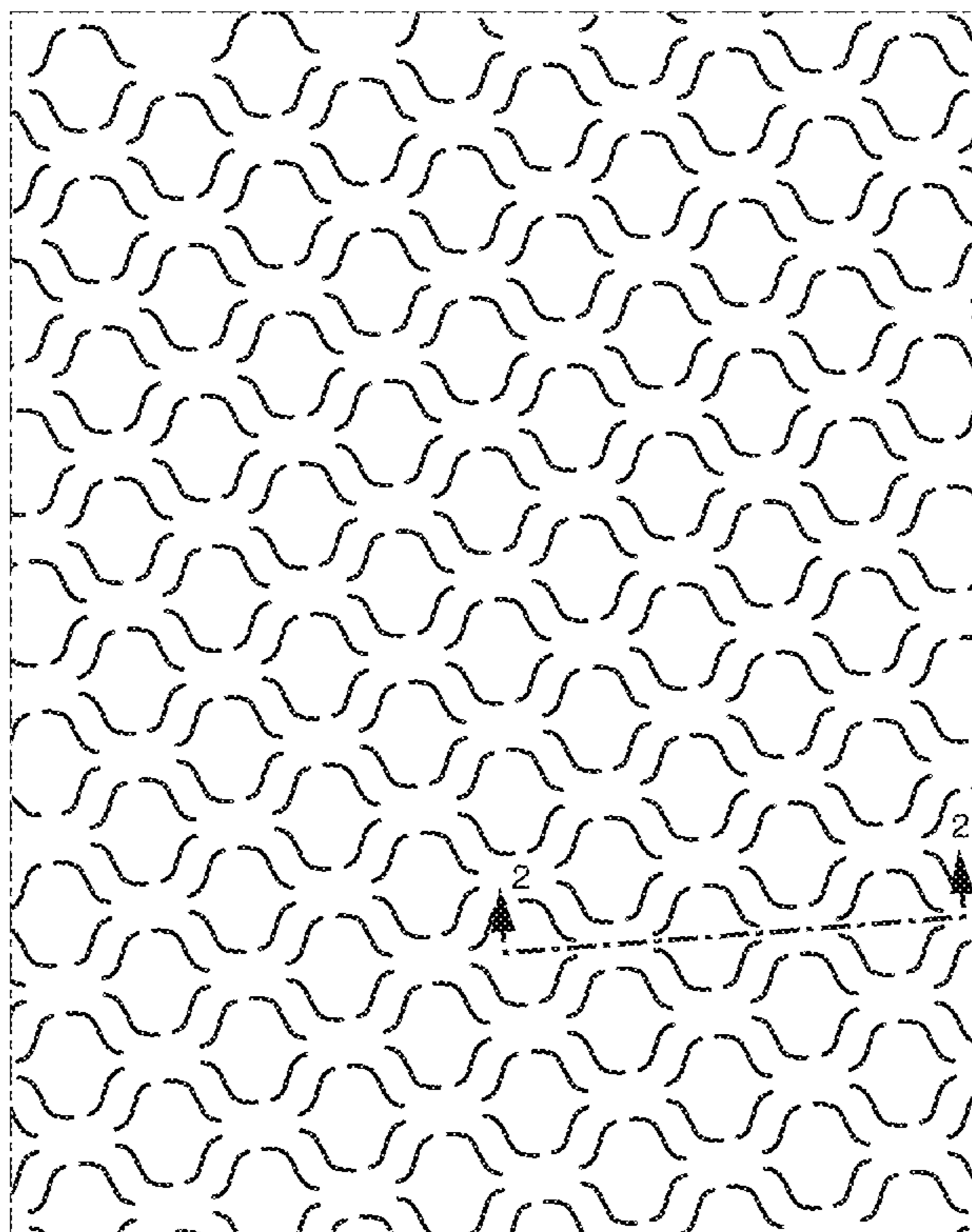
DESCRIPTION

FIG. 1 is a plan view of an embossed tissue sheet showing the claimed design; and,

FIG. 2 is a fragmentary sectional view of the embossed tissue sheet of FIG. 1 taken along line 2-2.

The dash dot dash broken lines surrounding the design and indicating the sectional view area form no part of the claimed design.

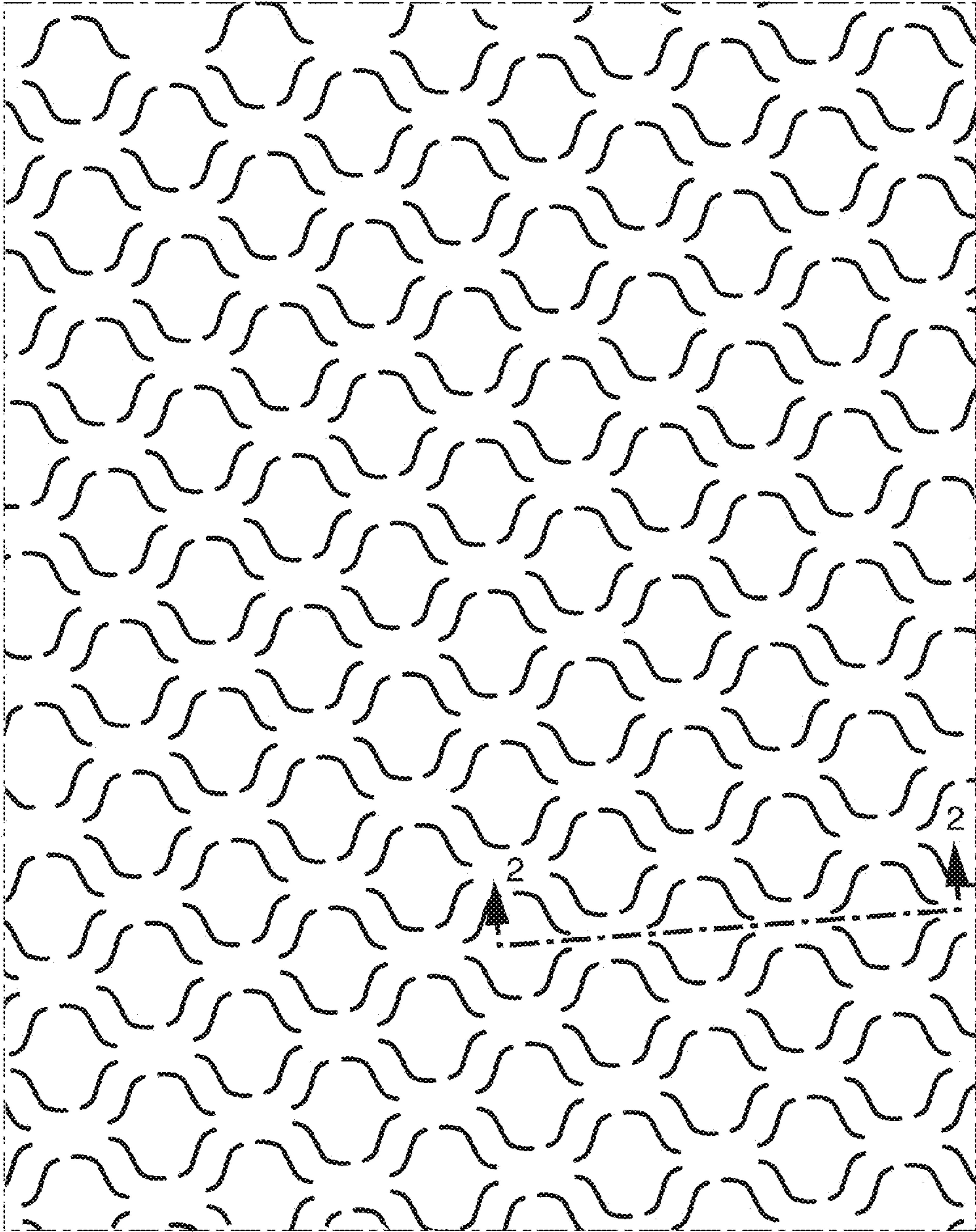
