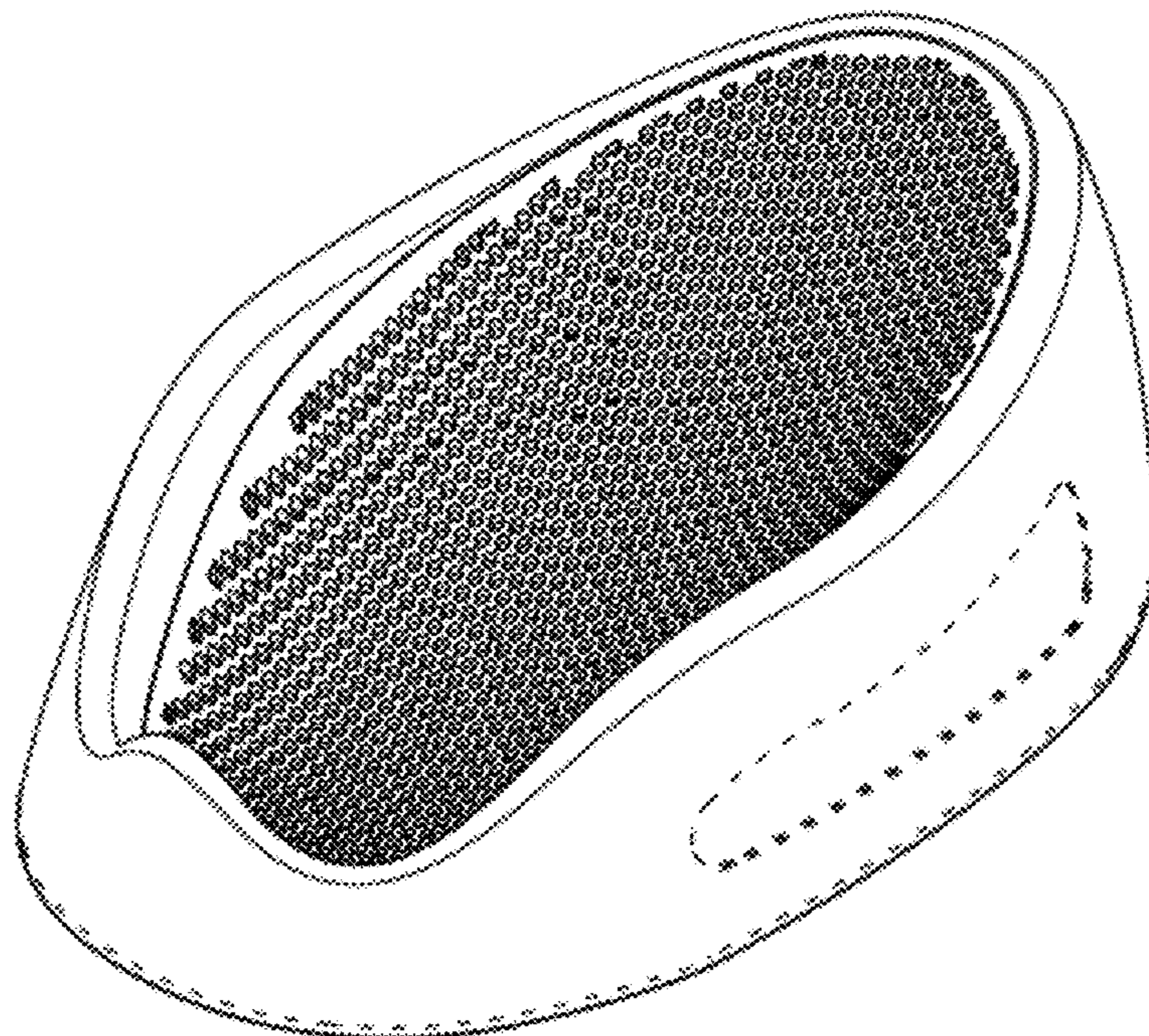
(57) **CLAIM**

The ornamental design for a baby bath support, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the baby bath support in accordance with the present design;
FIG. 2 is a left side view of the baby bath support of FIG. 1, the right side view being a mirror image thereof;
FIG. 3 is a front view of the baby bath support of FIG. 1;
FIG. 4 is a rear view of the baby bath support of FIG. 1;
FIG. 5 is a top view of a baby bath support of FIG. 1; and,
FIG. 6 is a bottom view of the baby bath support of FIG. 1.

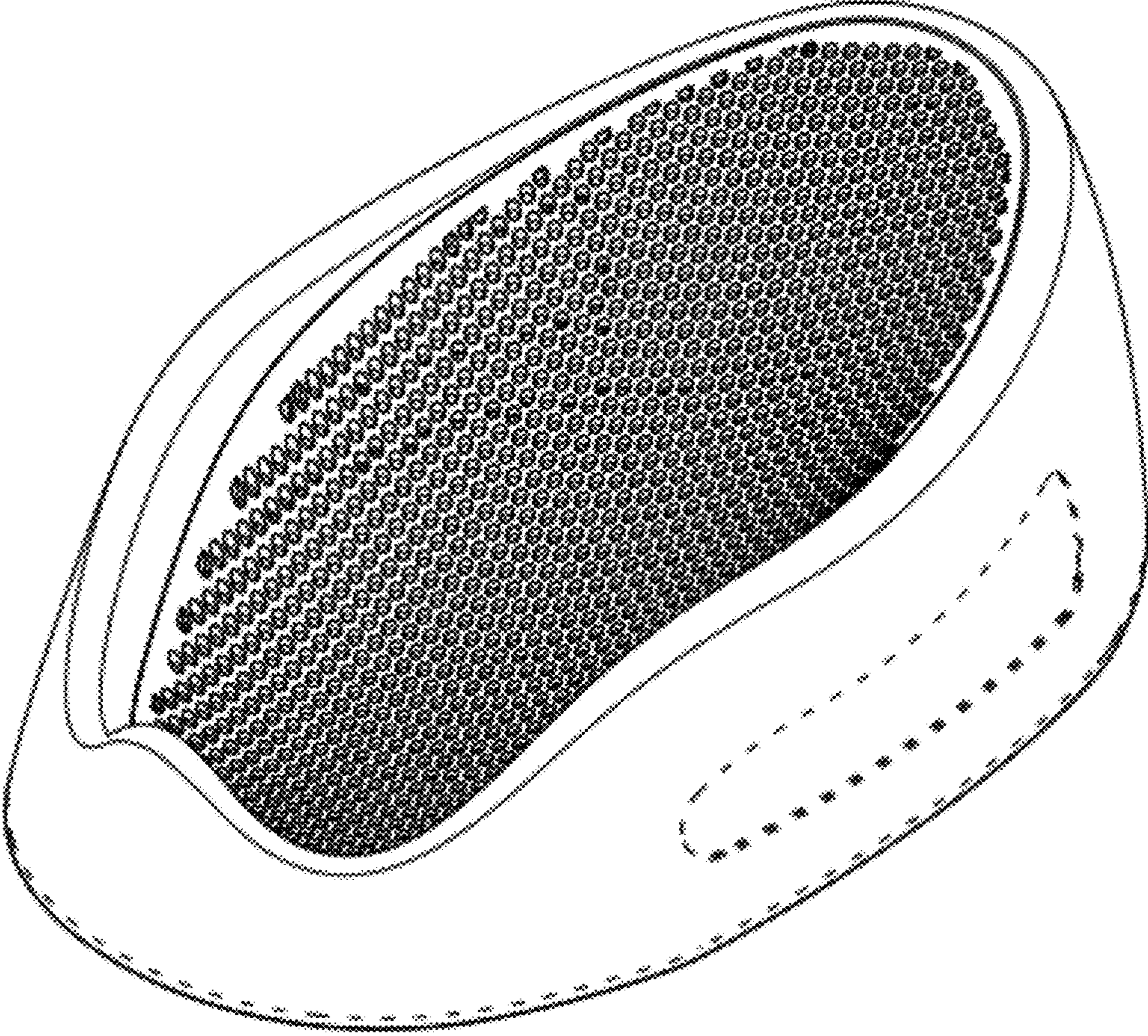

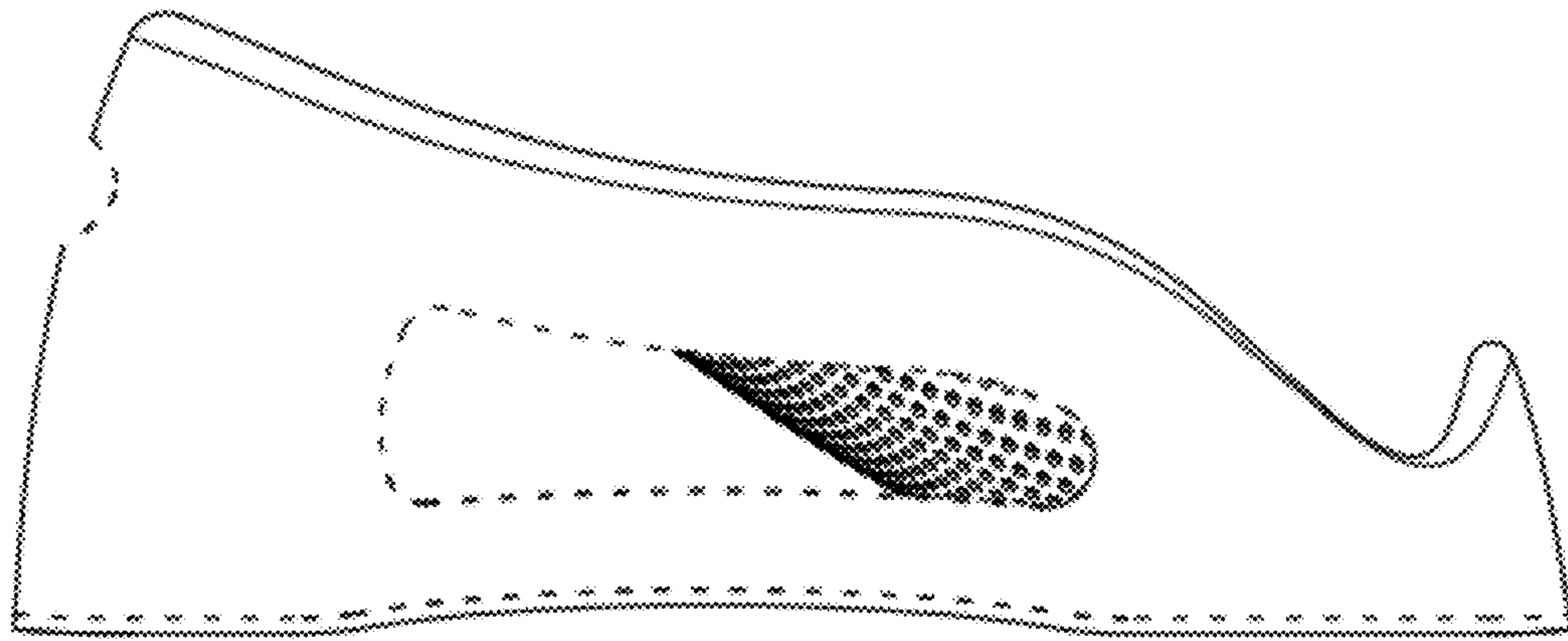

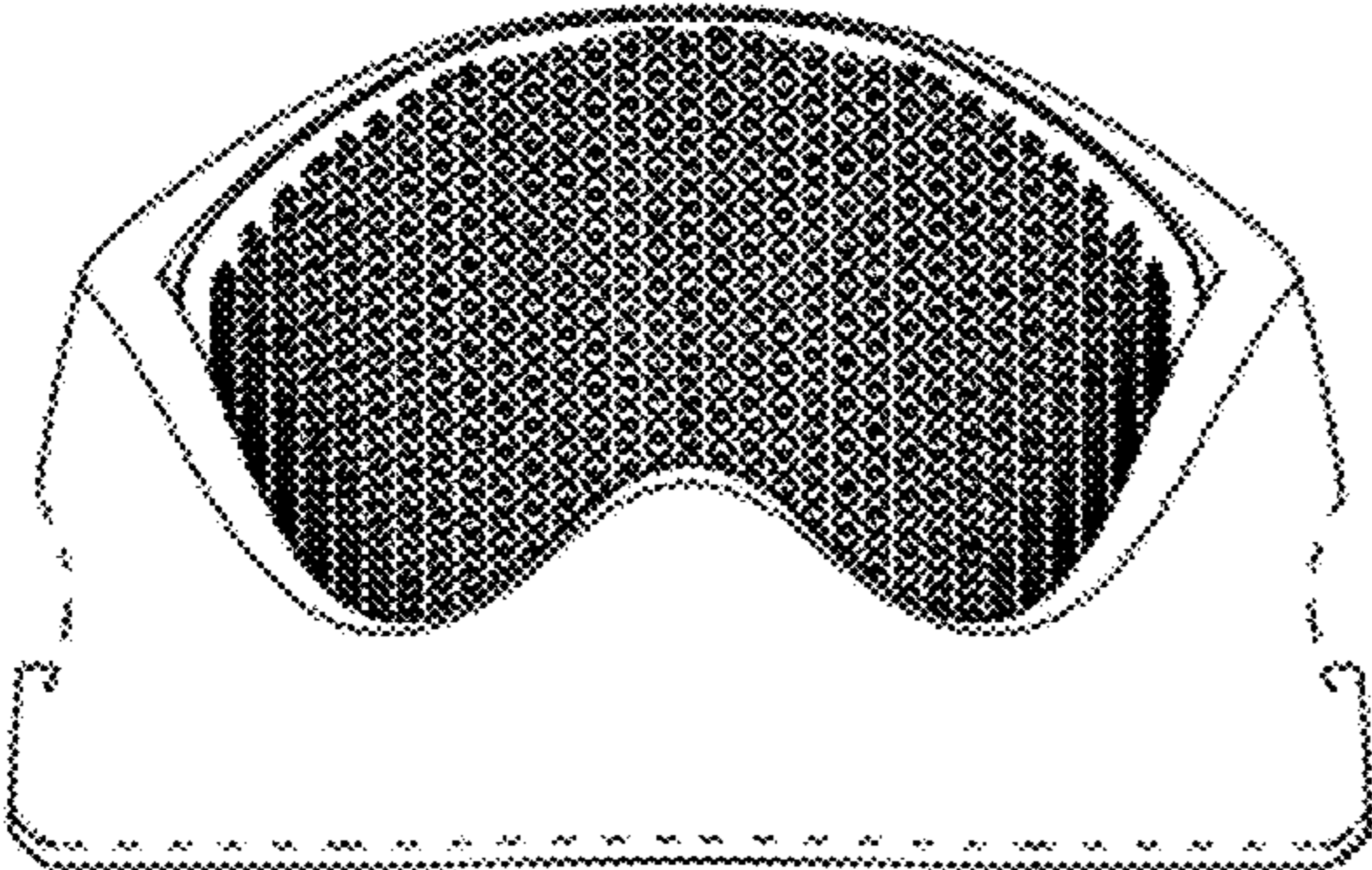

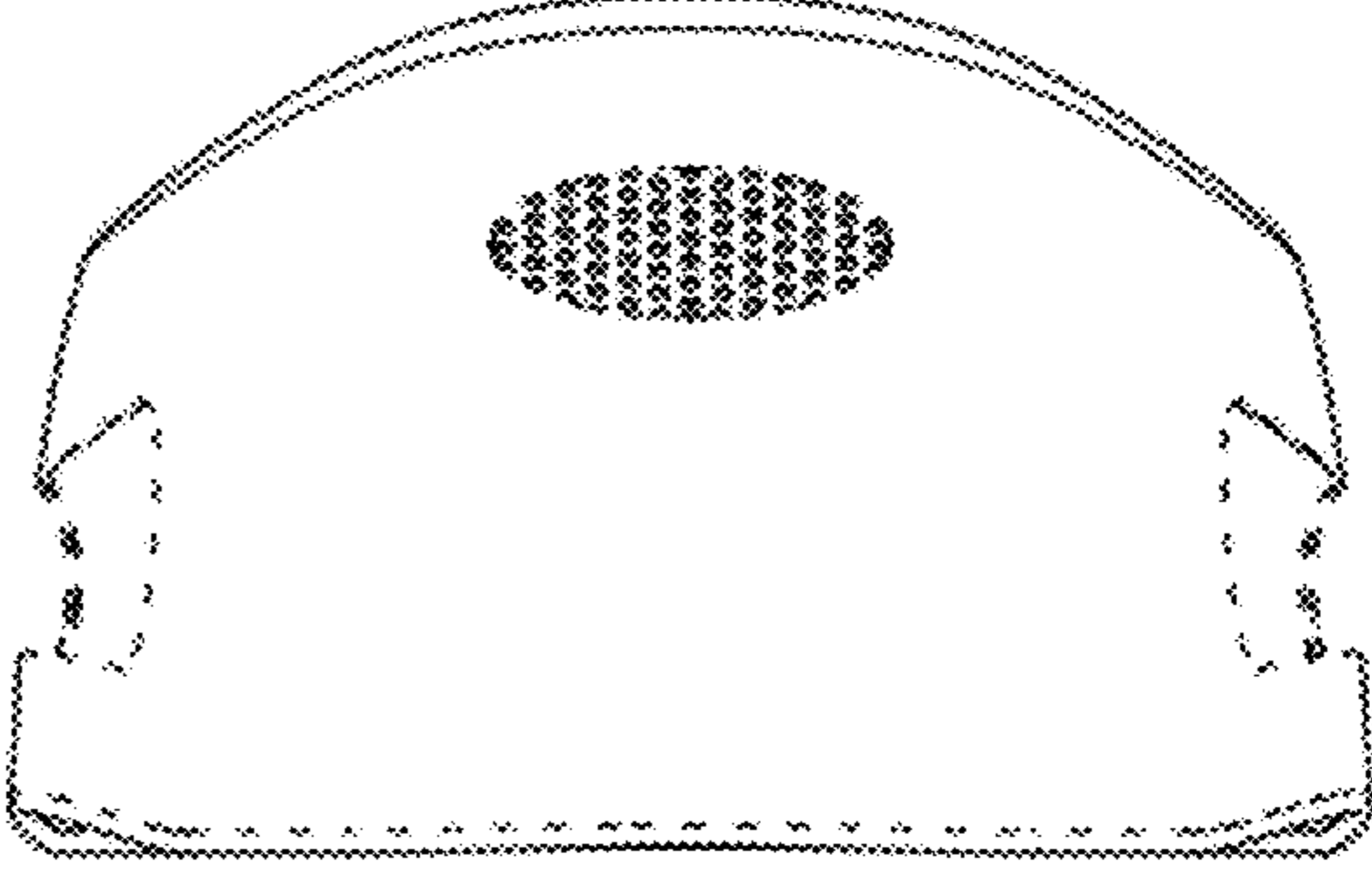

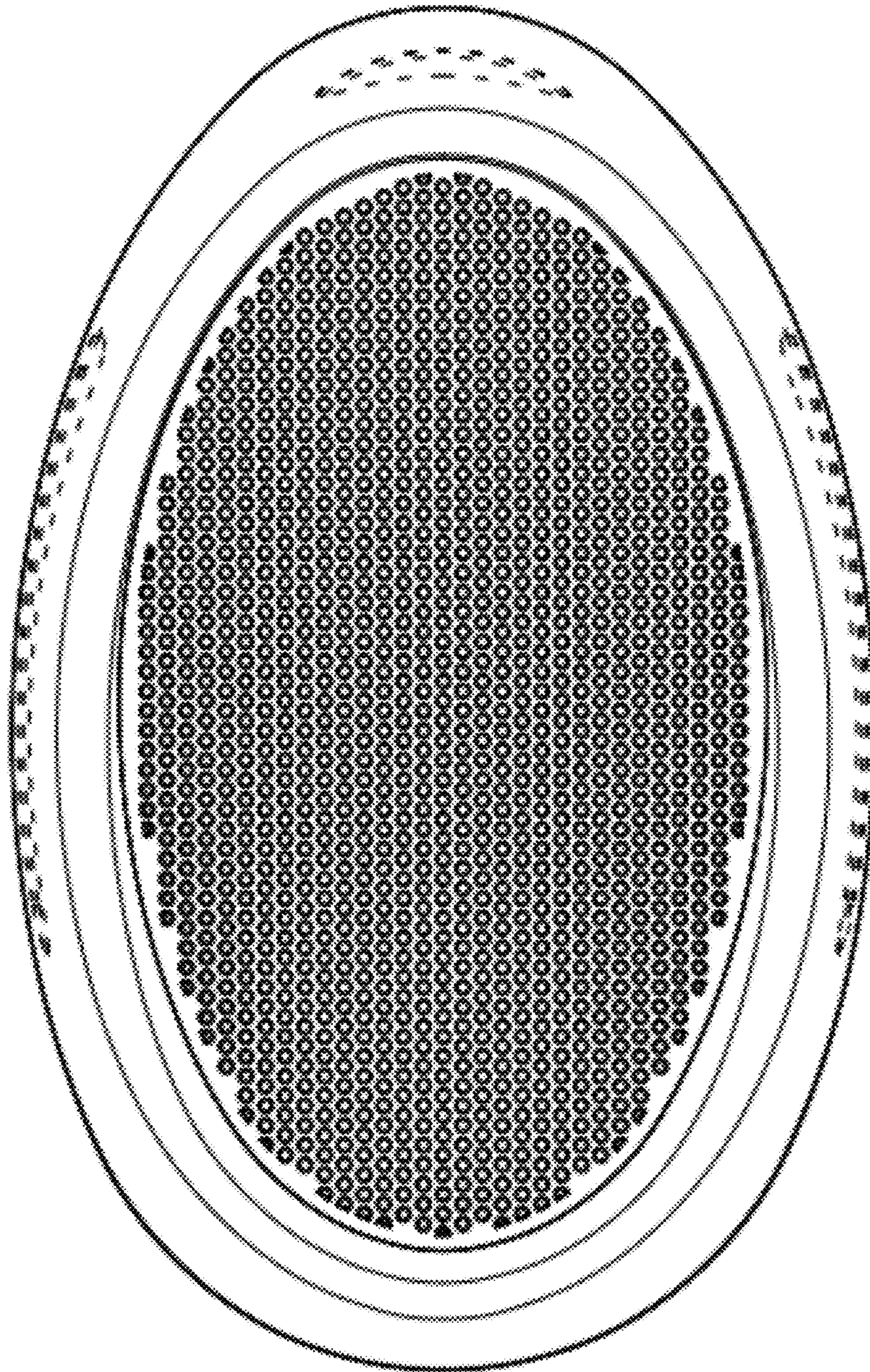

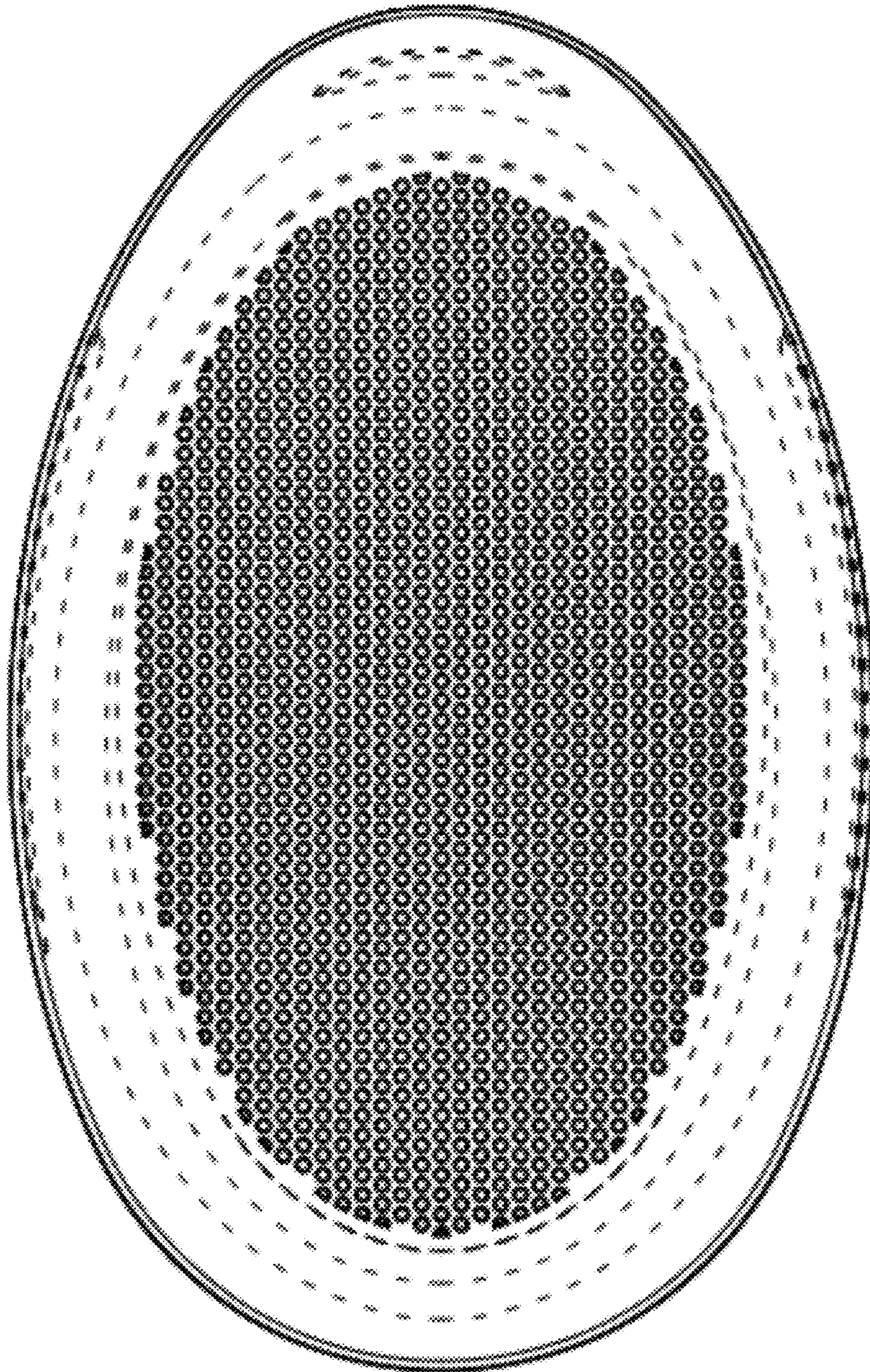
