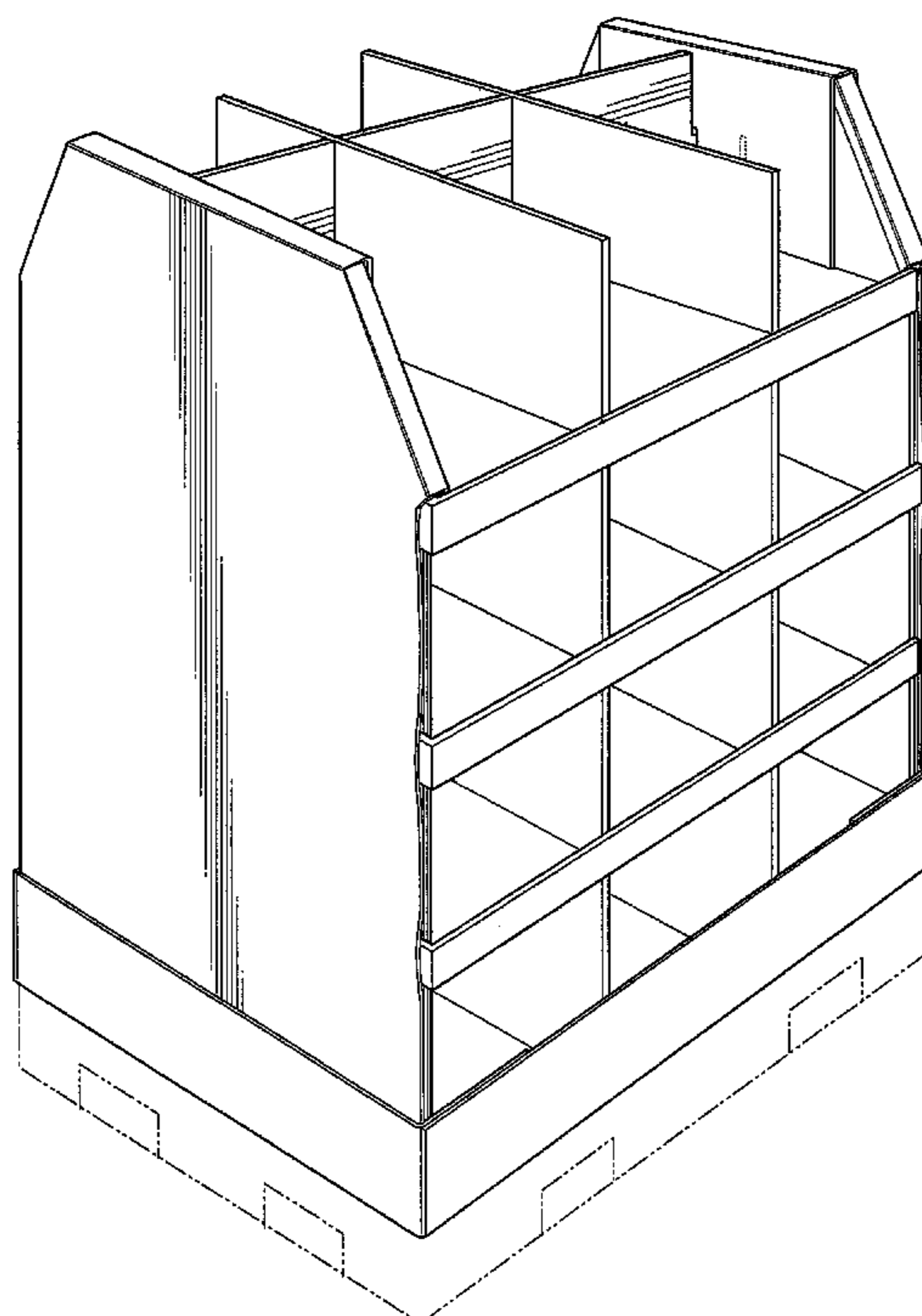
(57) **CLAIM**

The ornamental design for a structurally supporting shipping and display packaging assembly, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the present design; FIG. 2 is a front plan view, a corresponding rear view being a mirror image thereof; FIG. 3 is a right side view, a corresponding left side view being a mirror image thereof; FIG. 4 is a top view; and, FIG. 5 is a bottom view. The broken lines are for the purpose of illustrating the environment of the design only and form no part of the claimed design.

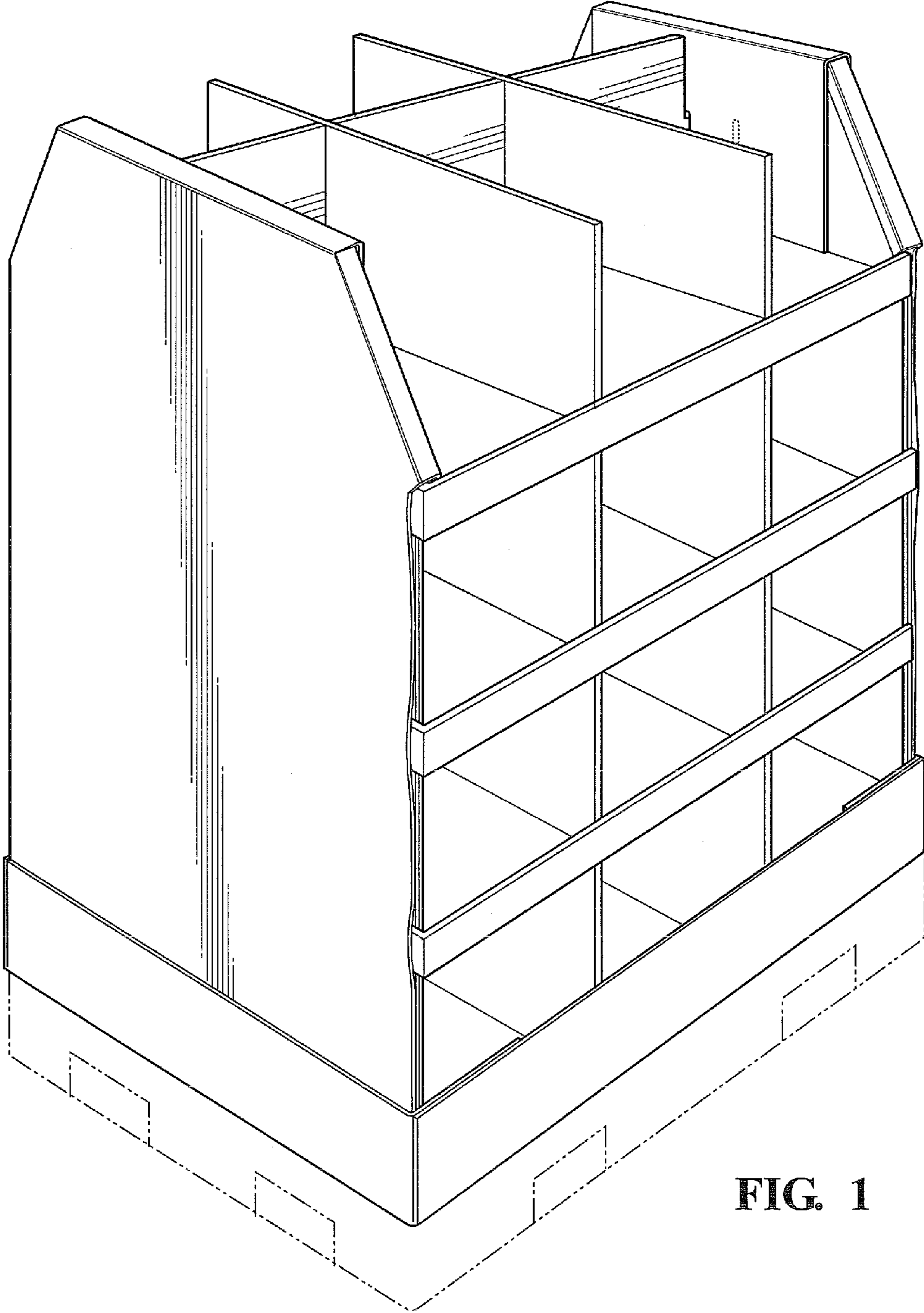

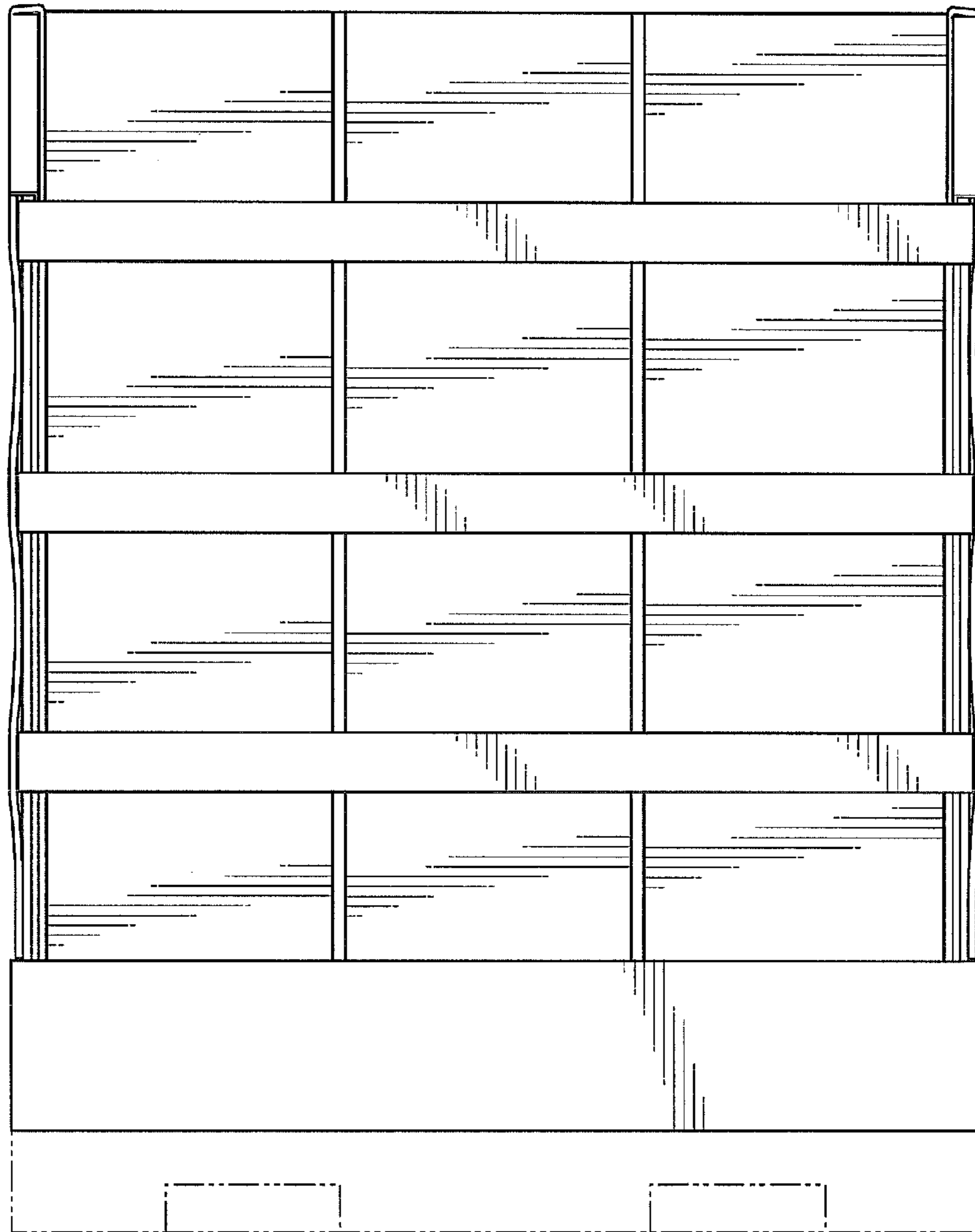

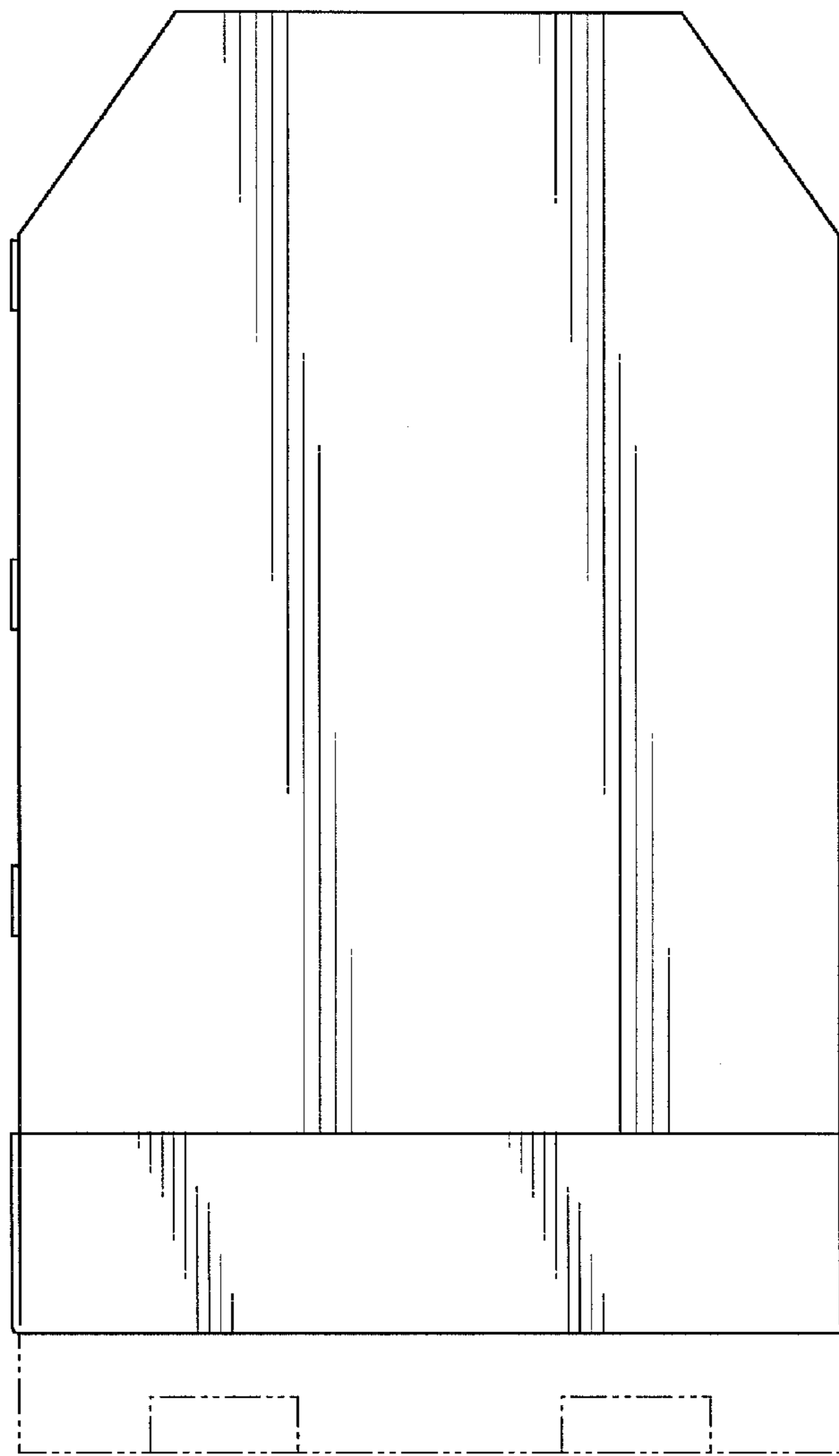

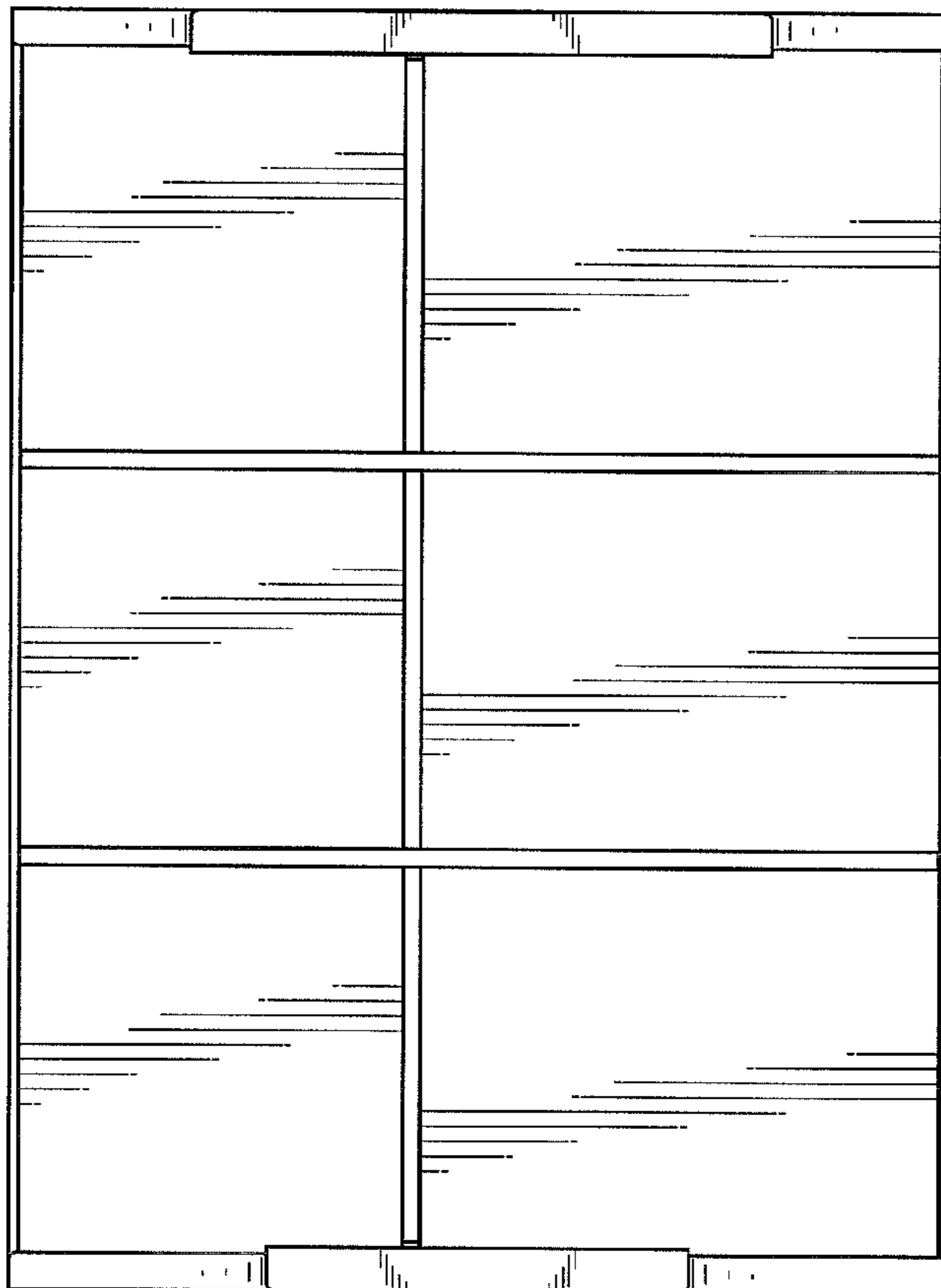

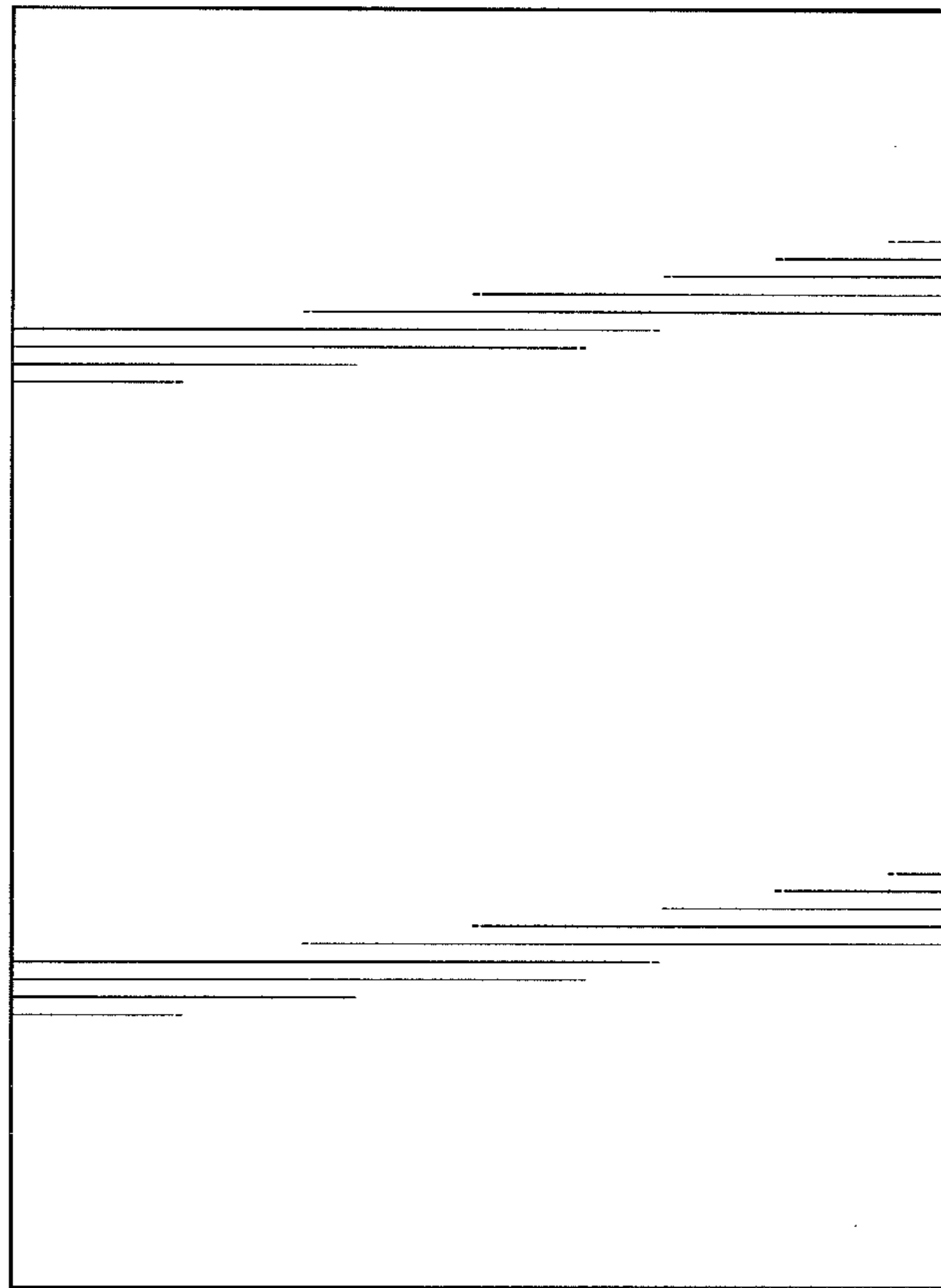
