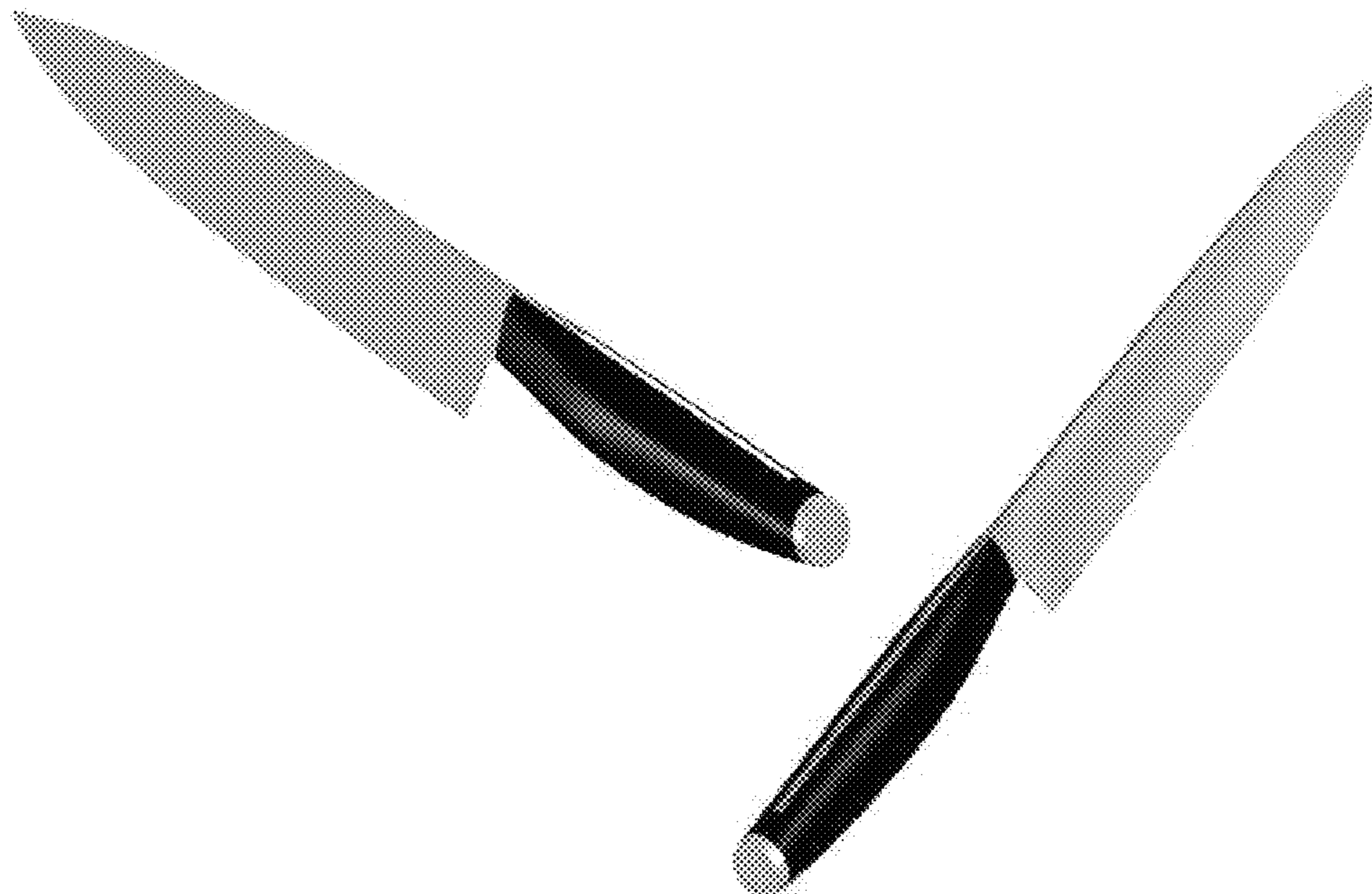
(57) **CLAIM**

The ornamental design for a knife, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a left side of a knife according to the invention from above a handle end thereof;  
FIG. 2 is a perspective view of a right side of the knife of FIG. 1 from above the handle end thereof;  
FIG. 3 is a side elevational view of the left side of the knife of FIG. 1, the opposite side being a mirror image thereof;  
FIG. 4 is a perspective view of the left side of the knife of FIG. 1 from above a blade end thereof; and,  
FIG. 5 is a perspective view of the left side of the knife of FIG. 2 rotated blade-upwards from above a handle end thereof.

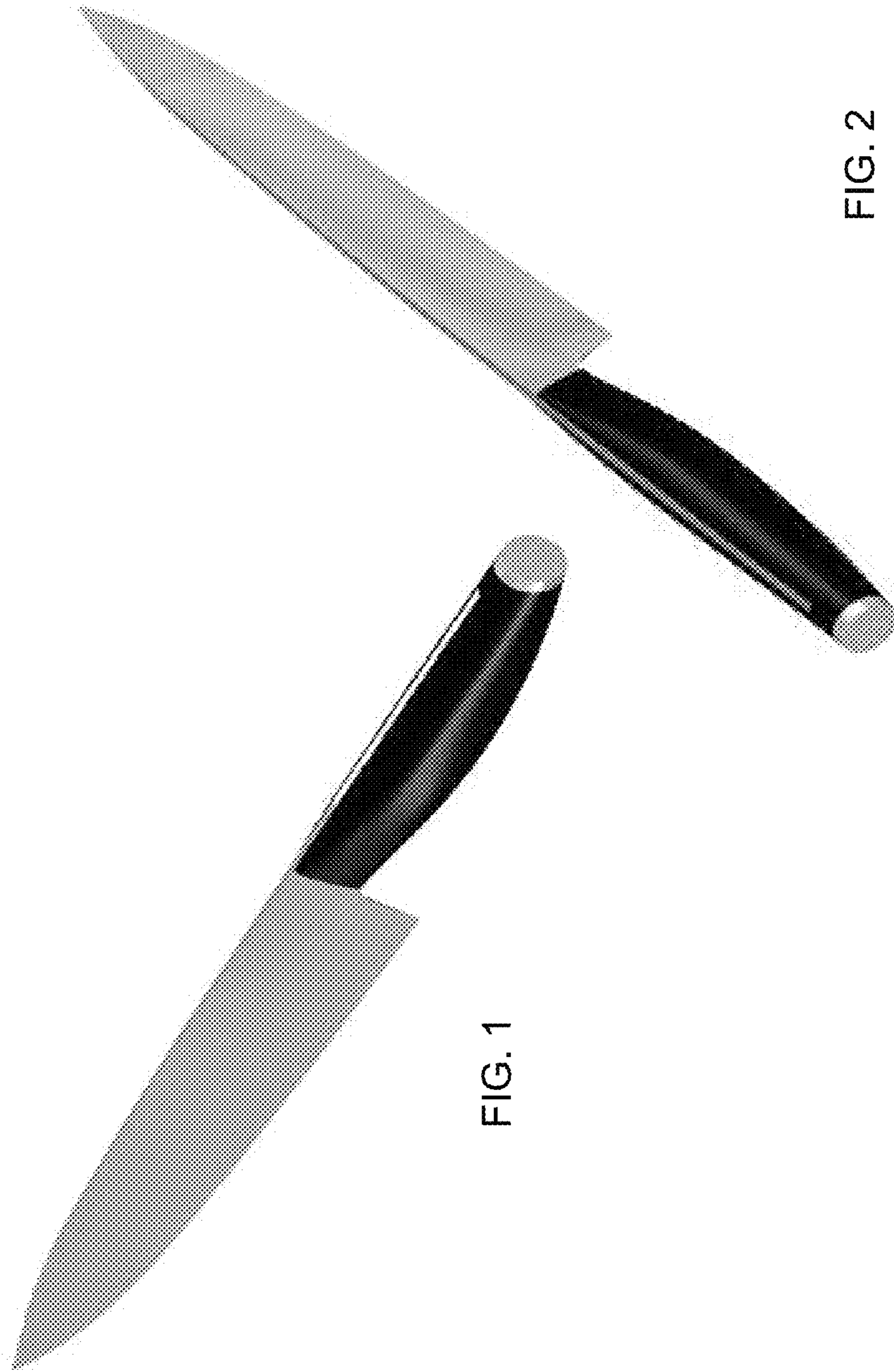

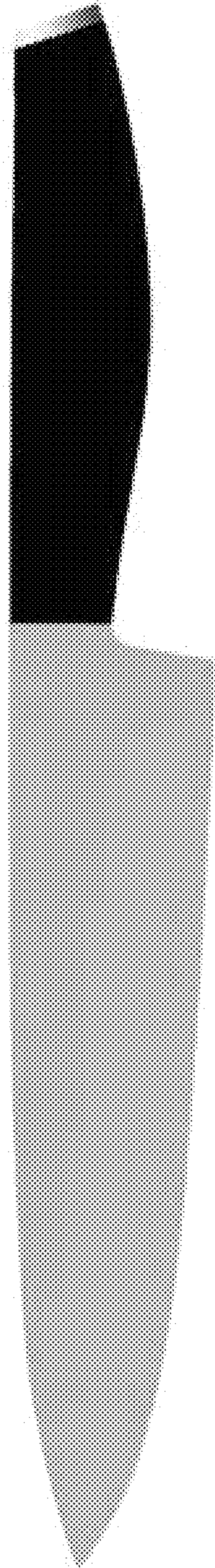

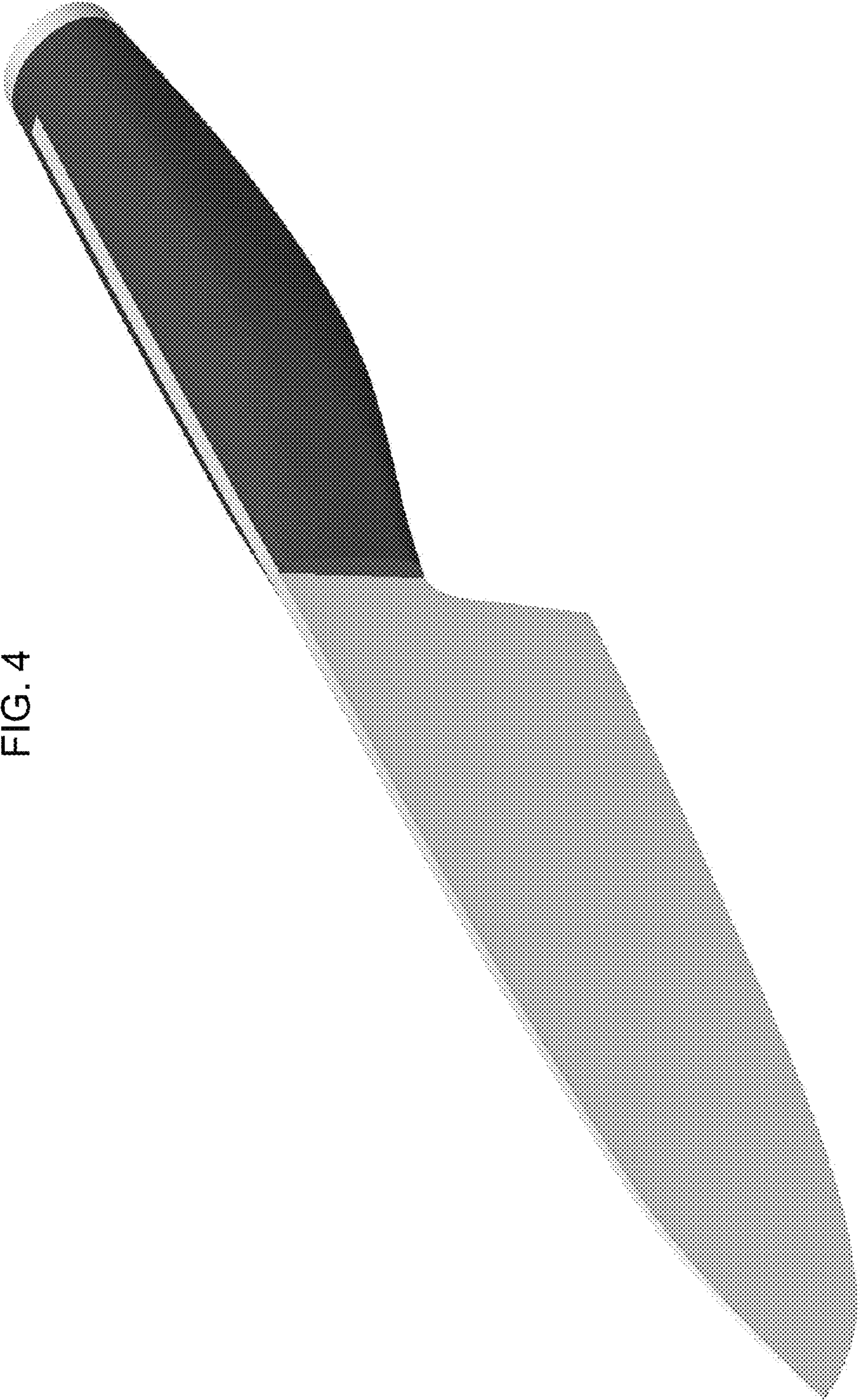

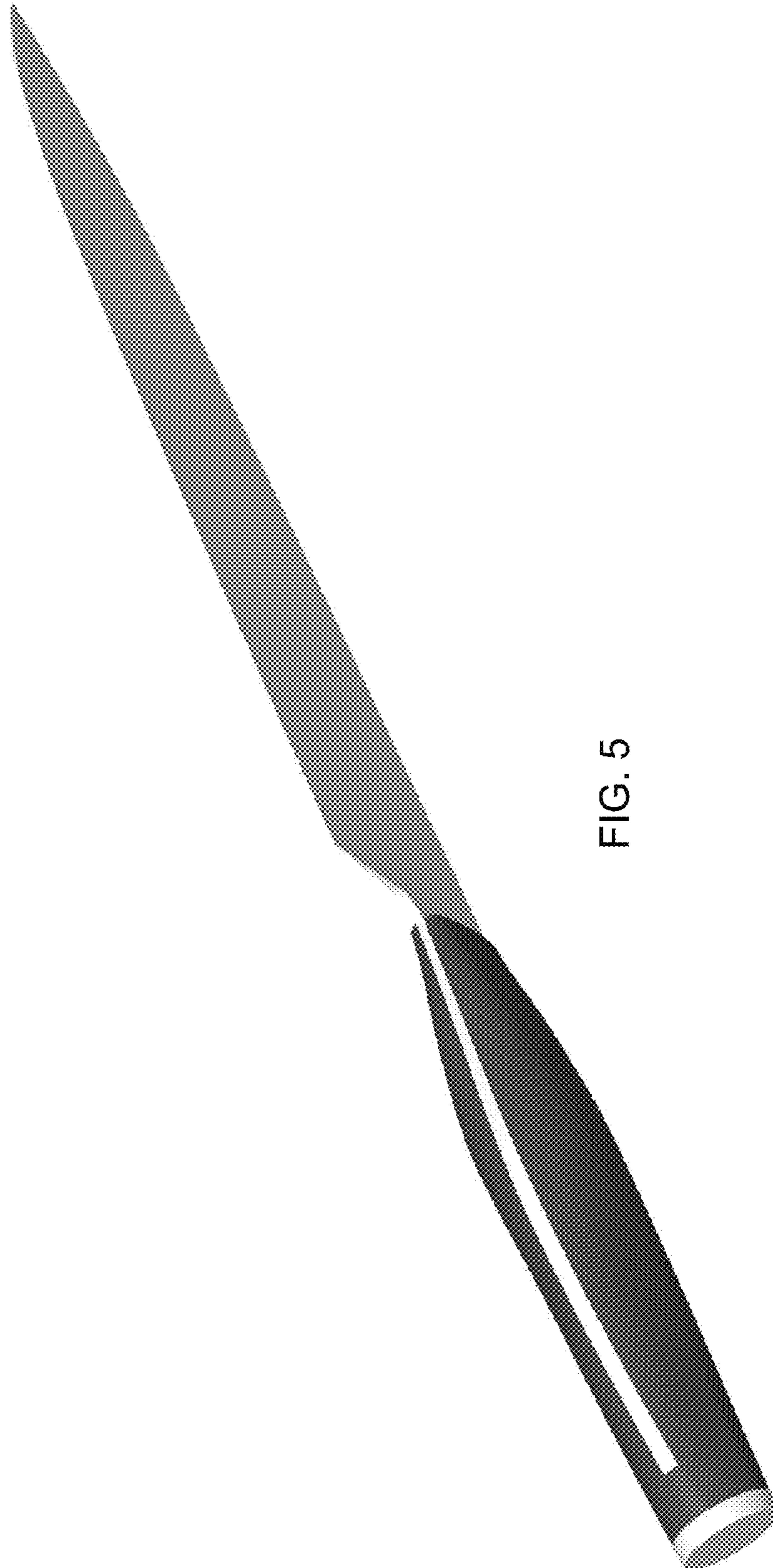
