(57) **CLAIM**

The ornamental design for silicone caulk smoother, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view from the front of a silicone caulk smoother according to an embodiment of the present invention.

FIG. 2 is a front view of the silicone caulk smoother shown in FIG. 1.

FIG. 3 is a back view of the silicone caulk smoother shown in FIG. 1.

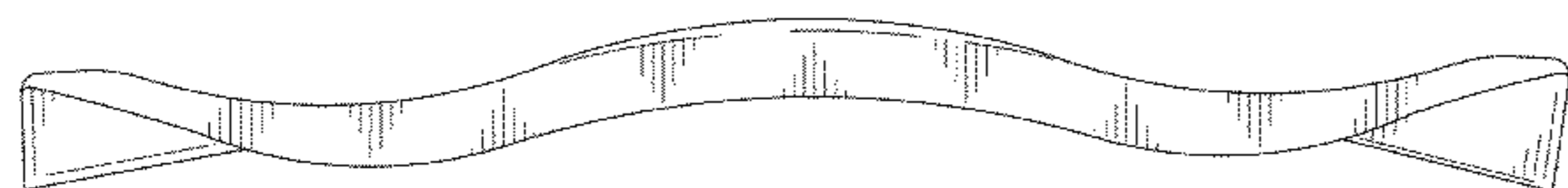
FIG. 4 is a left hand side view of the silicone caulk smoother shown in FIG. 1.

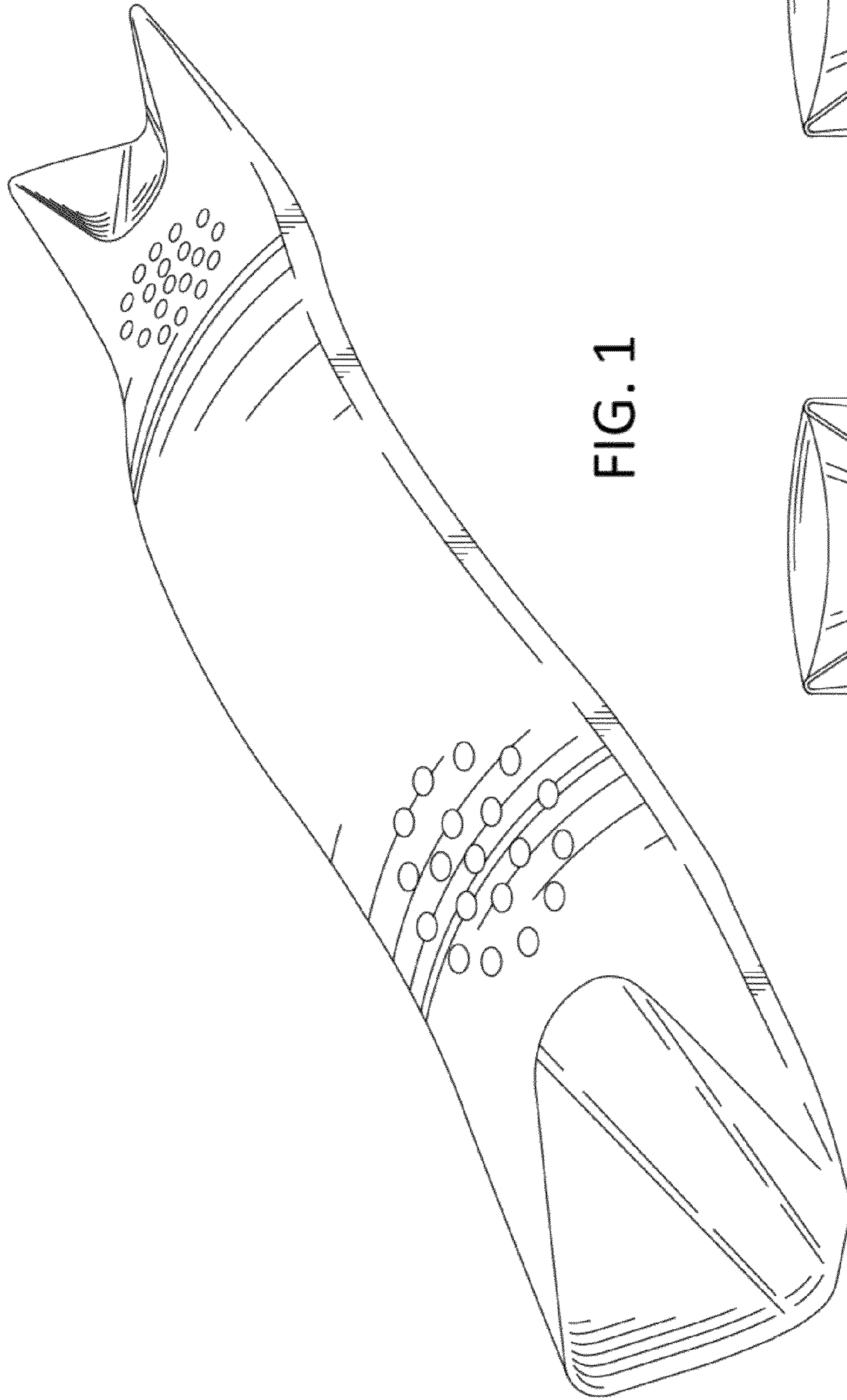

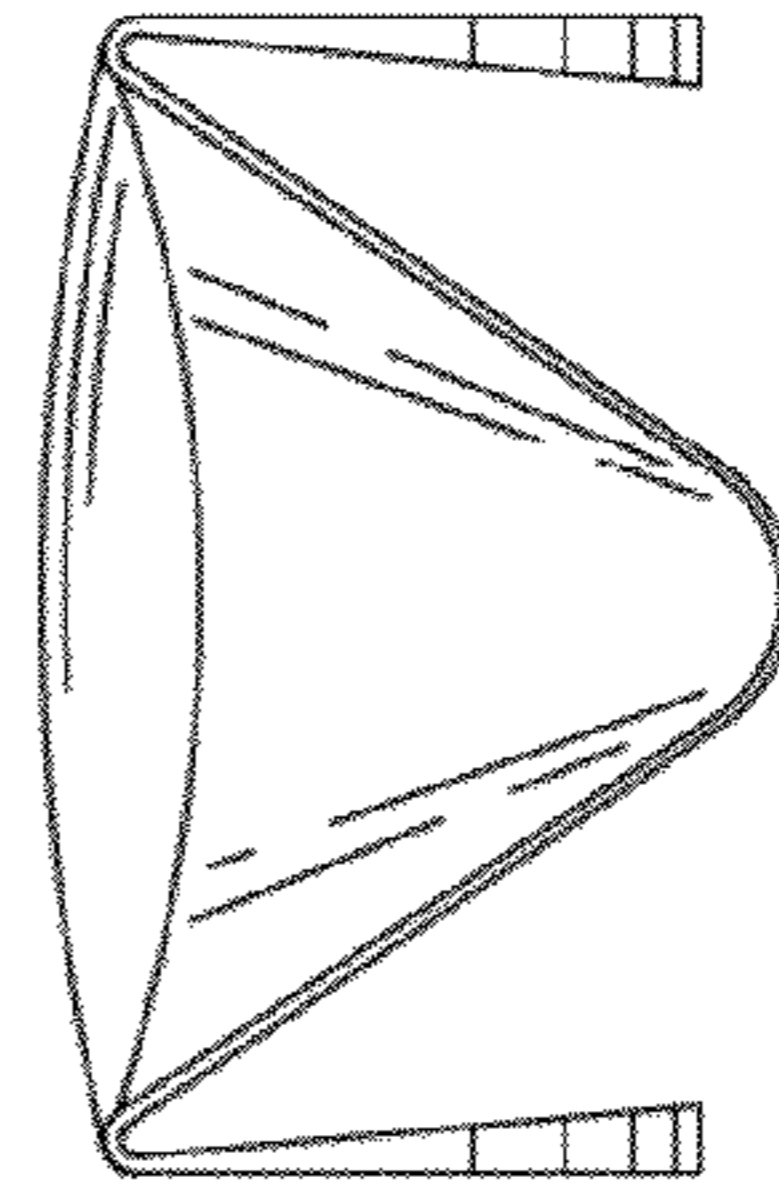

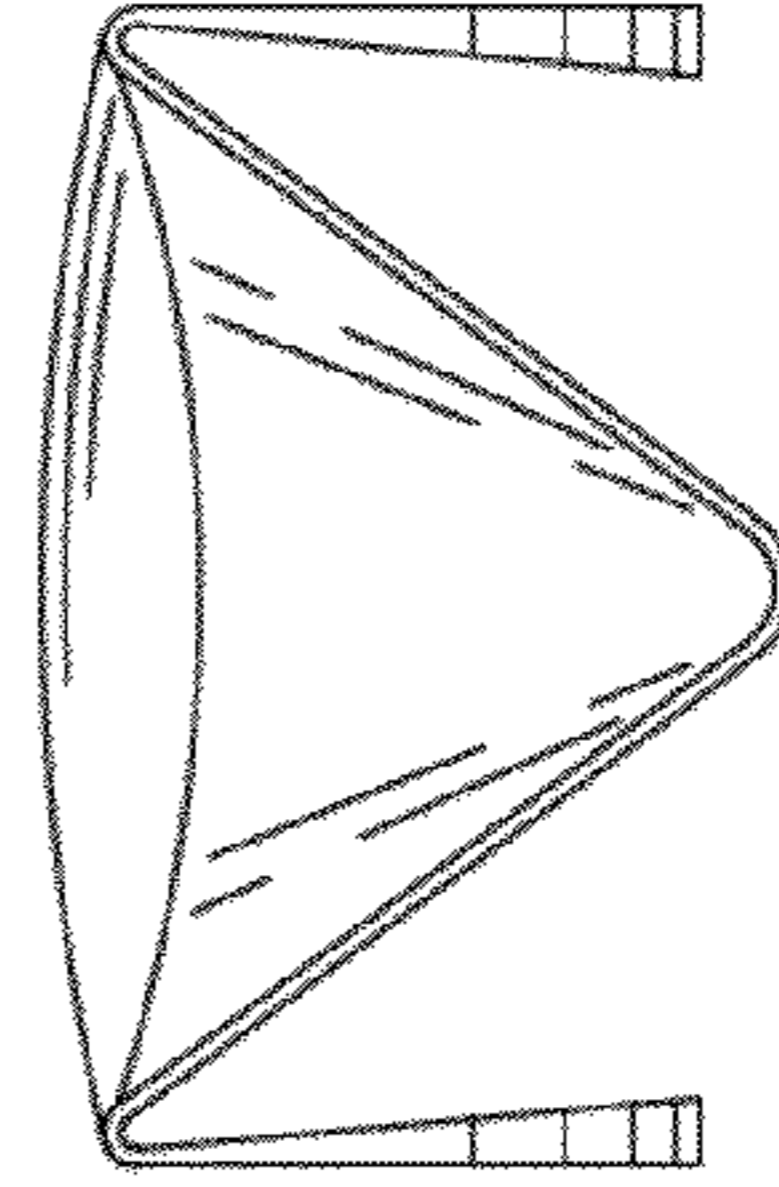

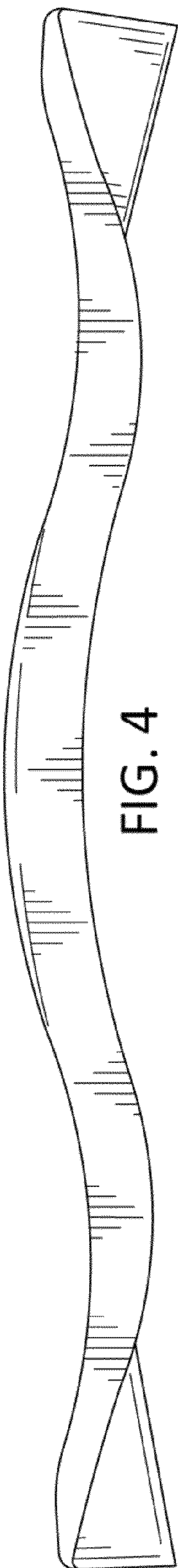

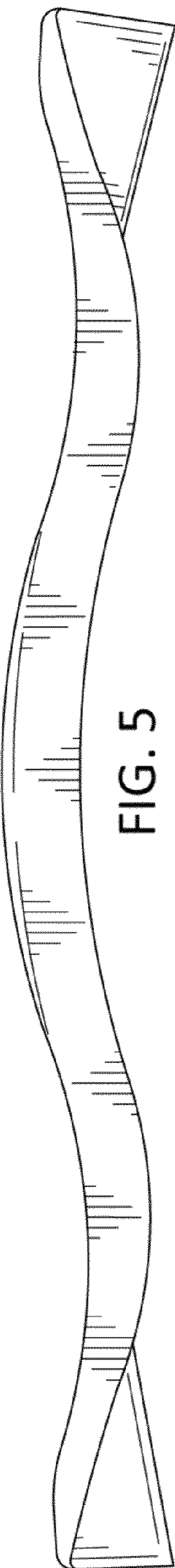

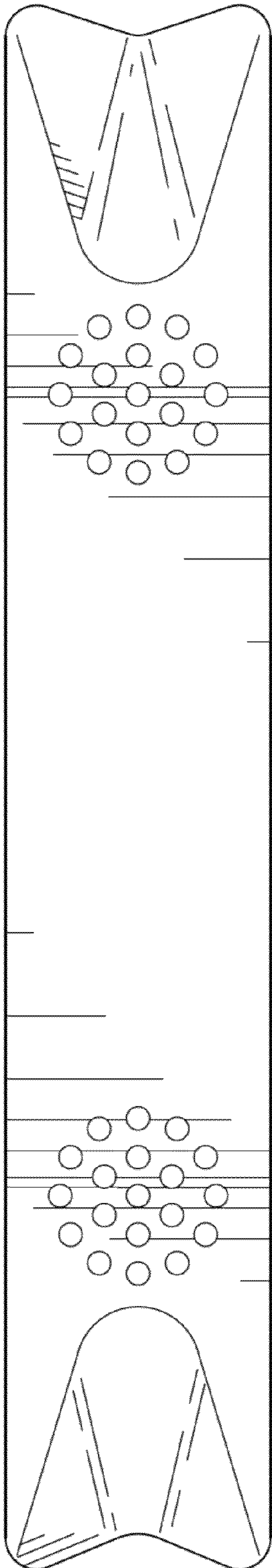

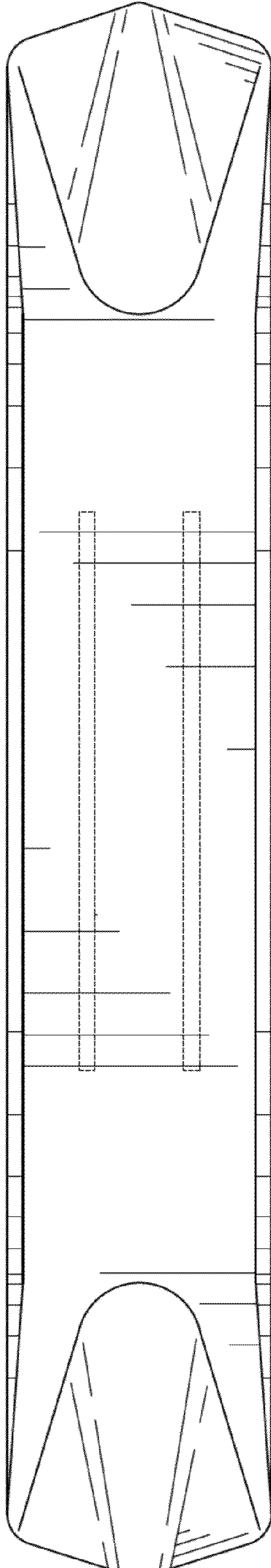
