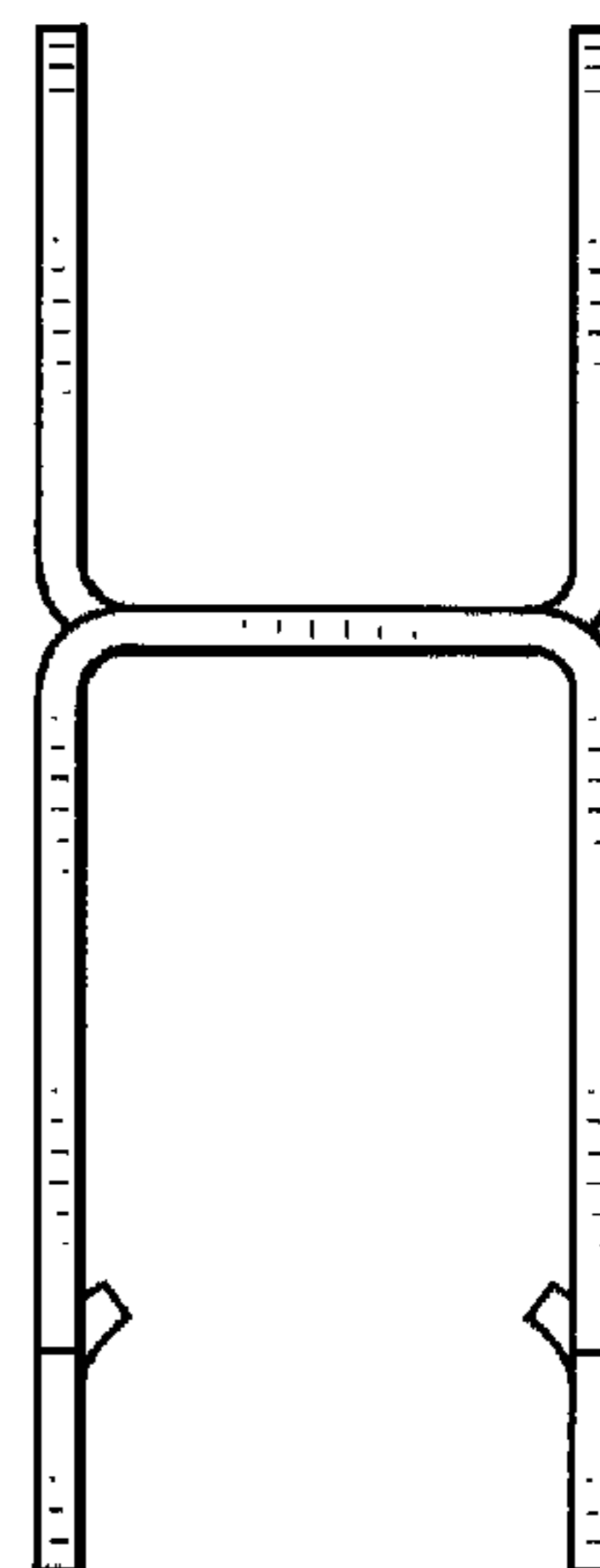
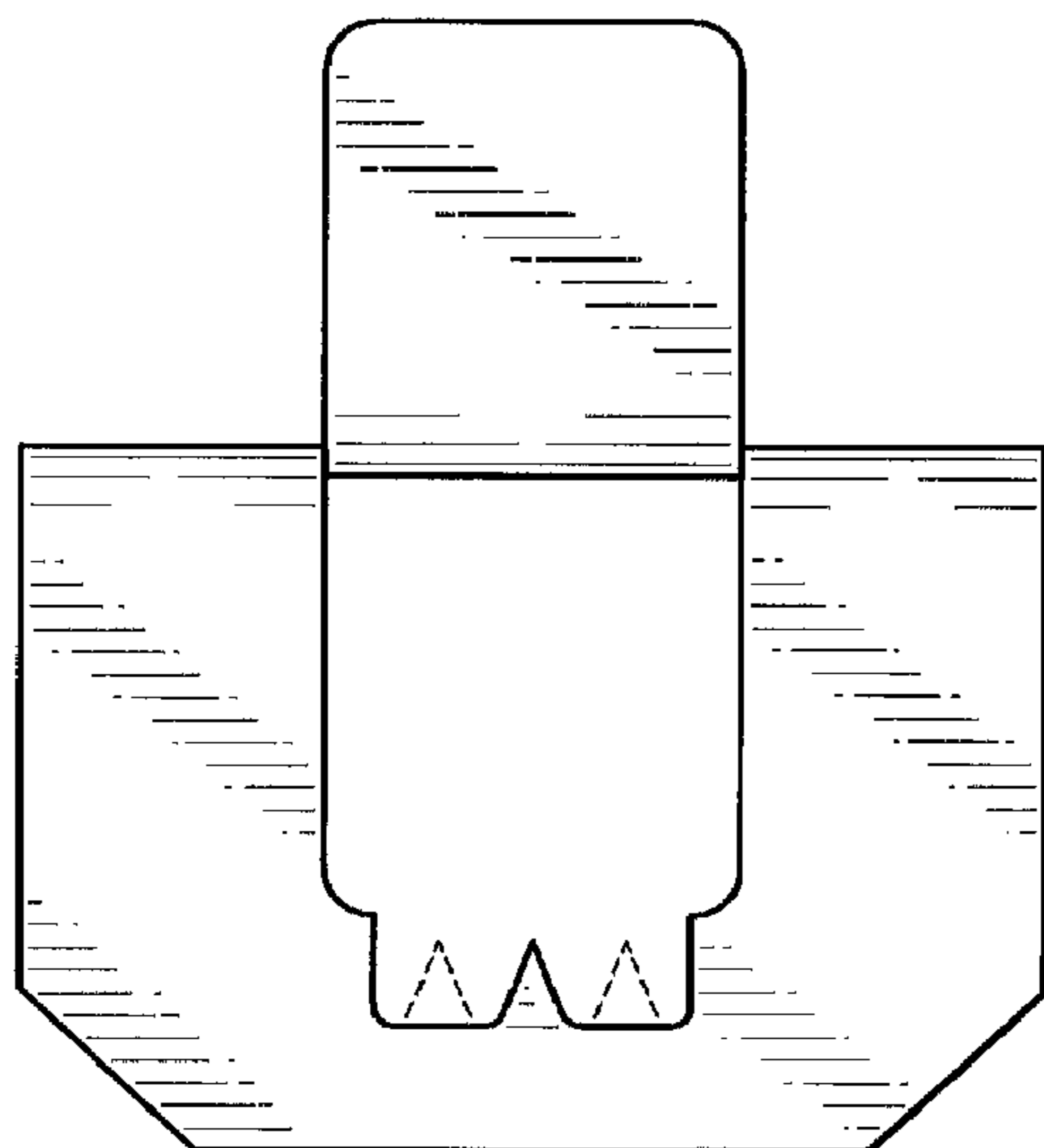
(57) **CLAIM**

The ornamental design for a plywood clip for use in roofing, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the plywood clip of the present invention which also serves as a rear elevational view. FIG. 2 is a side elevational view of the plywood clip which serves both as a left side elevational view and a right side elevational view. FIG. 3 is a top plan view of the plywood clip; and, FIG. 4 is a bottom plan view of the plywood clip. The broken lines represent portions of the article and form no part of the claimed design.

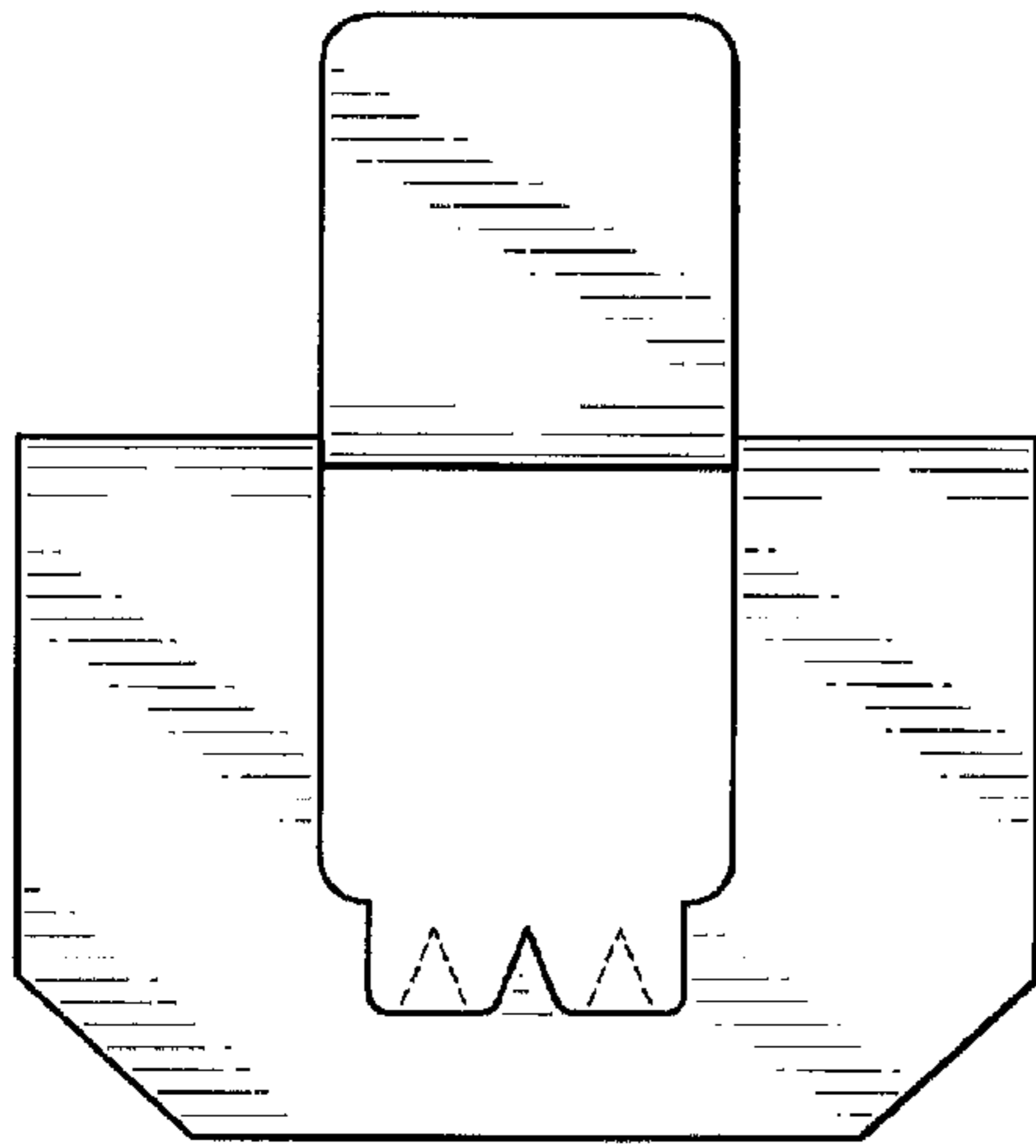

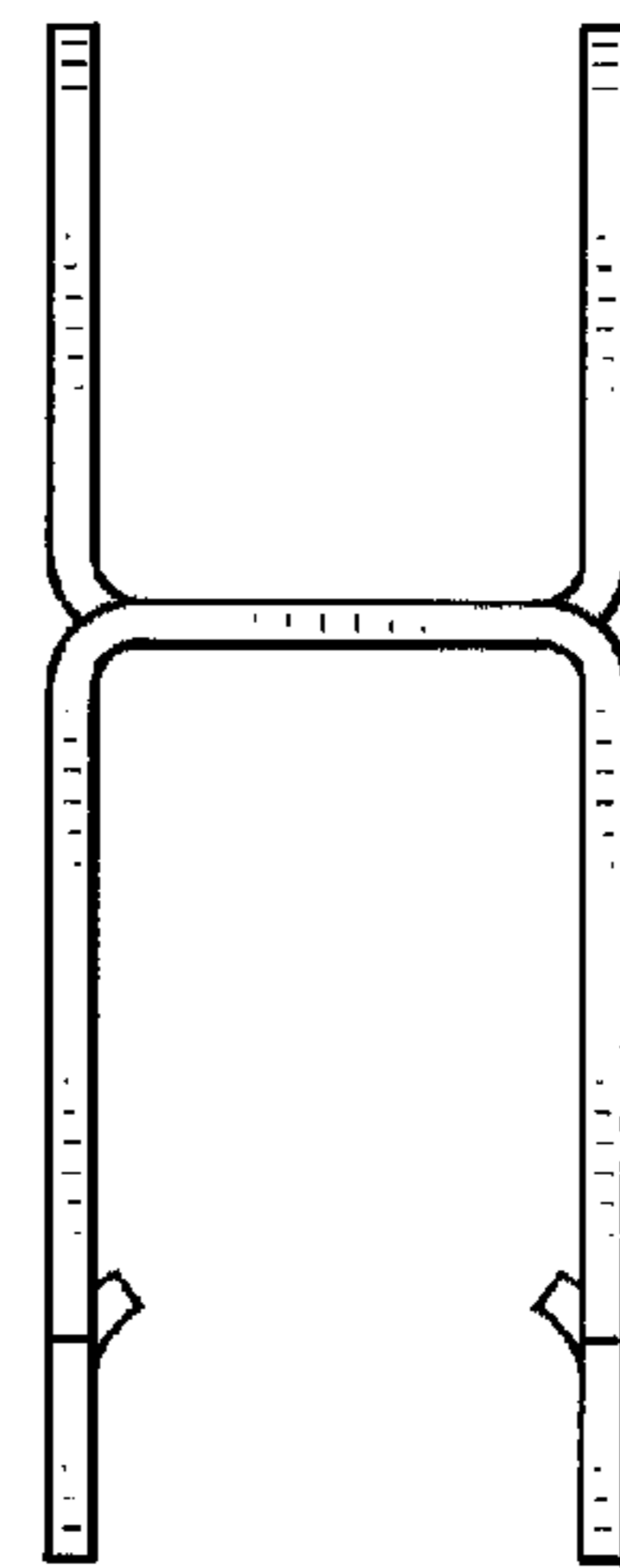

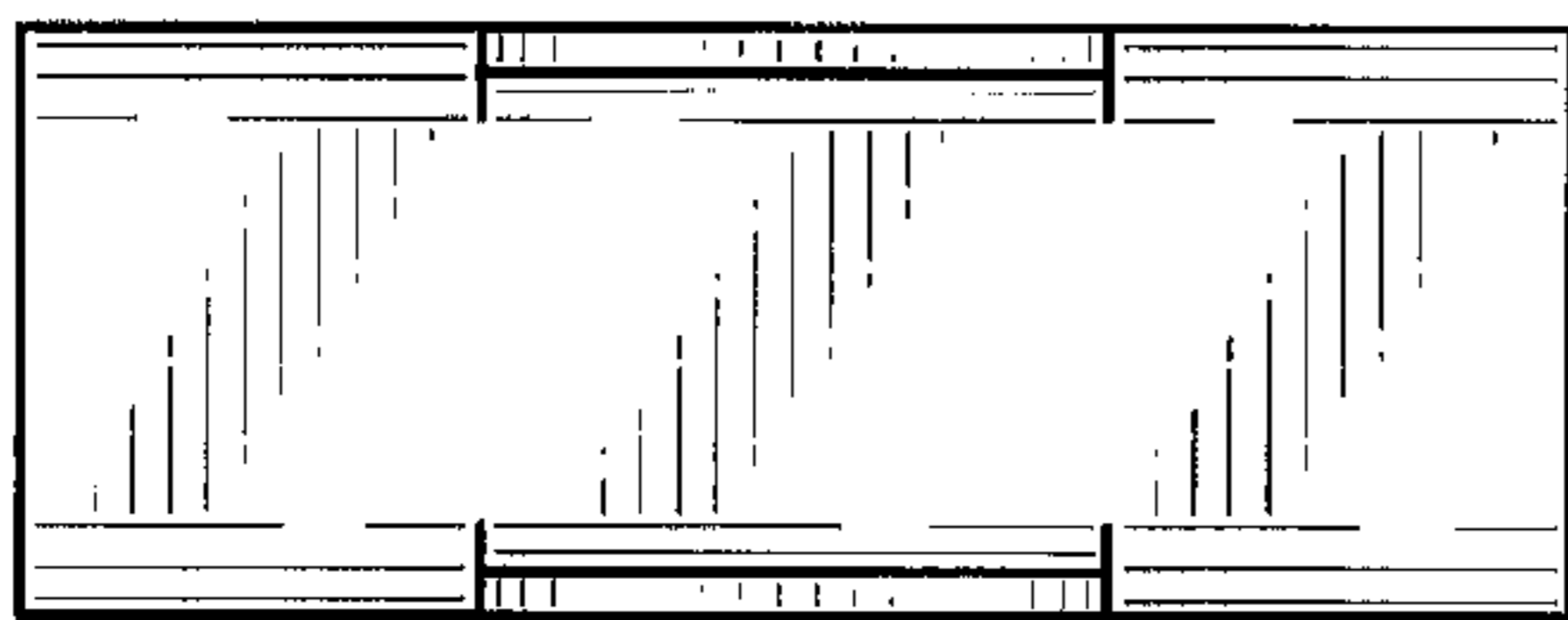

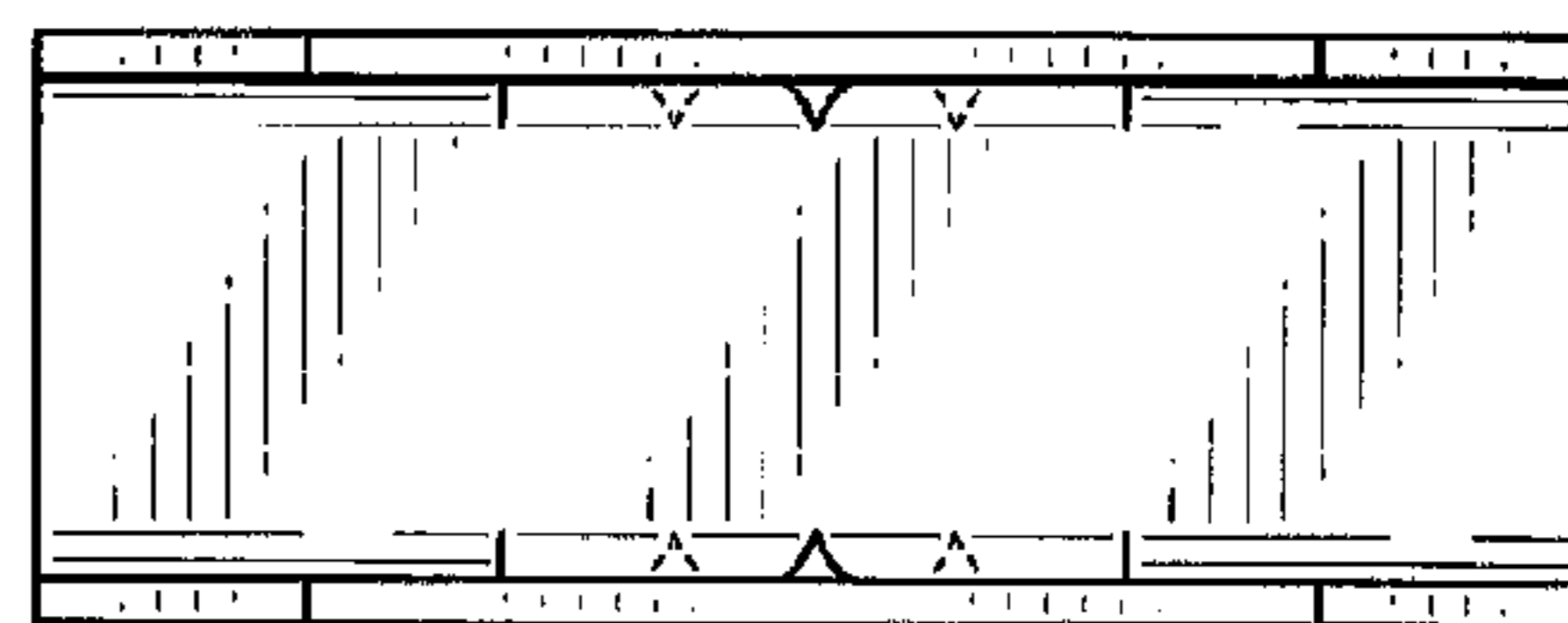
