(57) **CLAIM**

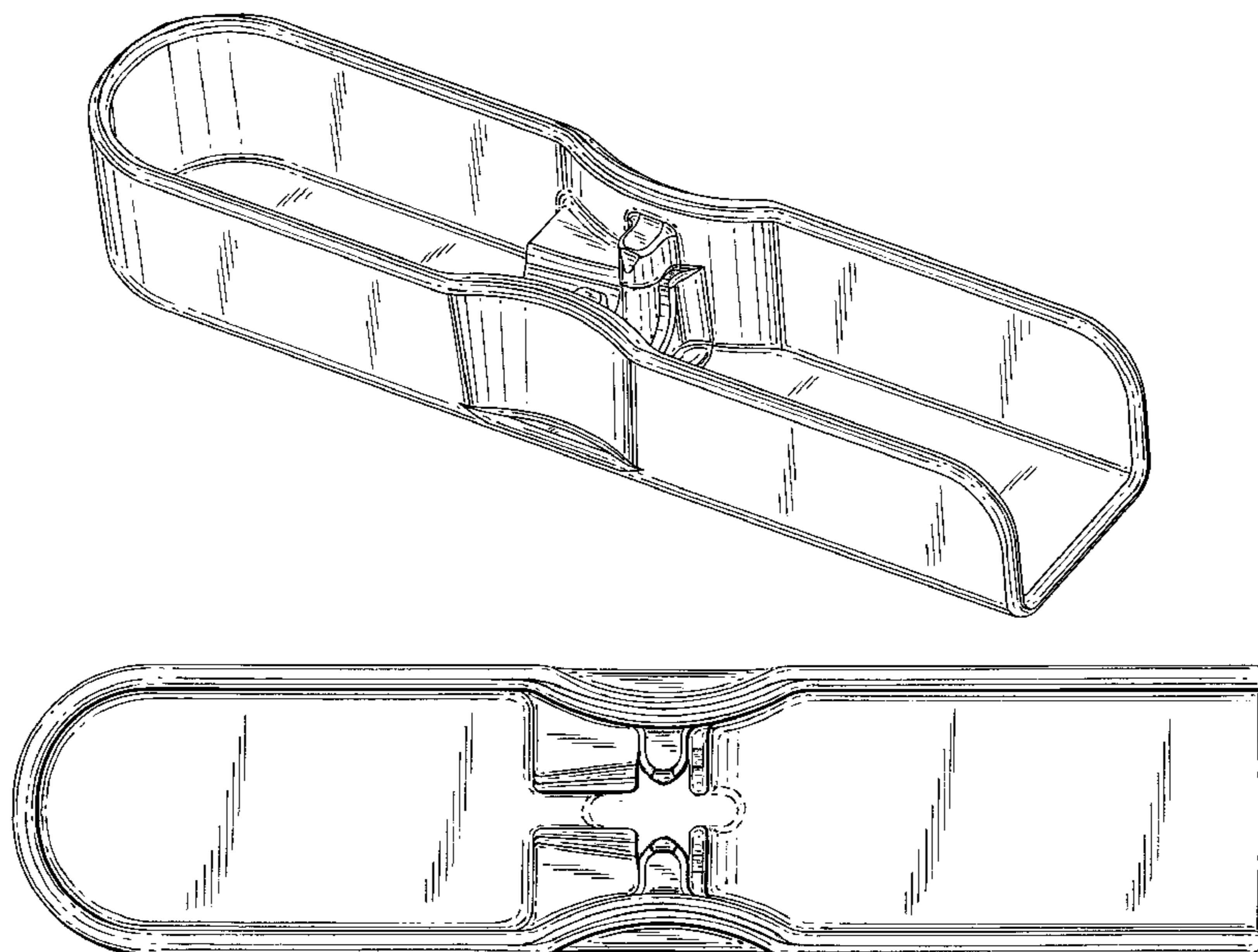
The ornamental design for an open packaging for surgical blade tips, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of an open packaging for surgical blade tips;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a right elevational view thereof;  
FIG. 4 is a front elevational view thereof;  
FIG. 5 is a rear elevational view thereof;  
FIG. 6 is a left elevational view thereof; and,  
FIG. 7 is a bottom plan view thereof.

The broken lines shown in FIGS. 2 and 7 are included for the purpose of illustrating portions of the open packaging for surgical blade tips that form no part of the claimed design. It is understood that the broken lines portions immediately adjacent the shaded areas define the bounds of the claim but form no part thereof.

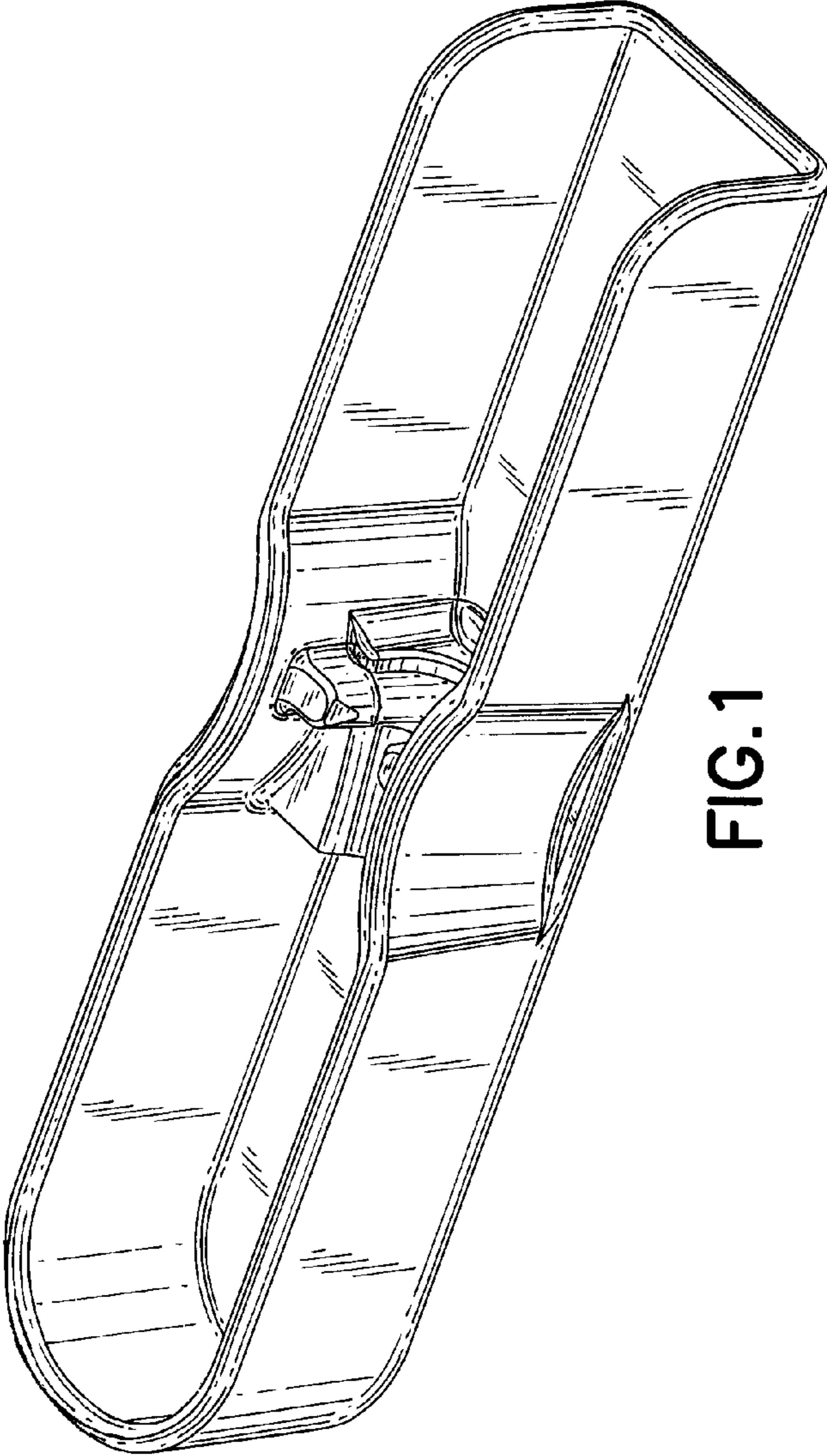

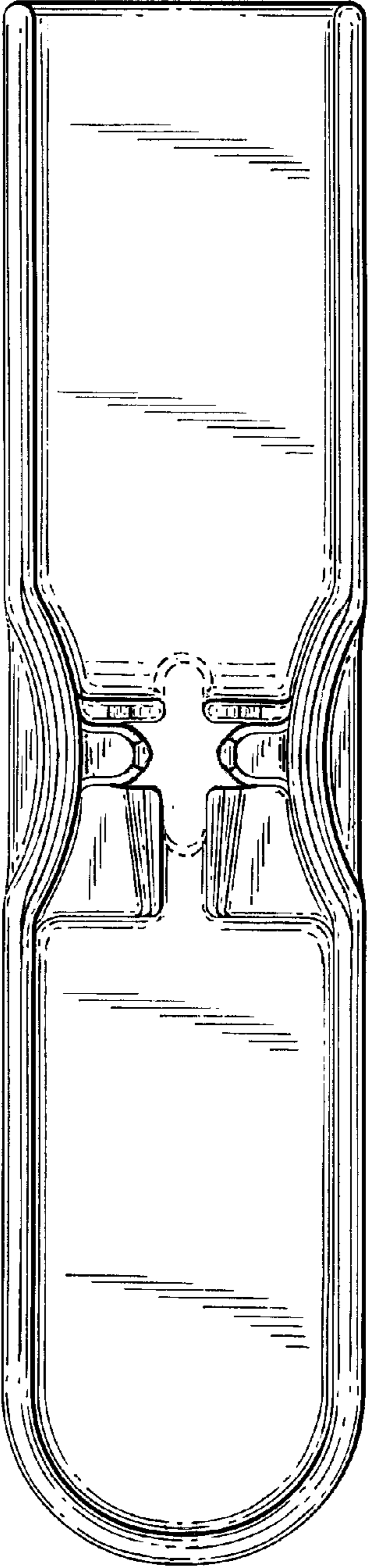

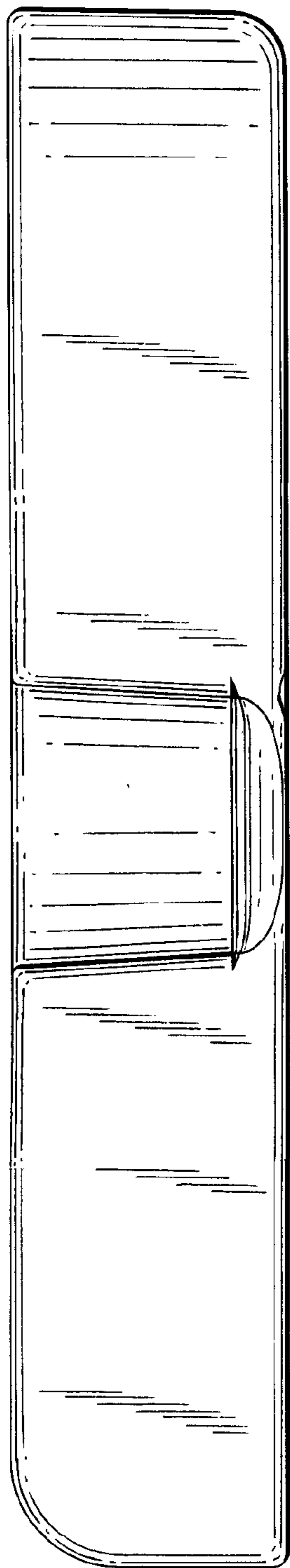

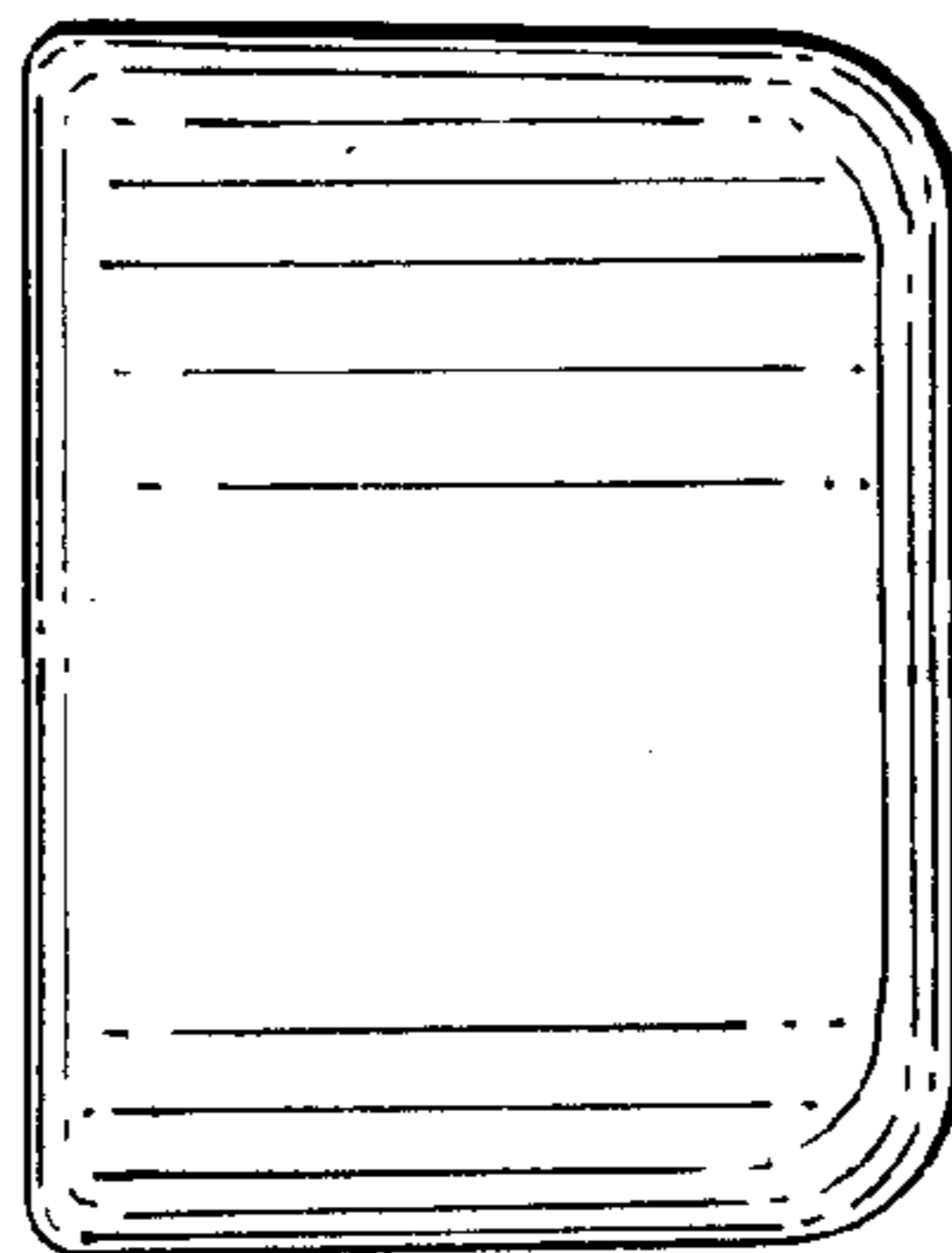

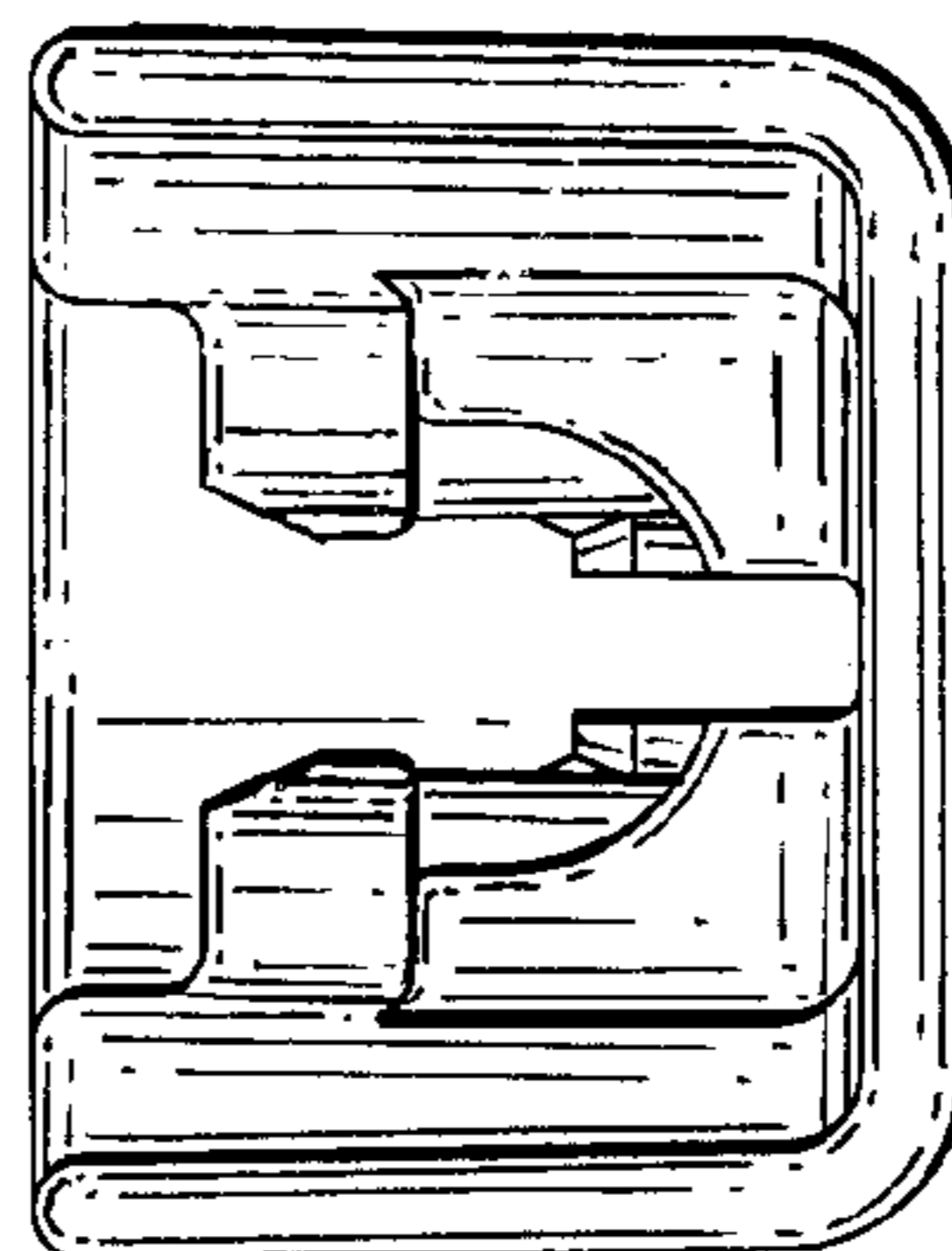

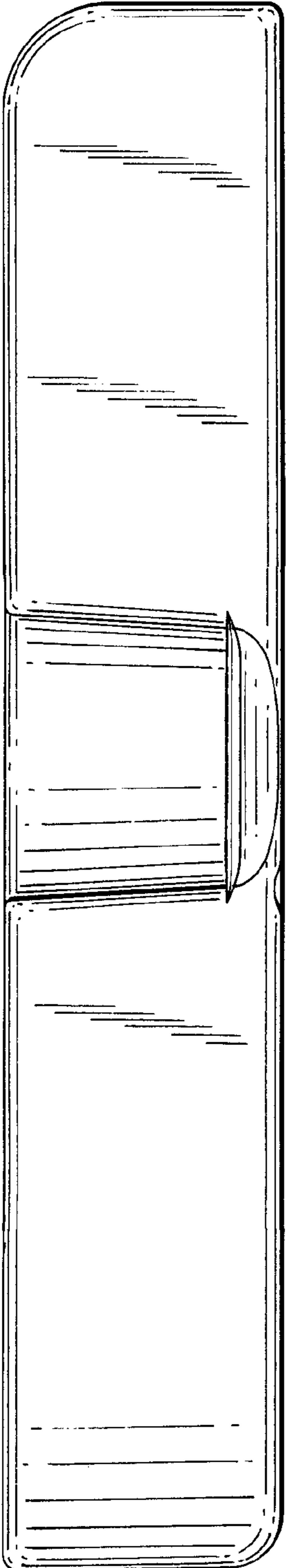

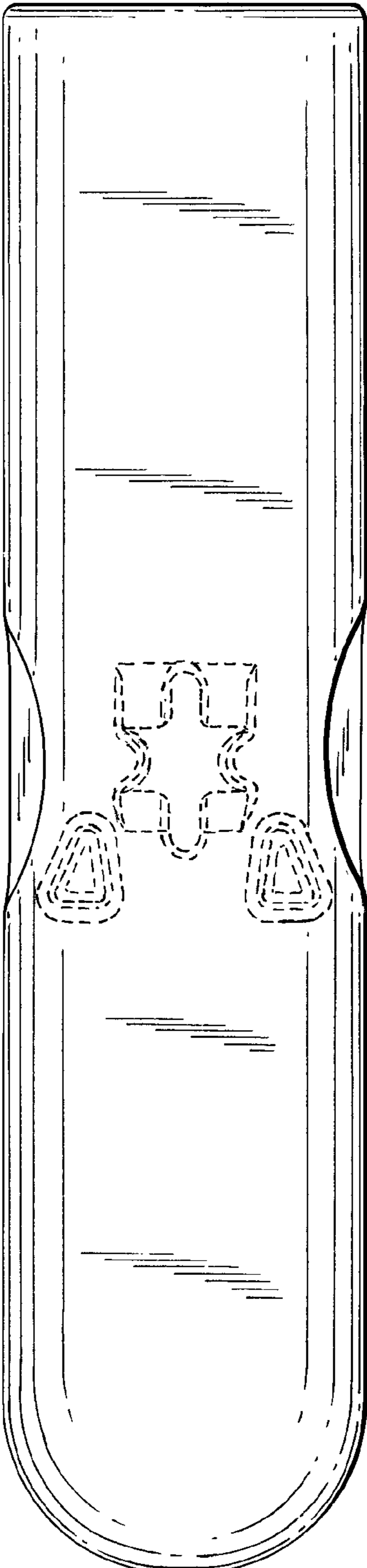
