(57) **CLAIM**

The ornamental design for a trigger sprayer package, as shown and described.

DESCRIPTION

This Application claims priority to U.S. application Ser. No. 29/286,003 filed Apr. 19, 2007 and to U.S. application Ser. No. 29/378,970 filed Nov. 11, 2010.

FIG. 10 is a rear view thereof; FIG. 11 is a left side view thereof;

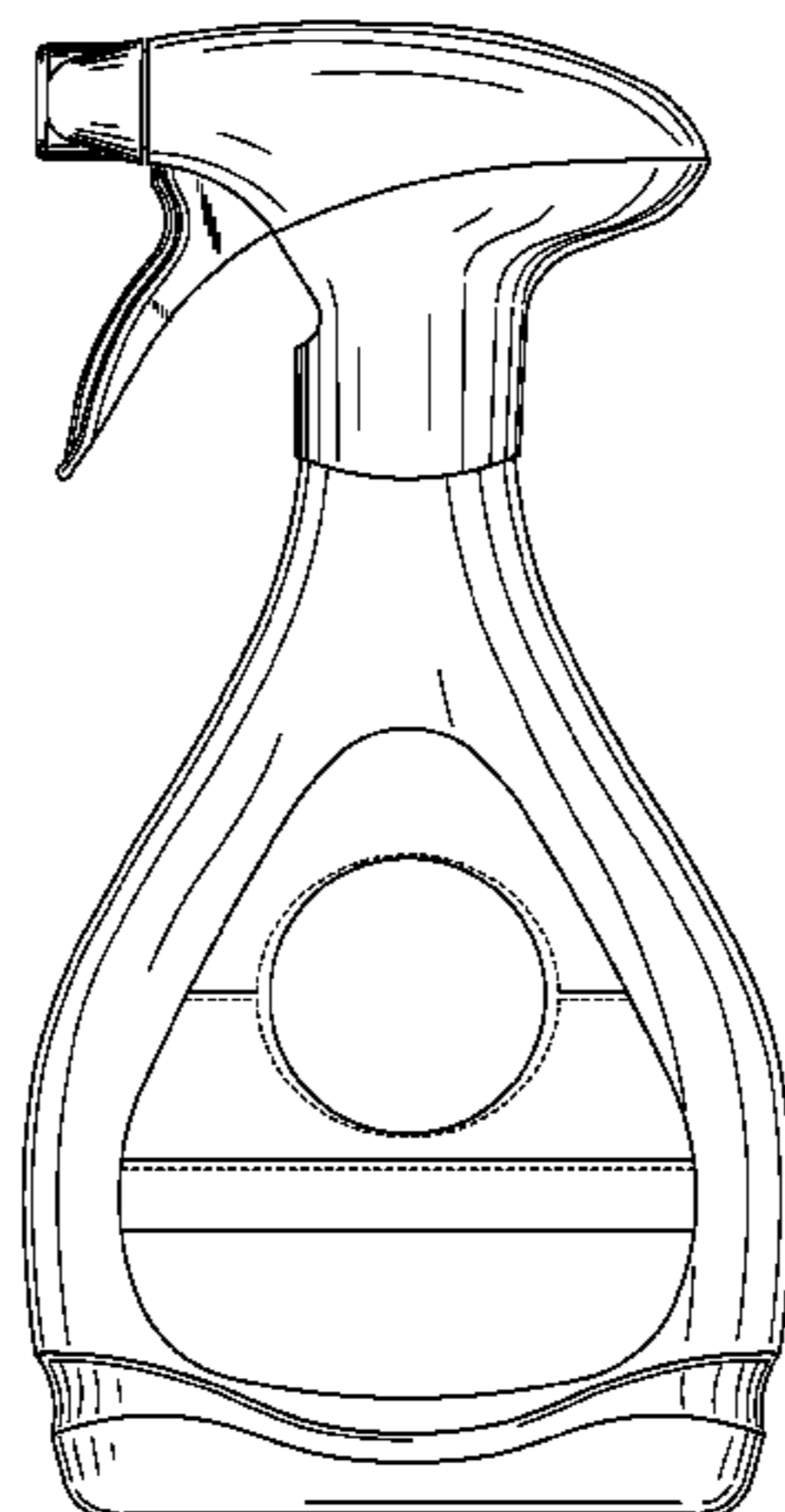
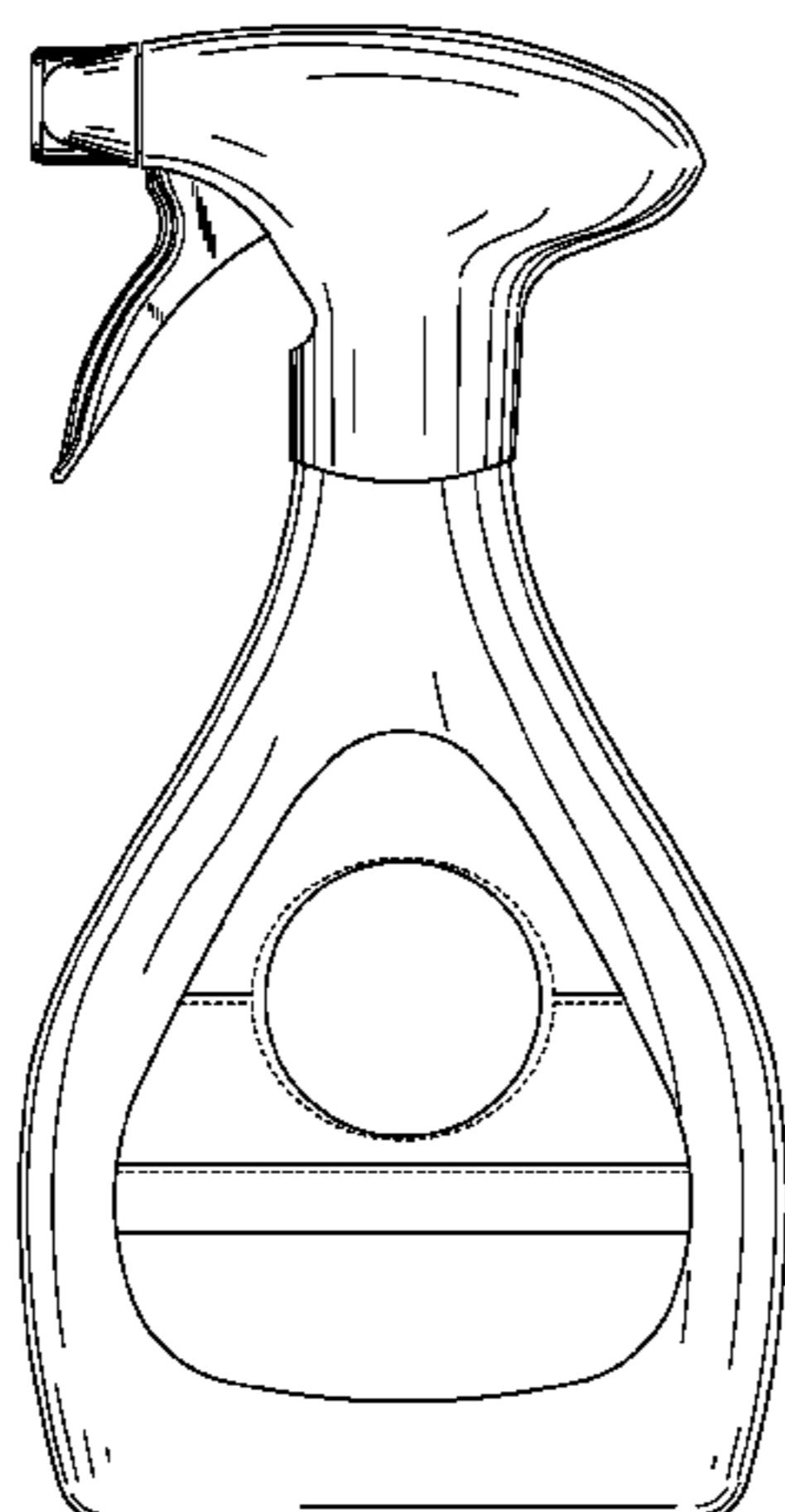
FIG. 12 is a right side view thereof;

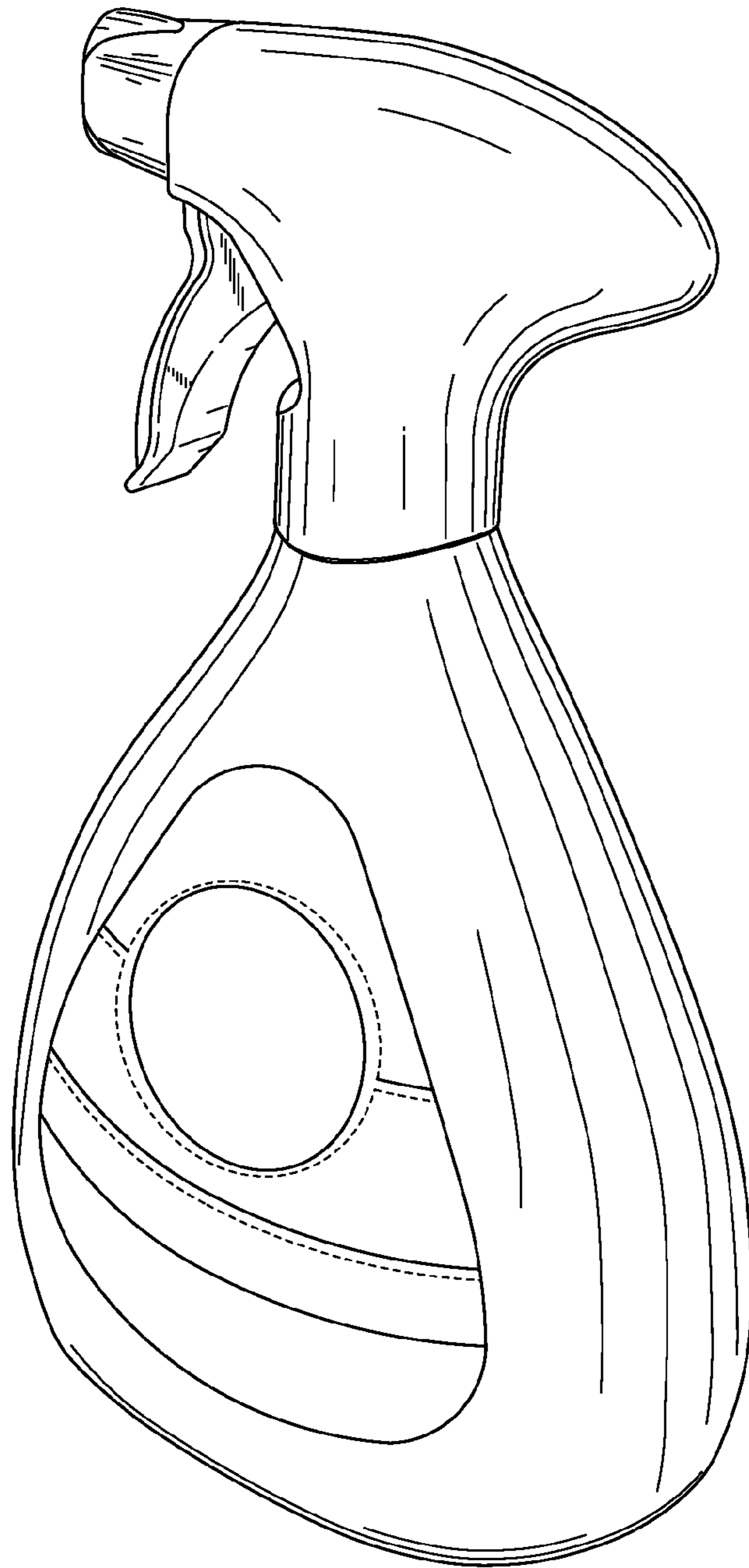

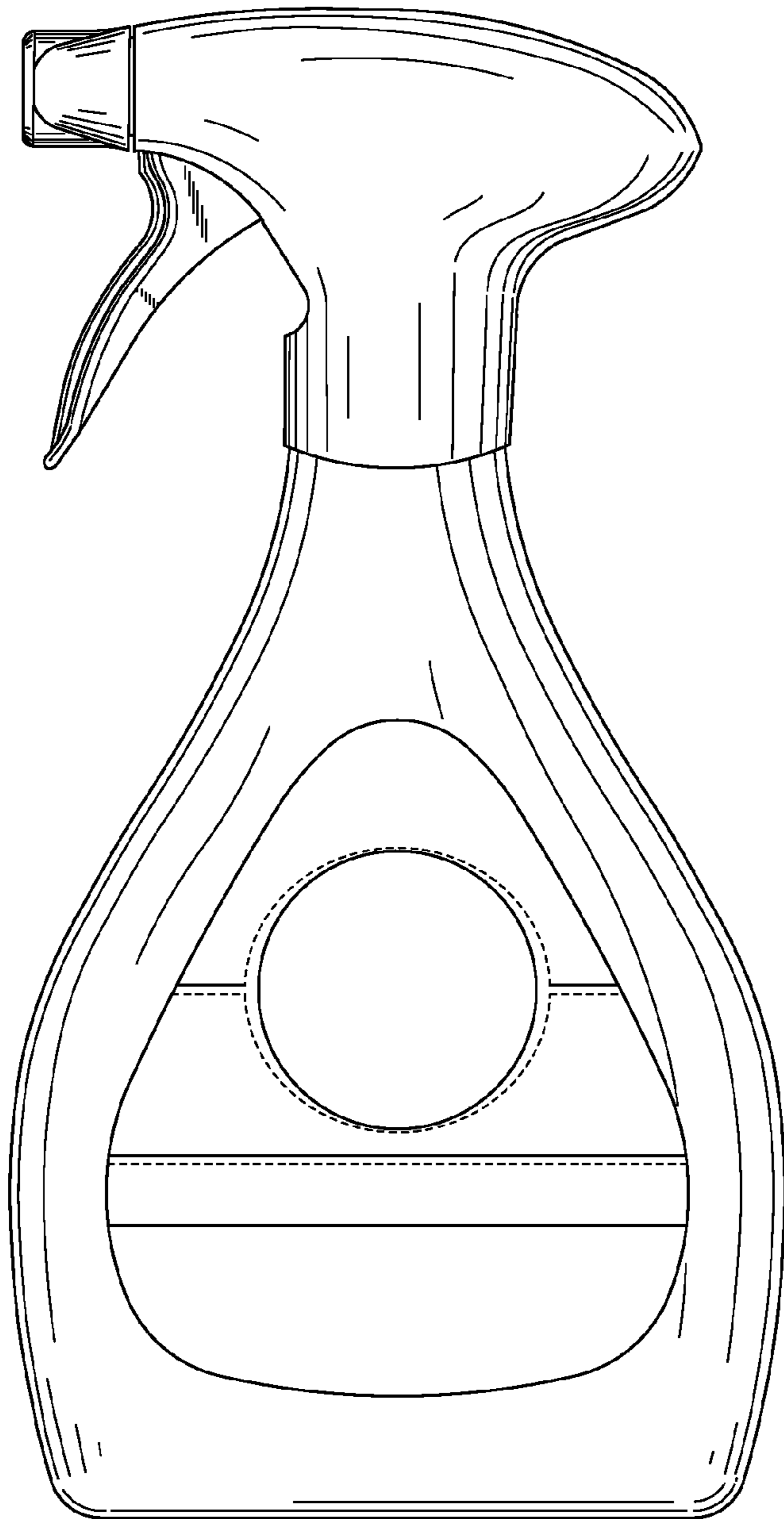

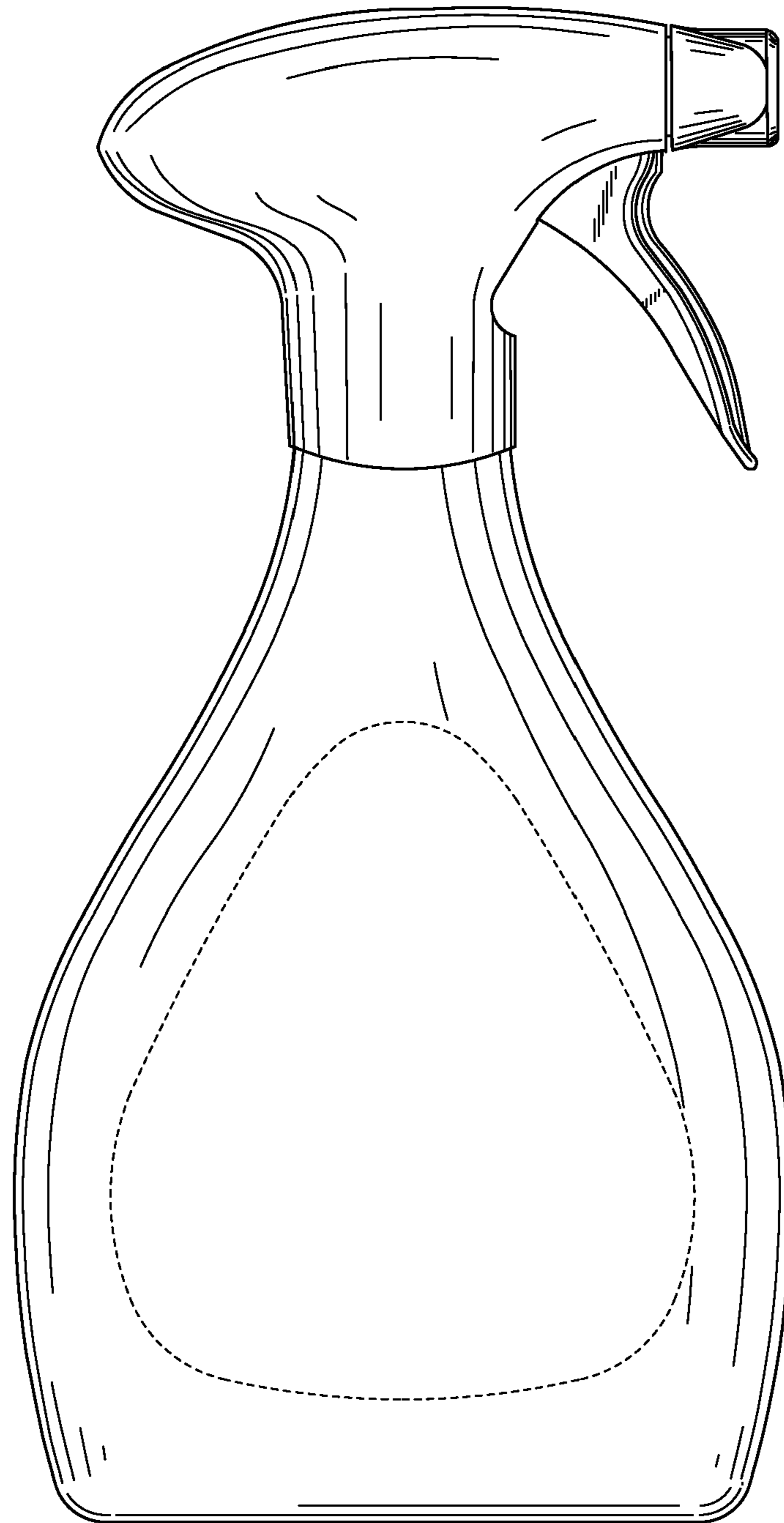

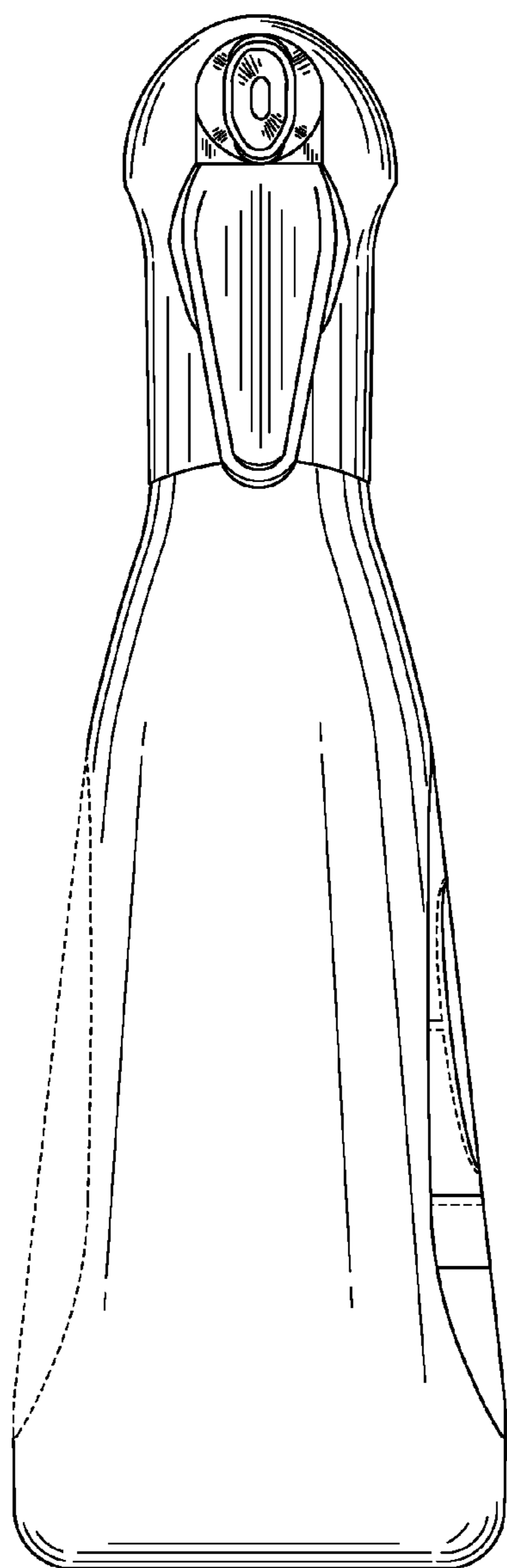

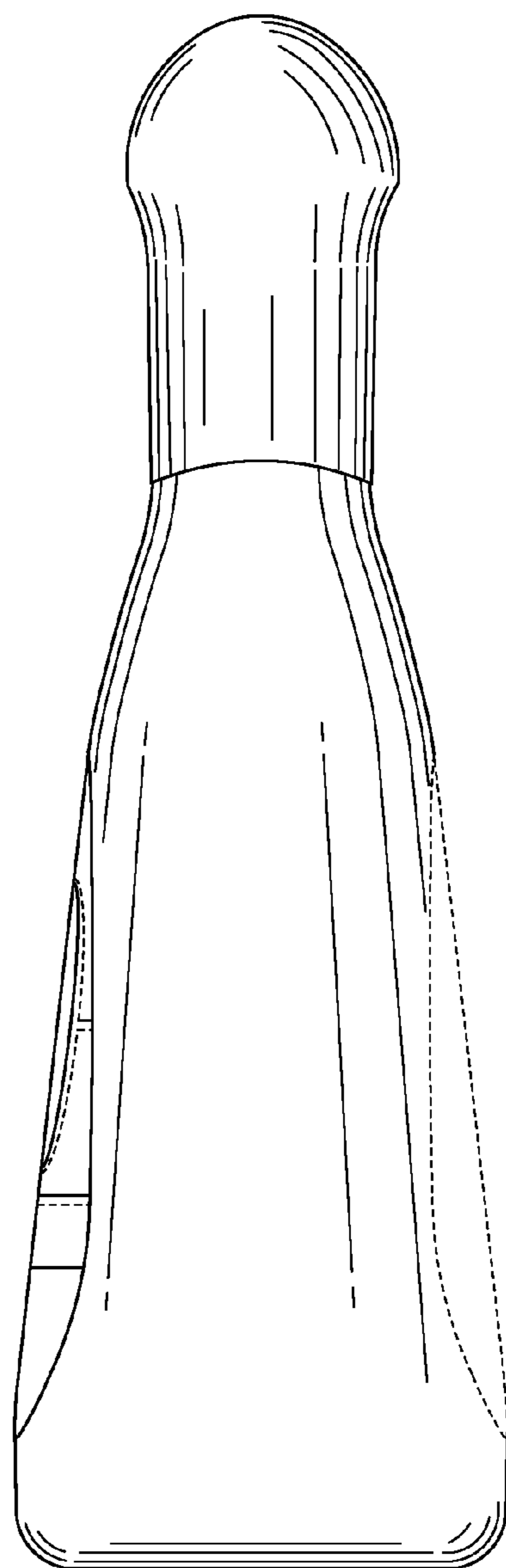

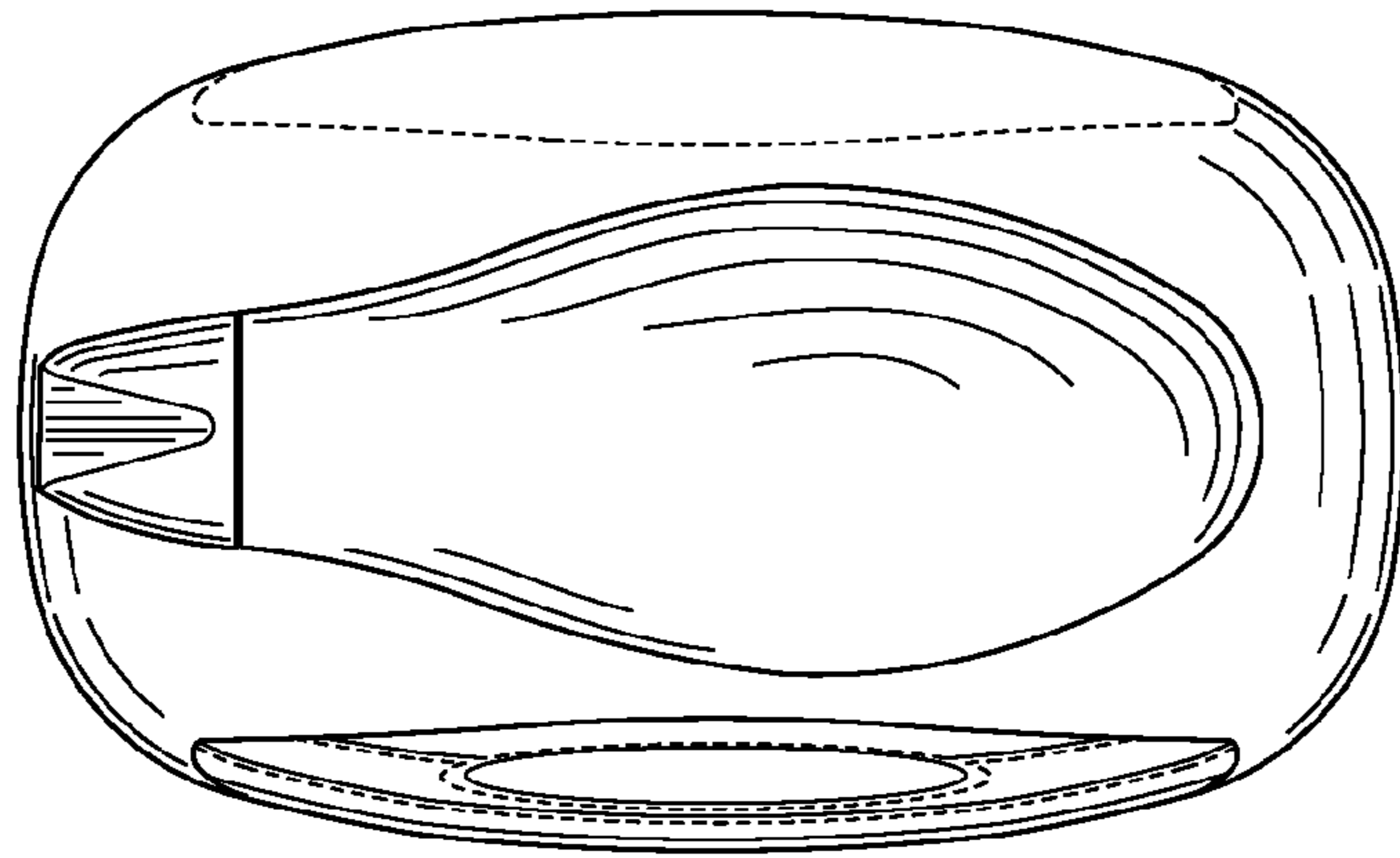

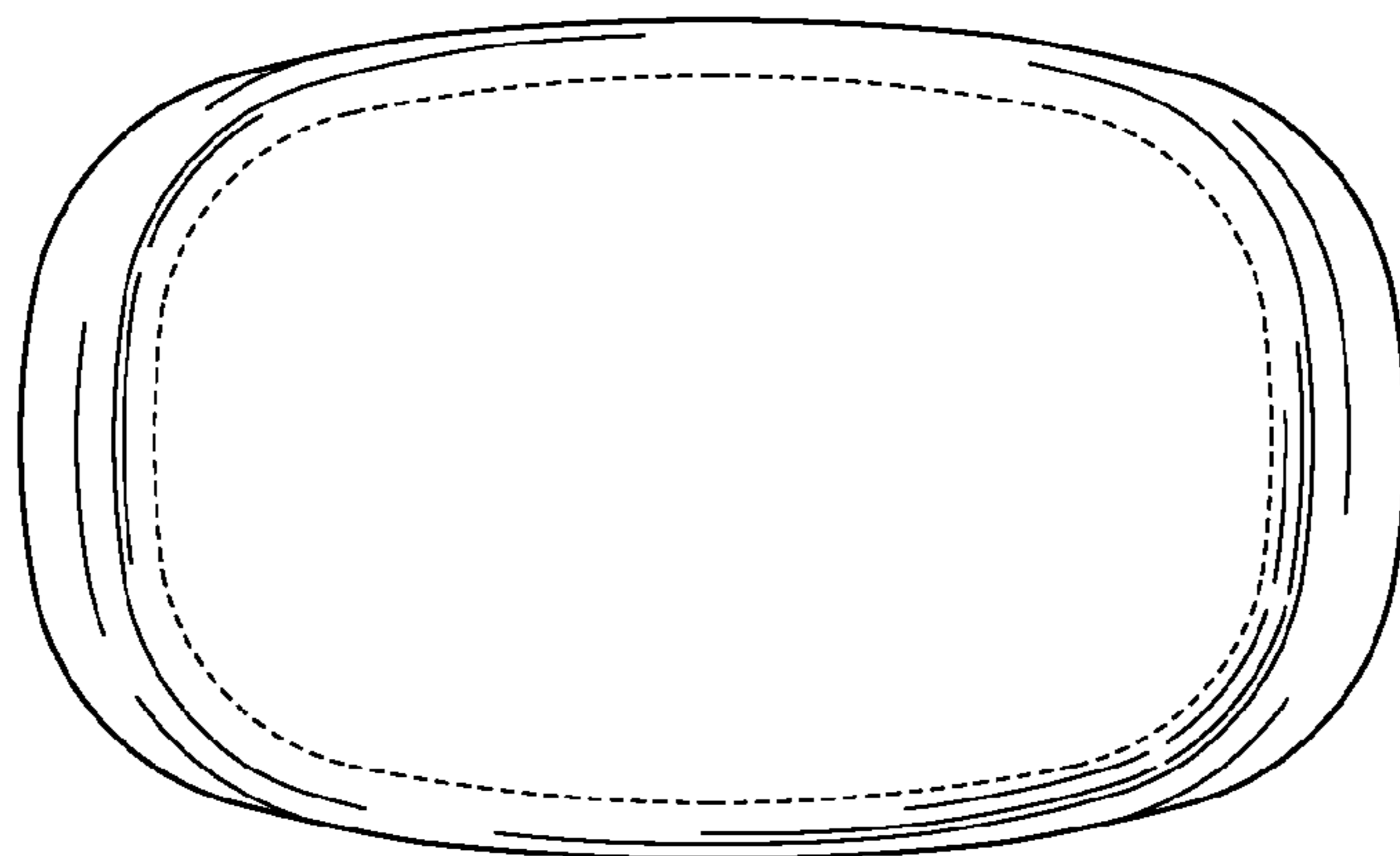

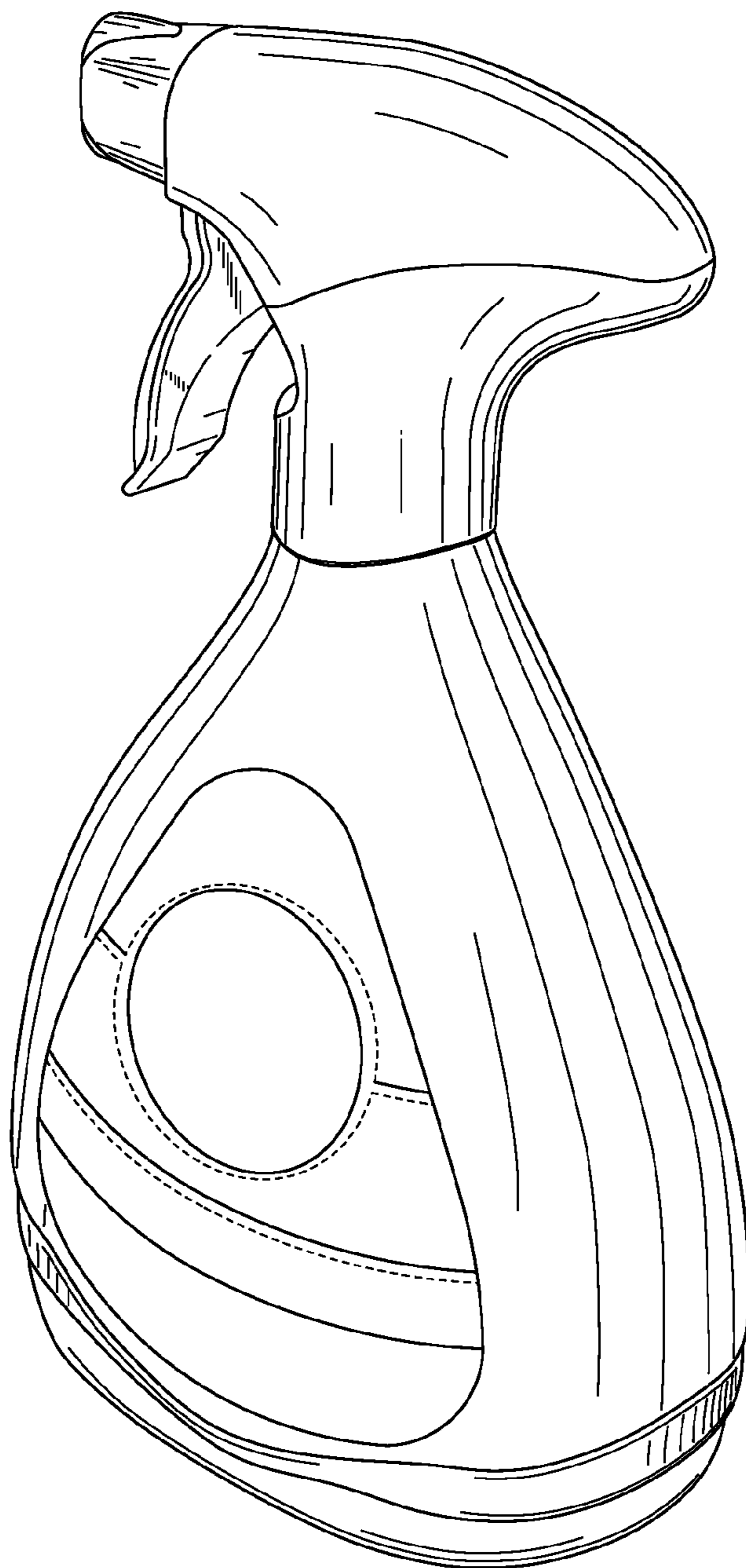

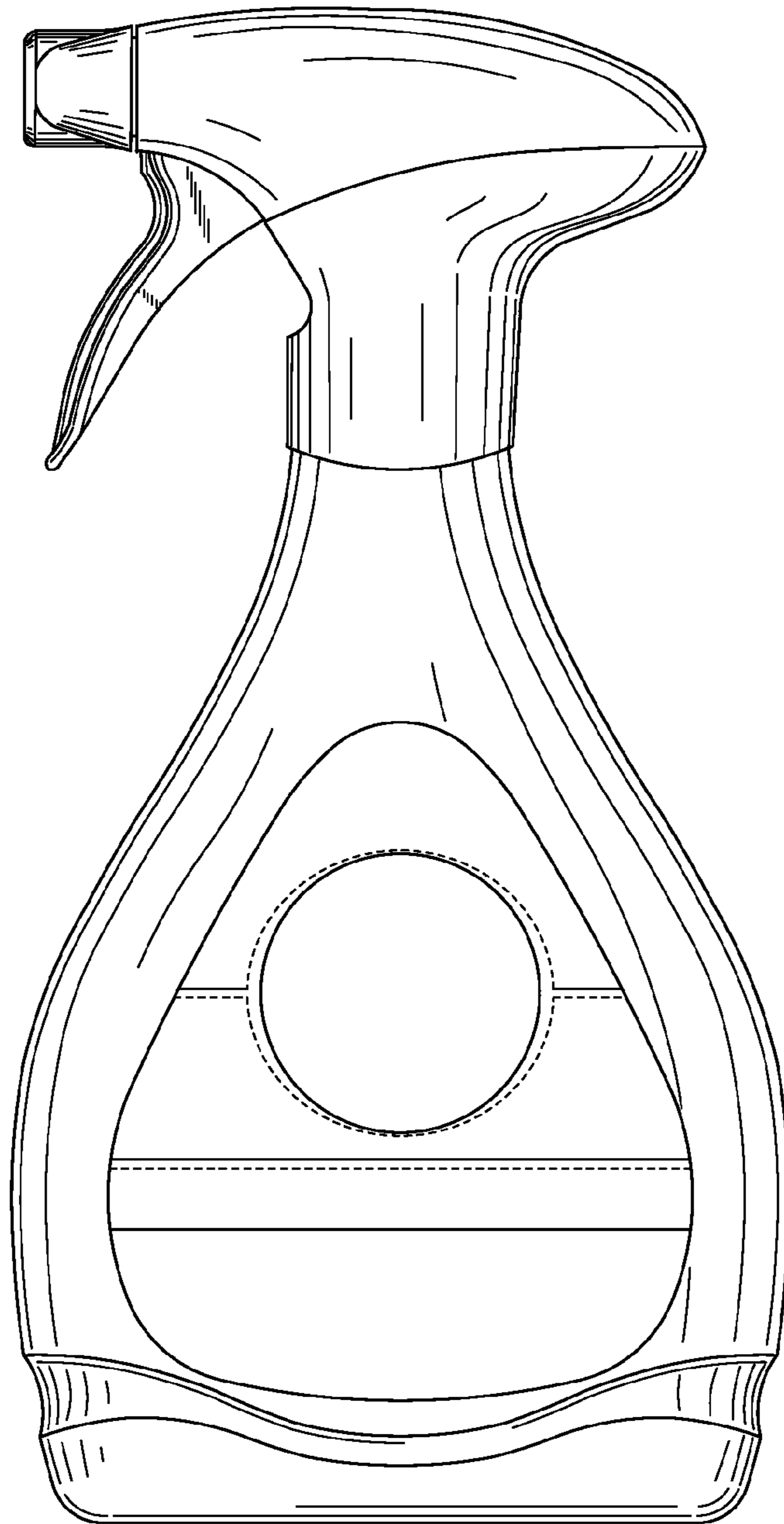

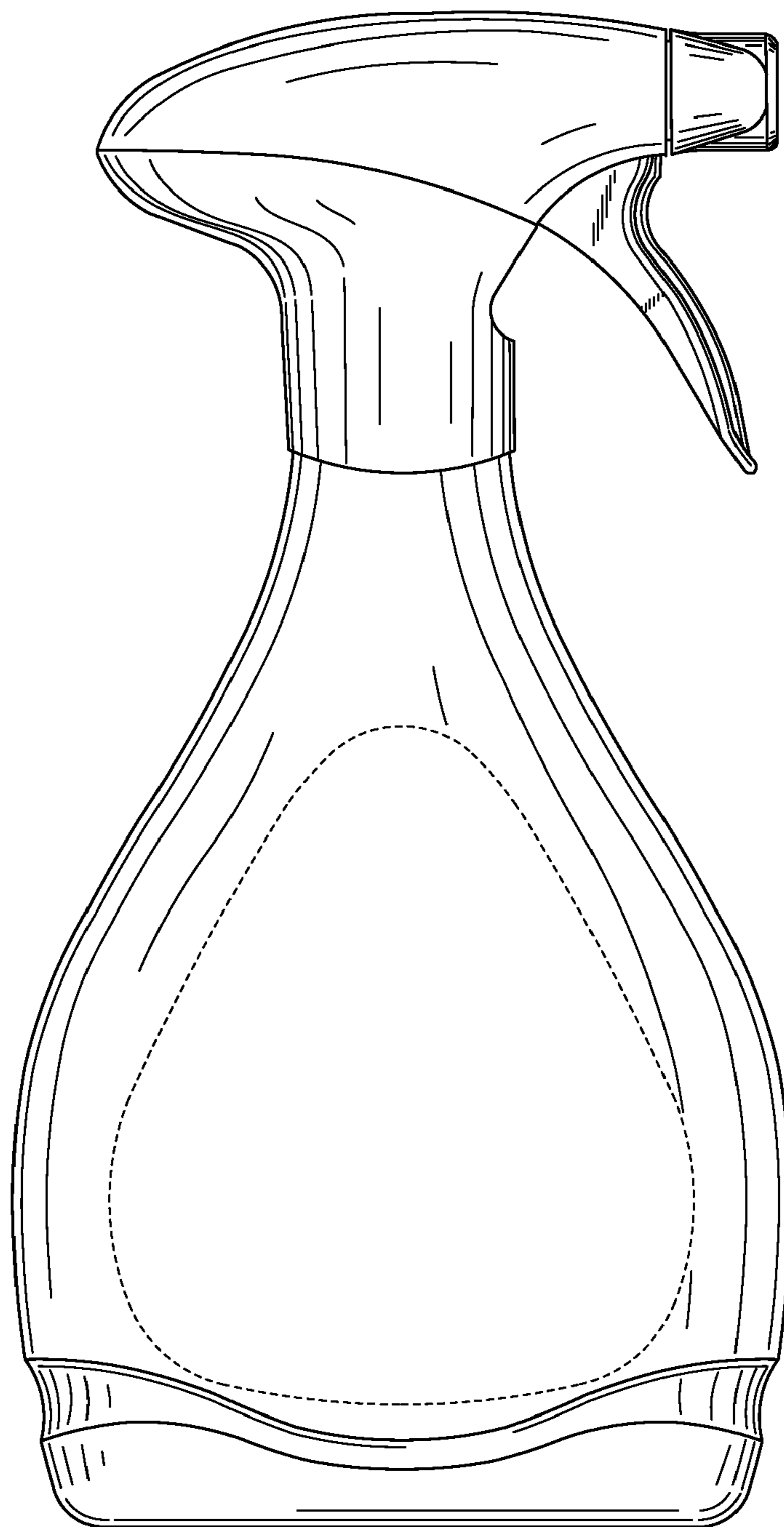

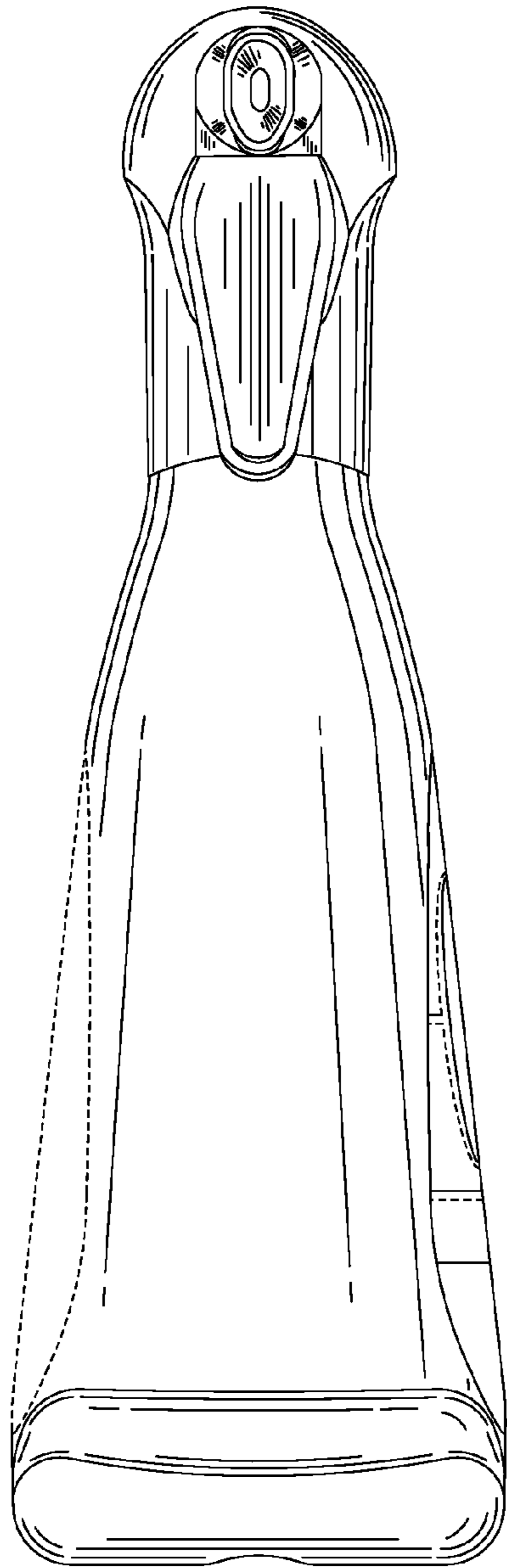

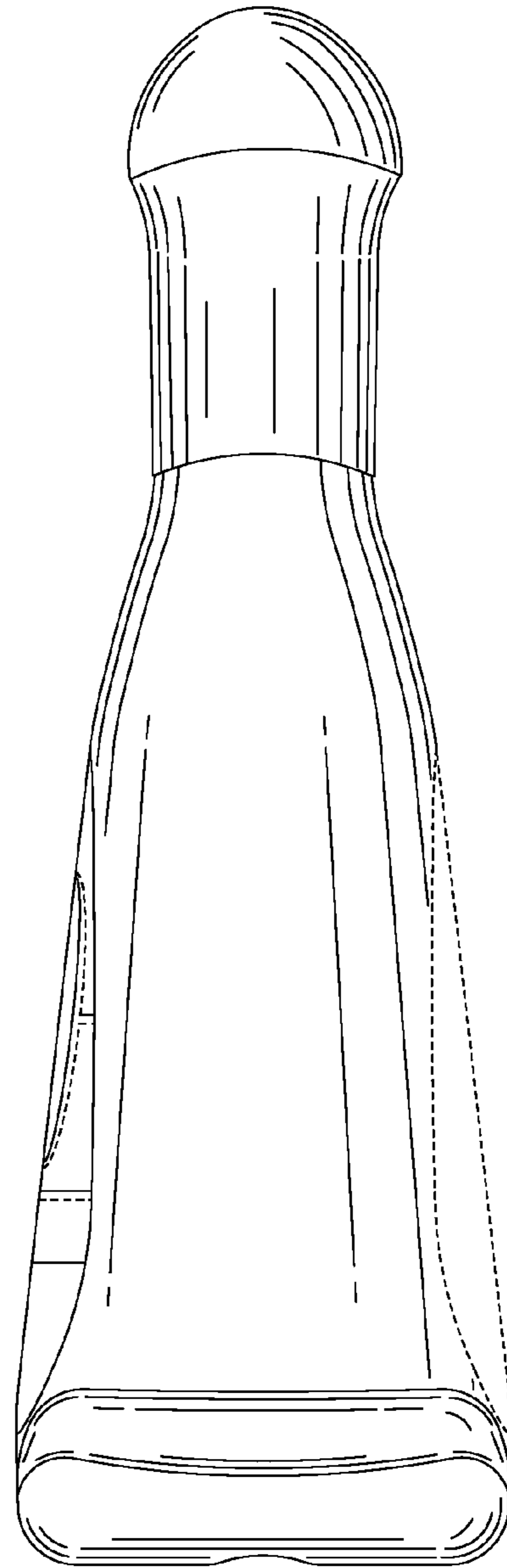

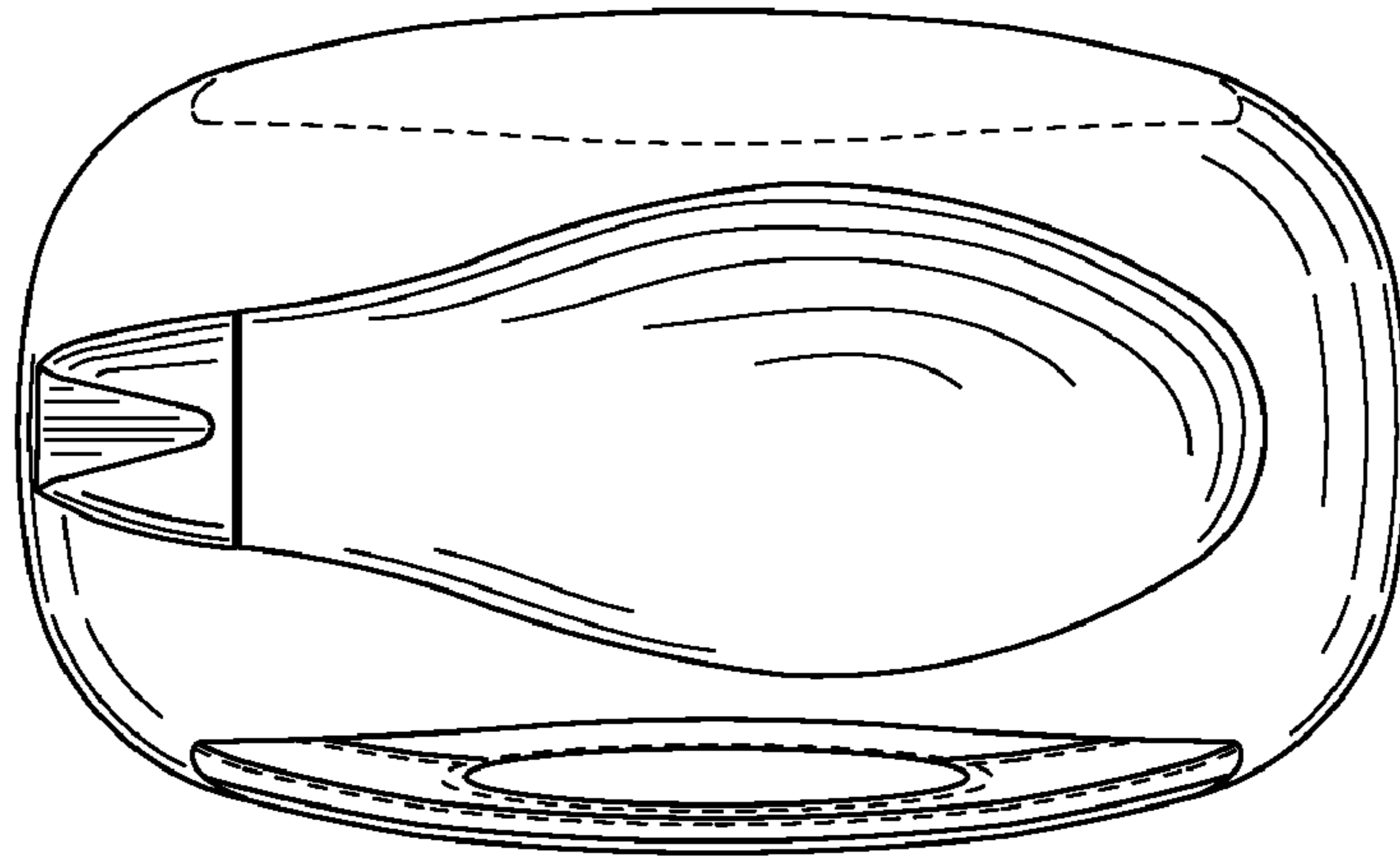

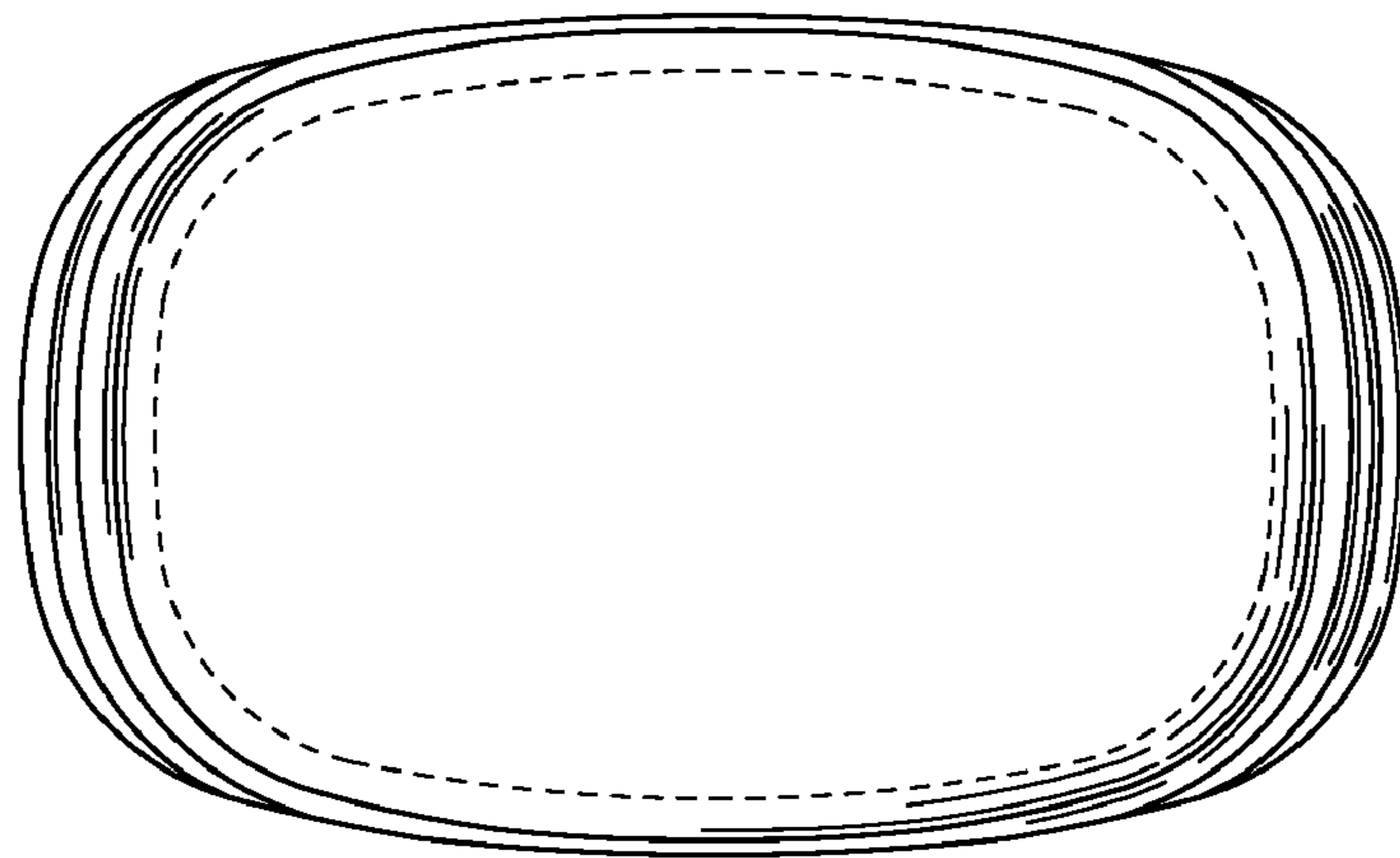
