(57) **CLAIM**

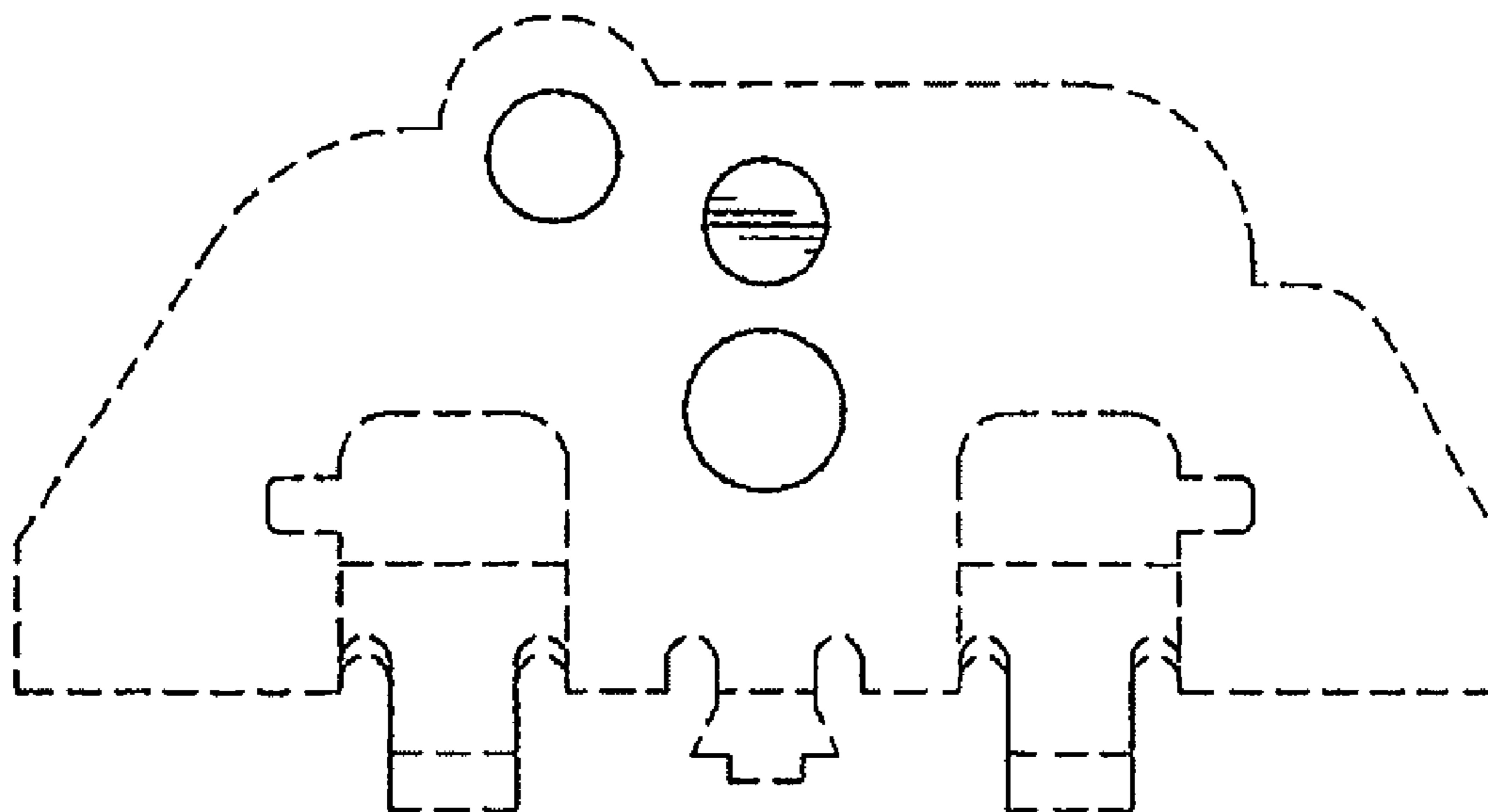
The ornamental design for a windshield wiper bracket, as shown and described.

DESCRIPTION

FIG. 1 is a front, right perspective view of a windshield wiper bracket showing my new design;
FIG. 2 is a right side view thereof;

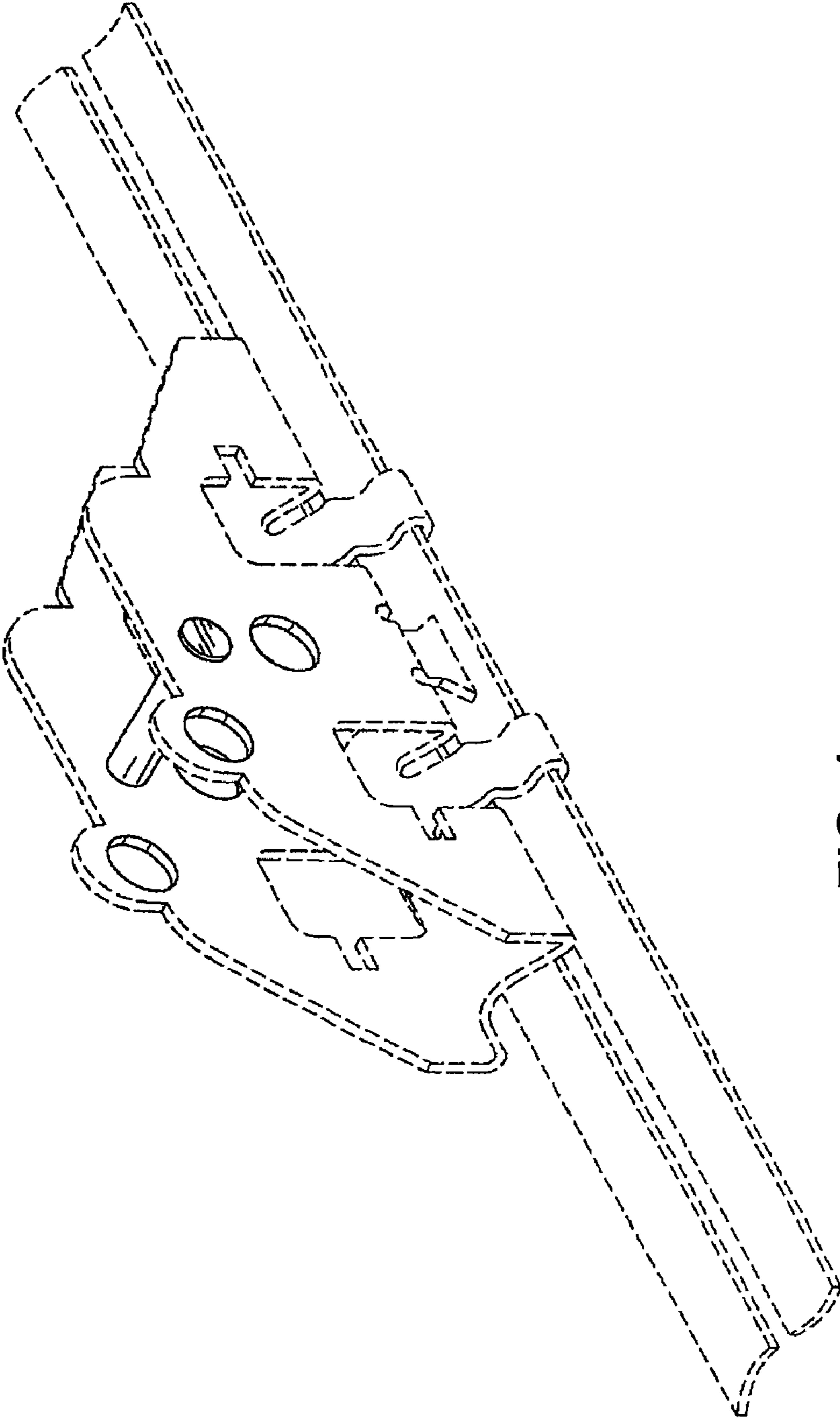

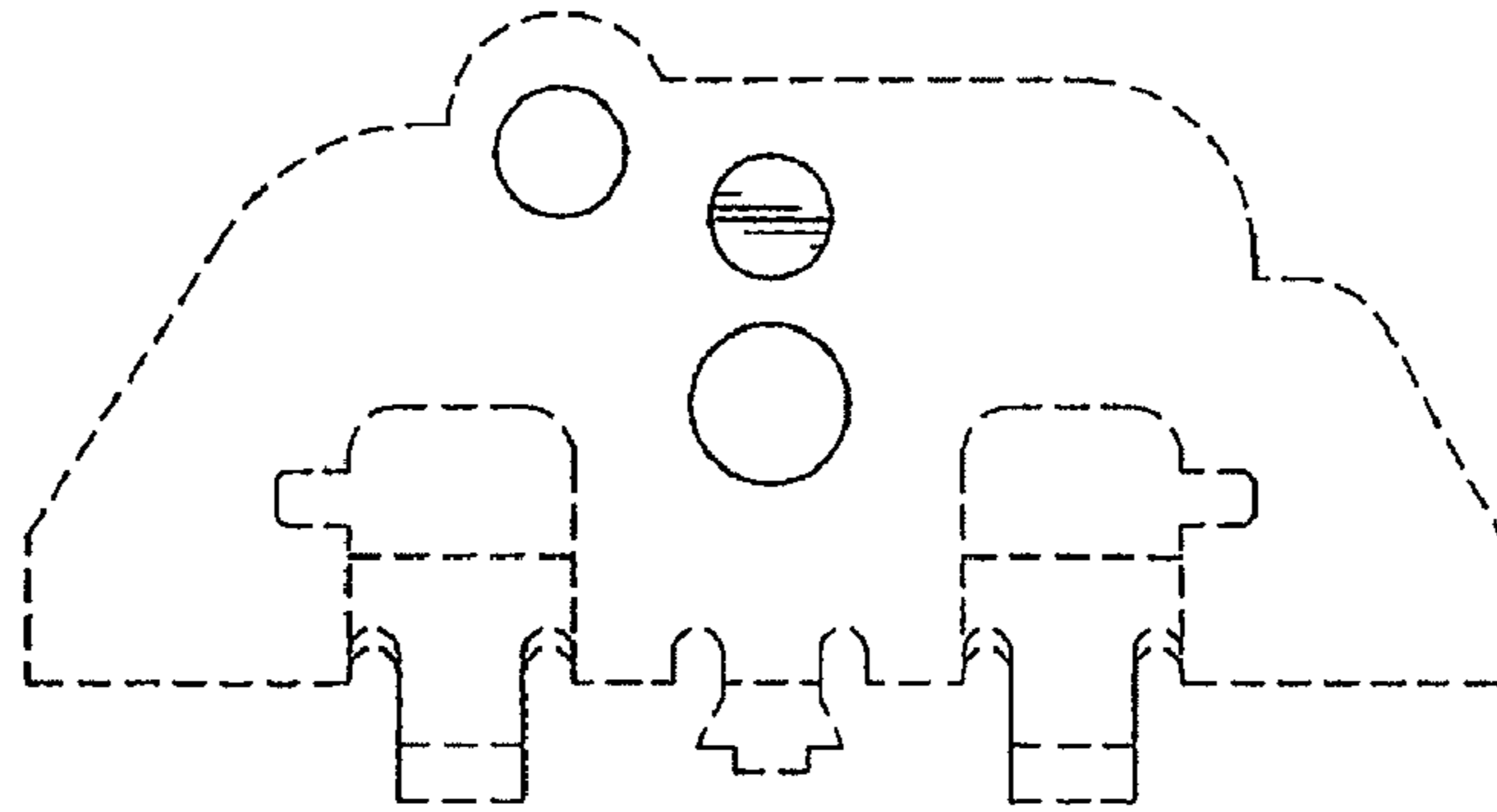

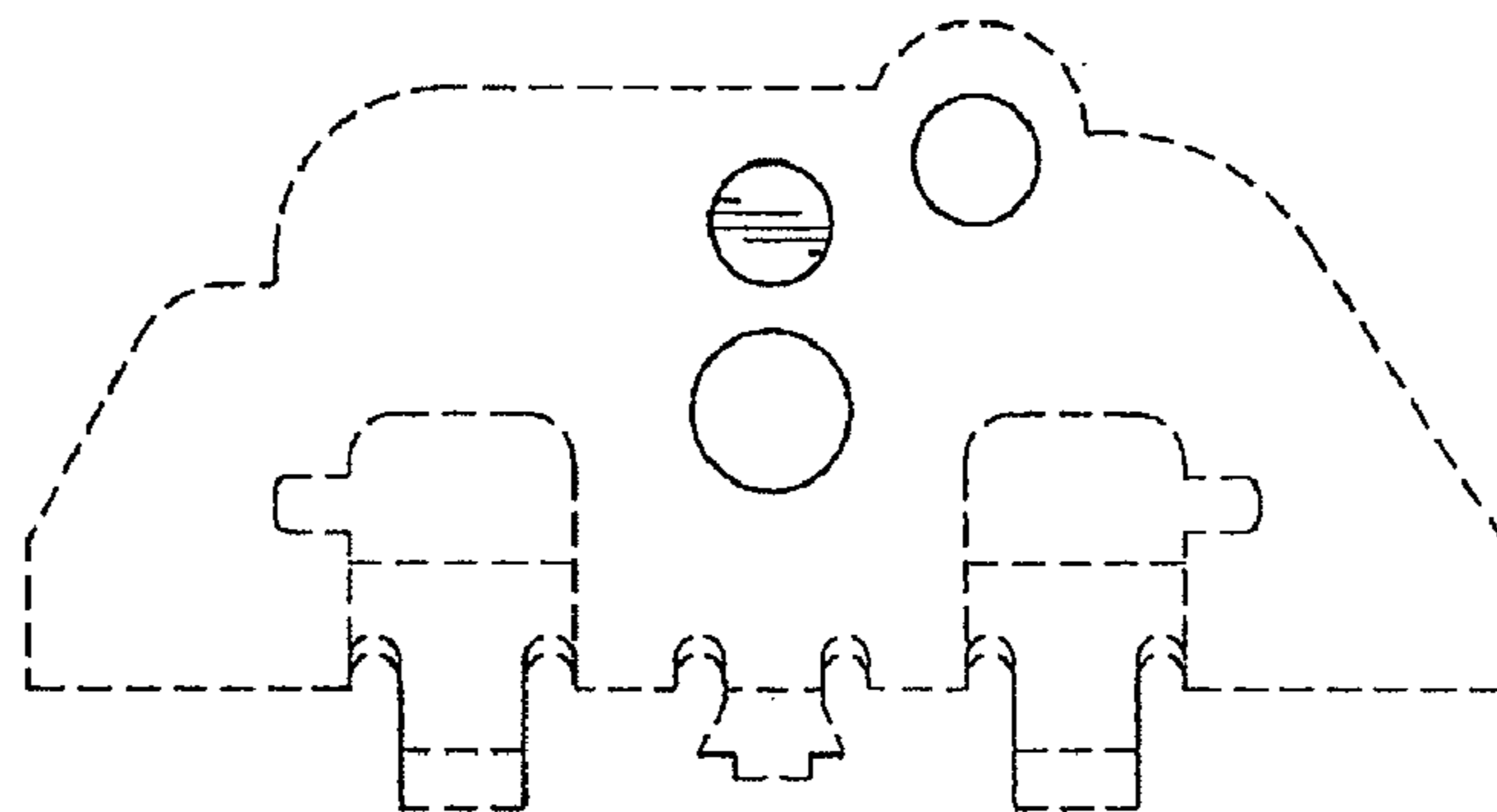

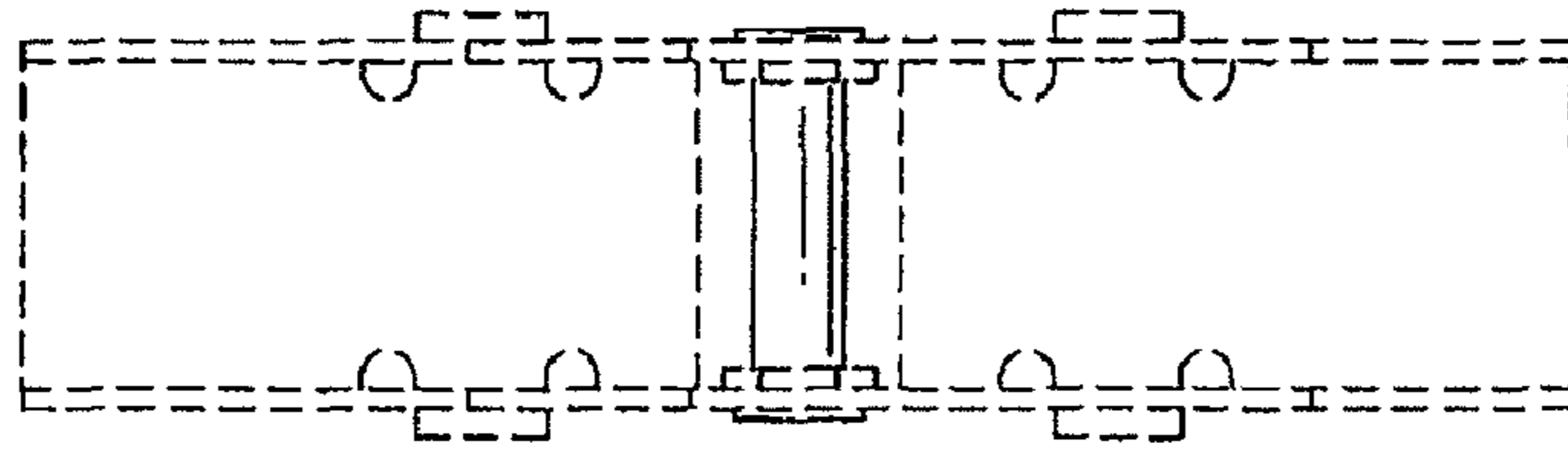

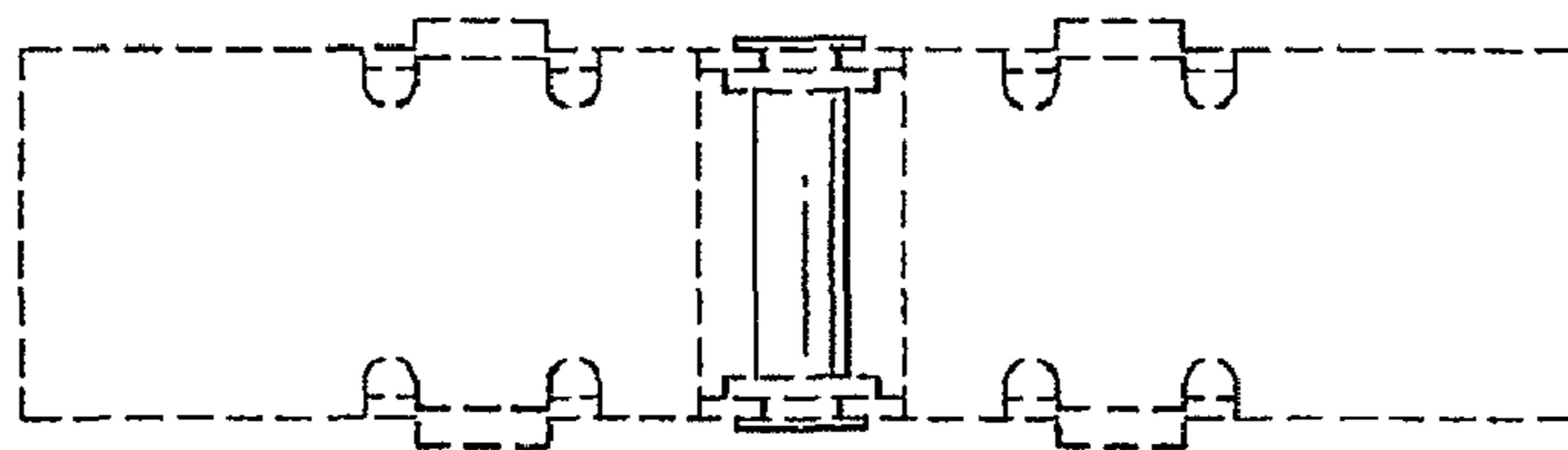

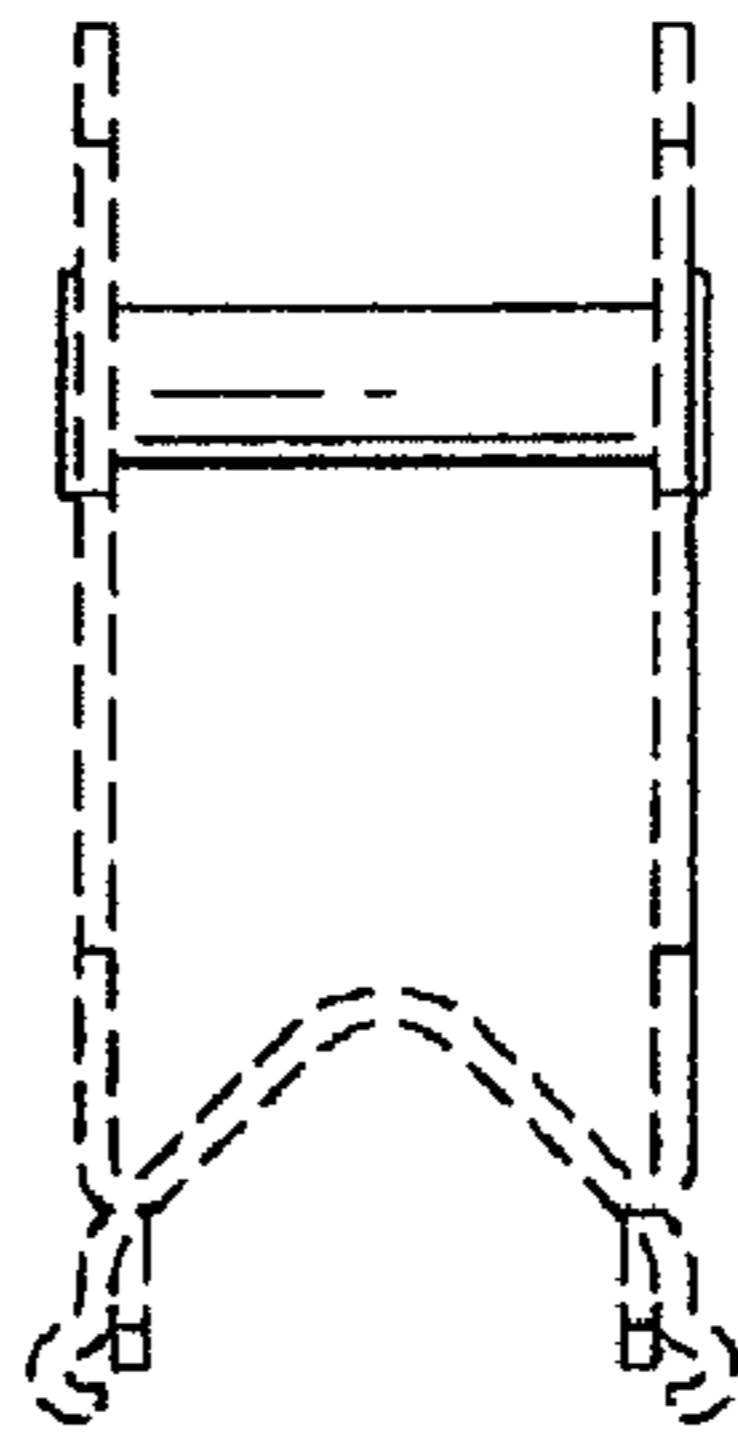
