new, original and ornamental design;

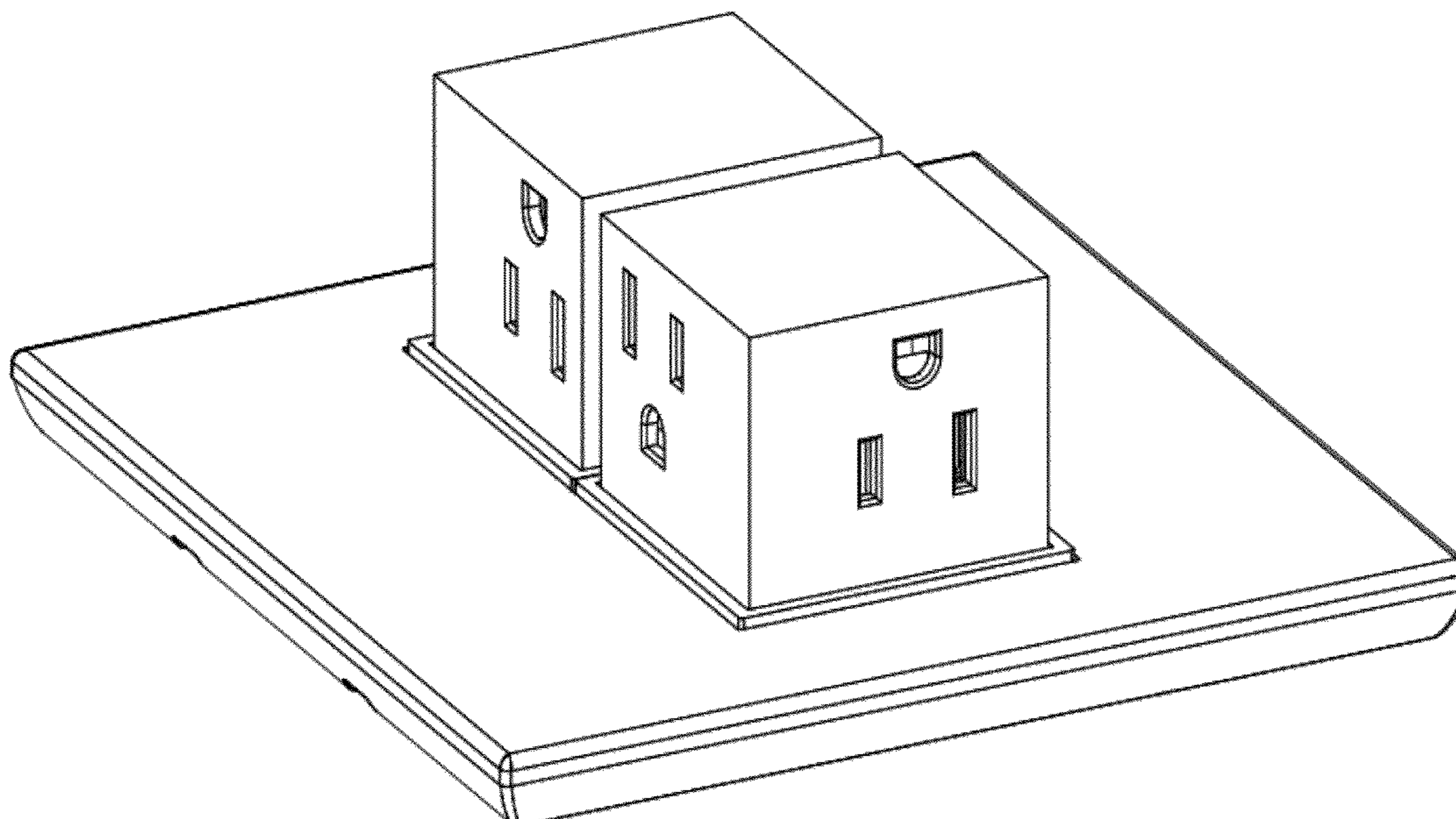
FIG. 4 is a right-hand side view of an electric receptacle

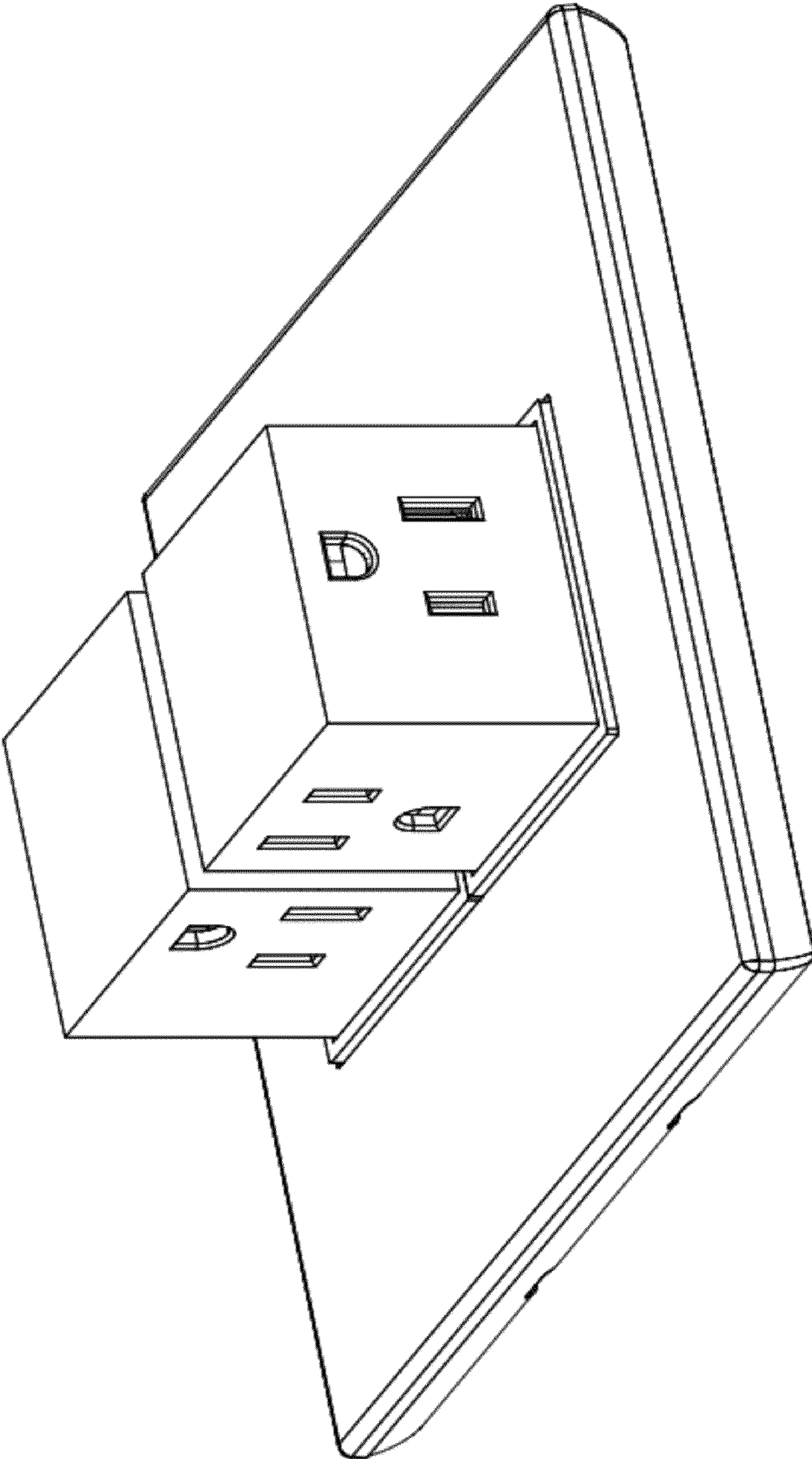

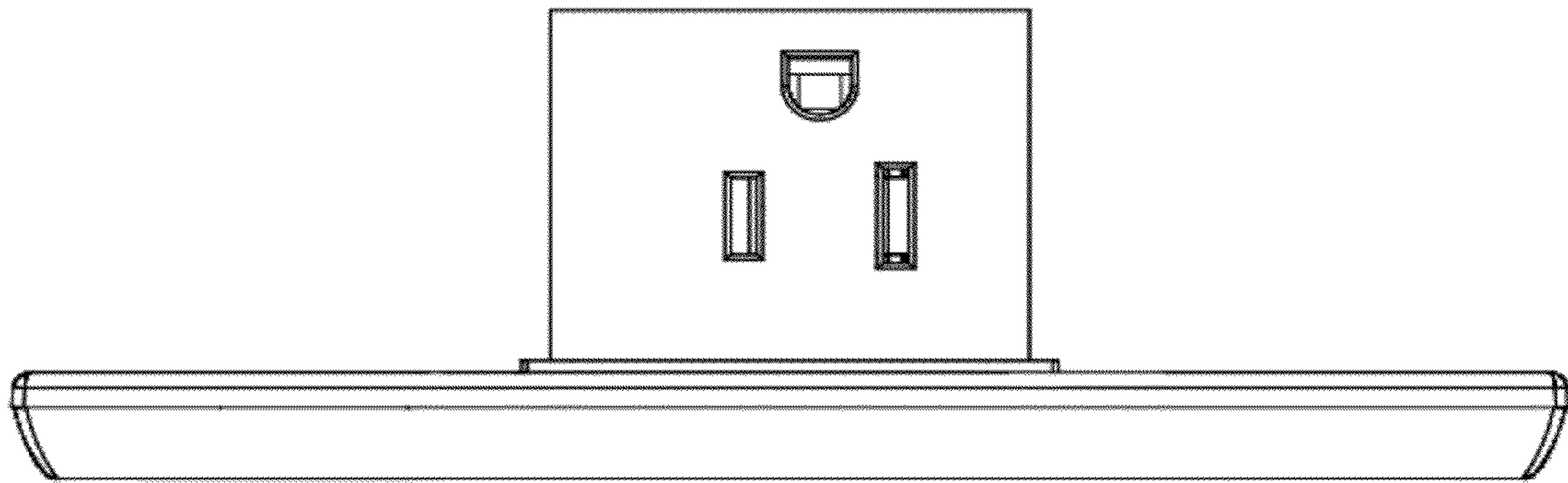

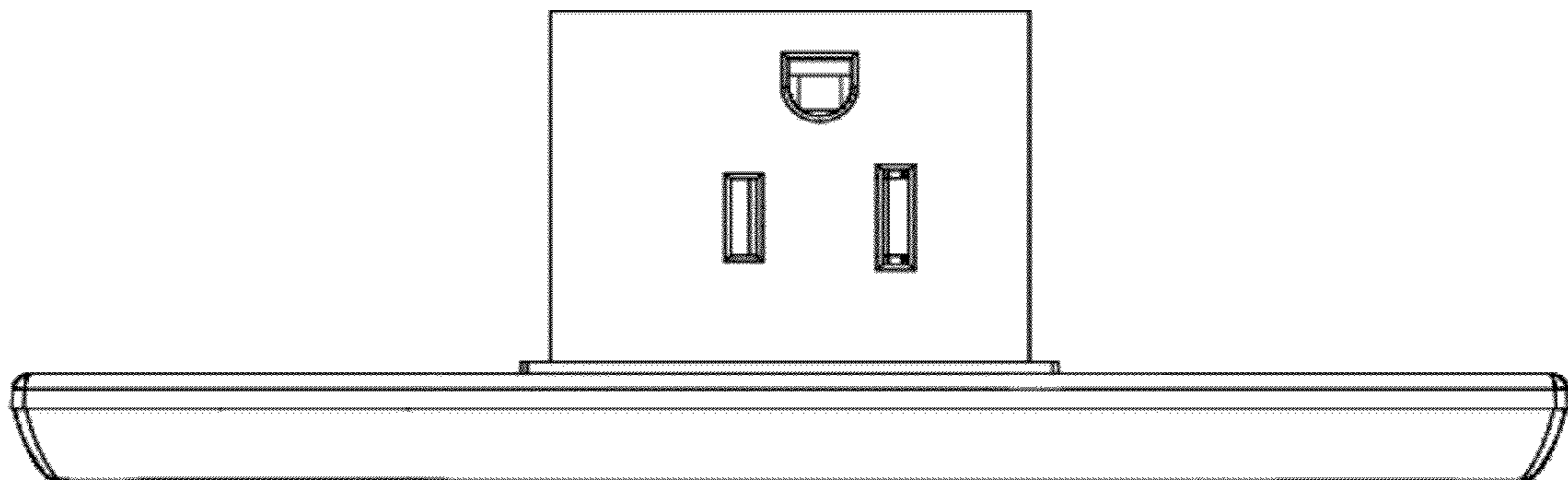

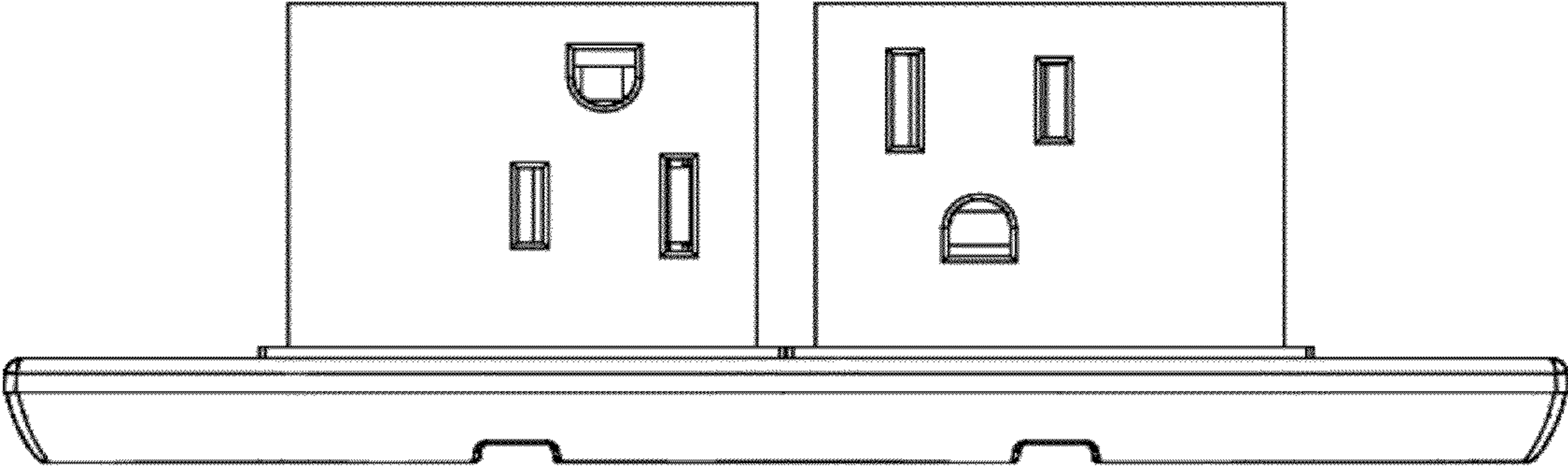

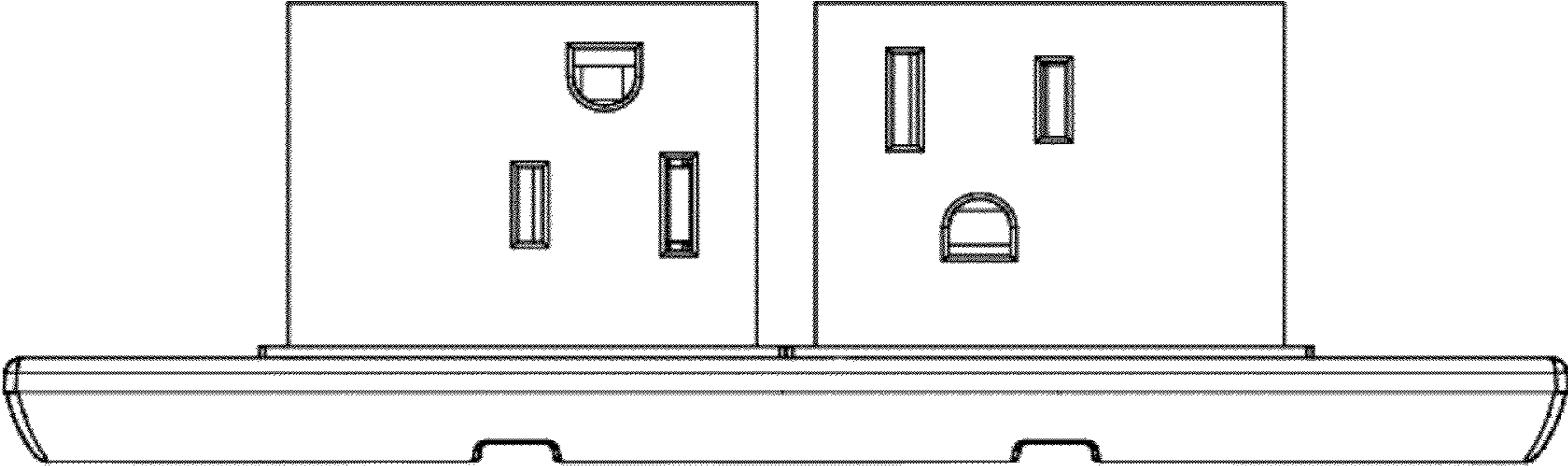

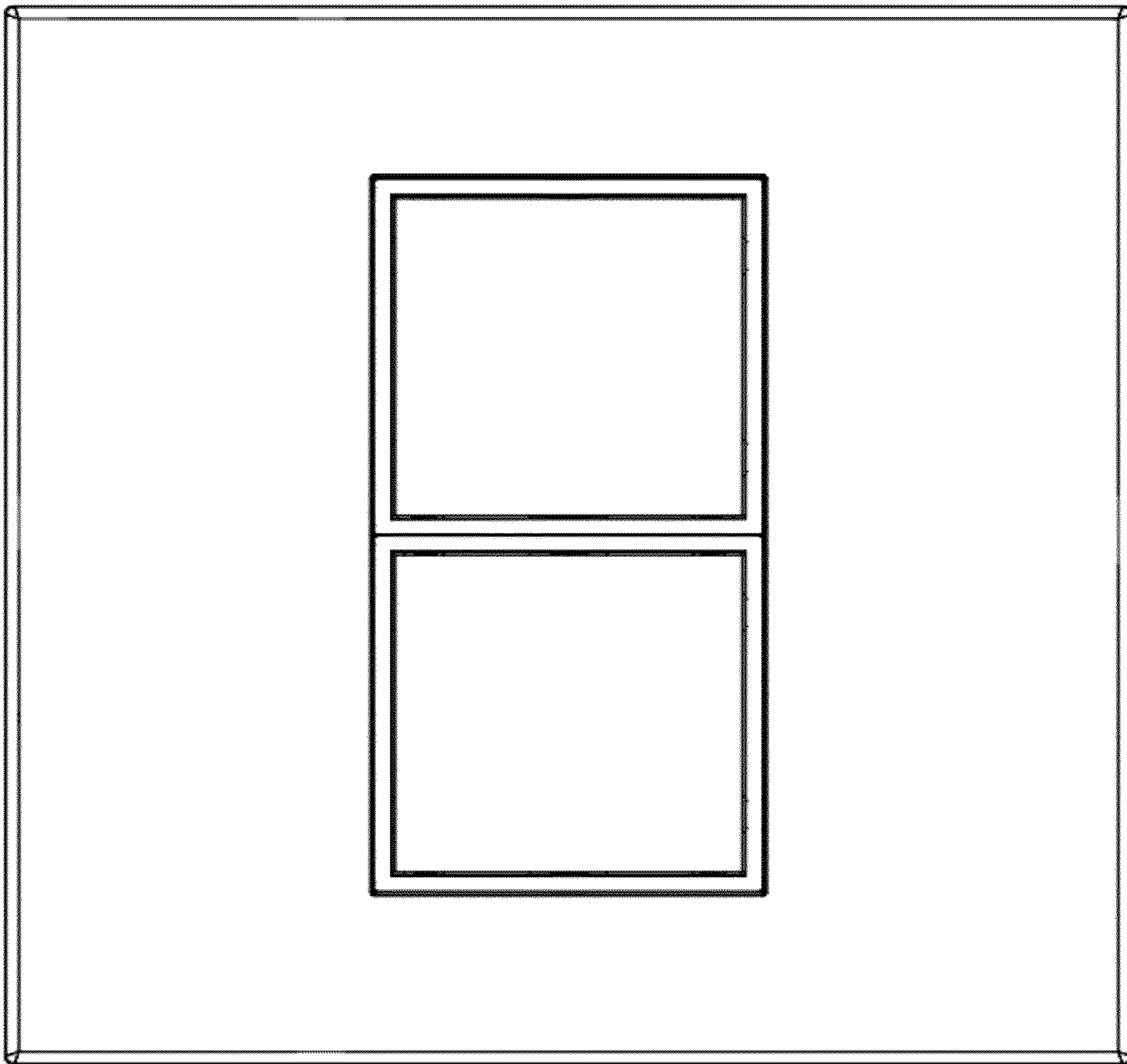
