FIG. 3 is a front elevational view thereof;

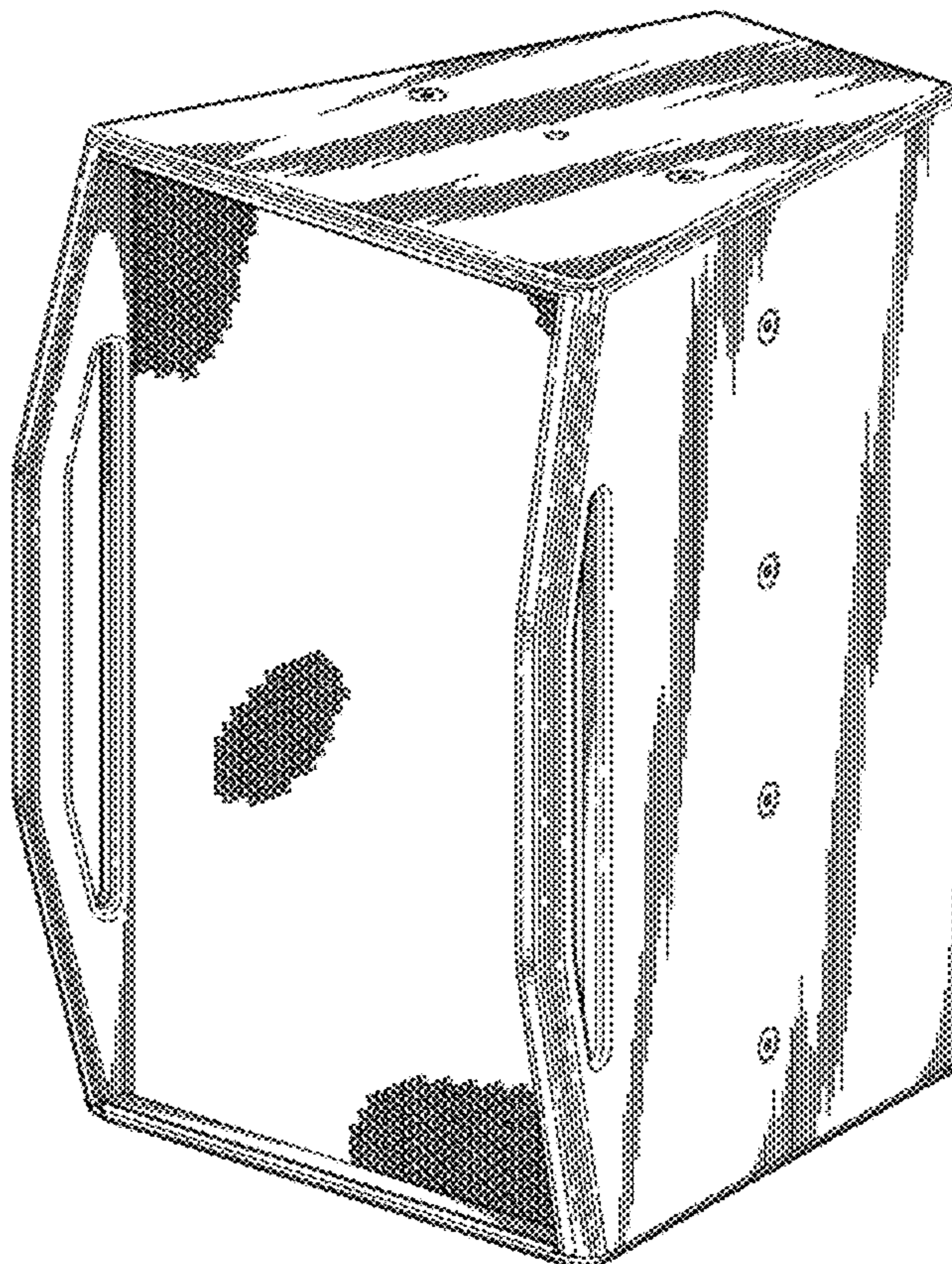
FIG. 4 is rear elevational view thereof;

FIG. 5 is a top plan view thereof; and,

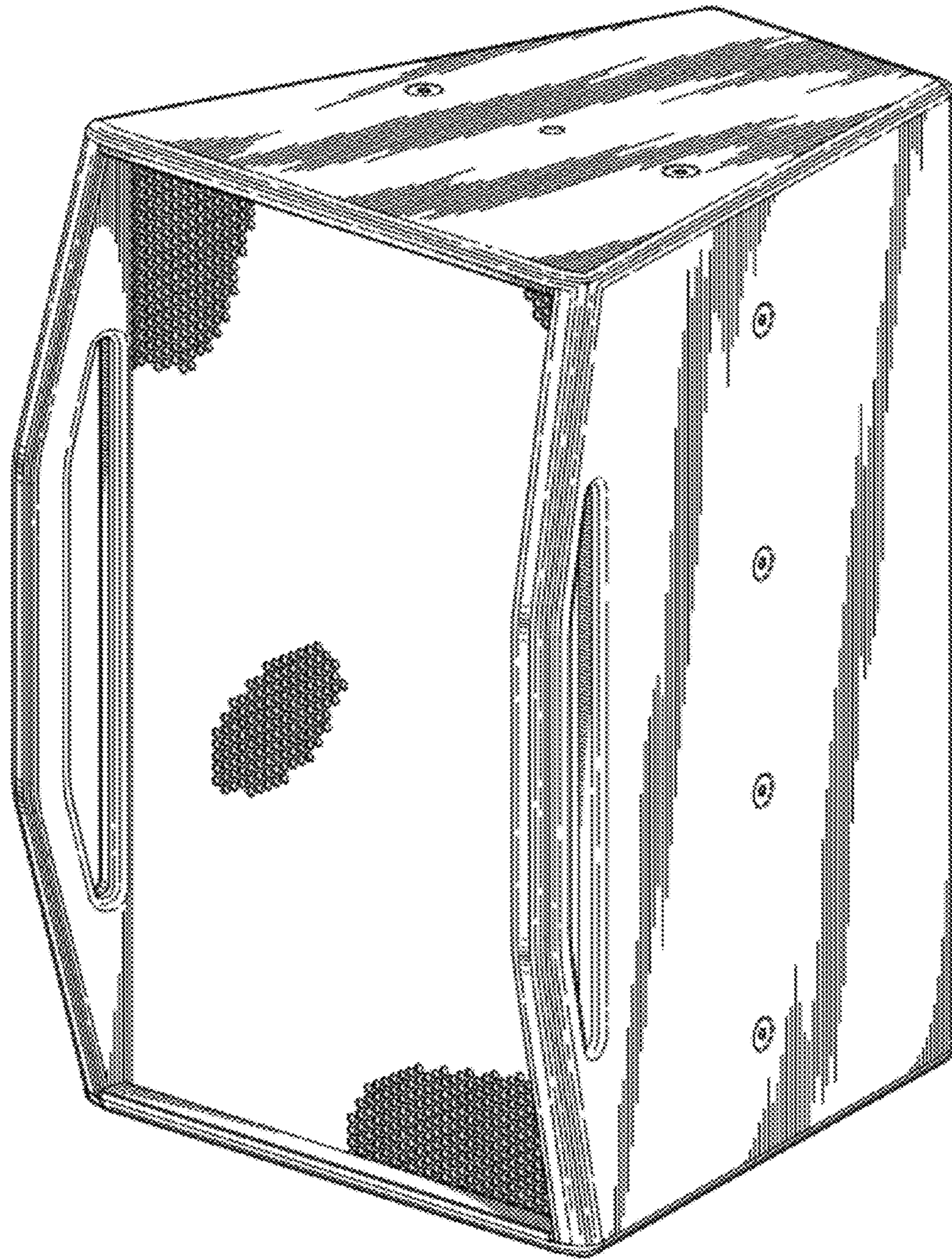
FIG. 6 is a bottom plan view thereof.

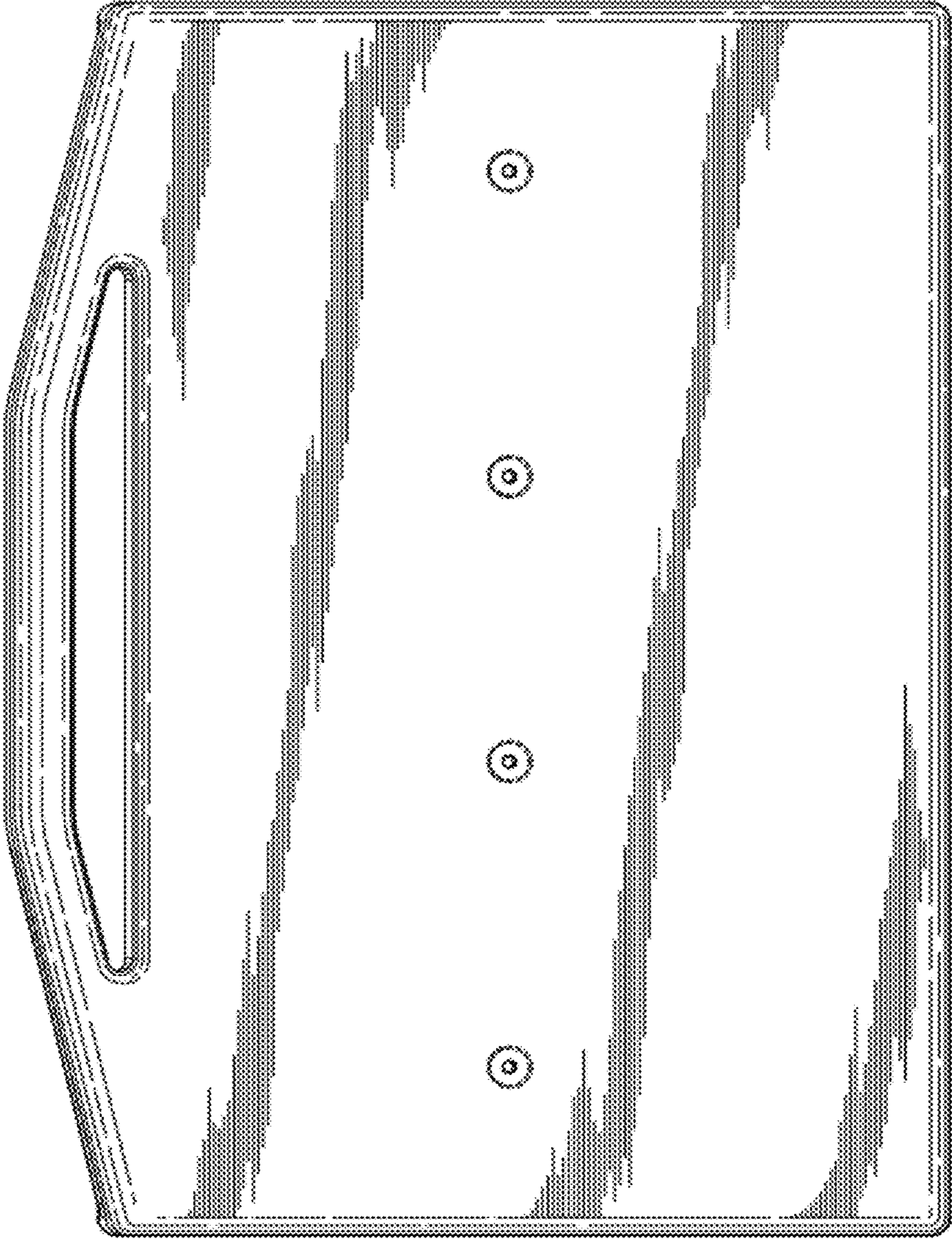






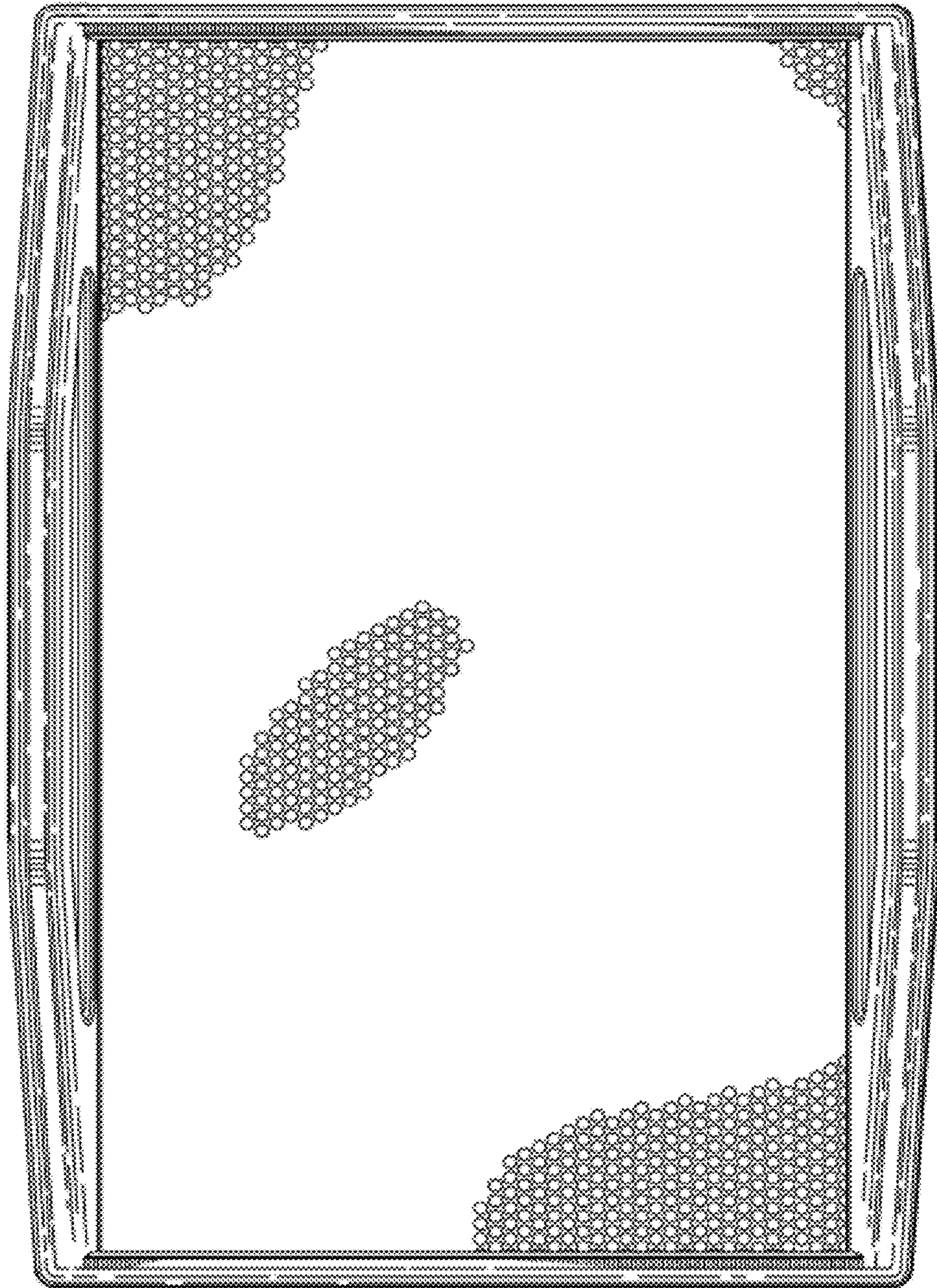

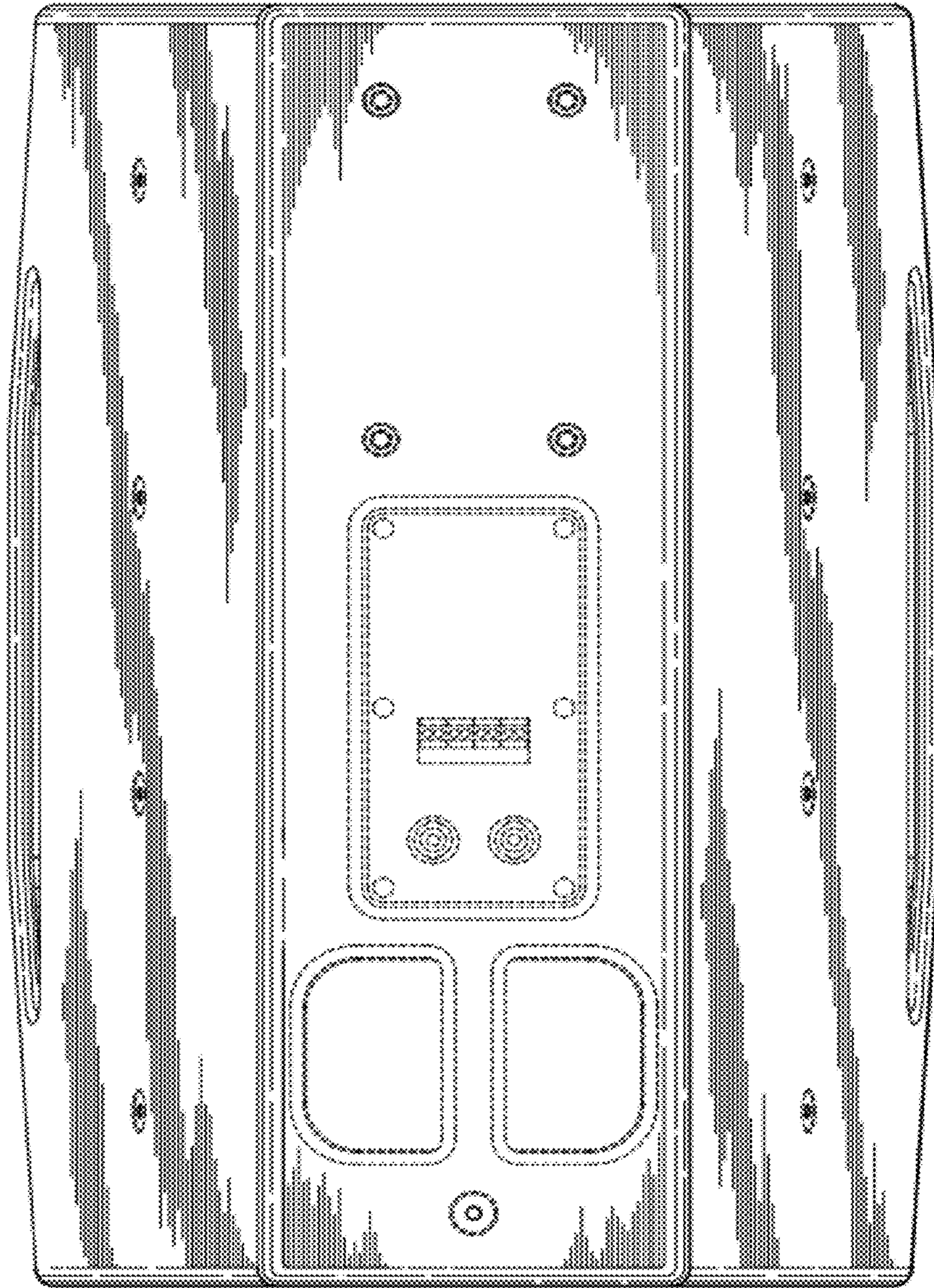

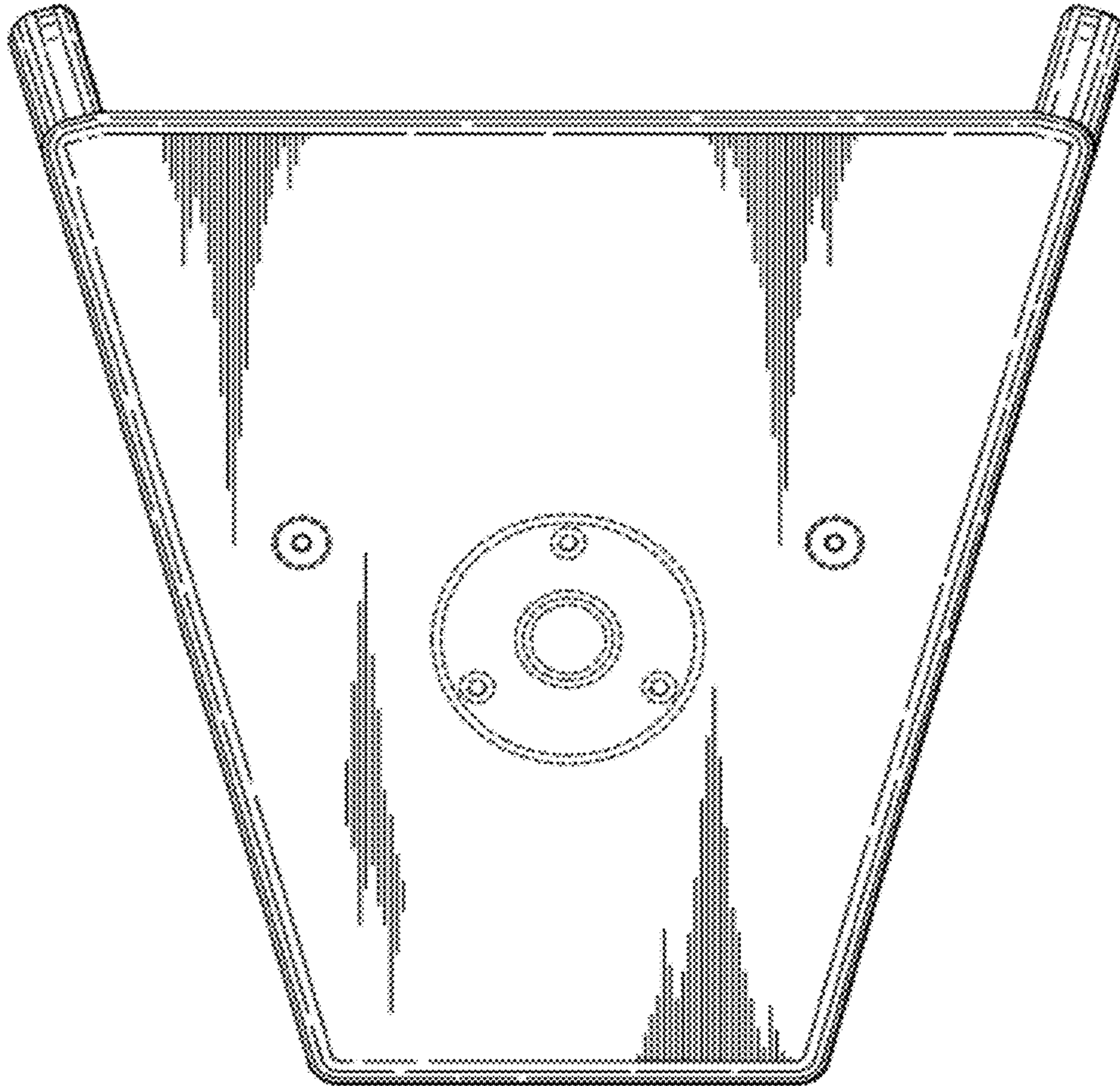

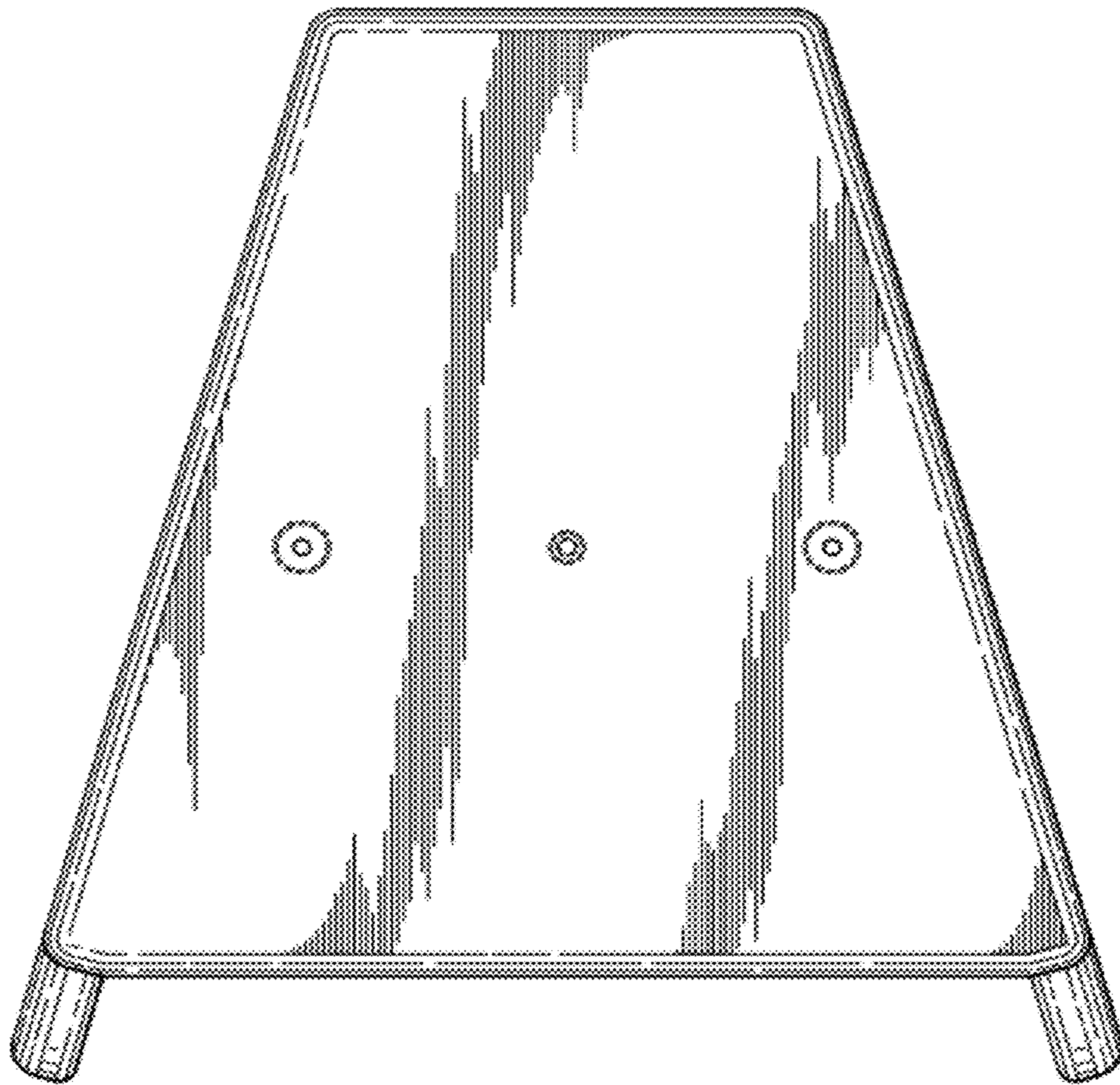
