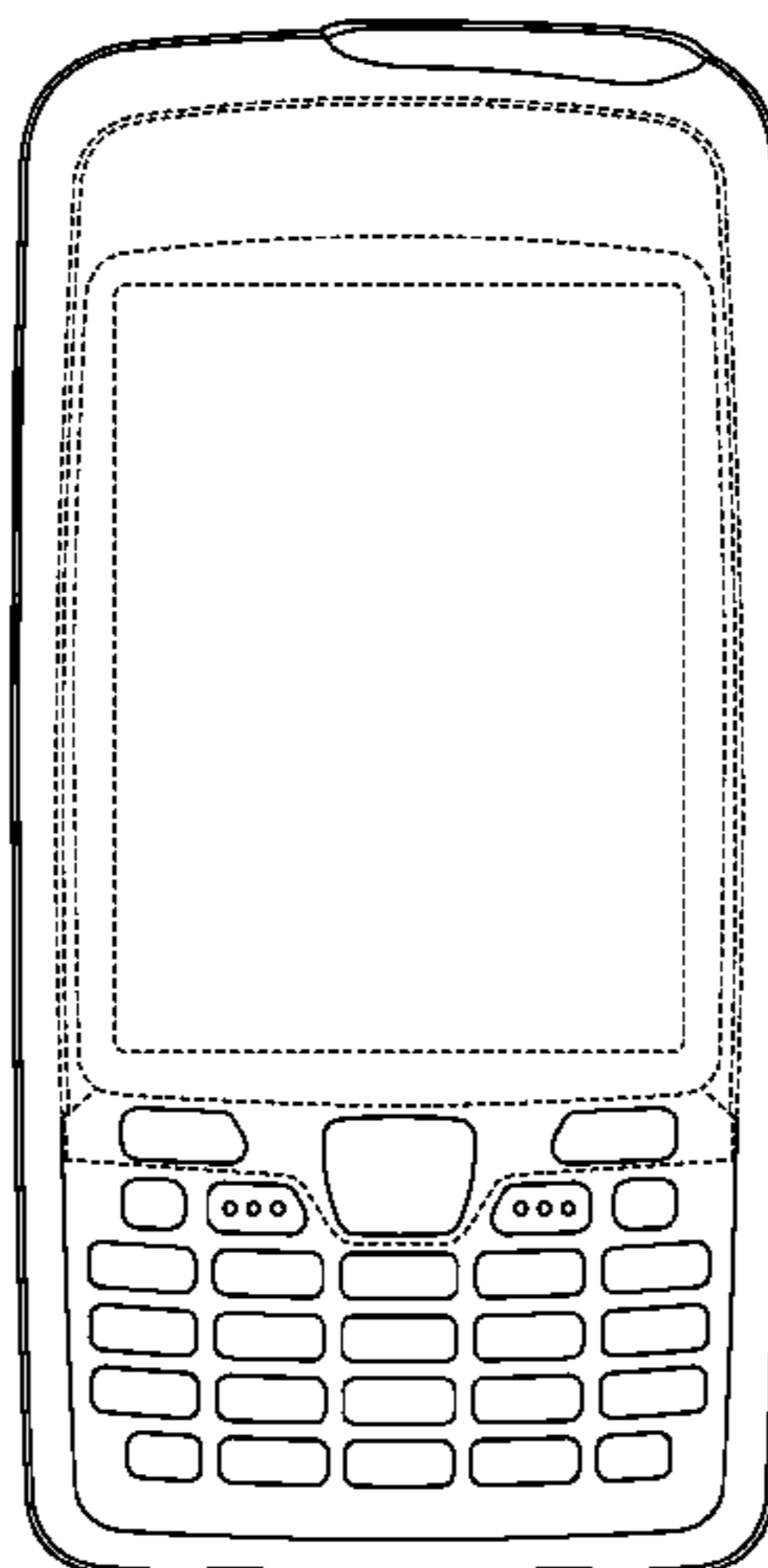
(57) **CLAIM**

The ornamental design for a portable housing, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a portable housing;
FIG. 2 is a first side view thereof;
FIG. 3 is an opposite side view of the portable housing to the view show in FIG. 2;
FIG. 4 is a rear elevation view of the portable housing of FIG. 1;
FIG. 5 is a top view thereof; and,
FIG. 6 is a bottom view thereof.
Broken lines and portions contained within broken lines are not claimed, not inclusive of any solid line elements present on the same surface. On the front face of the portable housing, the claimed portions of the framing extend up to the start of broken line.

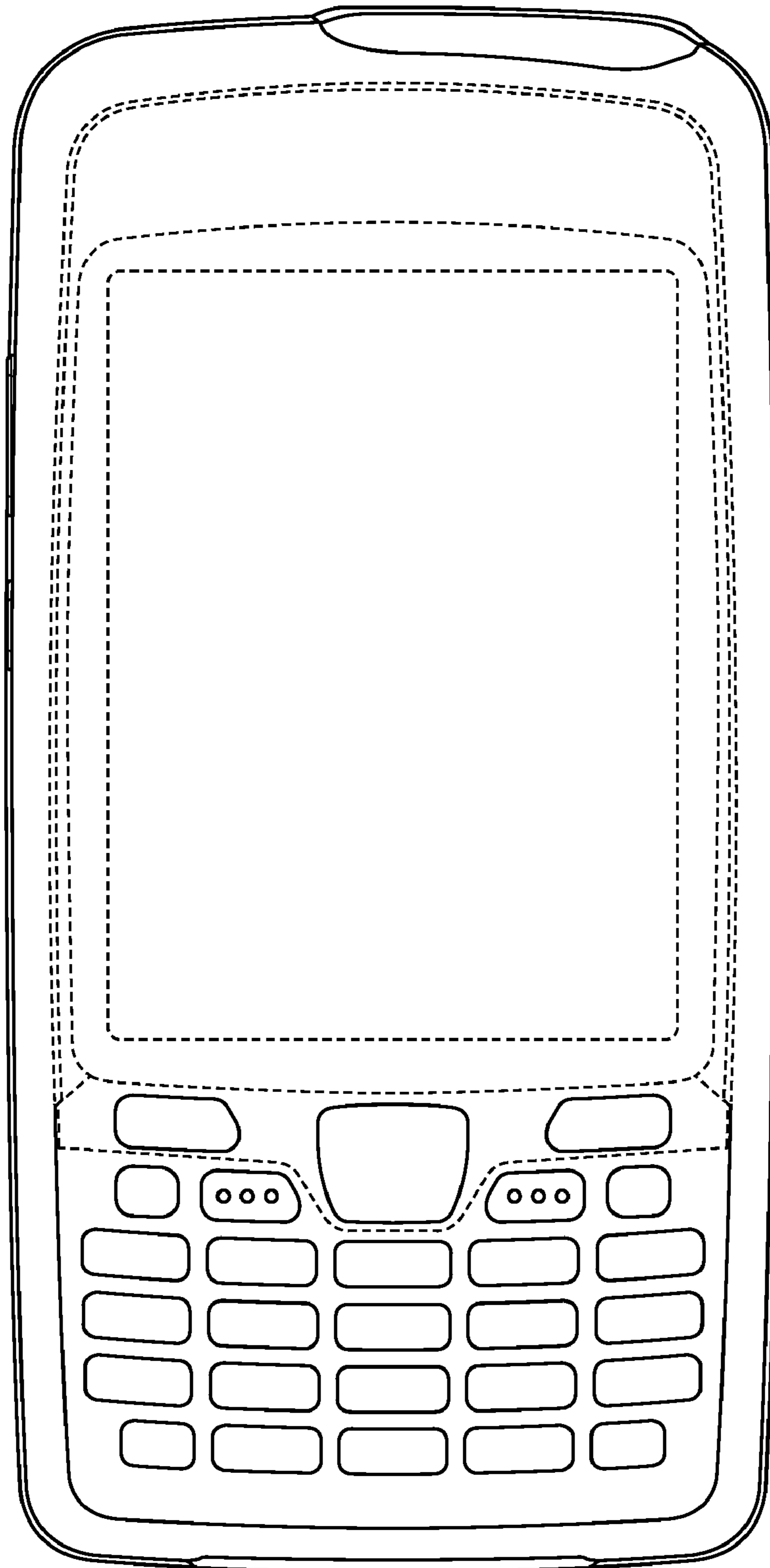

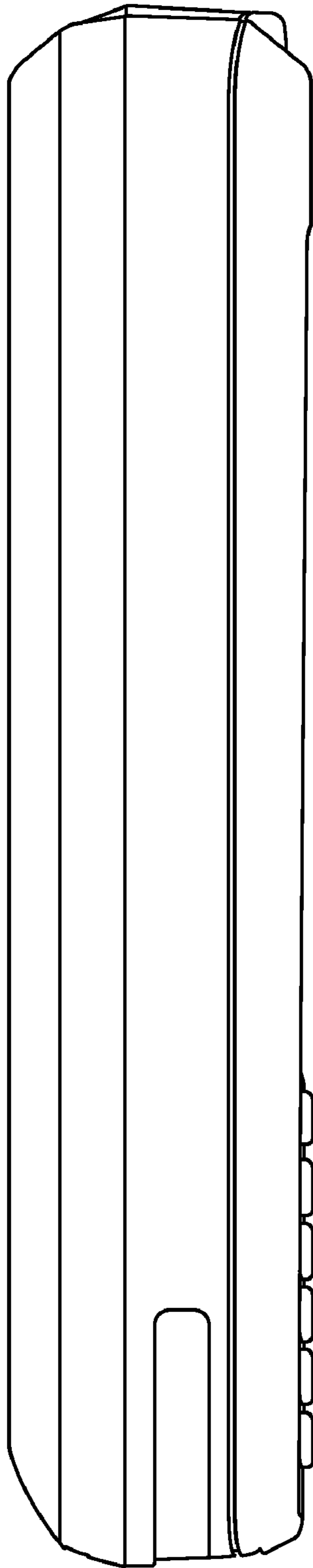

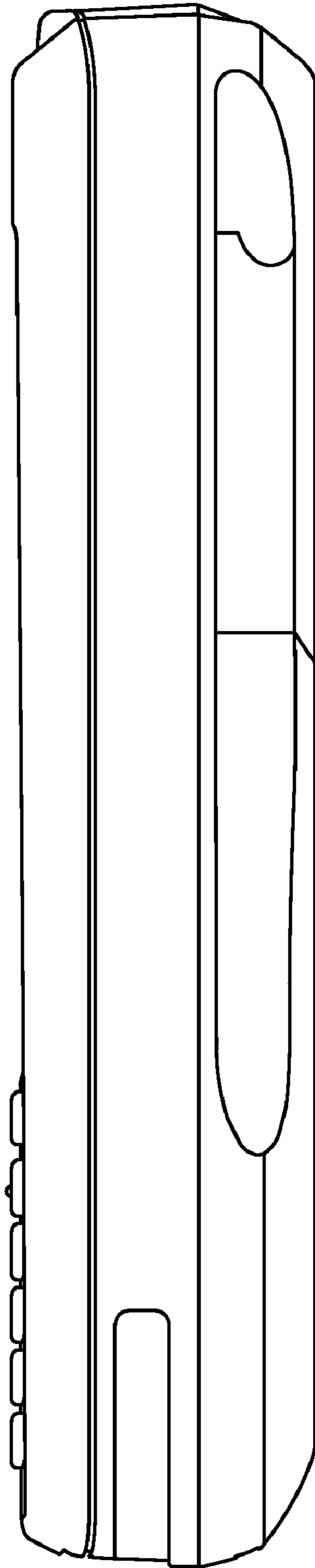

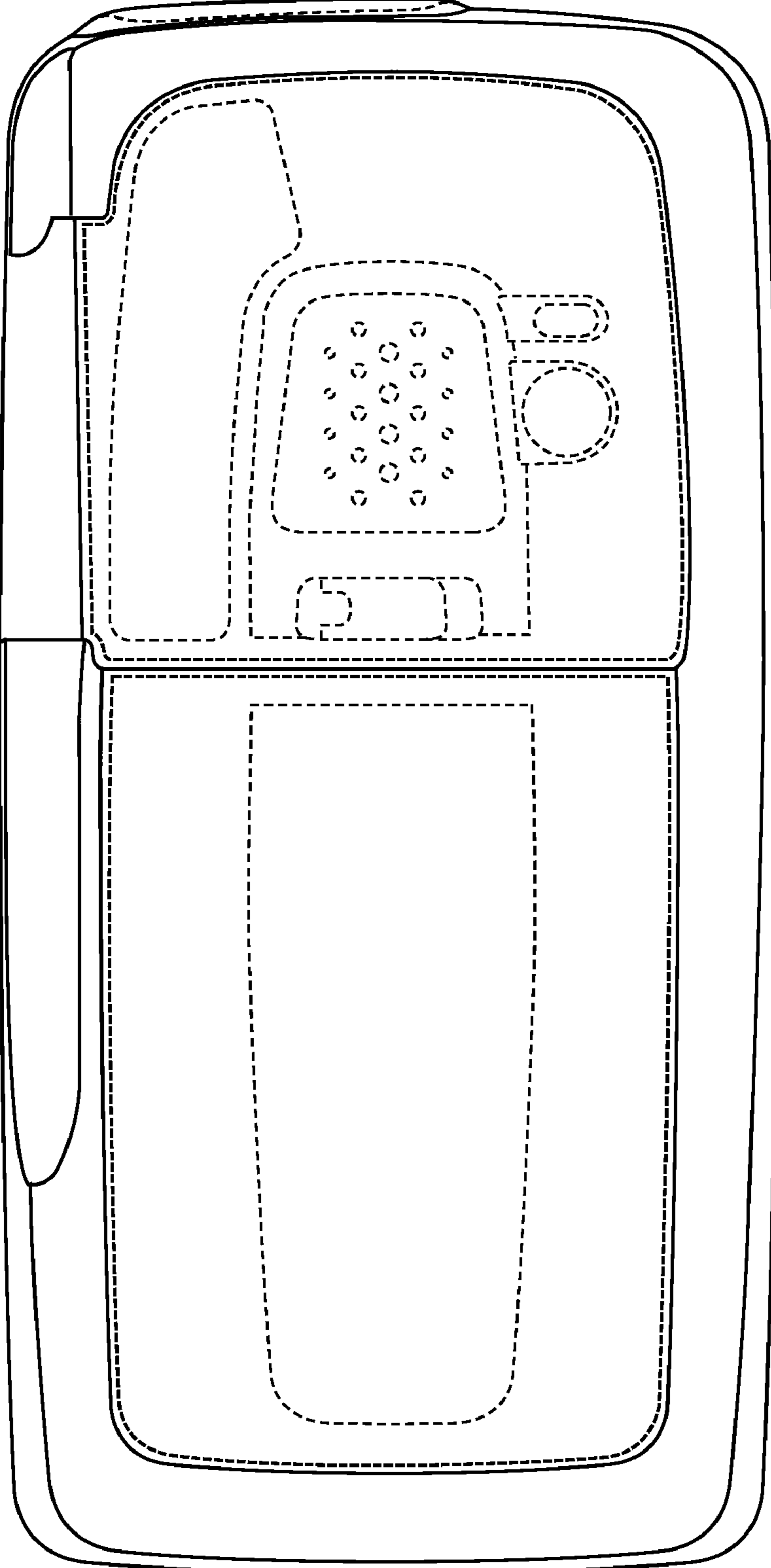

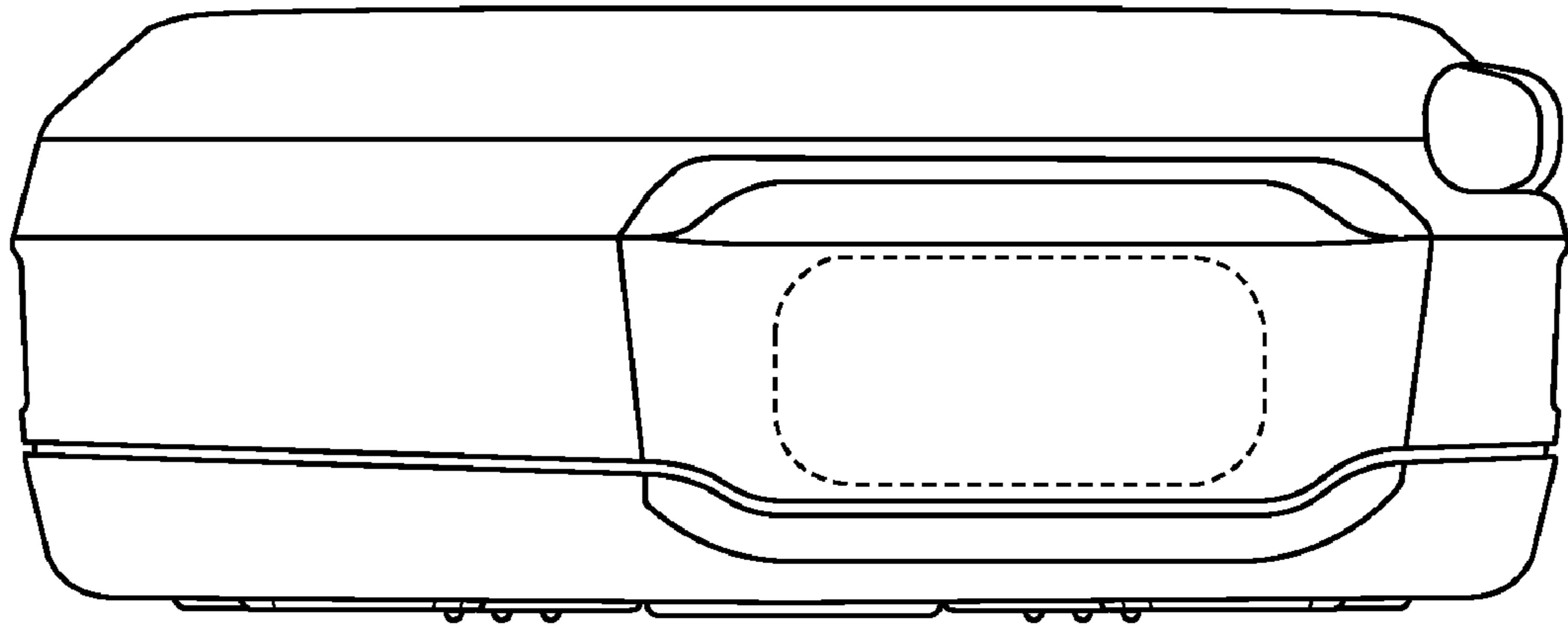

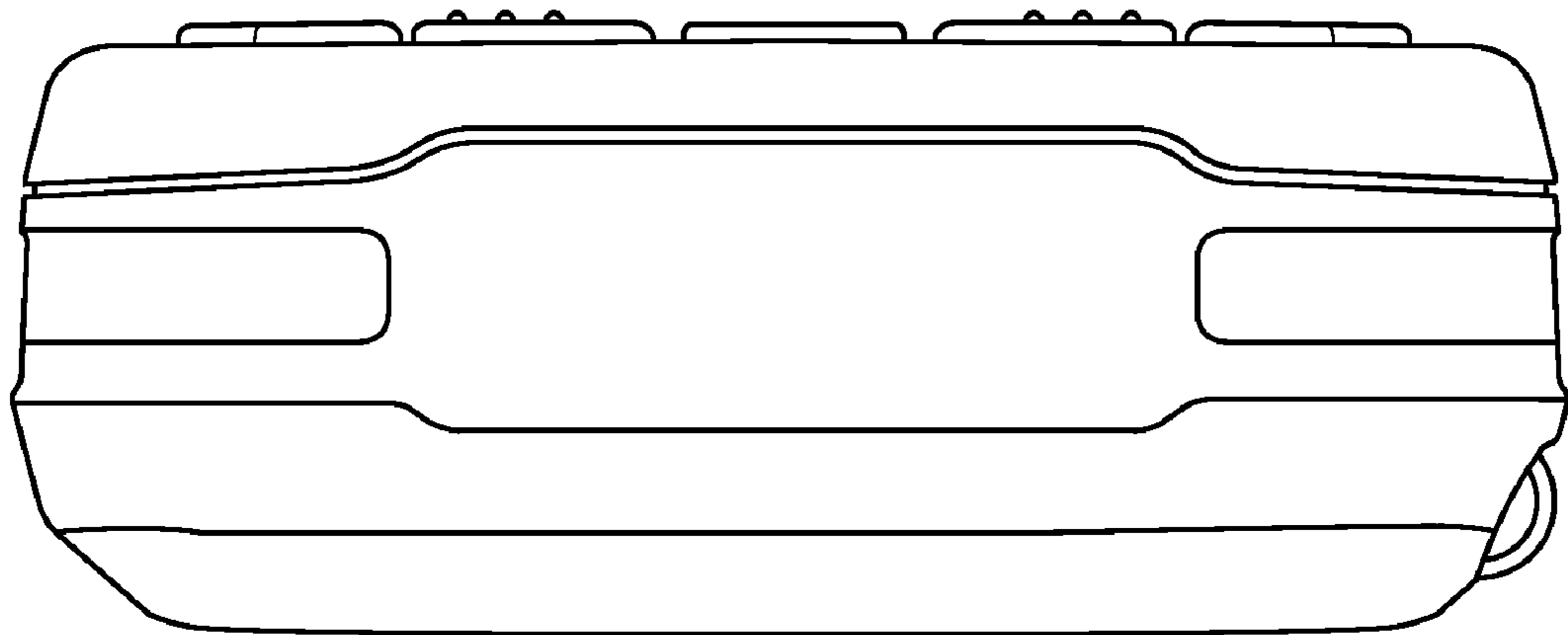
