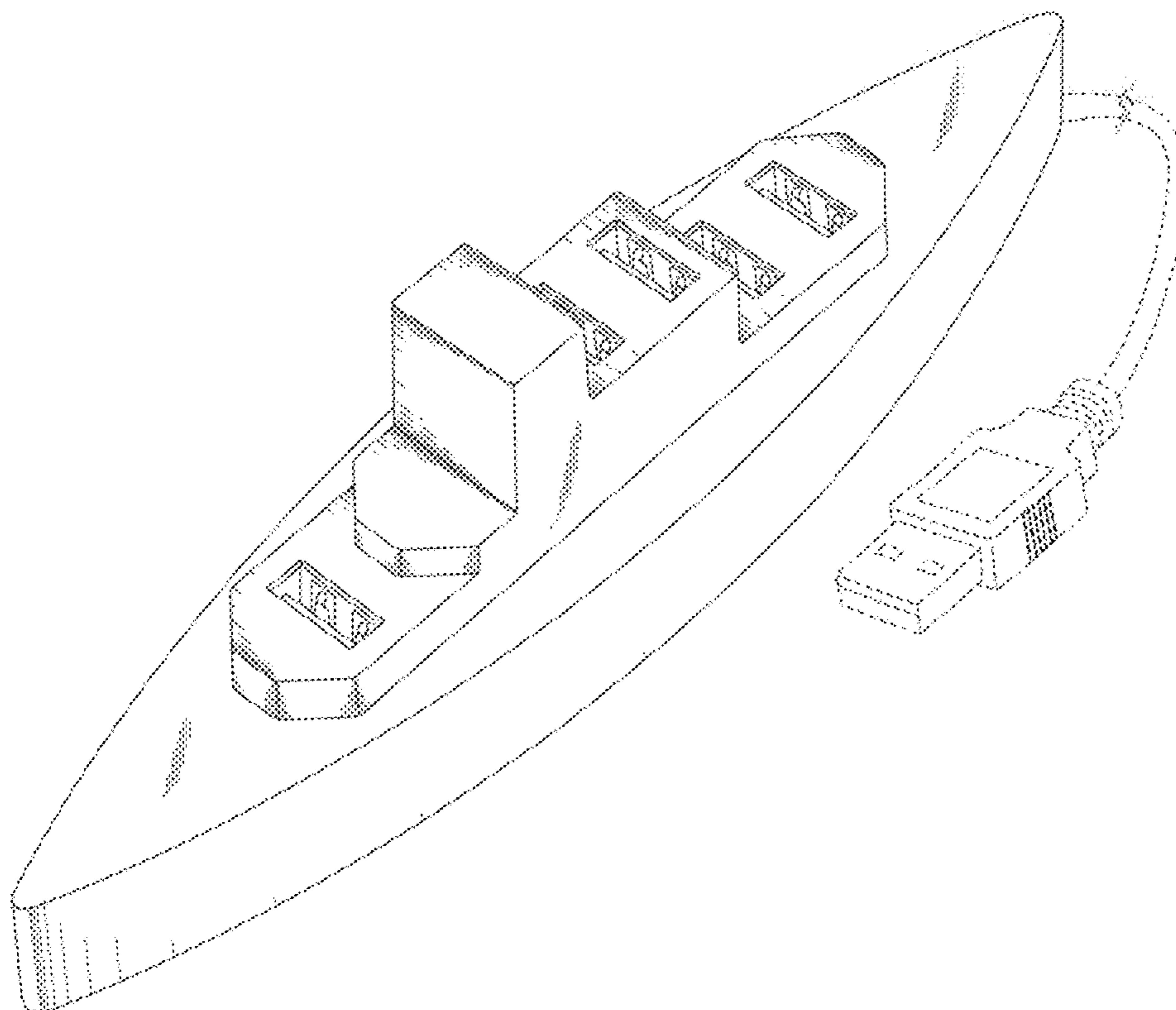

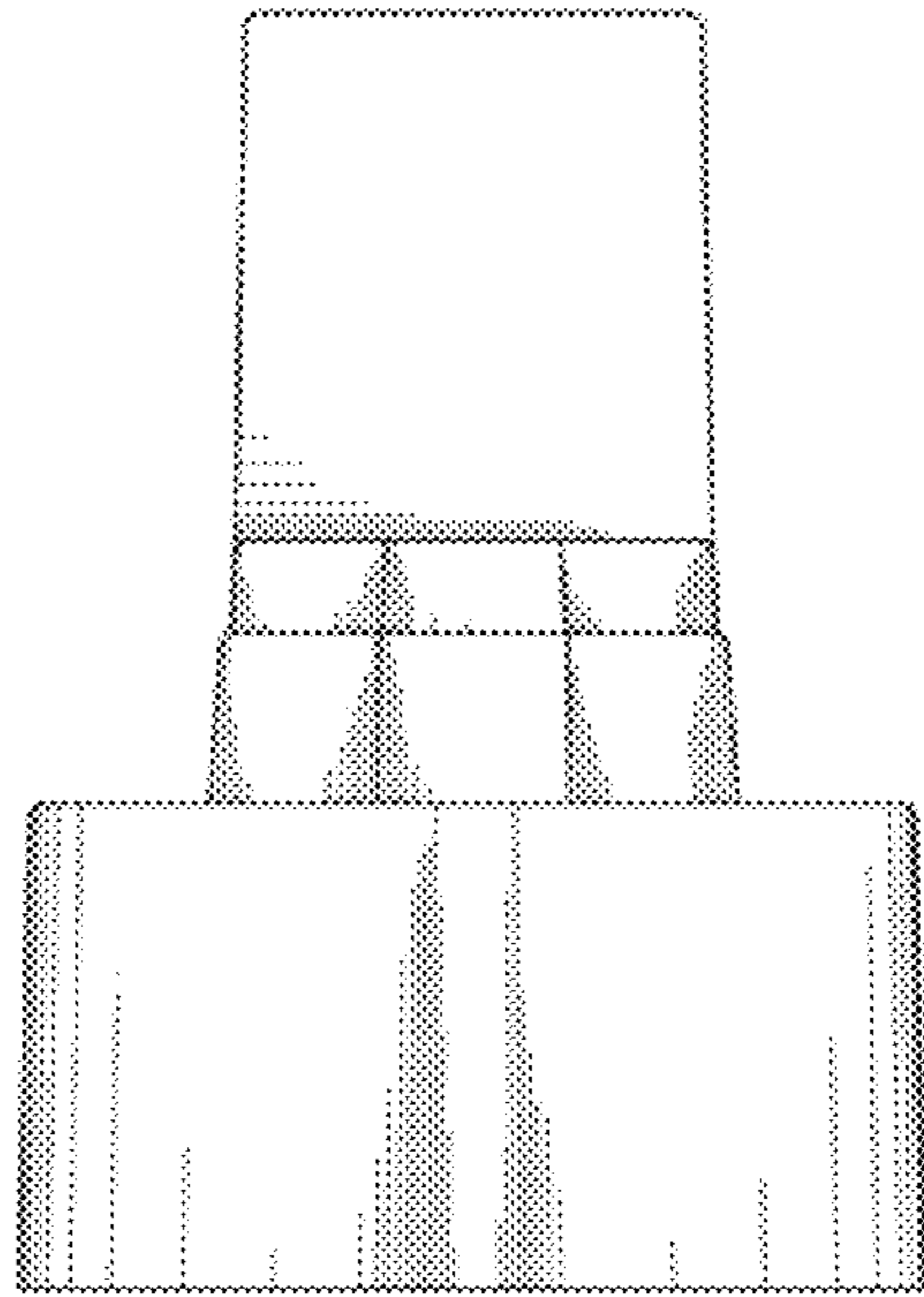
The ornamental design for a USB hub resembling a battleship, as shown and described.

**DESCRIPTION**

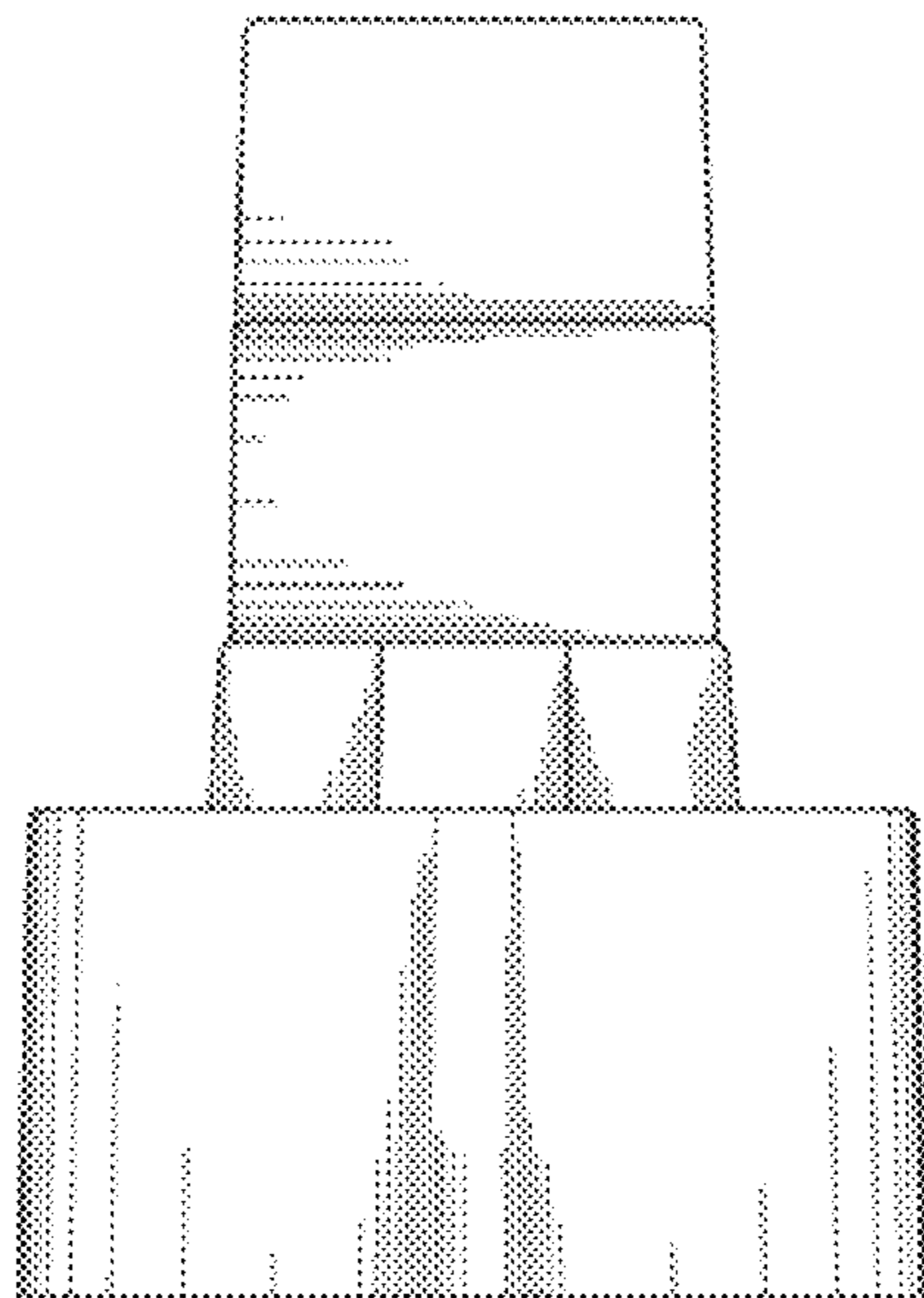
FIG. 1 is a front elevational view of the USB hub resembling a battleship showing our design;

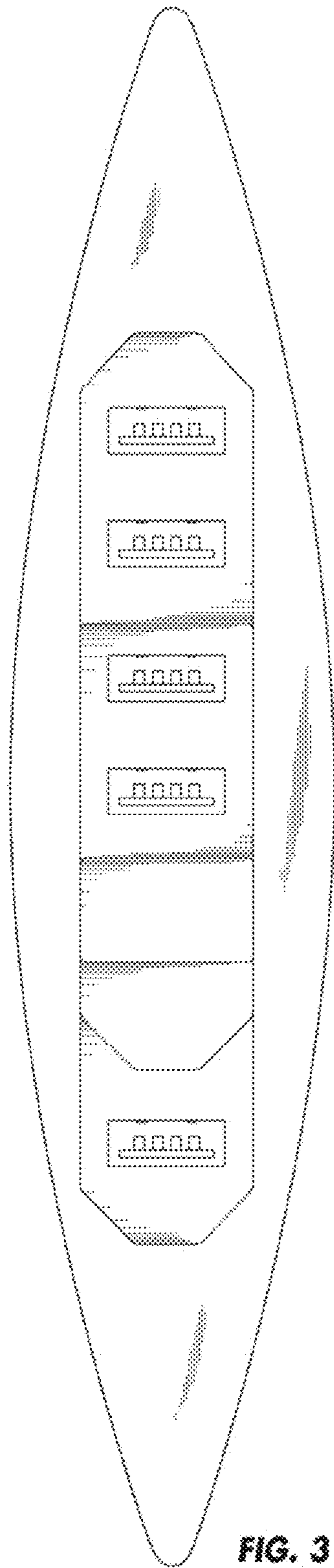

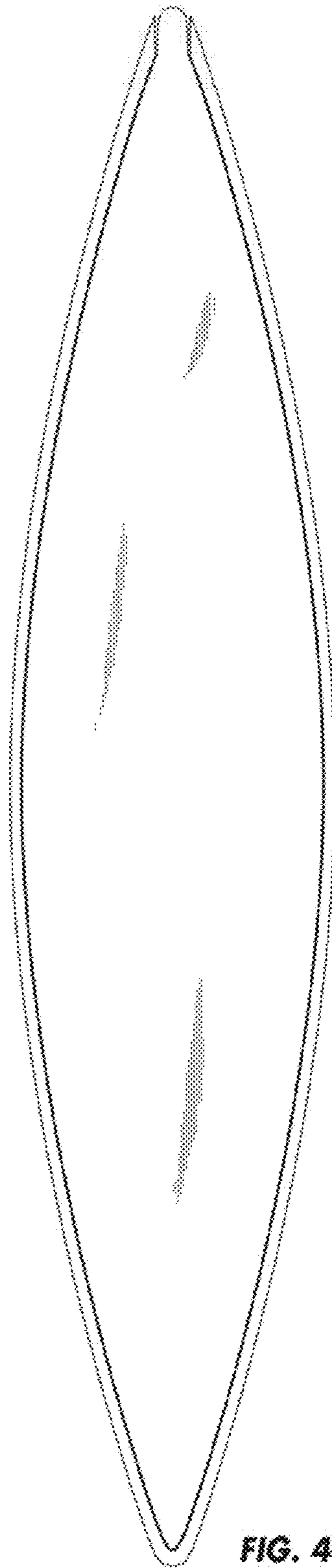
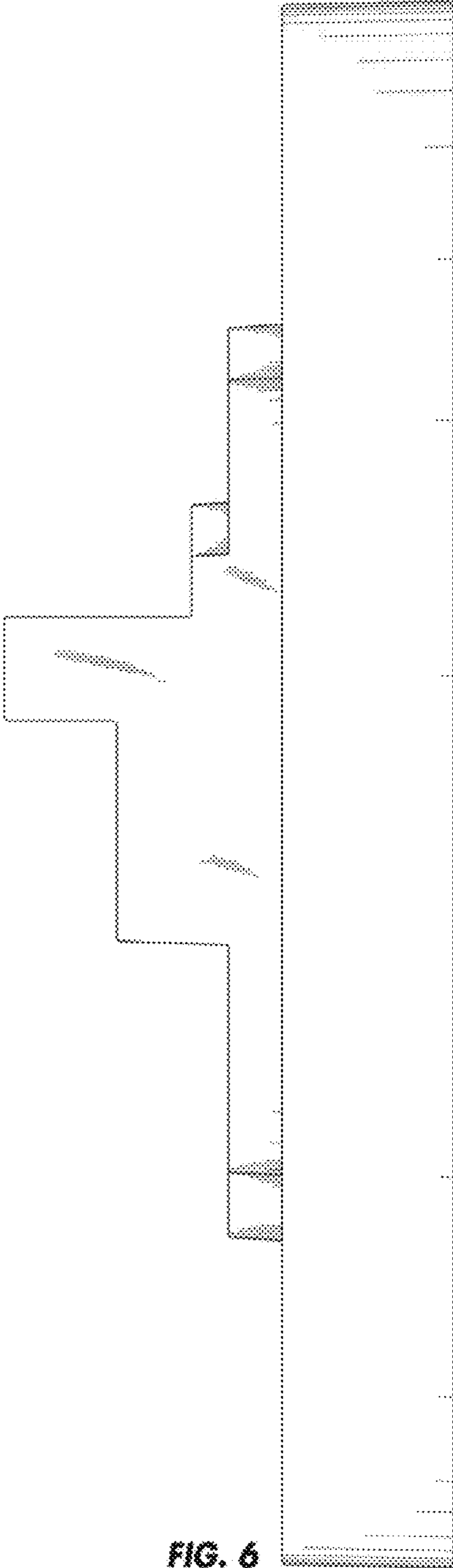
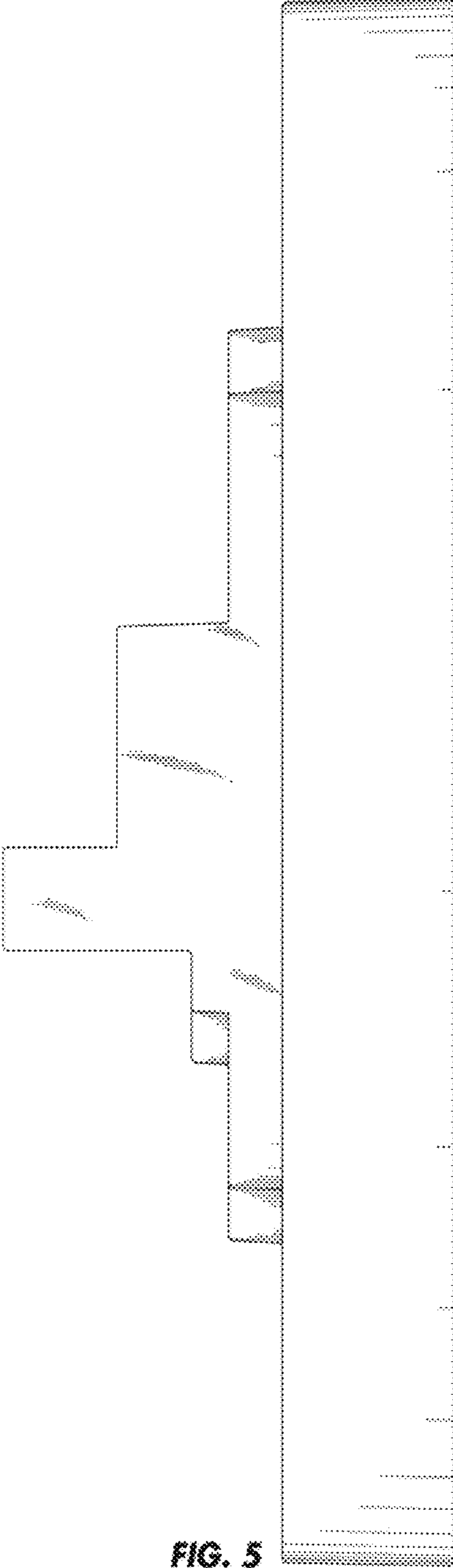

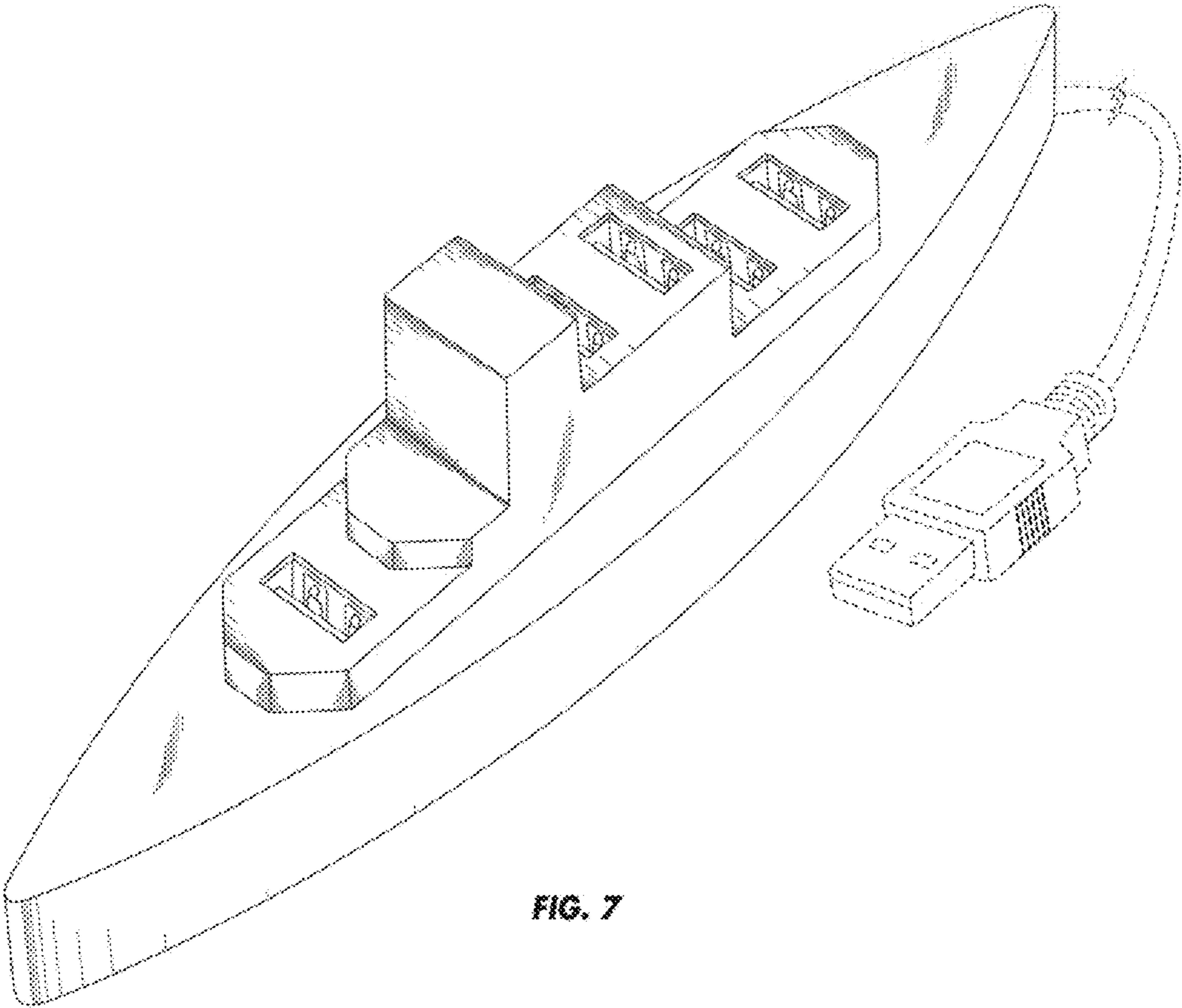
