(57) **CLAIM**

I claim the ornamental design for a bracelet with a USB flash drive pocket, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a bracelet with a USB flash drive pocket, showing my new design in a closed configuration;

FIG. 2 is a rear perspective view of FIG. 1;

FIG. 3 is a top plan view of FIG. 1, the bottom plan view being a mirror image thereof;

FIG. 4 is a rear elevational view of FIG. 1;

FIG. 5 is a front elevational view of FIG. 1;

FIG. 6 is a right-side elevational view of FIG. 1;

FIG. 7 is a left-side elevational view of FIG. 1;

FIG. 8 is a front perspective view thereof, illustrated in an open configuration; and,

FIG. 9 is a rear perspective view of FIG. 8.

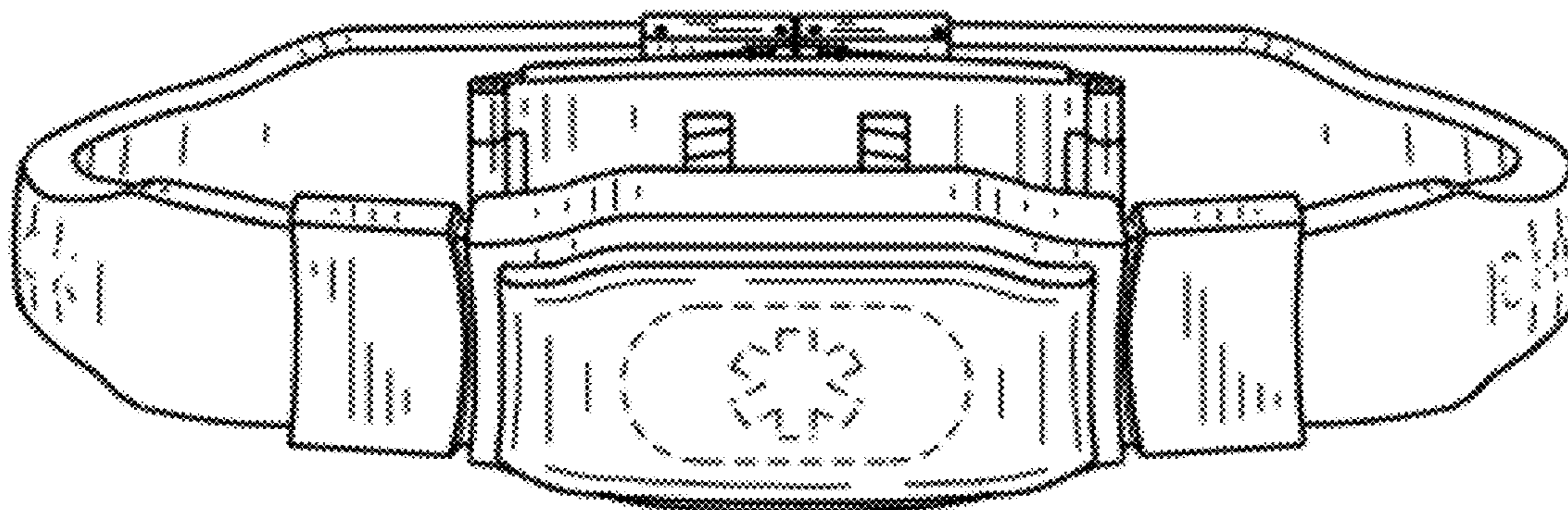
The broken lines showing a logo, USB flash drive, and text in the drawings depict environmental matter and form no part of the claimed design.

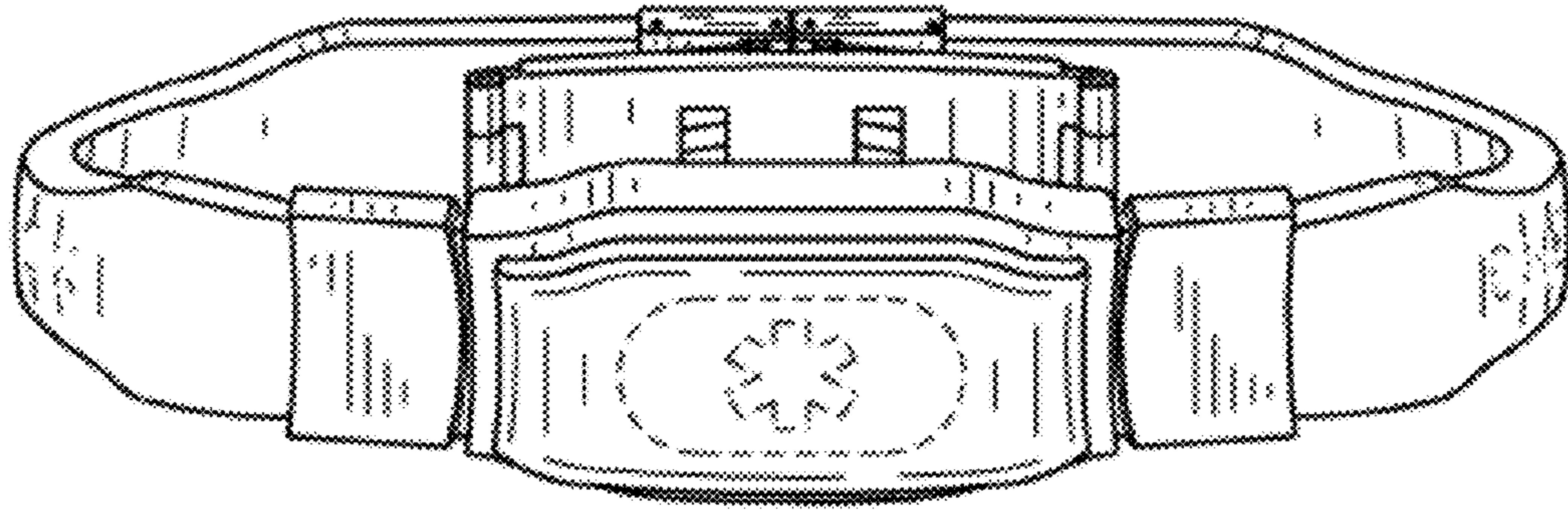

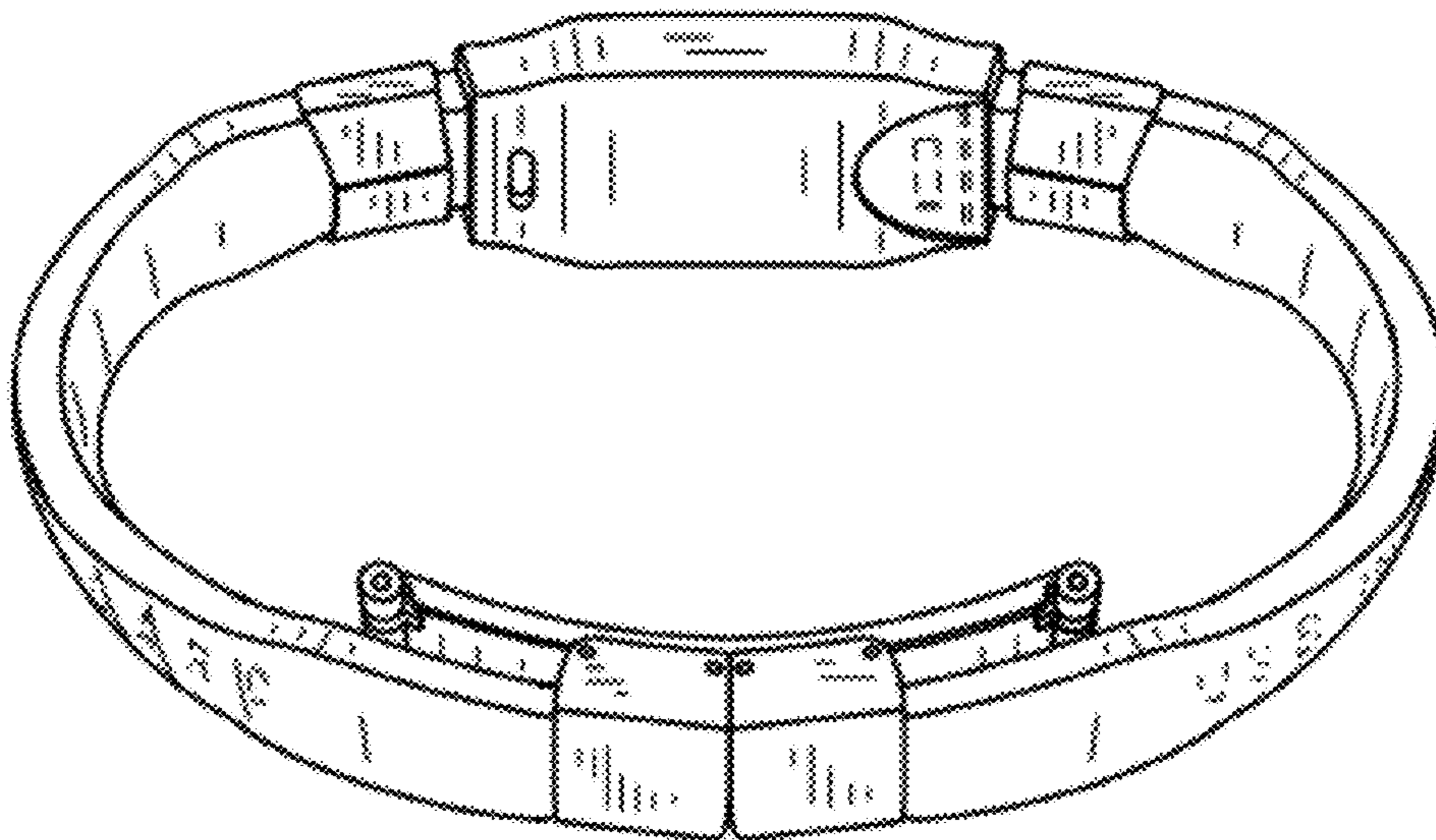

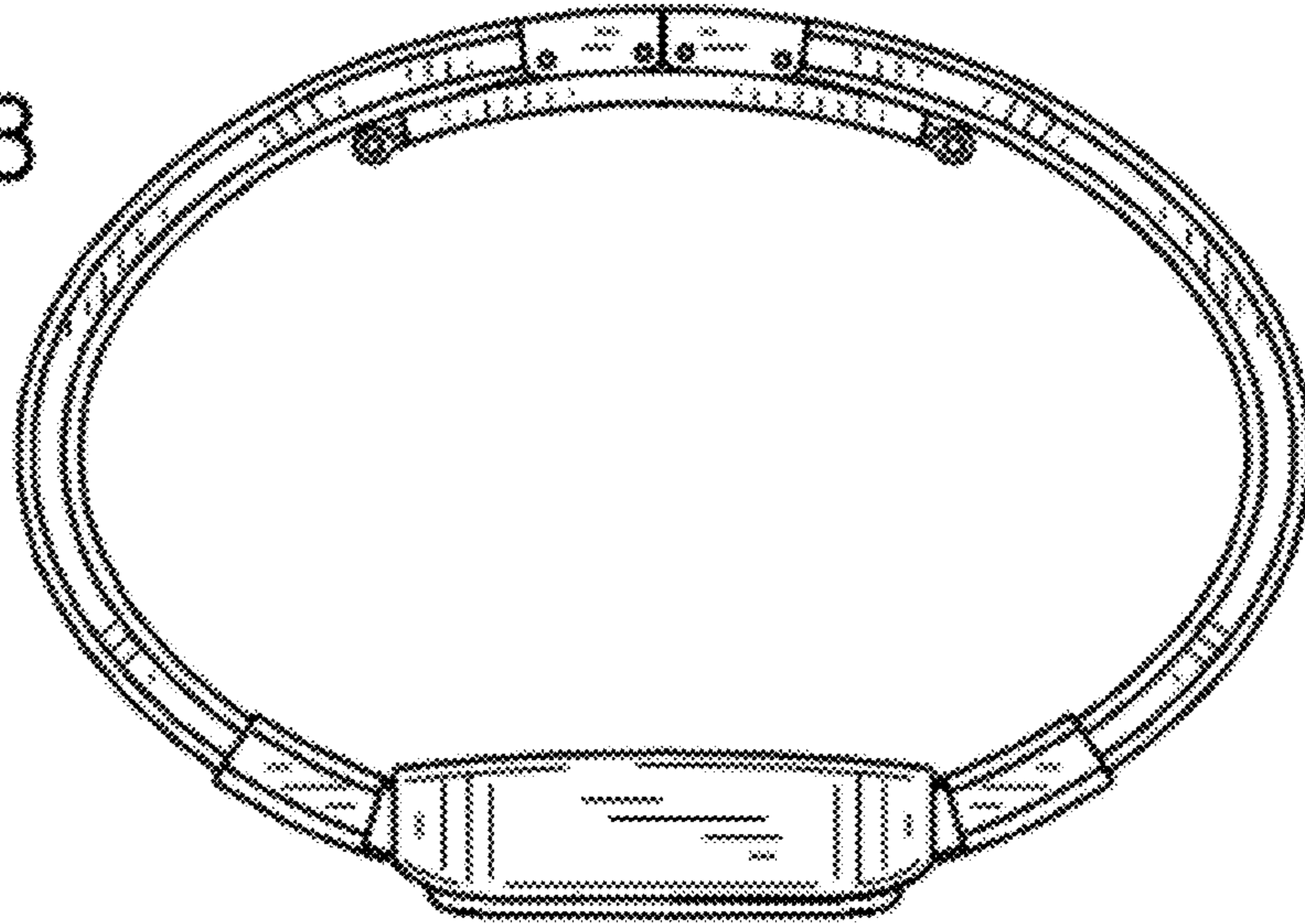

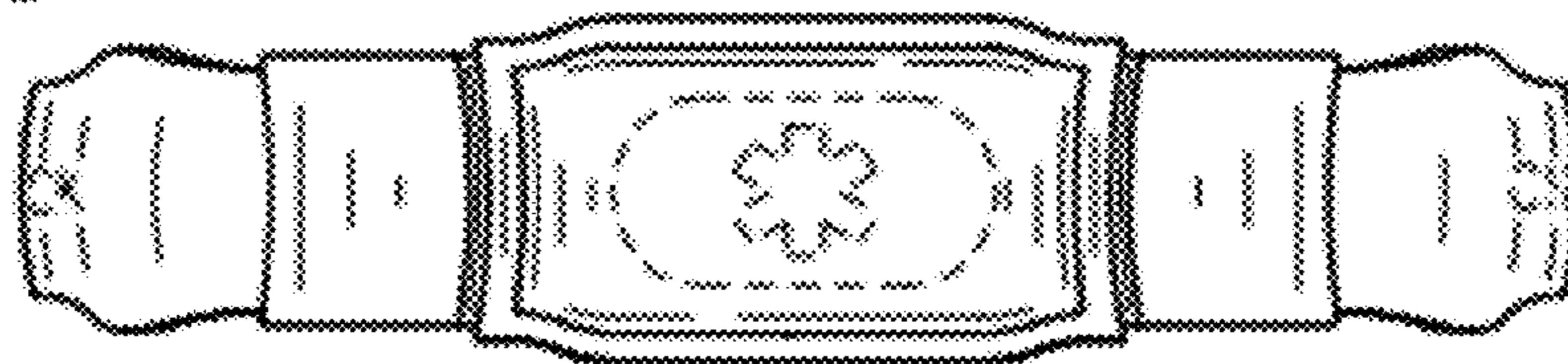

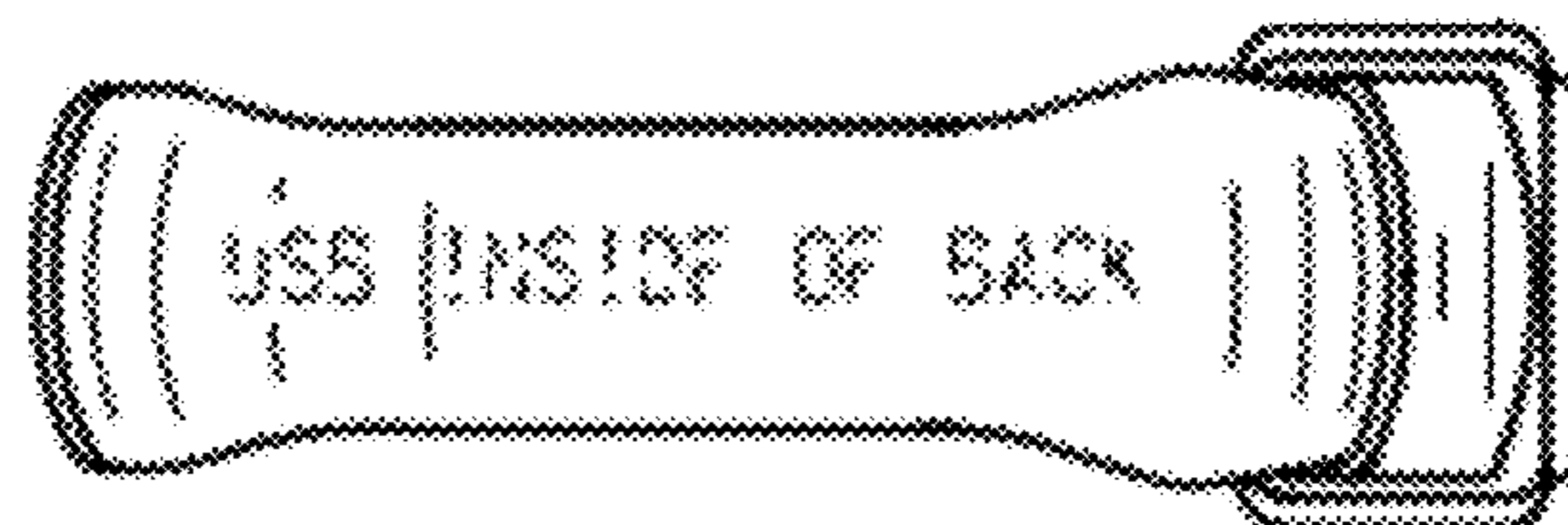
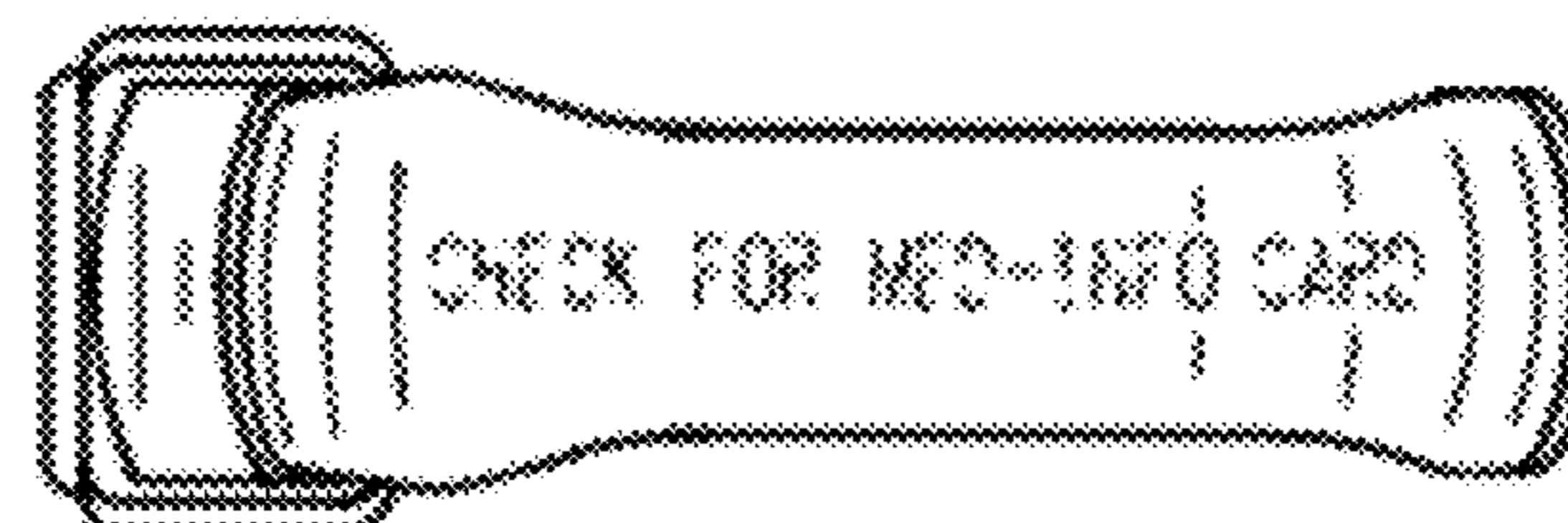

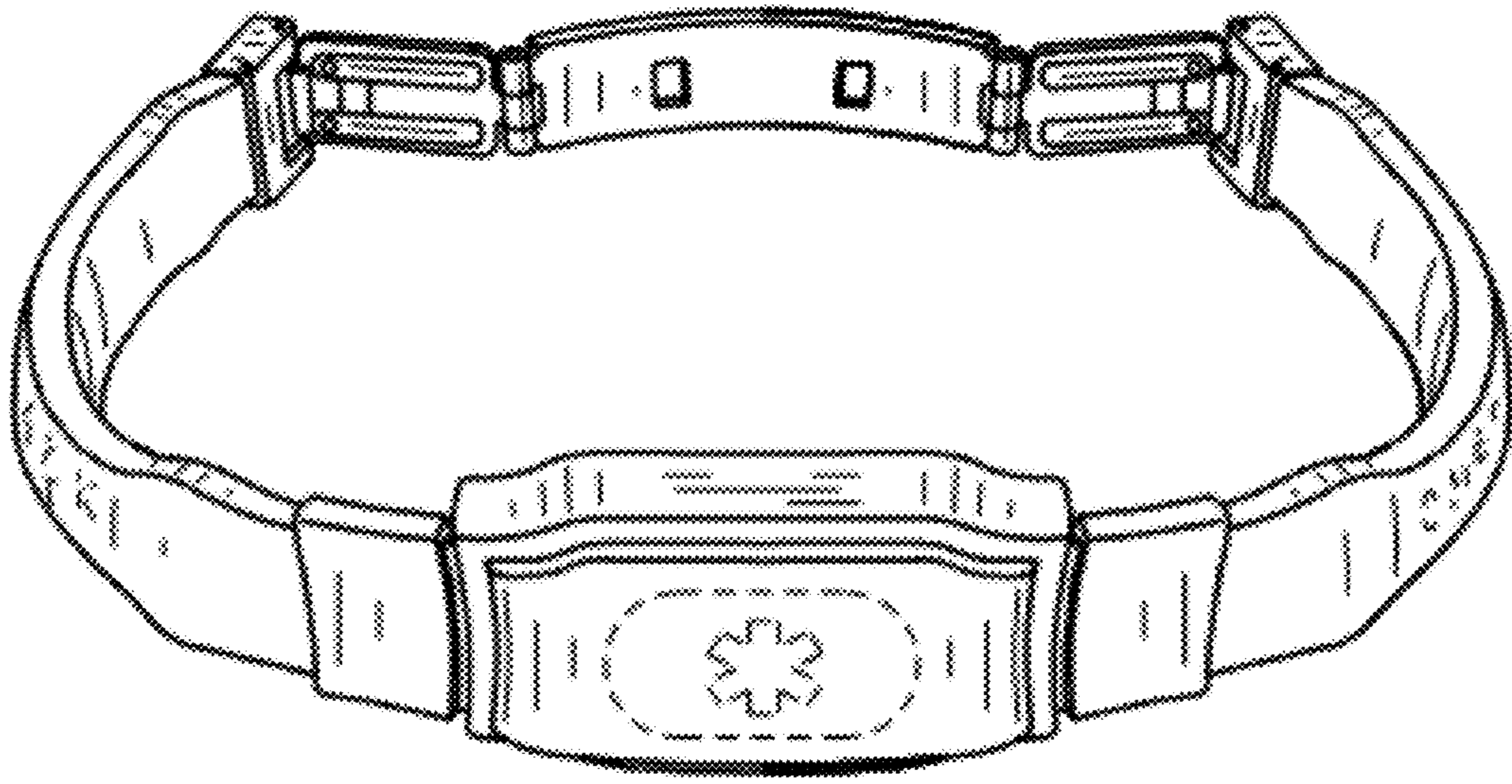

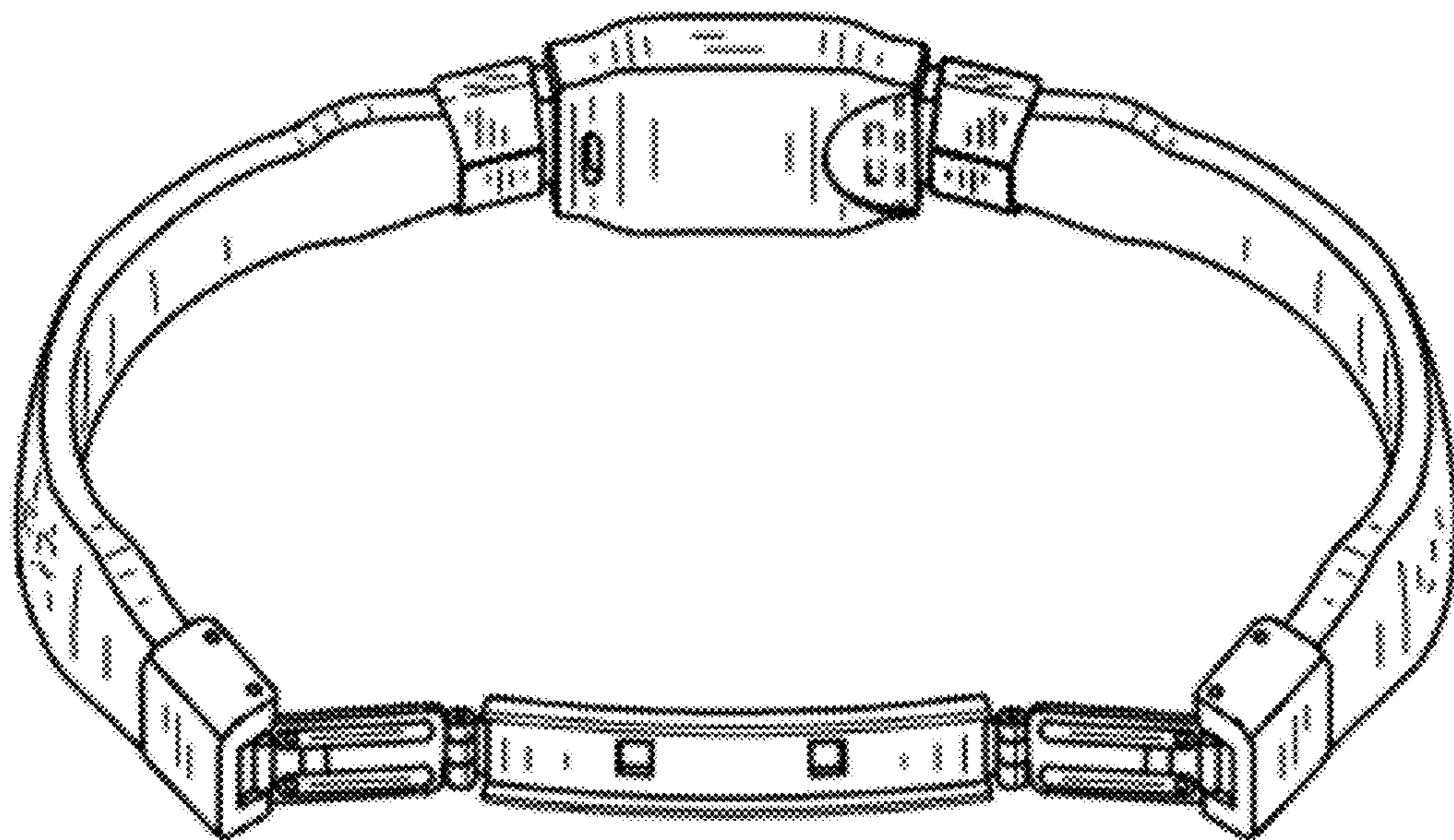
