The ornamental design for a display screen having a graphical user interface for providing supplemental information of a digital work, as shown and described.

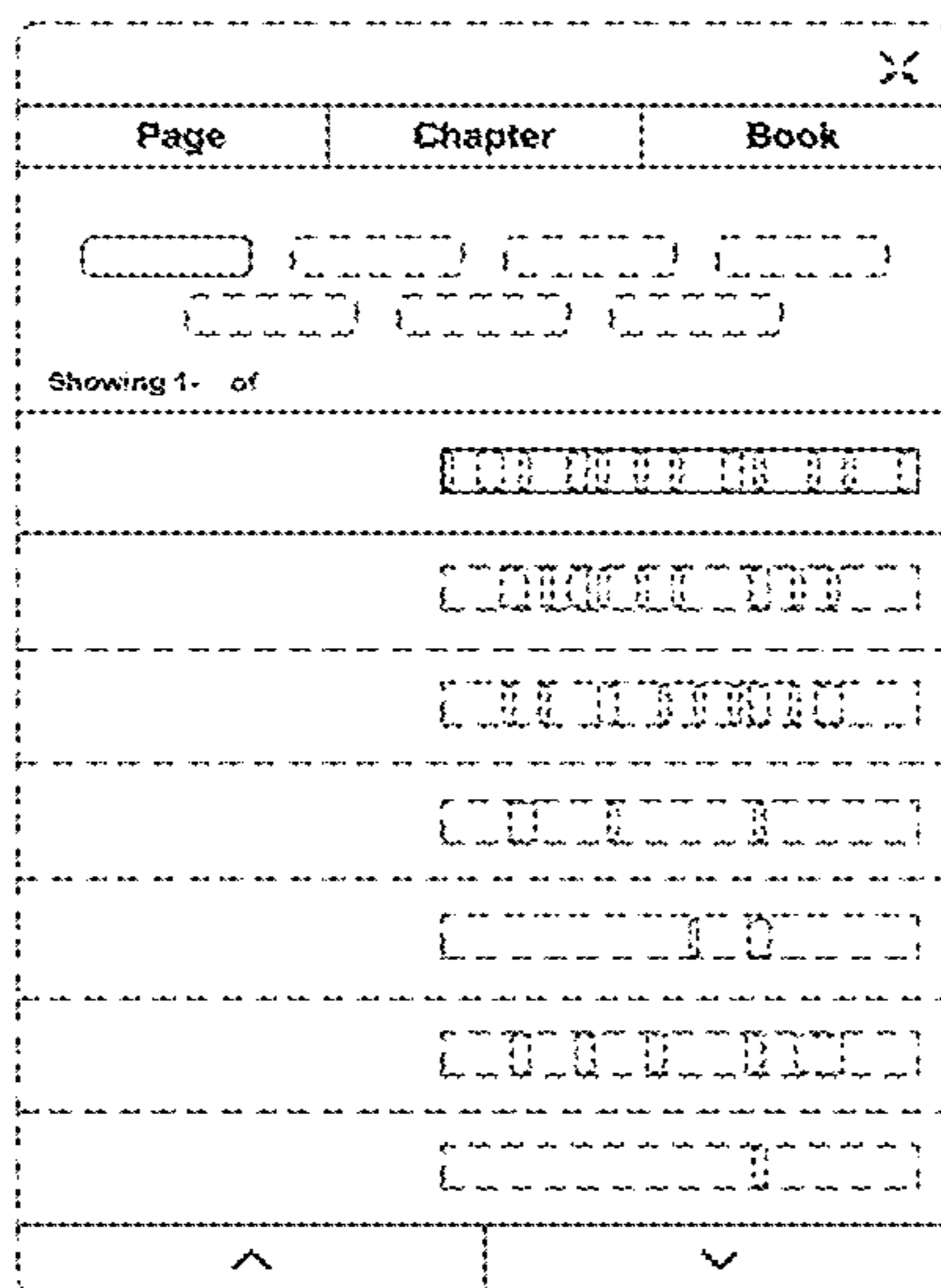
**DESCRIPTION**
