FIG. 16 is a front view of a second alternative vibrating ring of this invention;

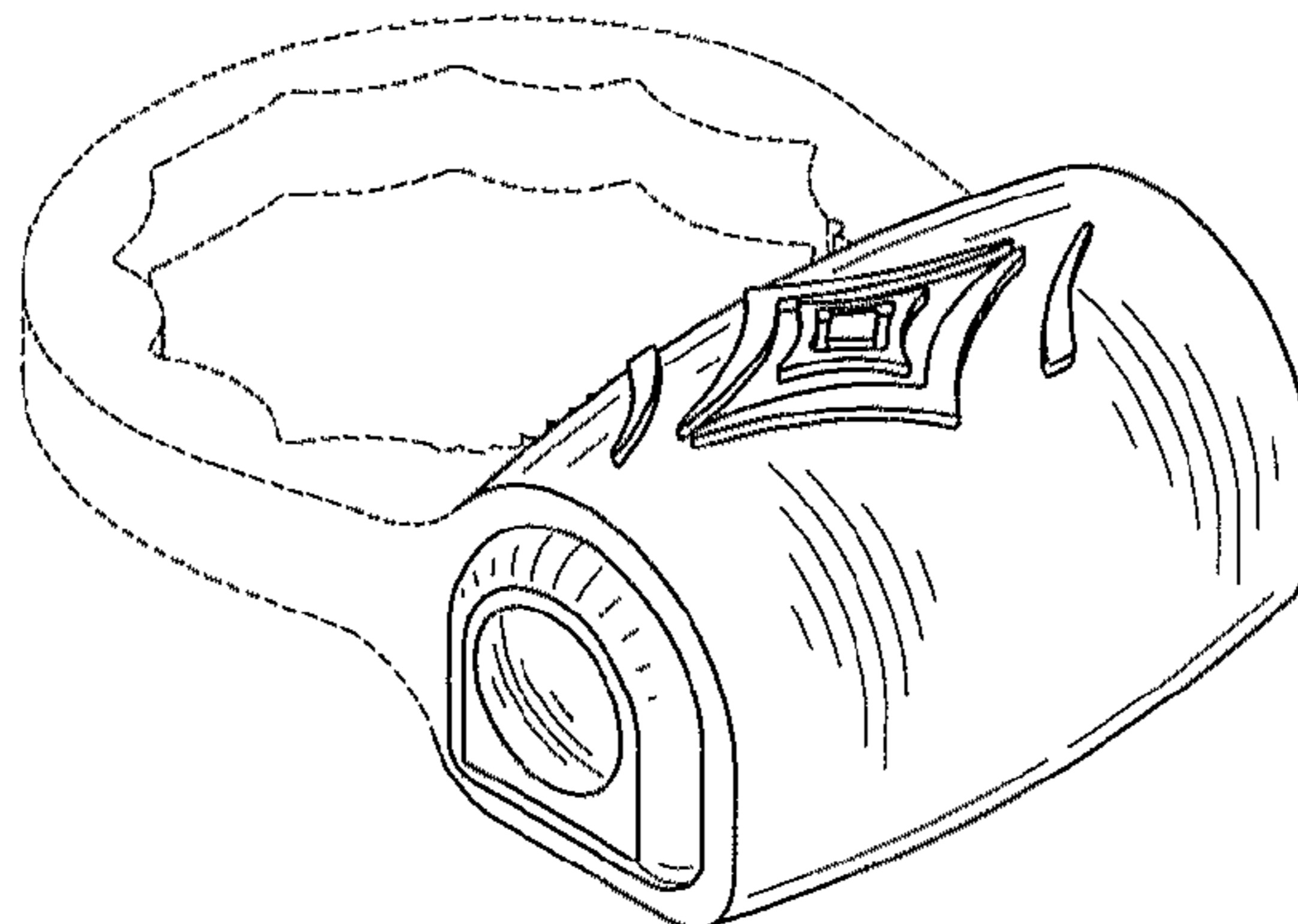


FIG. 17 is a rear view of a second alternative vibrating ring of this invention;

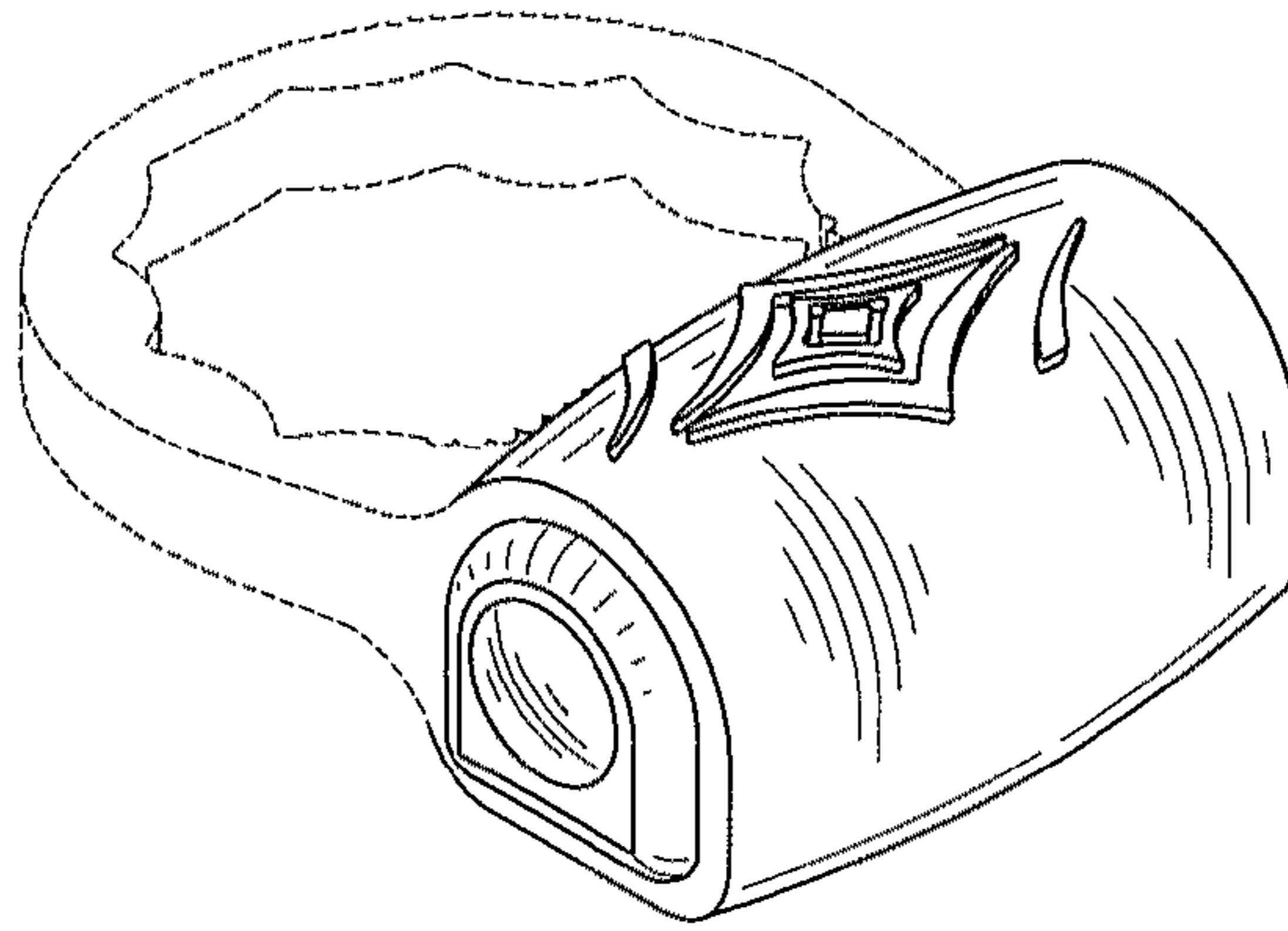

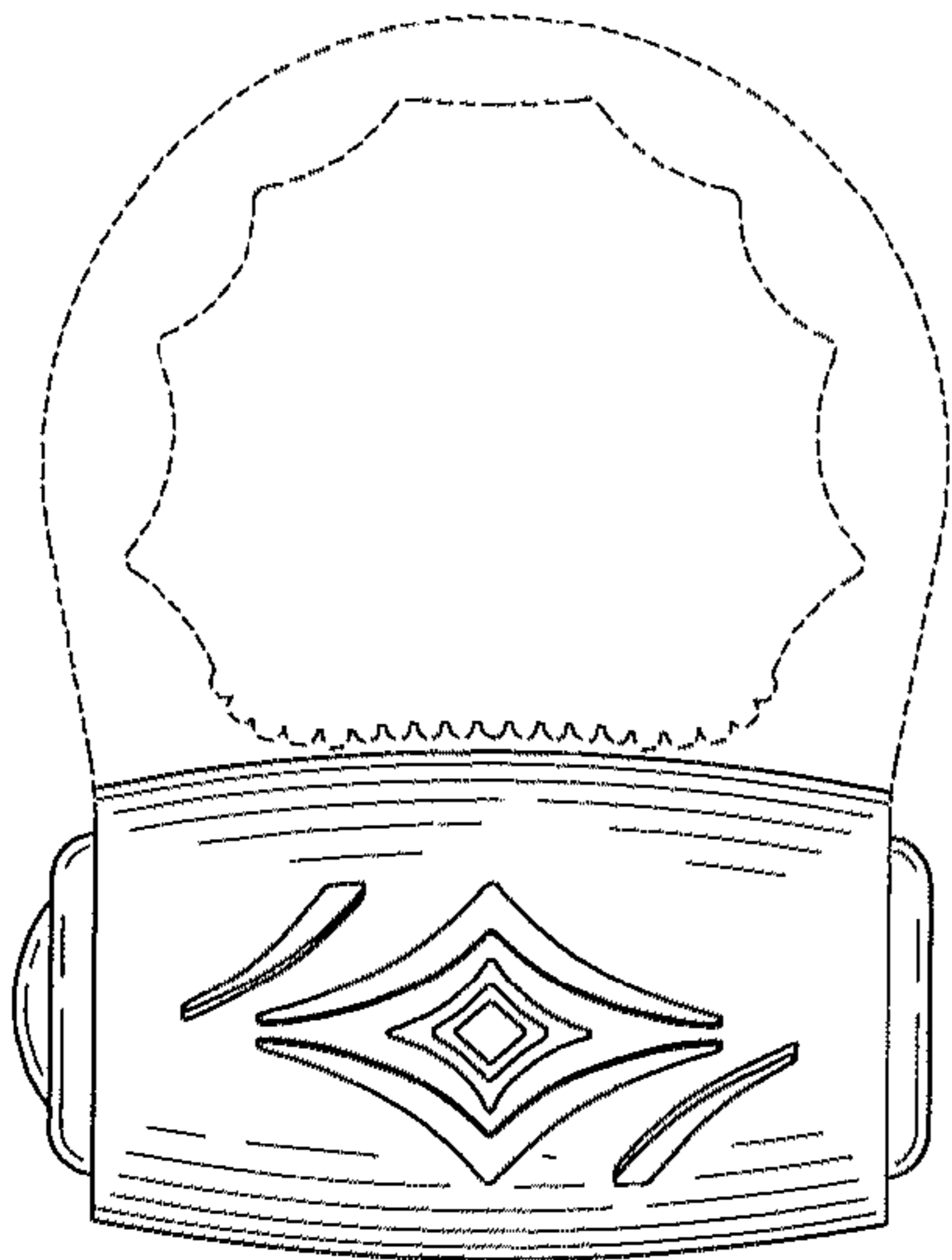

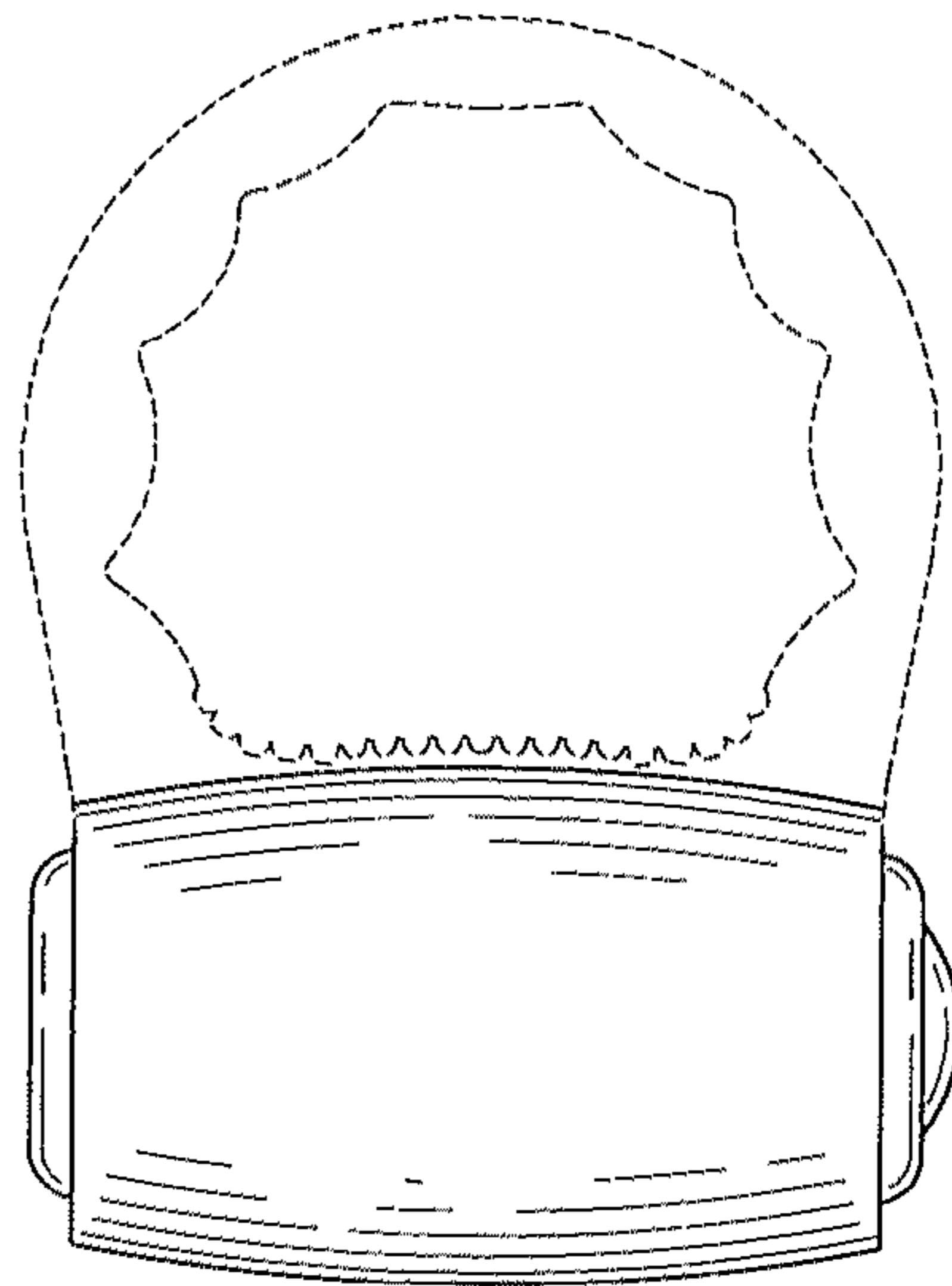

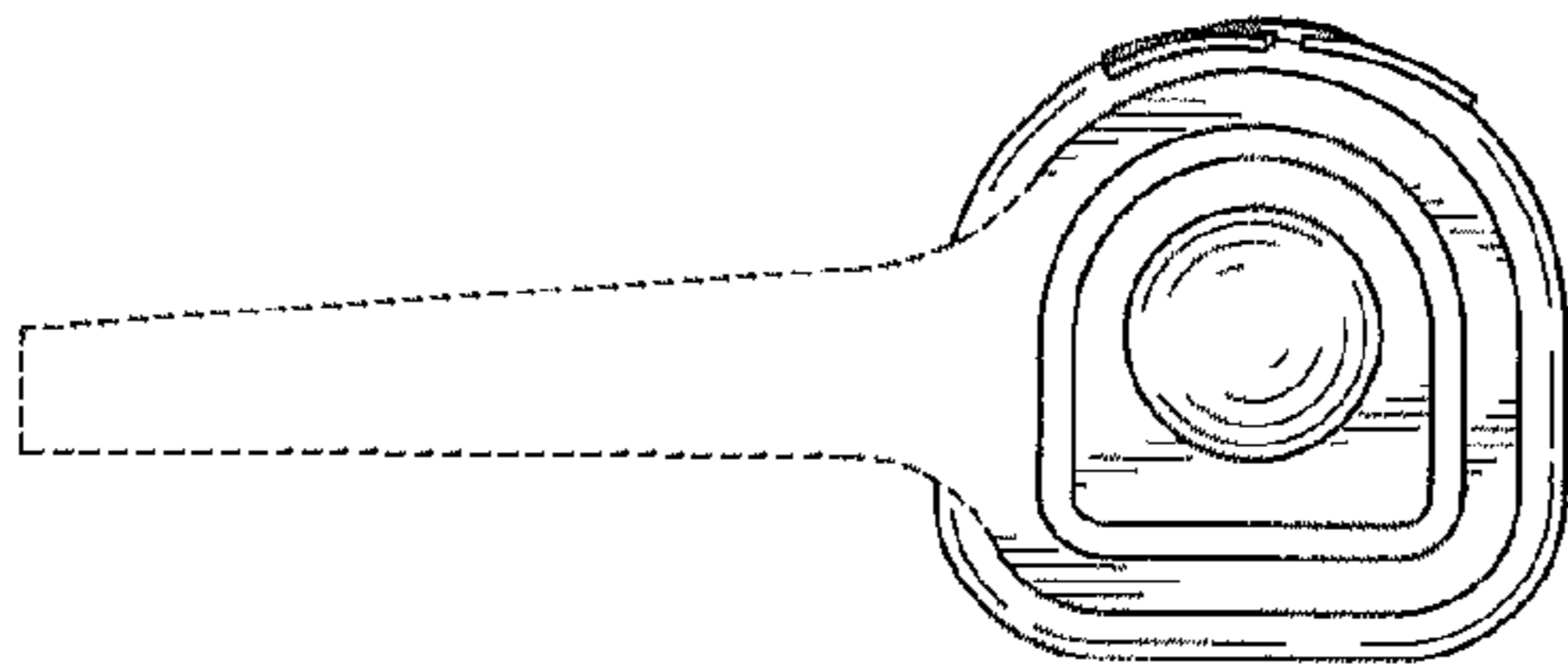

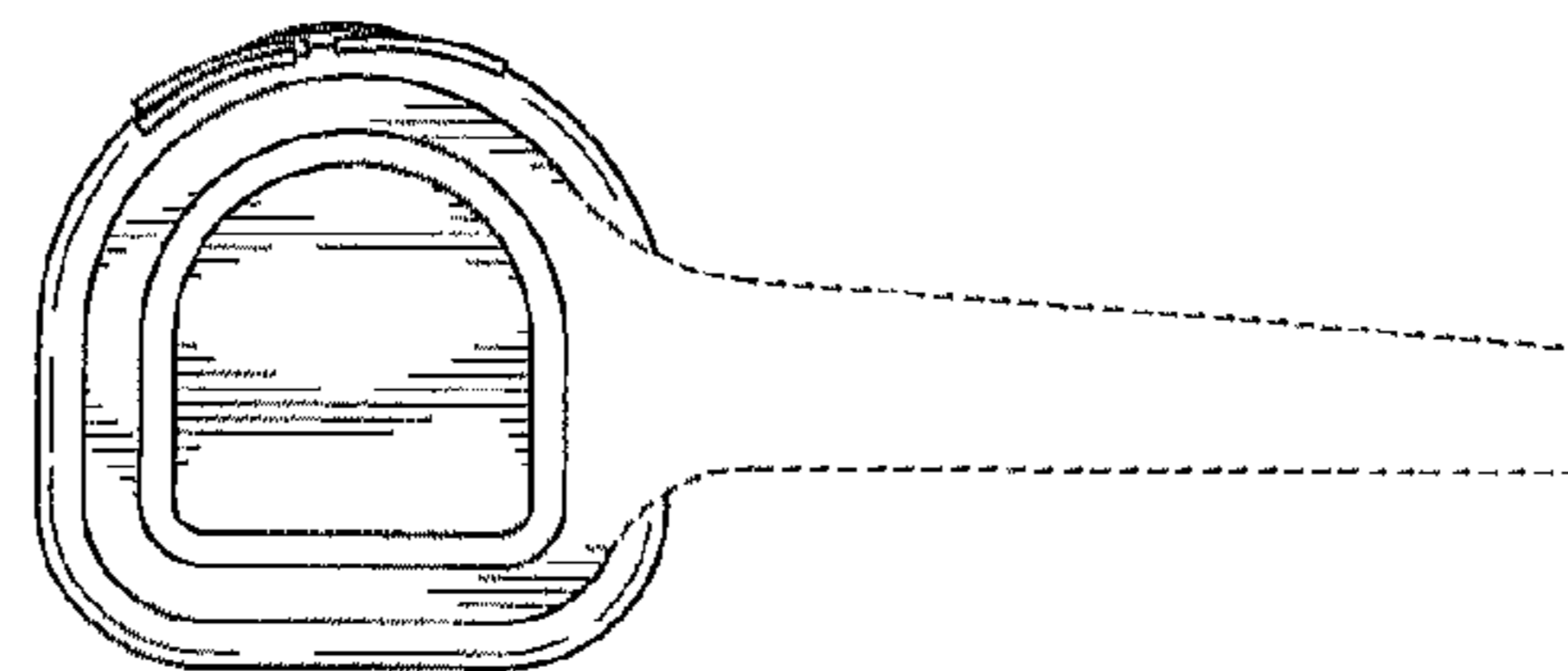

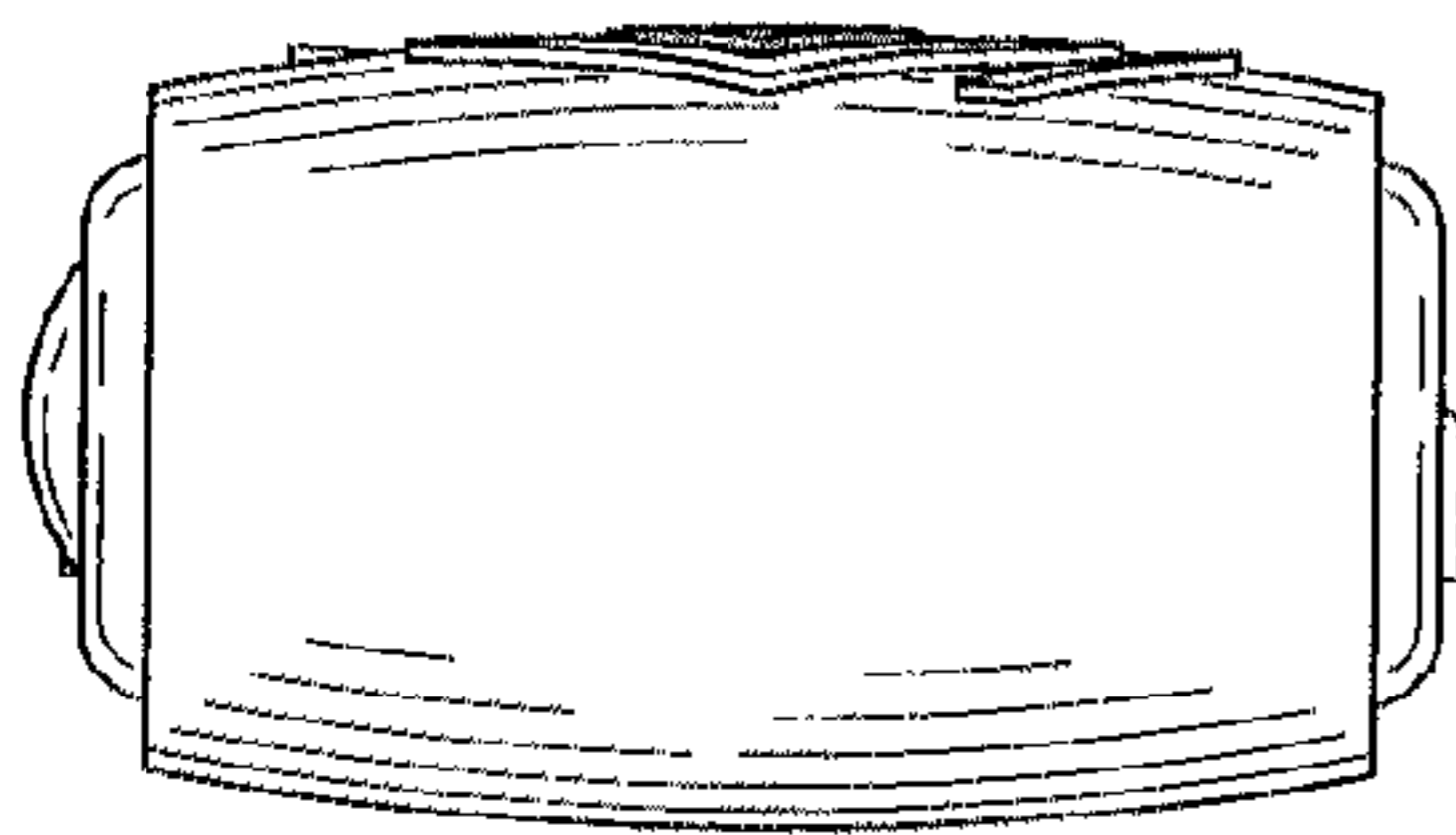

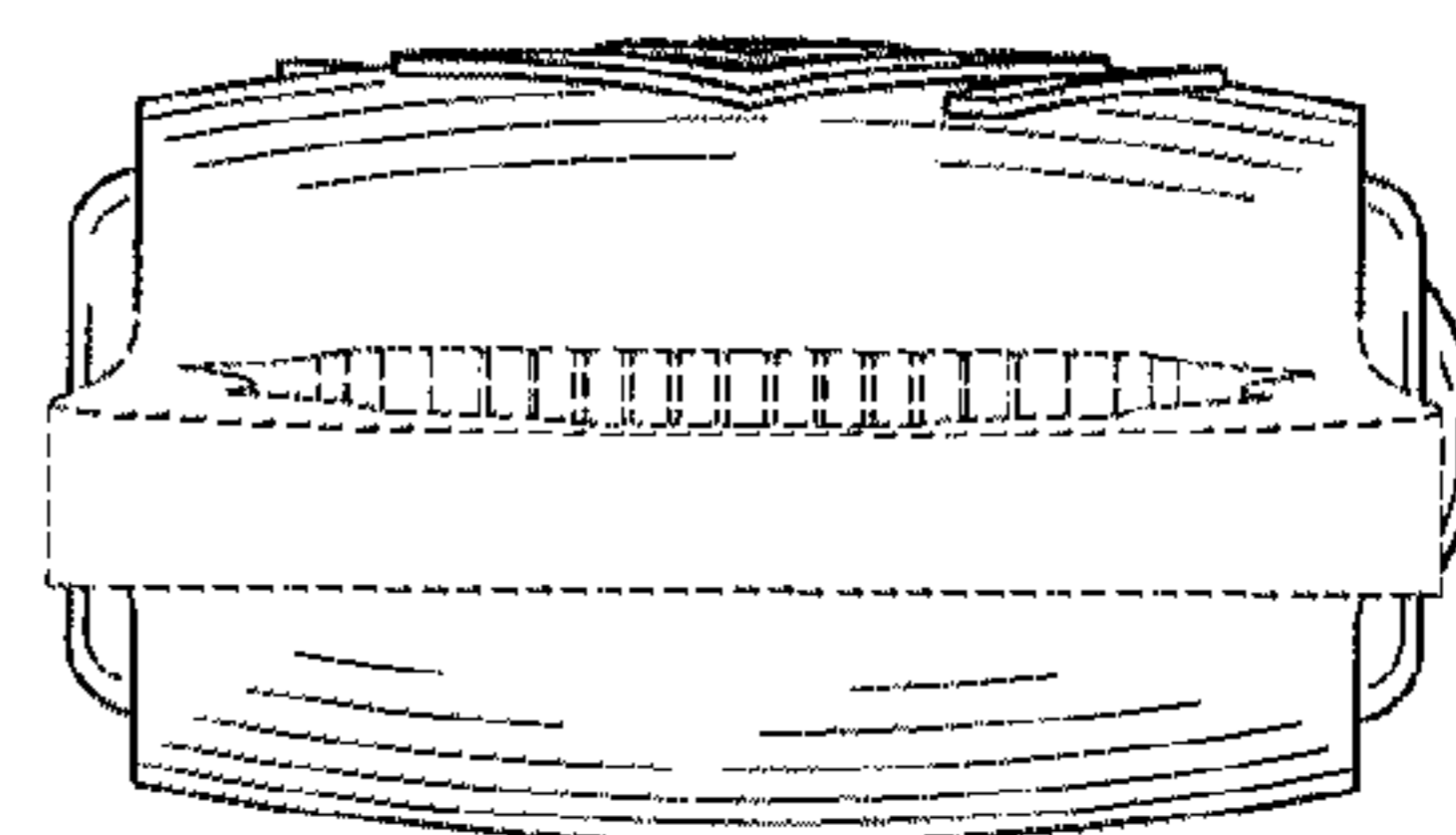

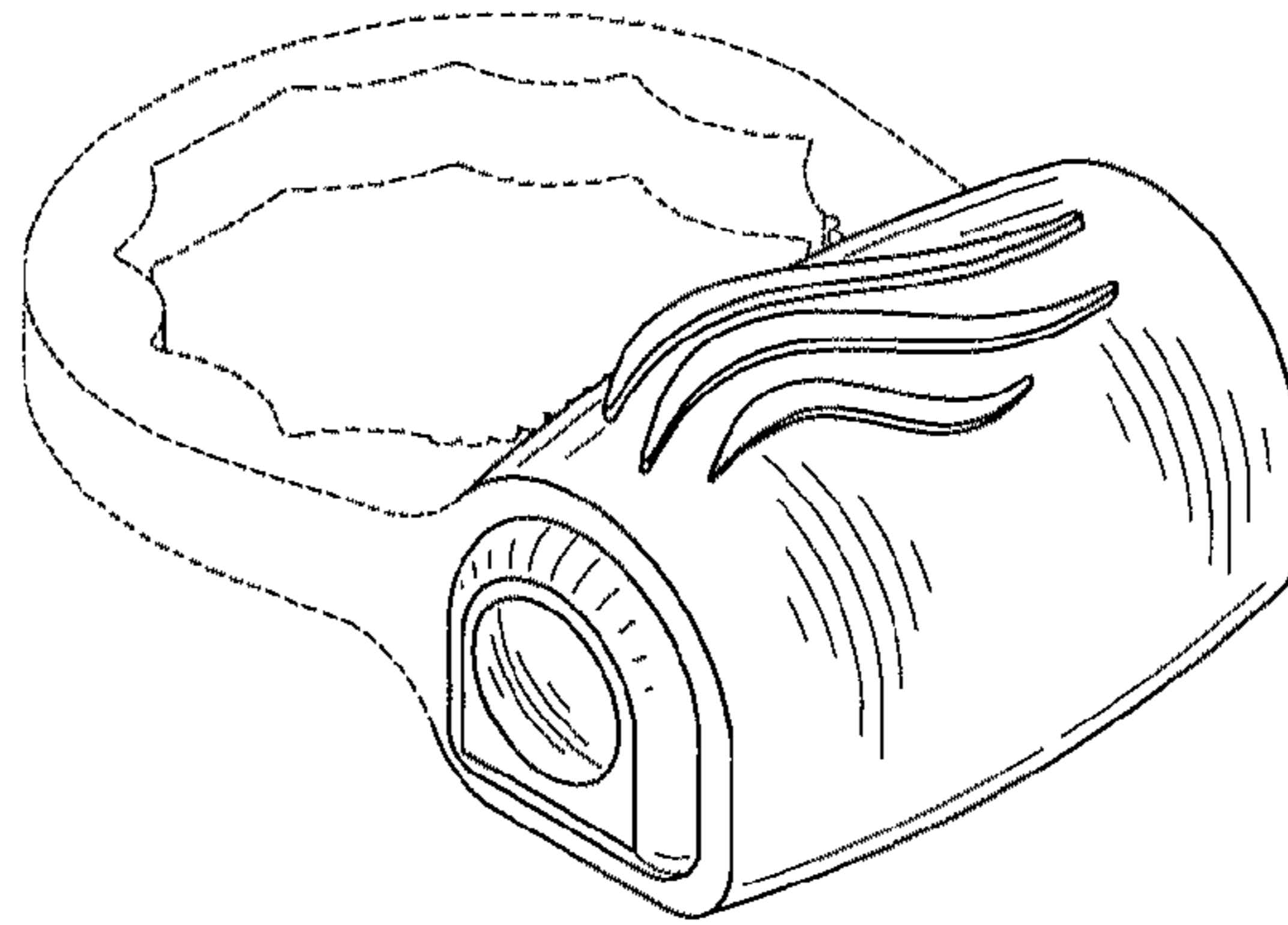

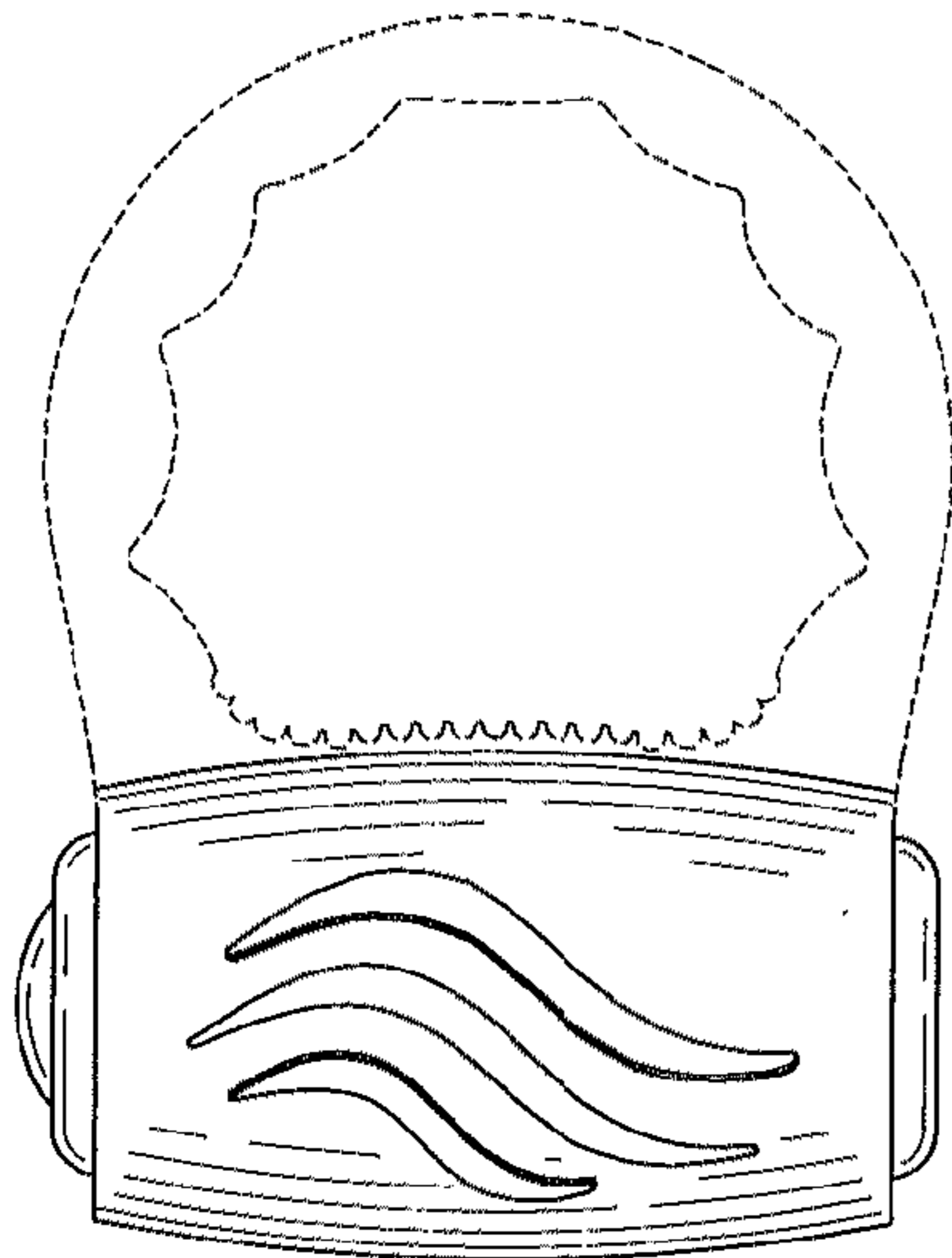

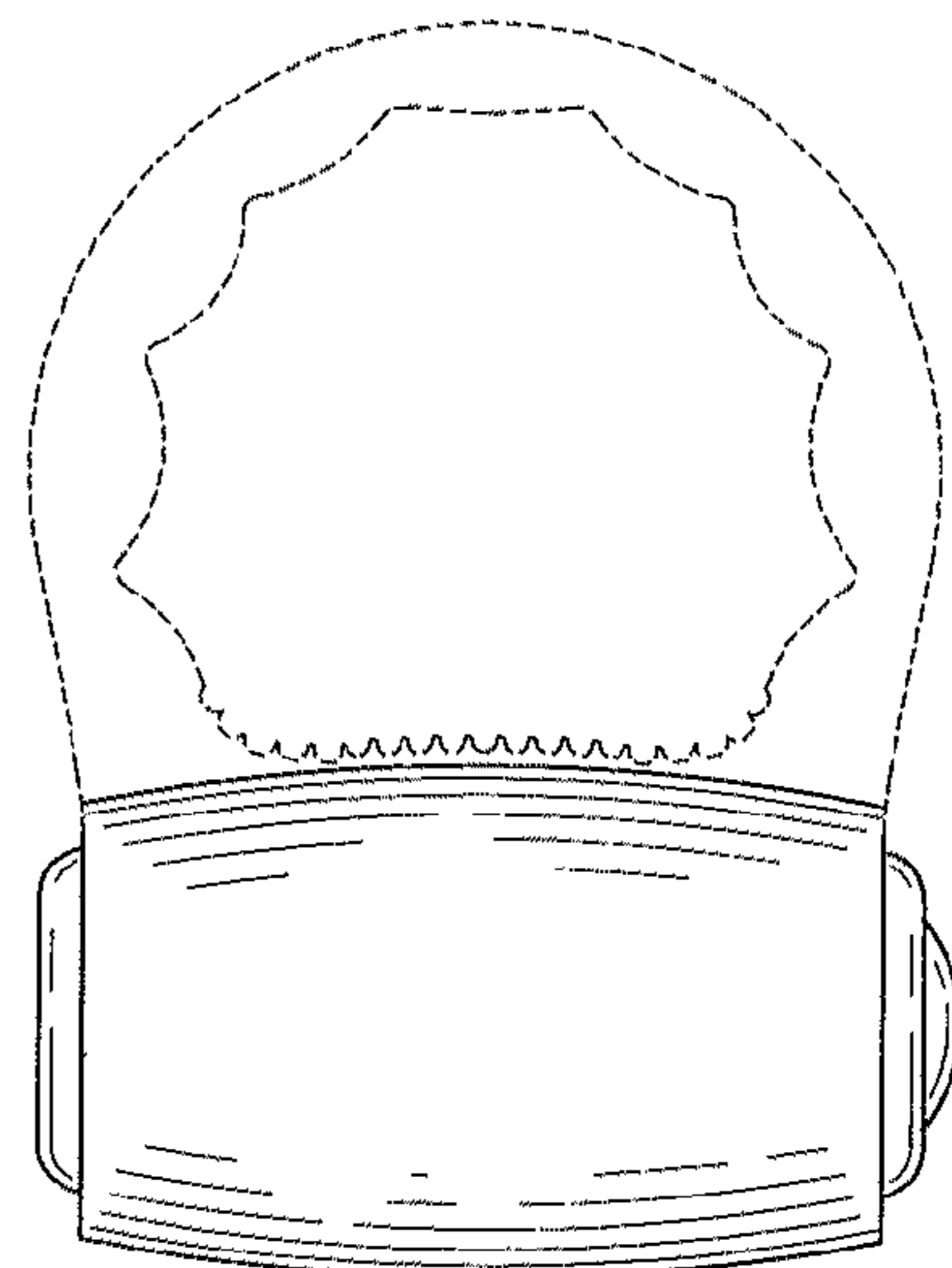

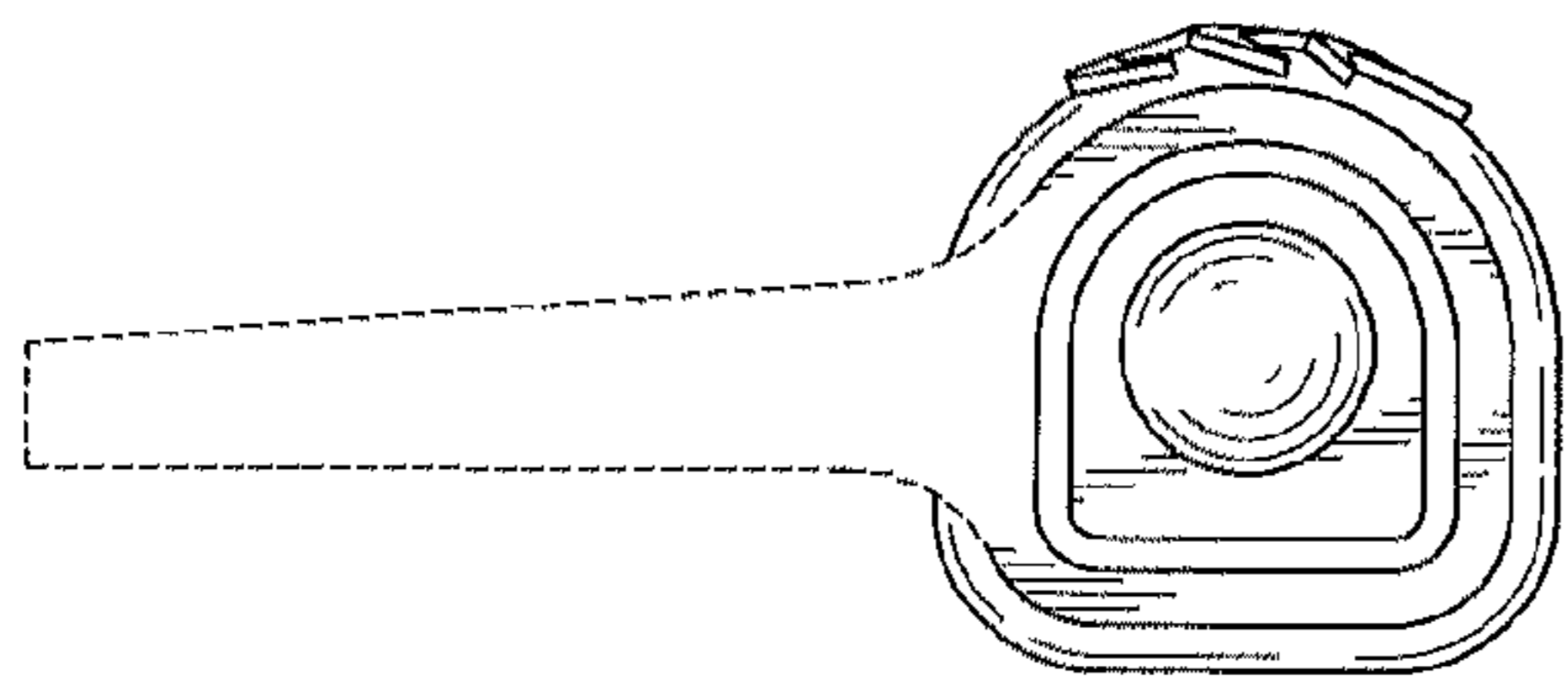

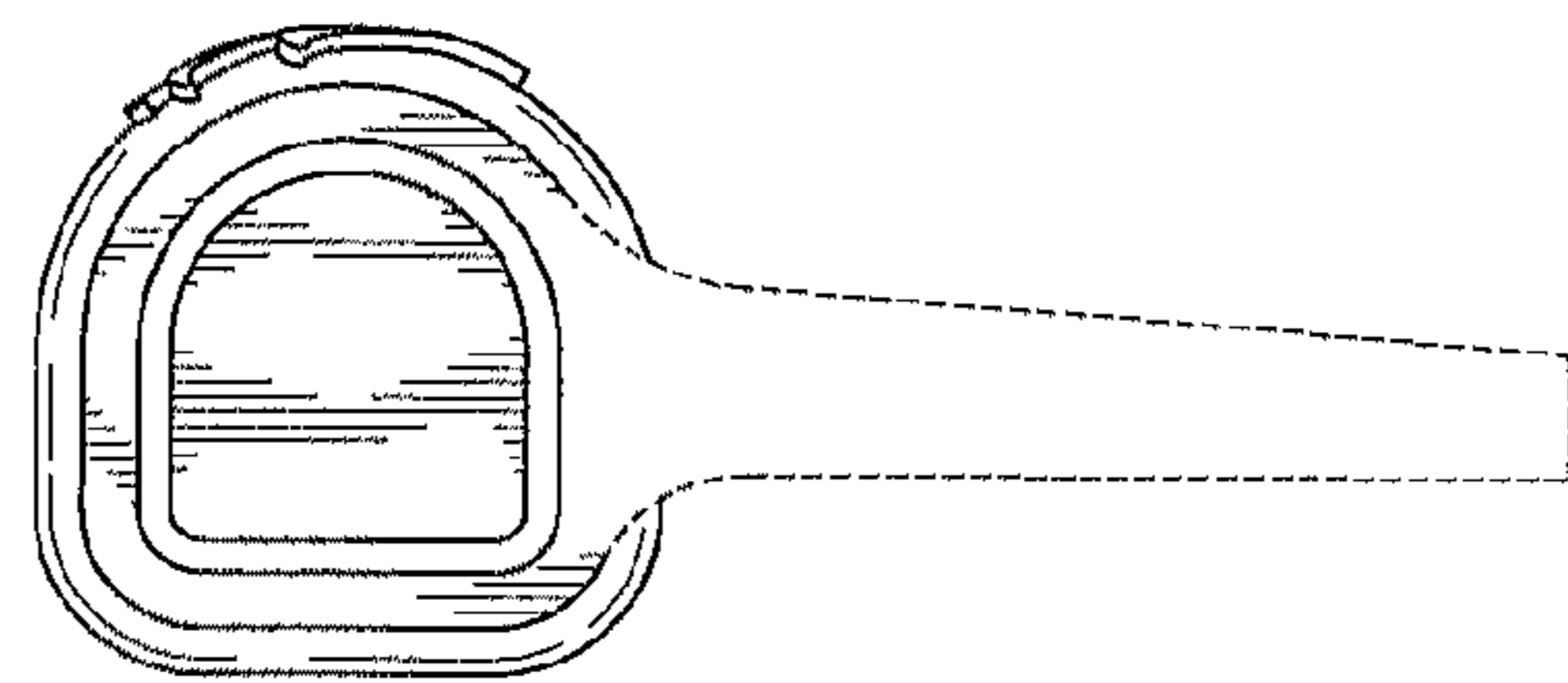

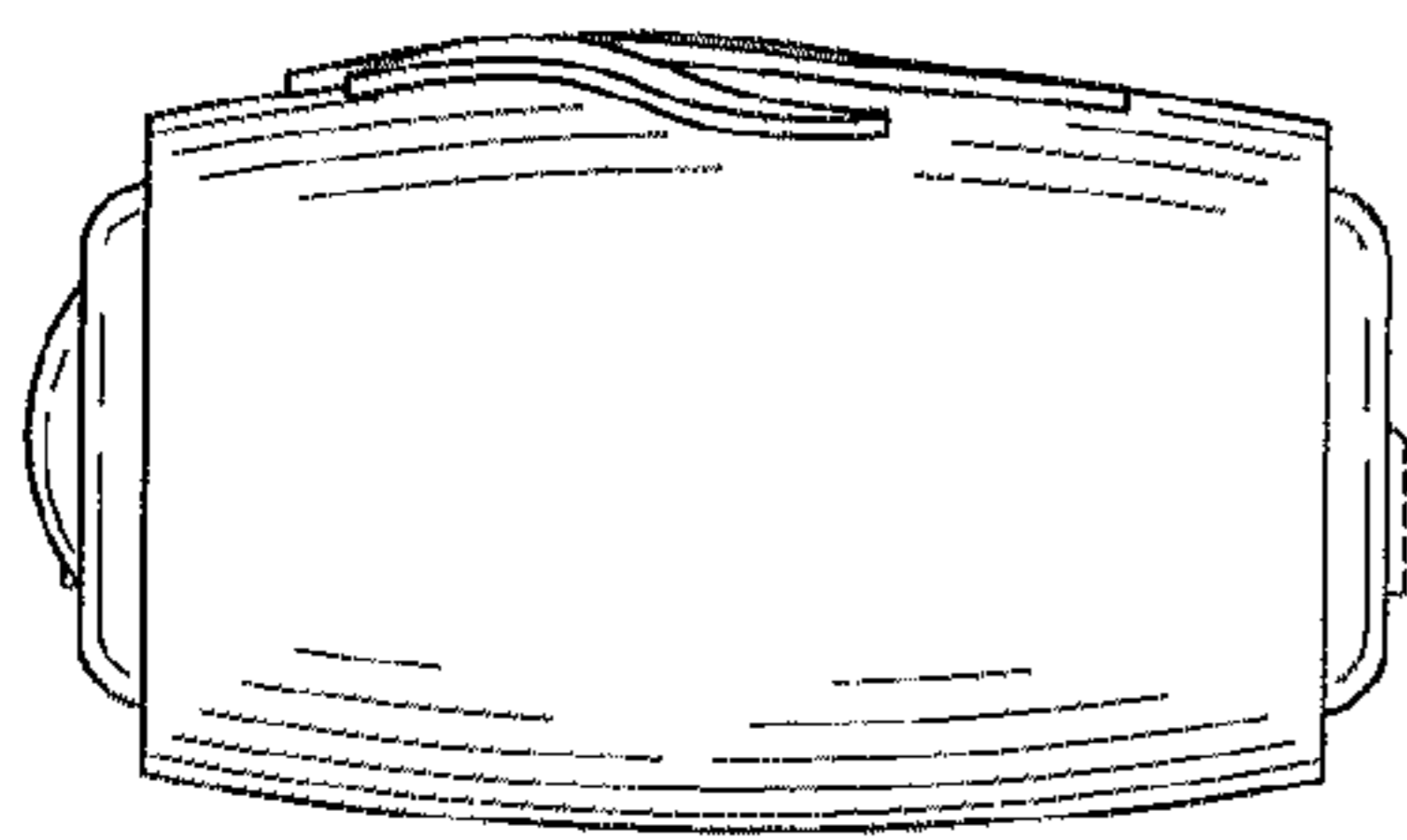

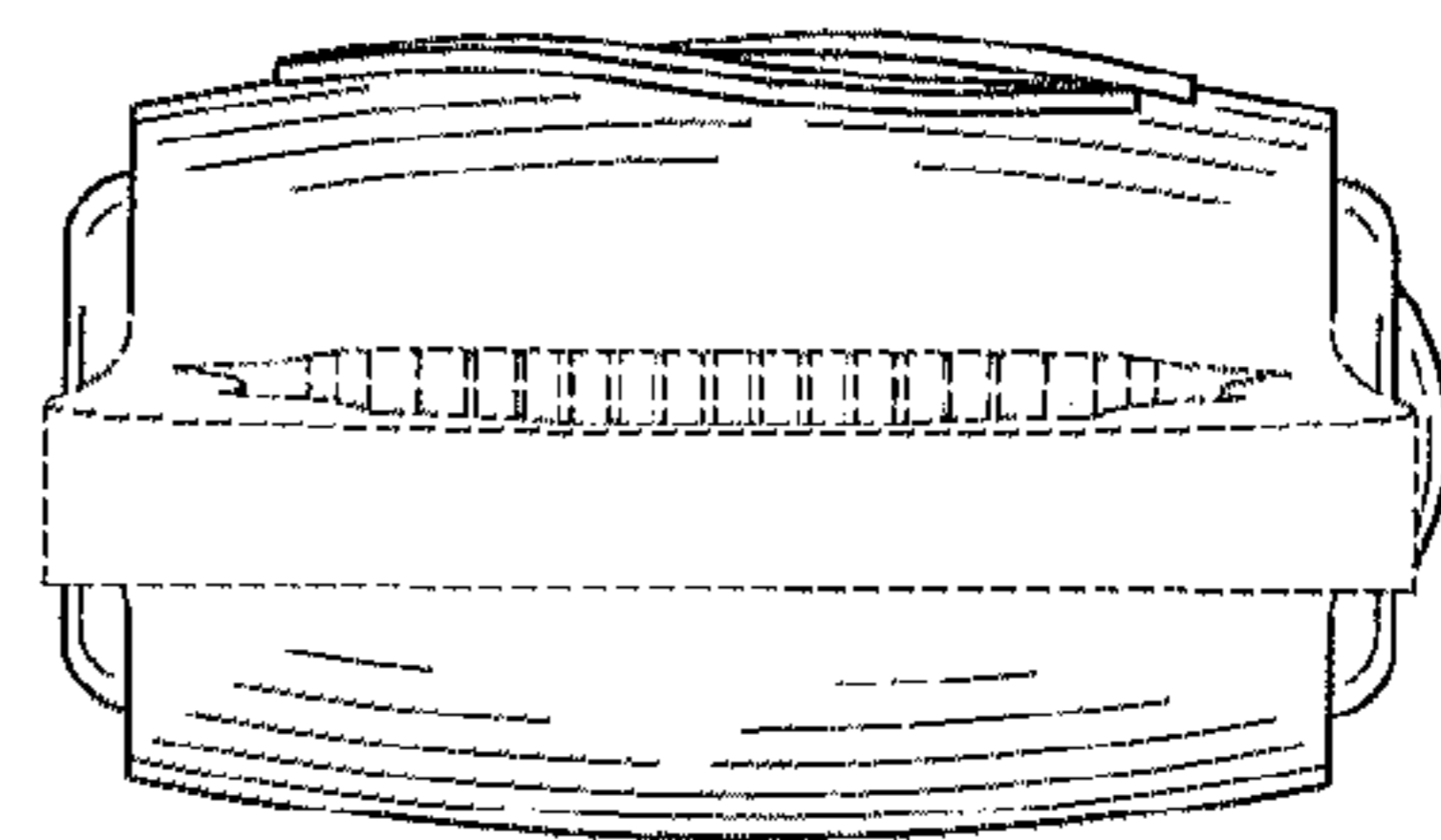

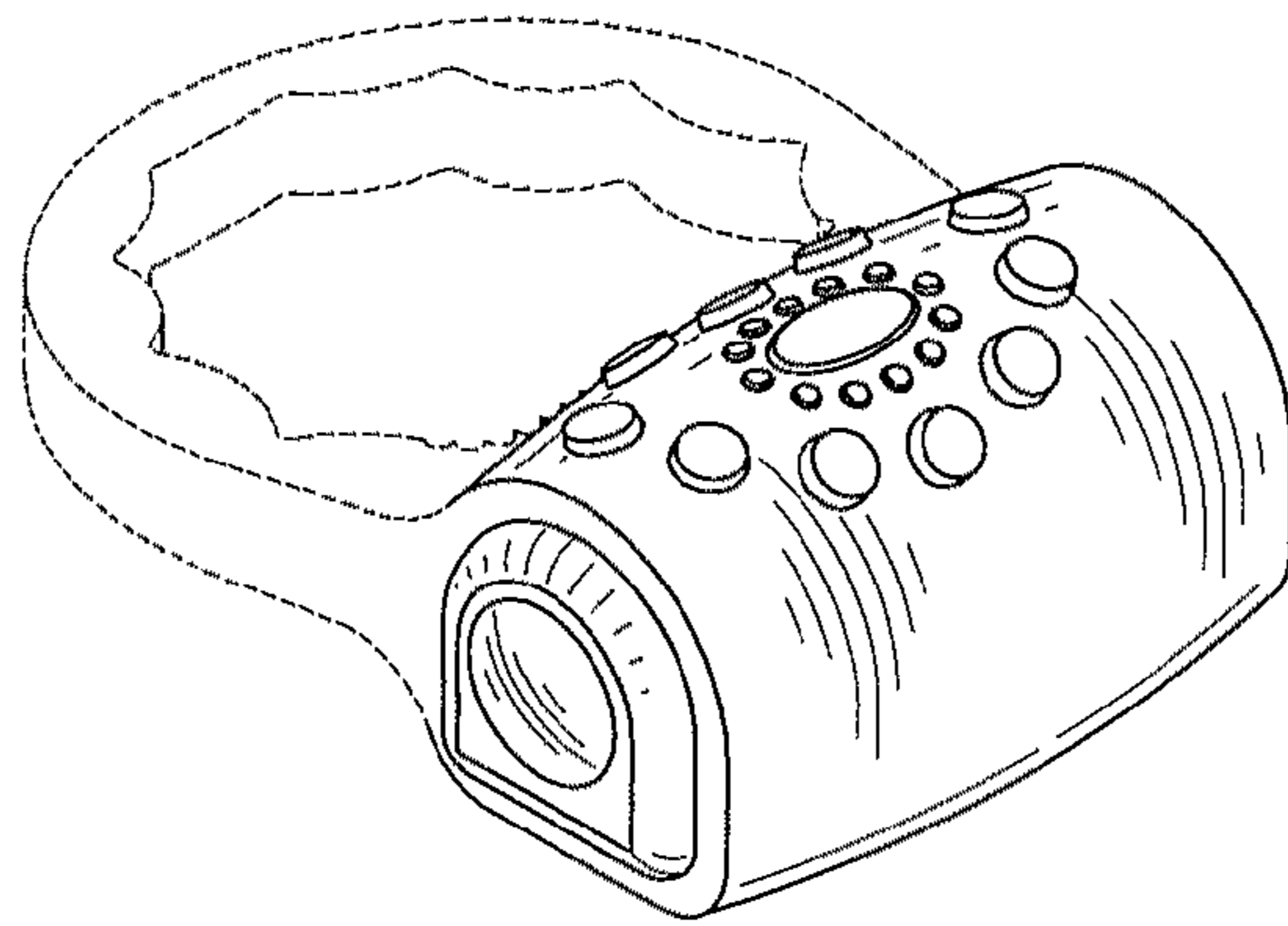

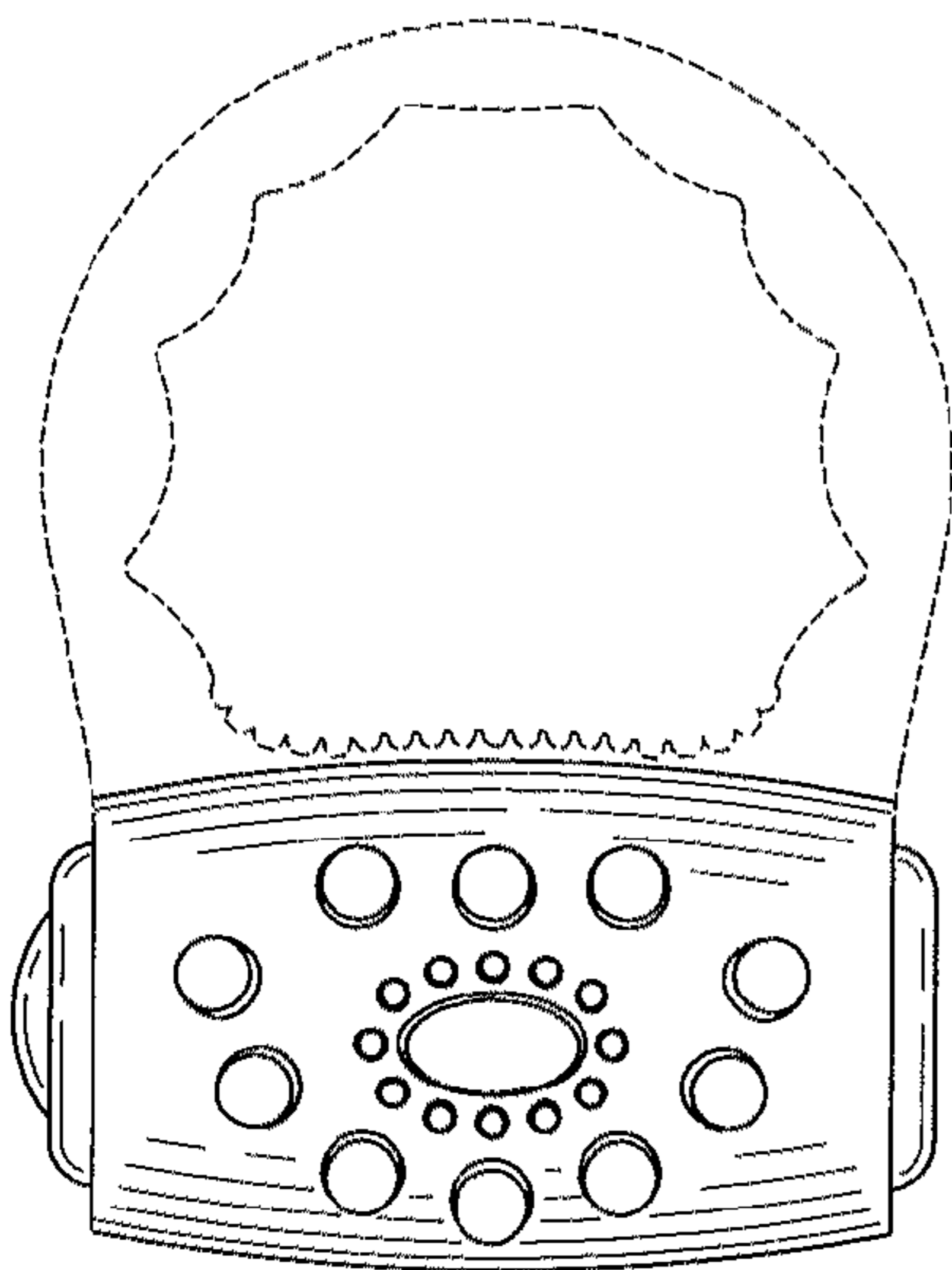

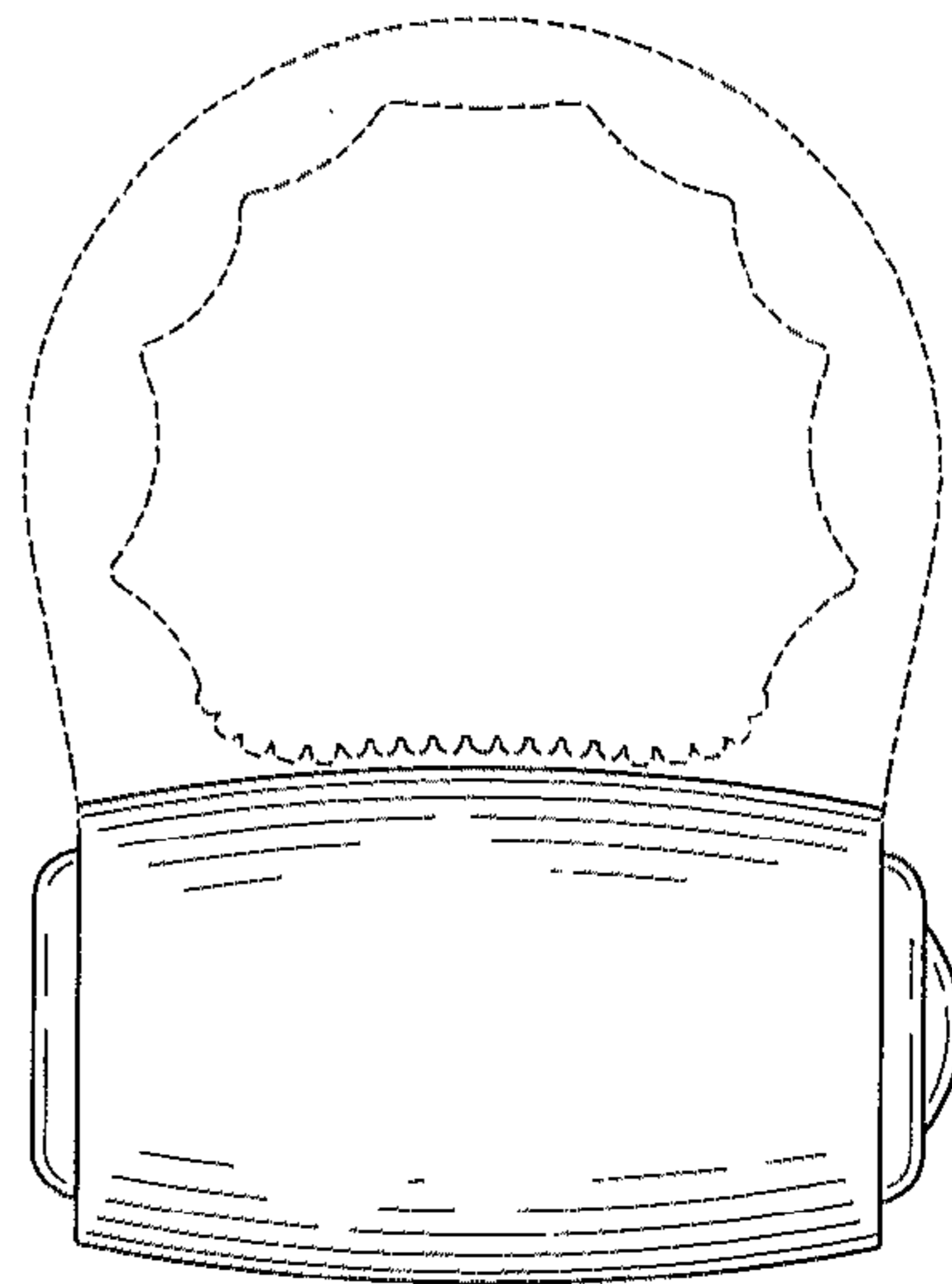

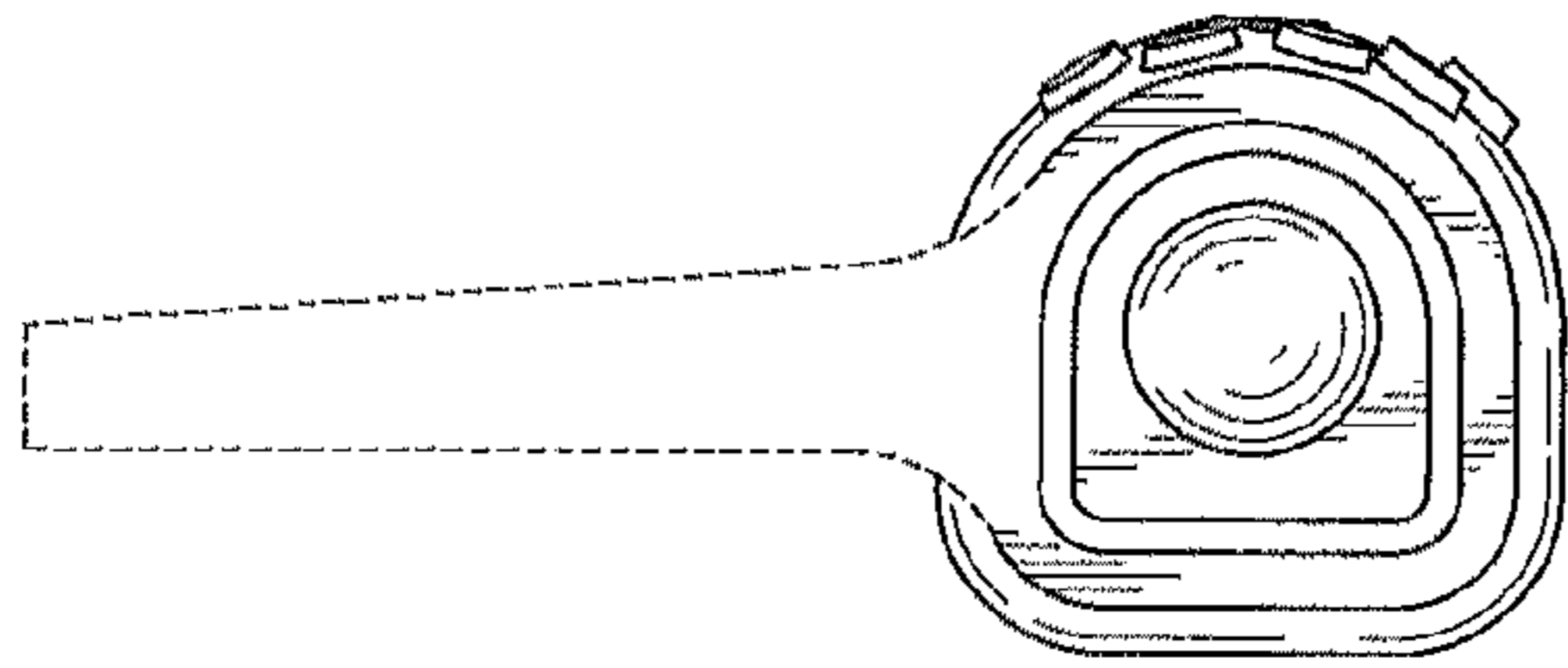

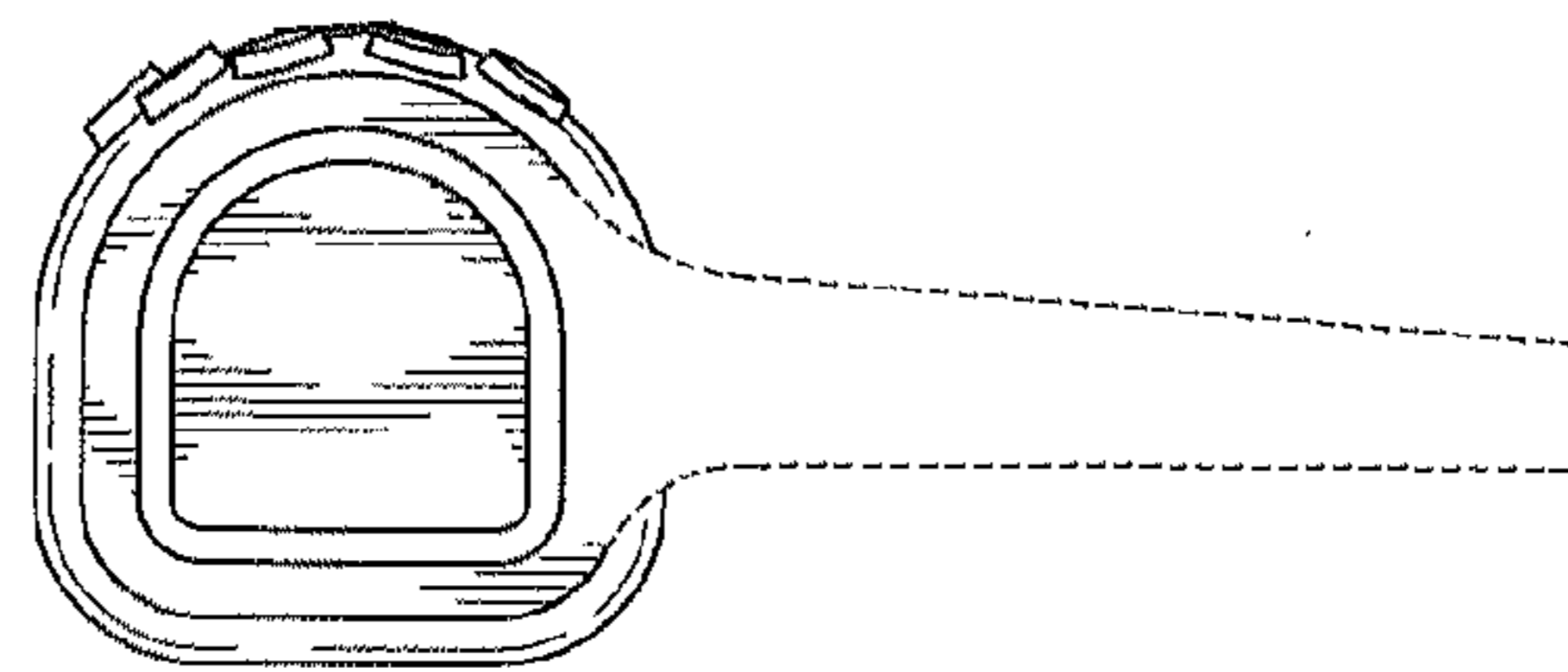

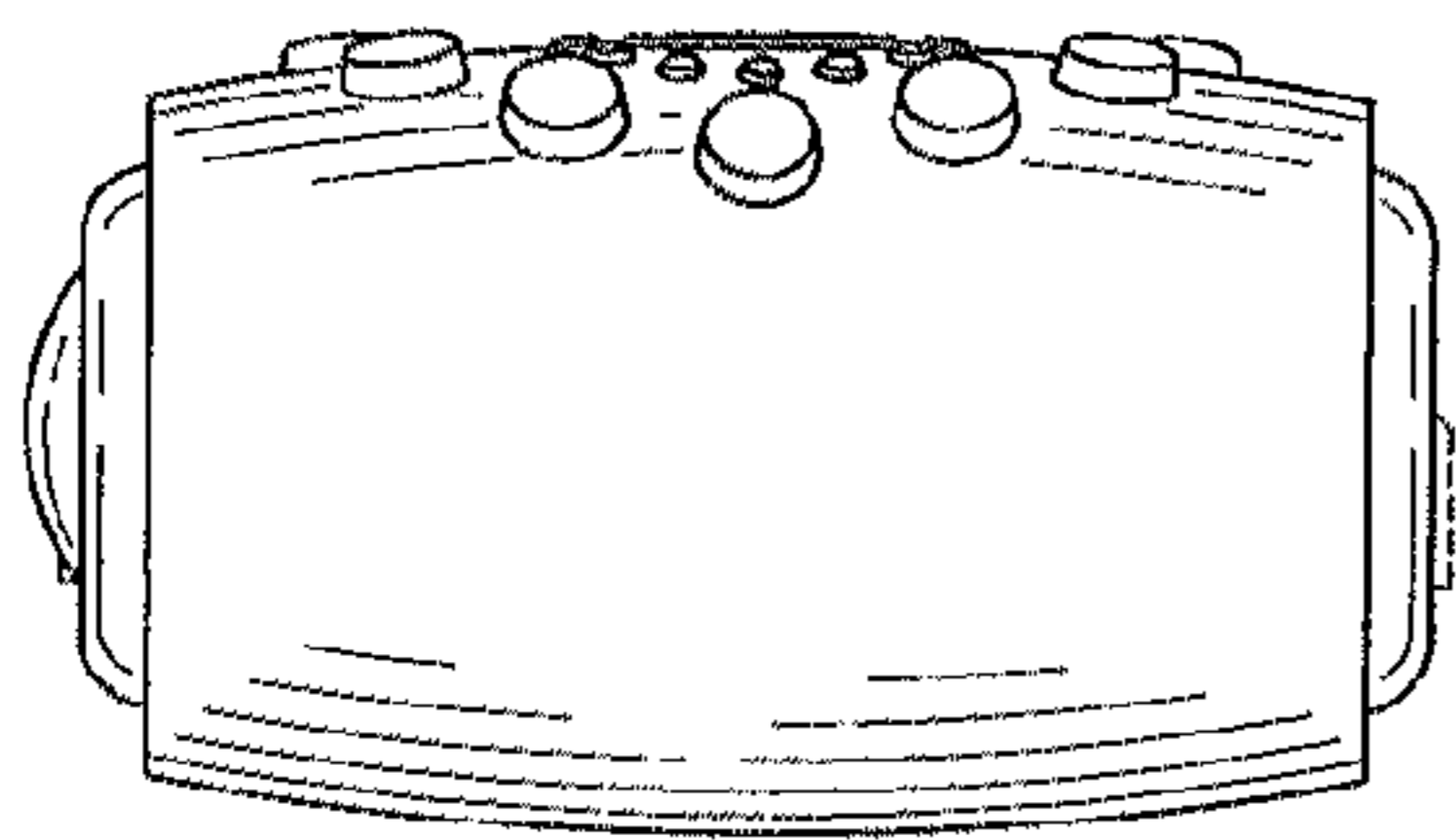

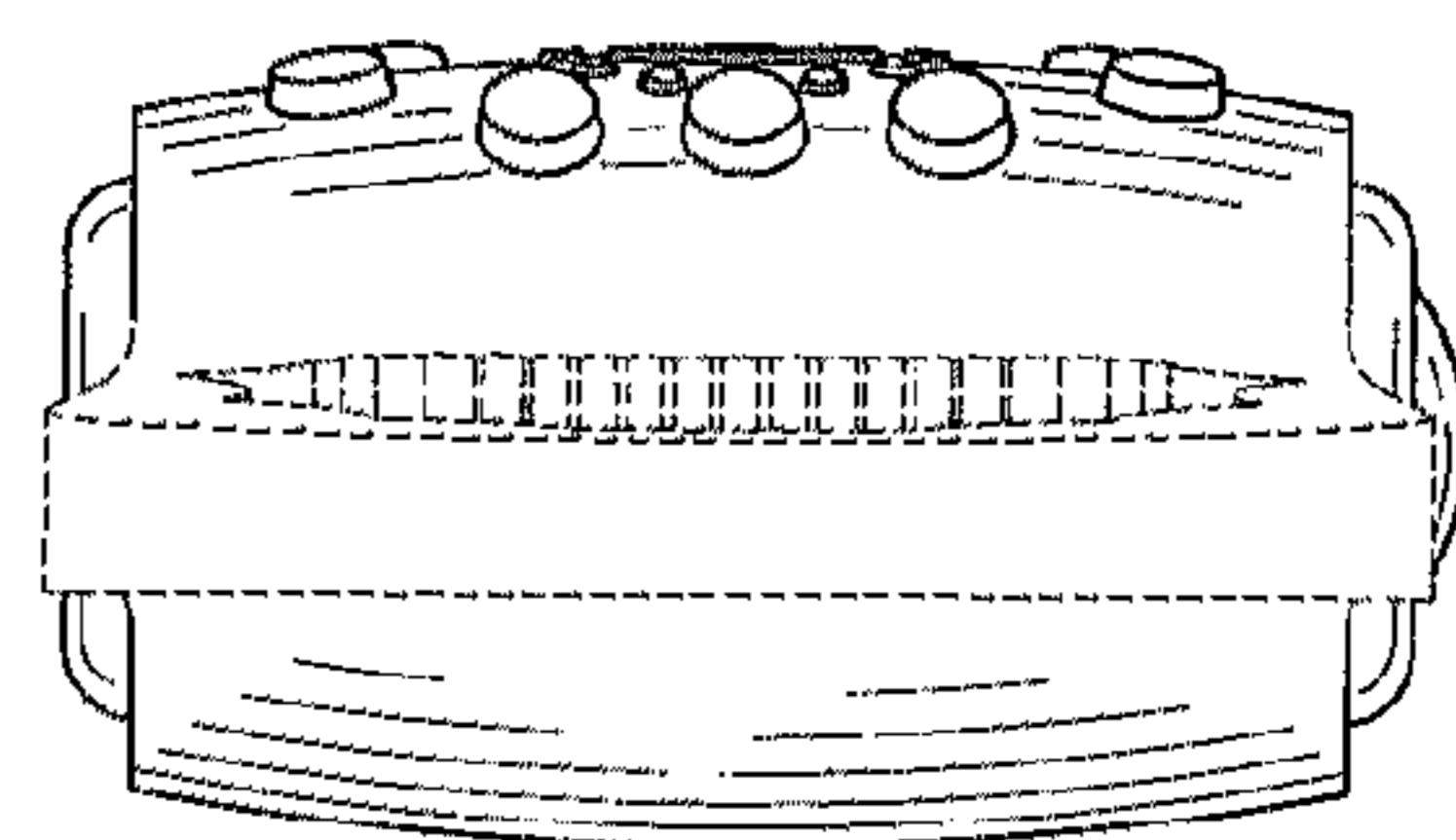

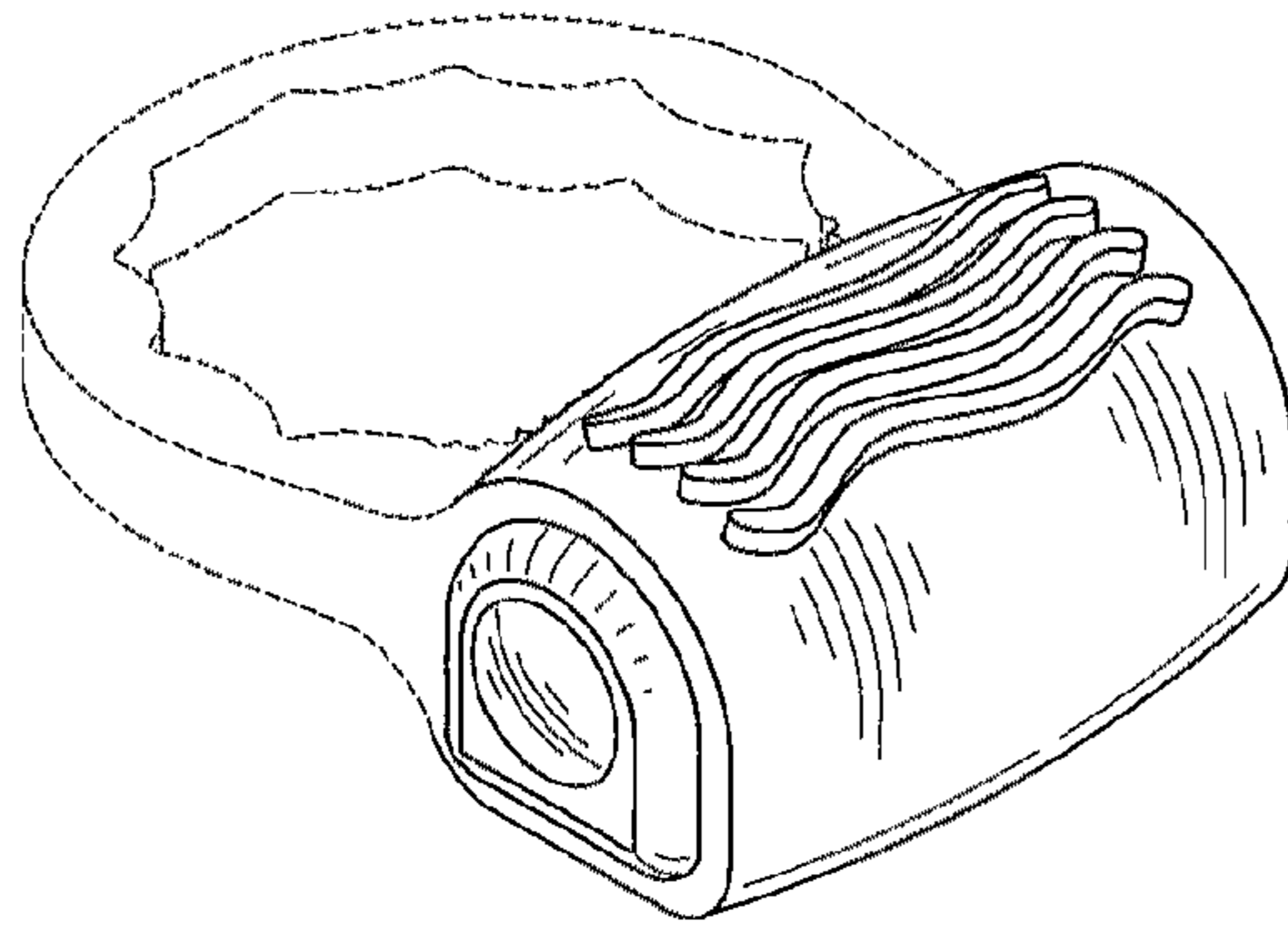

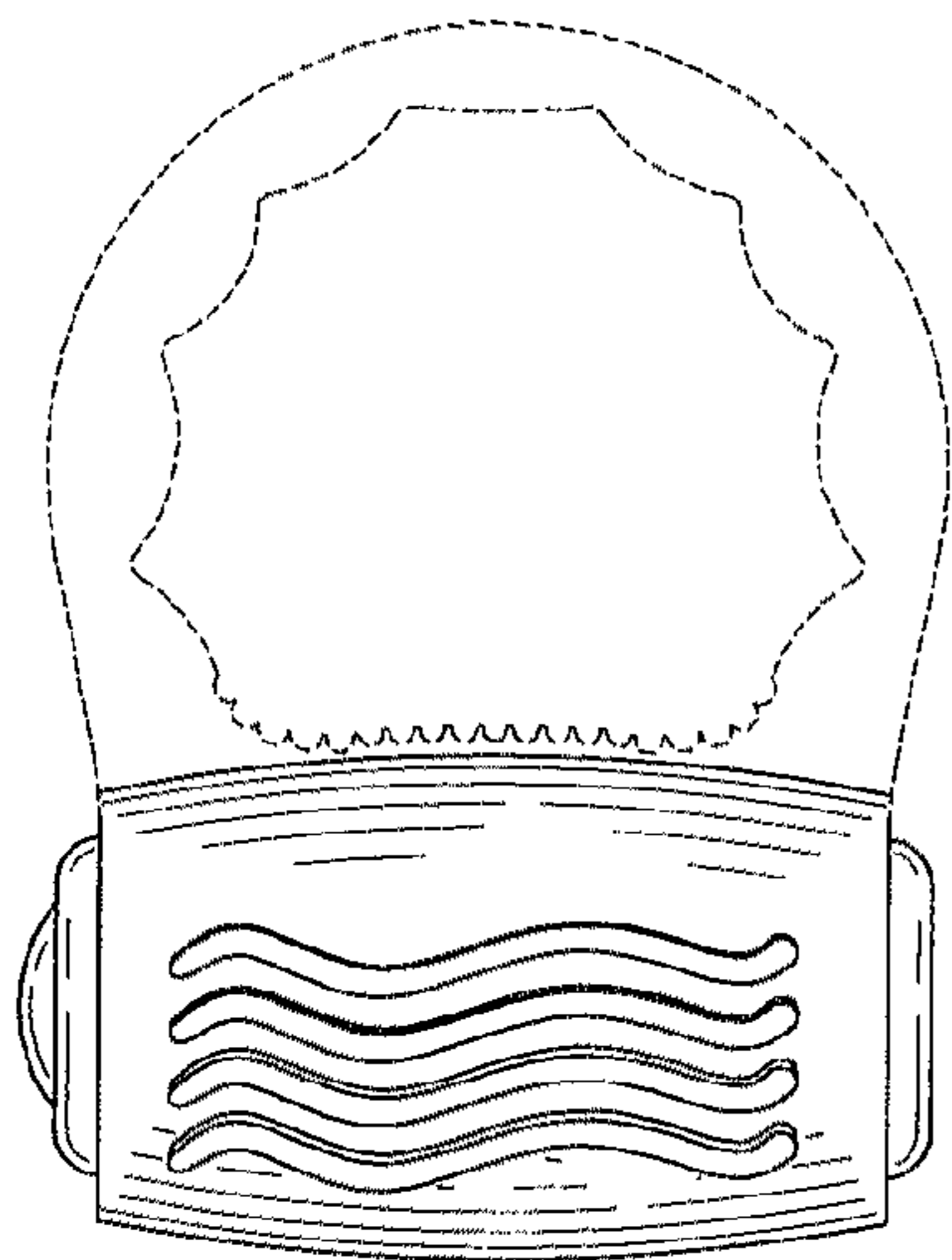

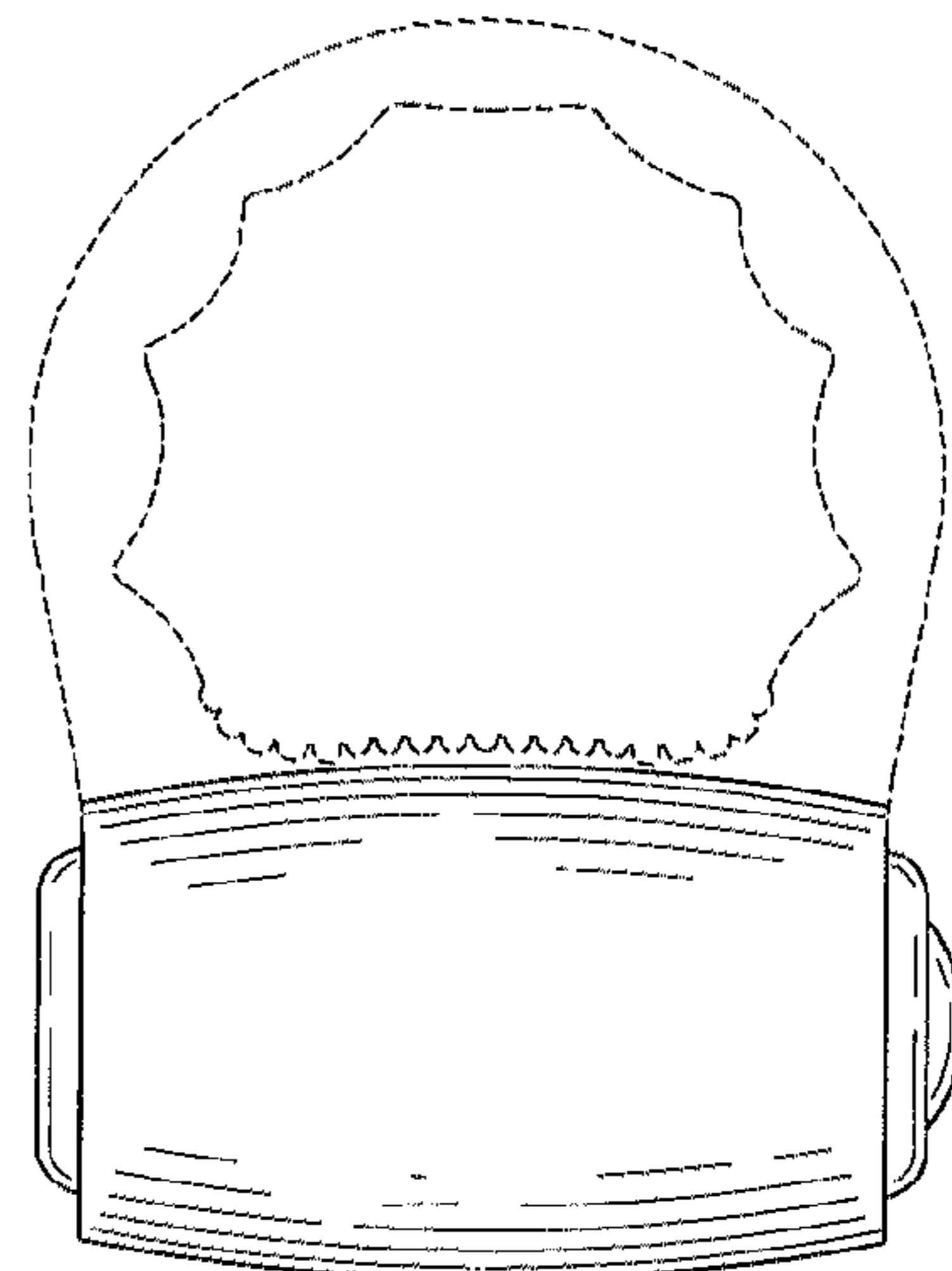

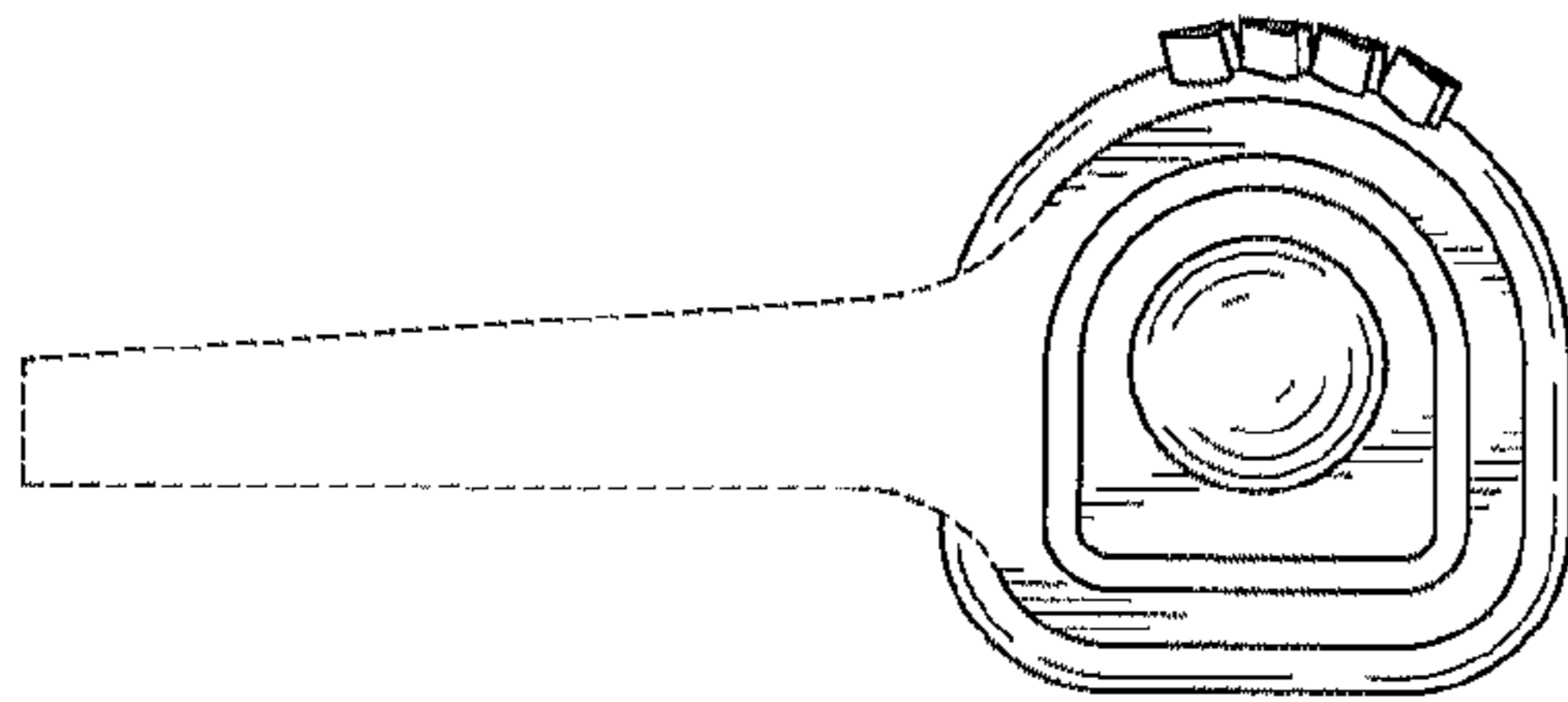

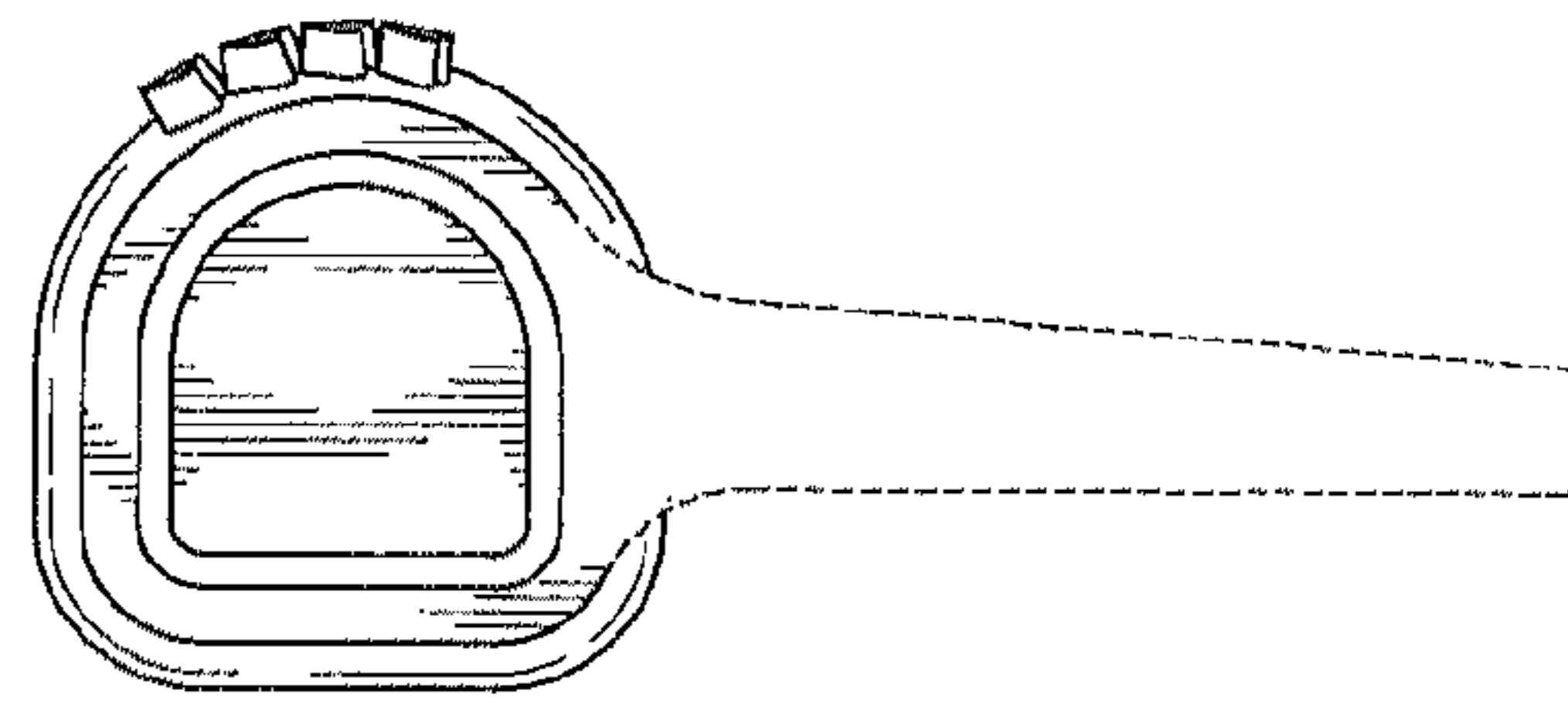

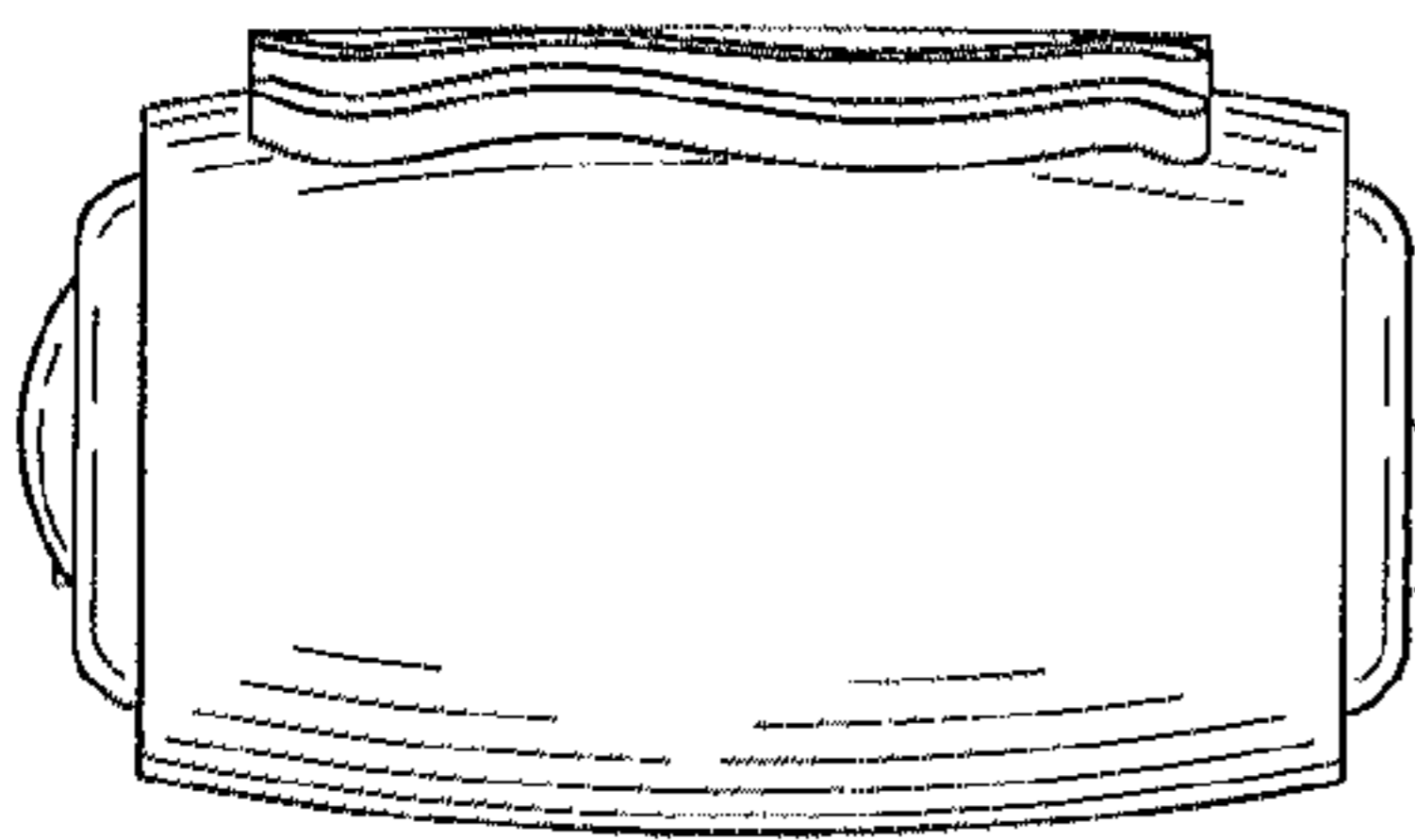

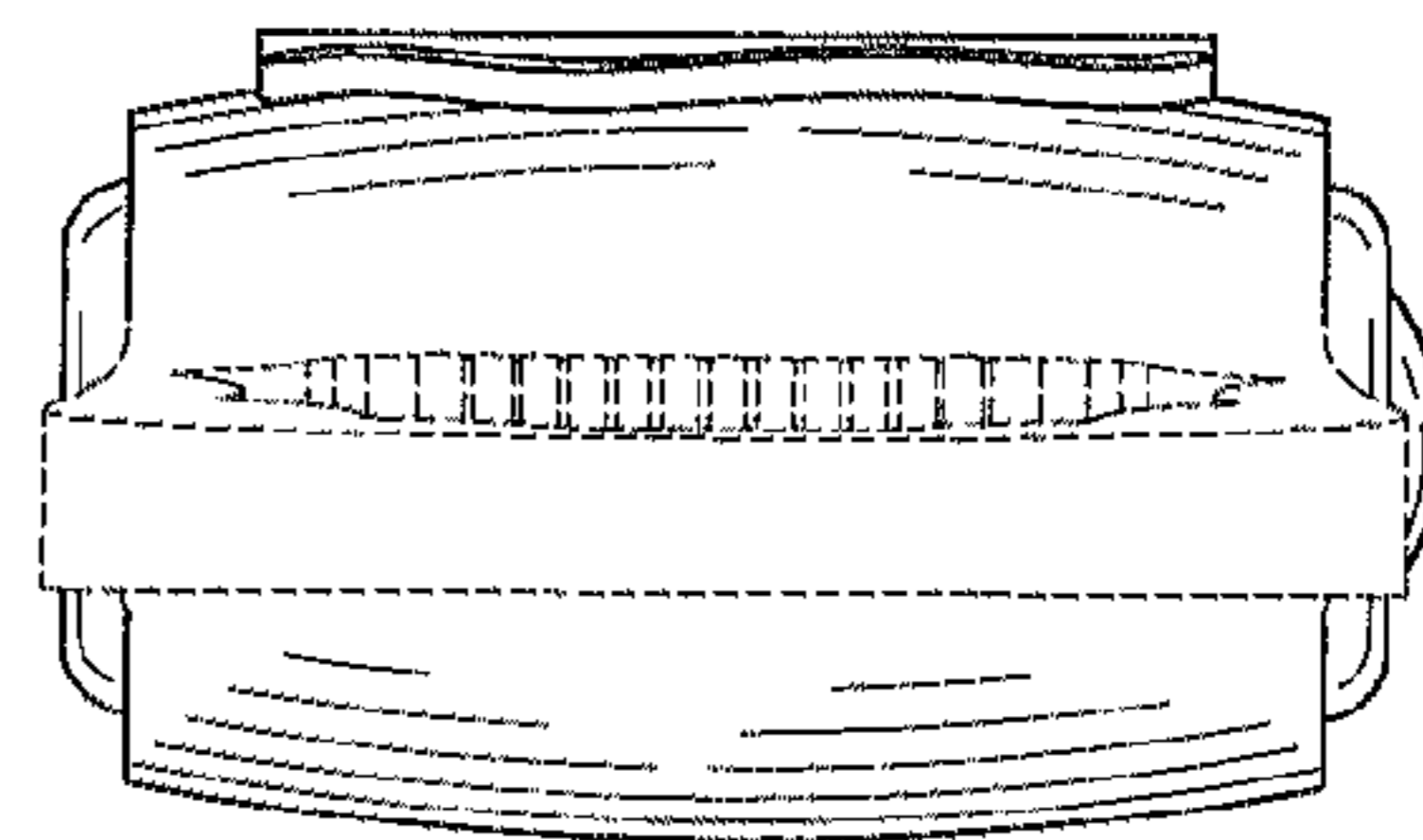

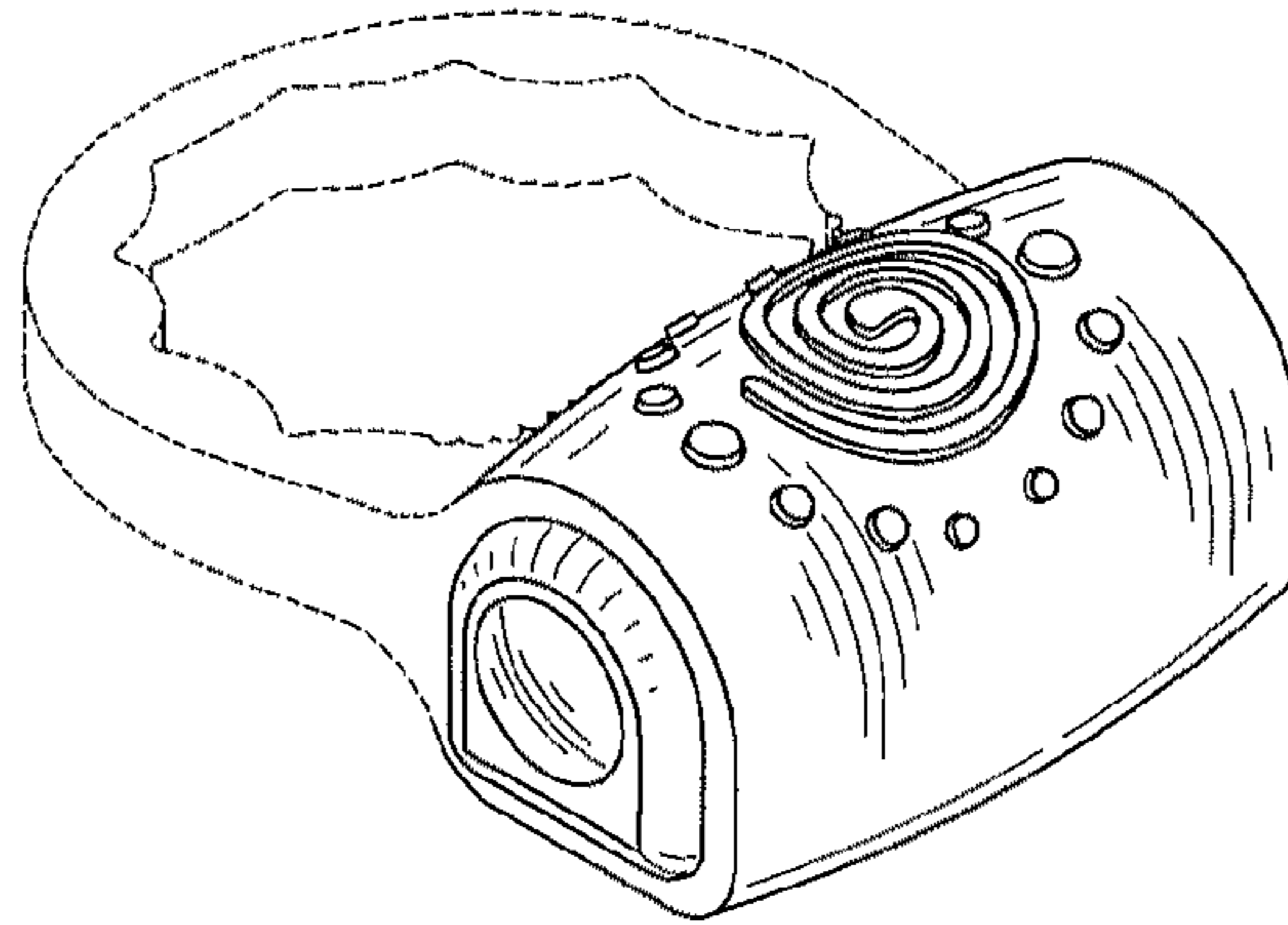

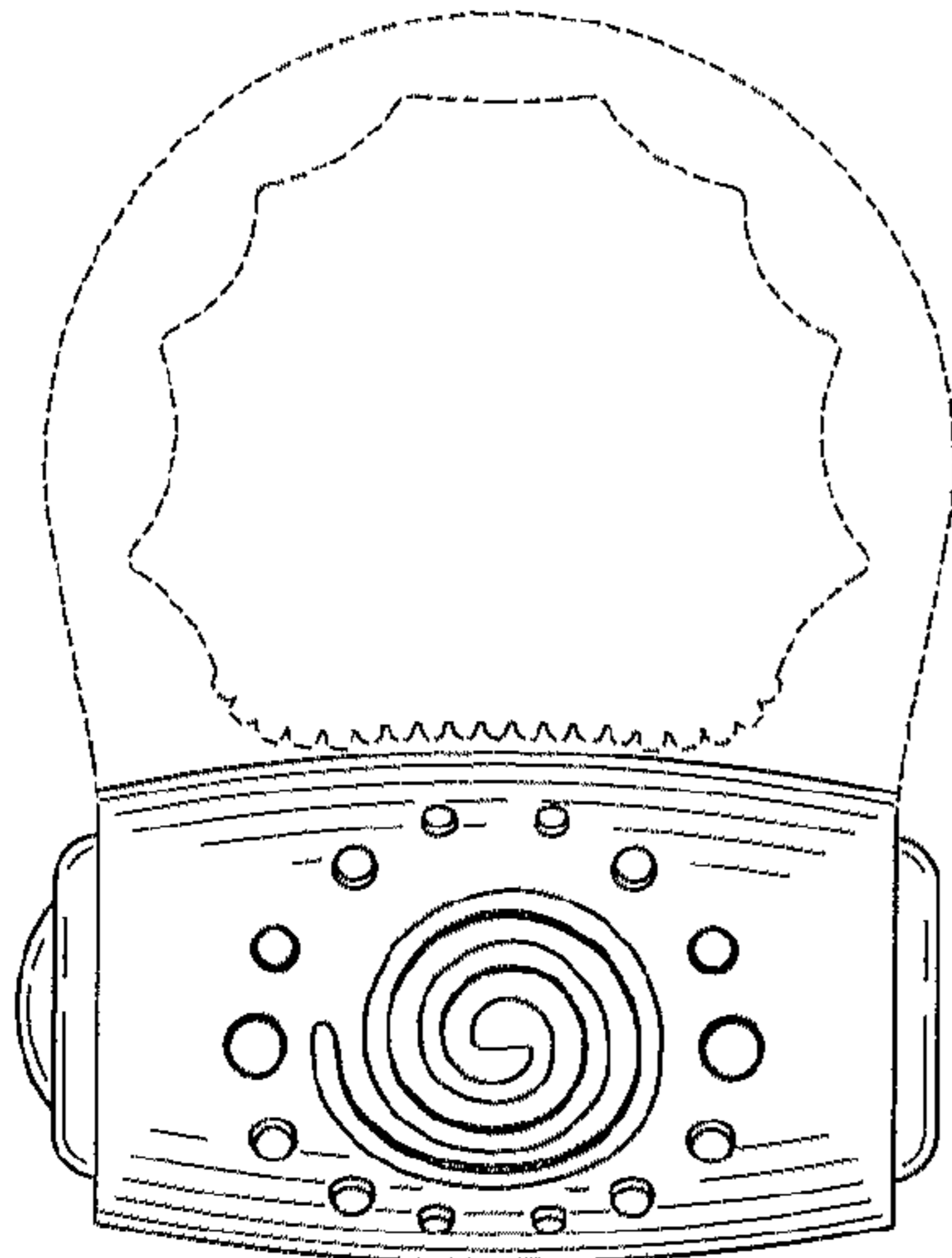

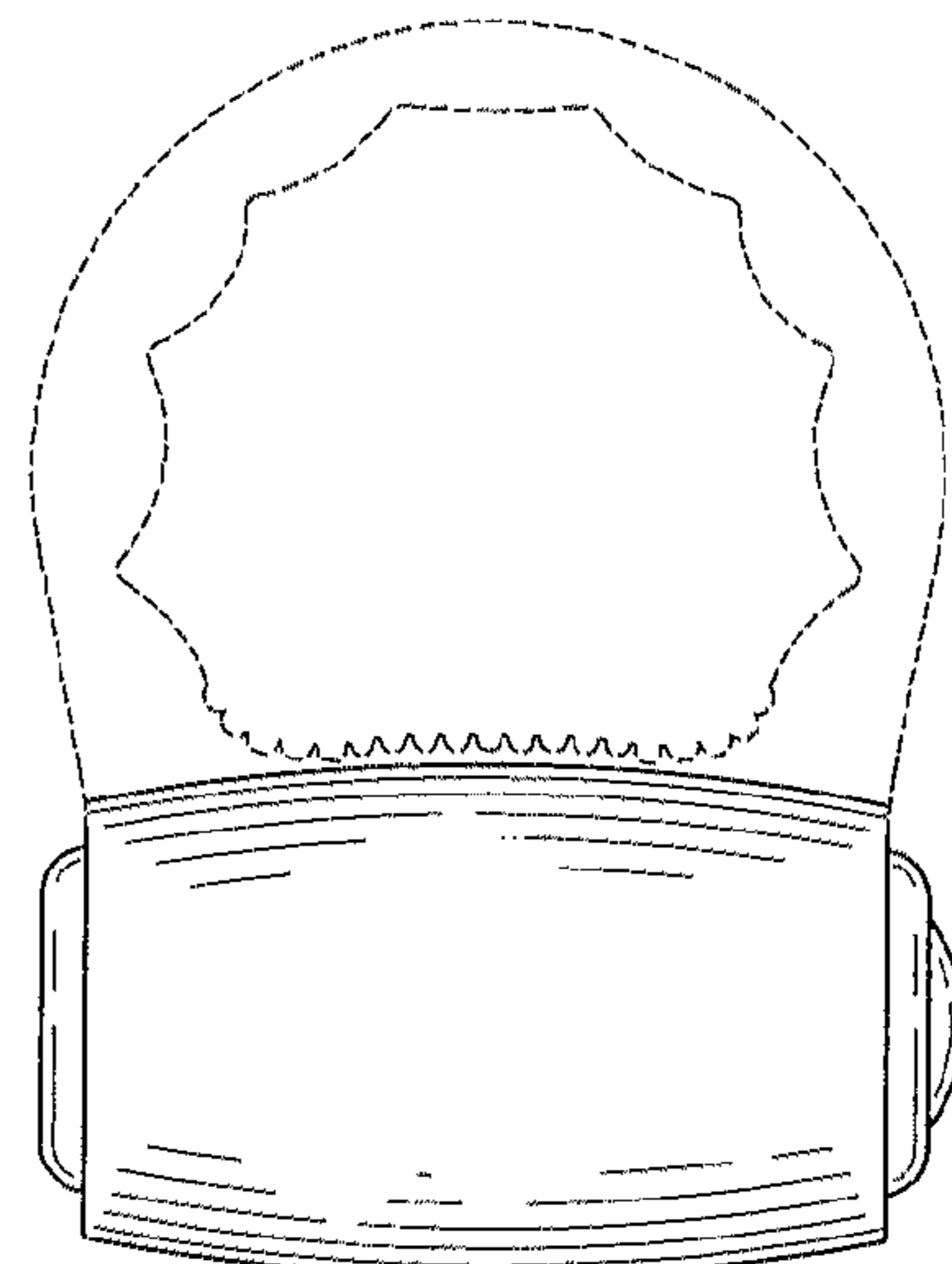

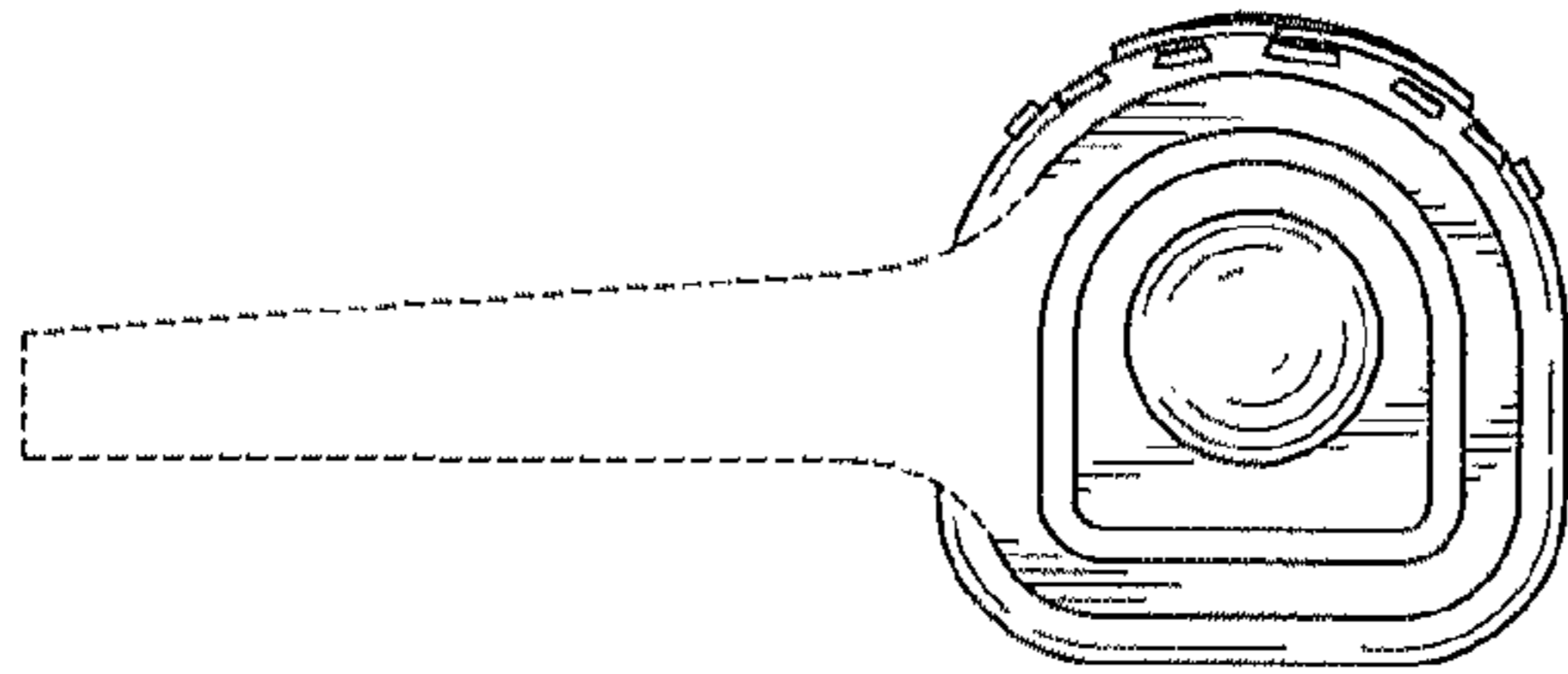

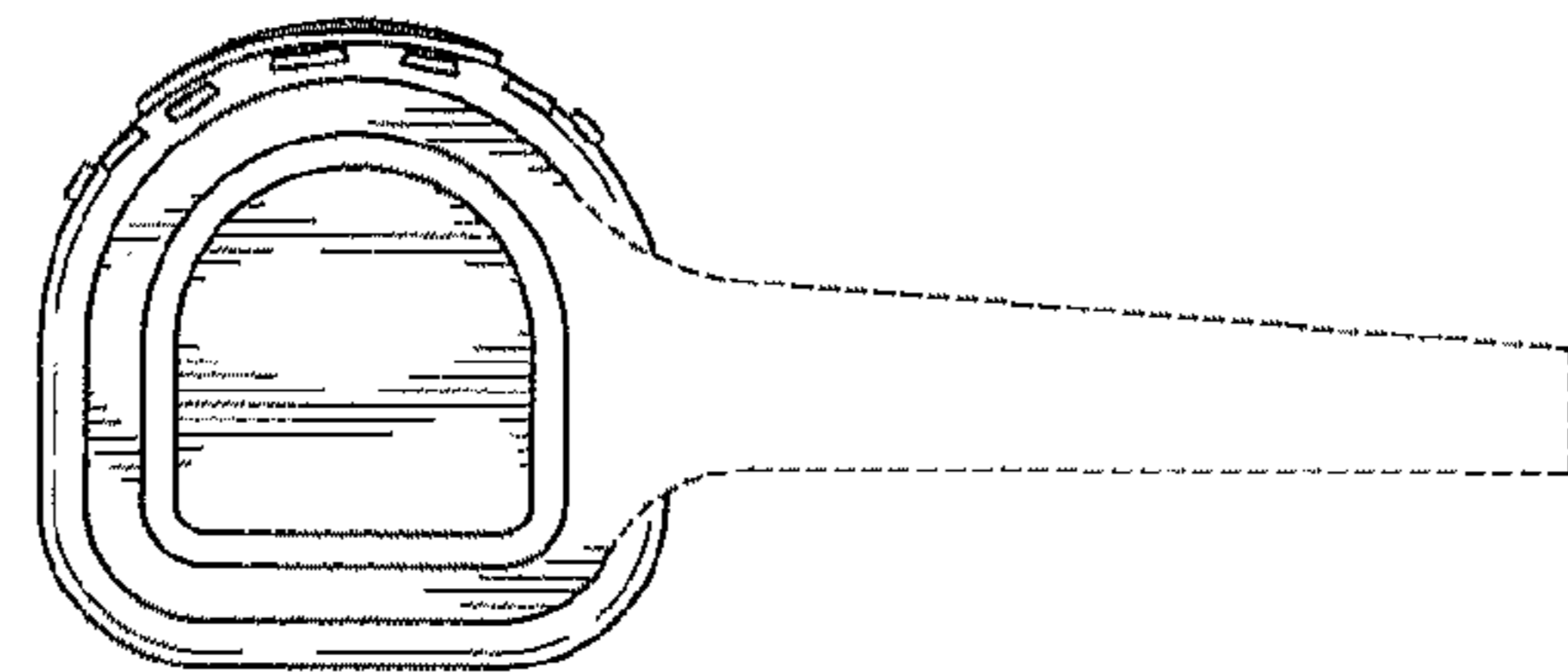

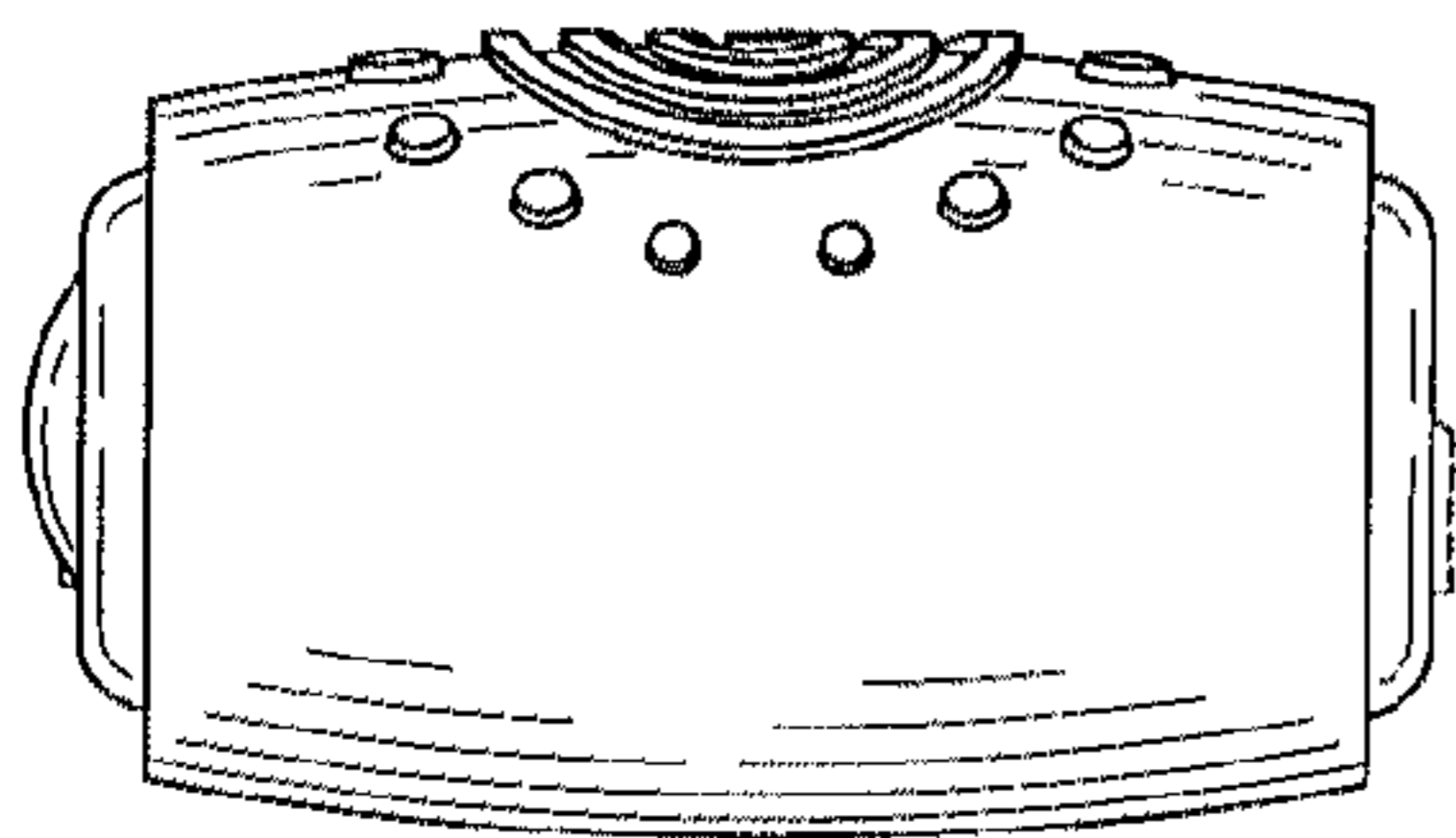
