(57) **CLAIM**

I claim the ornamental design for a horseshoe-shaped animal toy, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the horseshoe-shaped animal toy;

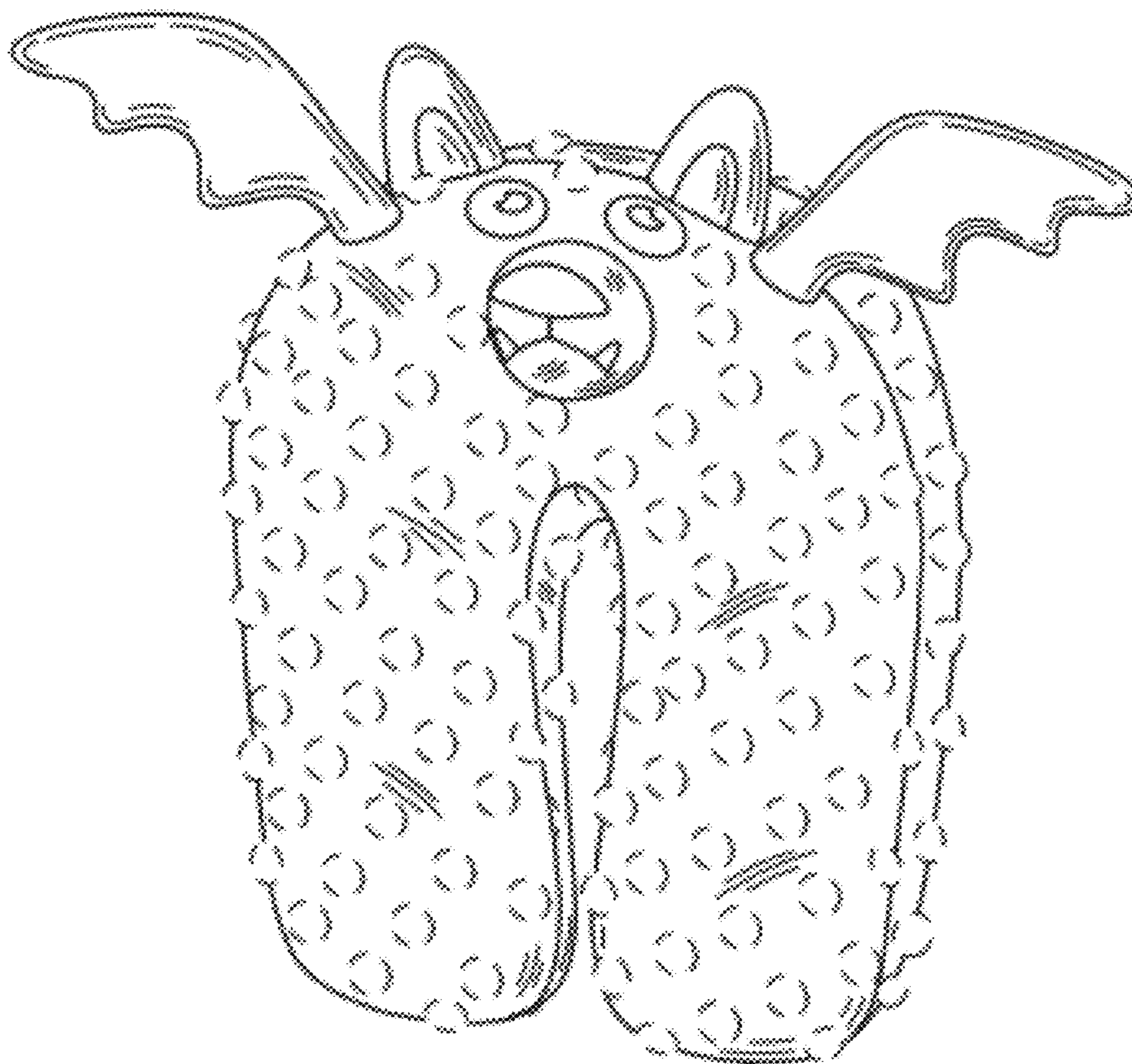

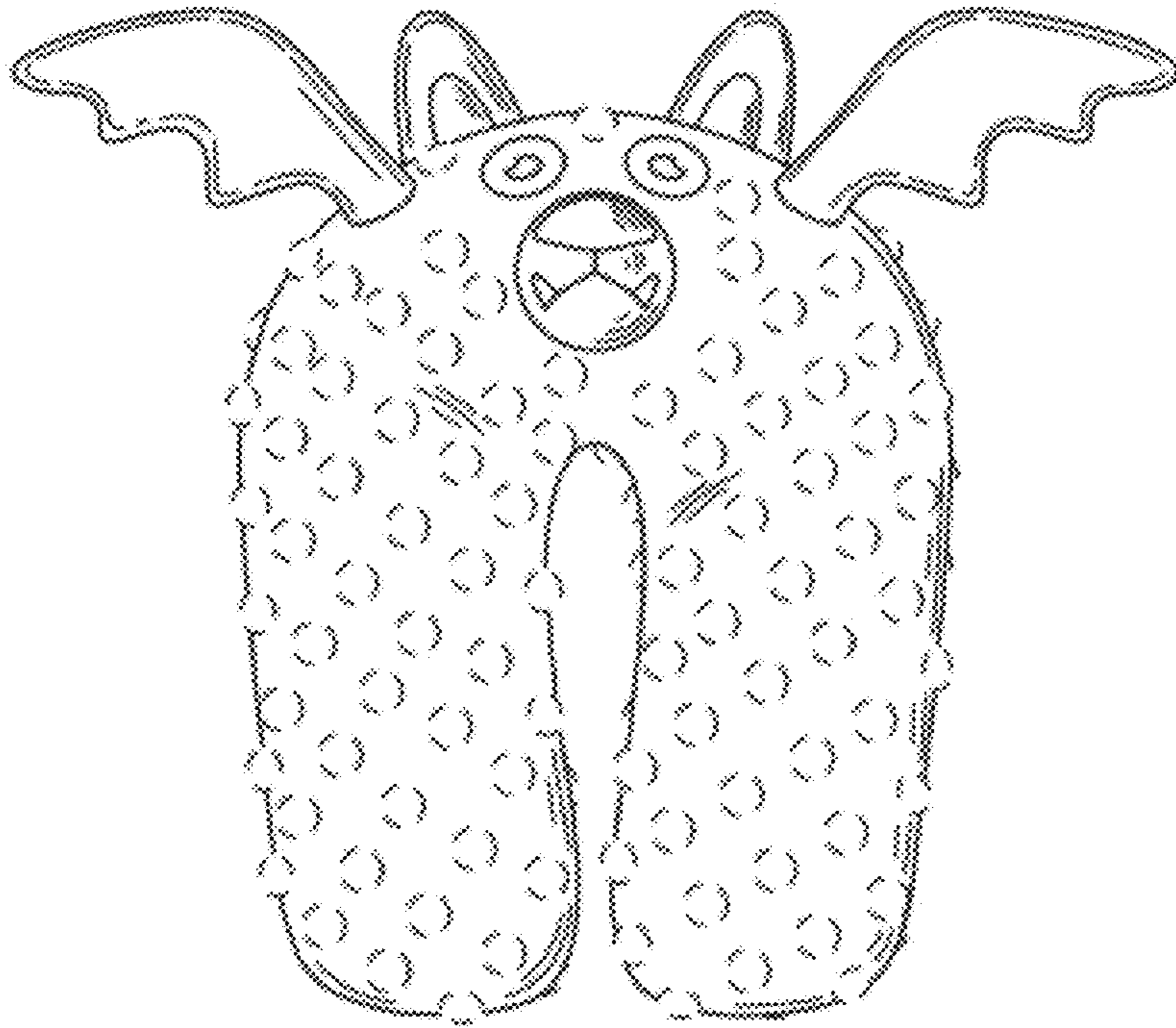

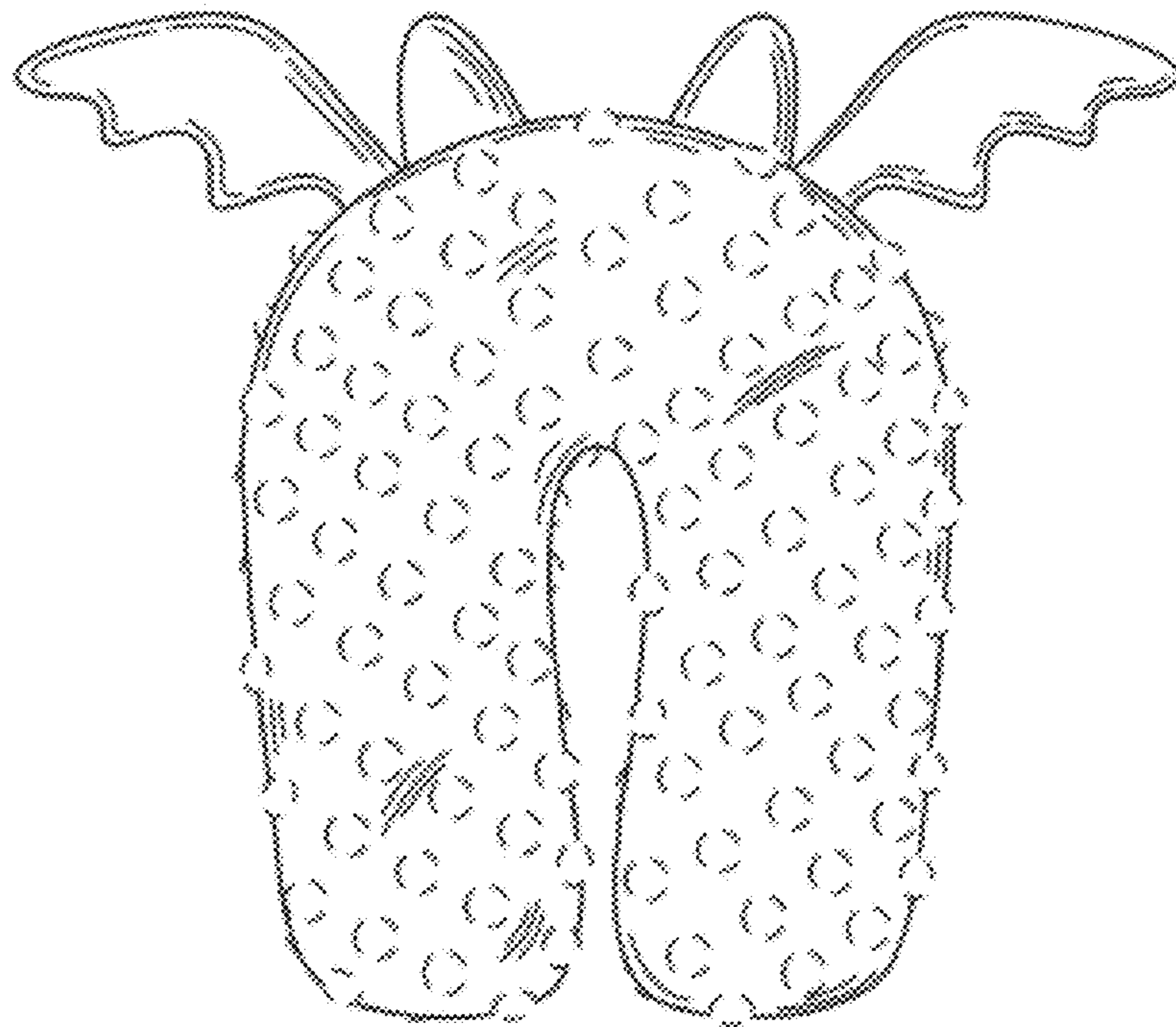

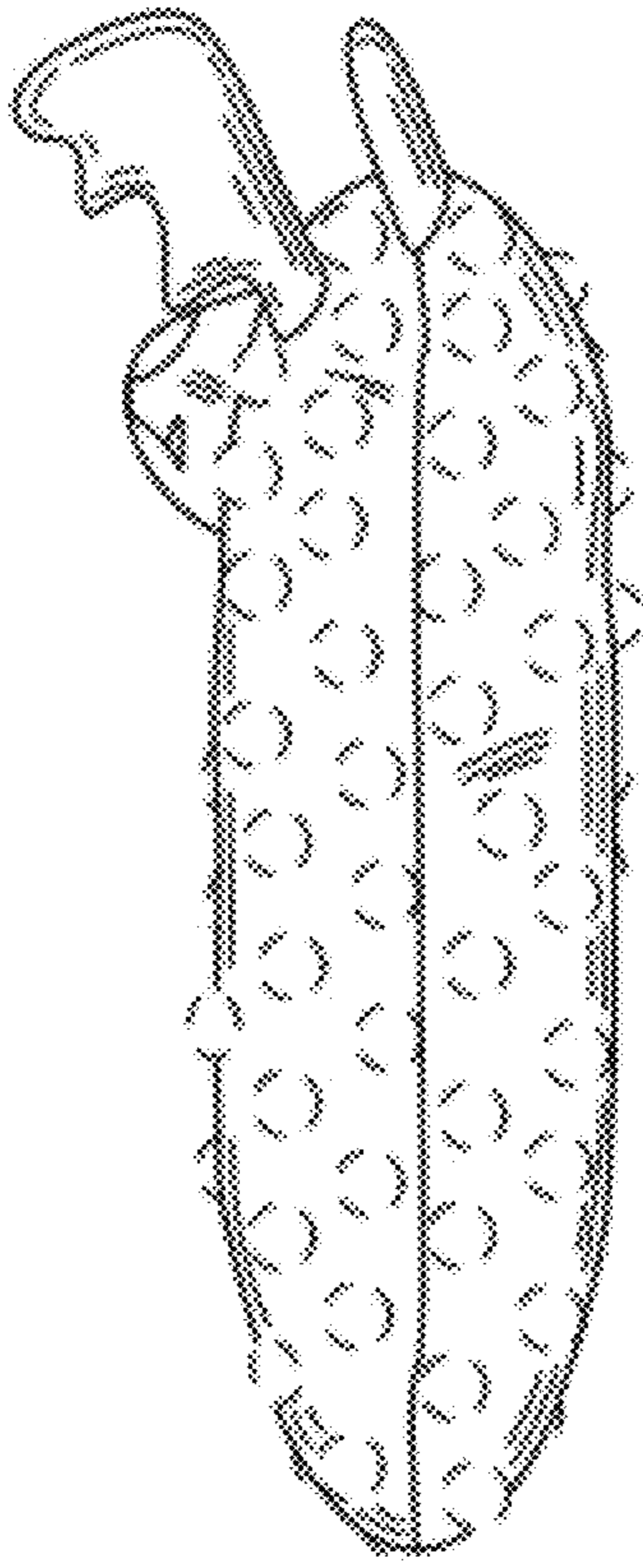

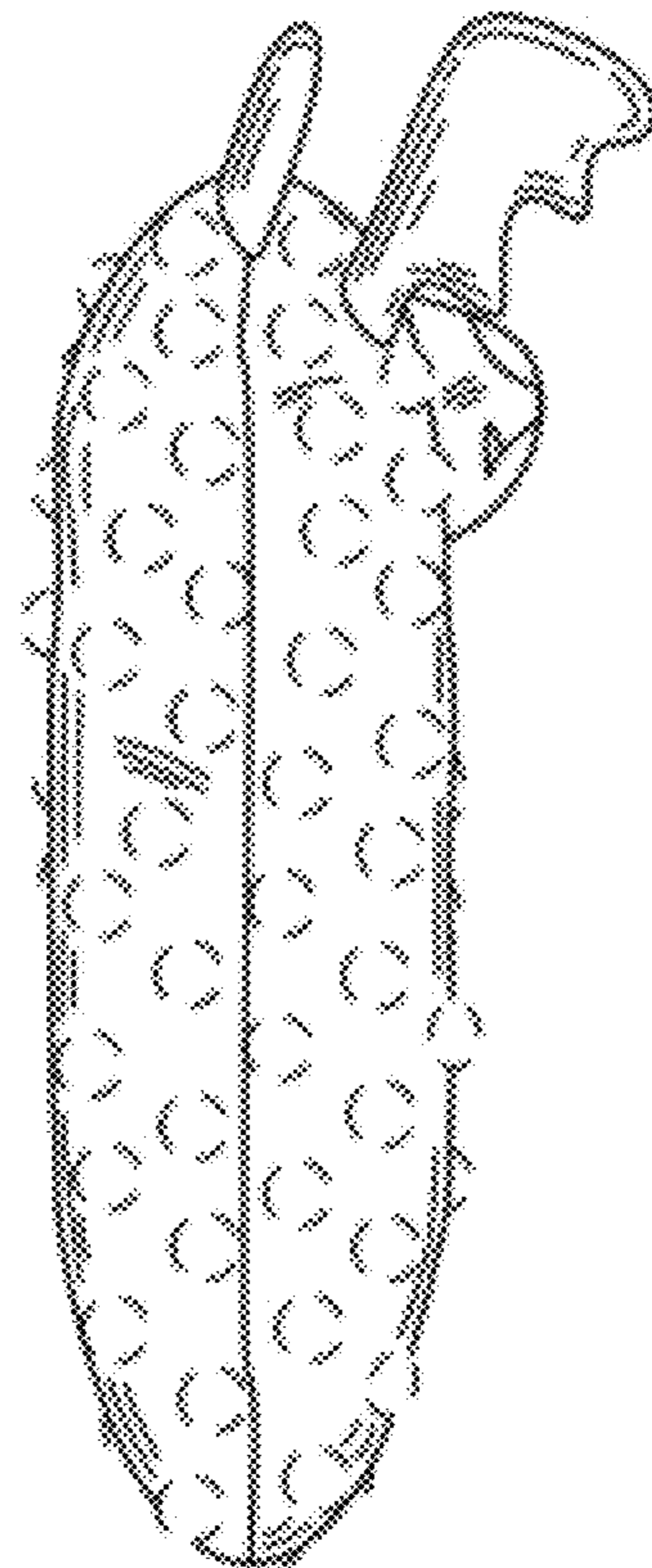

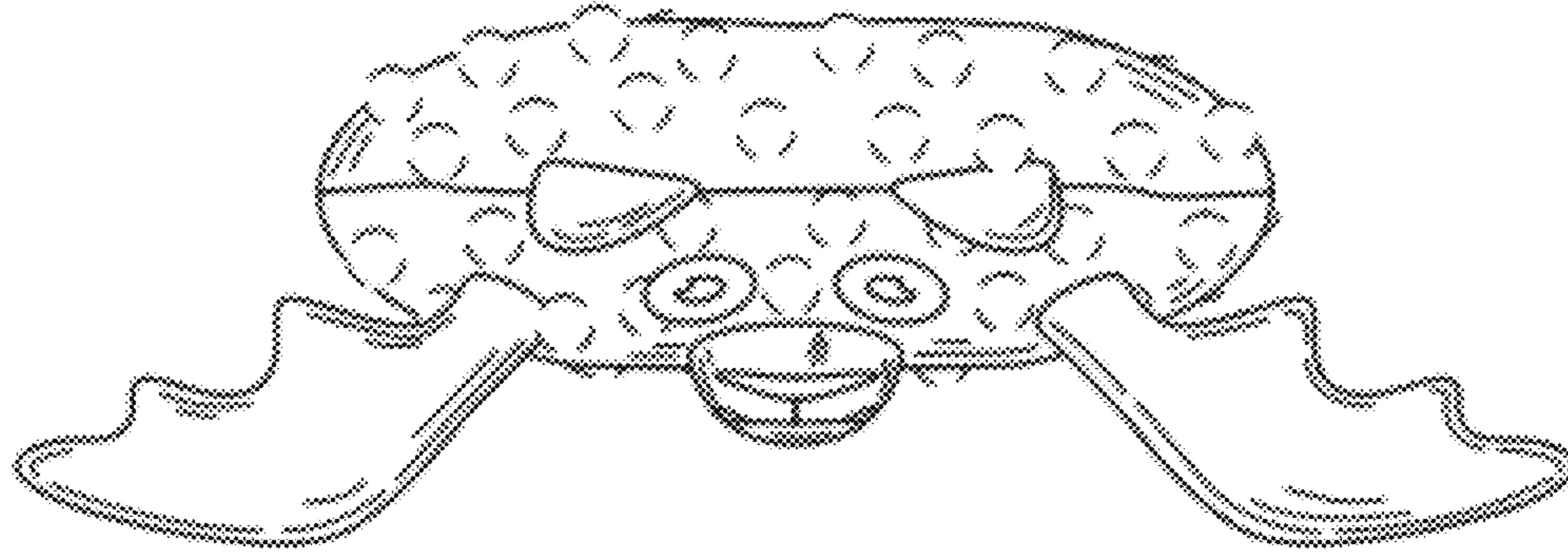

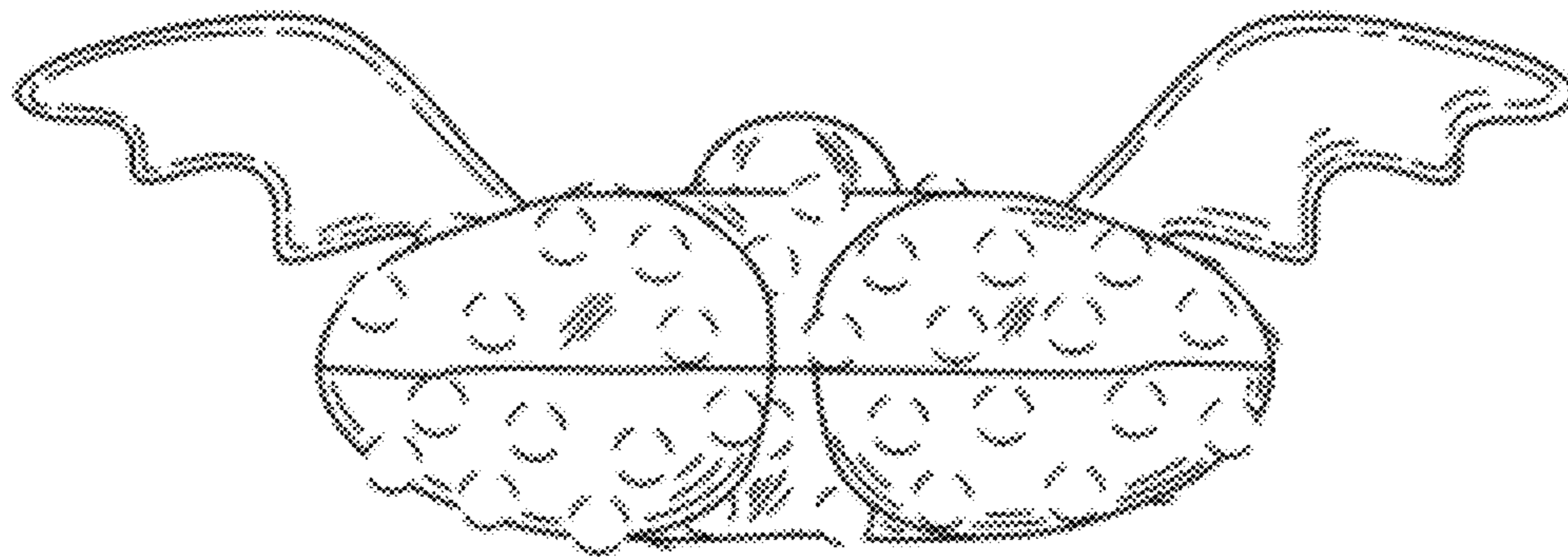
