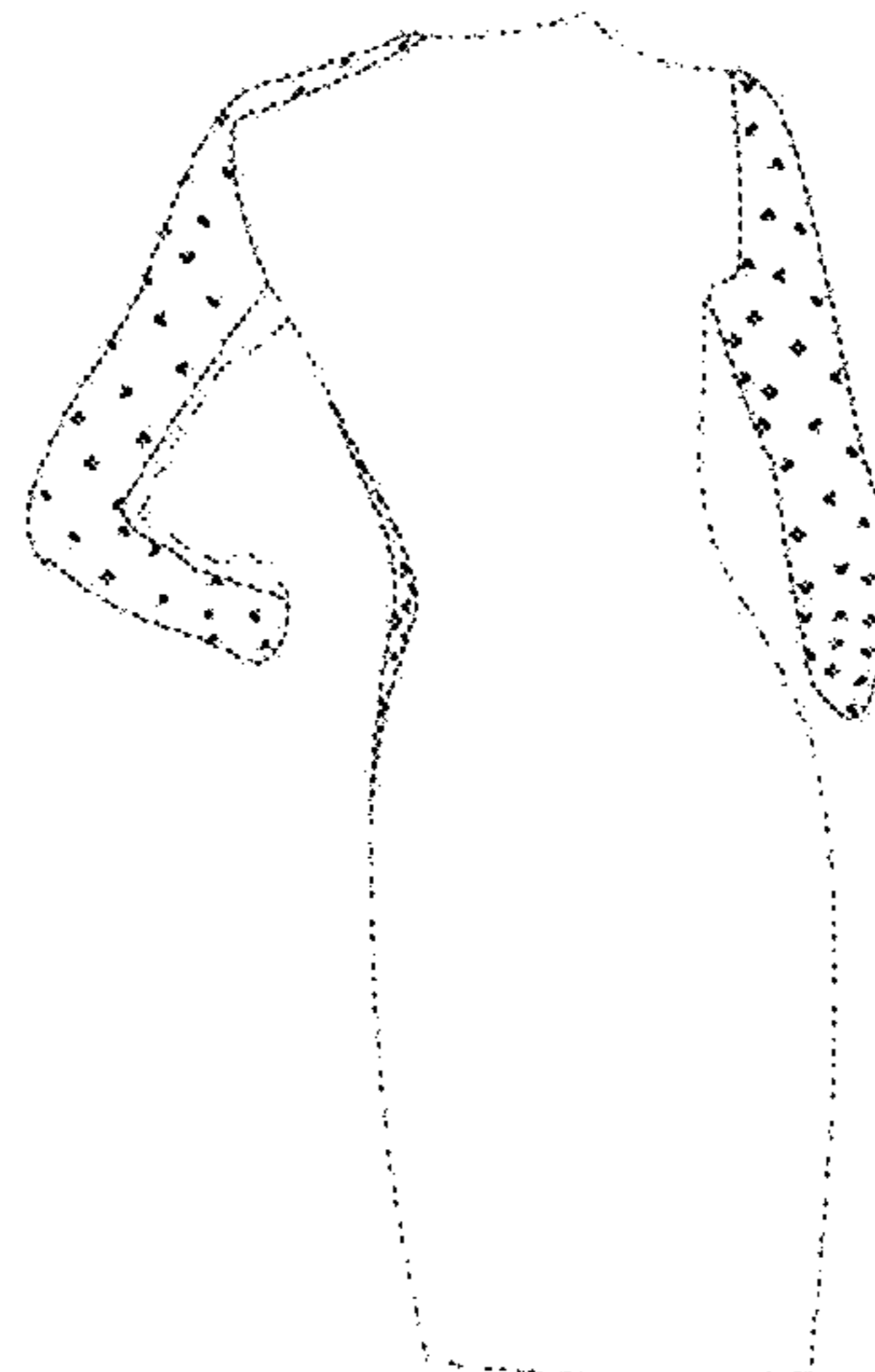
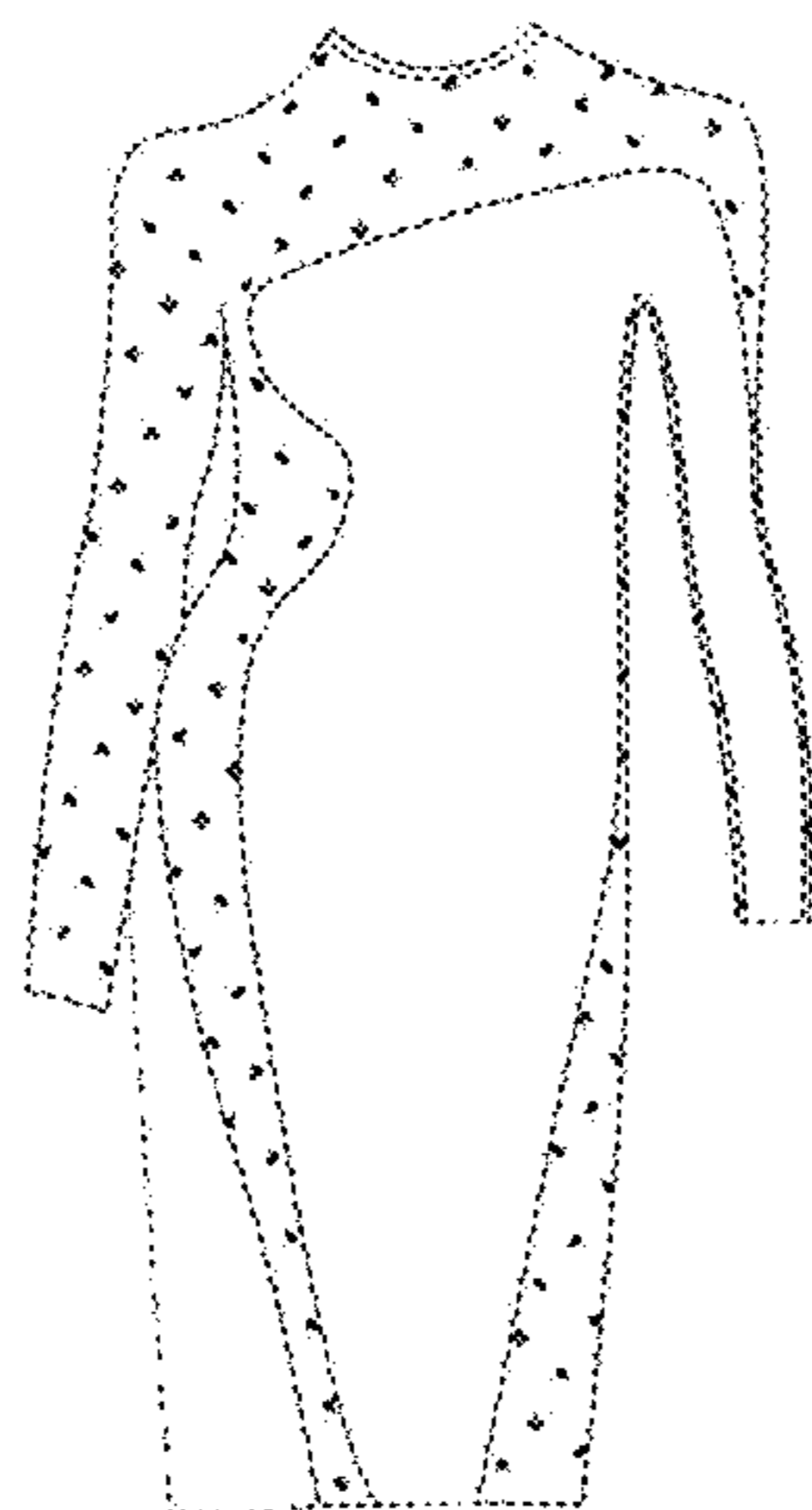
The ornamental design for a dress, as shown and described.

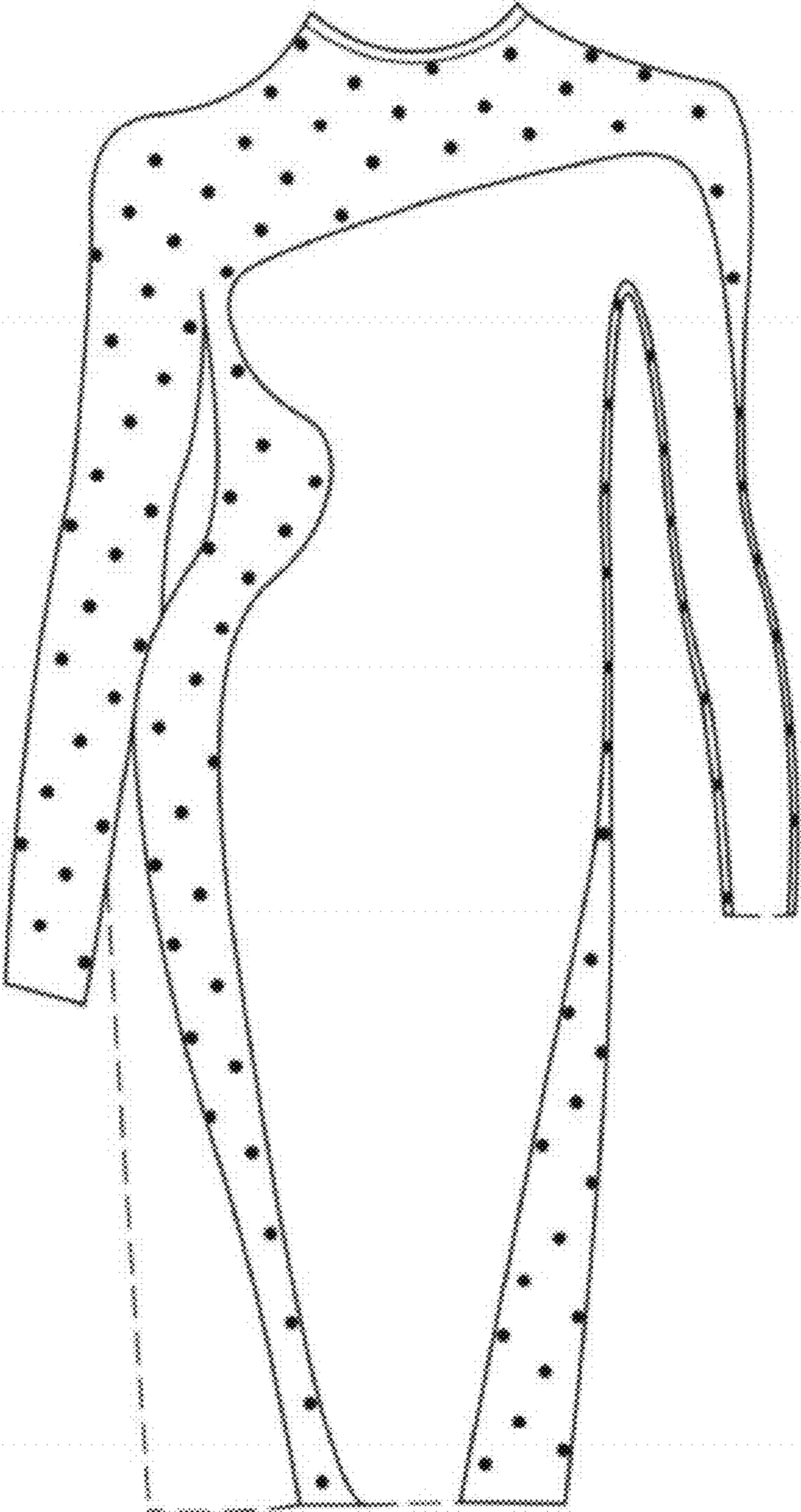

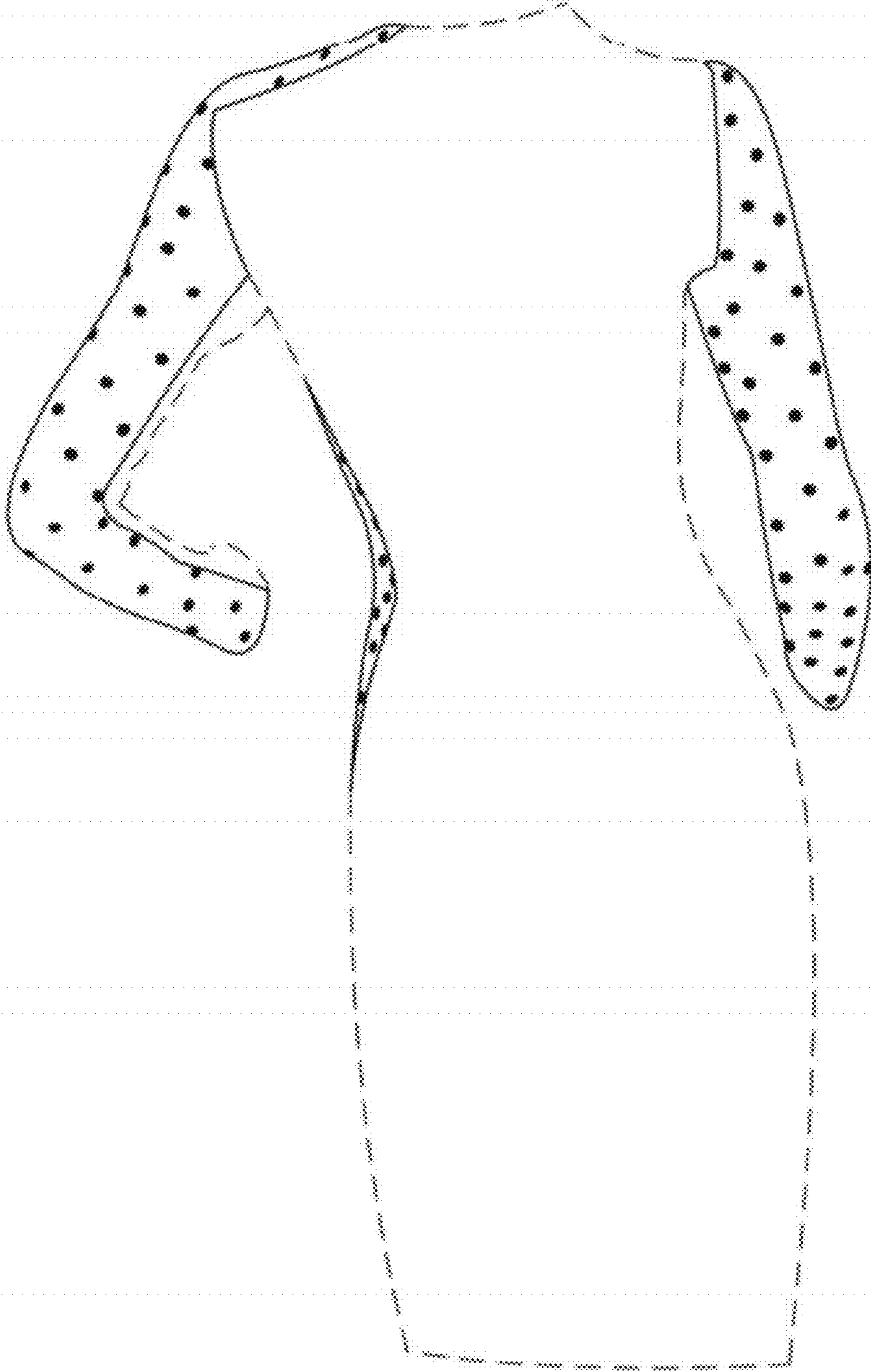
