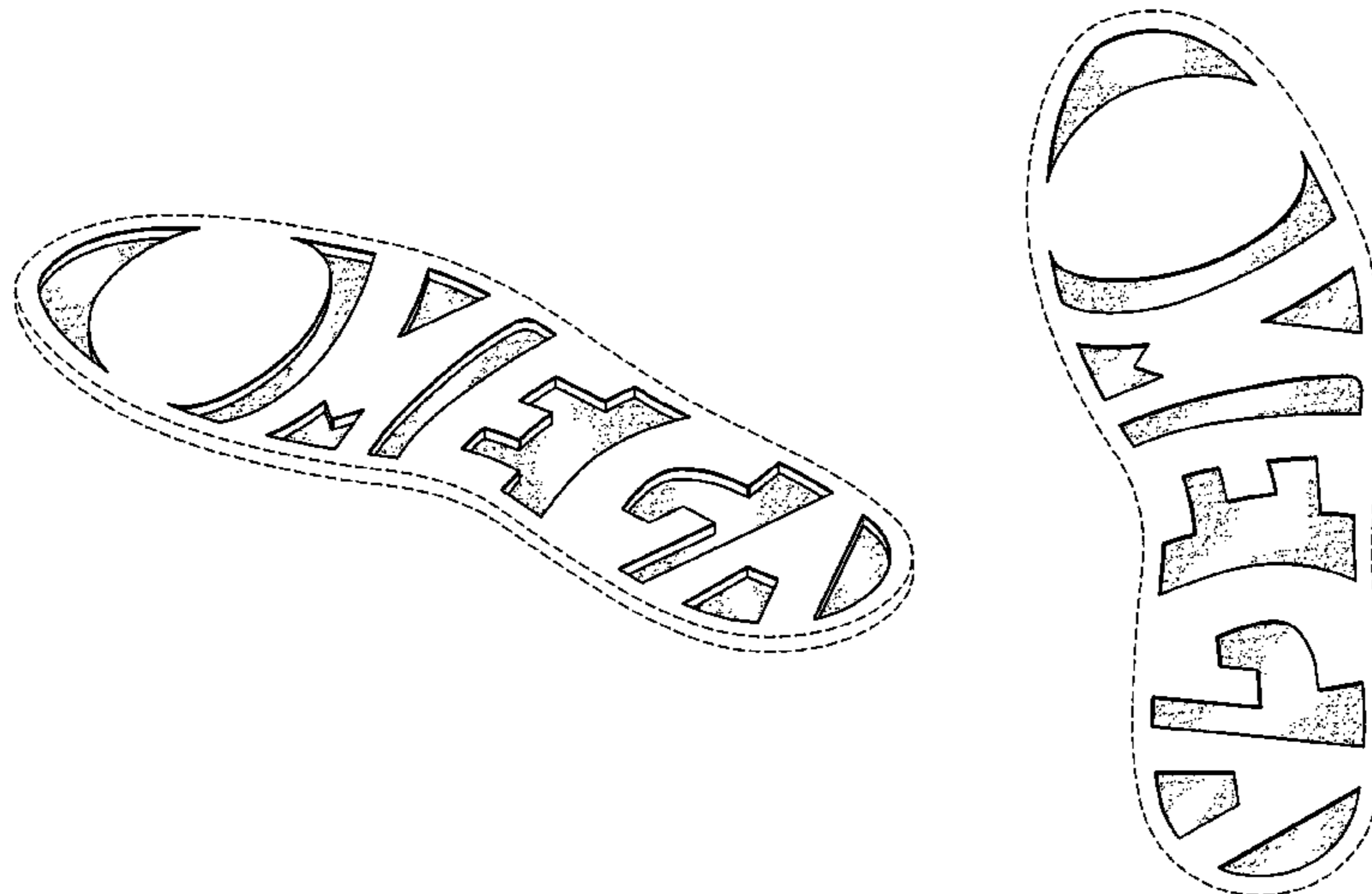
(57) **CLAIM**

The ornamental design for a shoe sole, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the shoe sole;
FIG. 2 is another perspective view of the shoe sole; and,
FIG. 3 is a plan view of the shoe sole.
The broken lines depict portions of the shoe sole that form no part of the claimed design.
A characteristic feature of the novel design resides in the word "OMEGA" formed into the sole.

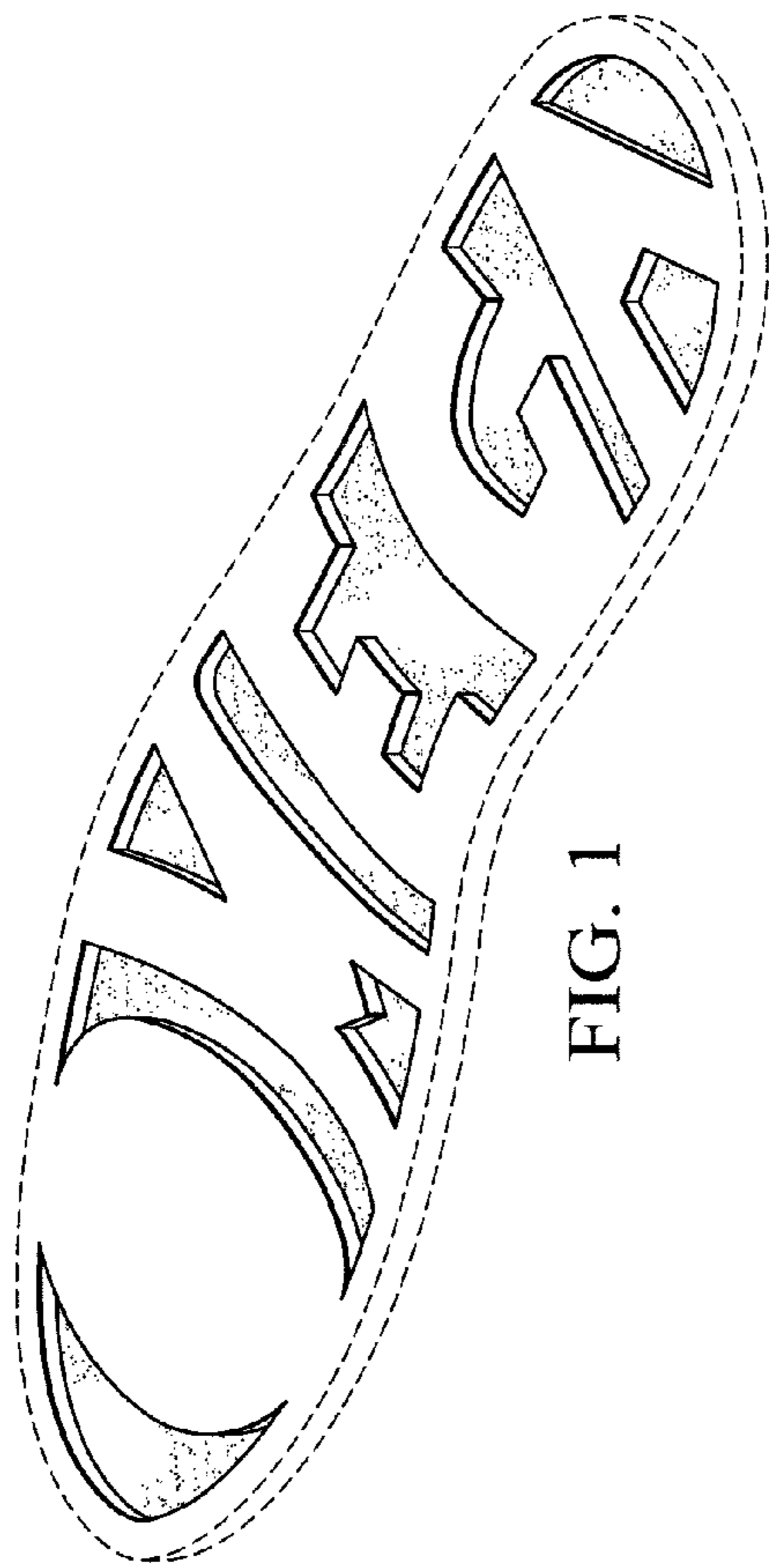

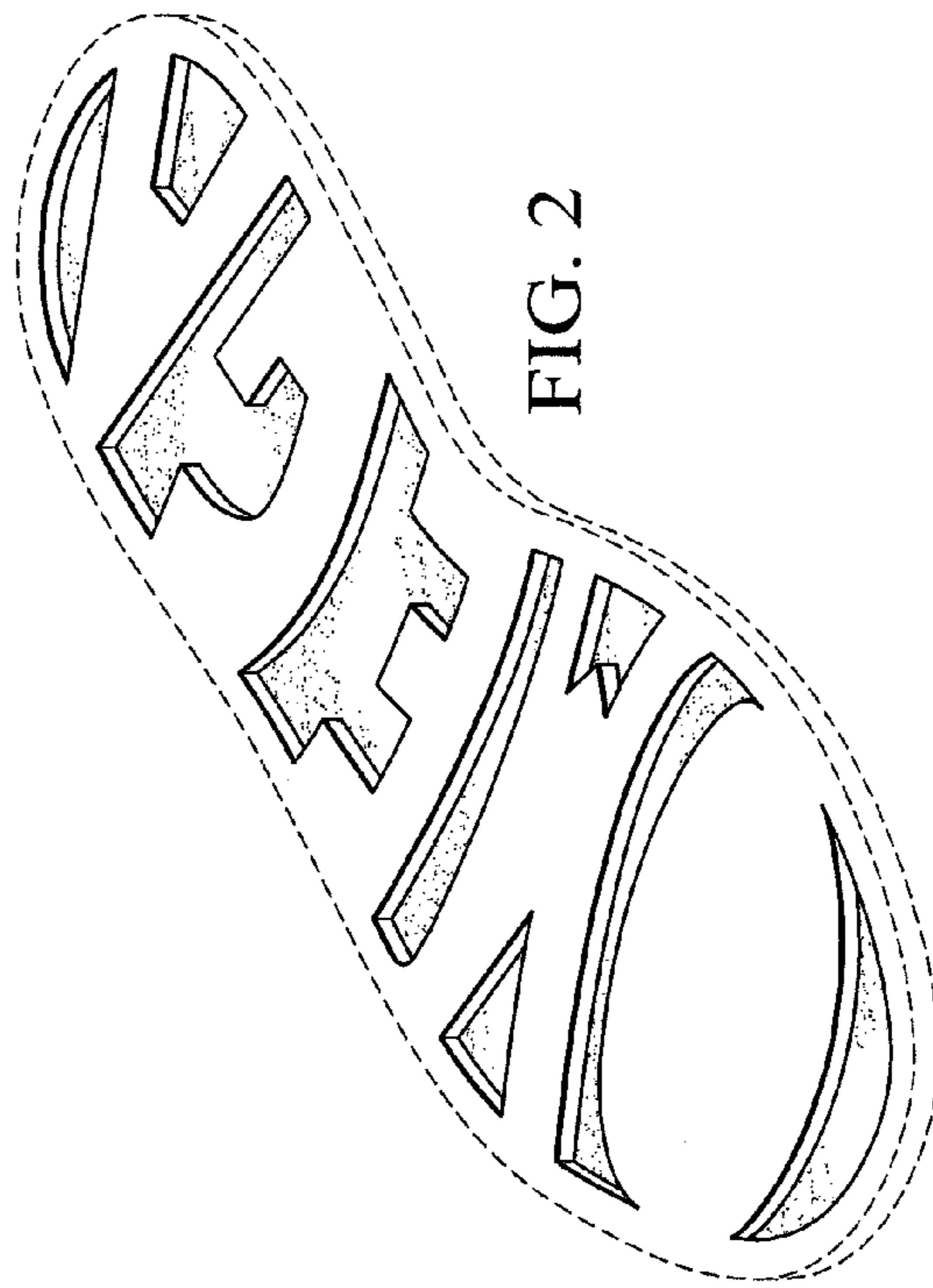
