(57) **CLAIM**

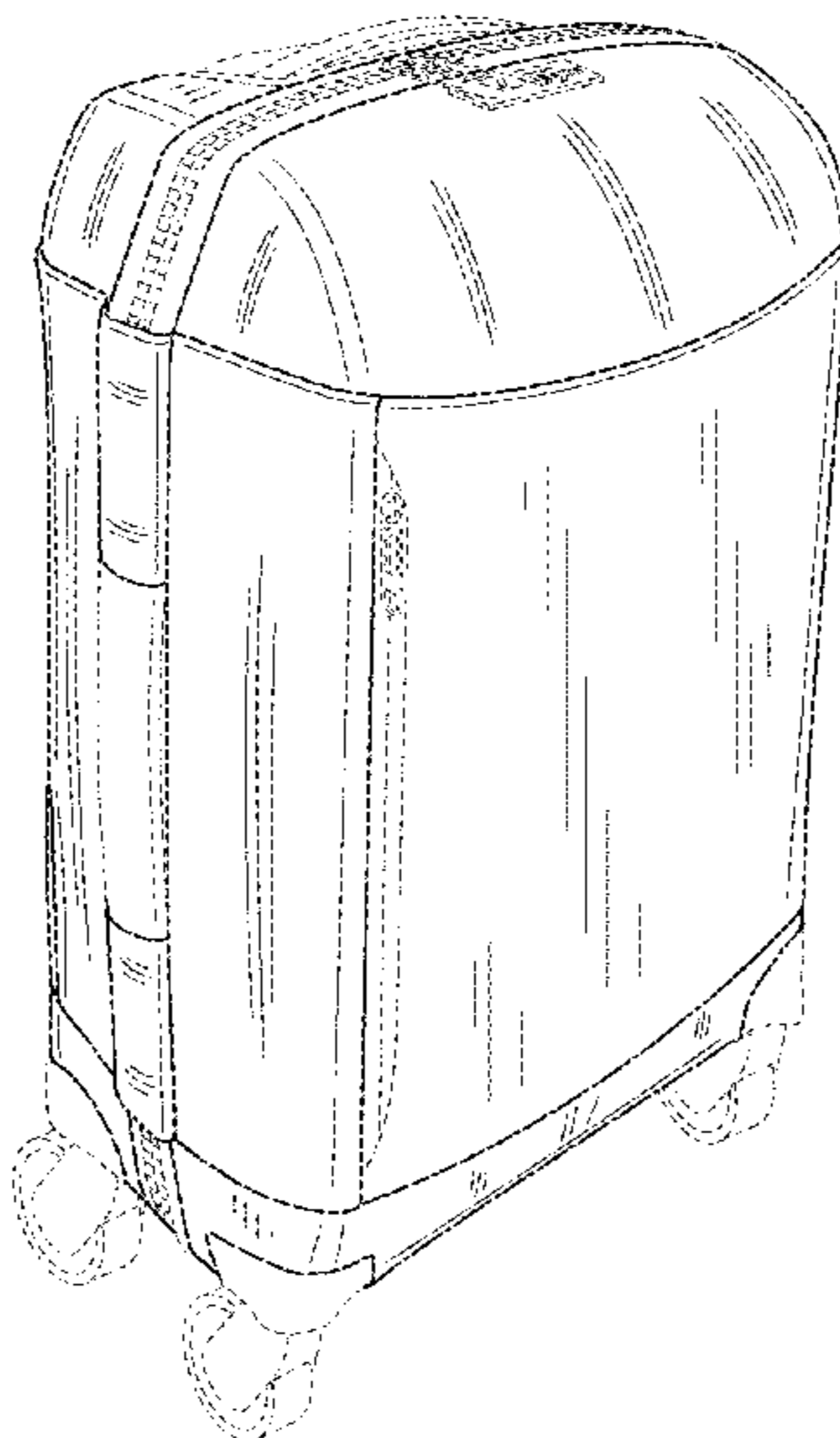
The ornamental design for a piece of luggage, as shown and described.

DESCRIPTION

FIG. 1 shows a front perspective view of a piece of luggage; FIG. 2 shows a front elevation view of the luggage of FIG. 1; FIG. 3 shows a rear elevation view of the luggage of FIG. 1; FIG. 4 shows a left elevation view of the luggage of FIG. 1; FIG. 5 shows a right elevation view of the luggage of FIG. 1; FIG. 6 shows a top view of the luggage of FIG. 1; and, FIG. 7 shows a bottom view of the luggage of FIG. 1.

The dashed lines depicting the wheels illustrate the environment of the claim. The remaining dashed lines illustrate the boundaries. None of the dashed lines forms part of the claimed design.

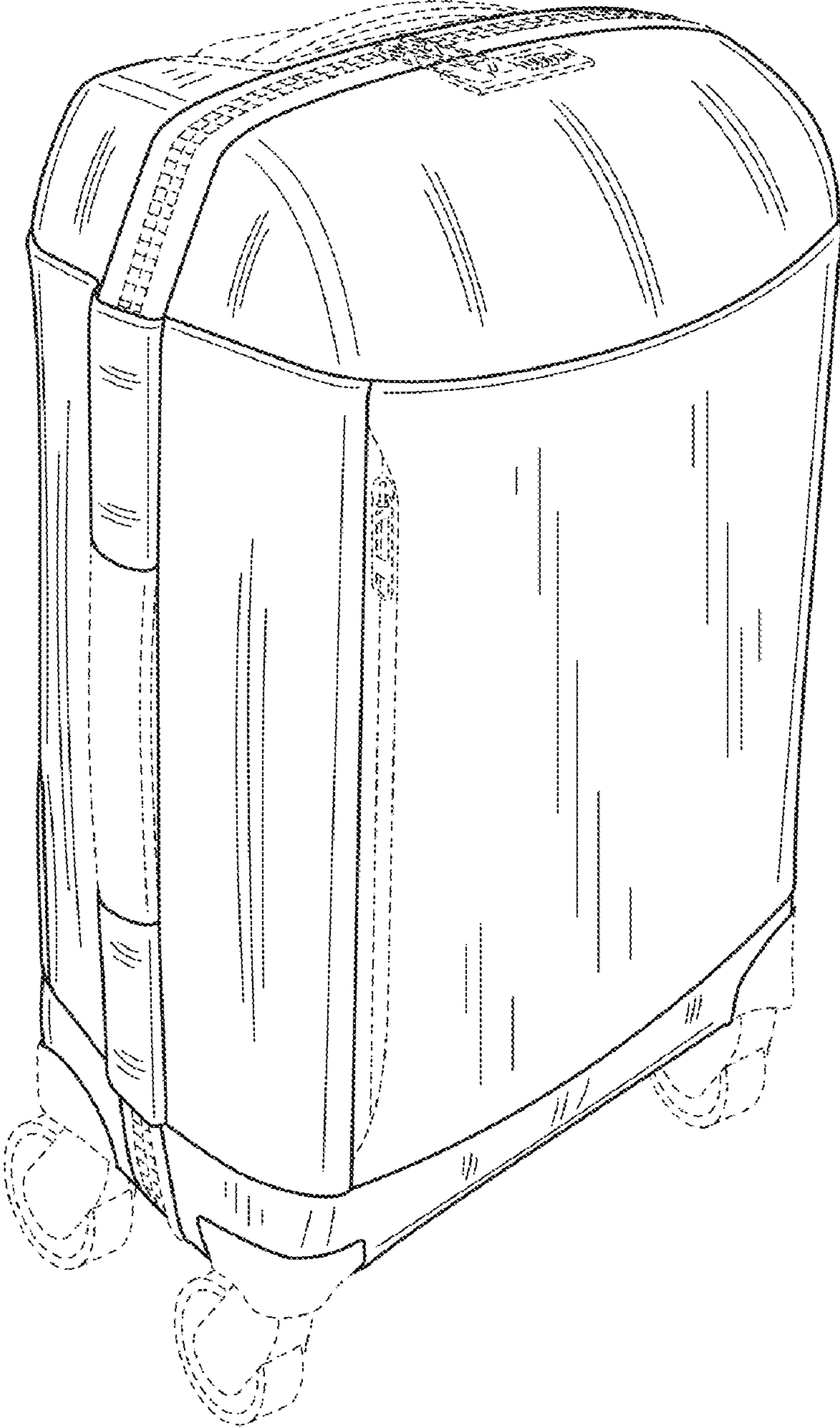

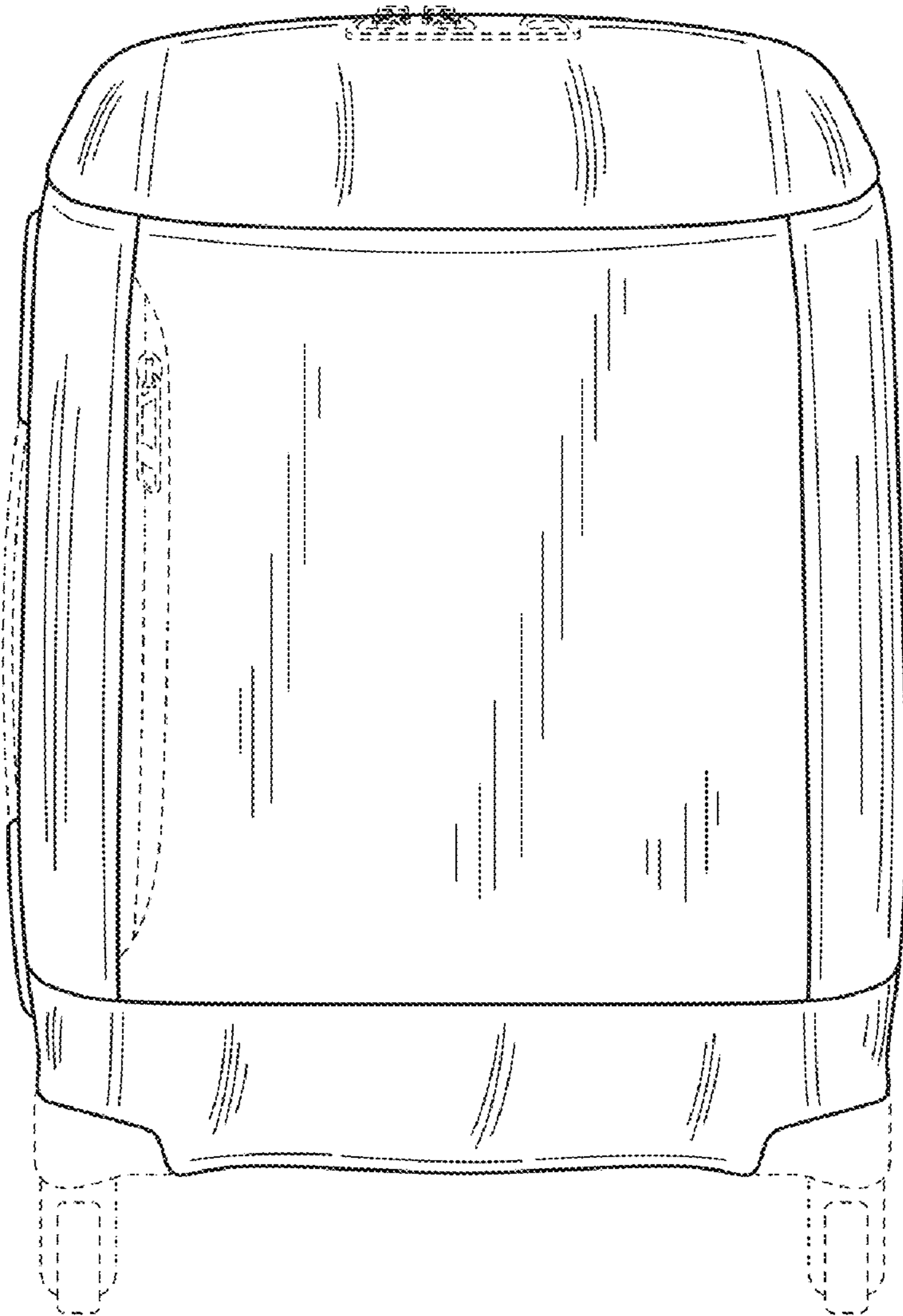

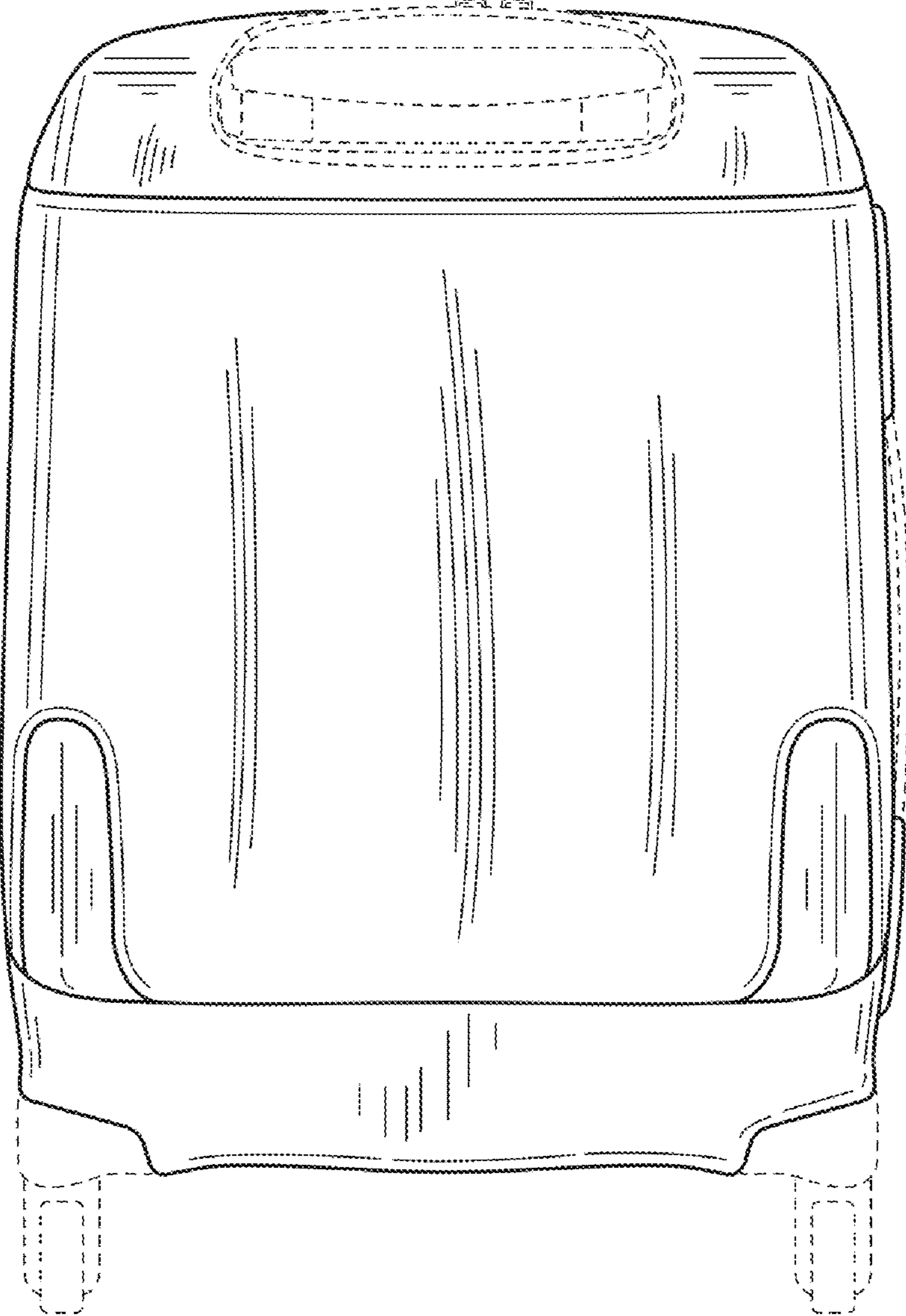

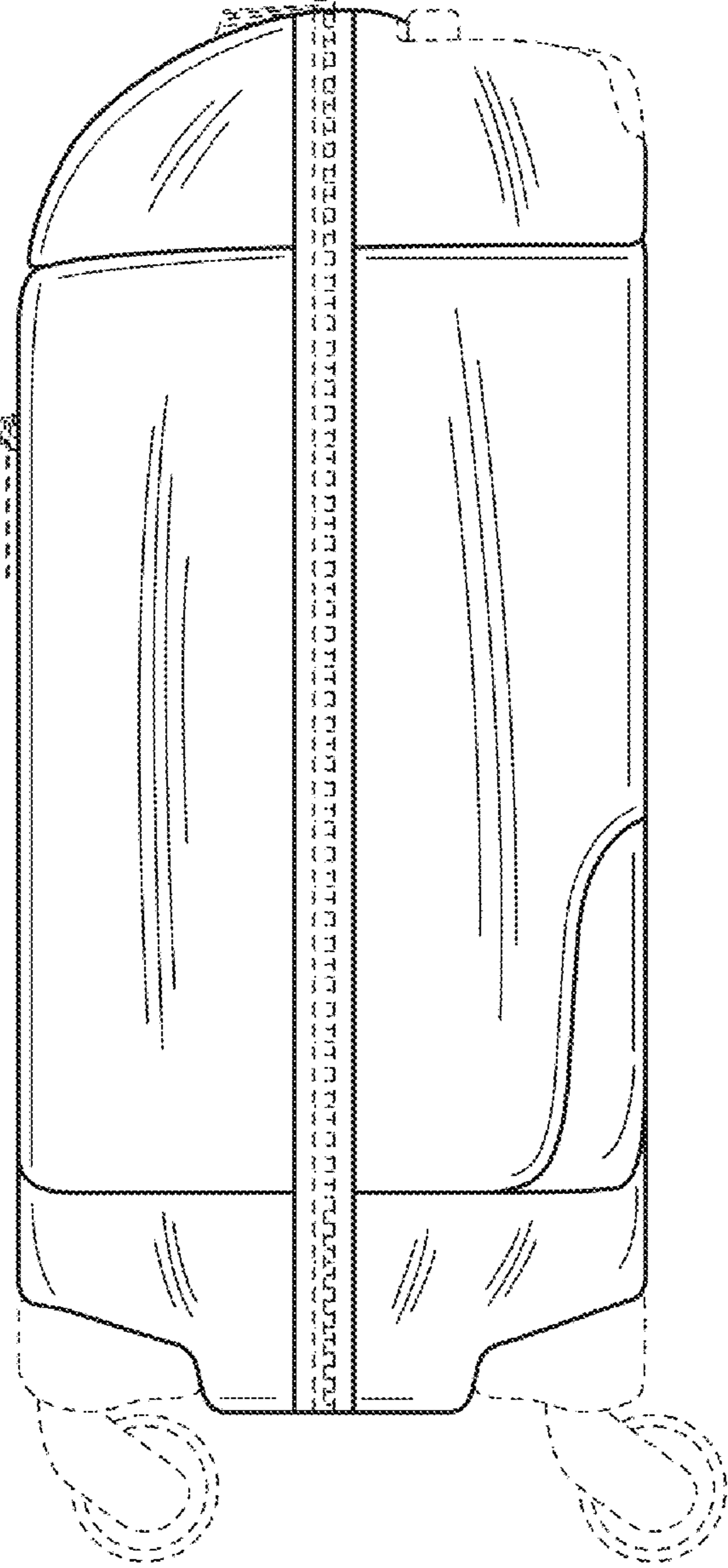

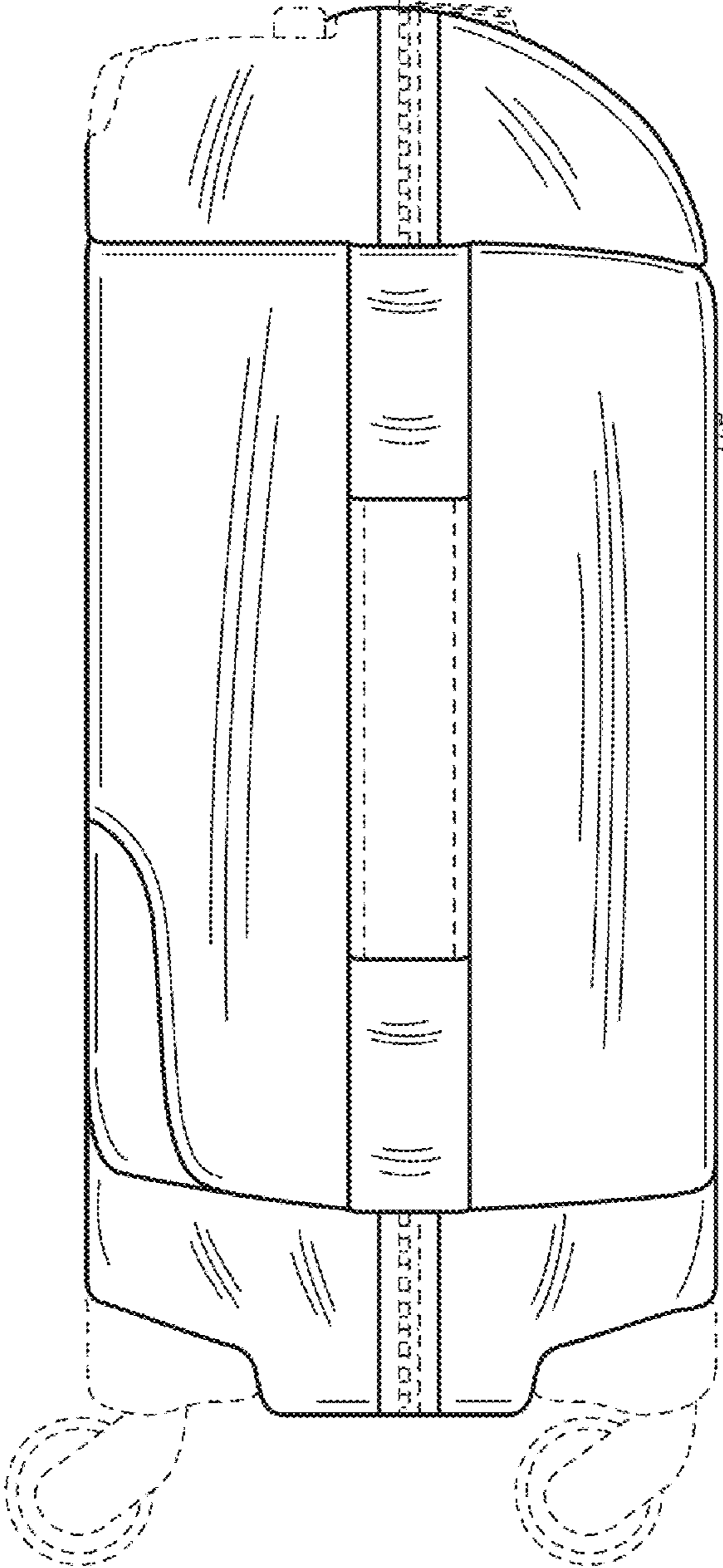

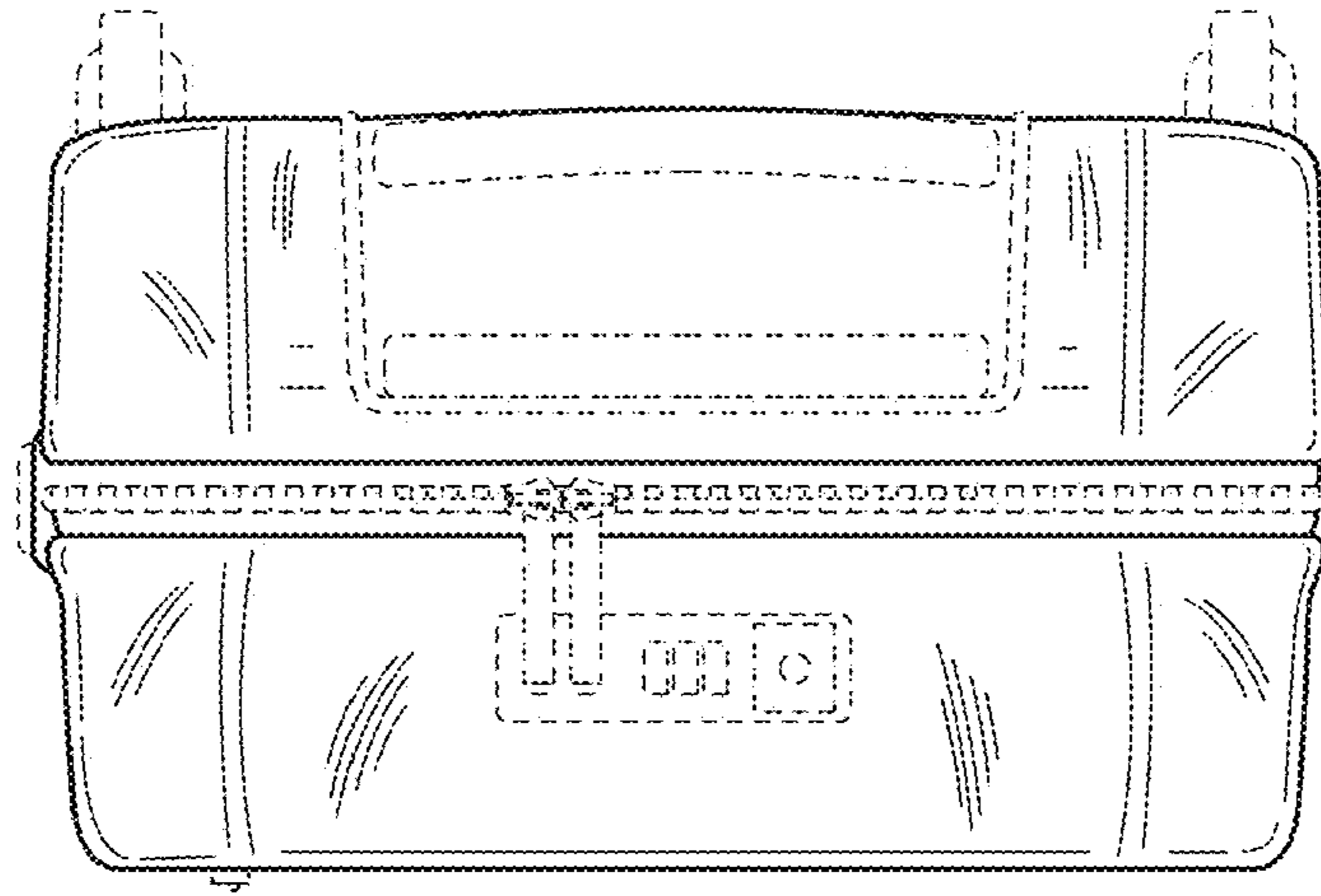

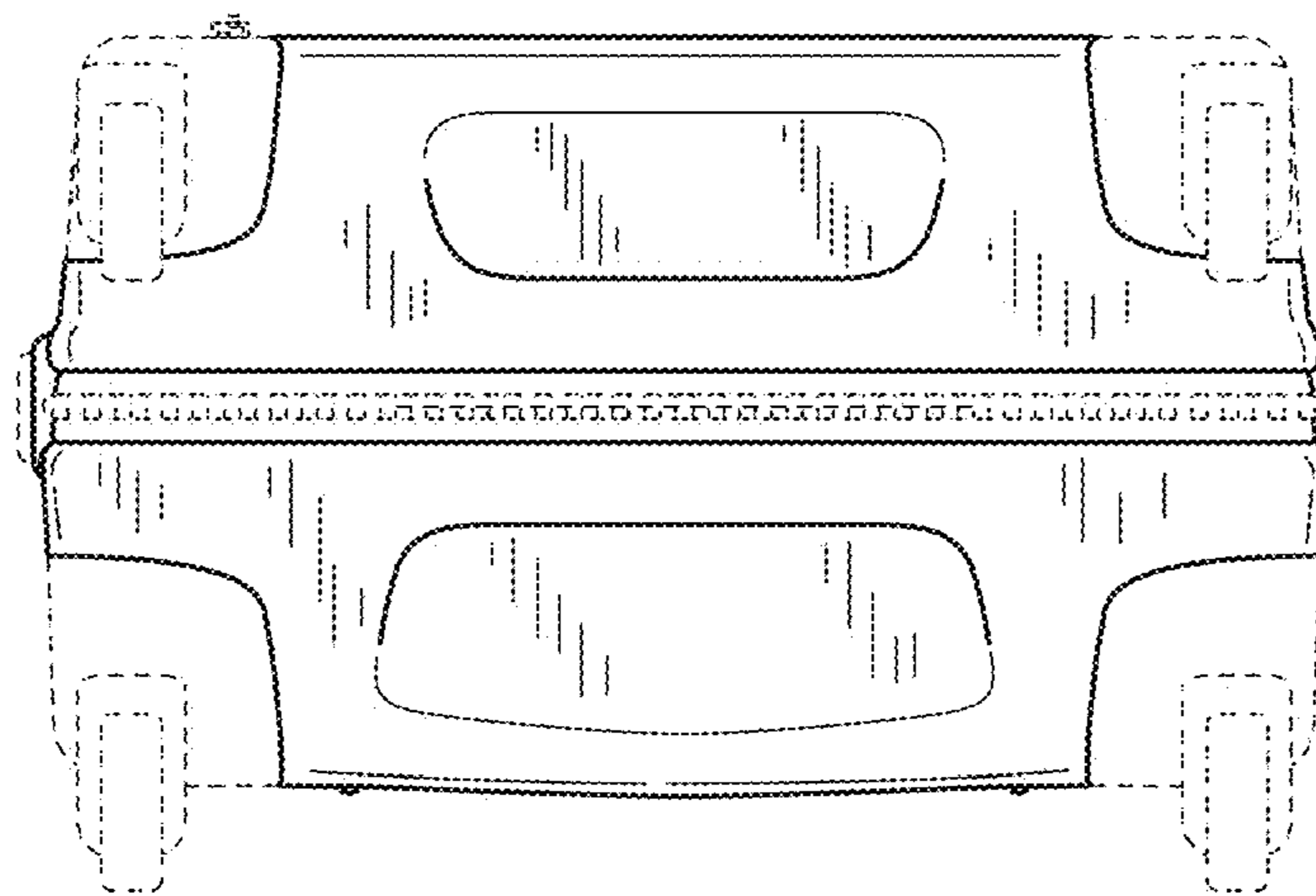
