FIG. 6 is a perspective view of the ski strap carrier positioned around the bottom of set of skies.

FIG. 7 is a perspective view of the ski strap carrier having a broken line to show infinite length.

FIG. 8 is a top view of the ski strap carrier having a broken line to show infinite length.

FIG. 9 is a bottom view of the ski strap carrier having a broken line to show infinite length.

FIG. 10 is a side view of the ski strap carrier having a broken line to show infinite length.

FIG. 11 is the other side view of the ski strap carrier having a broken line to show infinite length.

FIG. 12 is a front view of the ski strap carrier; and,

FIG. 13 is a back view of the ski strap carrier.

The broken lines in the drawing figures are to represent the environment and form no part of the claimed design.

The drawings of FIGS. 7-11 are shown broken for ease of illustration.

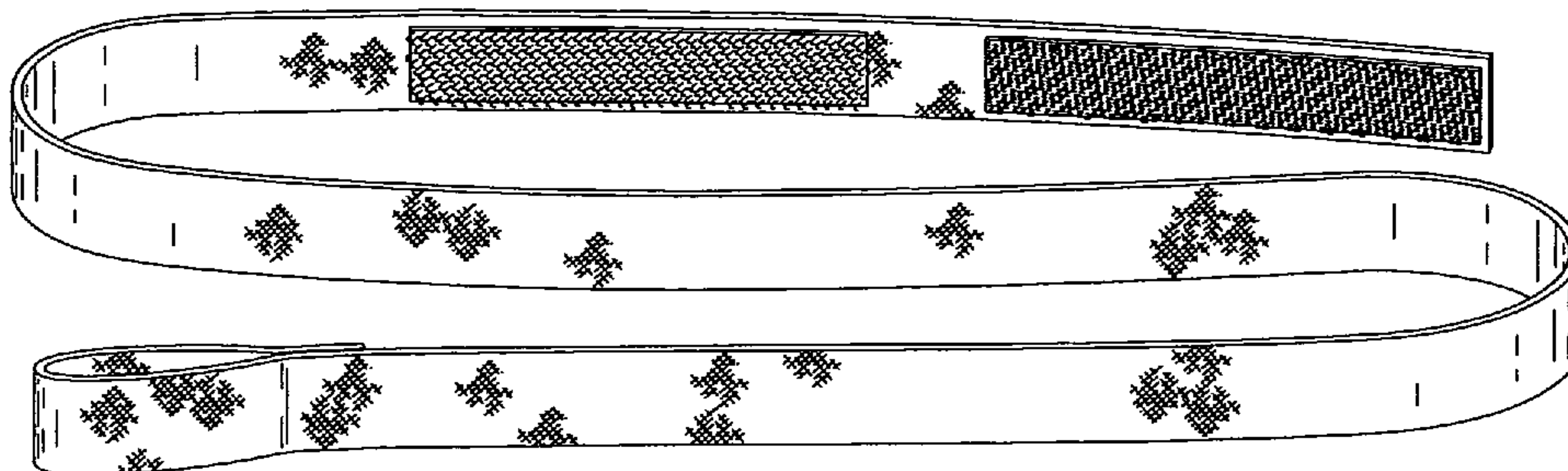

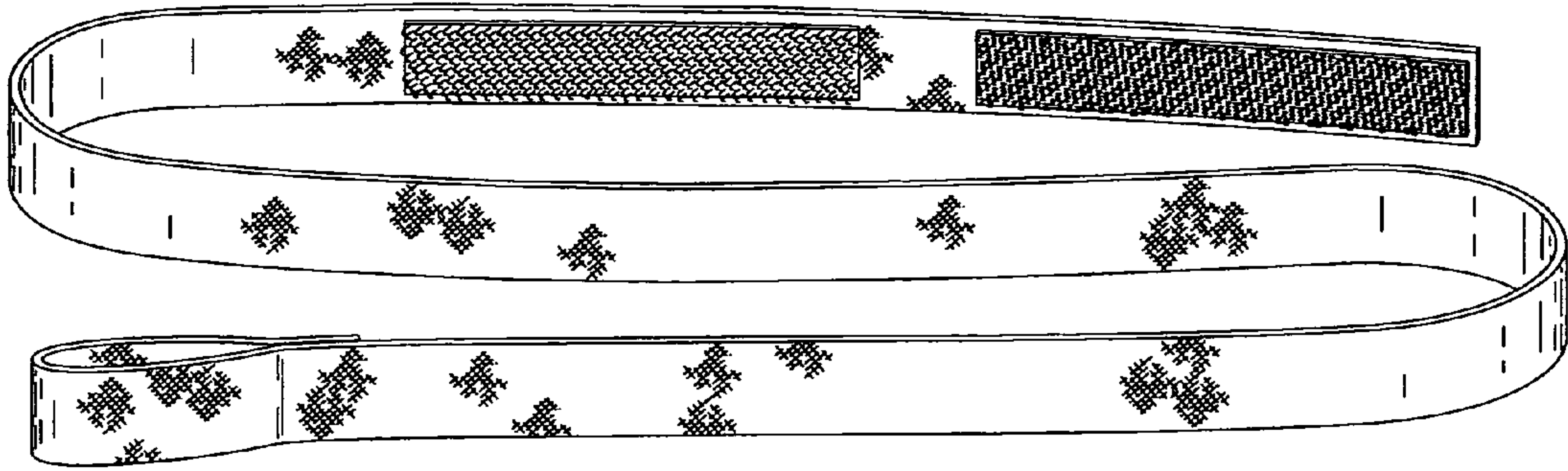

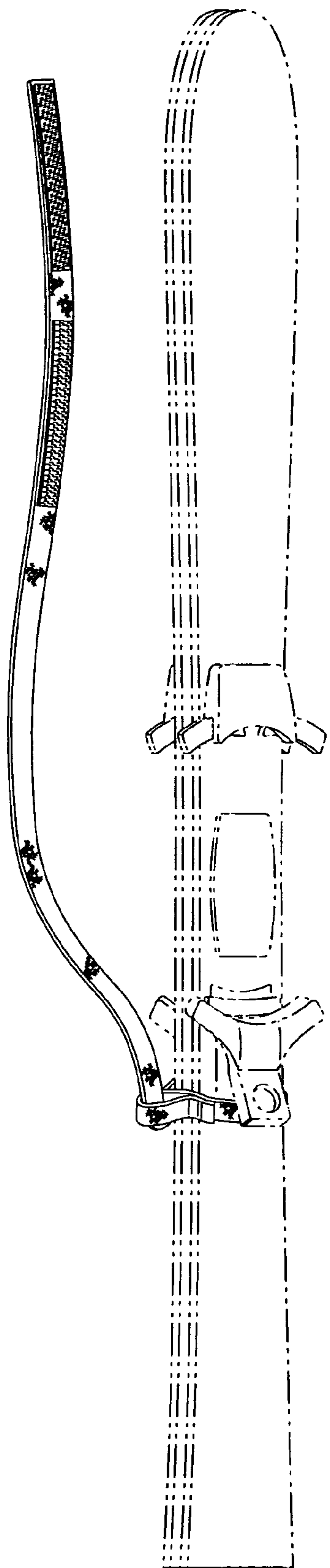
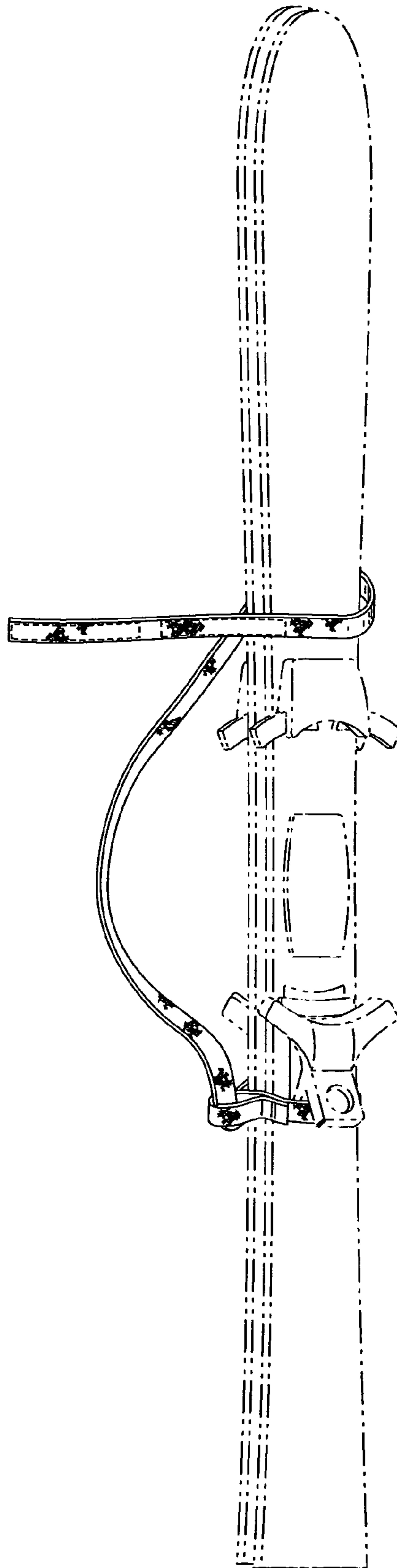
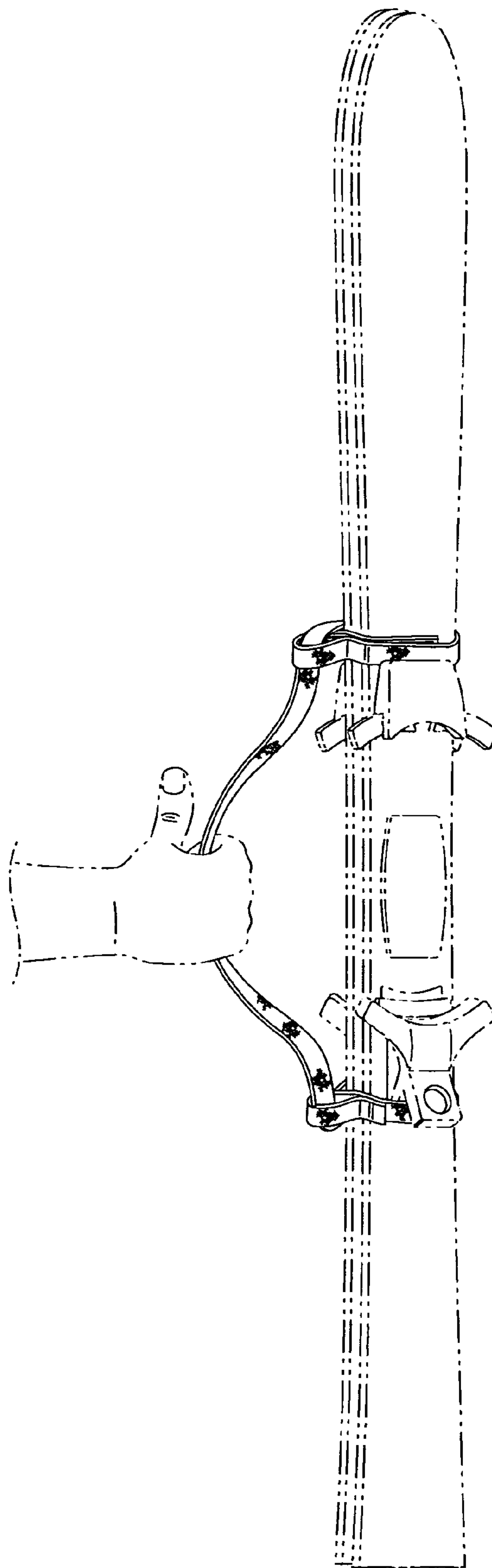


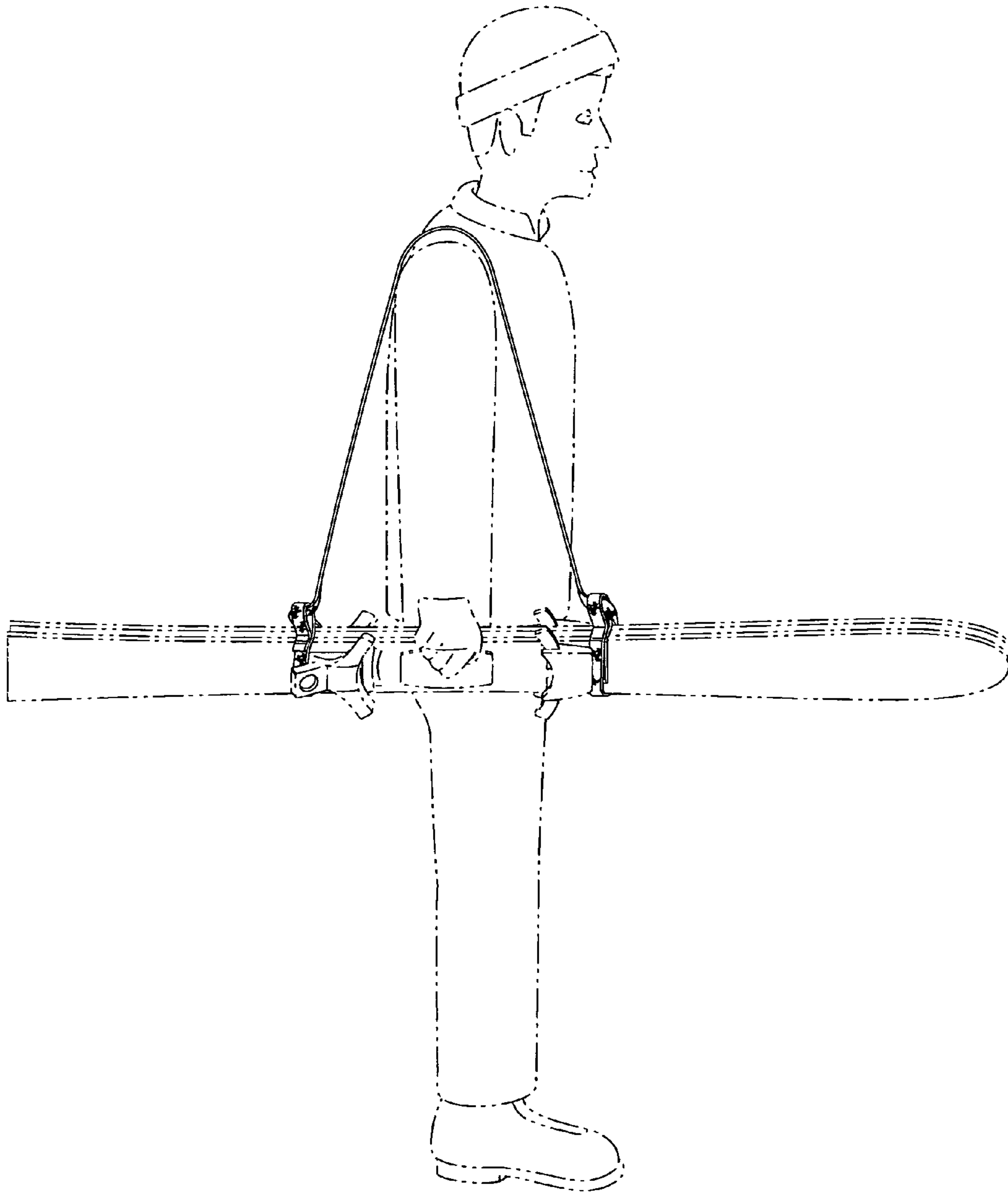

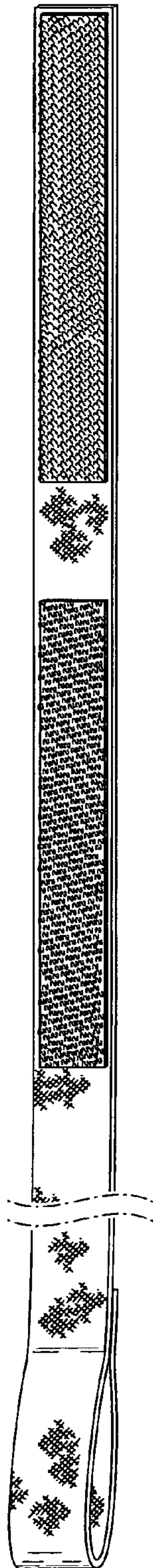

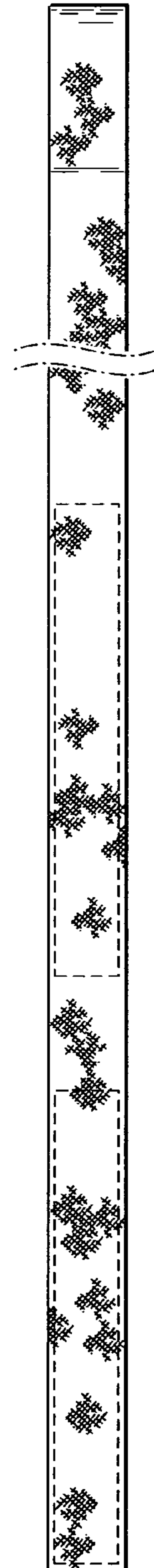

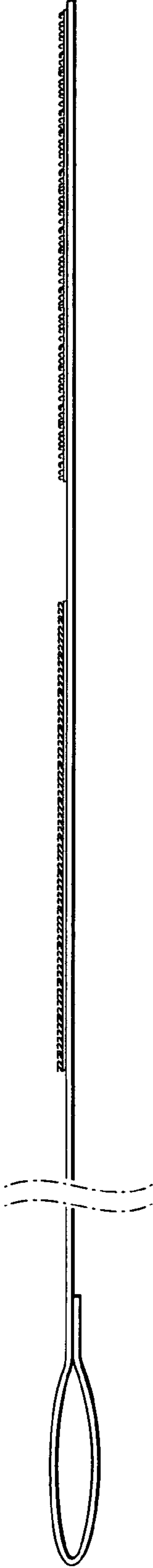

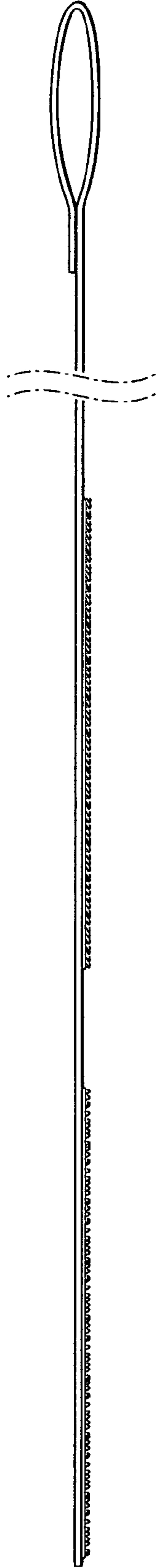
