(57) **CLAIM**

The ornamental design for a lace fabric, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a lace fabric in accordance with the present invention;

FIG. 2 is a back side view thereof;

FIG. 3 is a front perspective view thereof; and,

FIG. 4 is an enlarged front view taken on line 4-4 of FIG. 1.

It is understood that the design repeats uniformly along the entire length of the lace fabric.

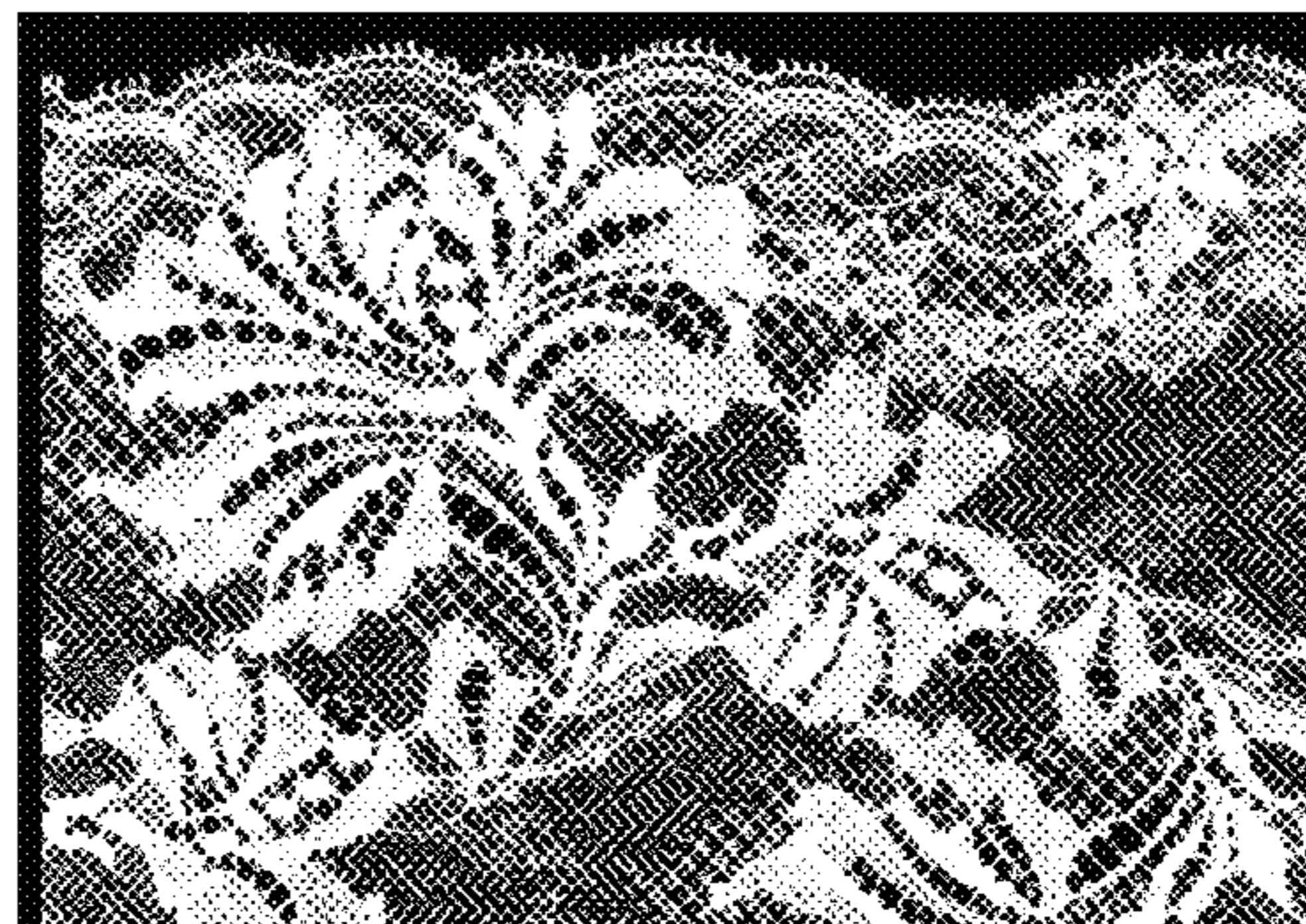
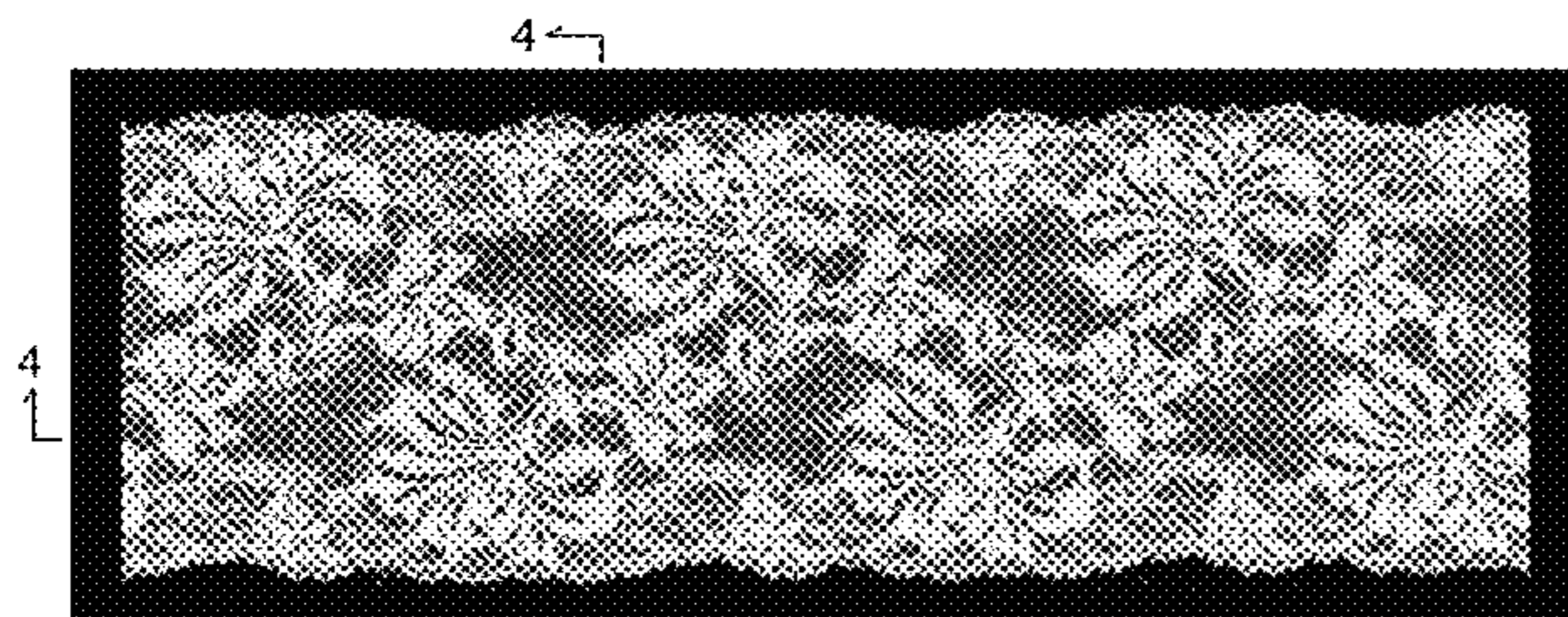

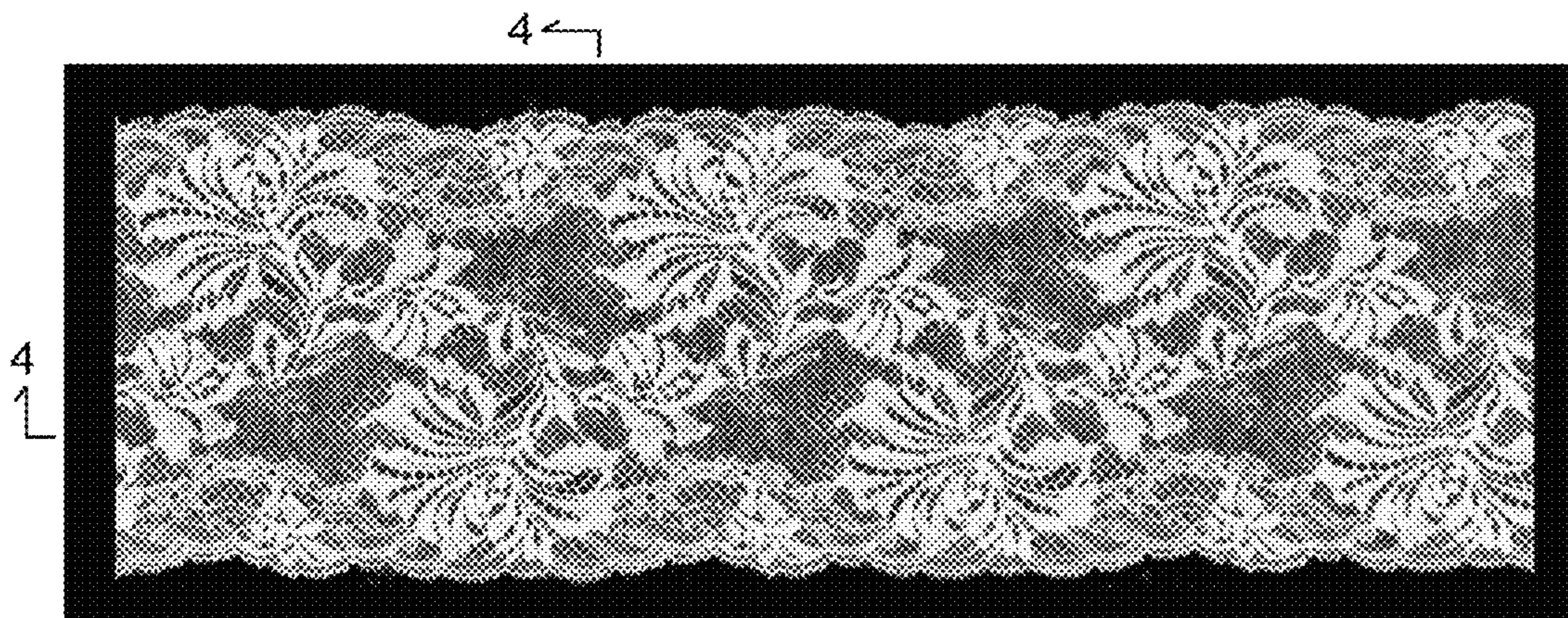

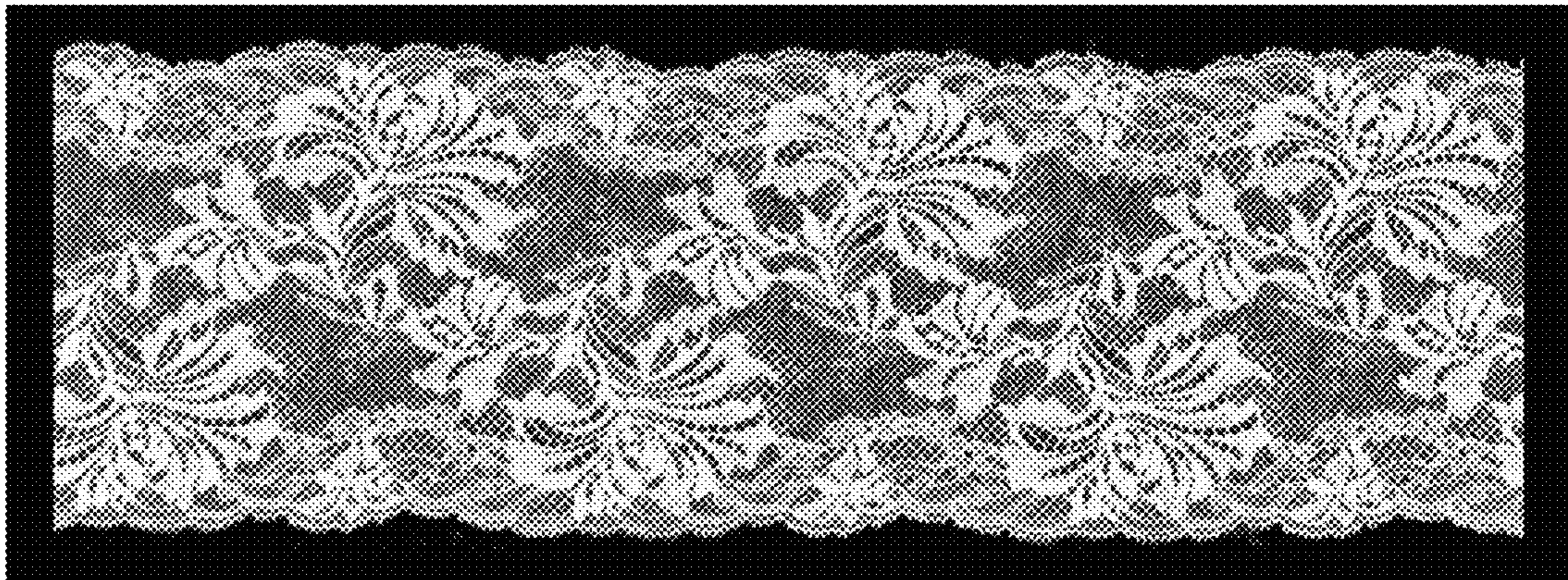

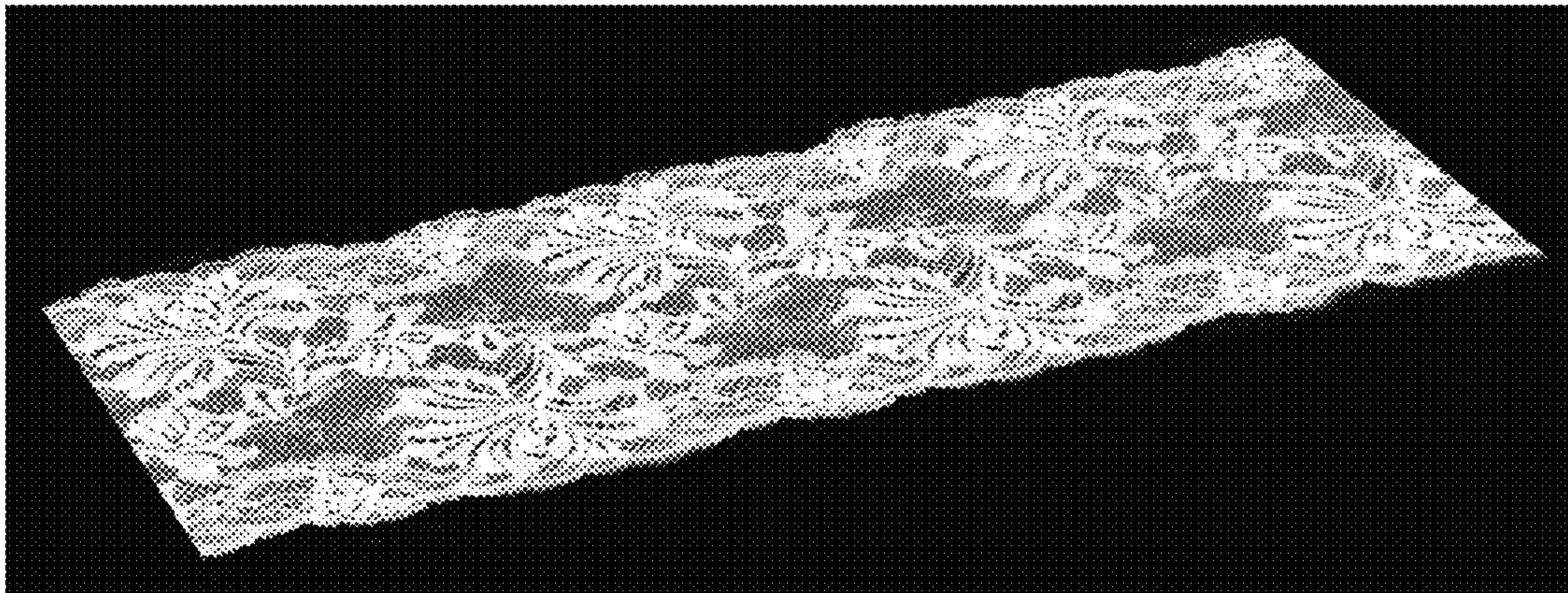
